(57) **CLAIM**

The ornamental design for a parking block, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a parking block showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a right side view thereof, note that the left side is a mirror image of the right side;

FIG. 6 is an enlarged sectional view taken along line A—A in FIG. 1;

FIG. 7 is an enlarged sectional view taken along line B—B in FIG. 1; and,

FIG. 8 is an enlarged sectional view showing the parking block in a use condition.

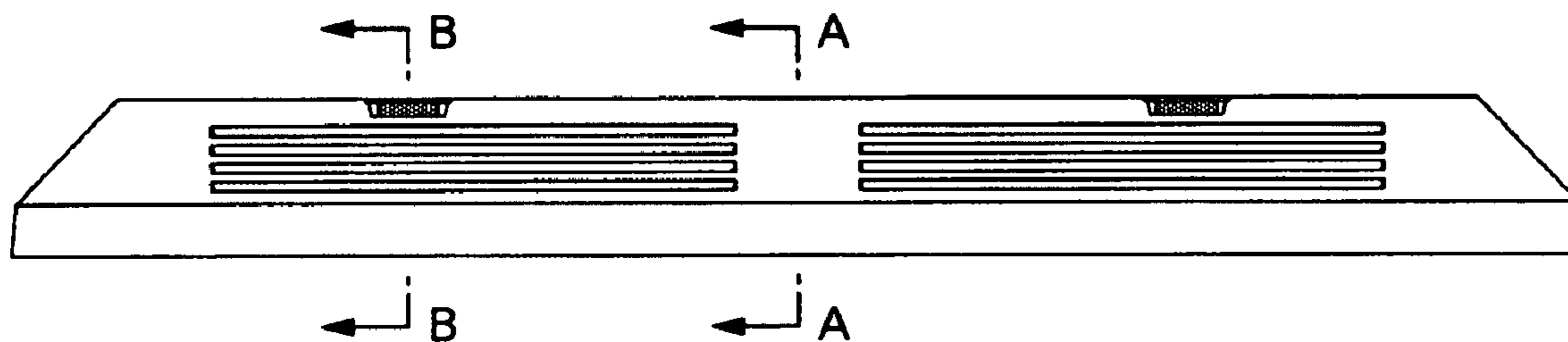

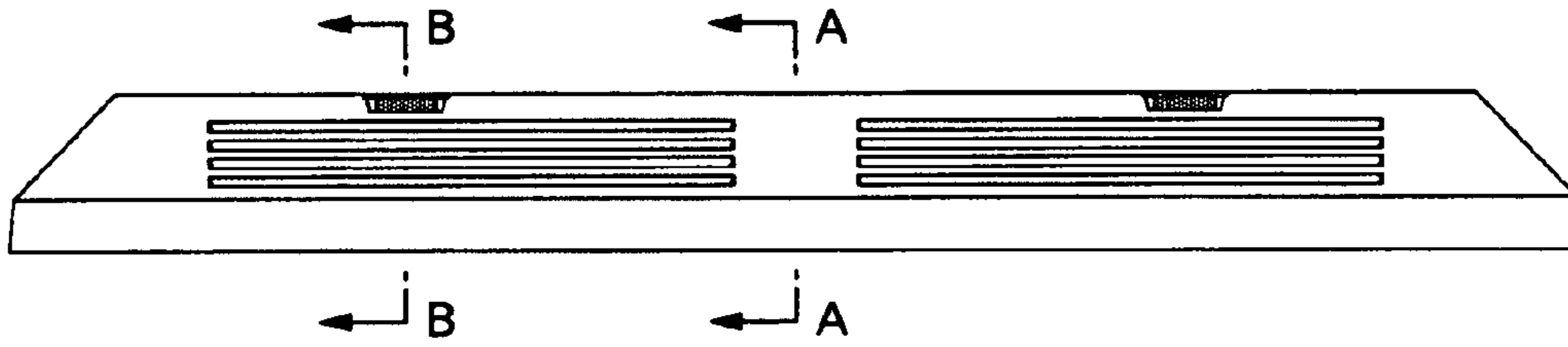

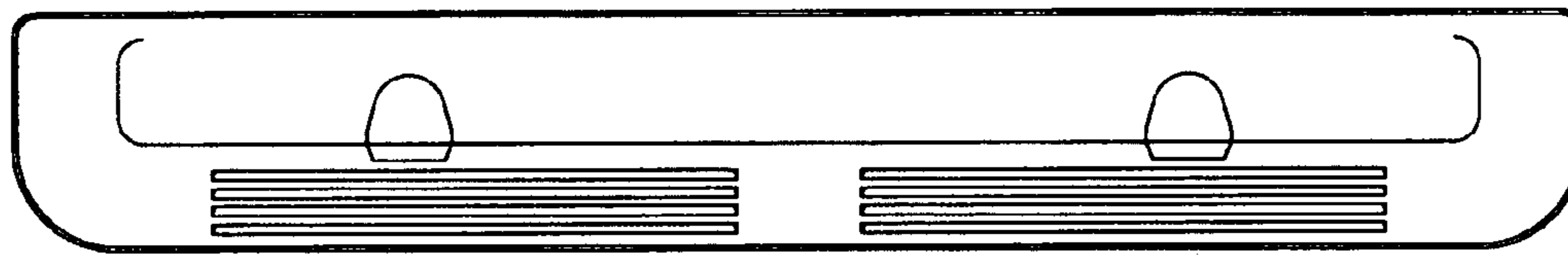

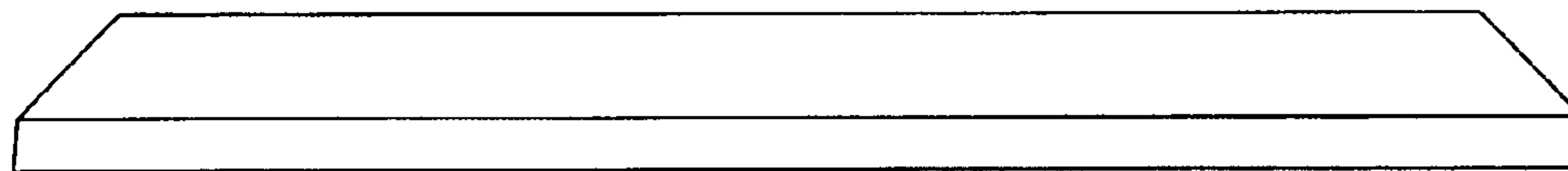

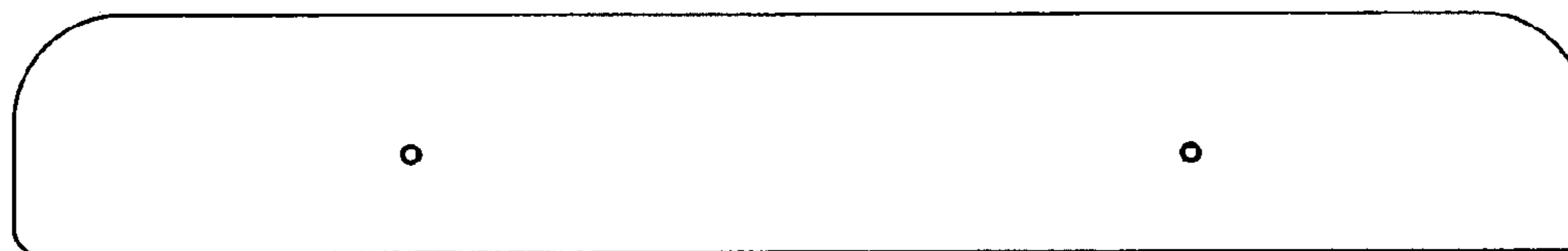

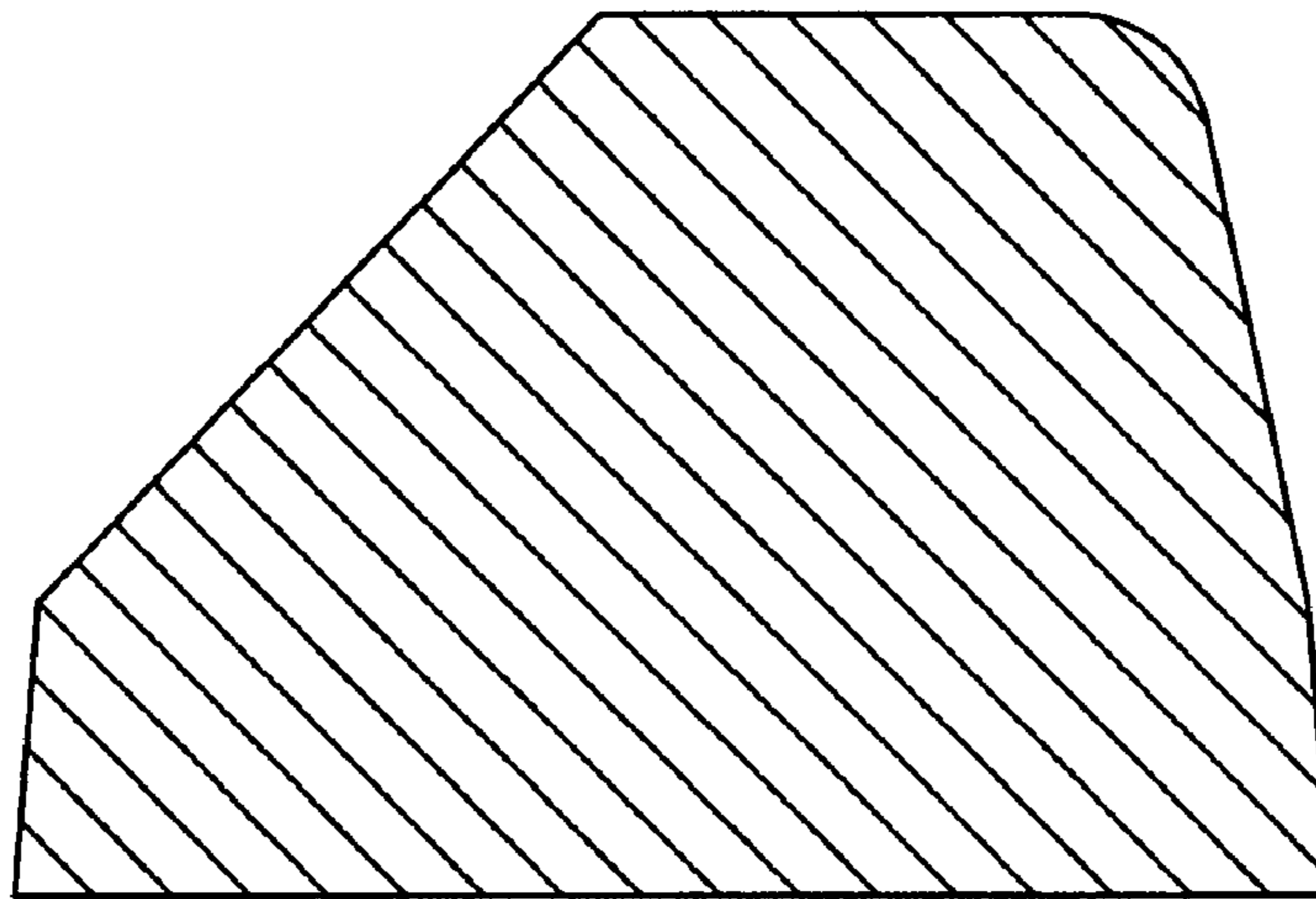

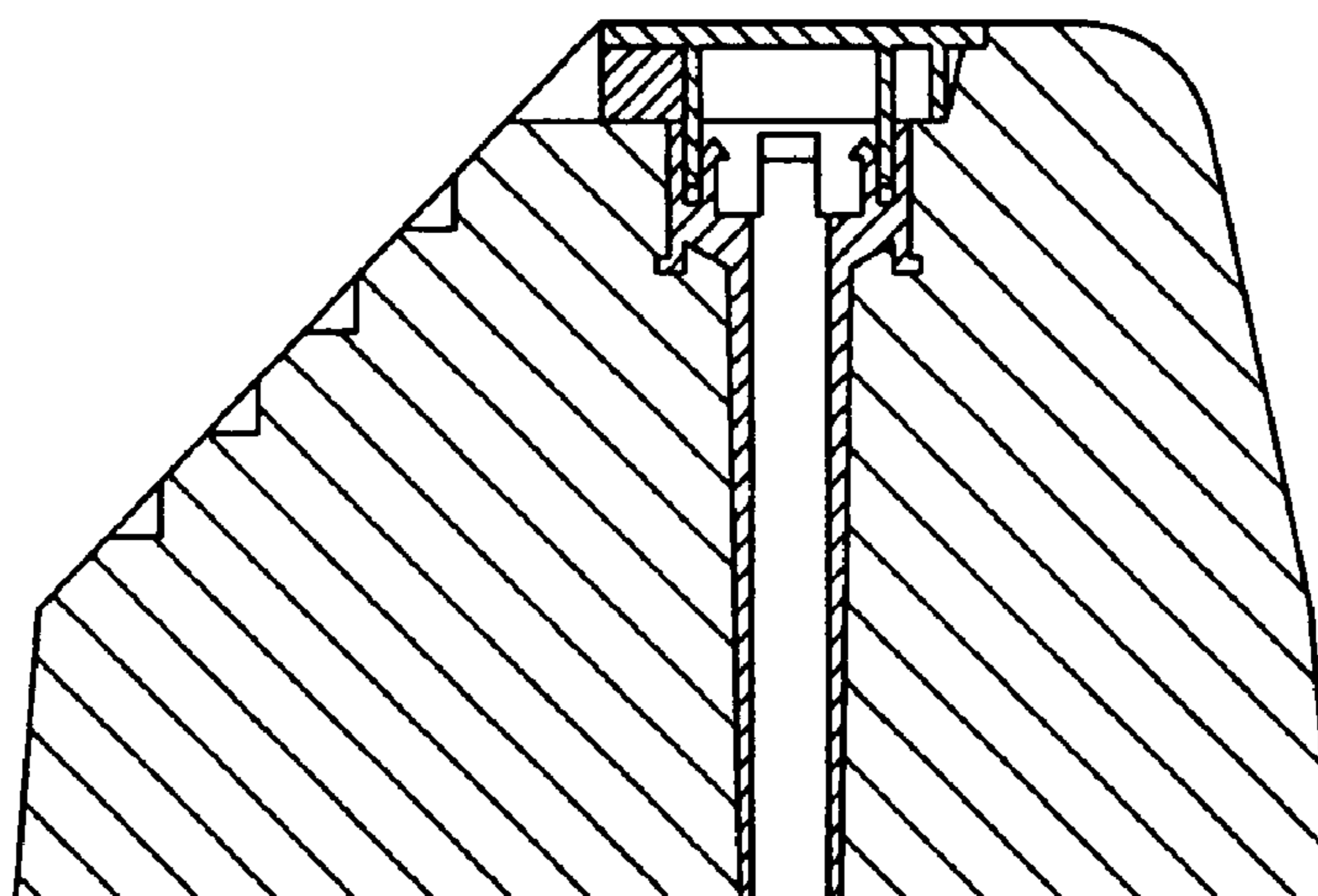
