FIG. 5 is a front elevational view of a fifth embodiment of a roof shingle;

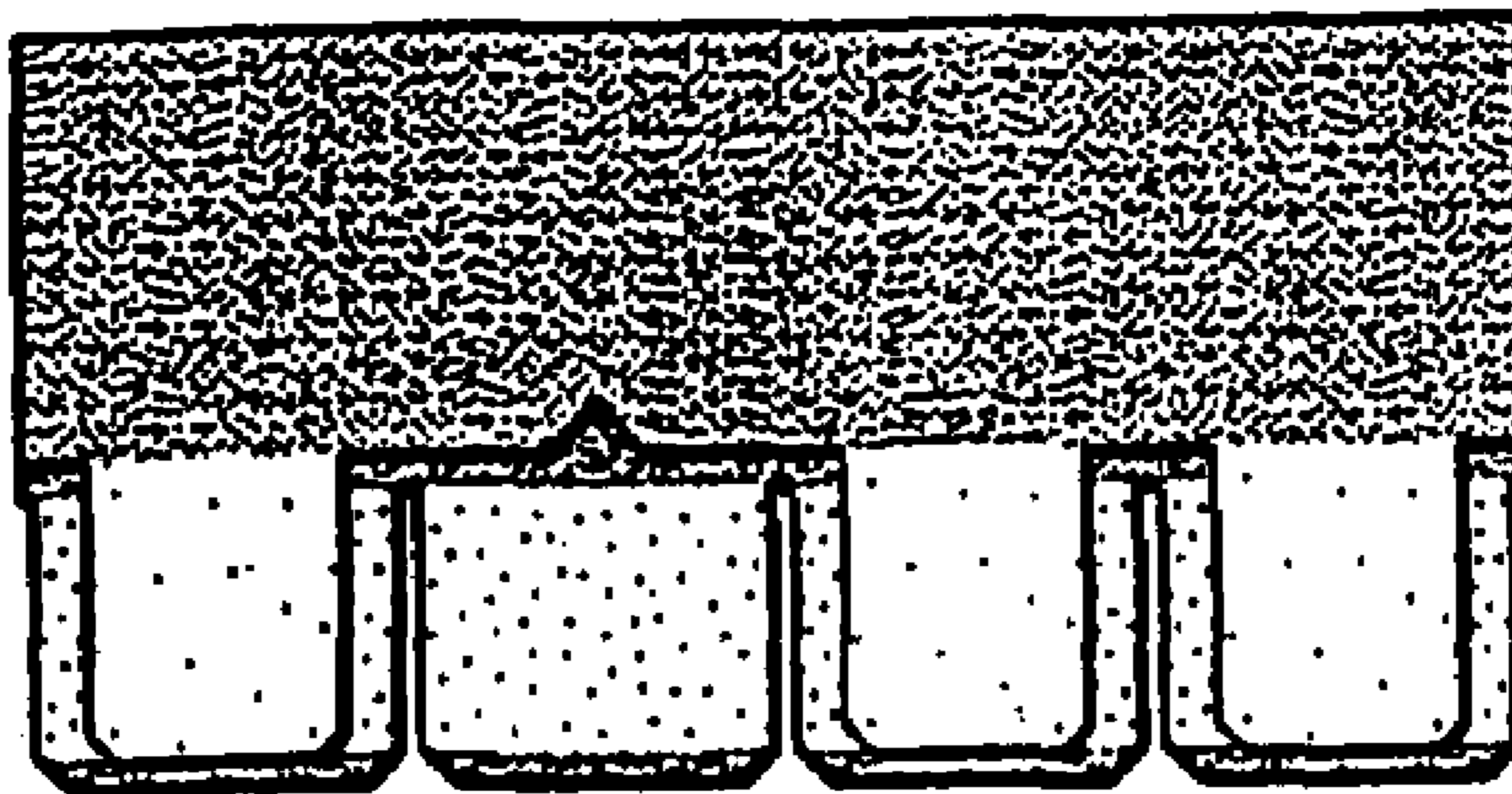


FIG. 6 is a front elevational view of a sixth embodiment of a roof shingle;

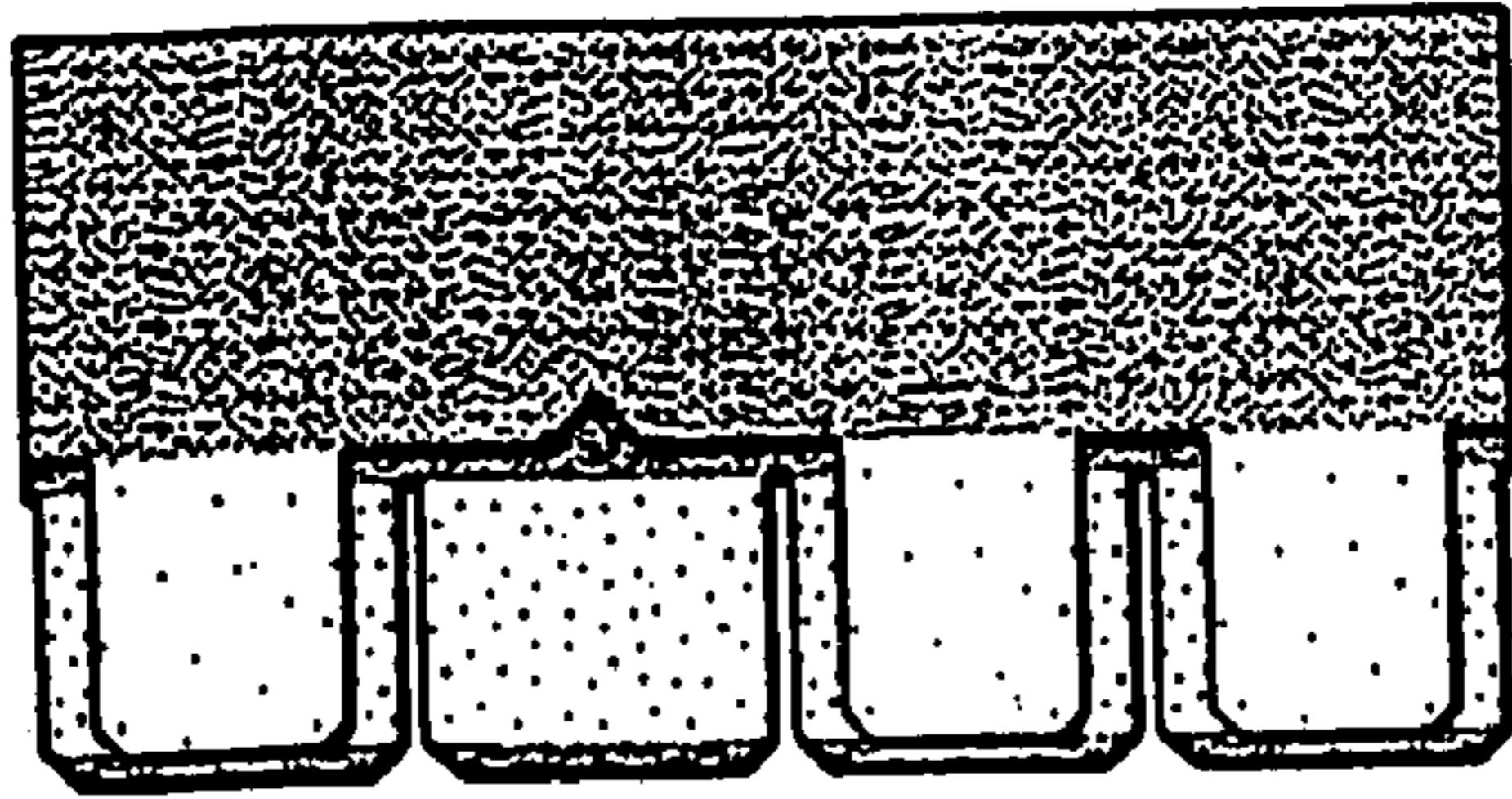

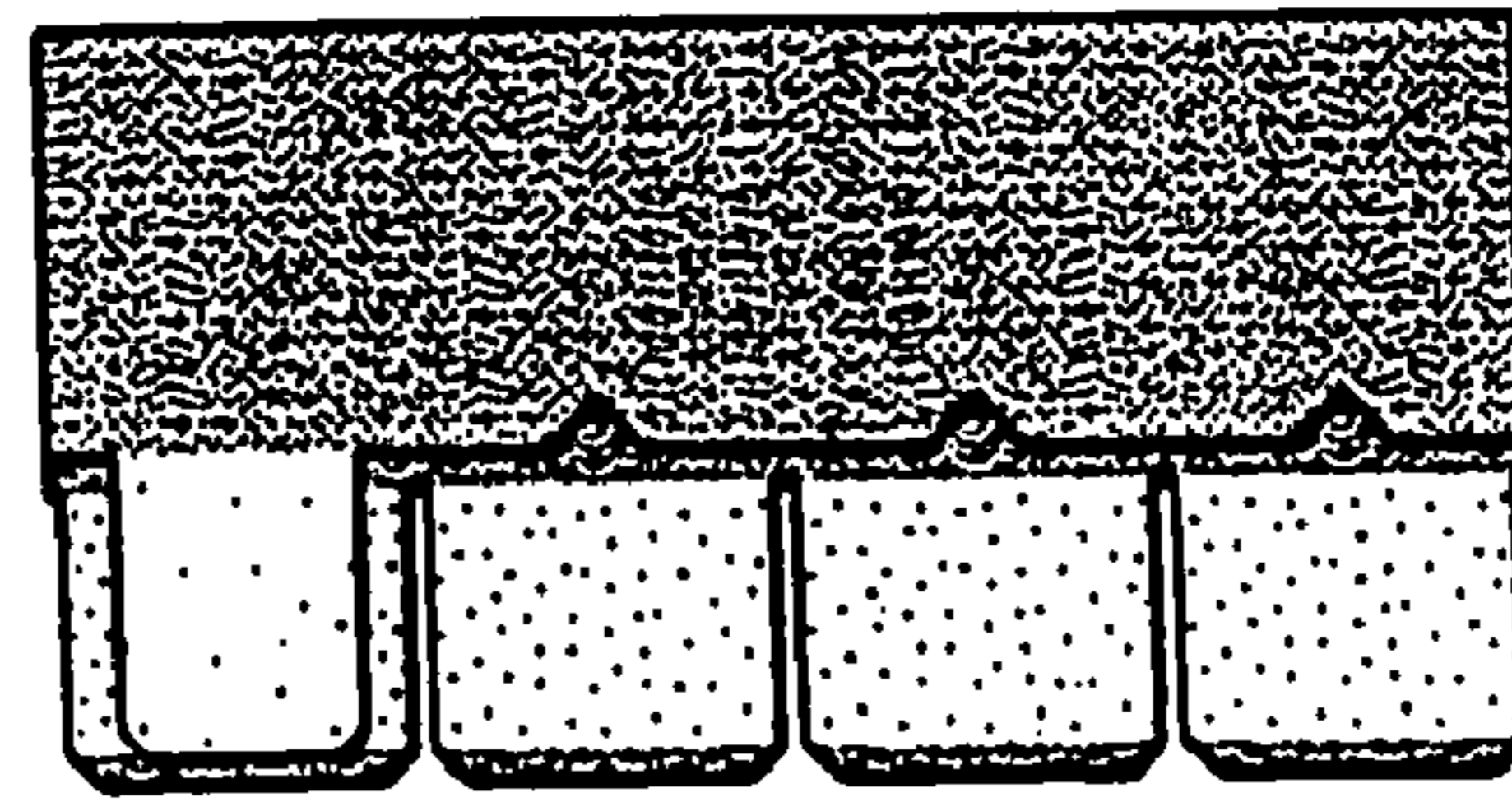

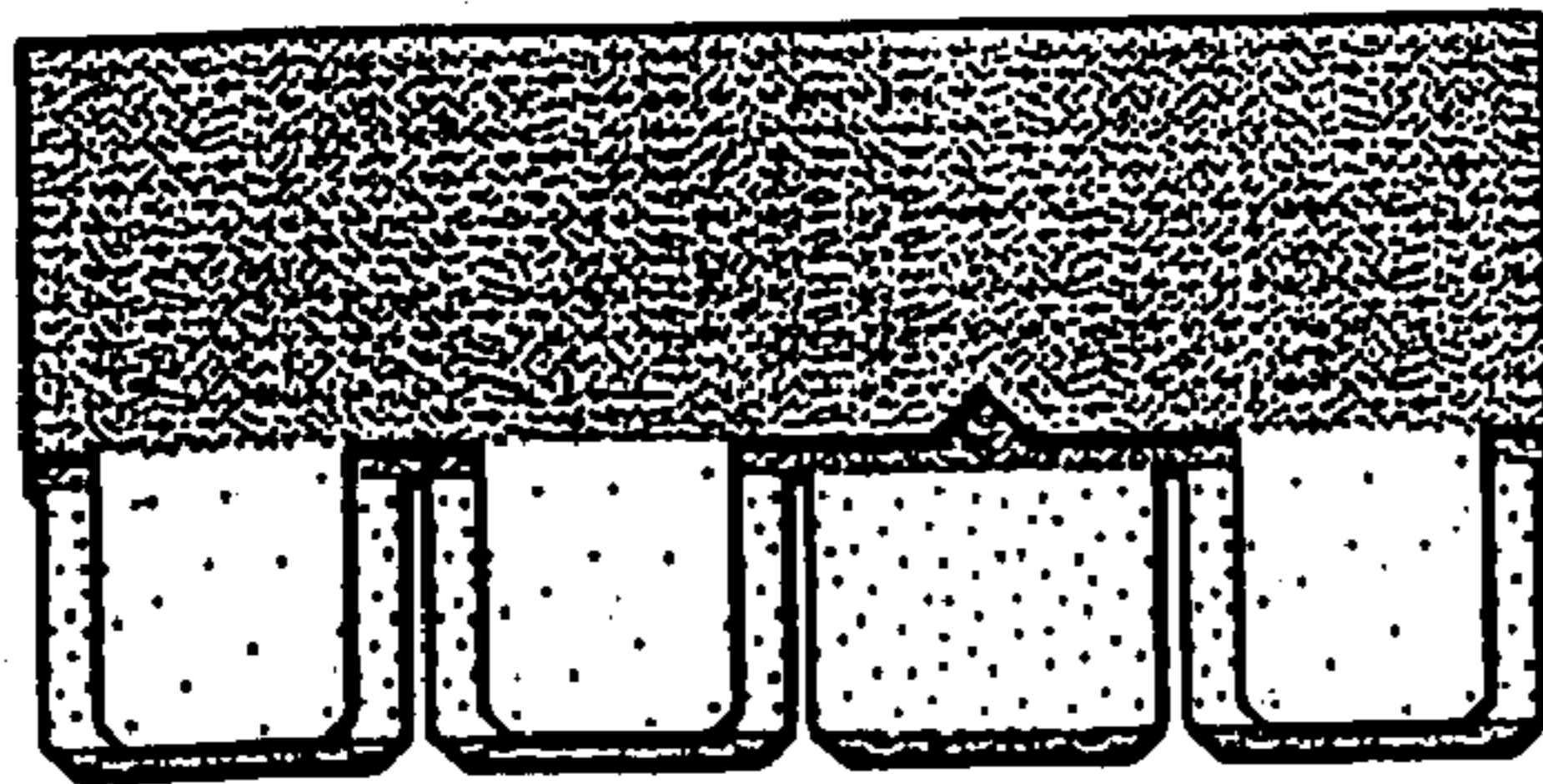

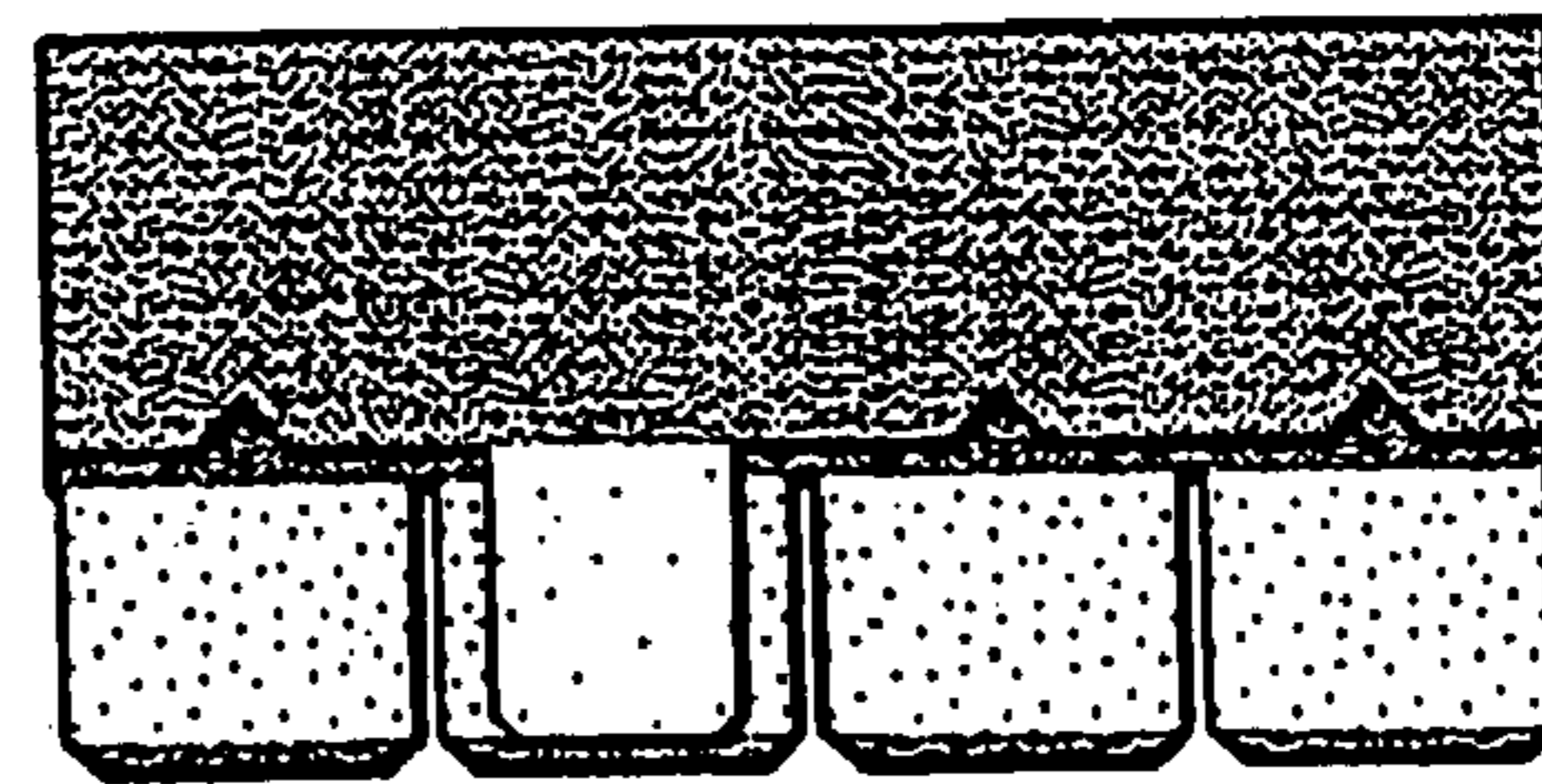

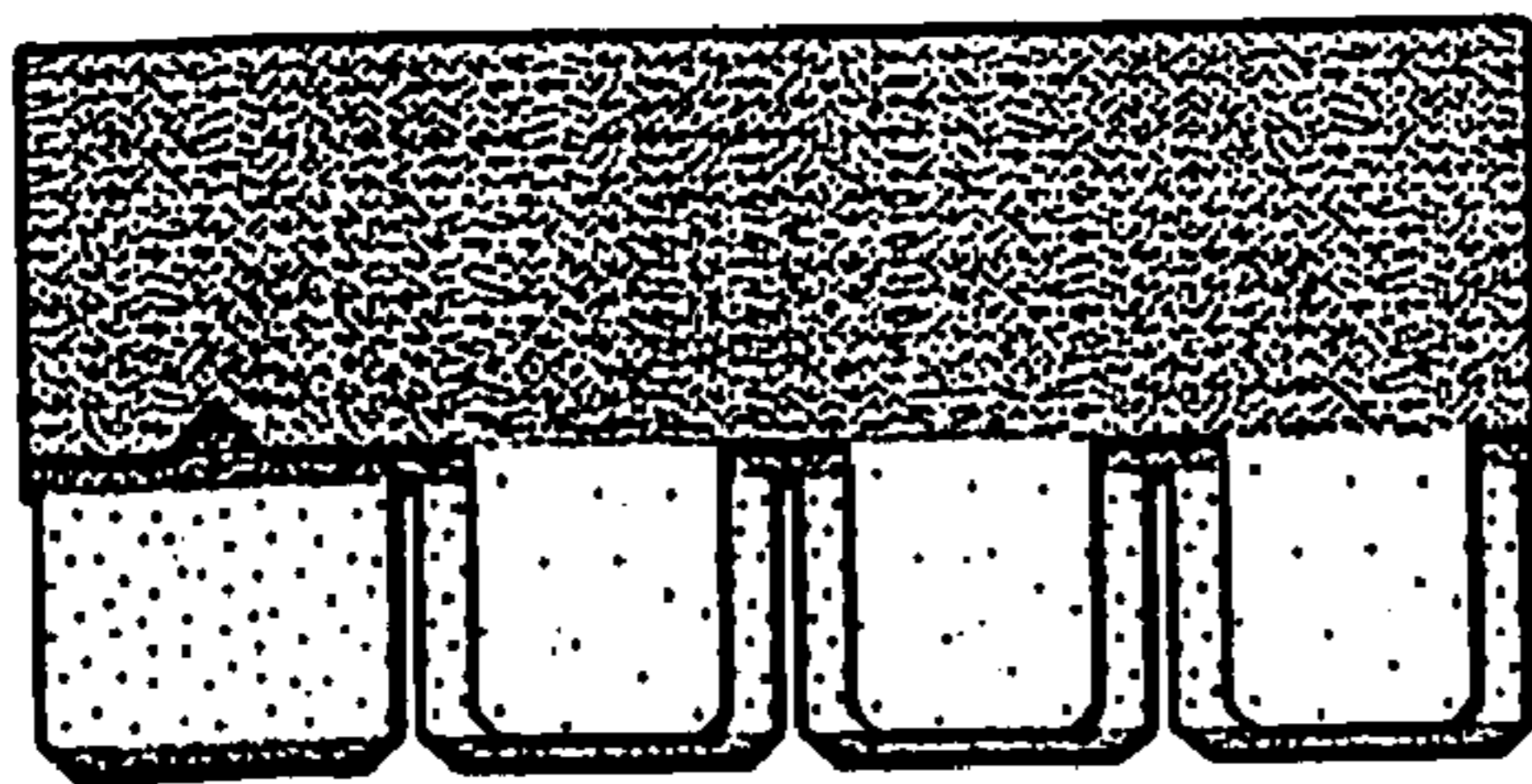

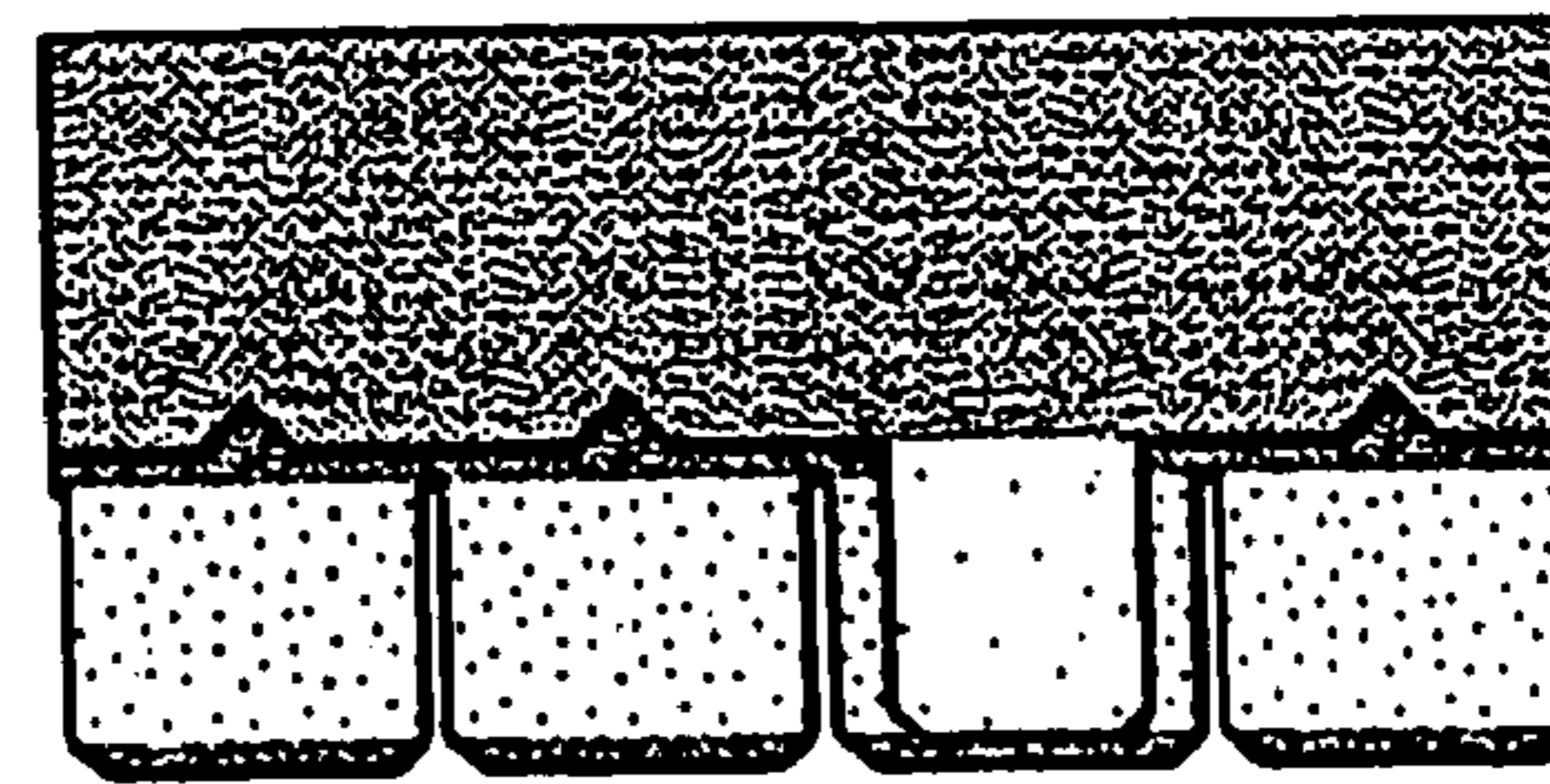

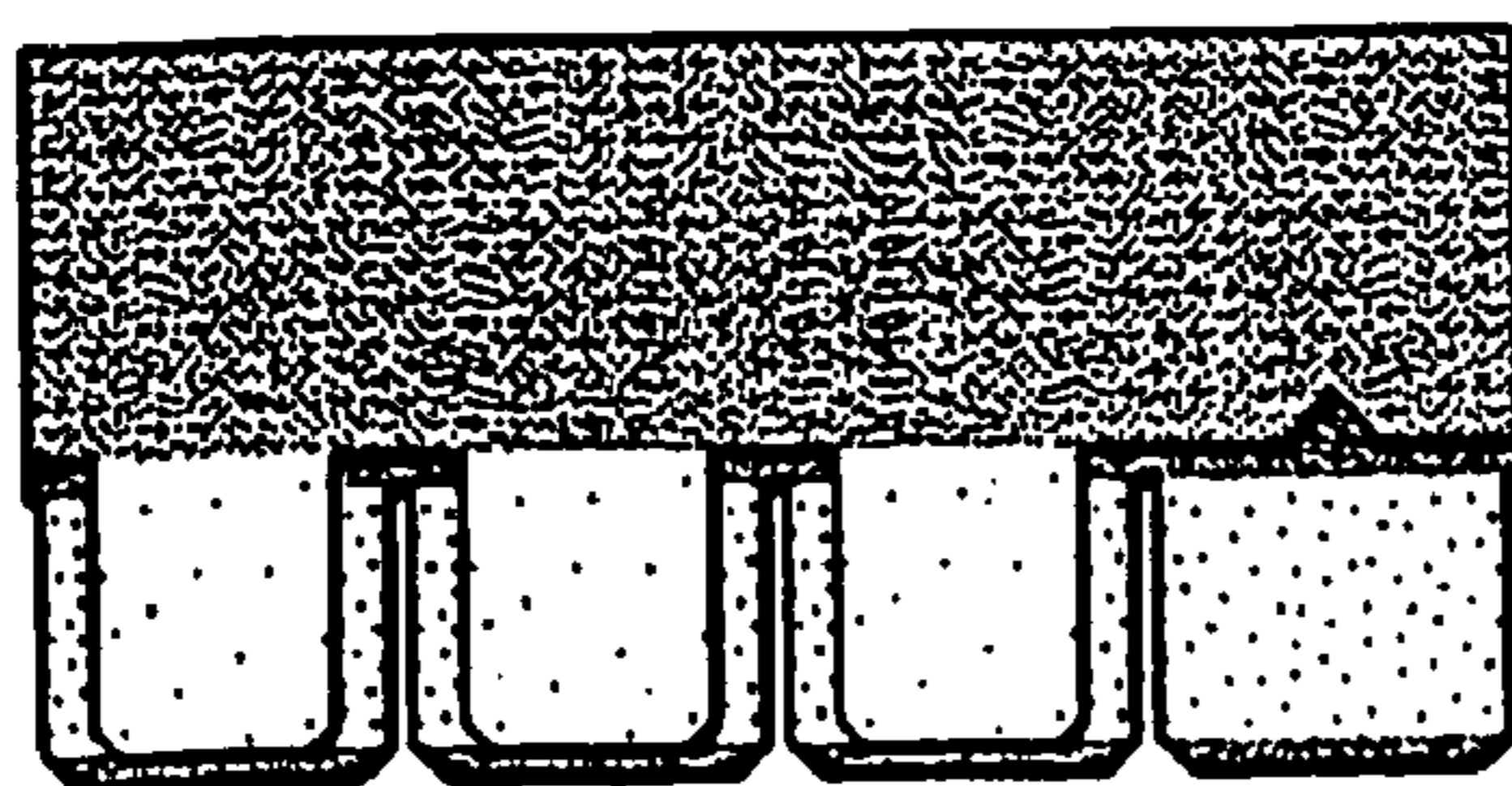

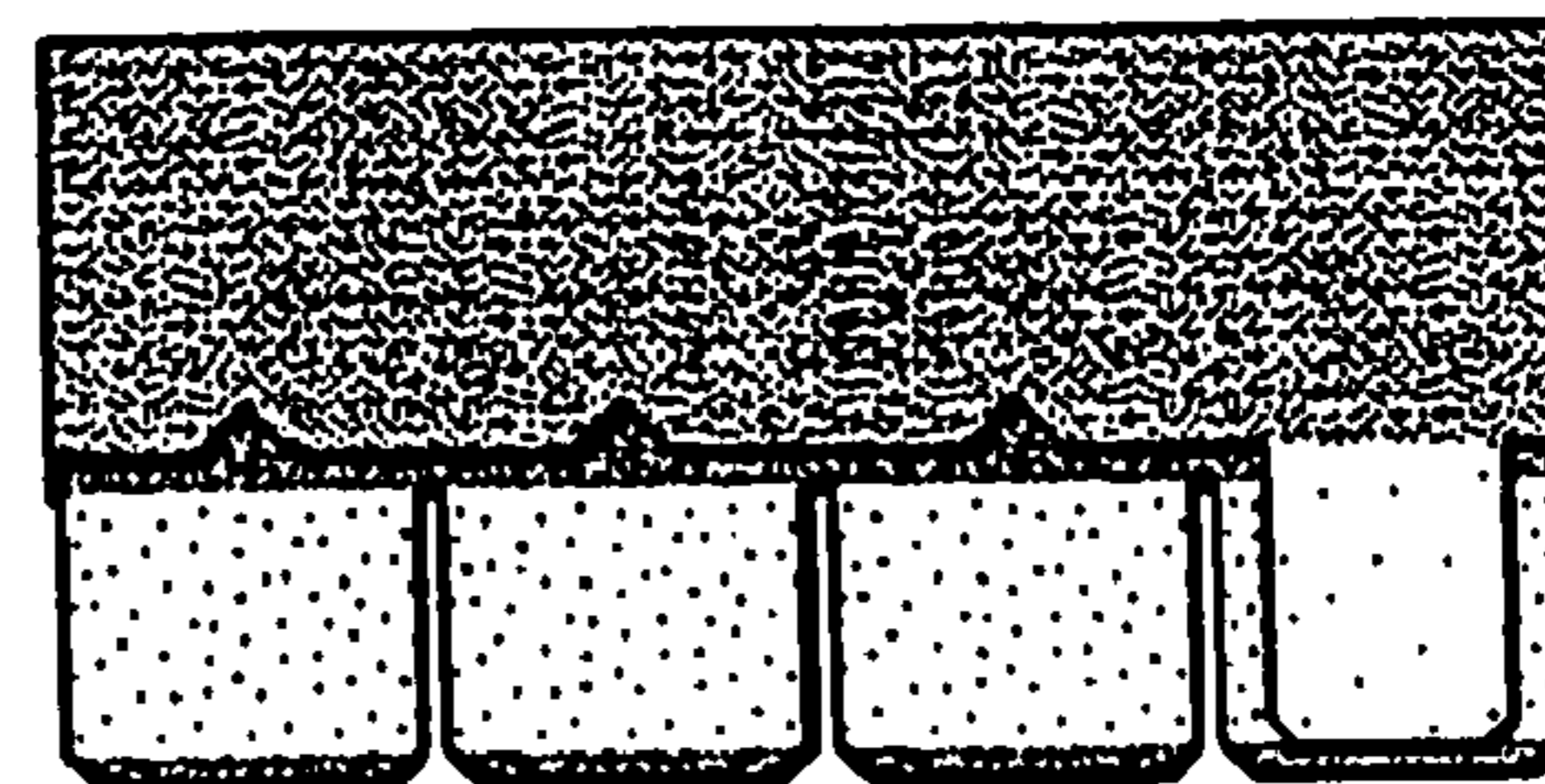

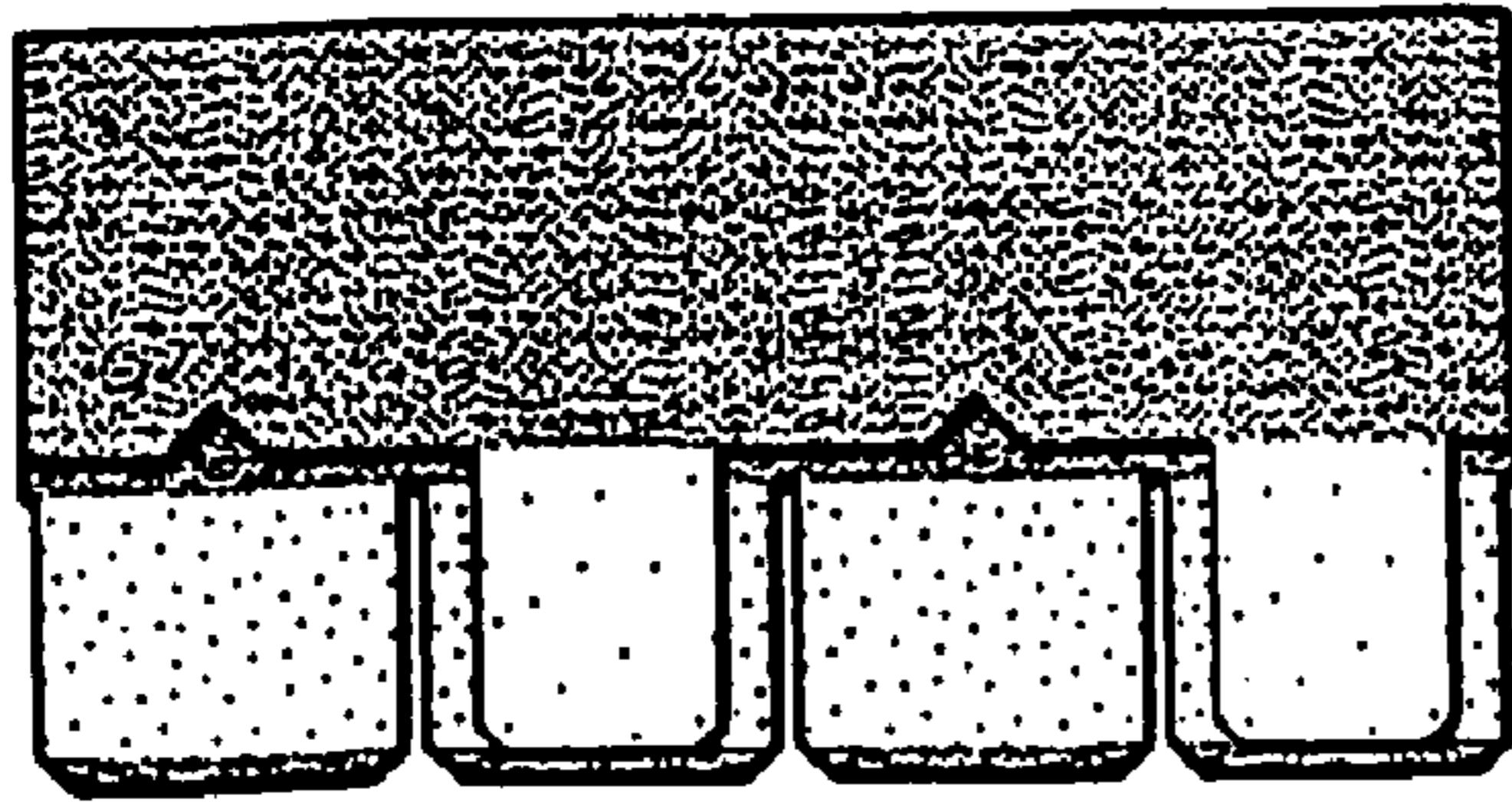

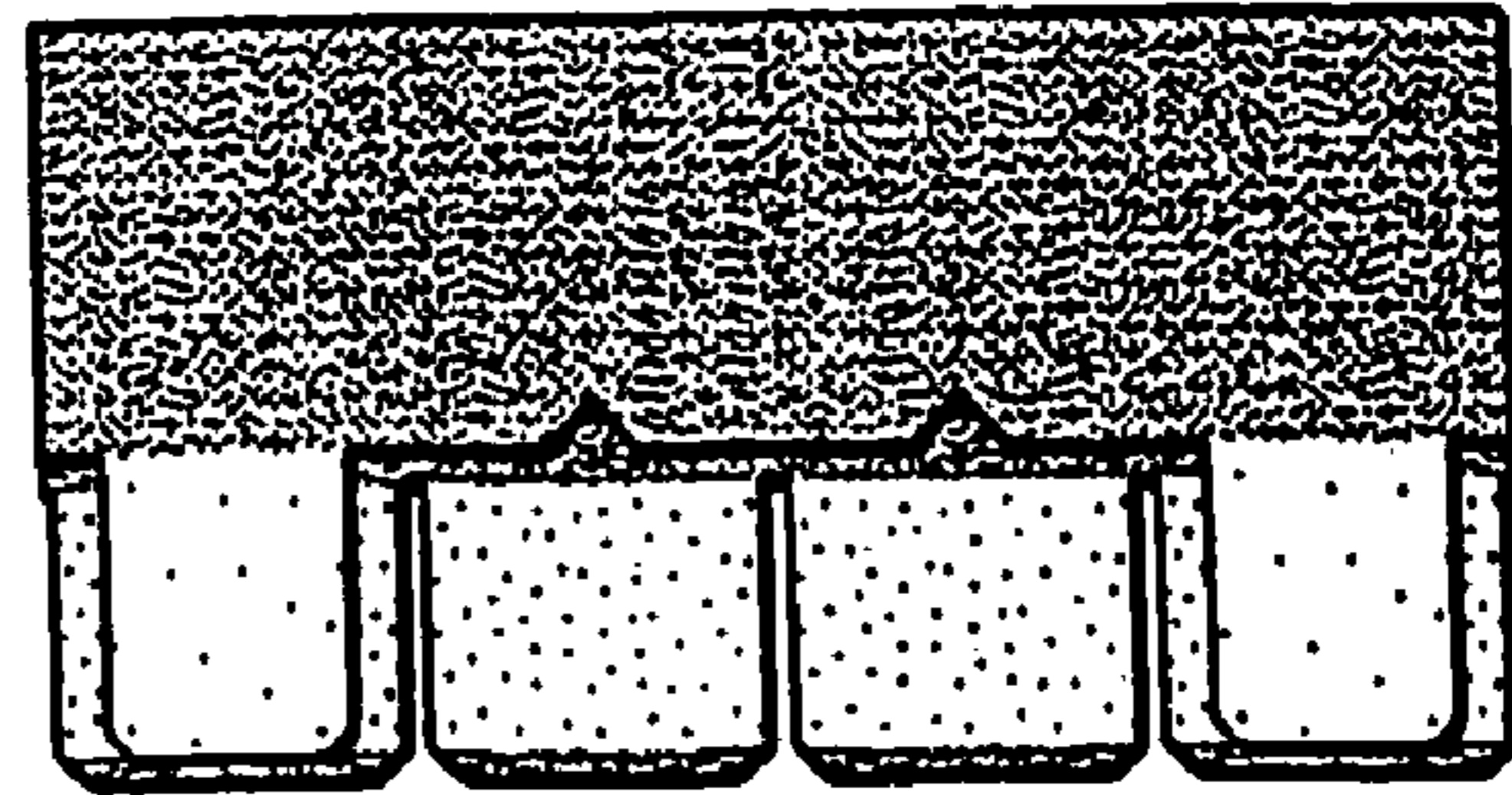

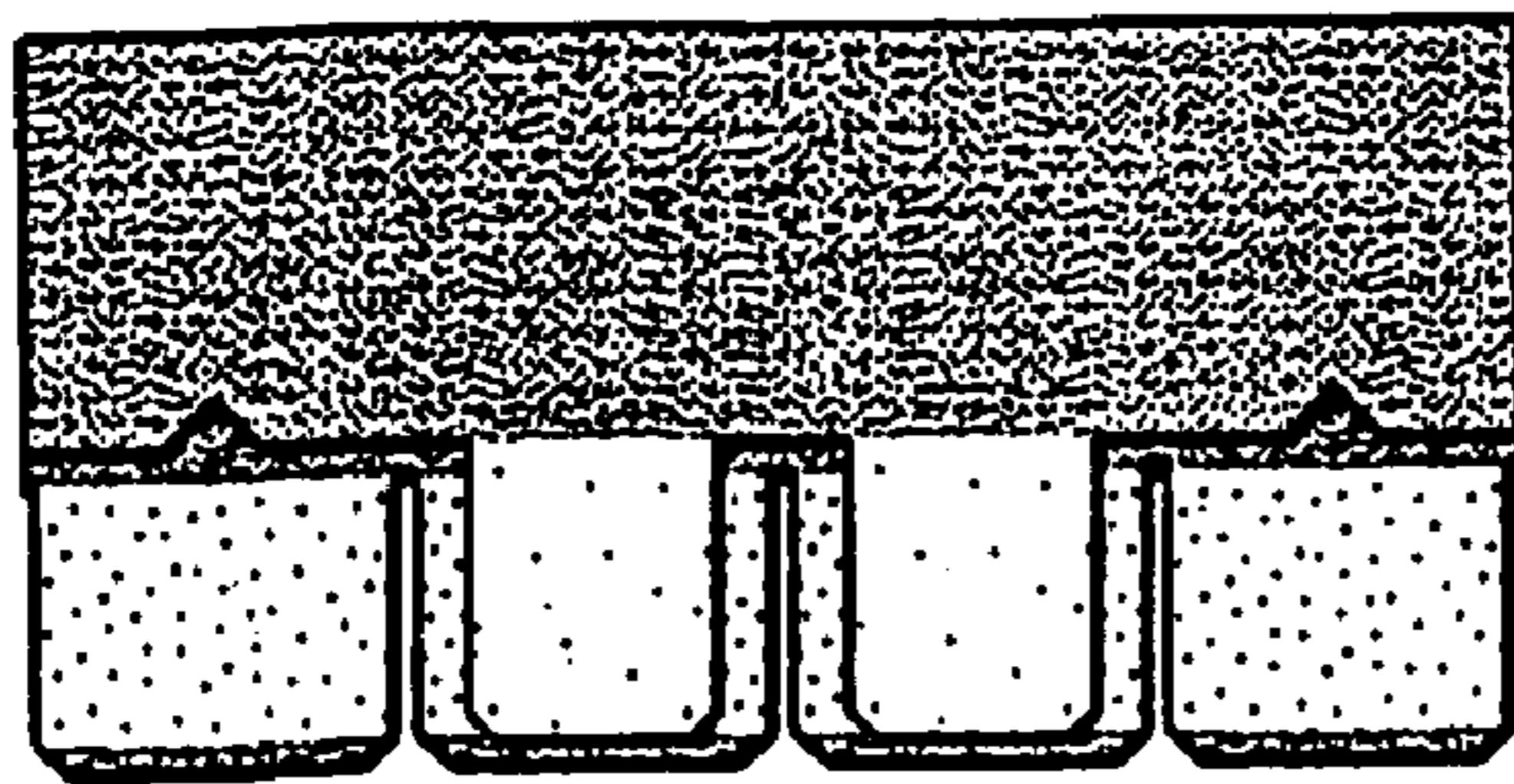

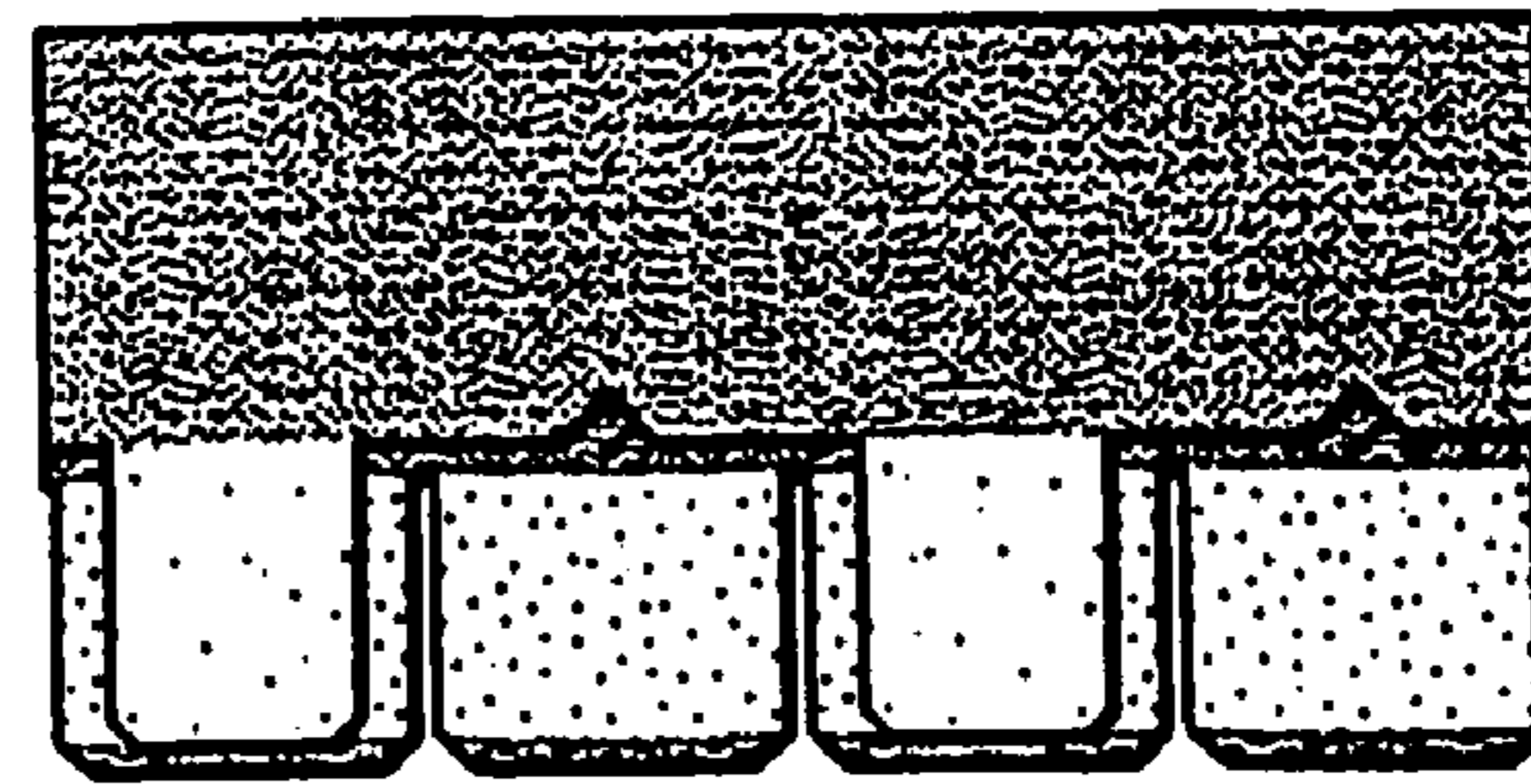

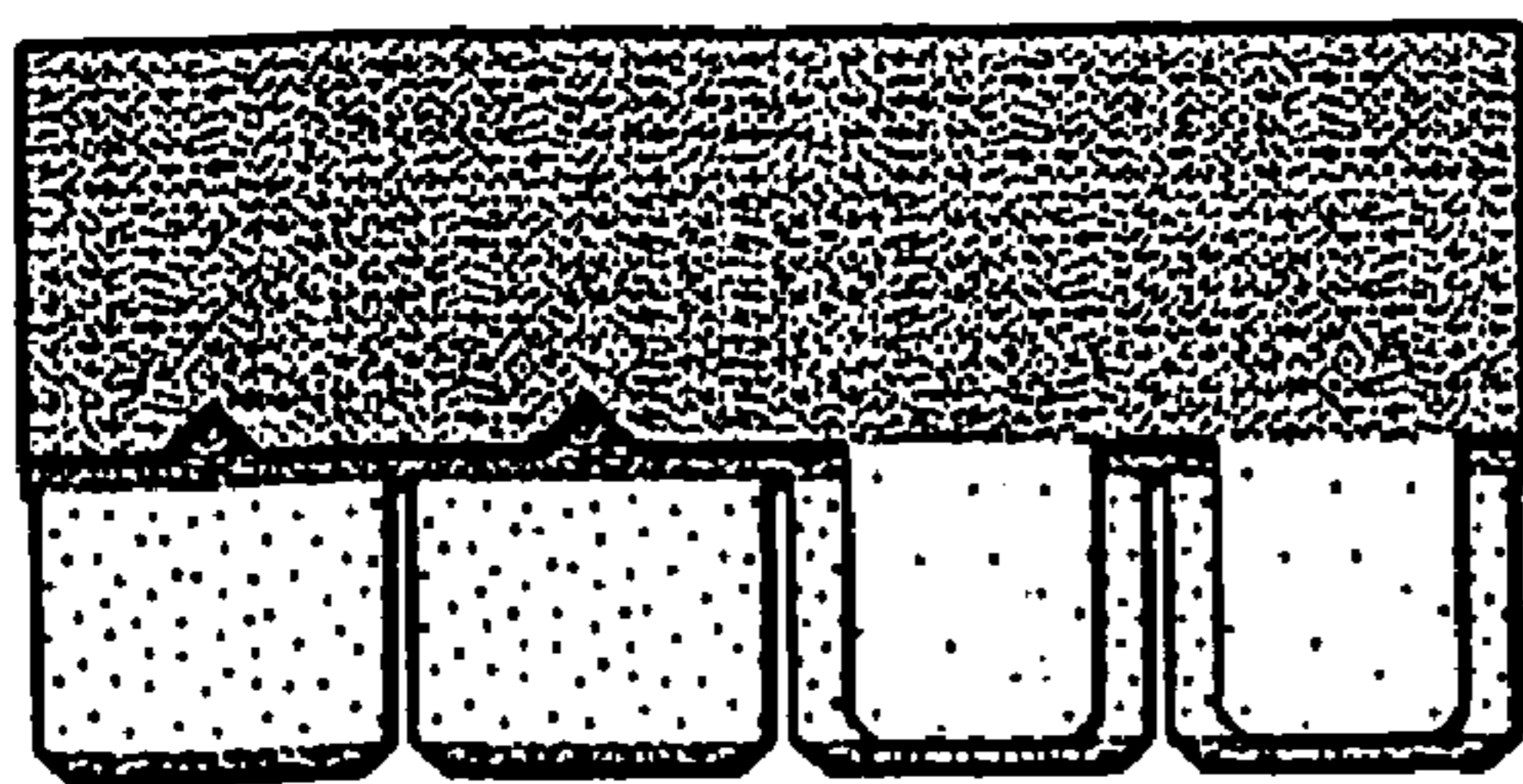

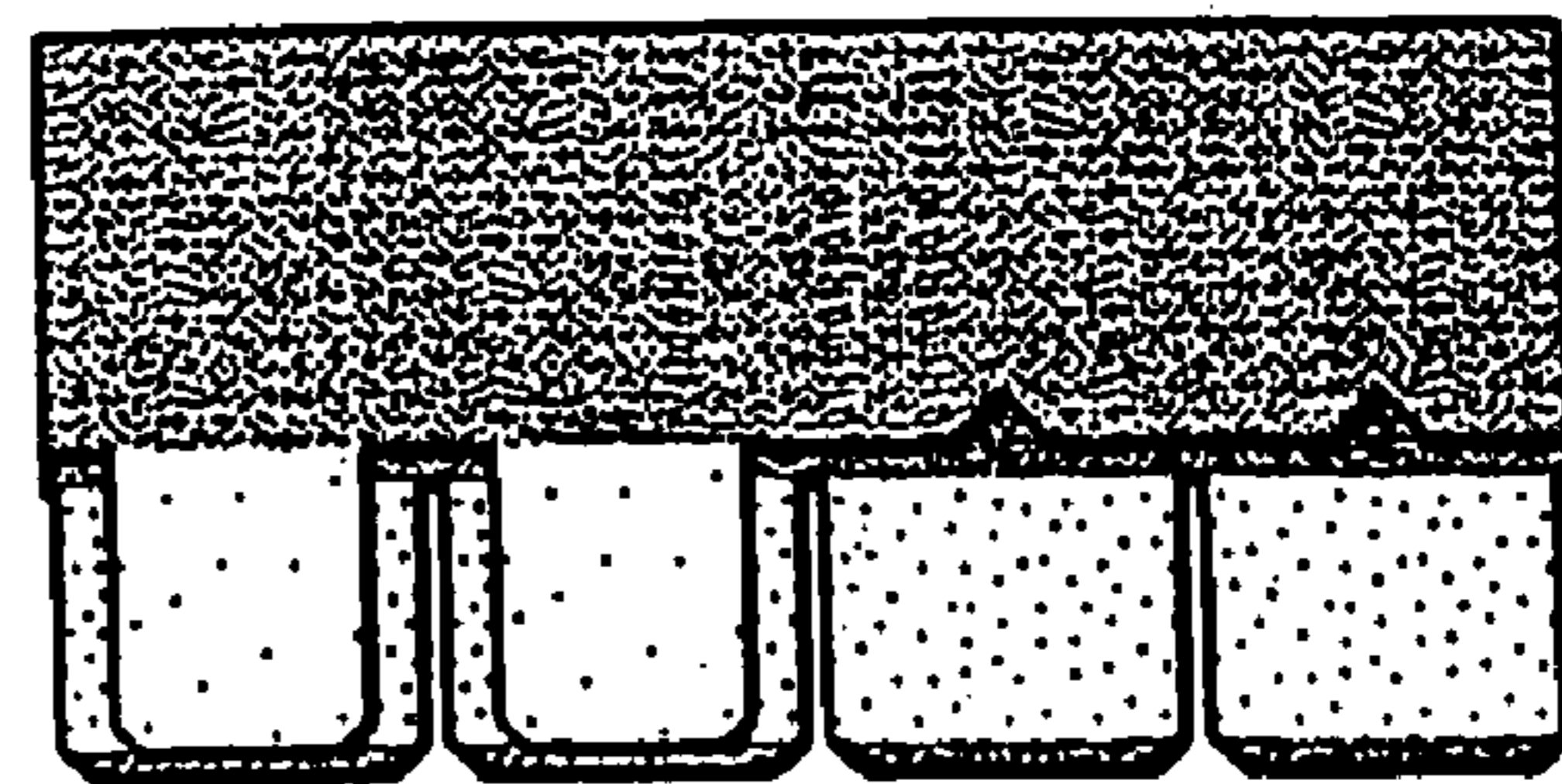

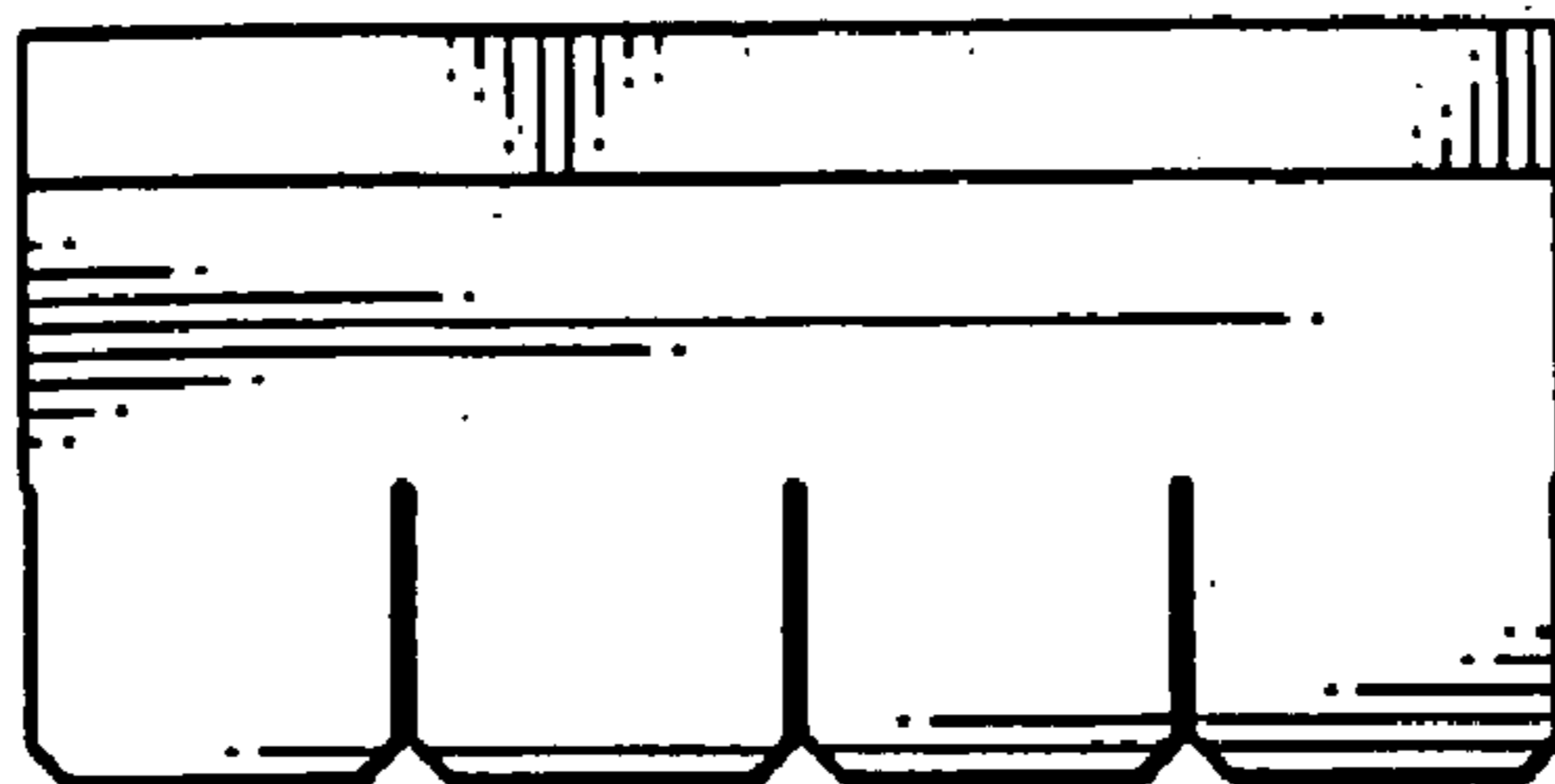
