FIG. 2 is a front view of a double pocket for garments thereof; at a reduced scale incorporated into a rear panel of jeans;

FIG. 3 is a front view of a double pocket for garments; at a reduced scale incorporated into a rear panel of a skirt; and, FIG. 4 is a front view of a double pocket for garments; at a reduced scale incorporated into a front panel of a skirt or jacket.

The interior broken lines showing on the double pocket for garments represents stitching and is part of the claimed design.

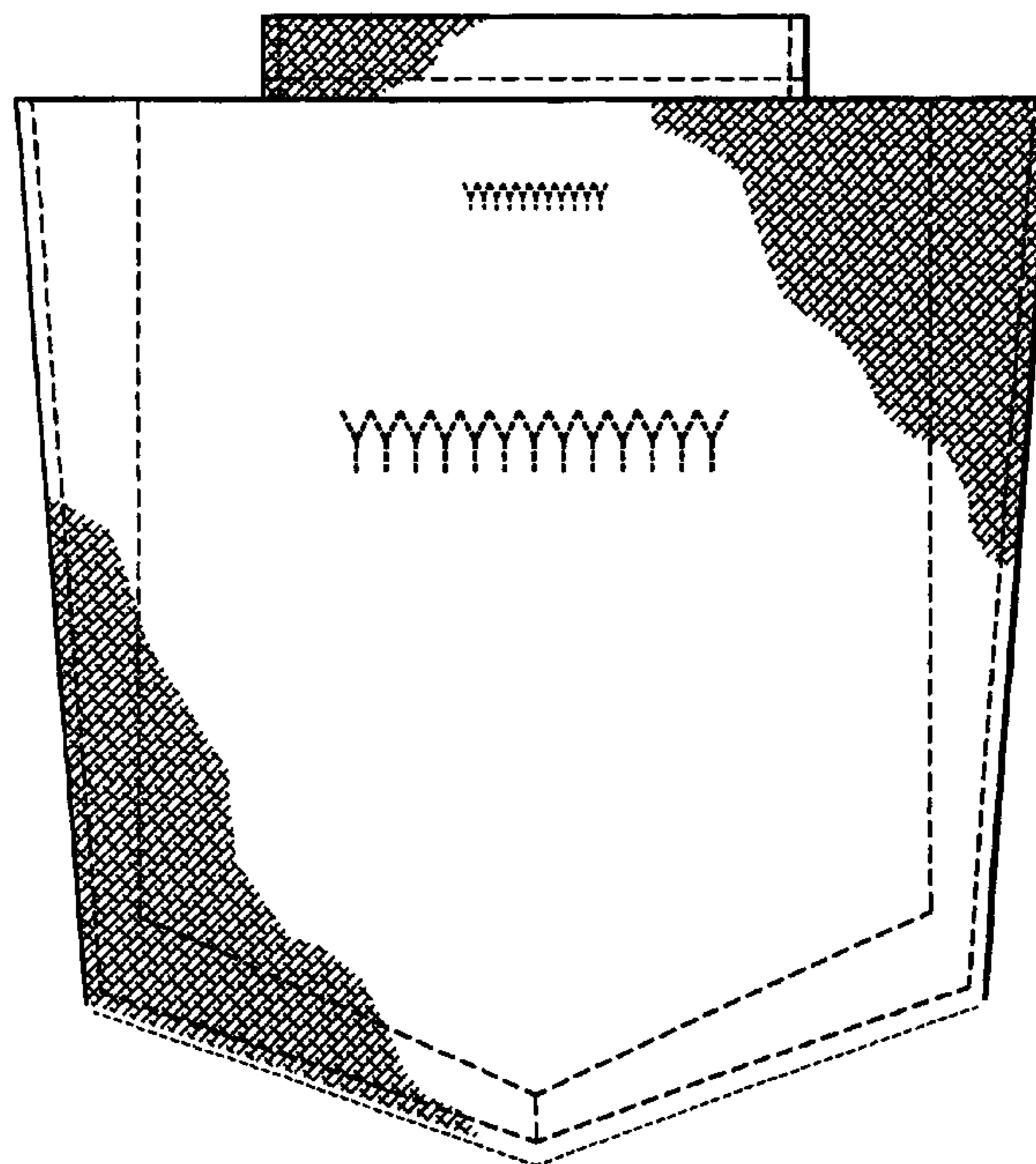

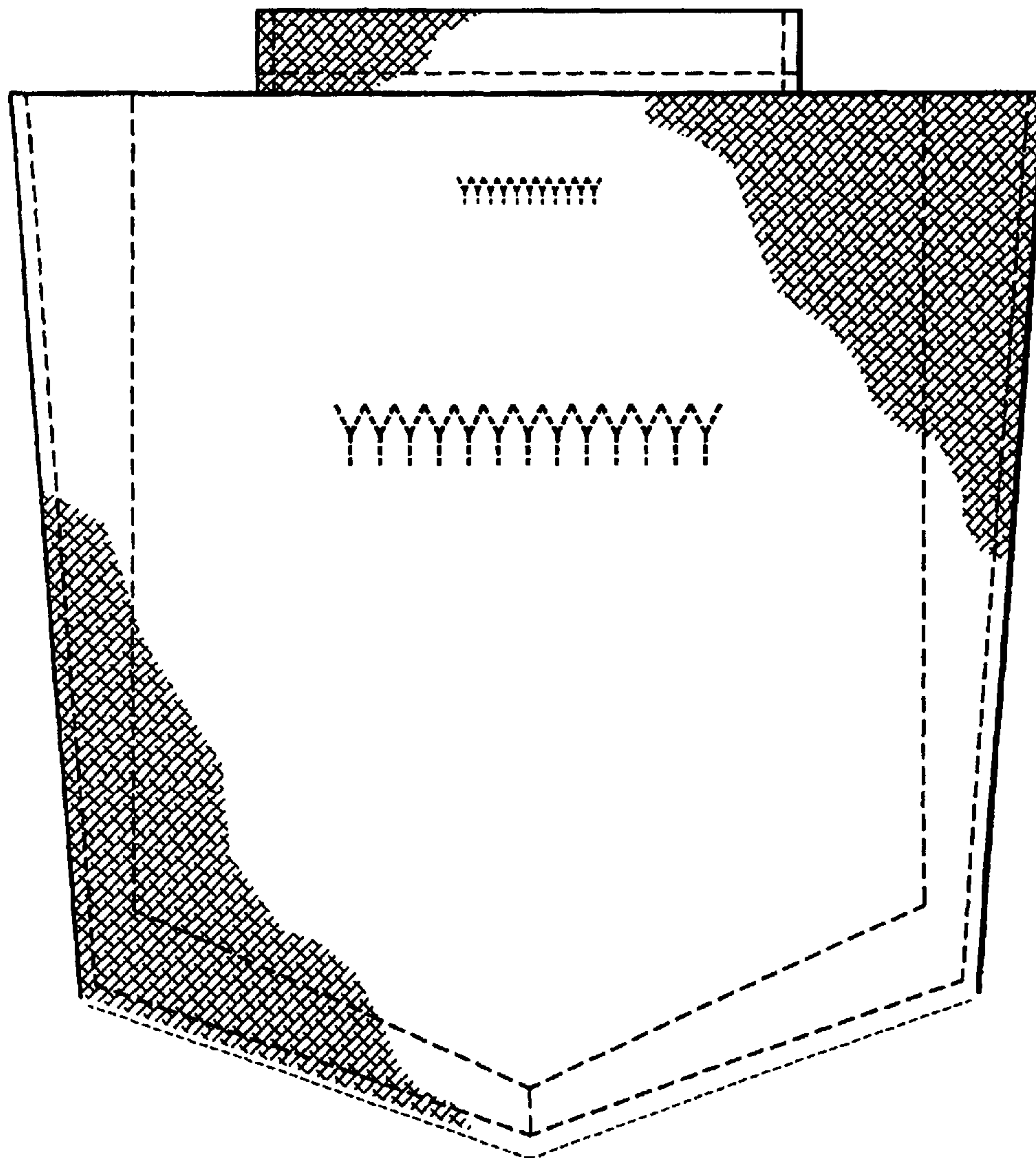
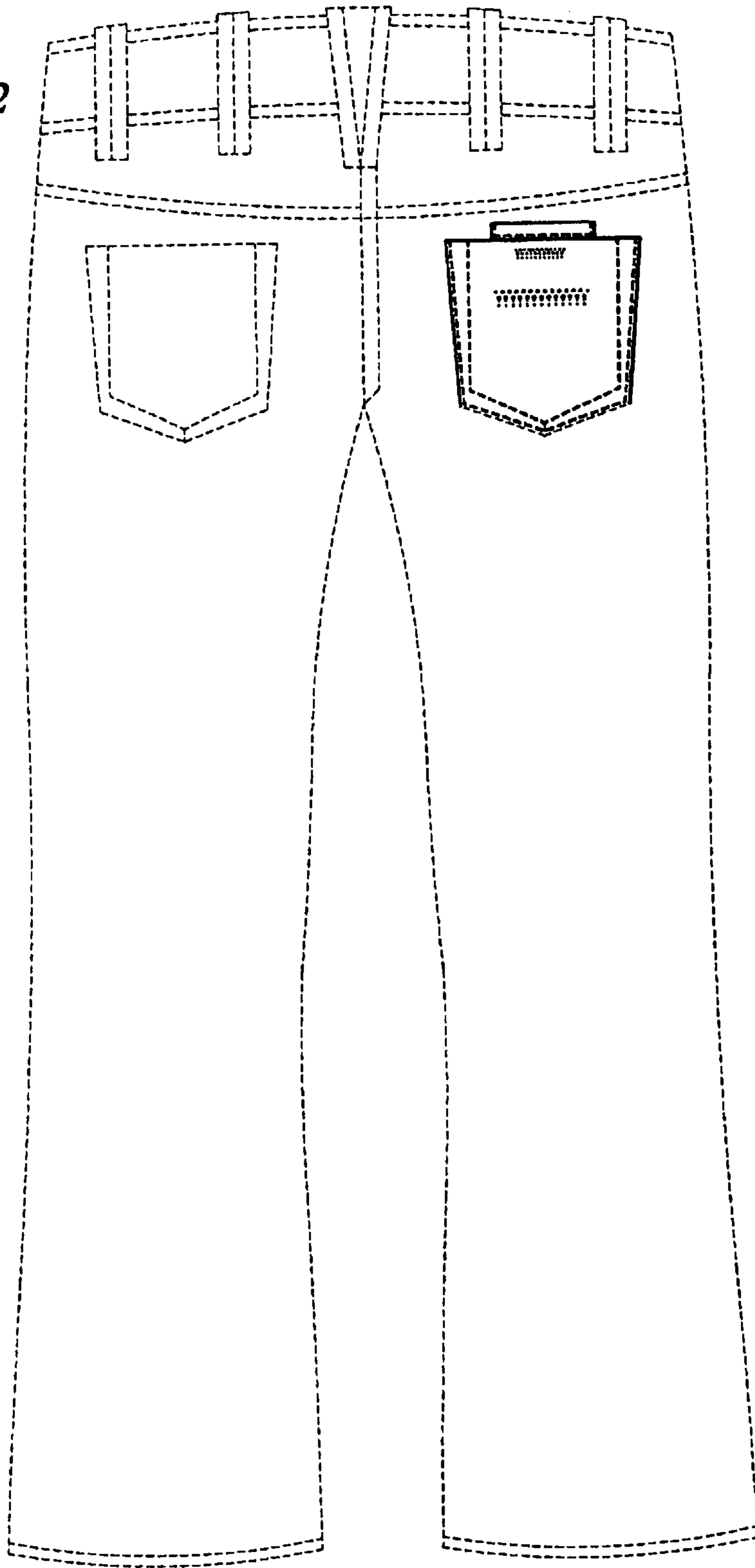

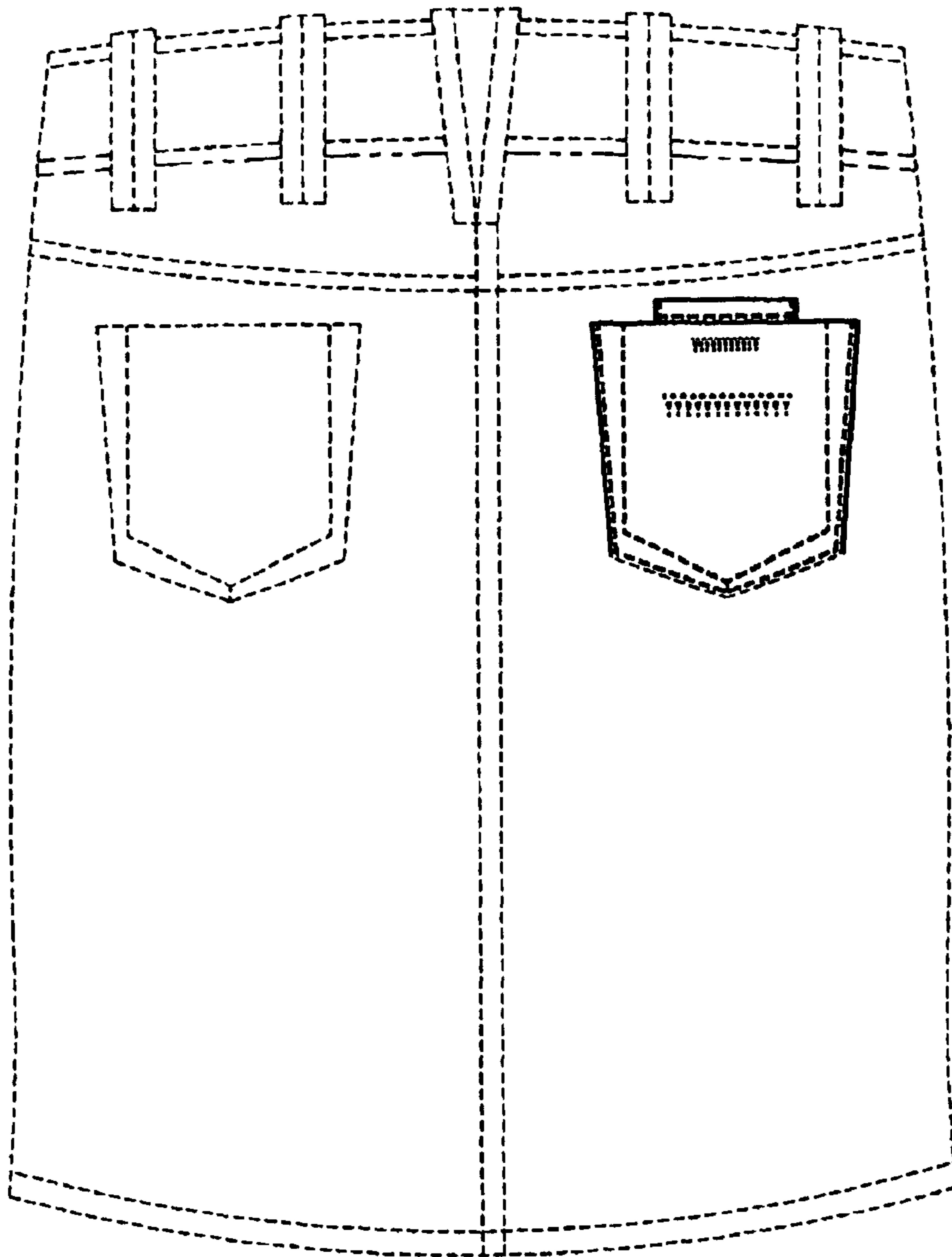

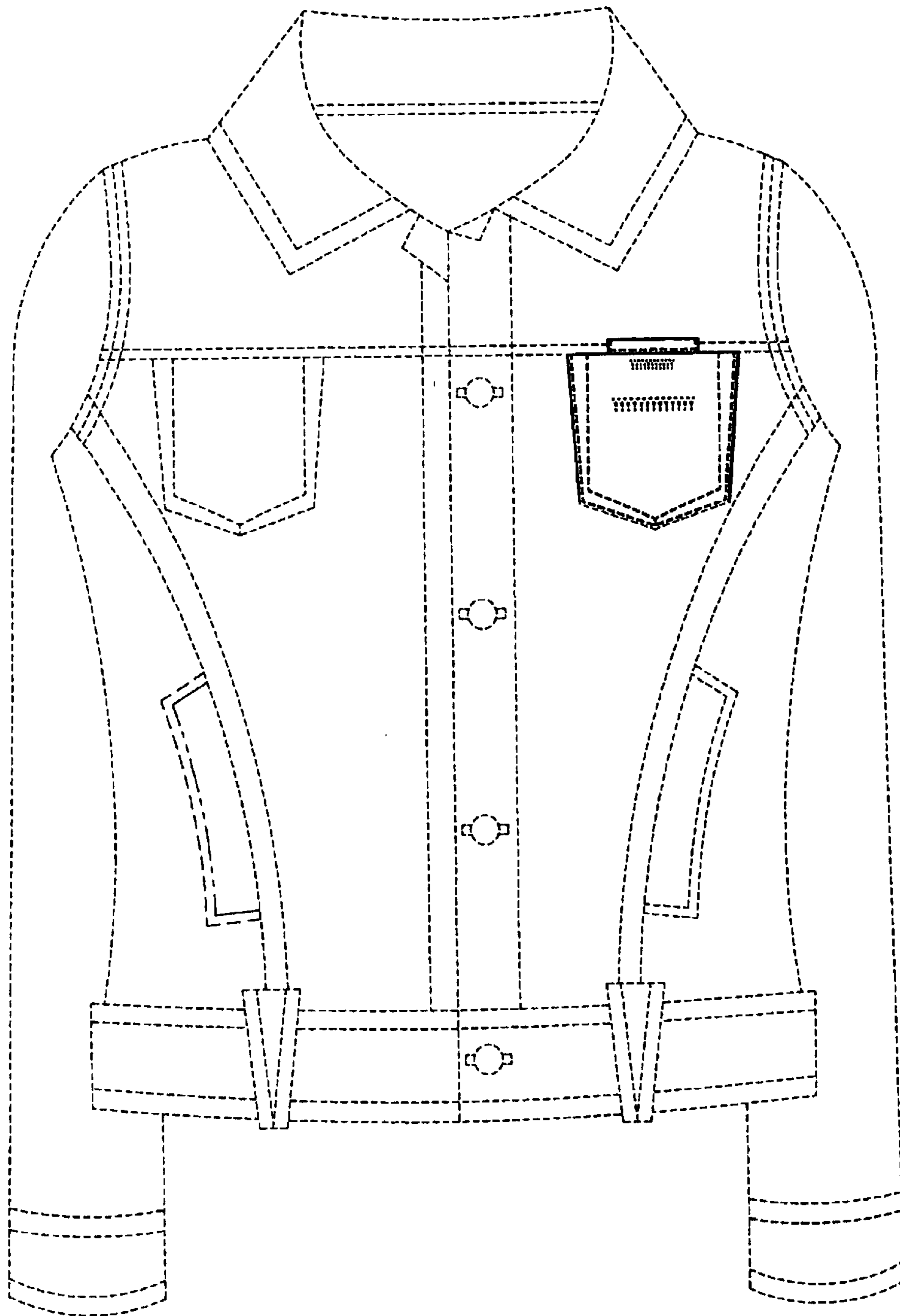
