DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a footwear outsole showing our new design.

FIG. 3 is a left side elevational view thereof.

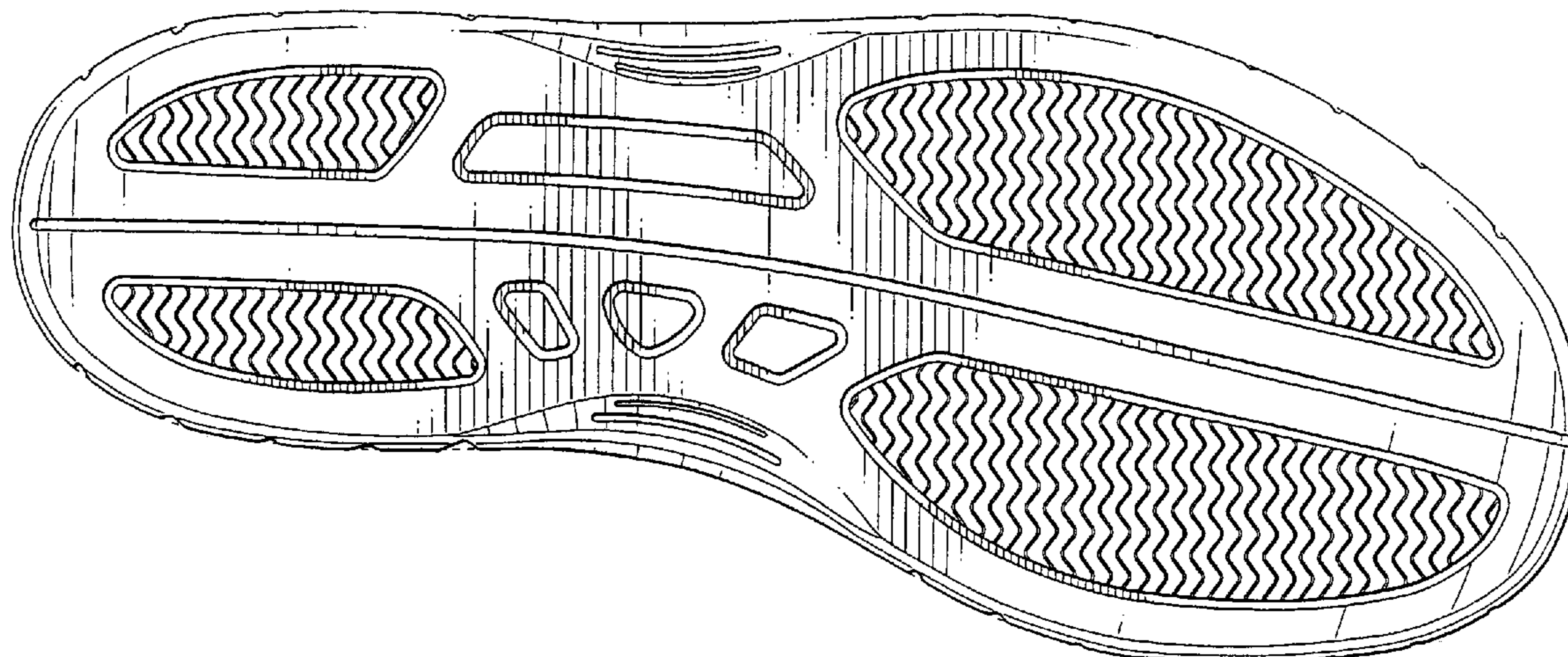
FIG. 4 is a front elevational view thereof.

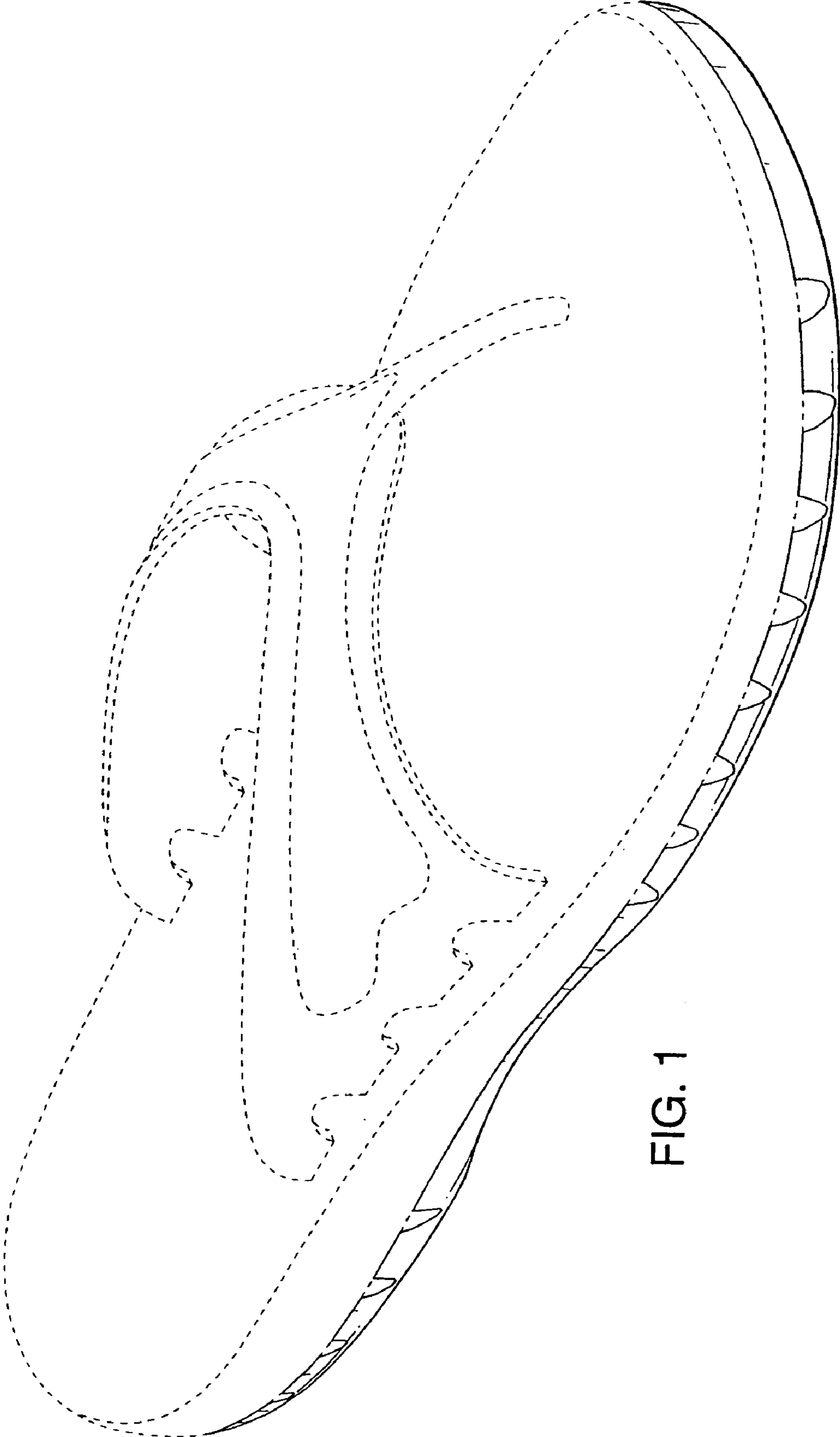

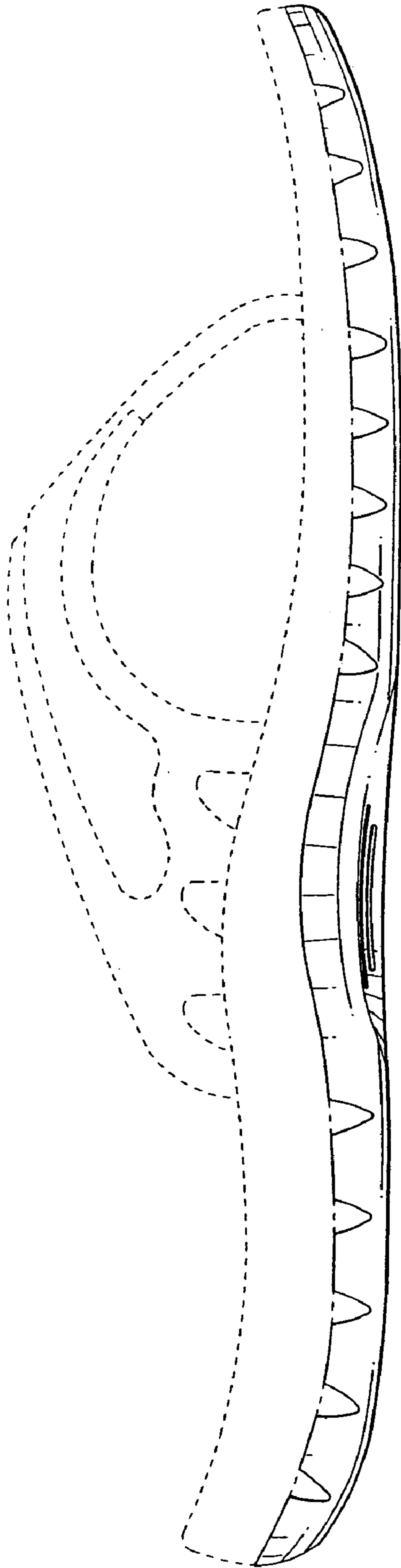

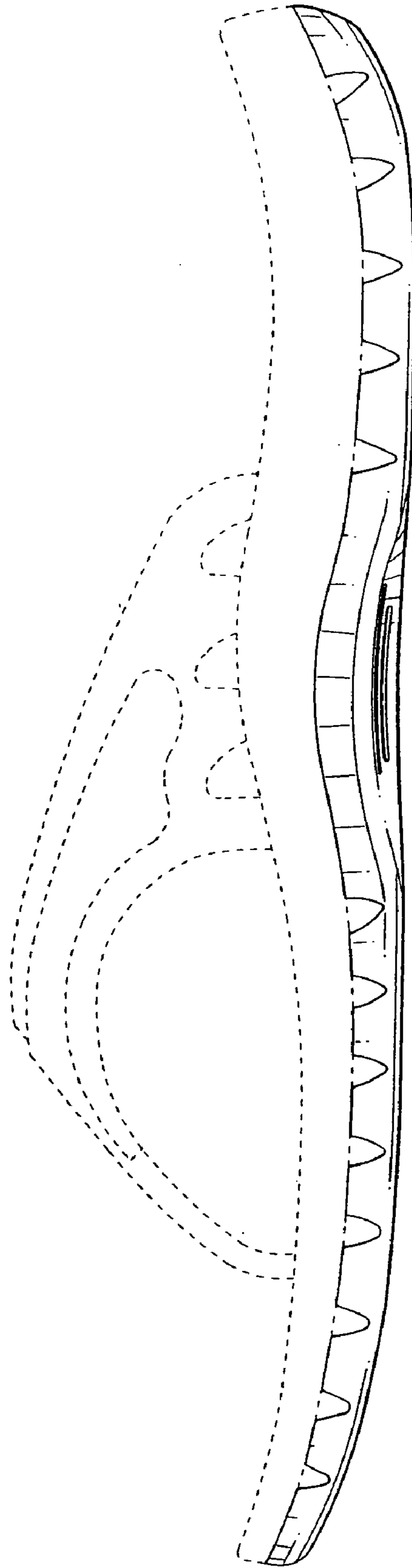

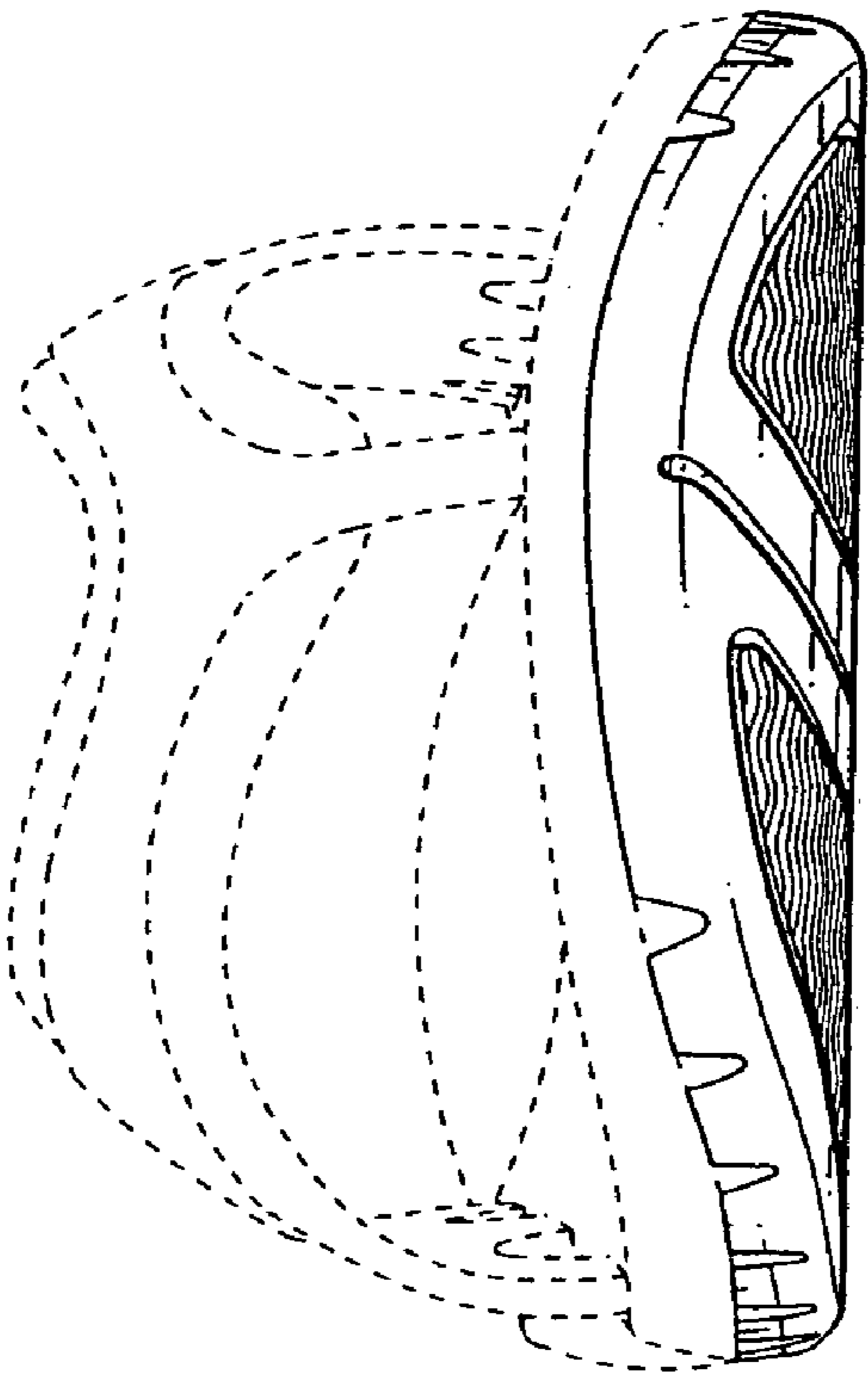

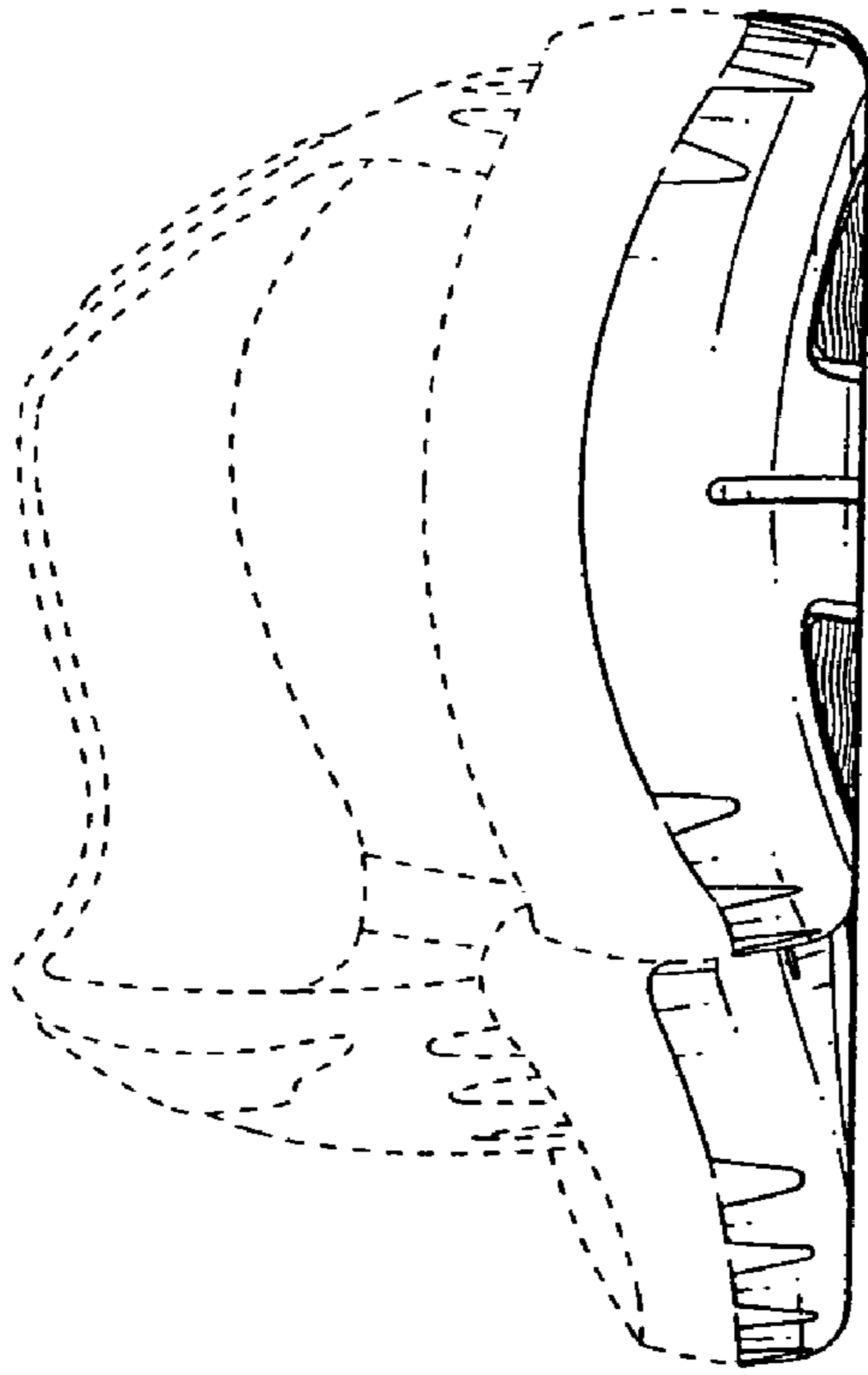

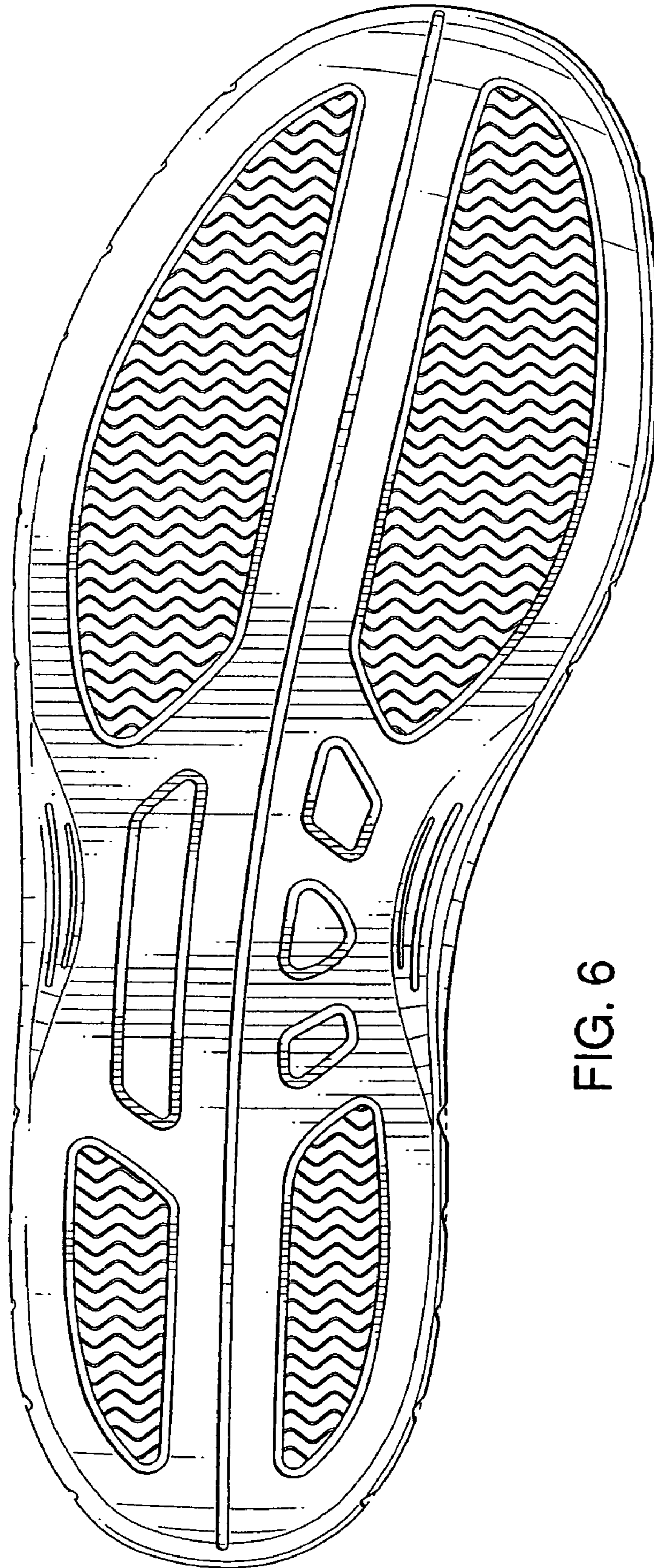
