(57) **CLAIM**

The ornamental design for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my footwear design;

FIG. 2 is a left side view of the footwear shown in FIG. 1;

FIG. 3 is a right side view of the footwear shown in FIG. 1;

FIG. 4 is a front view of the footwear shown in FIG. 1;

FIG. 5 is a rear view of the footwear shown in FIG. 1;

FIG. 6 is a top view of the footwear shown in FIG. 1;

FIG. 7 is a front perspective view of an alternative embodiment of the footwear shown in FIG. 1;

FIG. 8 is left side view of the alternative embodiment of the footwear shown in FIG. 7;

FIG. 9 is a right side view of the alternative embodiment of the footwear shown in FIG. 7;

FIG. 10 is a front view of the alternative embodiment of the footwear shown in FIG. 7;

FIG. 11 is a rear view of the alternative embodiment of the footwear shown in FIG. 7; and,

FIG. 12 is a top view of the alternative embodiment of the footwear shown in FIG. 7.

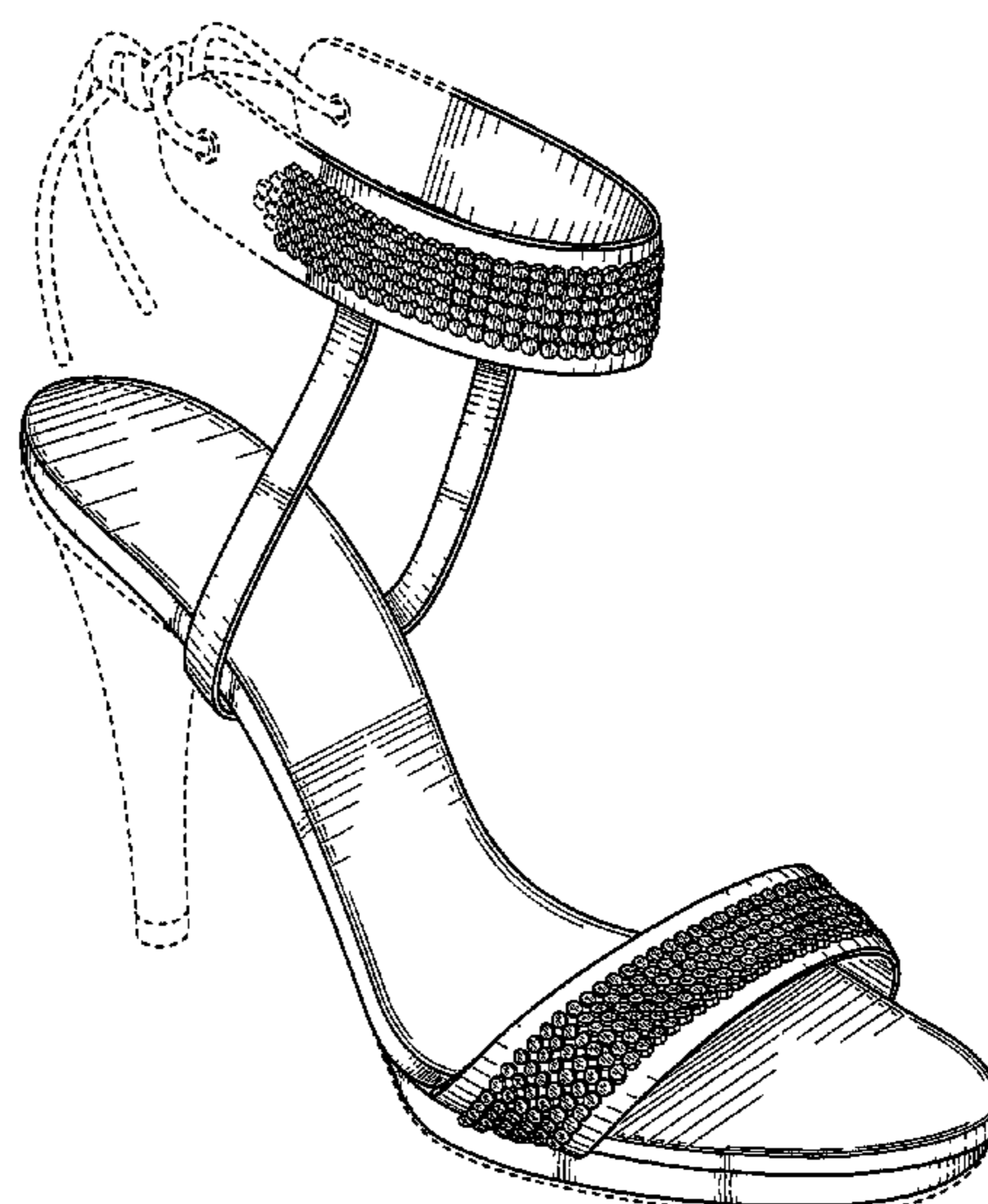
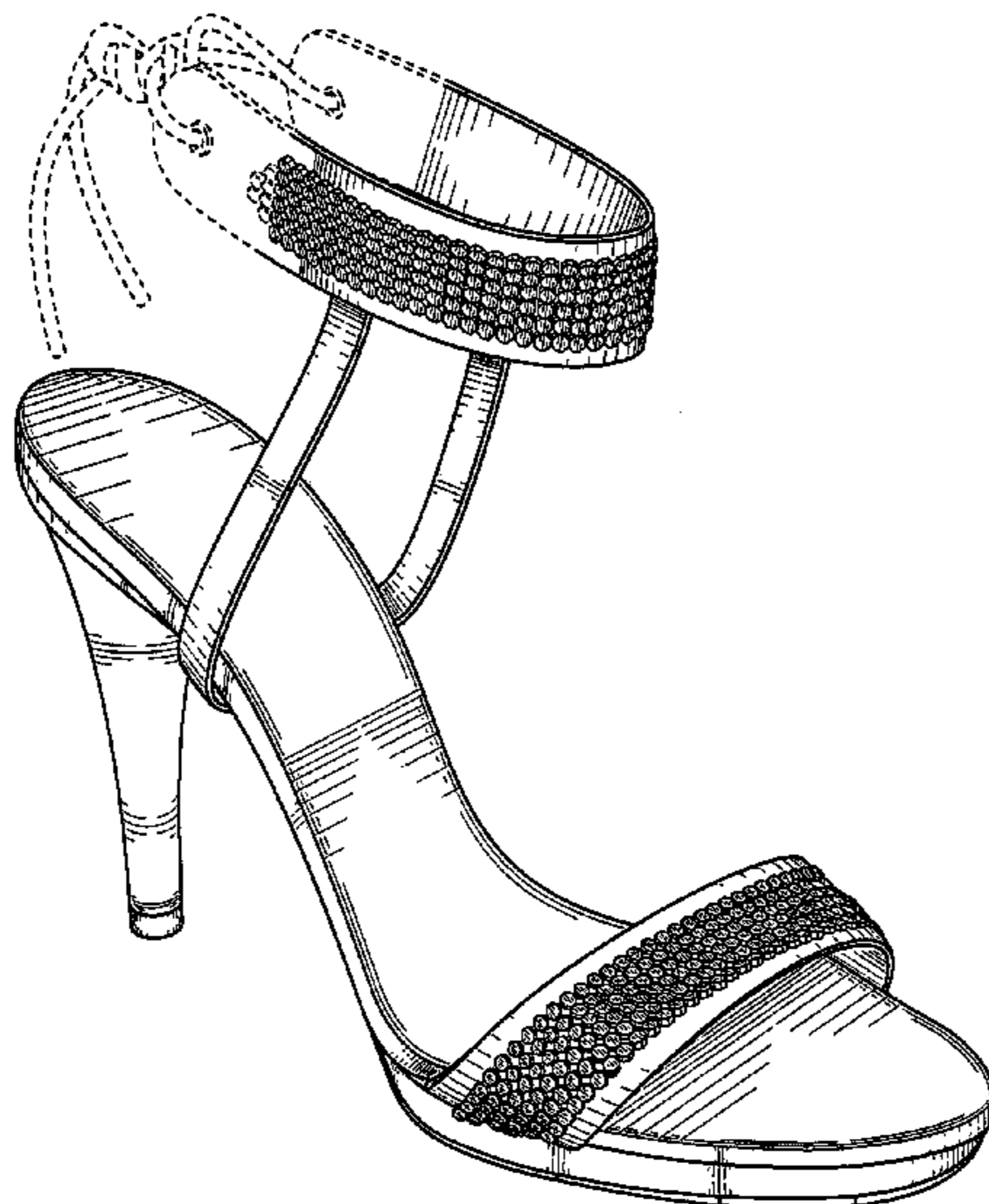

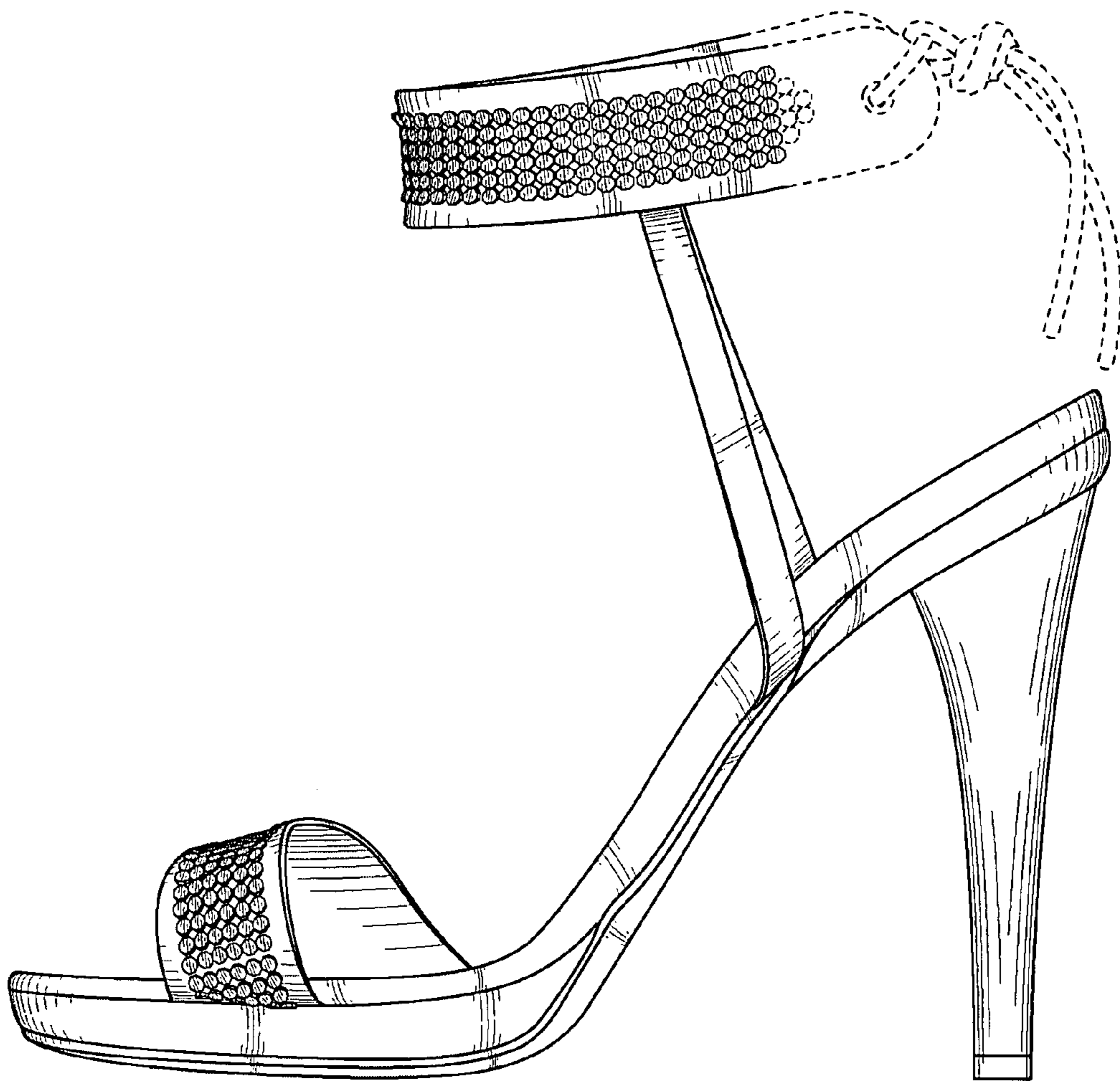

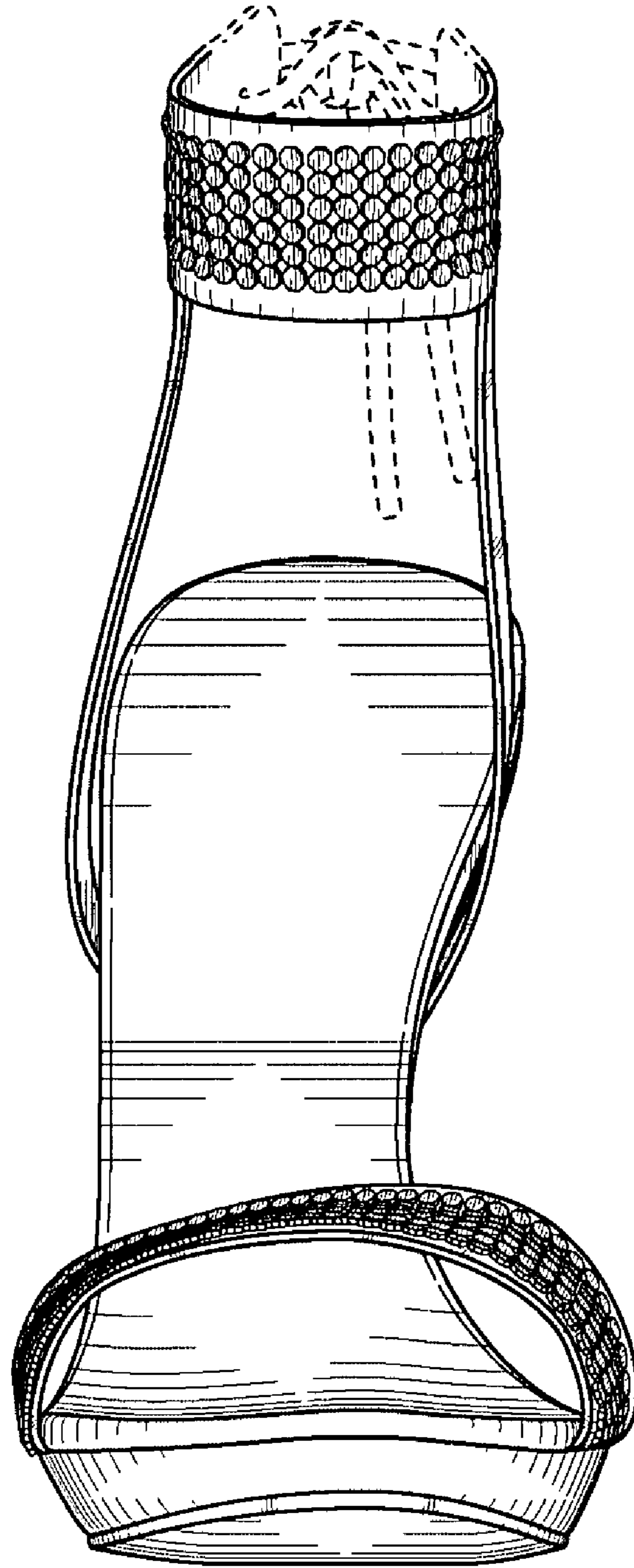

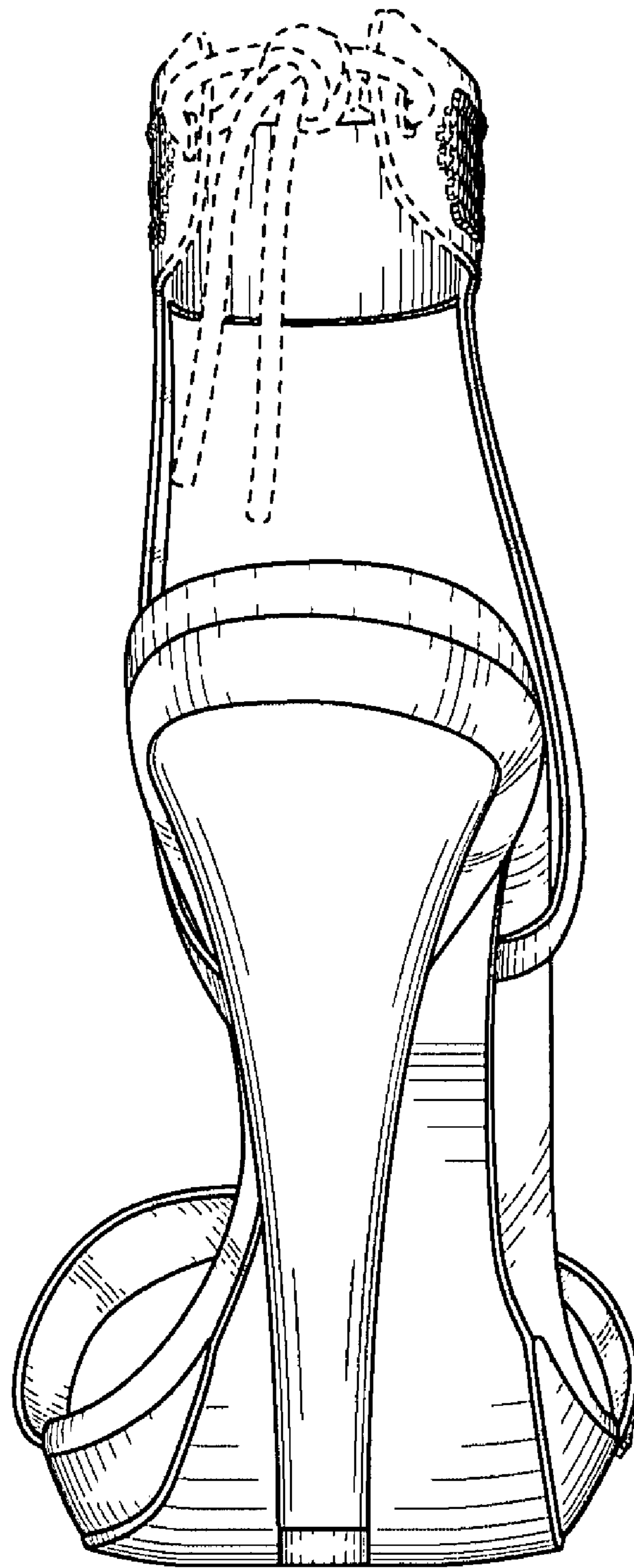

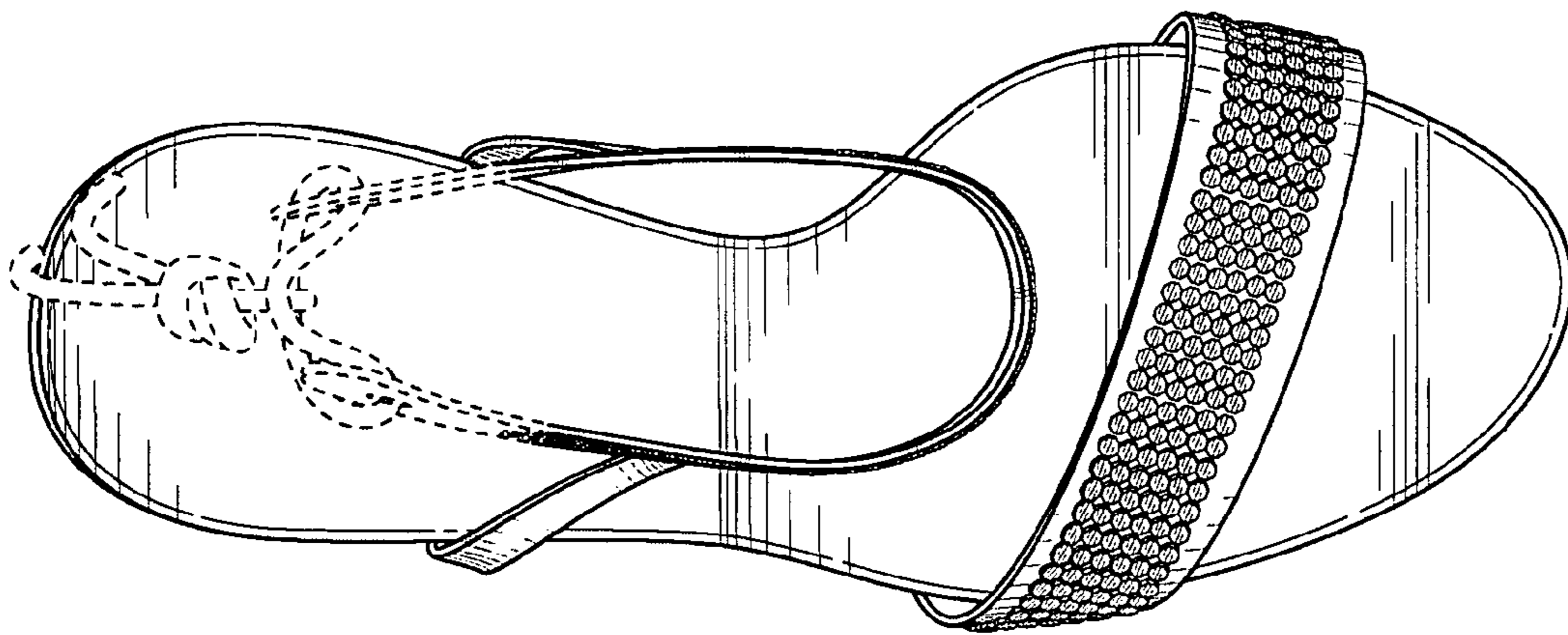

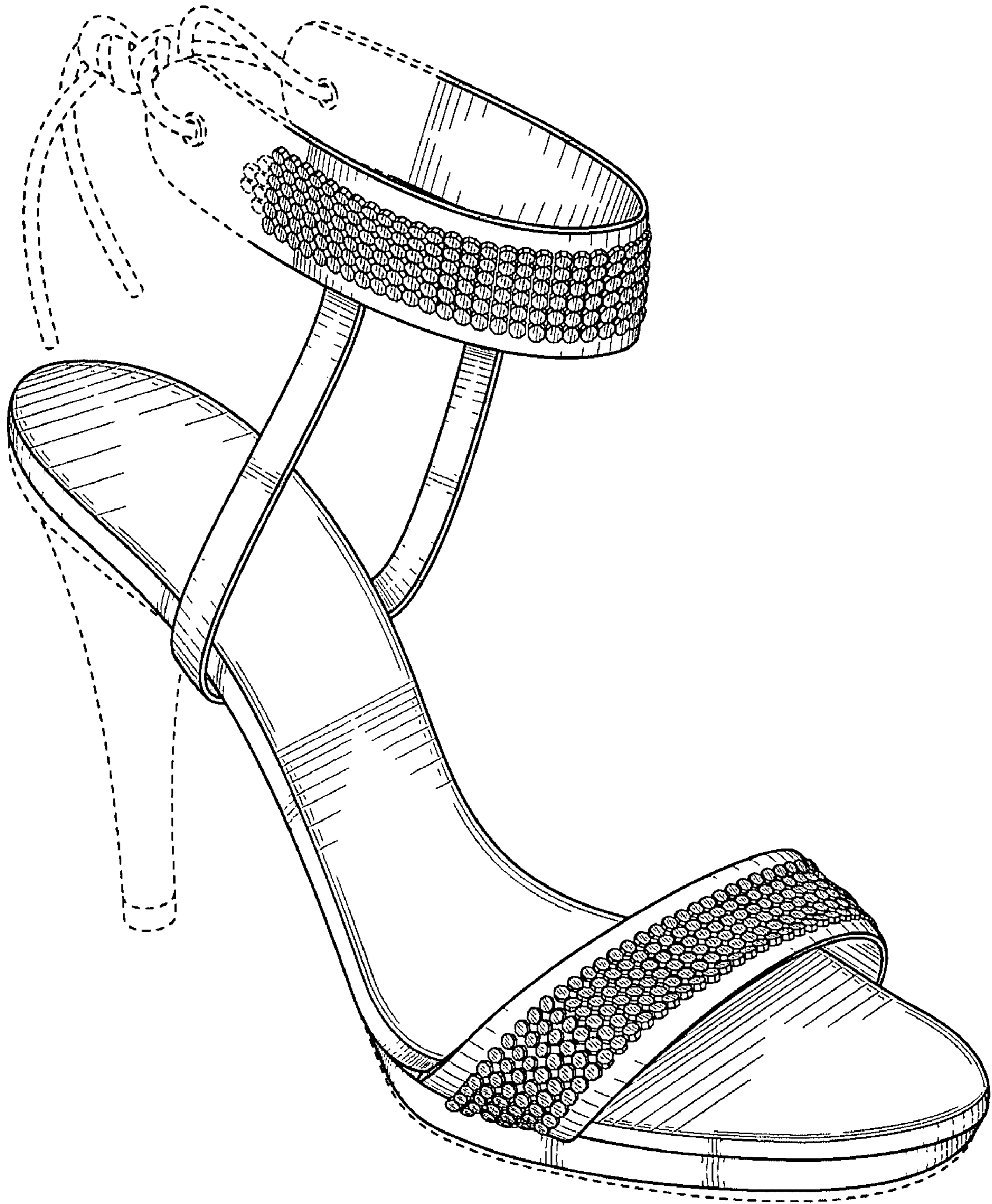

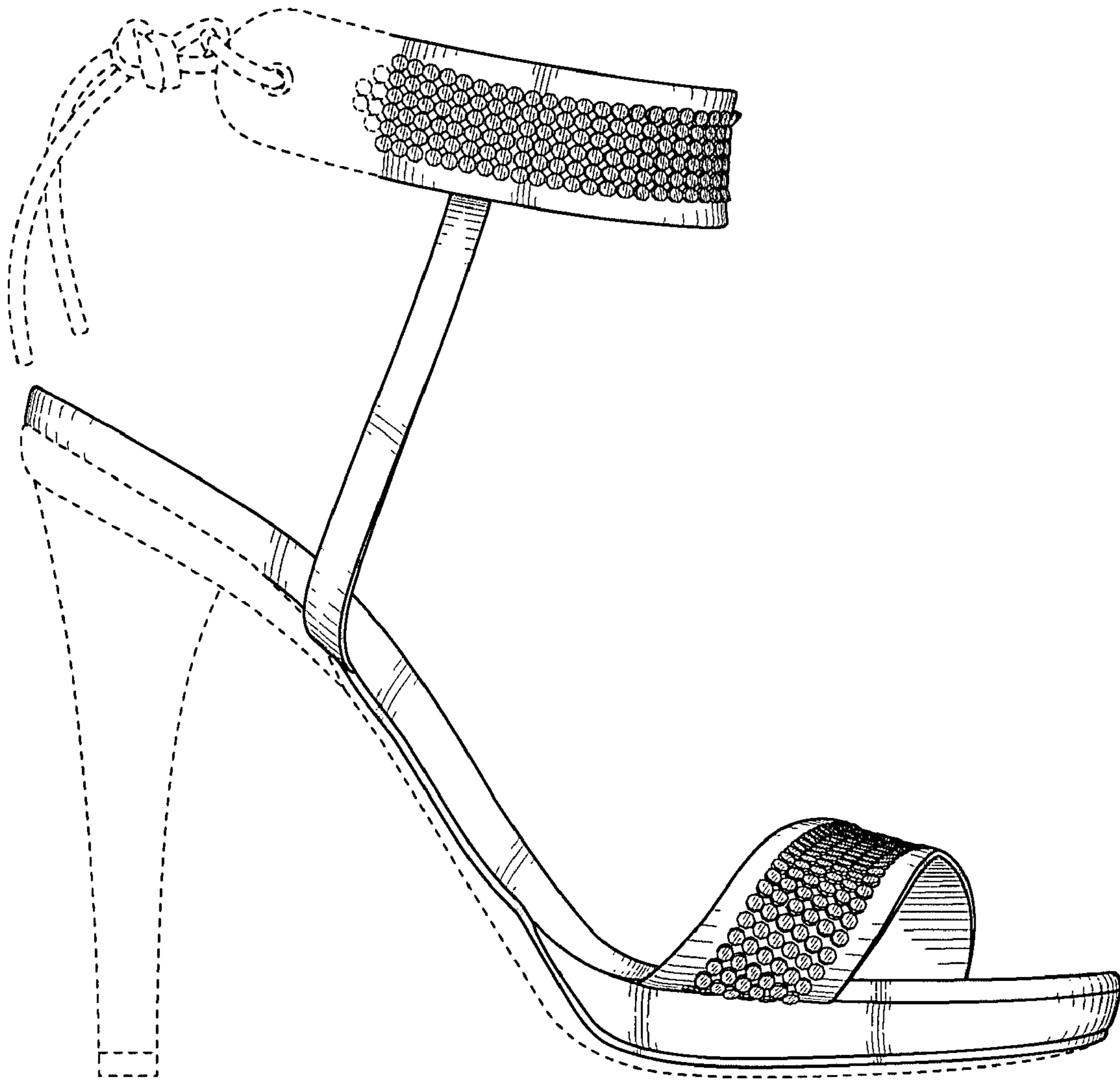

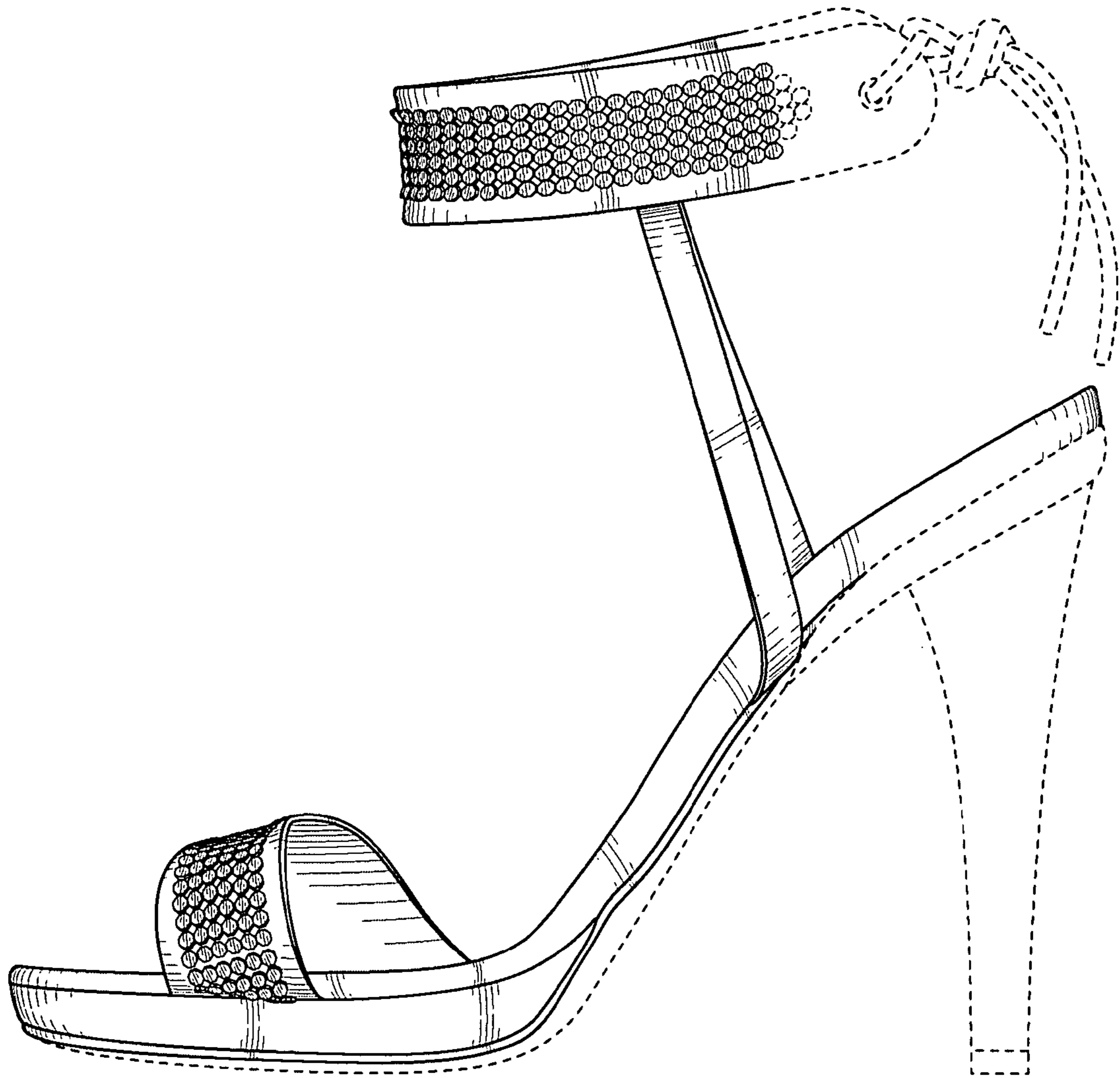

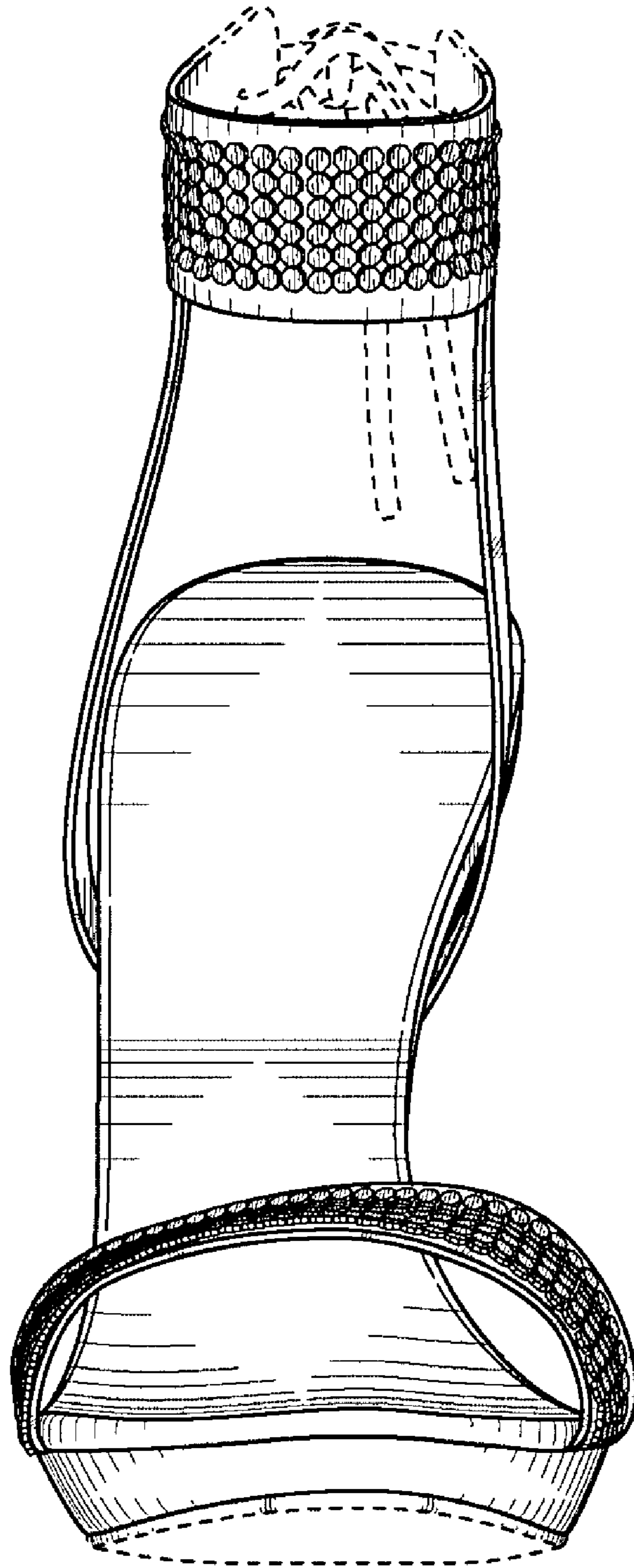

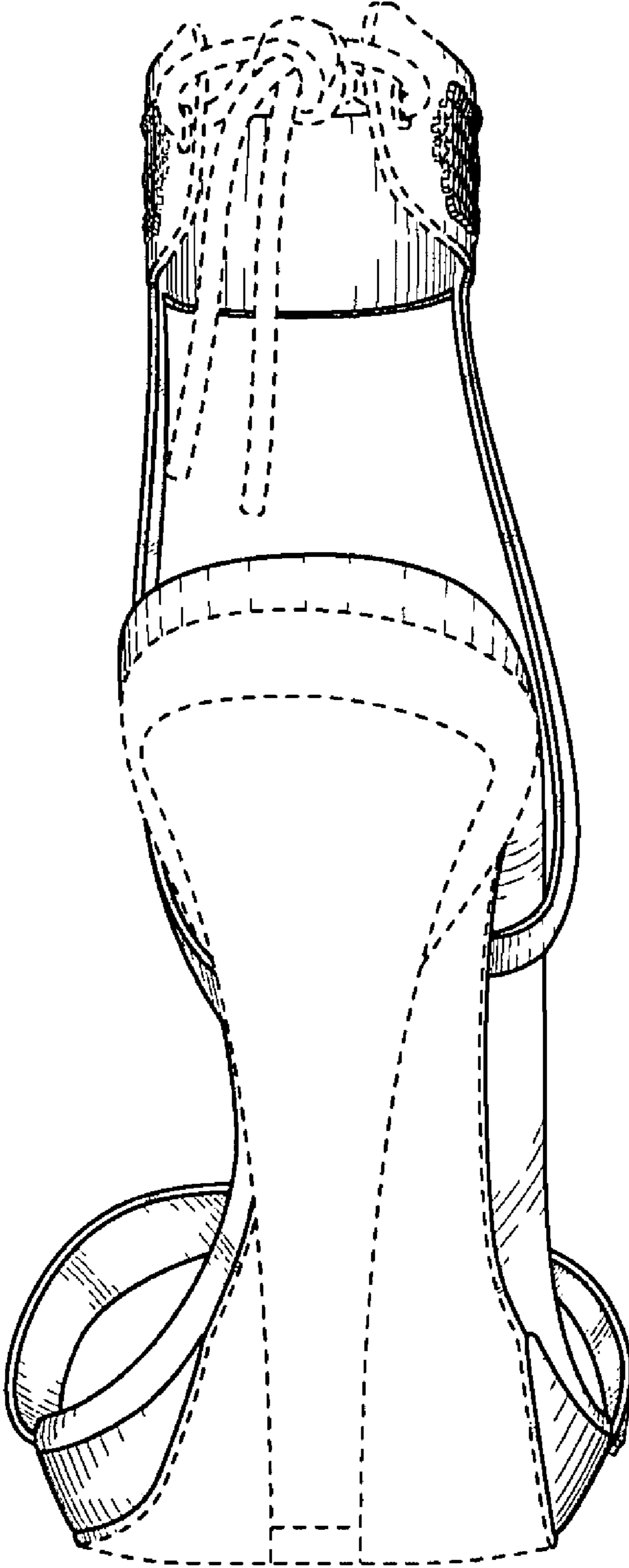

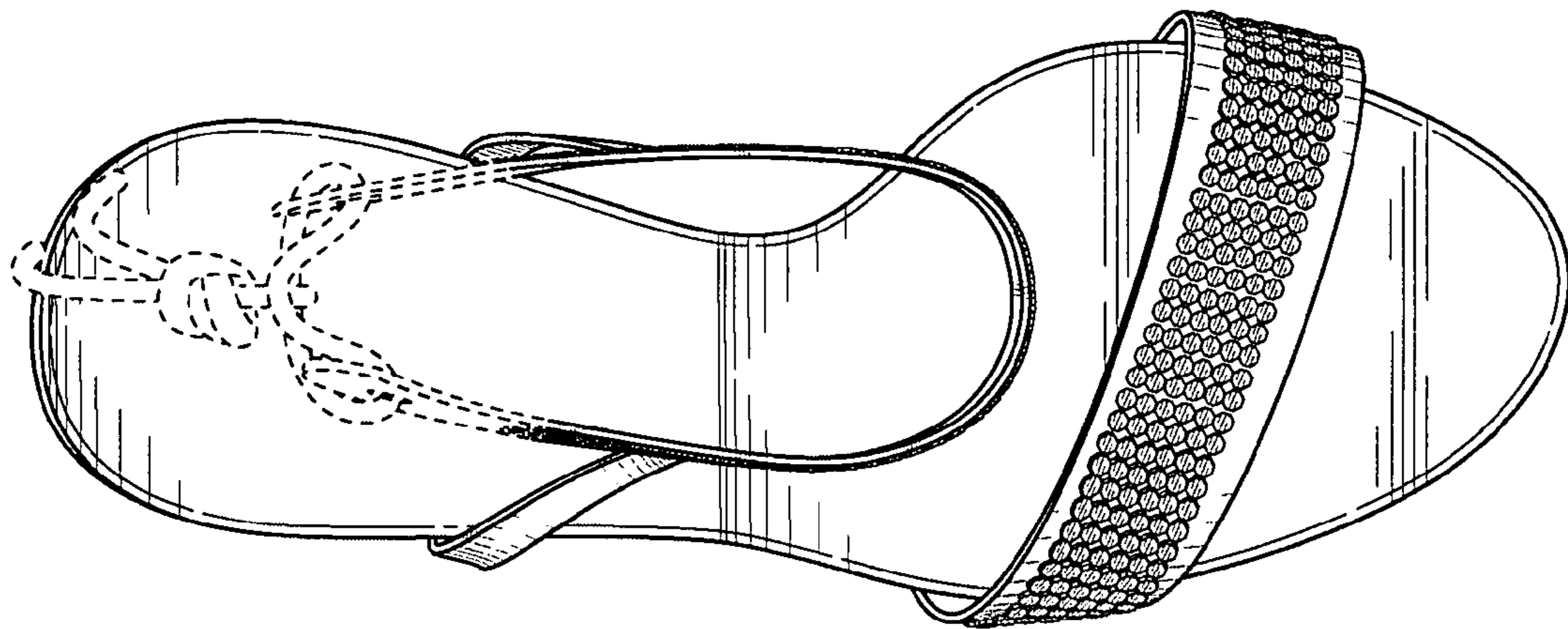
