**DESCRIPTION**

FIG. 1 is a front, left perspective view of an embodiment of a storage box showing my new design;

FIG. 3 is a rear elevational view thereof, the front elevational view thereof being a mirror image thereof;

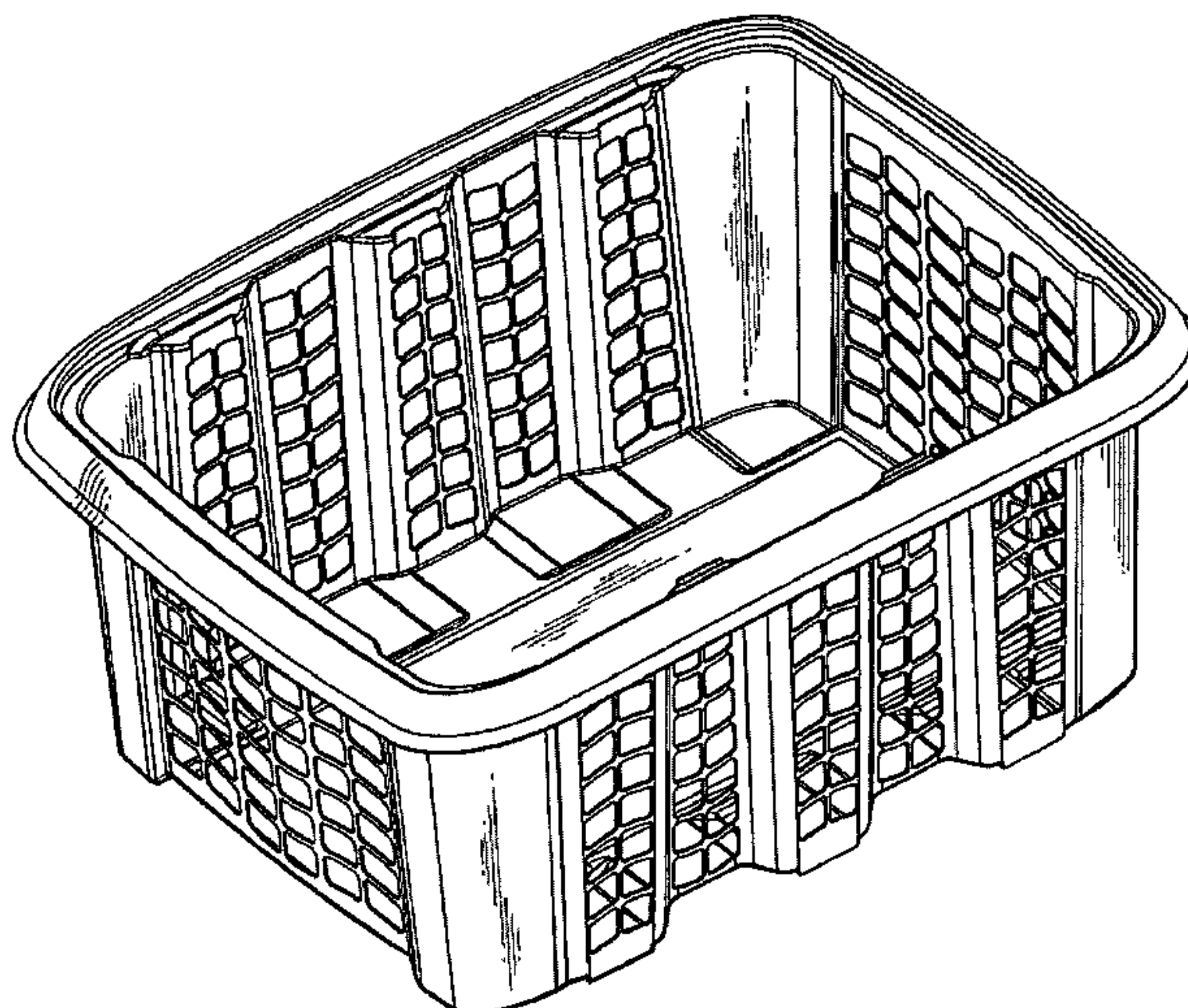
FIG. 4 is a bottom plan view thereof;

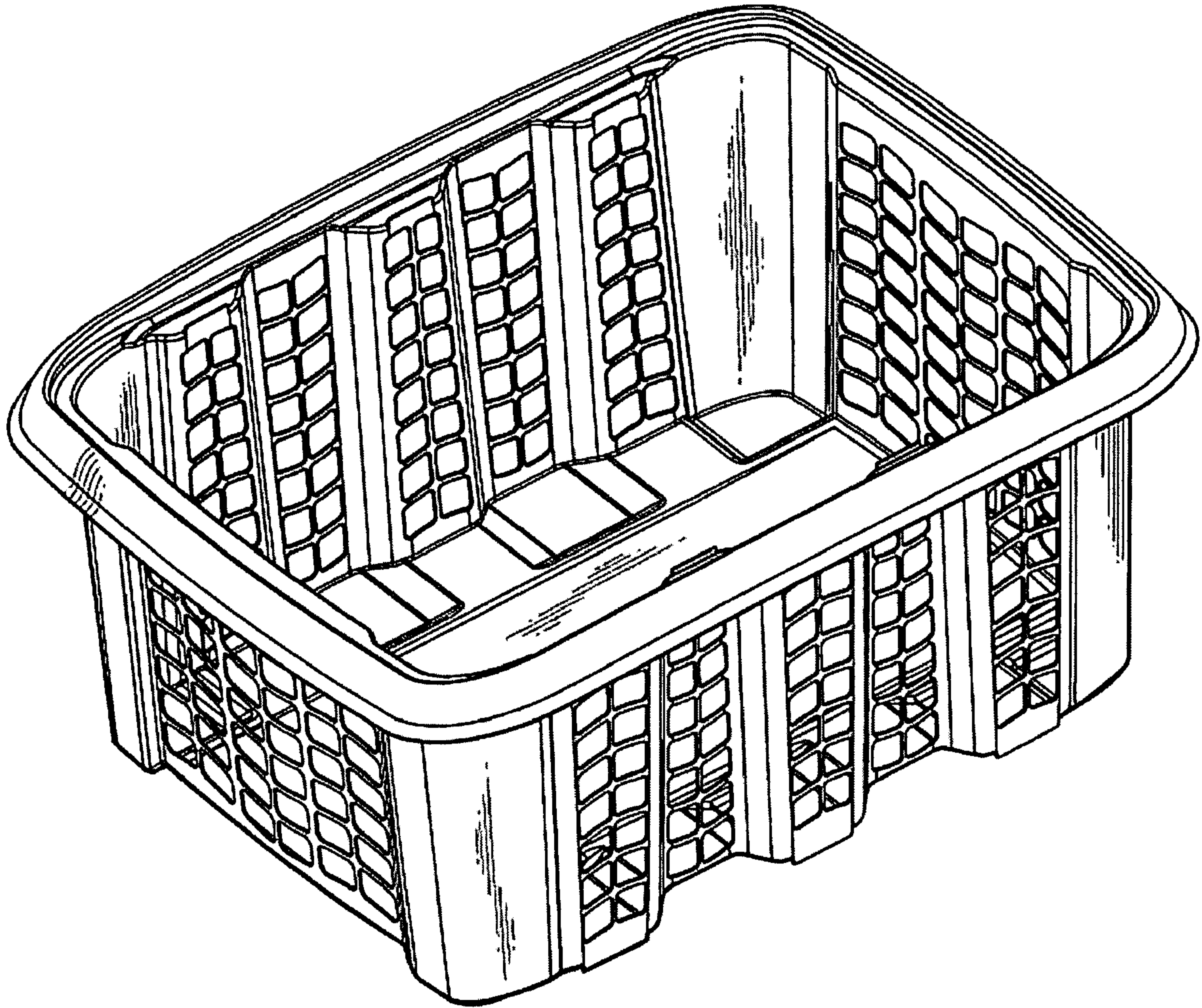

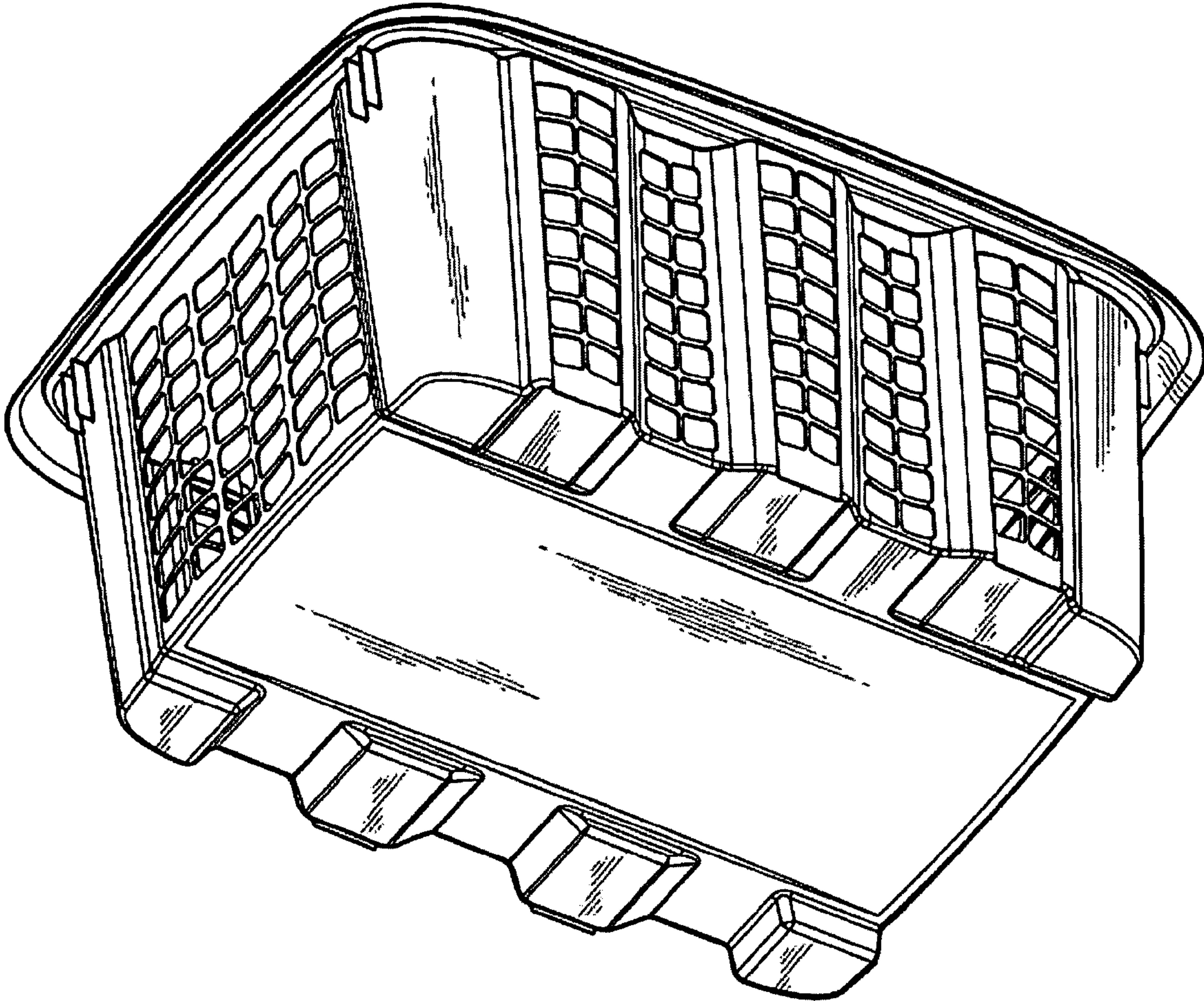

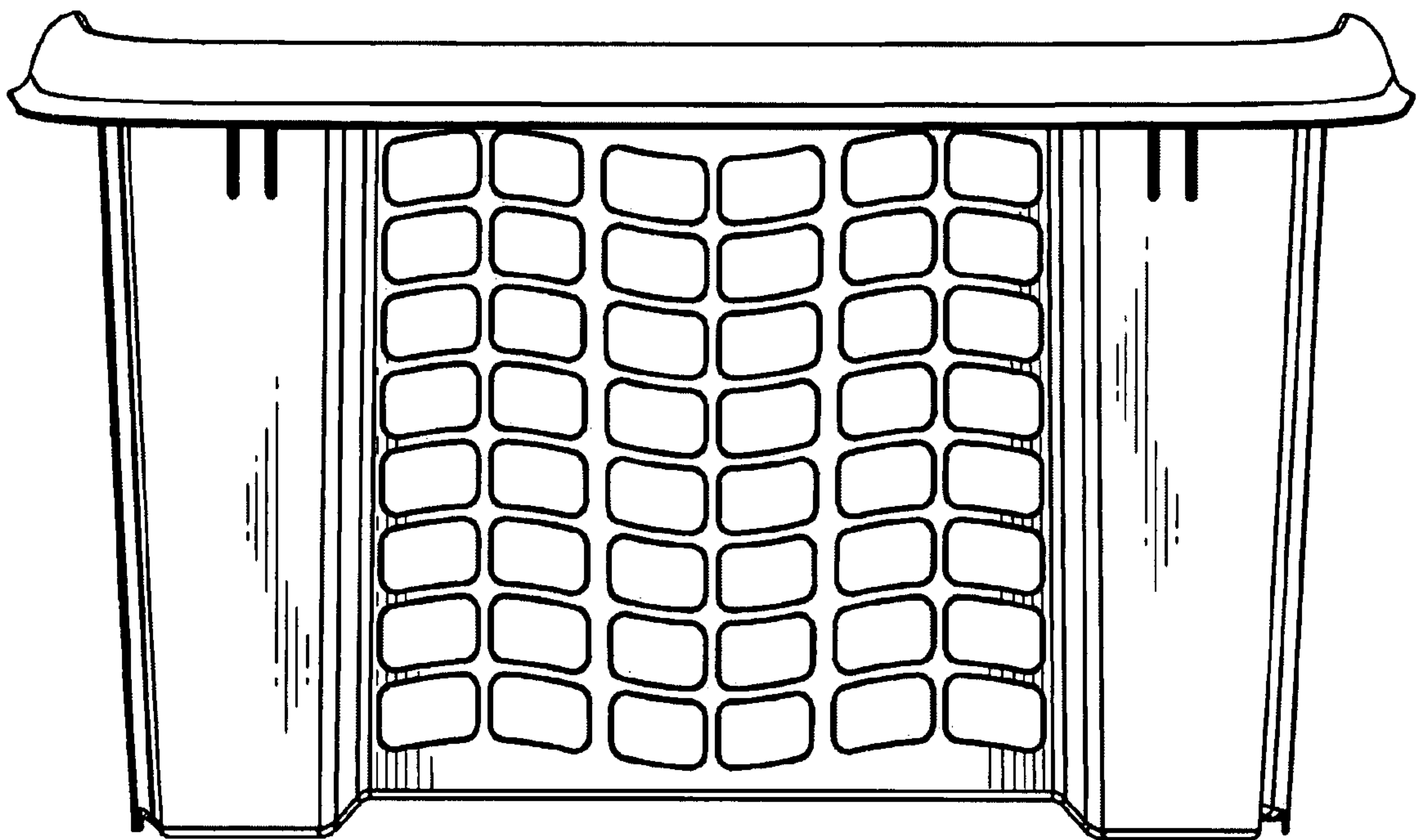

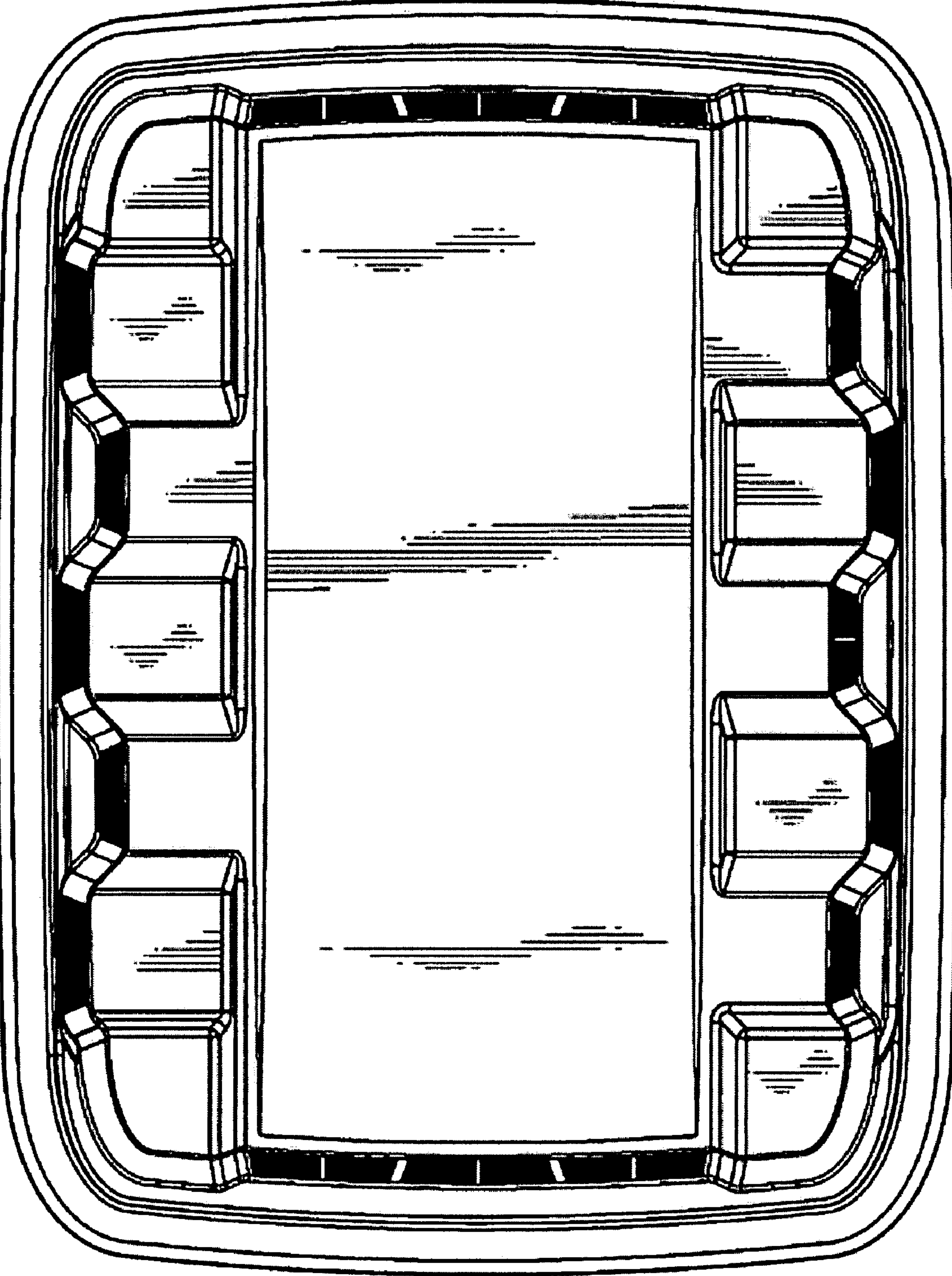

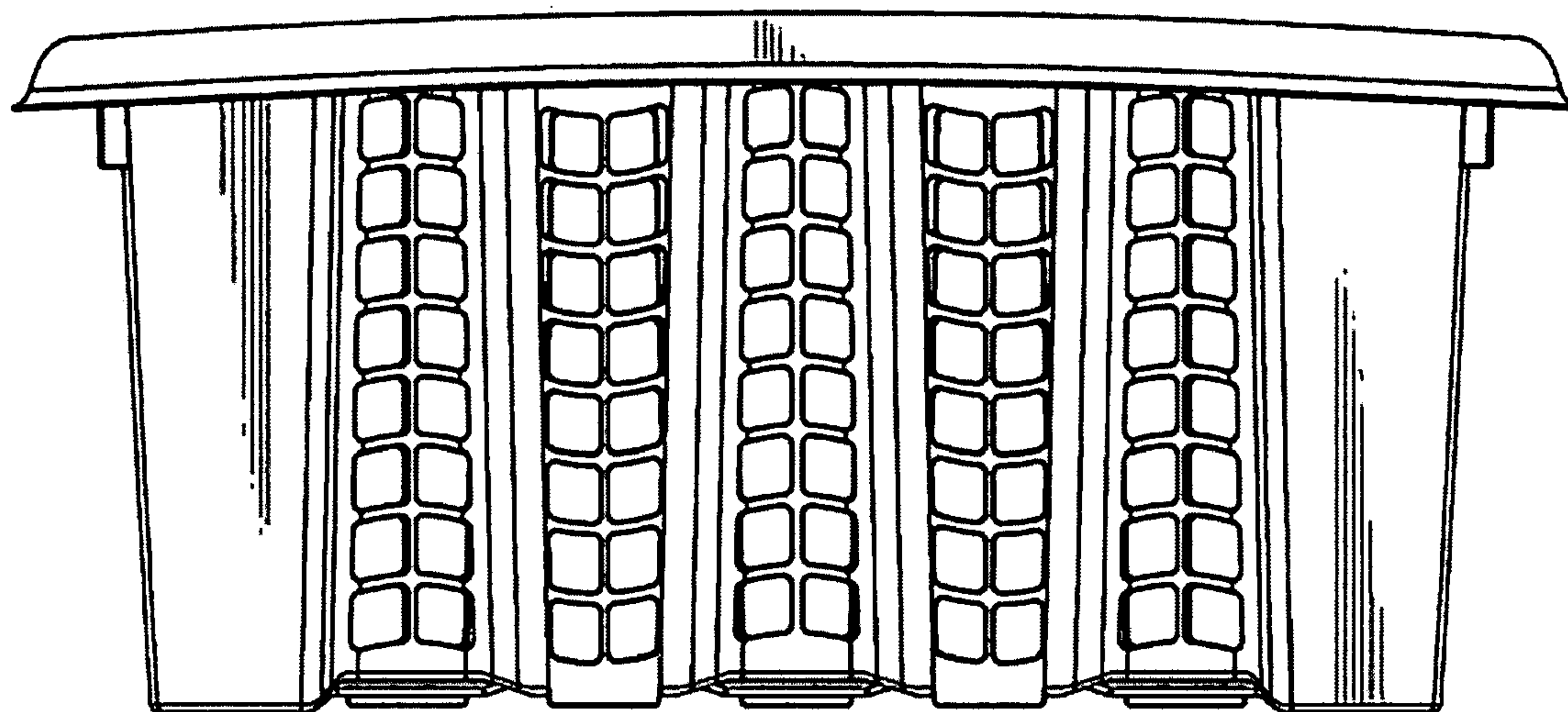

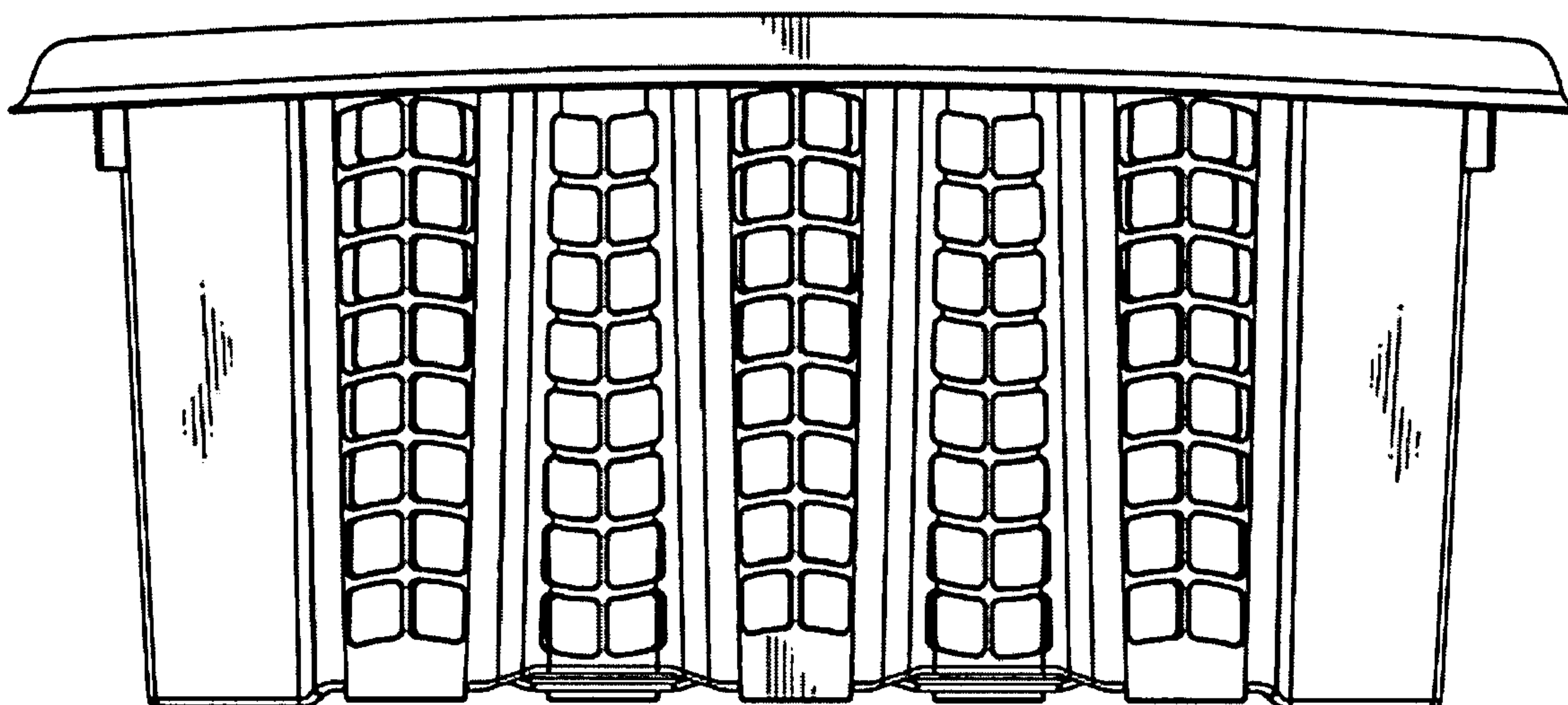

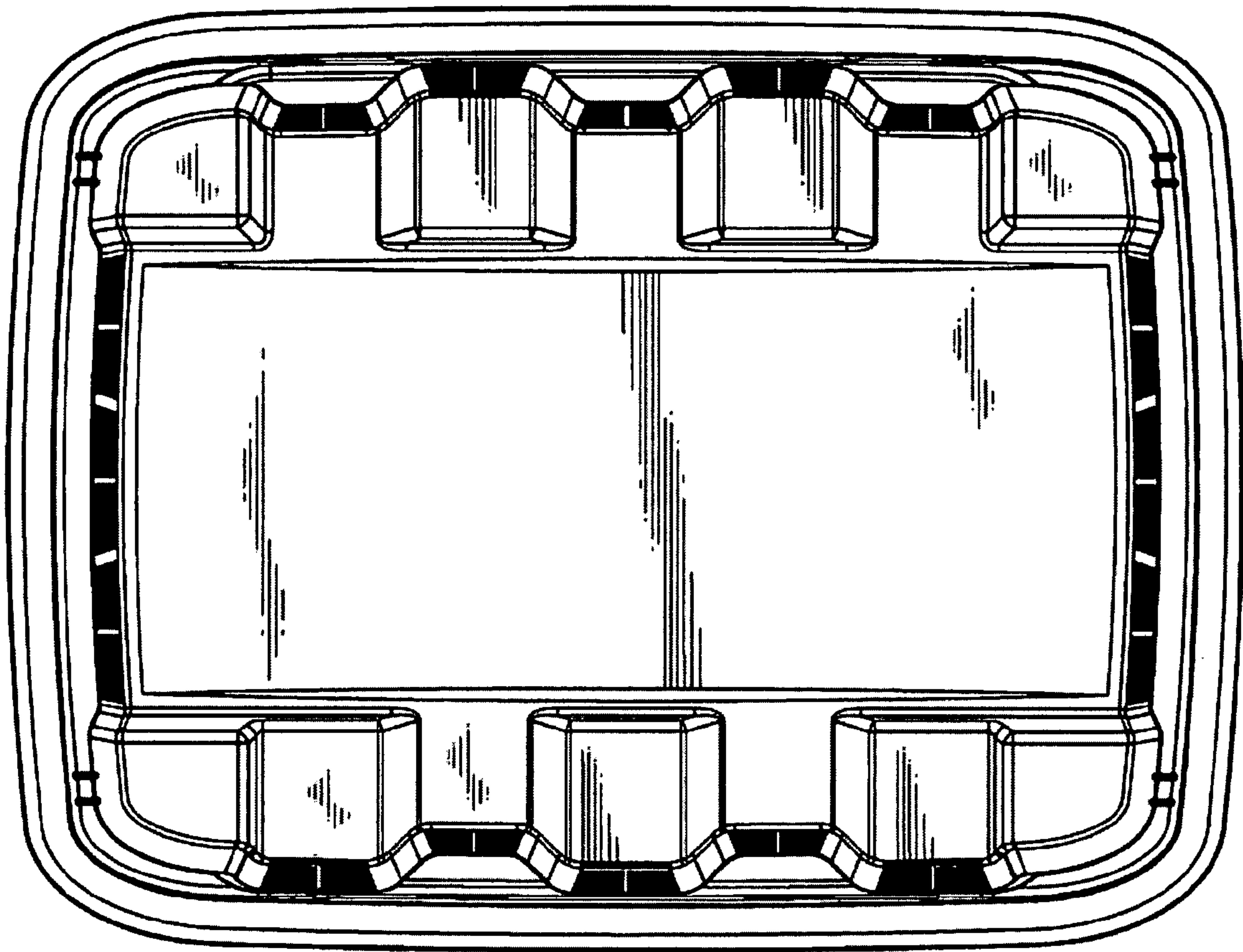
