FIG. 3 is a top plan view;

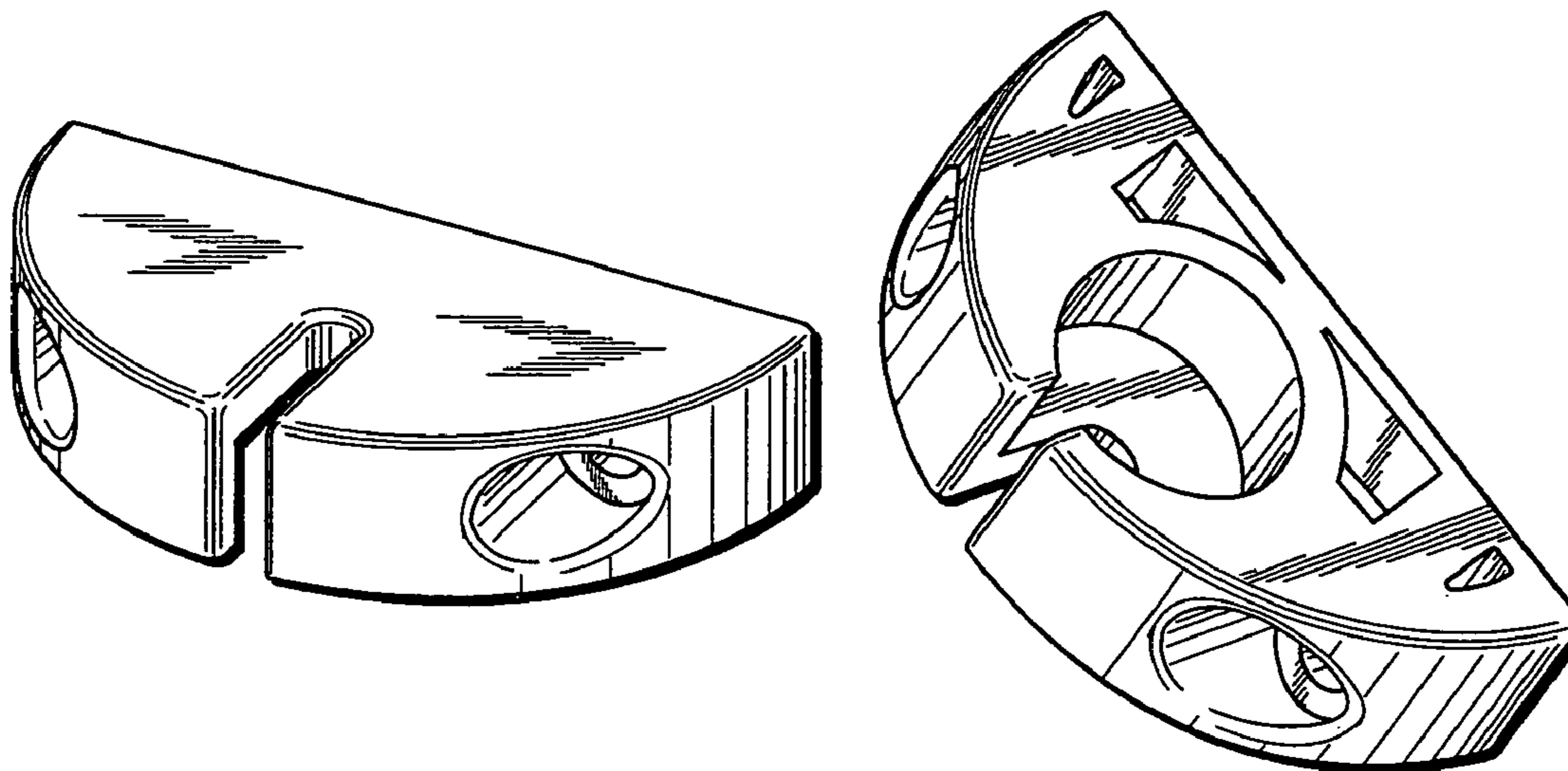
FIG. 4 is a front view;

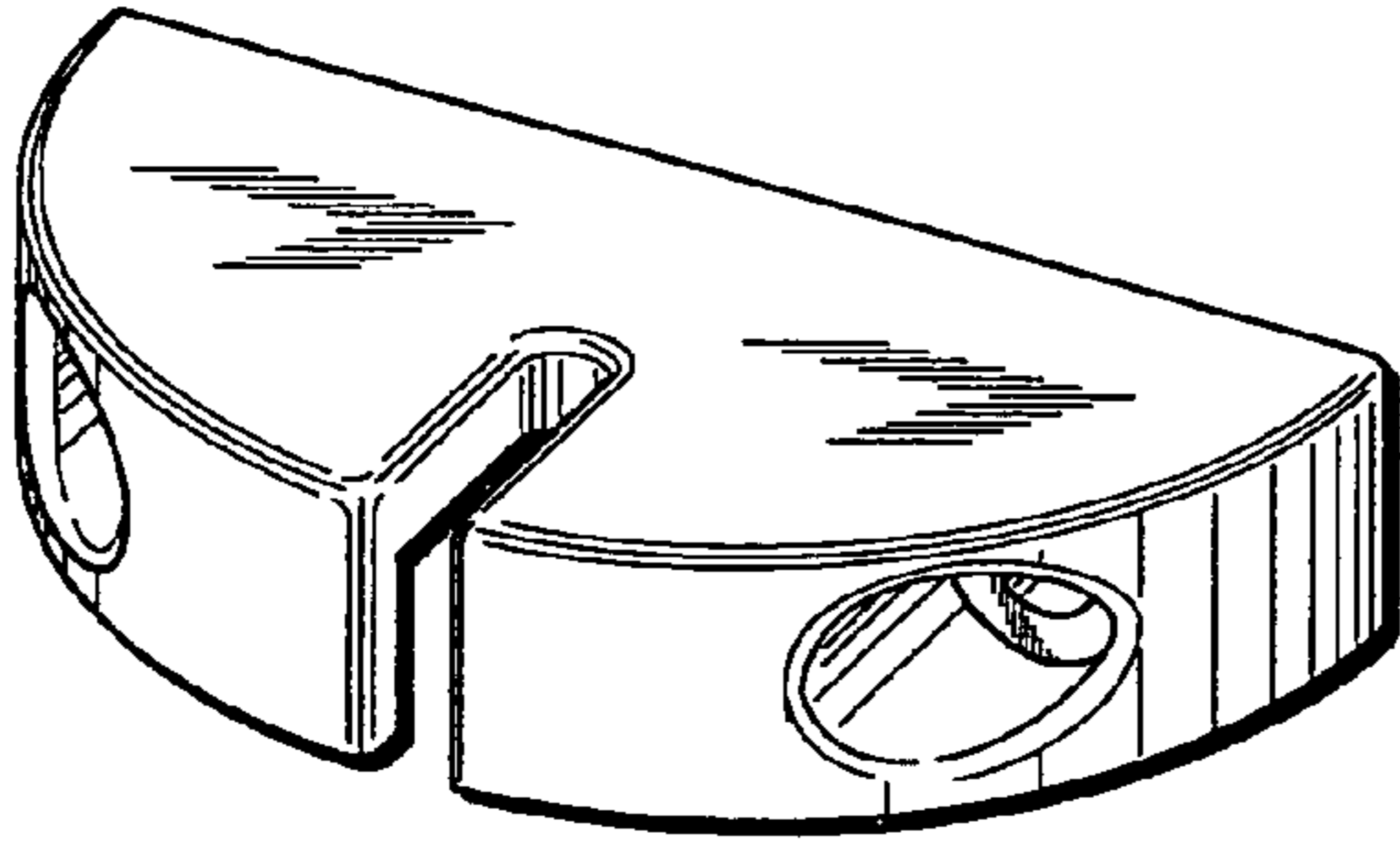
FIG. 5 is a side view;

FIG. 6 is a bottom plan view; and,

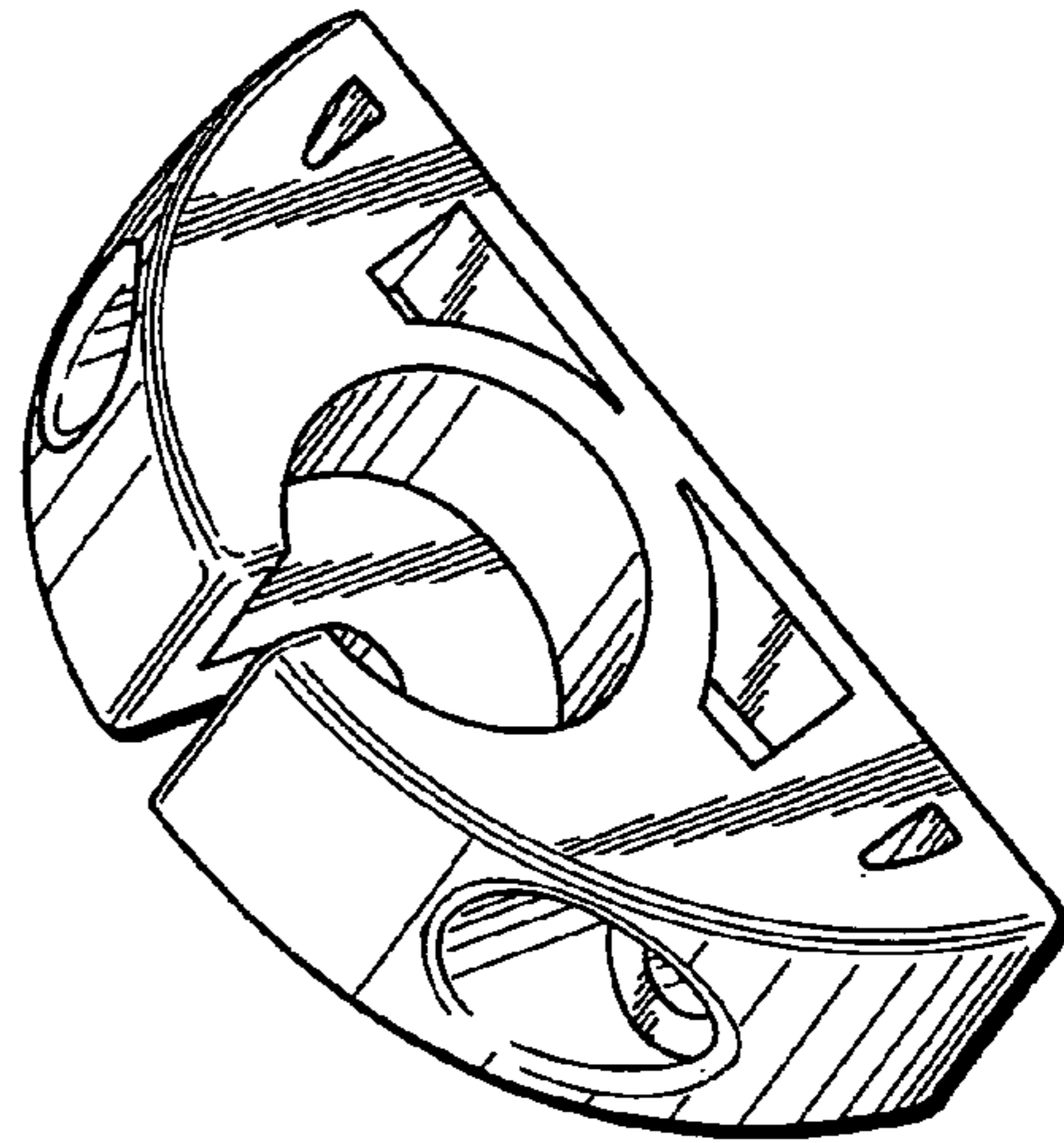
FIG. 7 is a rear view.

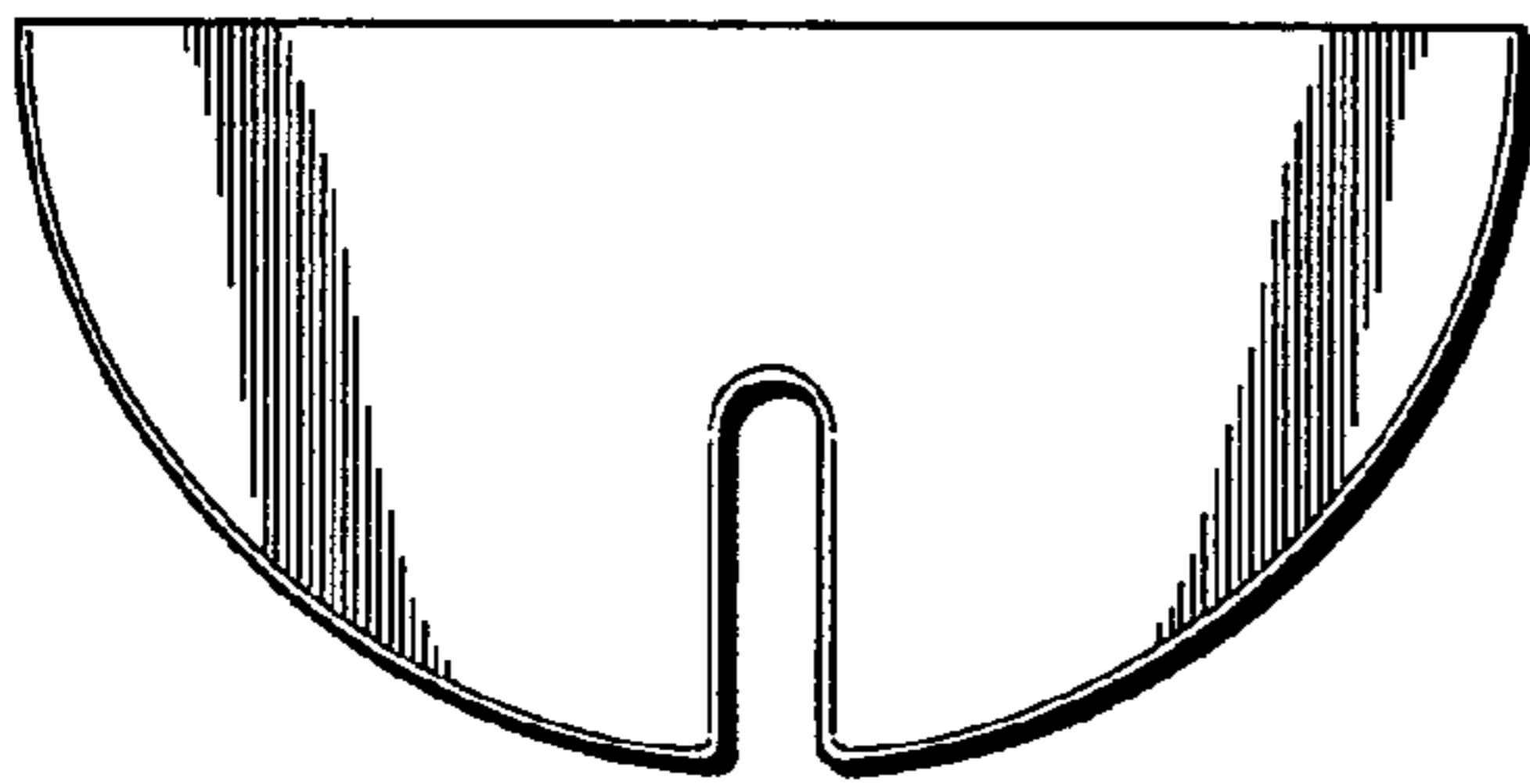




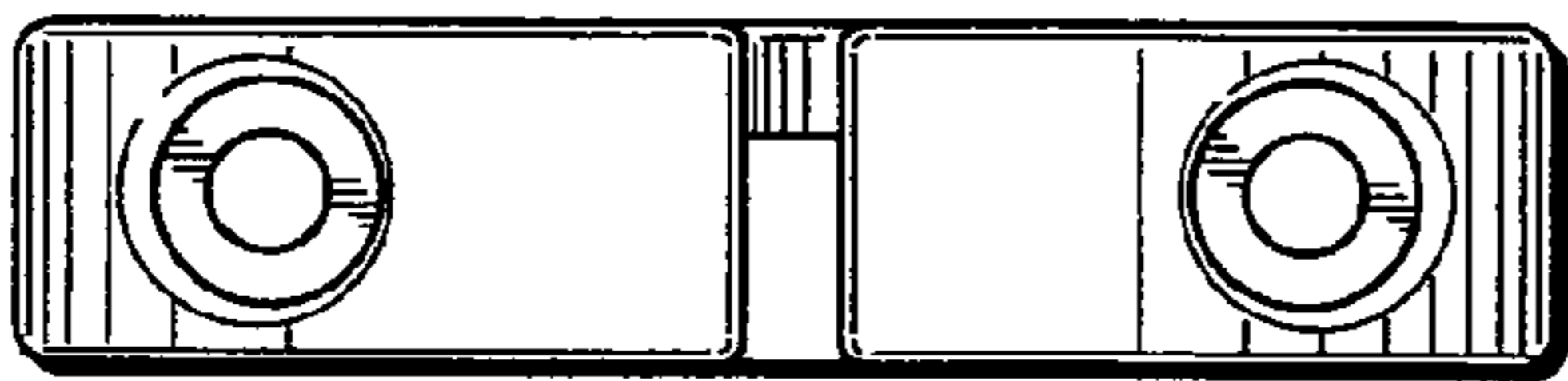

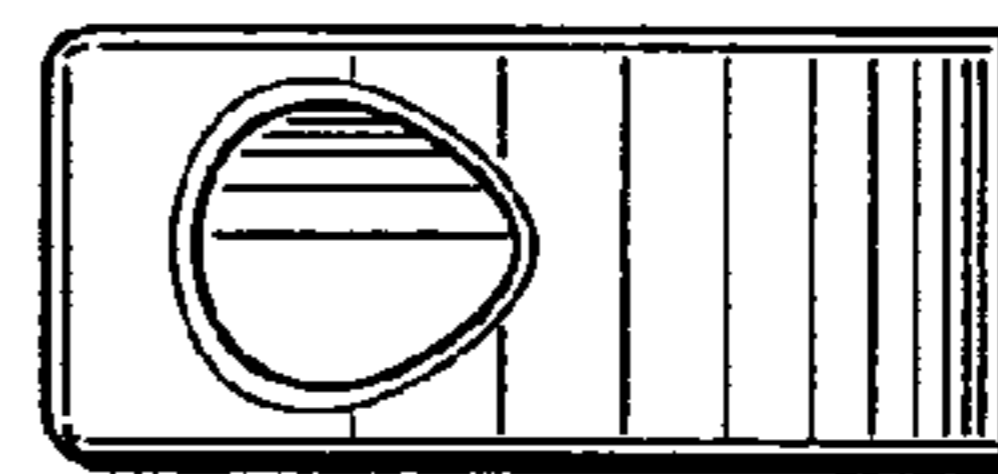

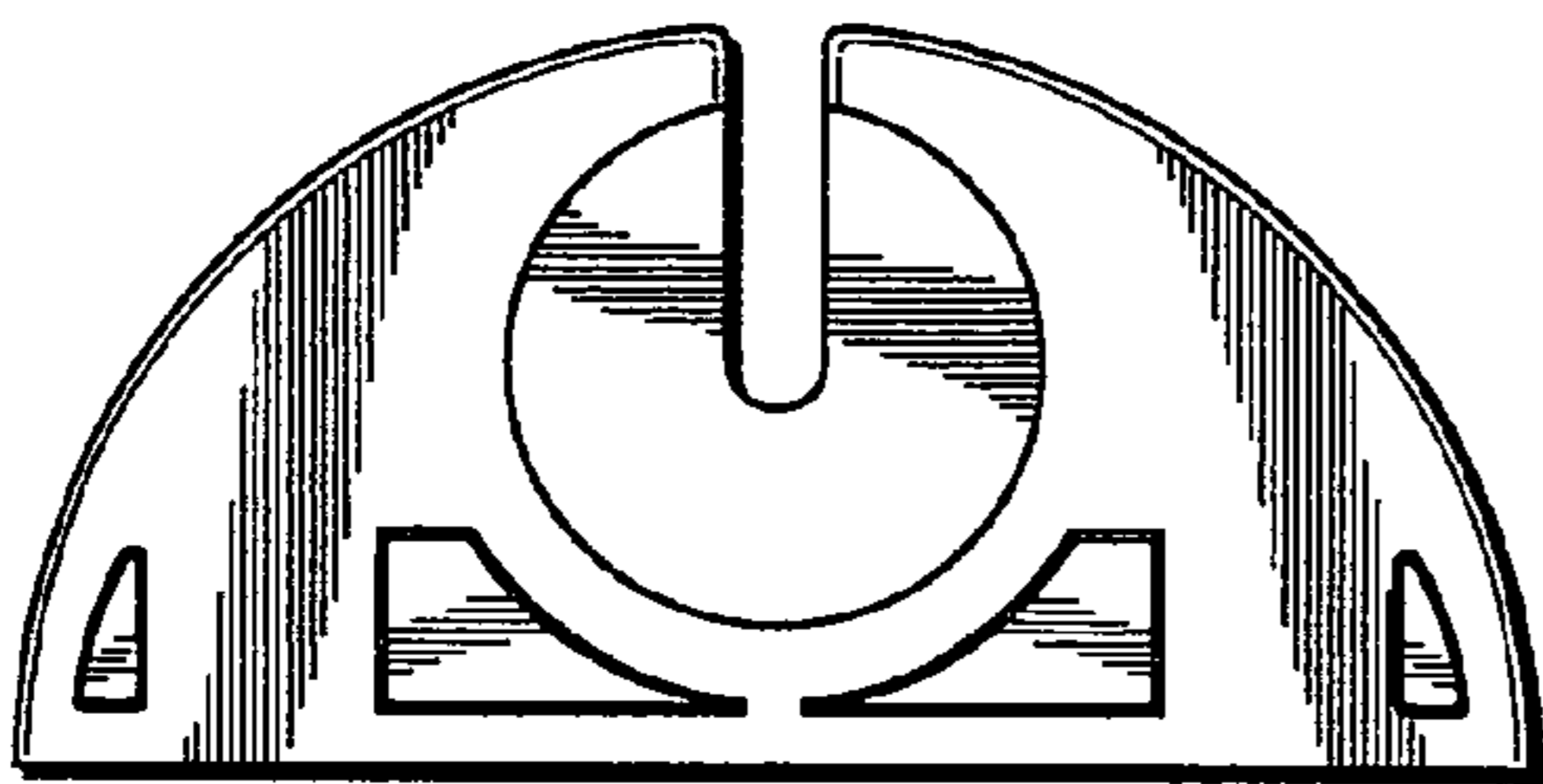

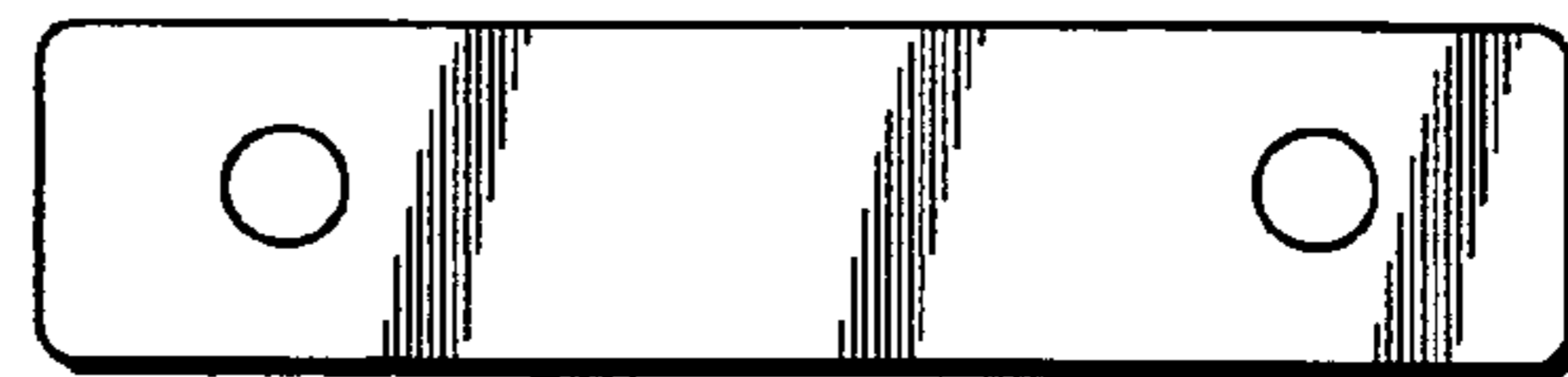
