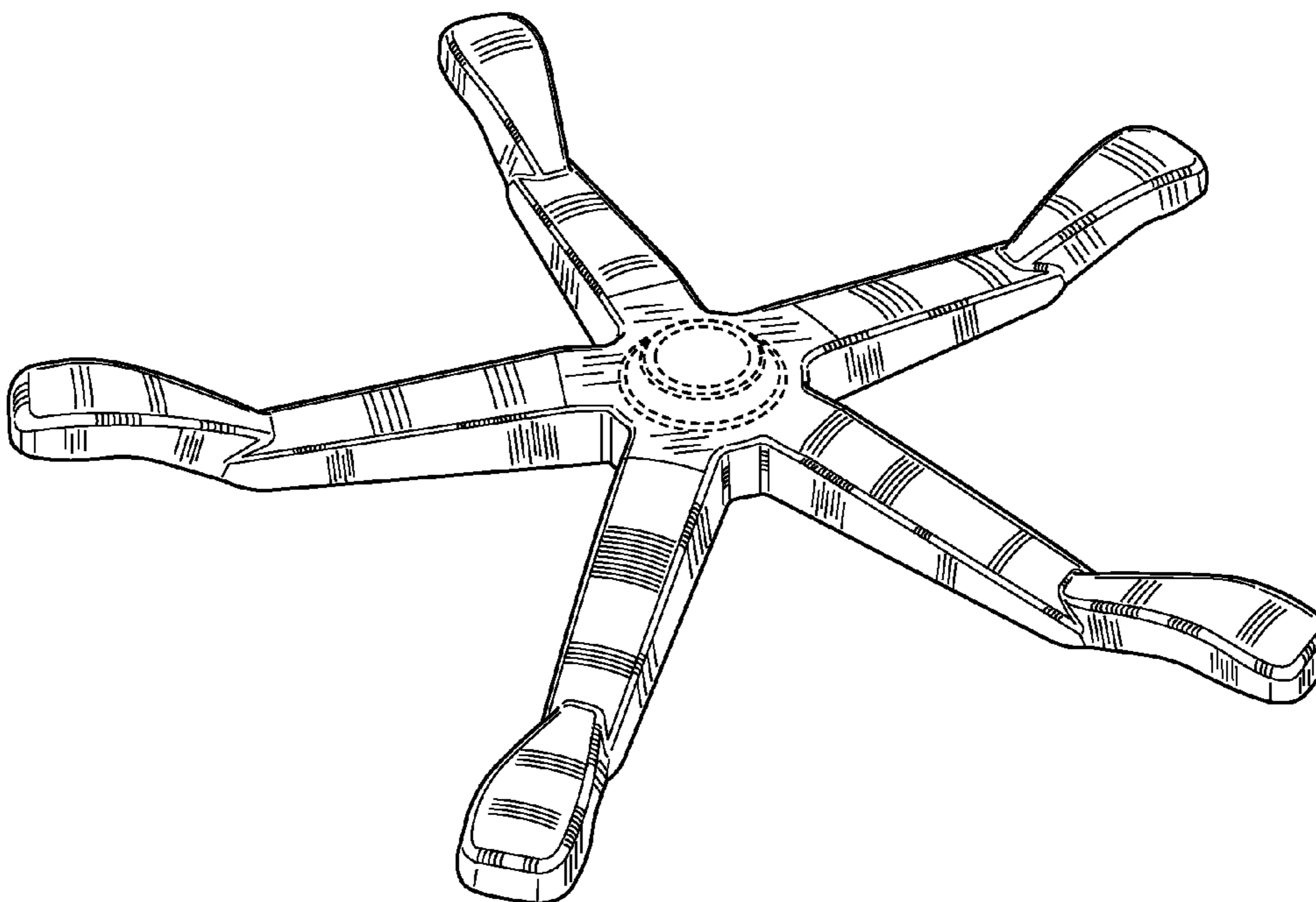
FIG. 5 is a rear view of the chair base;

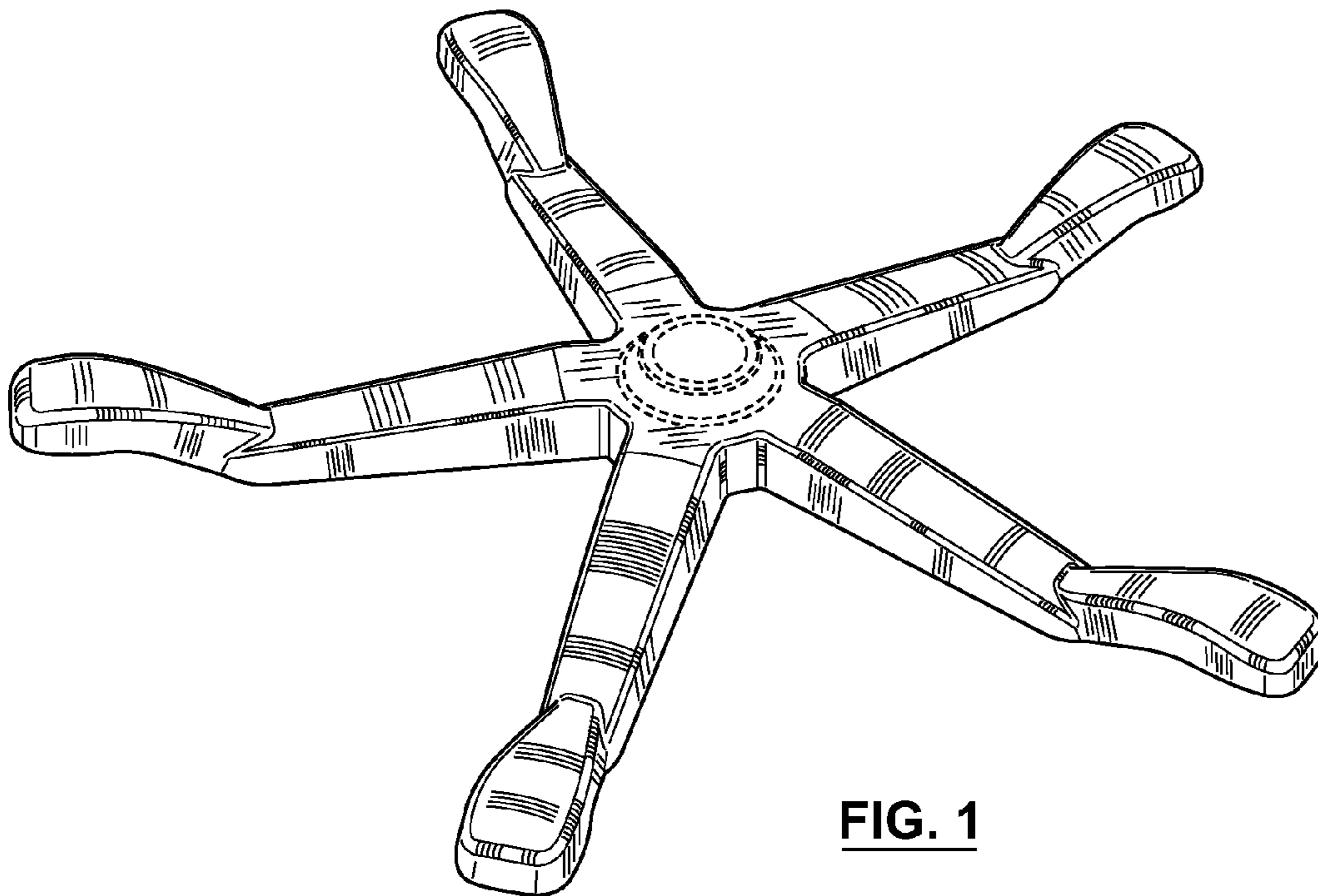

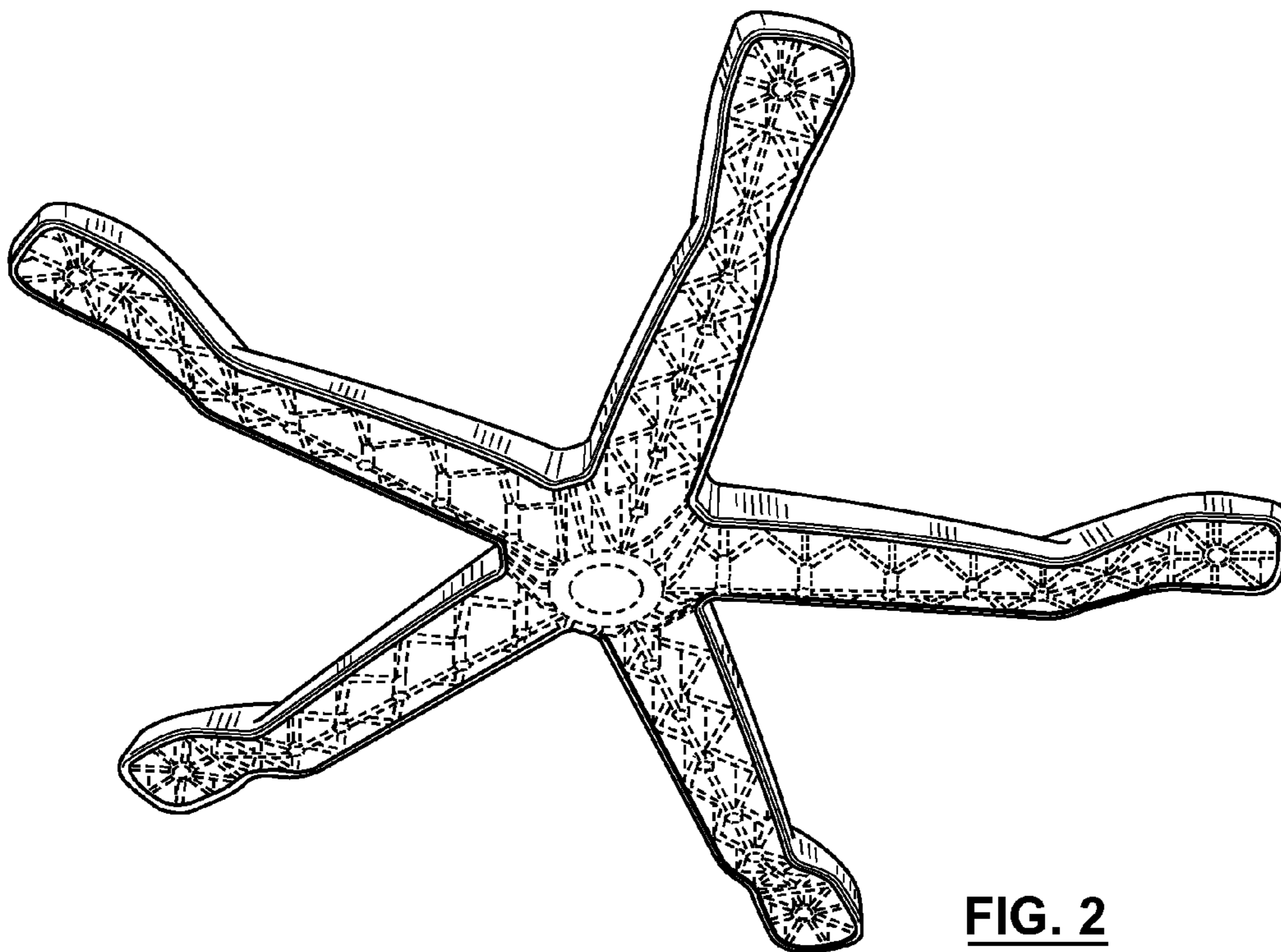

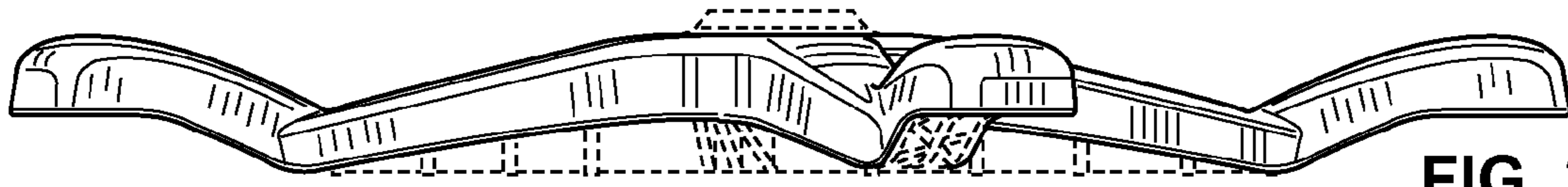

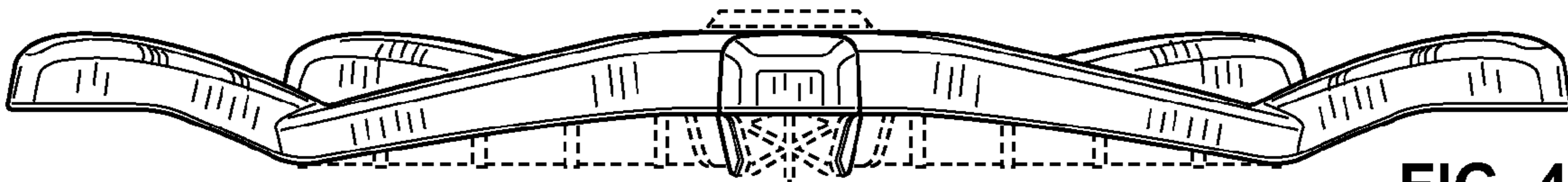

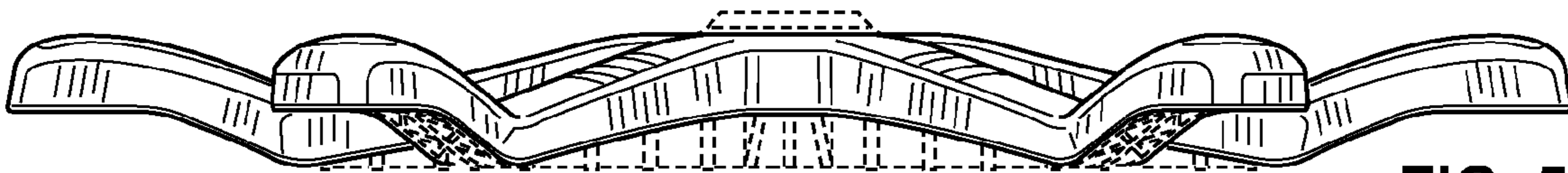

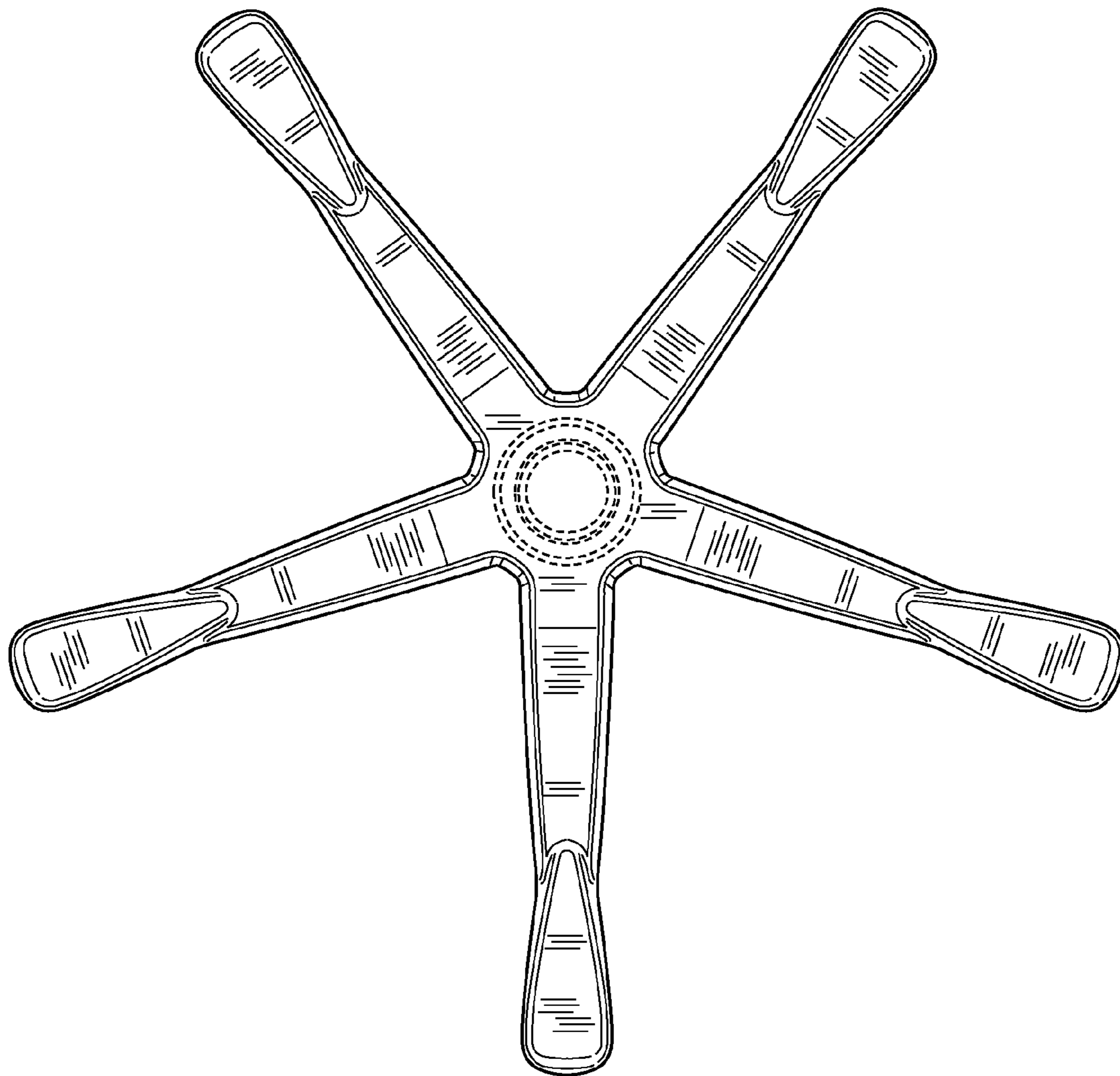

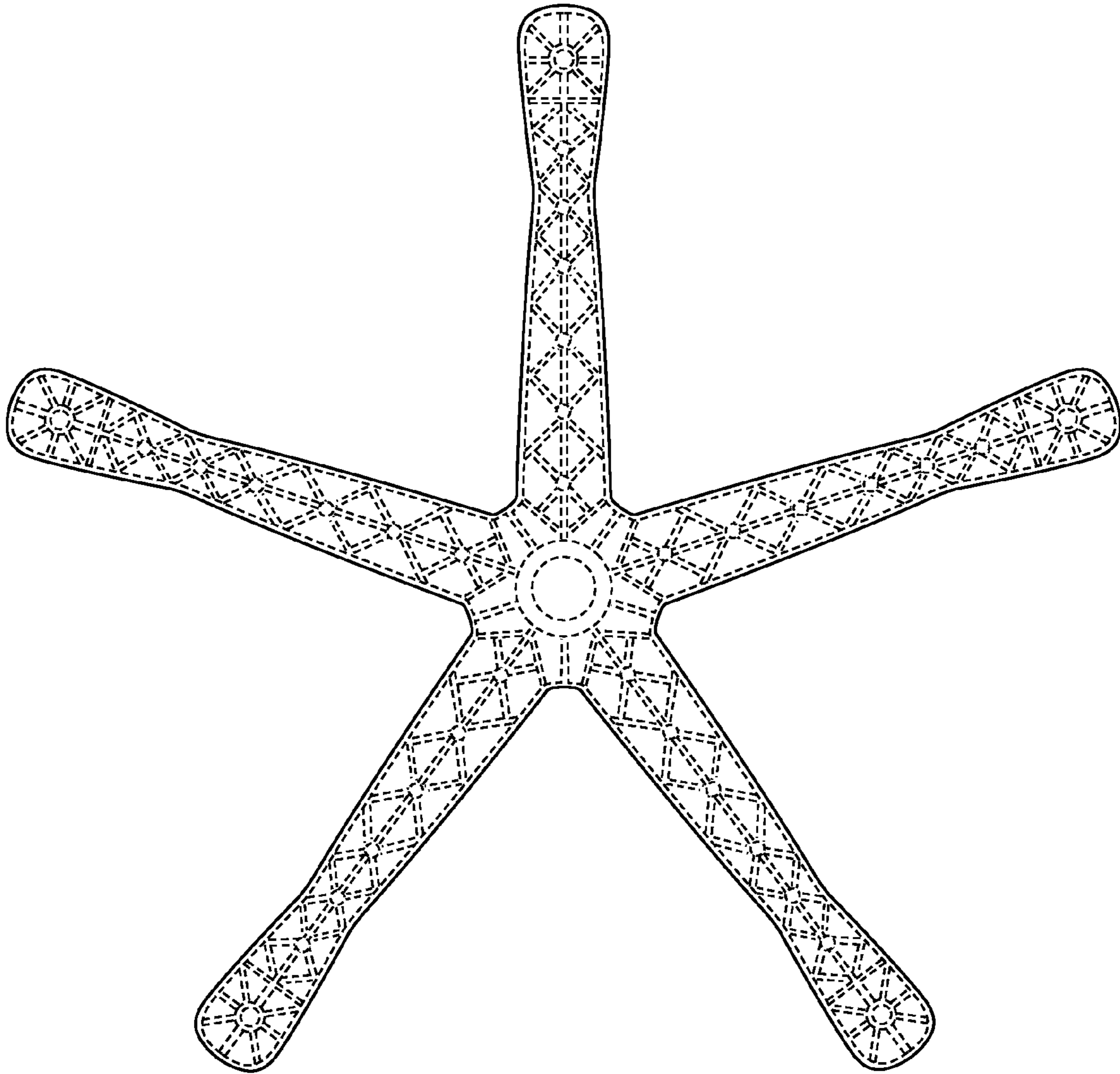
