FIG. 1 is a perspective view of a ceramic soap pump according to the present invention;

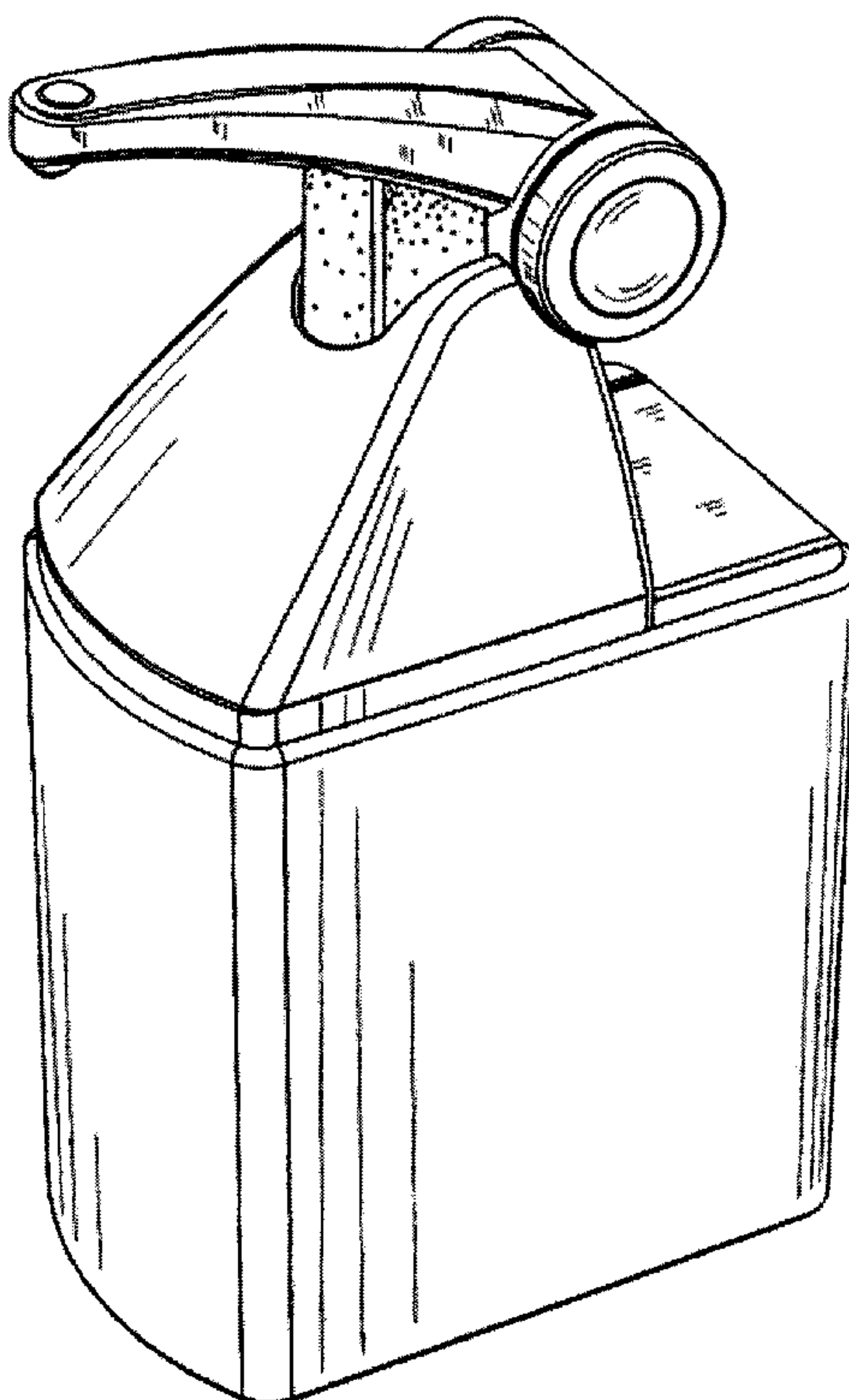
FIG. 2 is a right side elevational view of FIG. 1; the left side elevational view being a mirror image thereof.

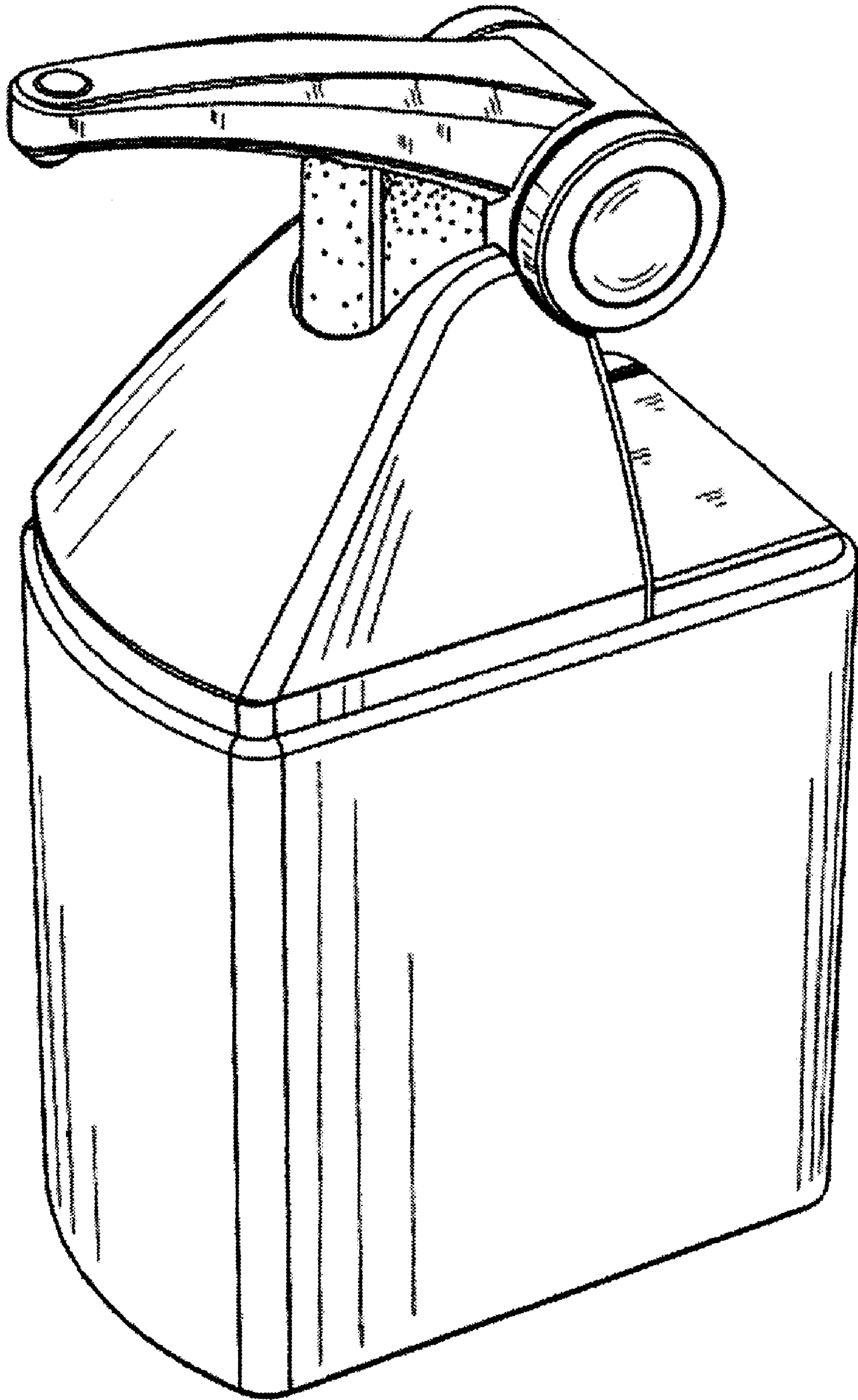

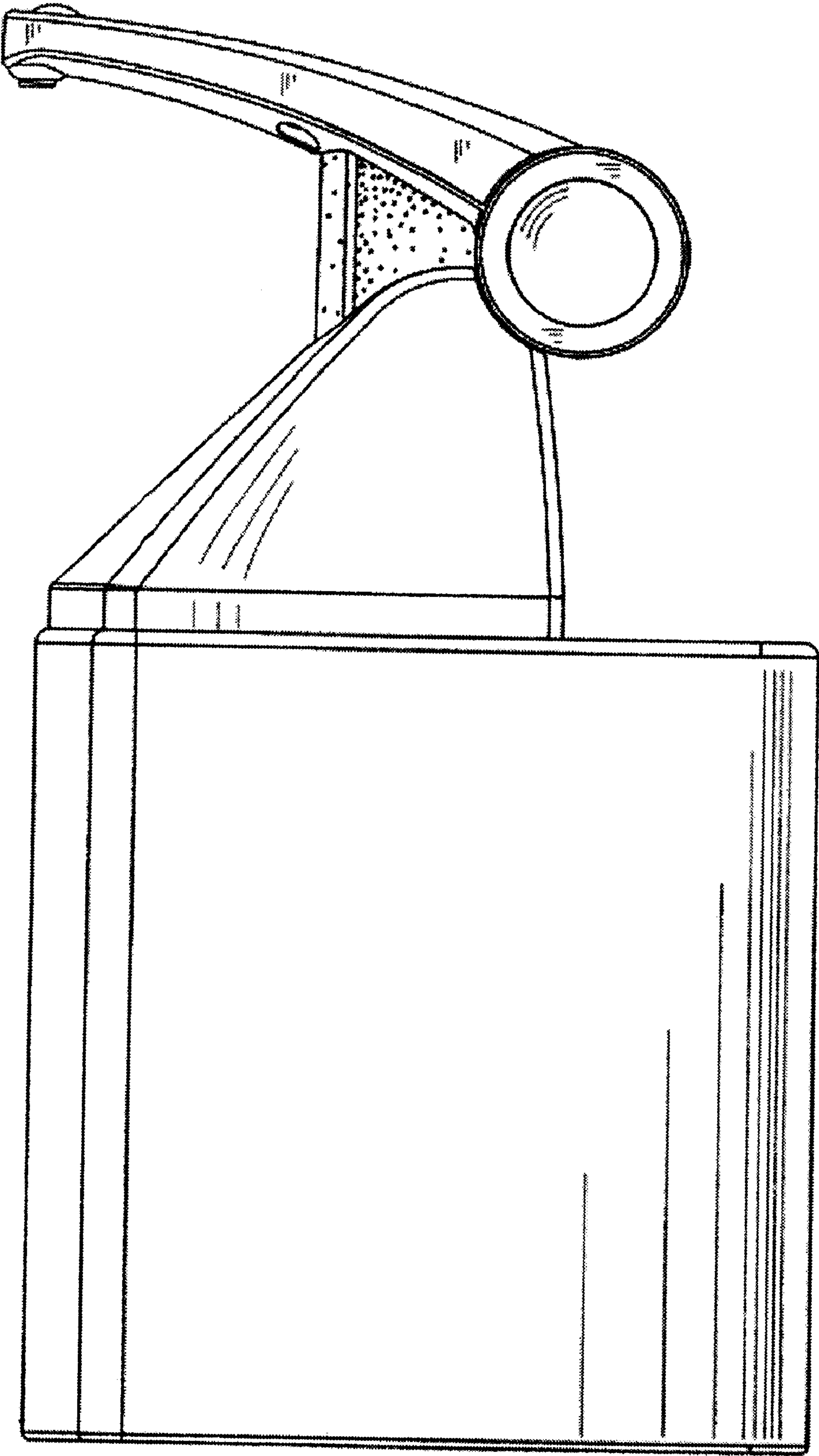

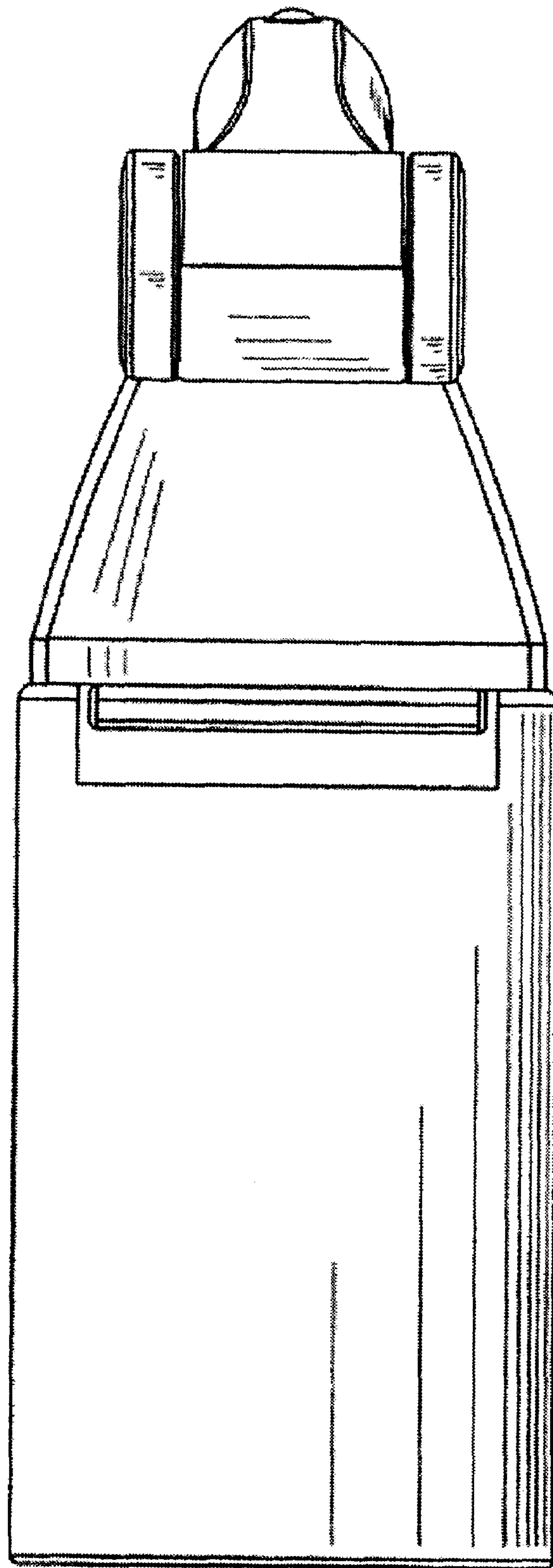

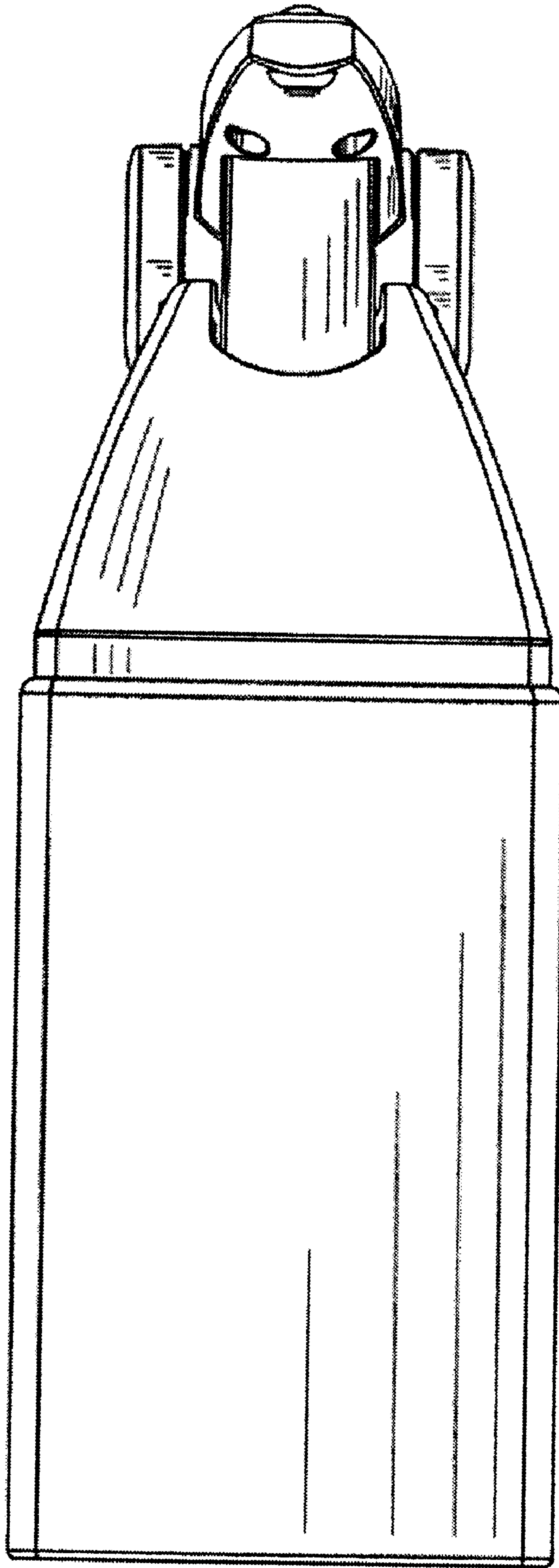

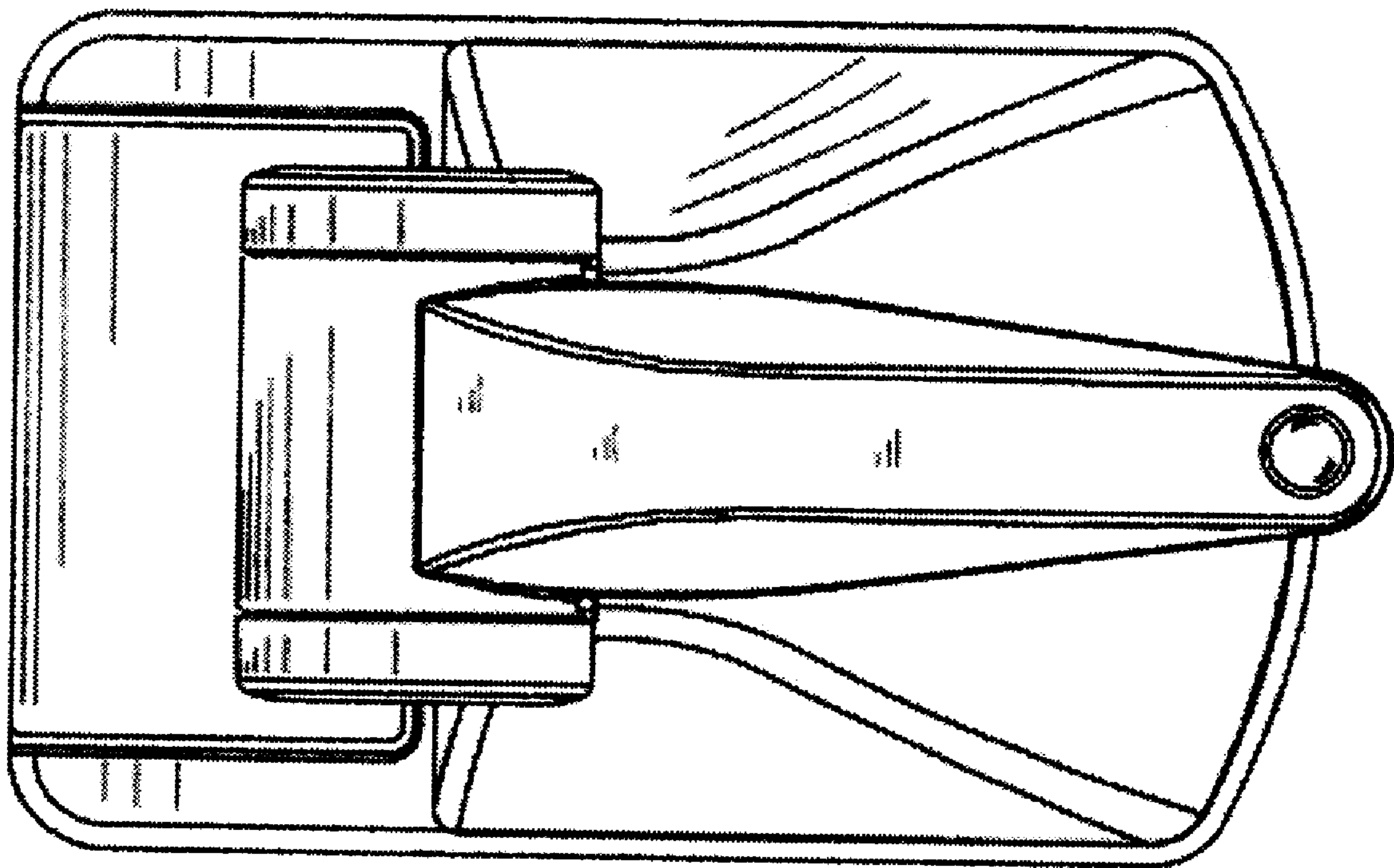
