**DESCRIPTION**

FIG. 1 is a perspective view of a cabinet according to an embodiment of the present invention;

FIG. 2 is a front plan view of the cabinet shown in FIG. 1;

FIG. 3 is a top plan view of the cabinet shown in FIG. 1; and

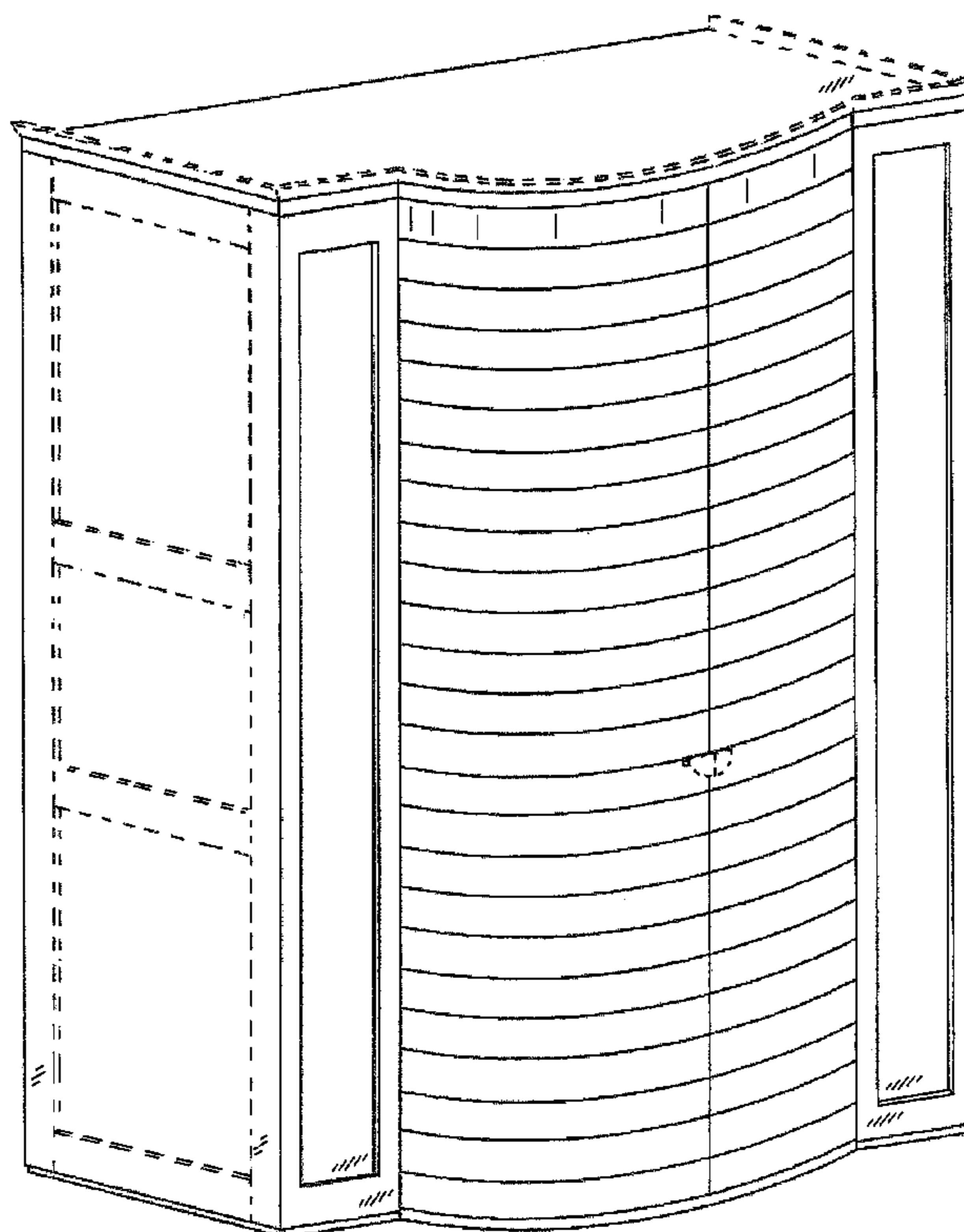
FIG. 4 is a top cross-sectional view of the cabinet shown in FIG. 1 taken along line 4—4, wherein the doors are in a closed position;

FIG. 5 is a top cross-sectional view of the cabinet shown in FIG. 1 taken along line 4—4, wherein the doors are in an opened position; and,

FIG. 6 is a right side plan view of the cabinet shown in FIG. 1, the left side plan view is a mirror image of the right side plan view.

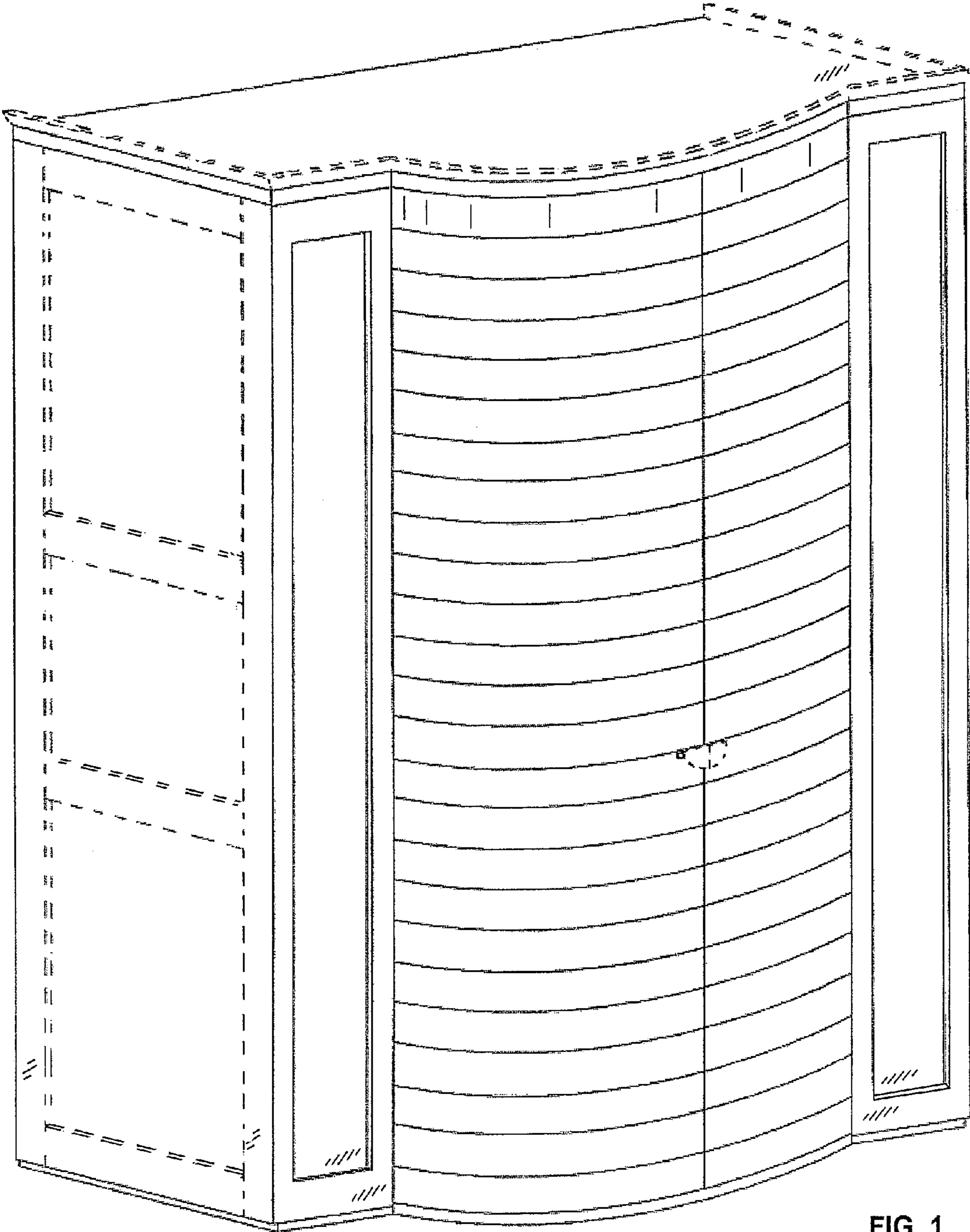

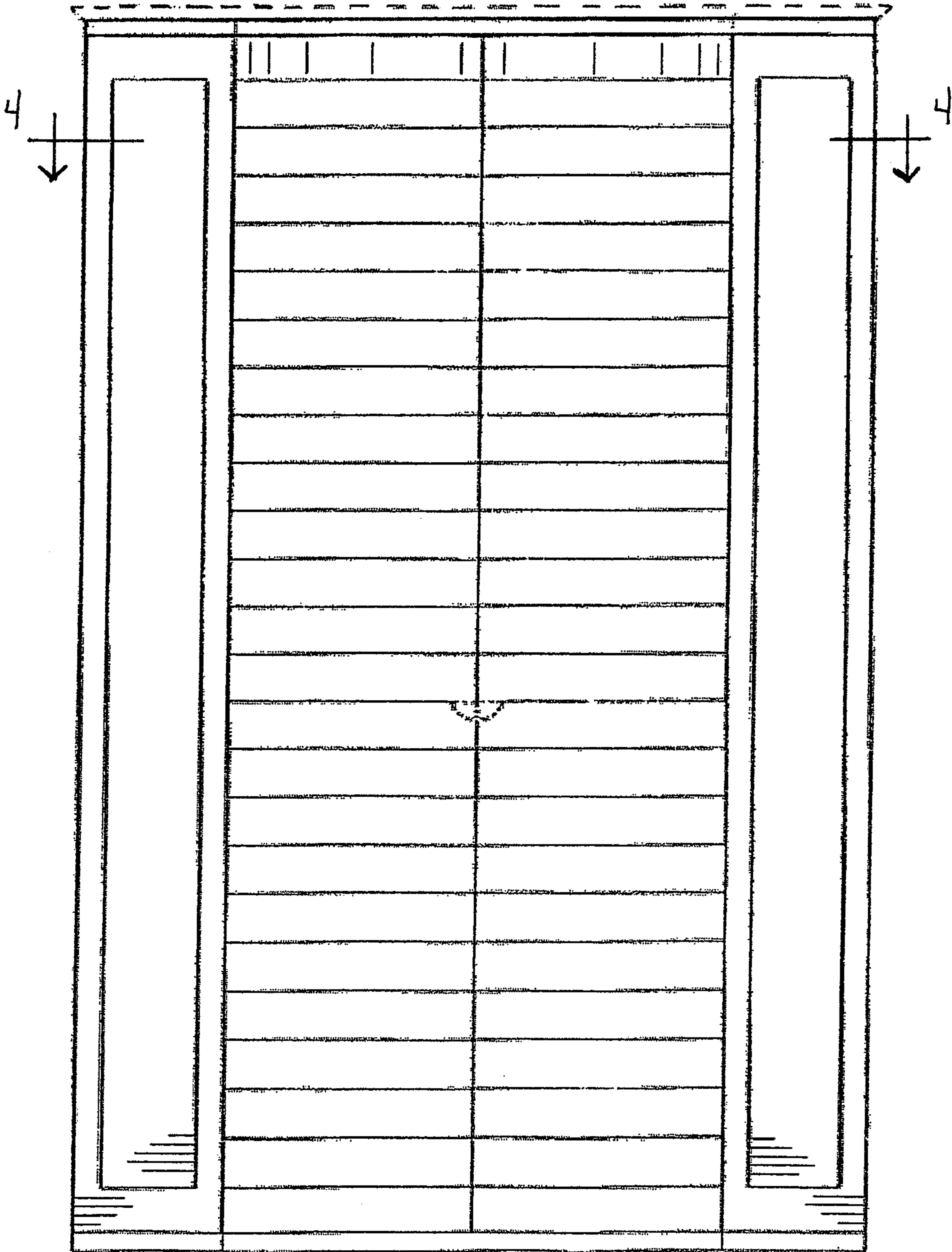

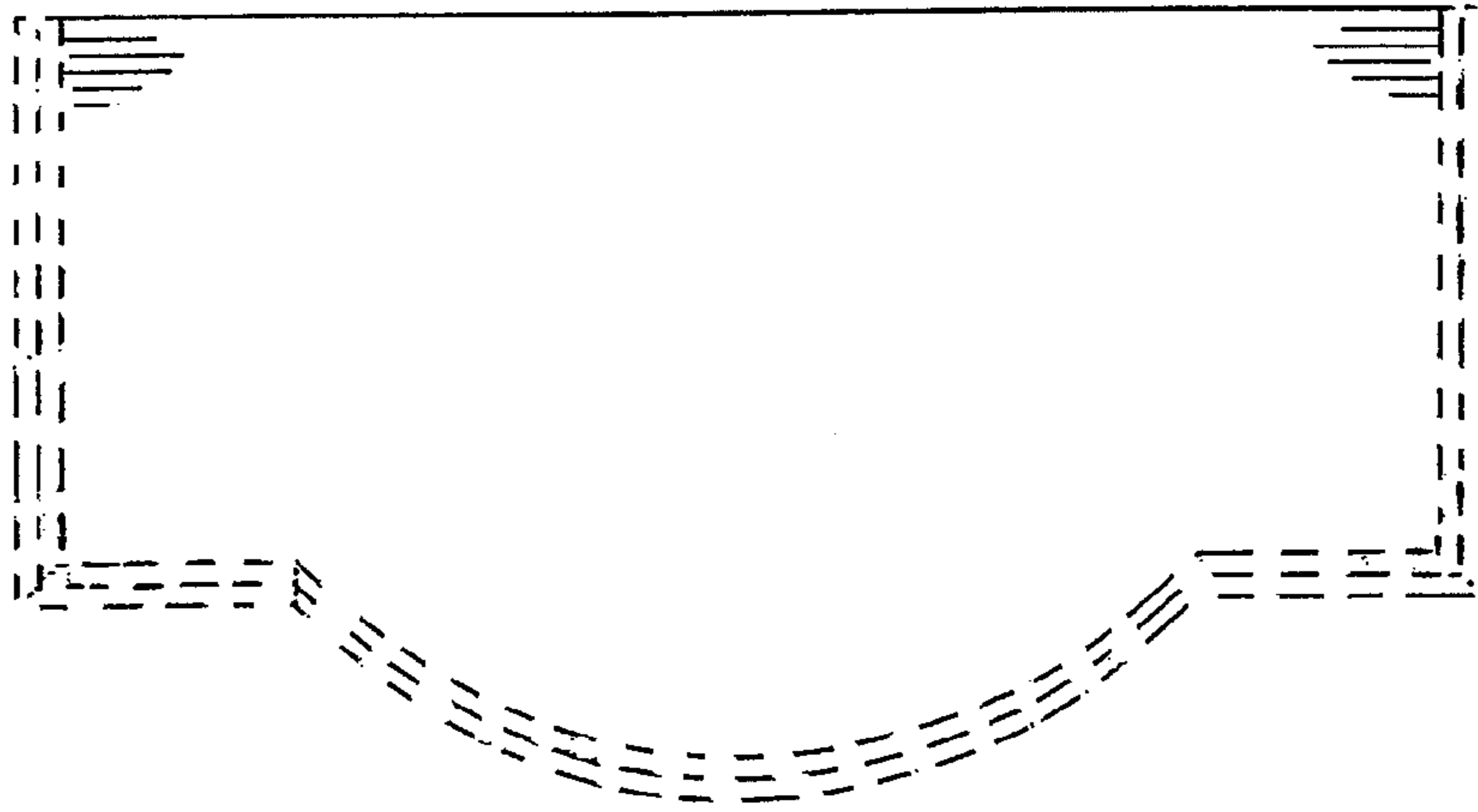

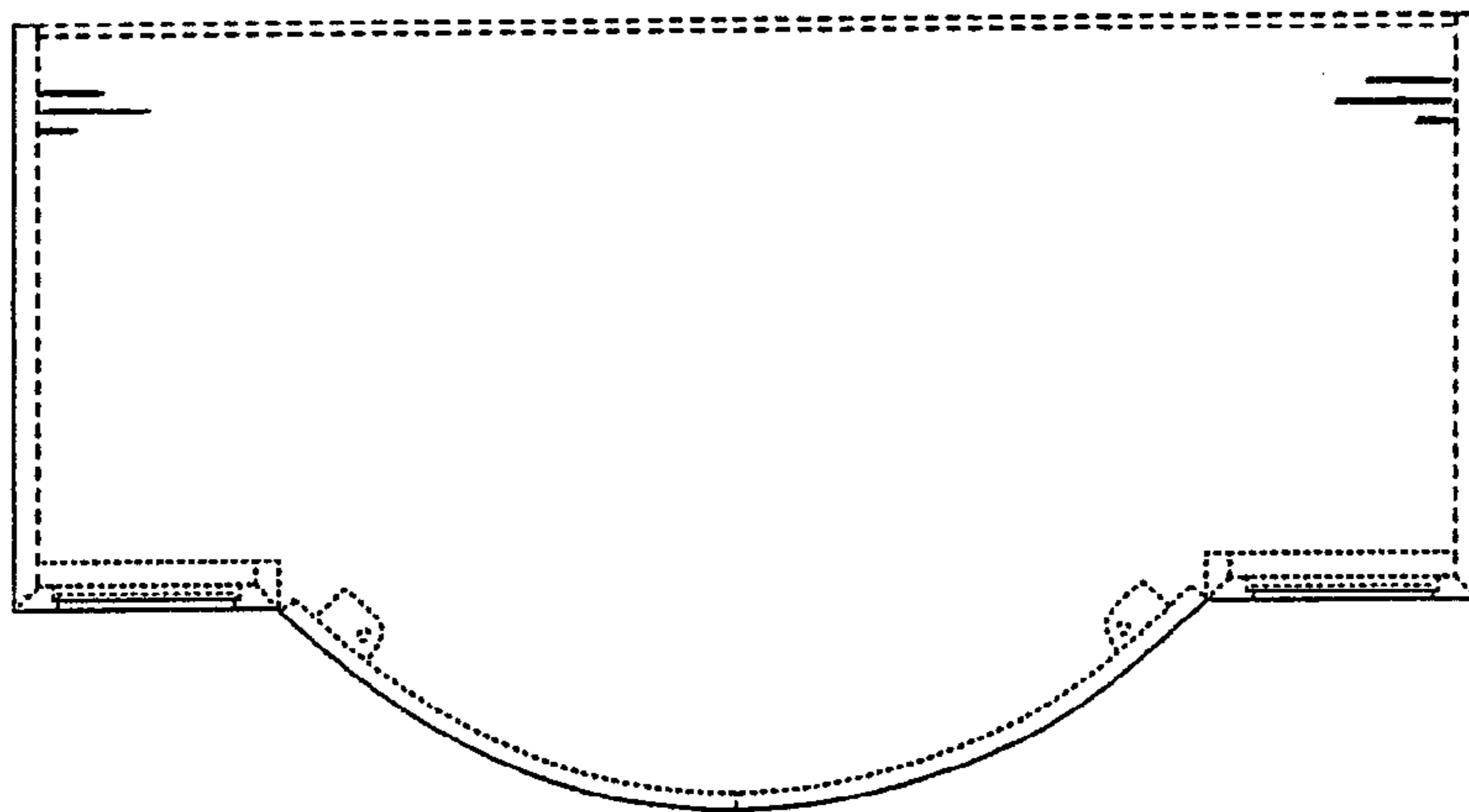

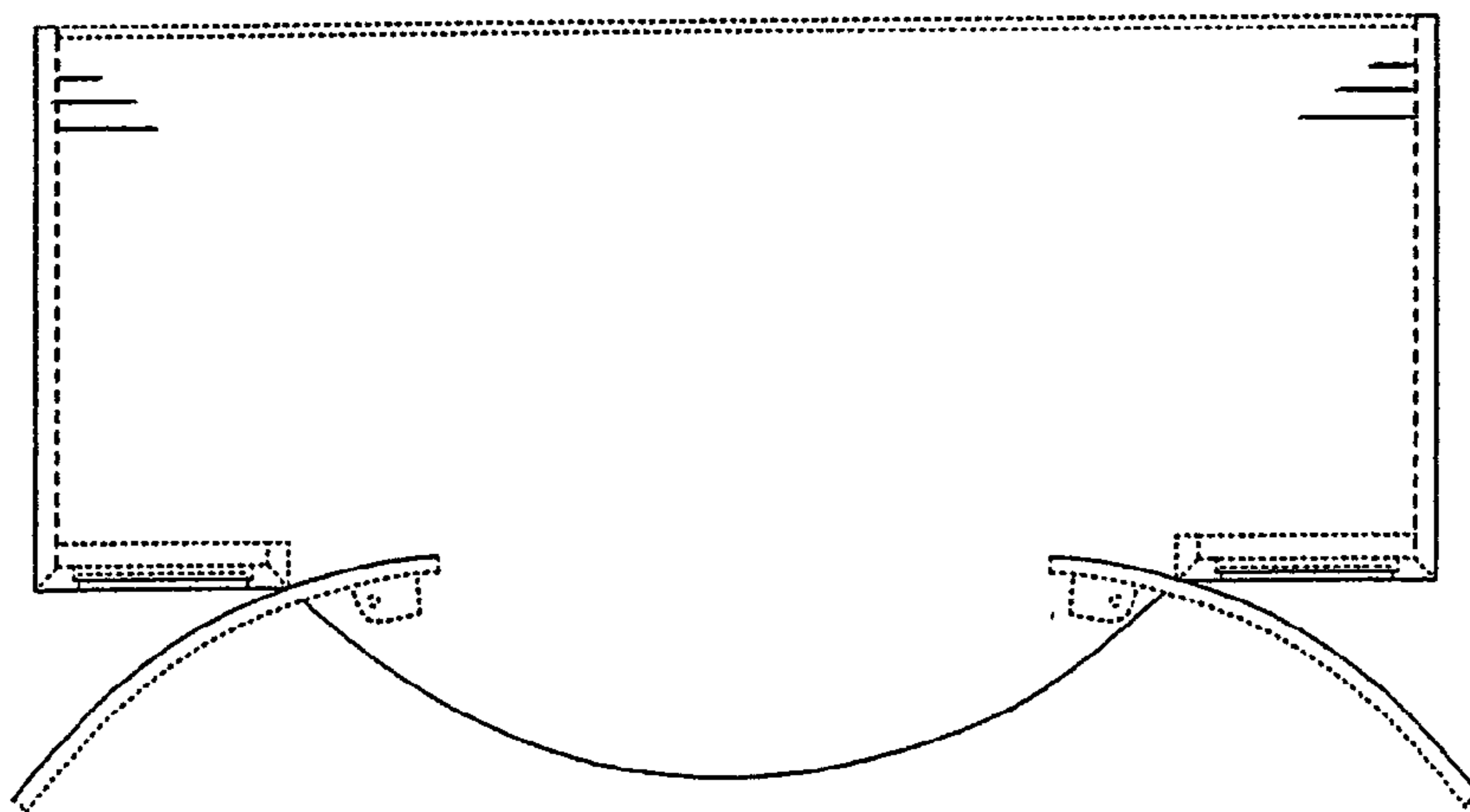

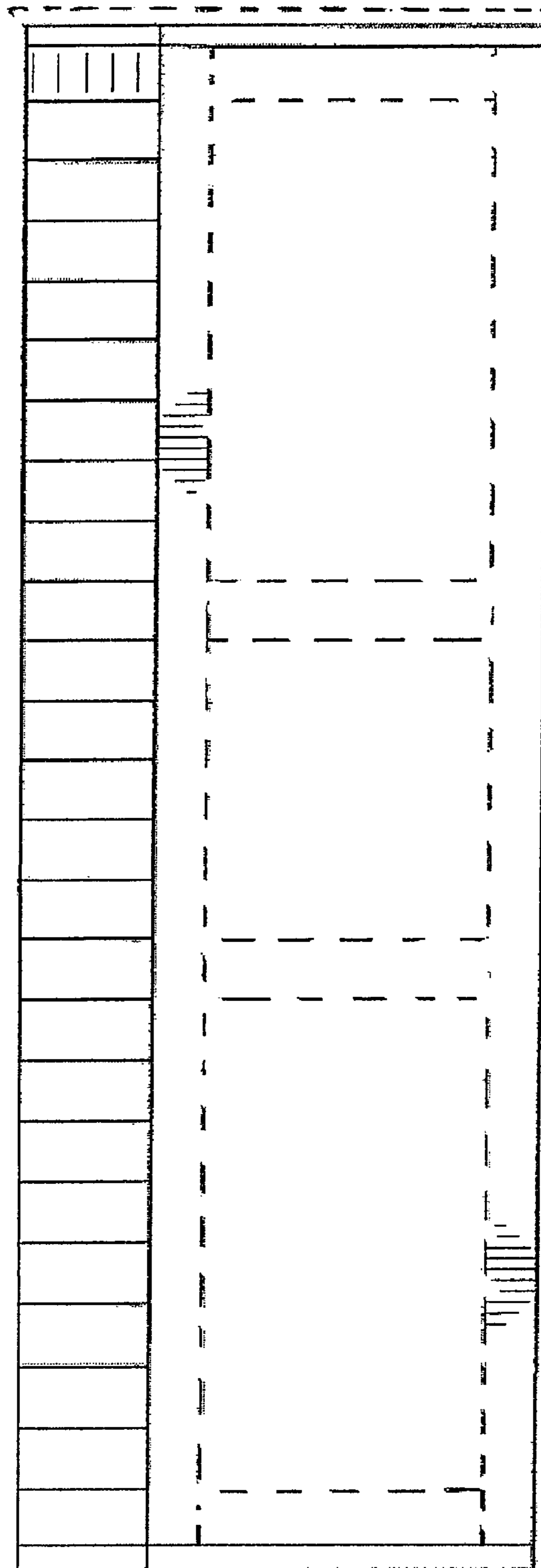
