FIG. 5 is a right side elevational view of the bottle of FIG. 1, the left side elevational view of the bottle of FIG. 1 being a mirror image thereof;  
FIG. 6 is a rear elevational view of the bottle of FIG. 1;  
FIG. 7 is a perspective view of a bottle according to a second preferred embodiment of our new design;  
FIG. 8 a top plan view of the bottle of FIG. 7;  
FIG. 9 is a bottom plan view of the bottle of FIG. 7;  
FIG. 10 is a front elevational view of the bottle of FIG. 7;  
FIG. 11 is a right side elevational view of the bottle of FIG. 7, the left side elevational view of the bottle of FIG. 7 being a mirror image thereof; and,  
FIG. 12 is a rear elevational view of the bottle of FIG. 7.

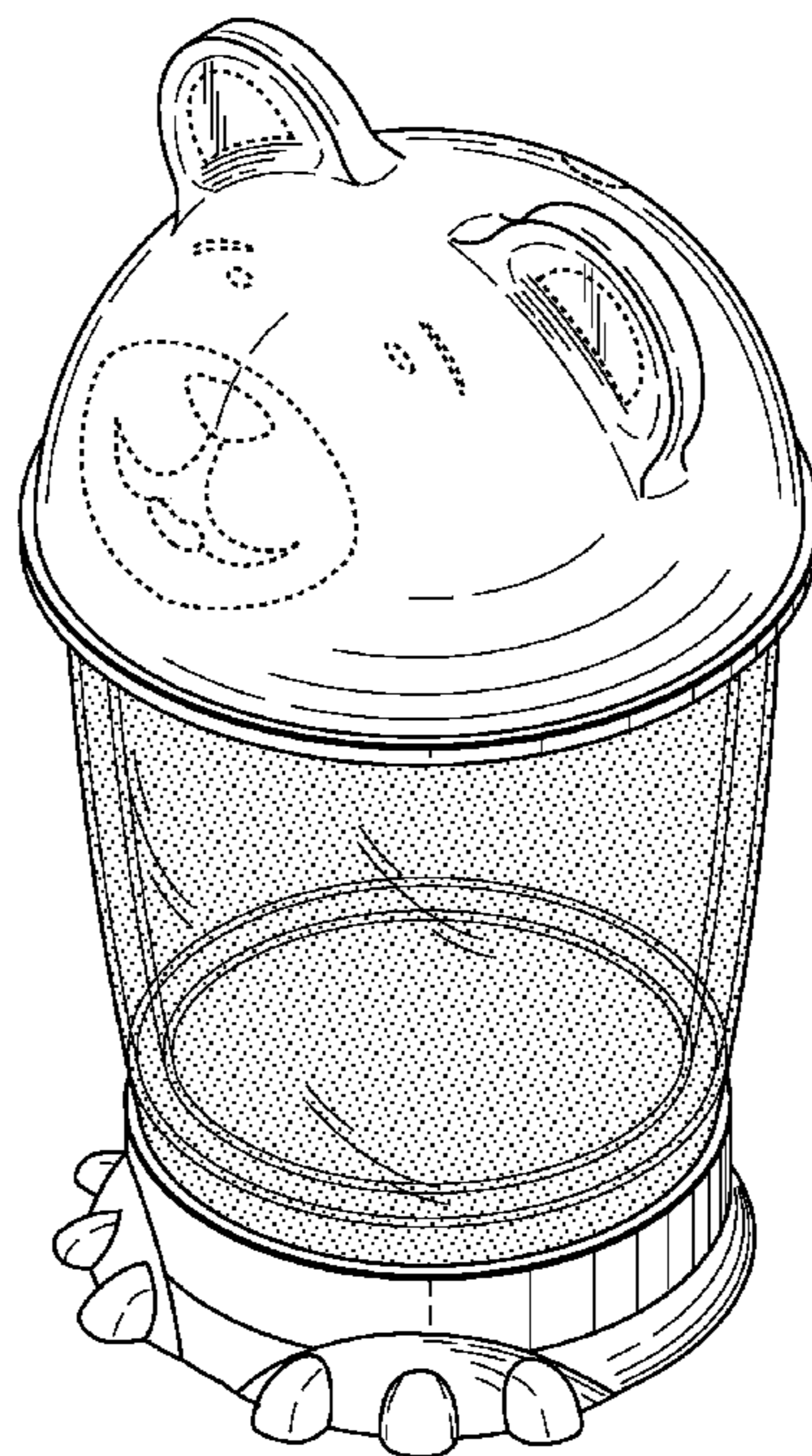

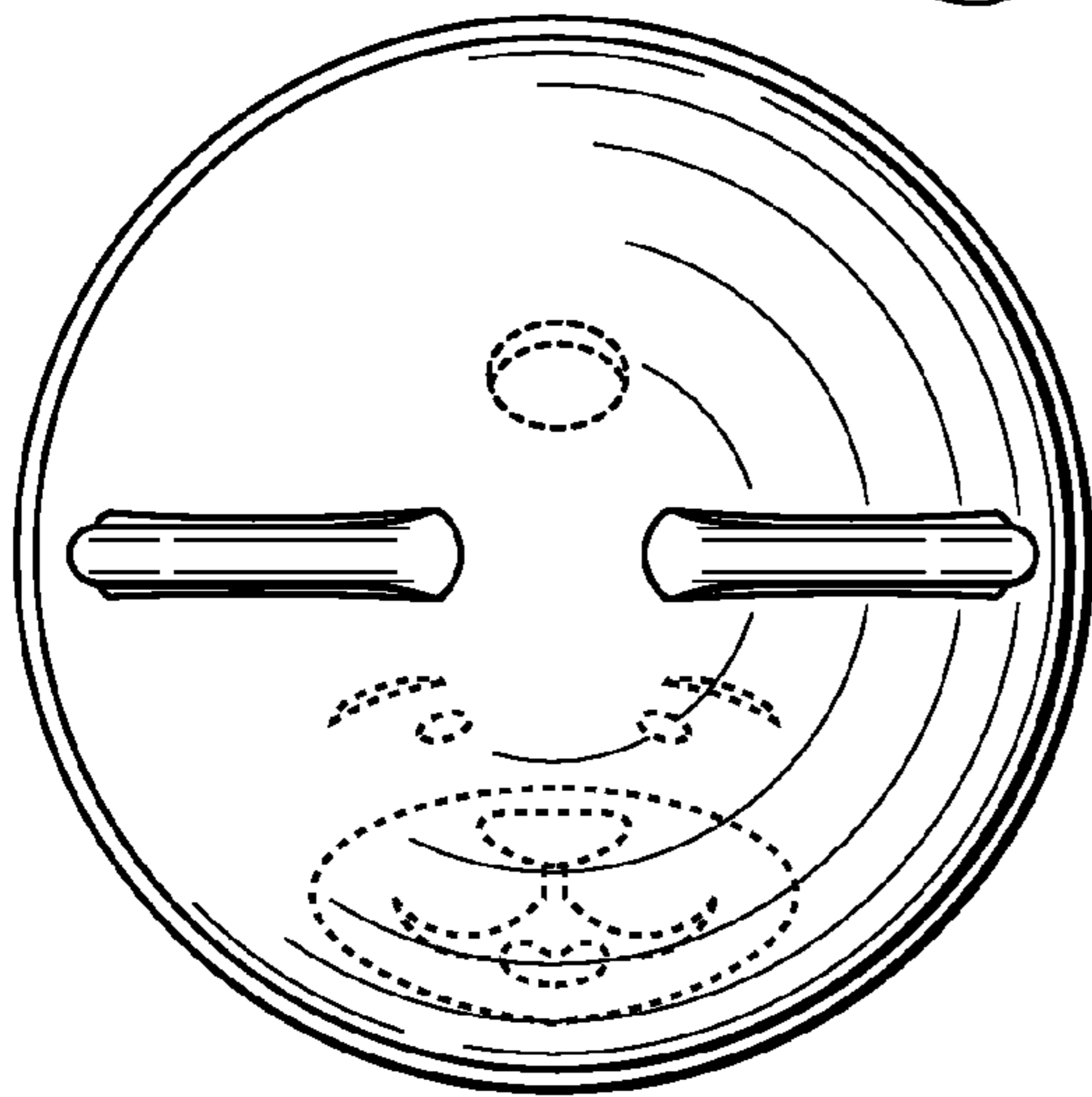
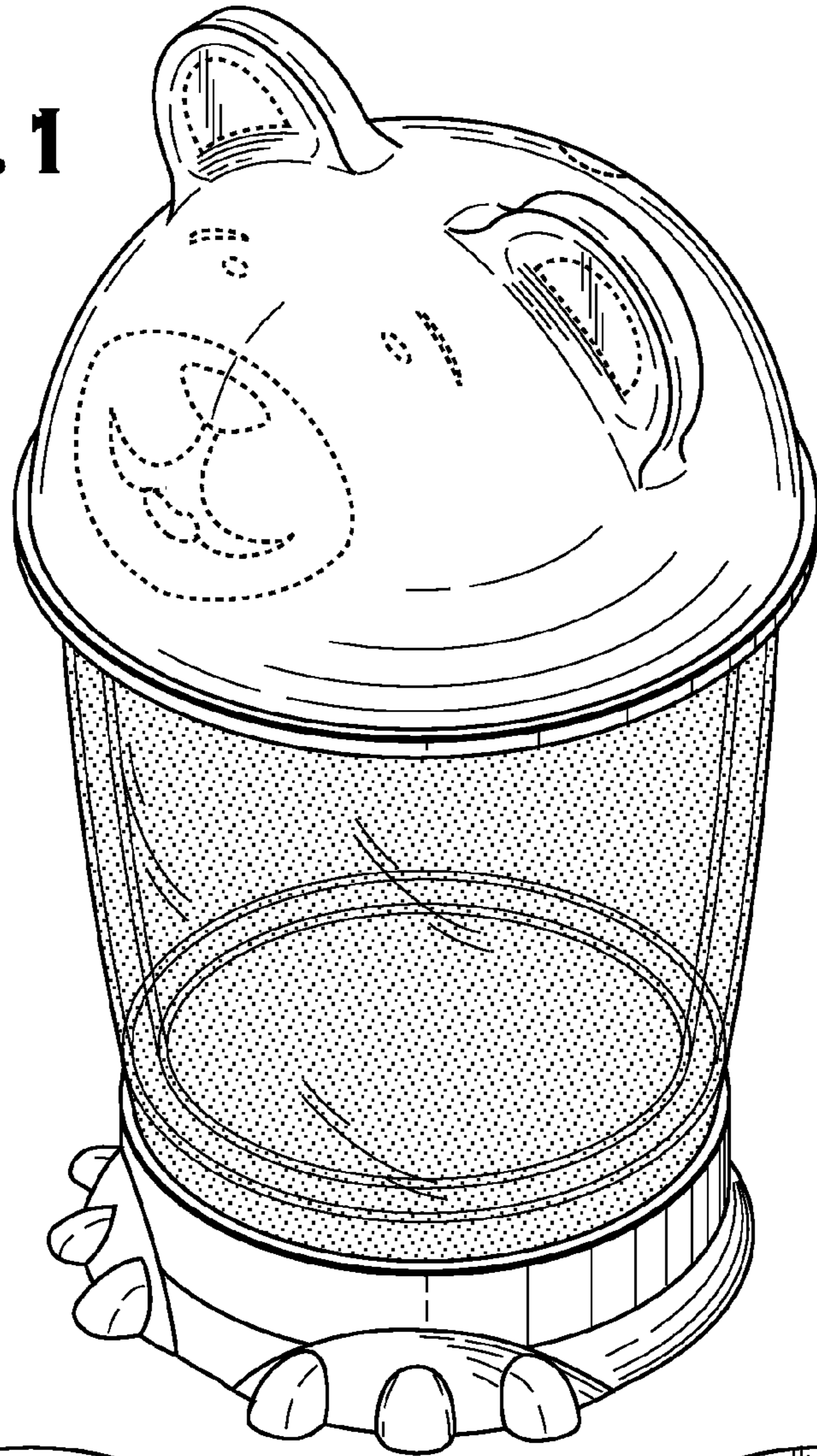

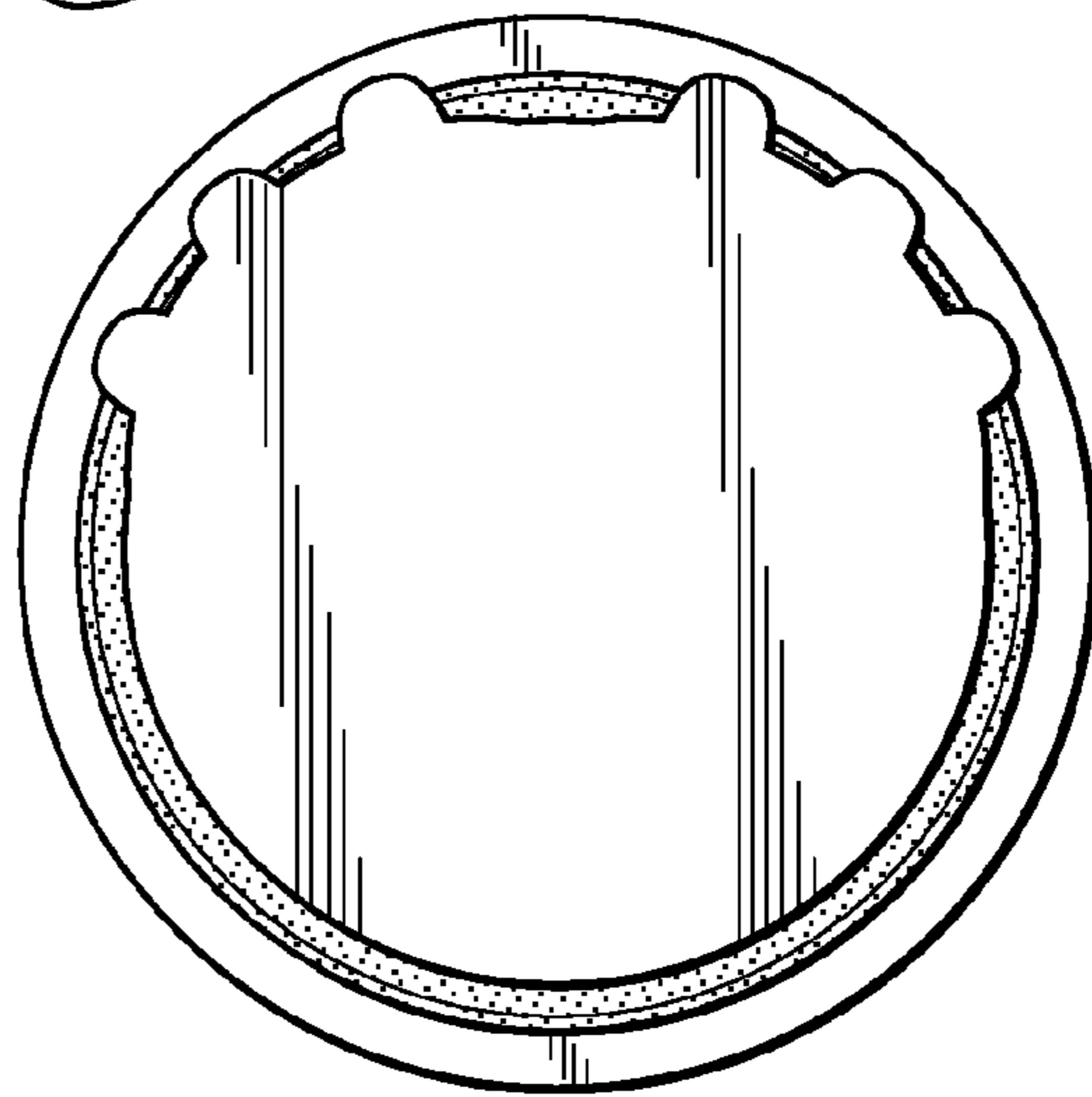

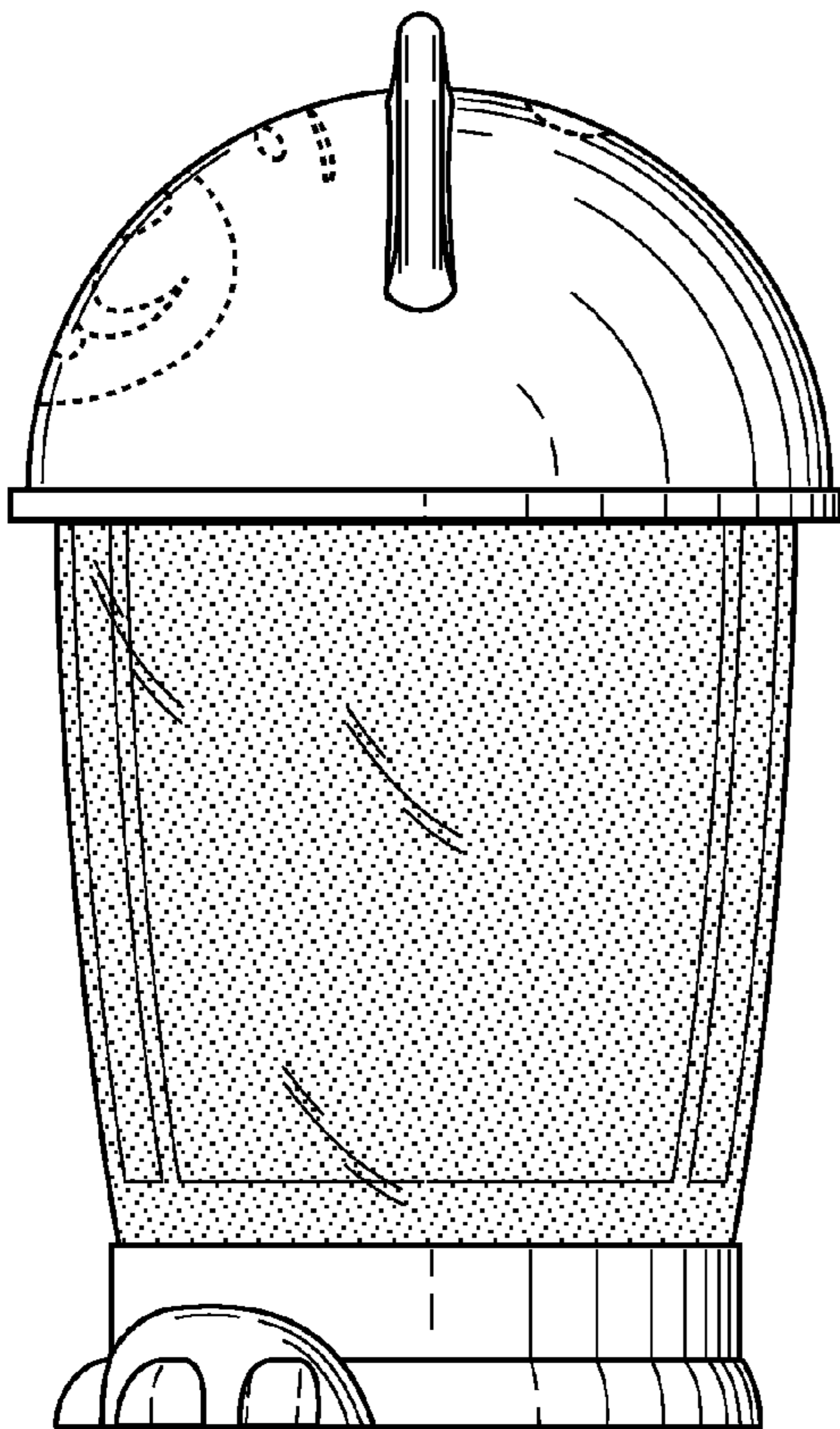
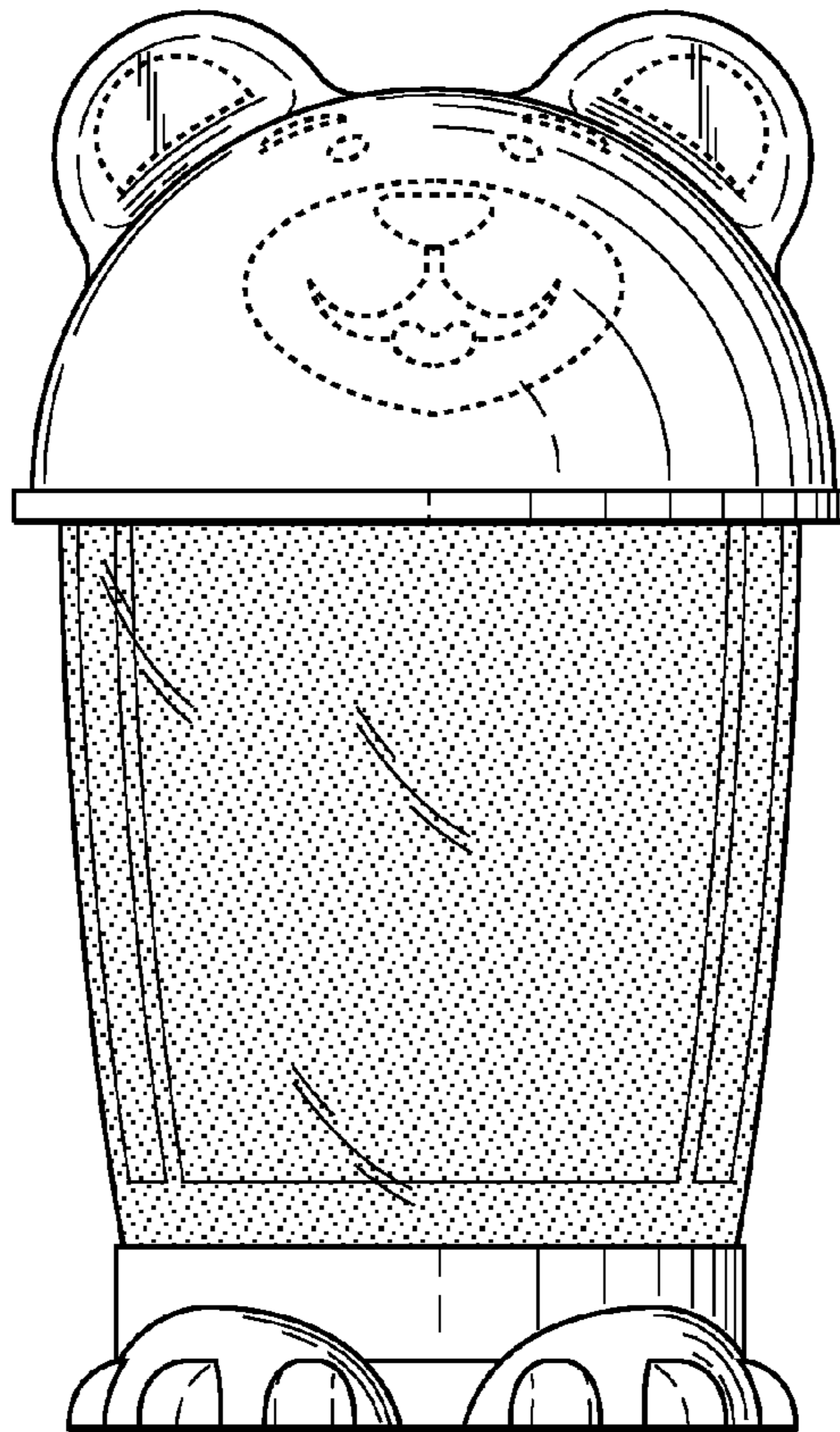

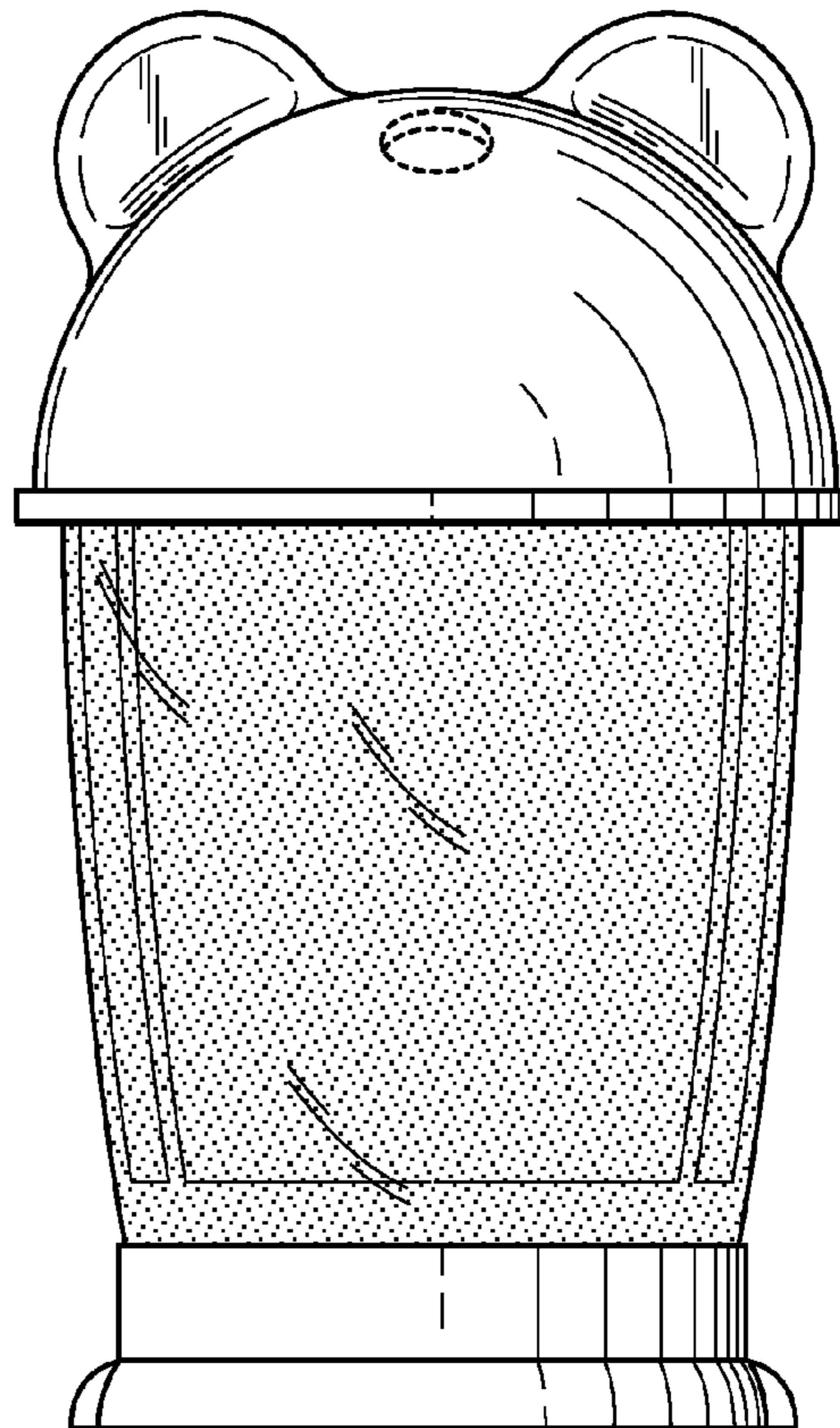

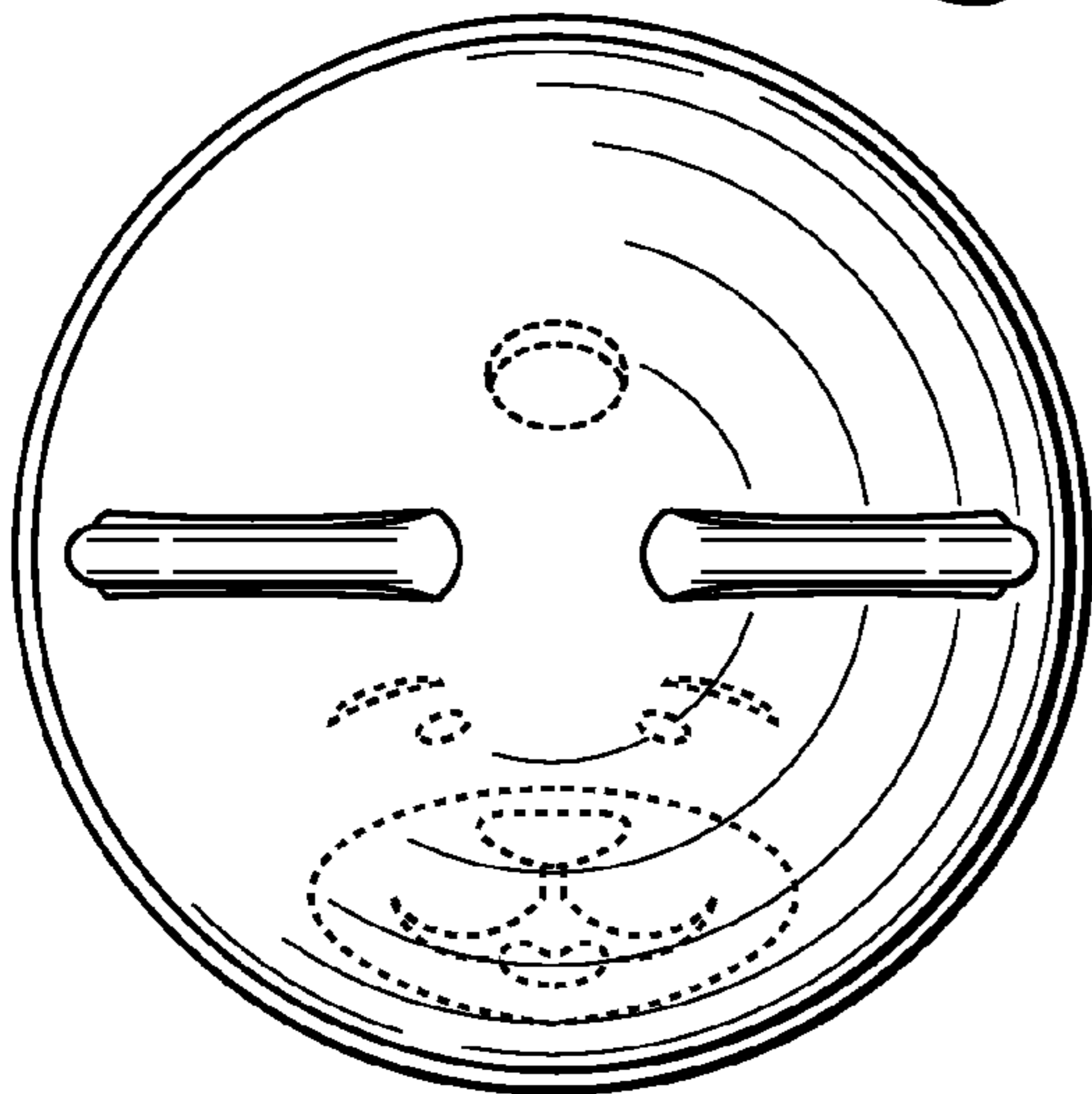
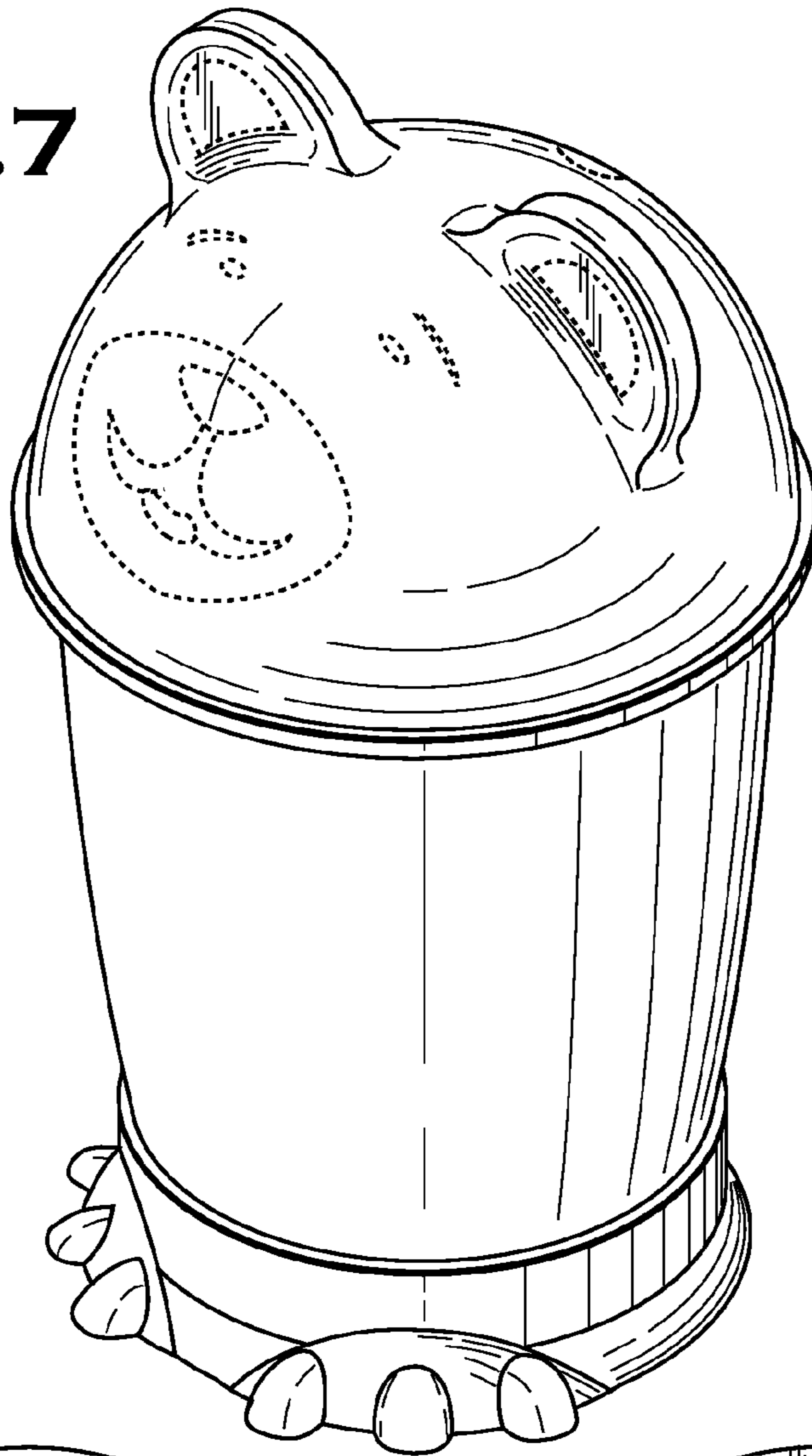

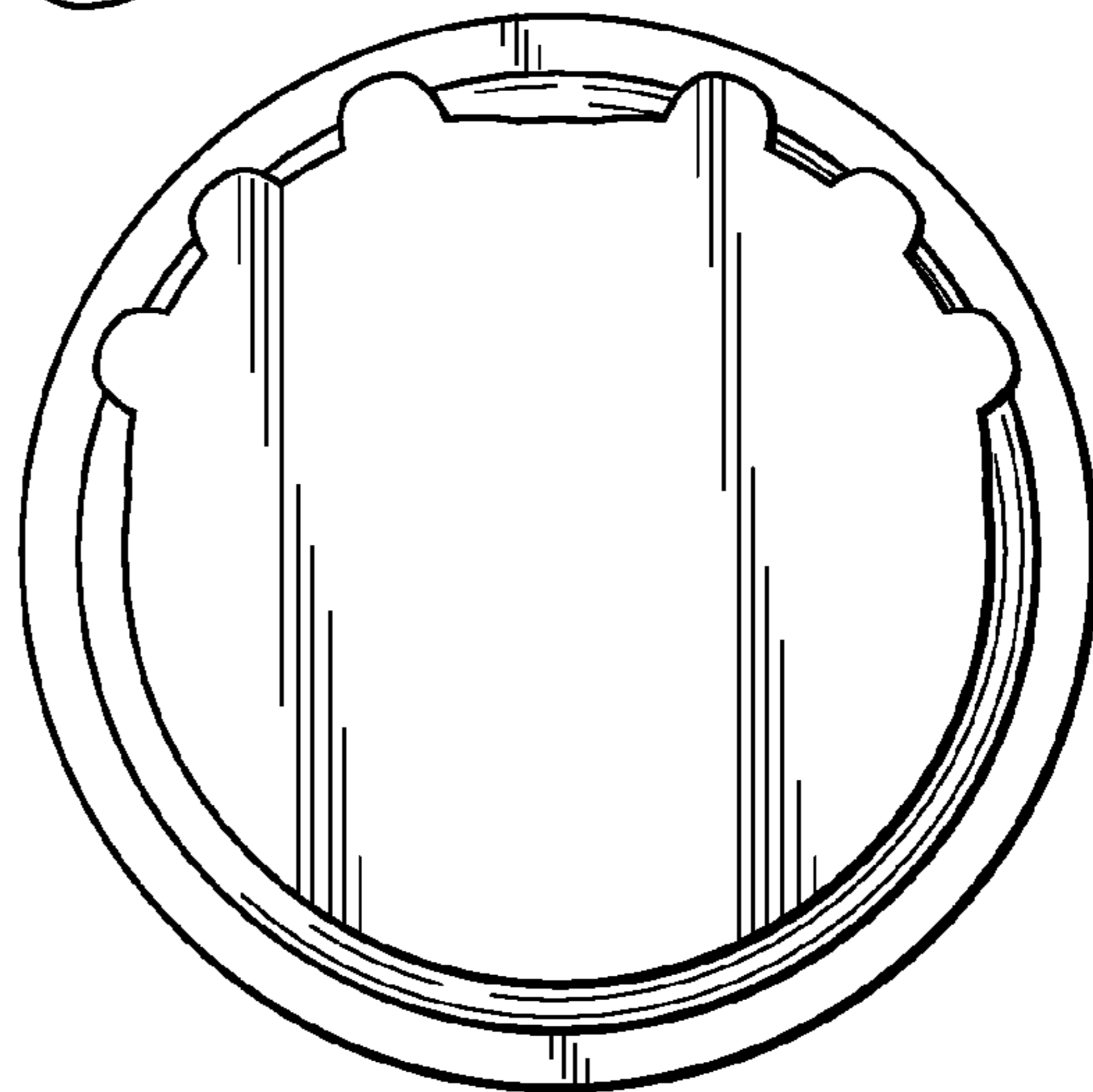

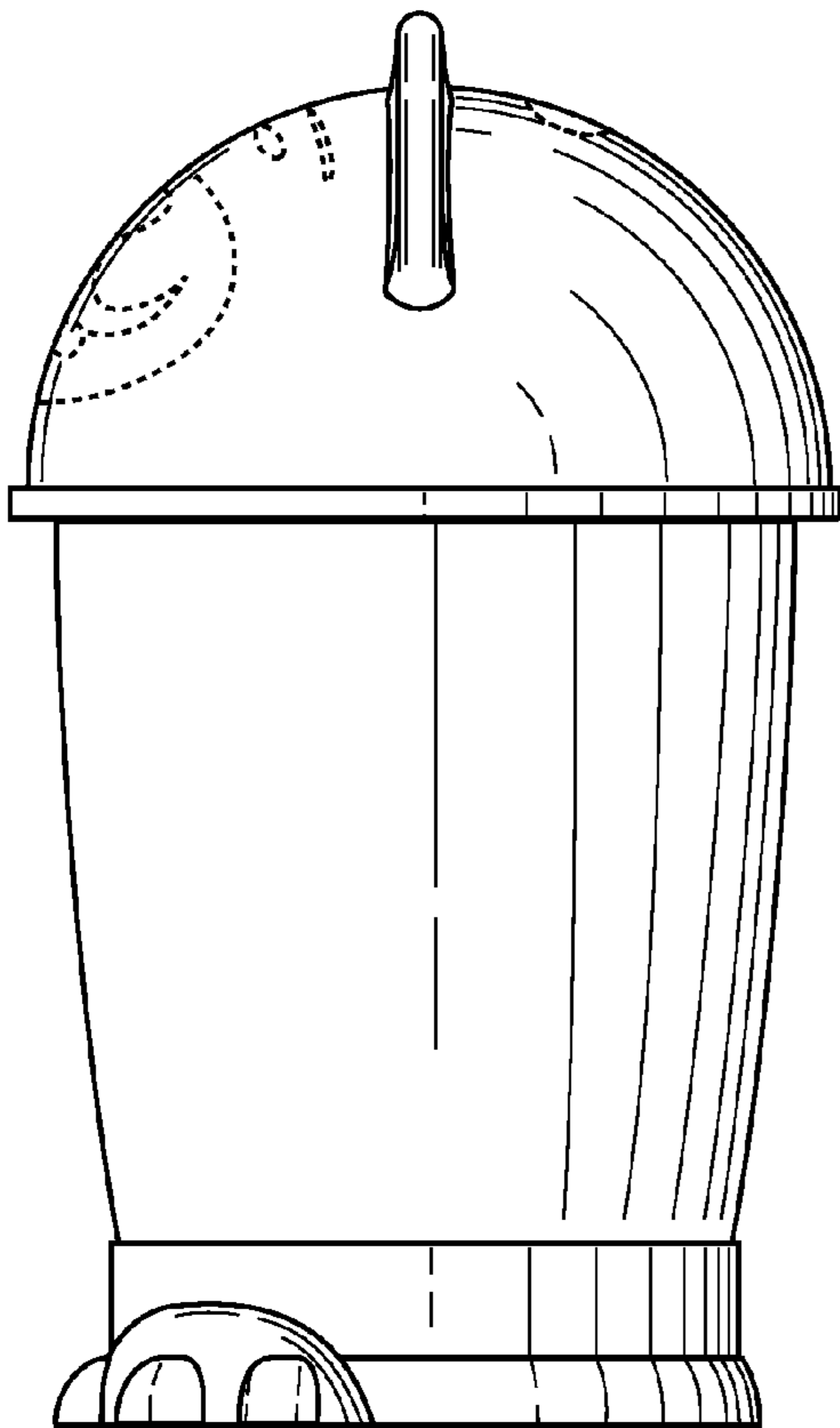
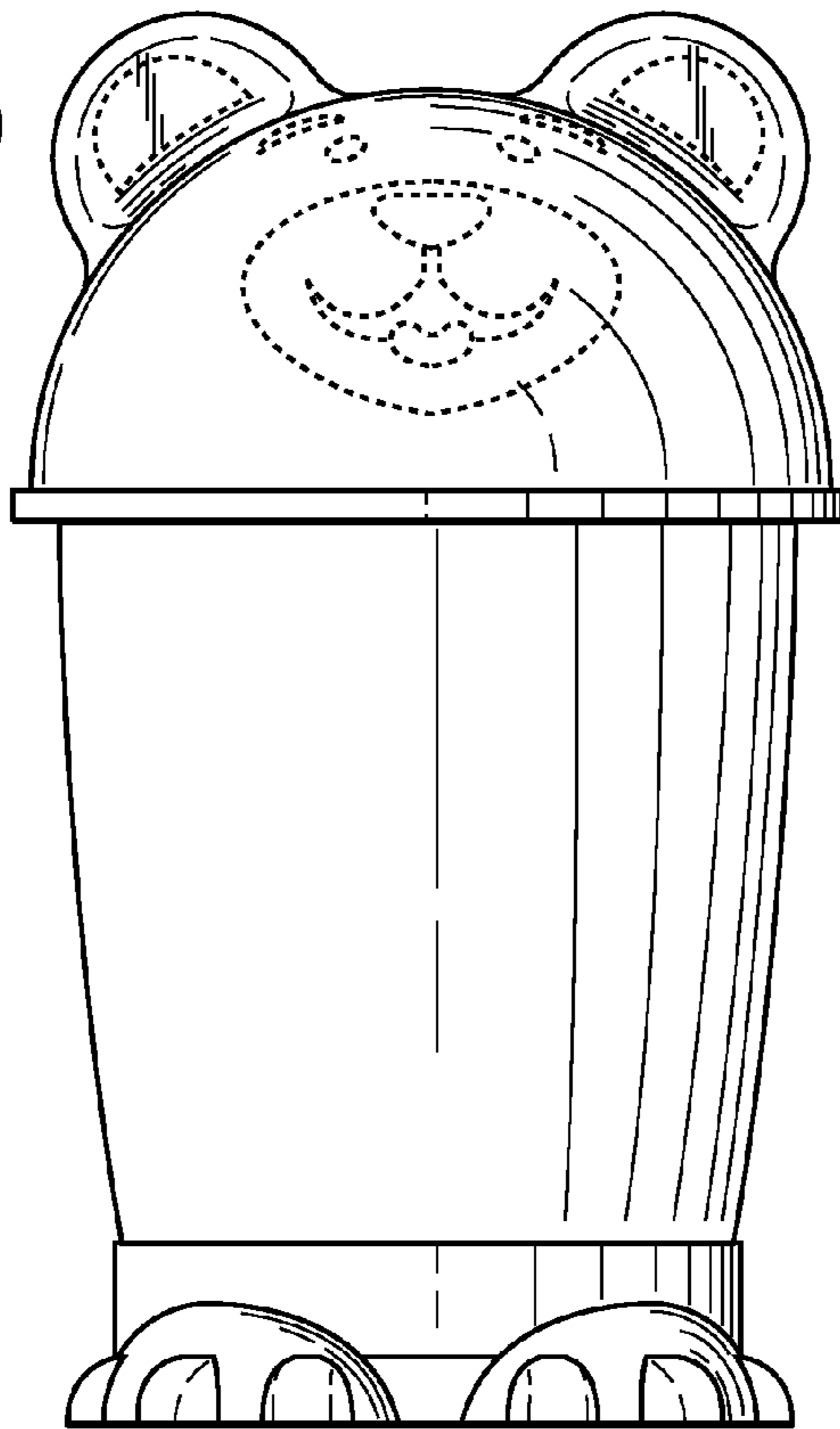

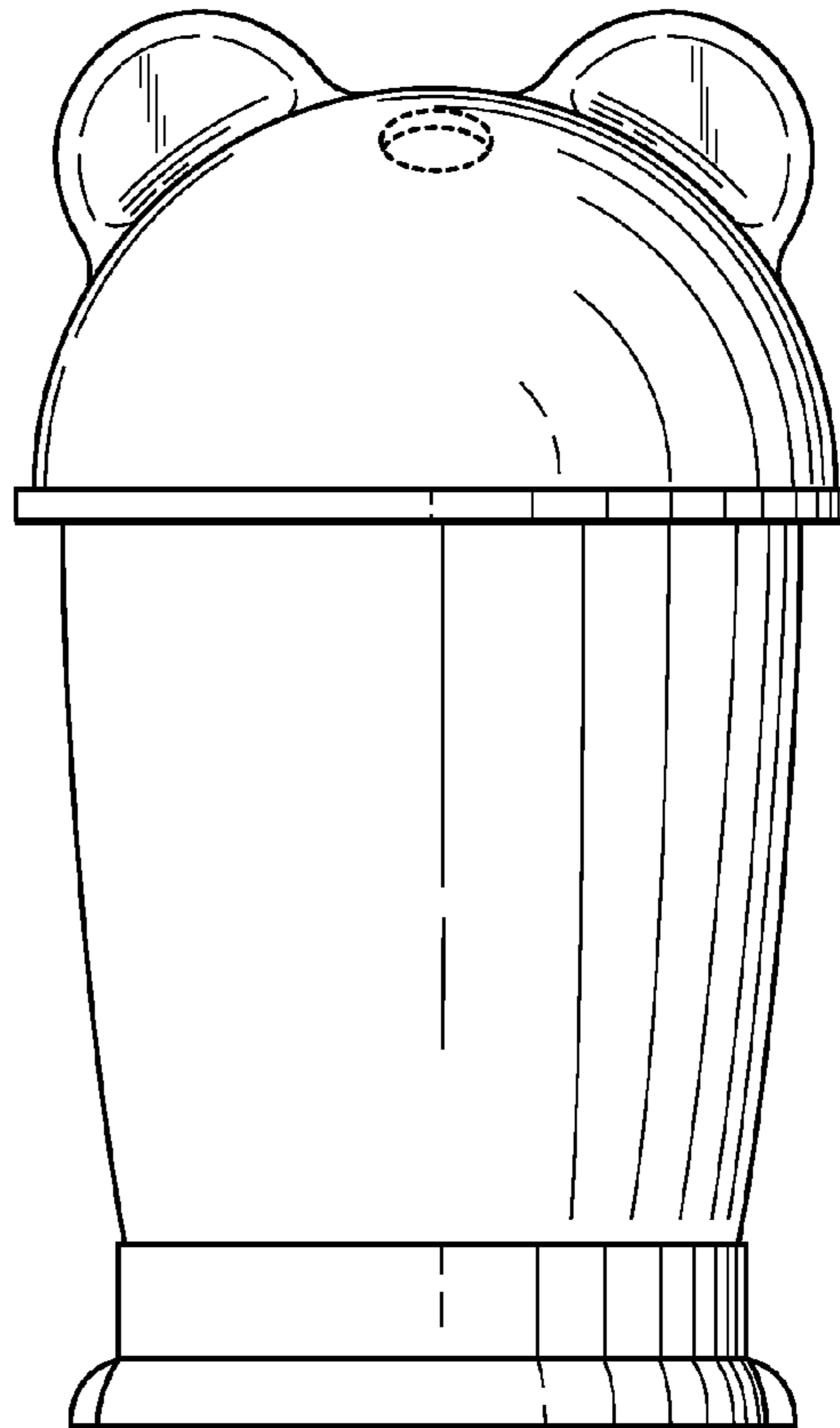
