FIG. 7 is a bottom view thereof.

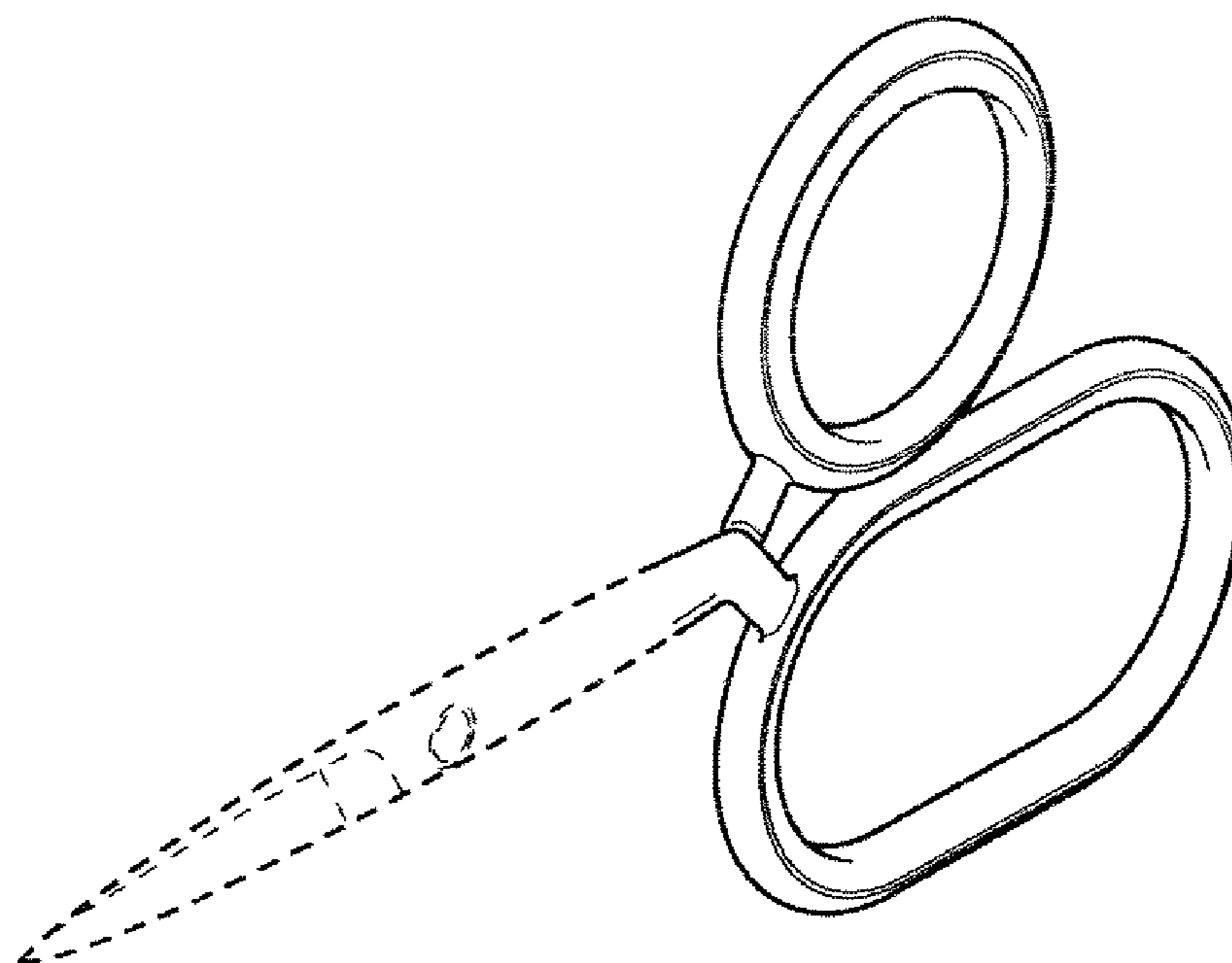
The broken lines showing the blades of the scissors are for illustrative purposes only and form no part of the claimed design.

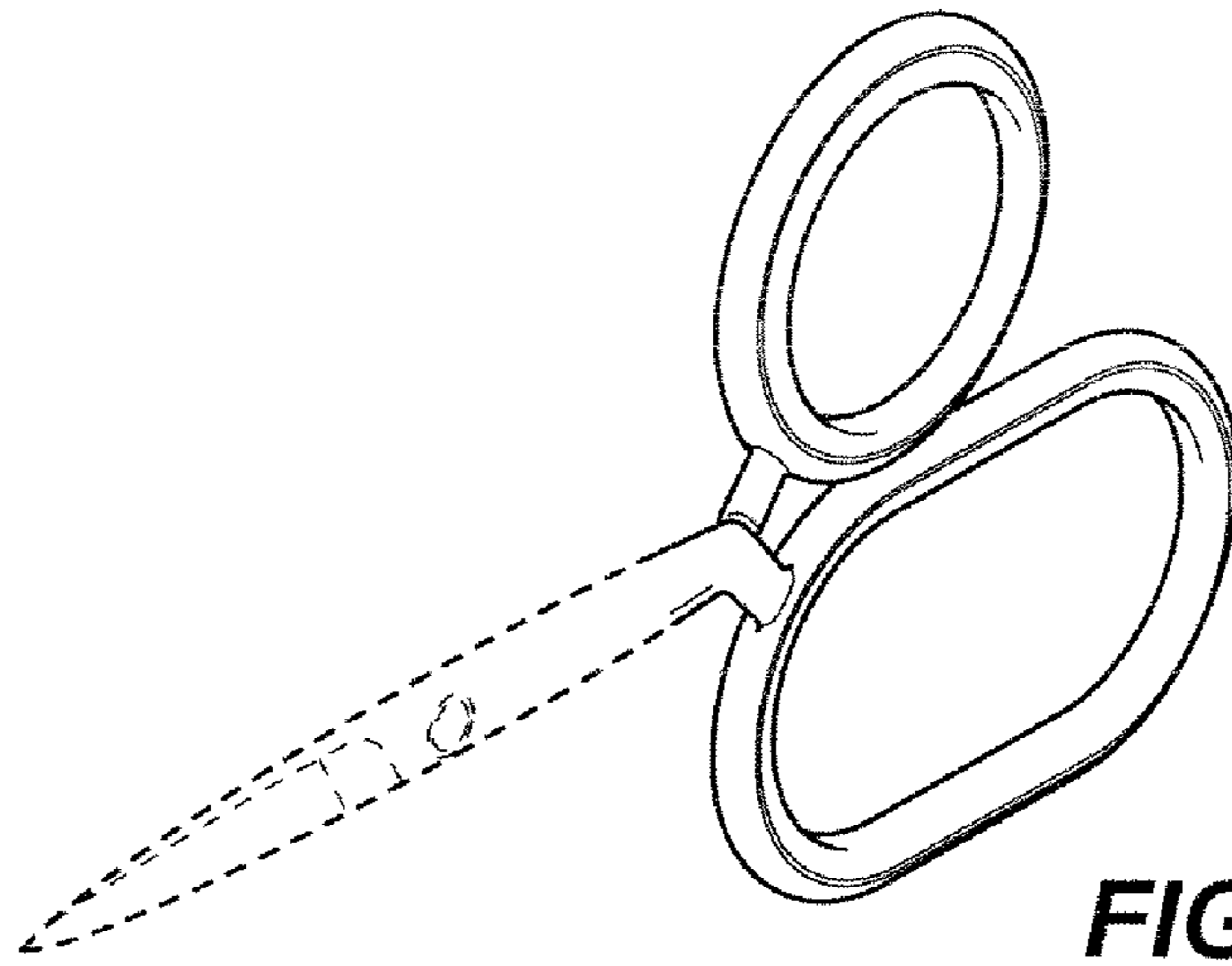

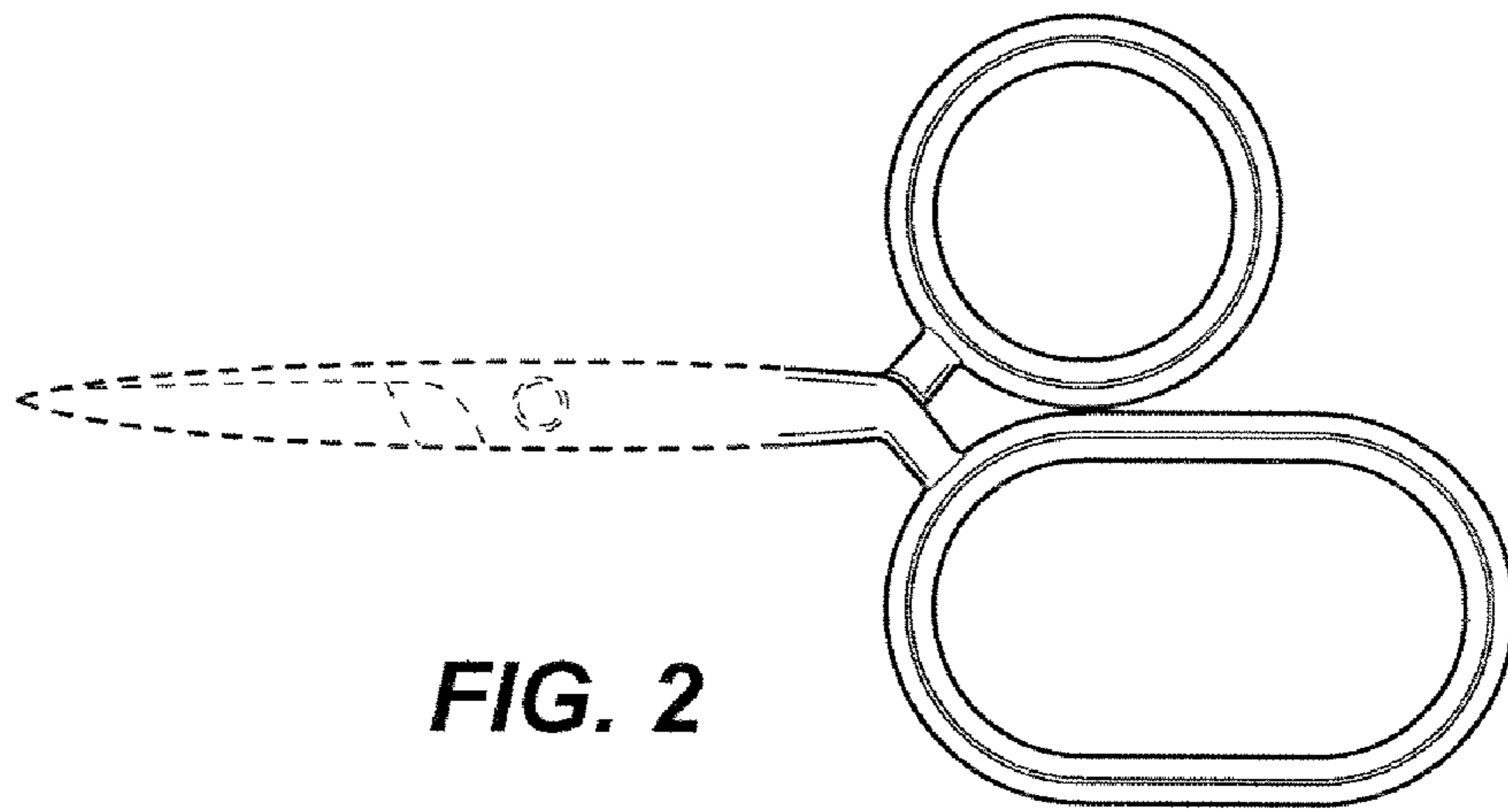

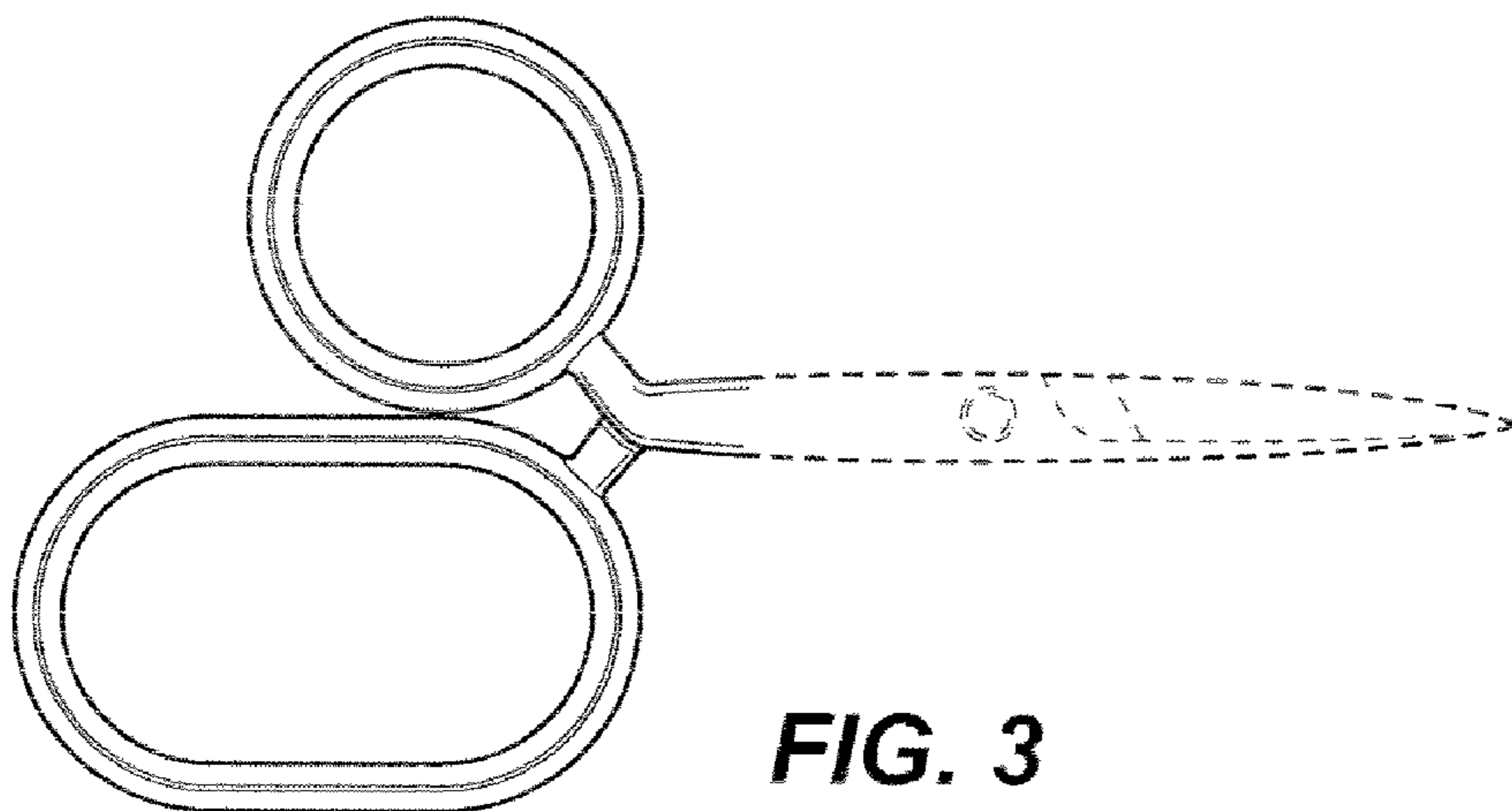
