FIG. 1 is a perspective view of a perfume applicator showing our new design.

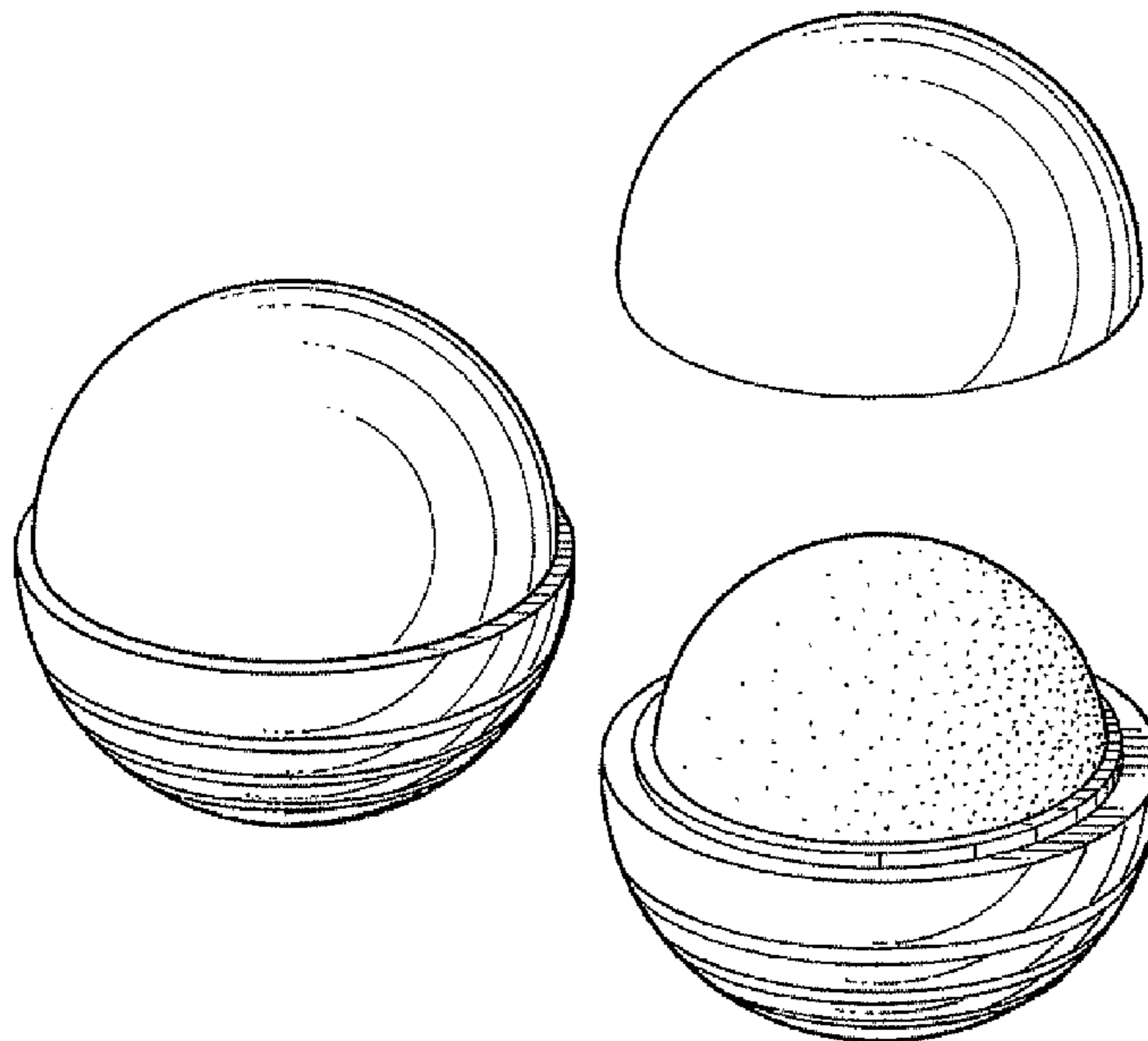
FIG. 2 is an exploded perspective view thereof;

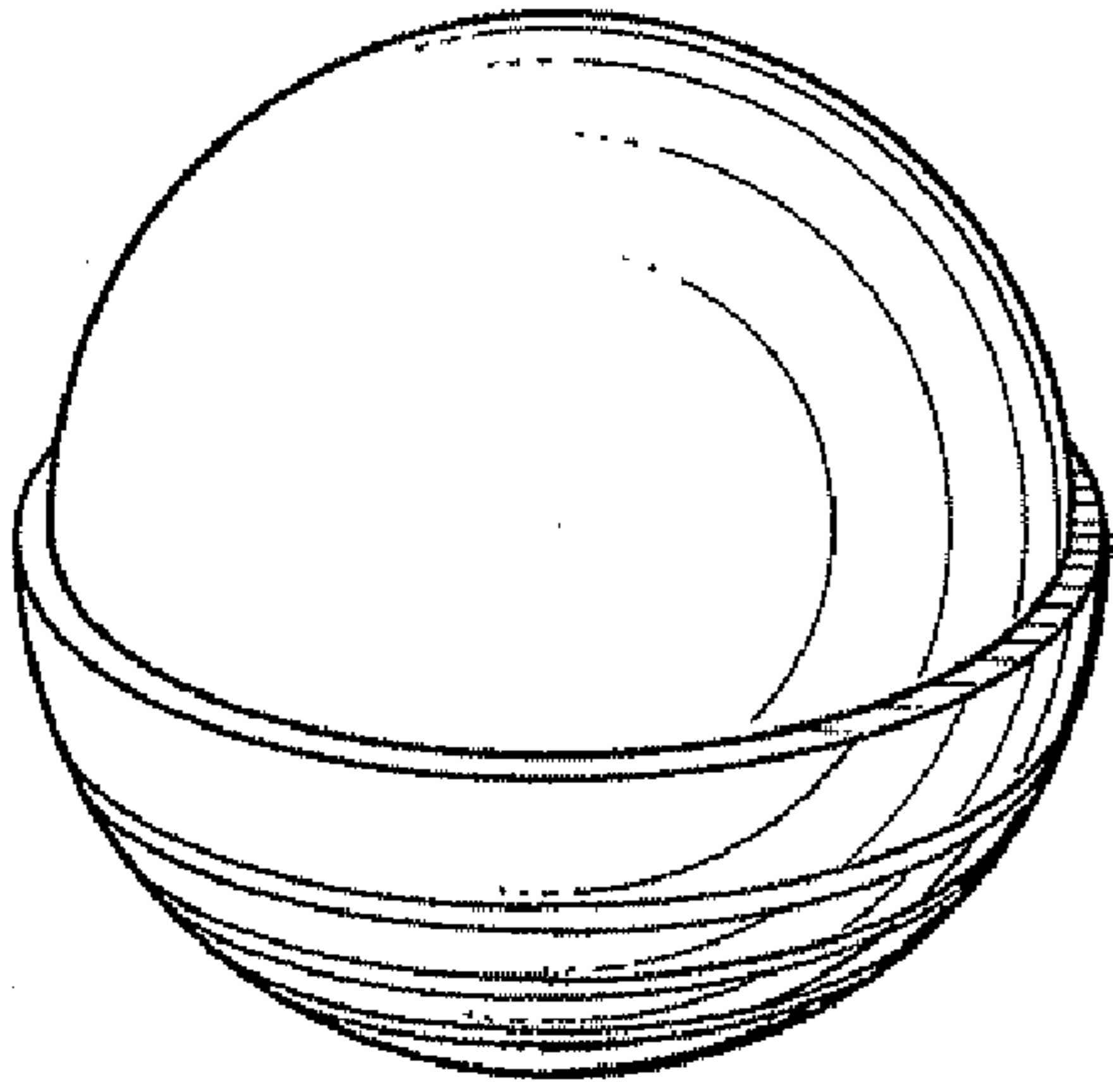

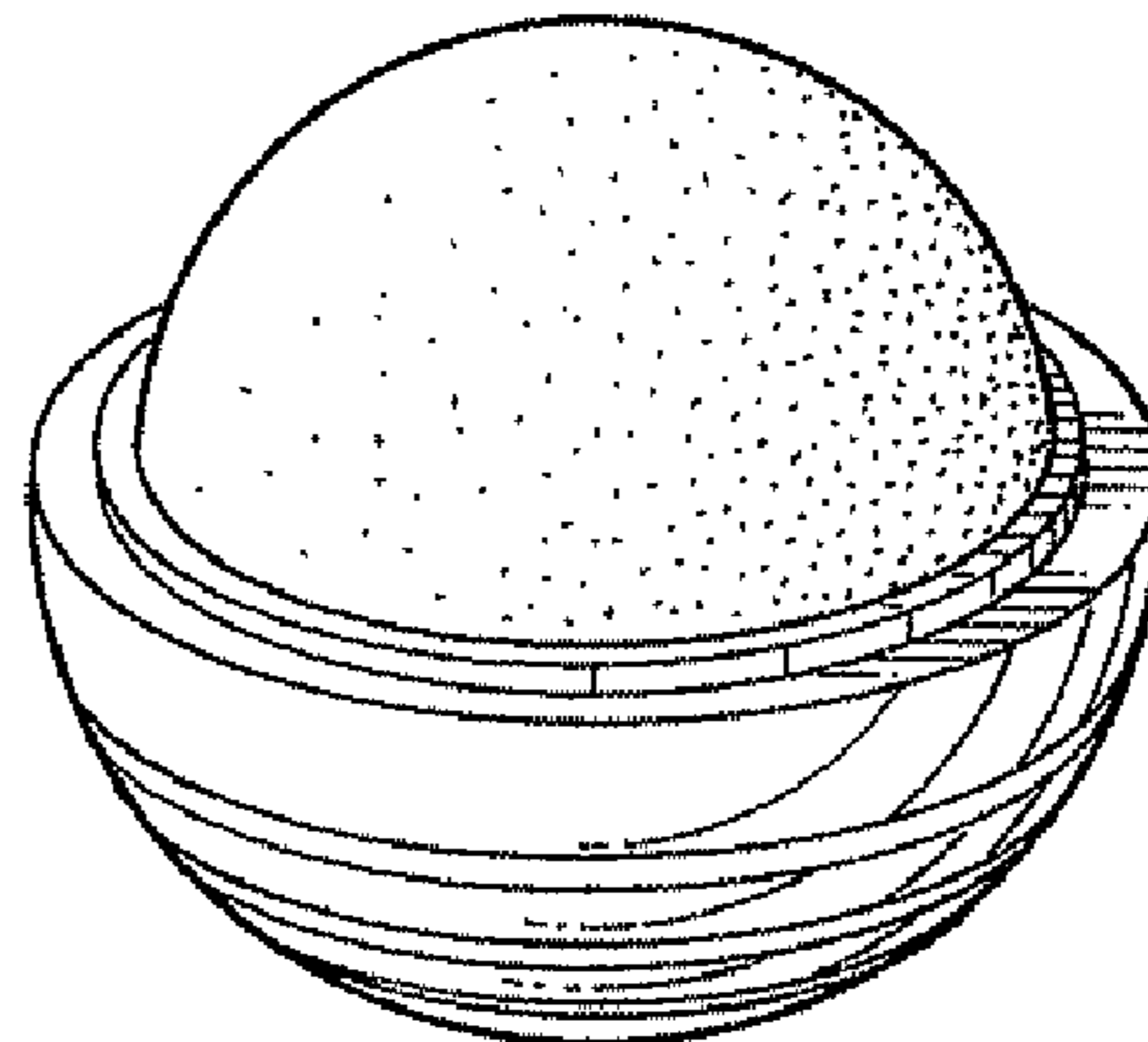
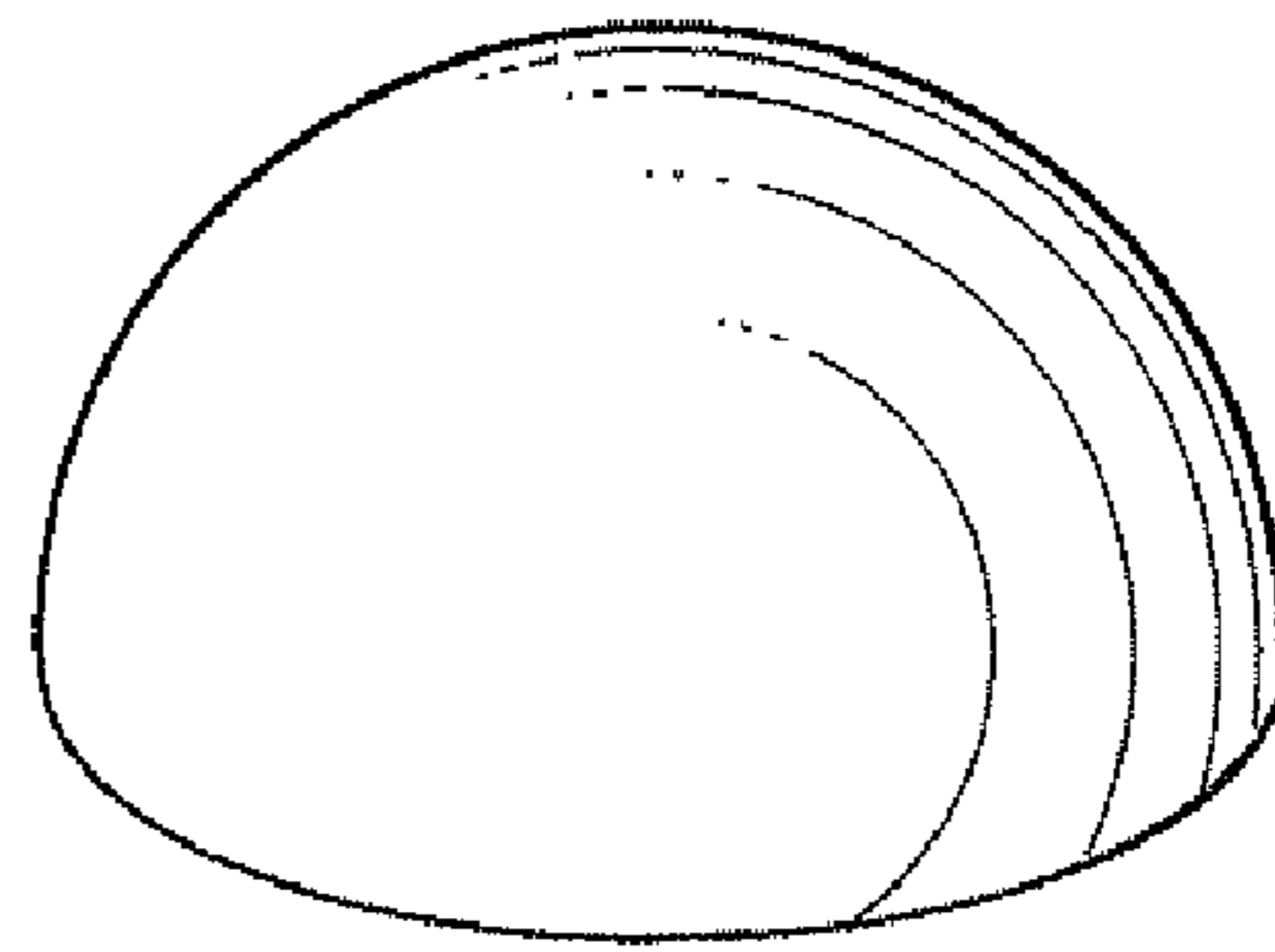

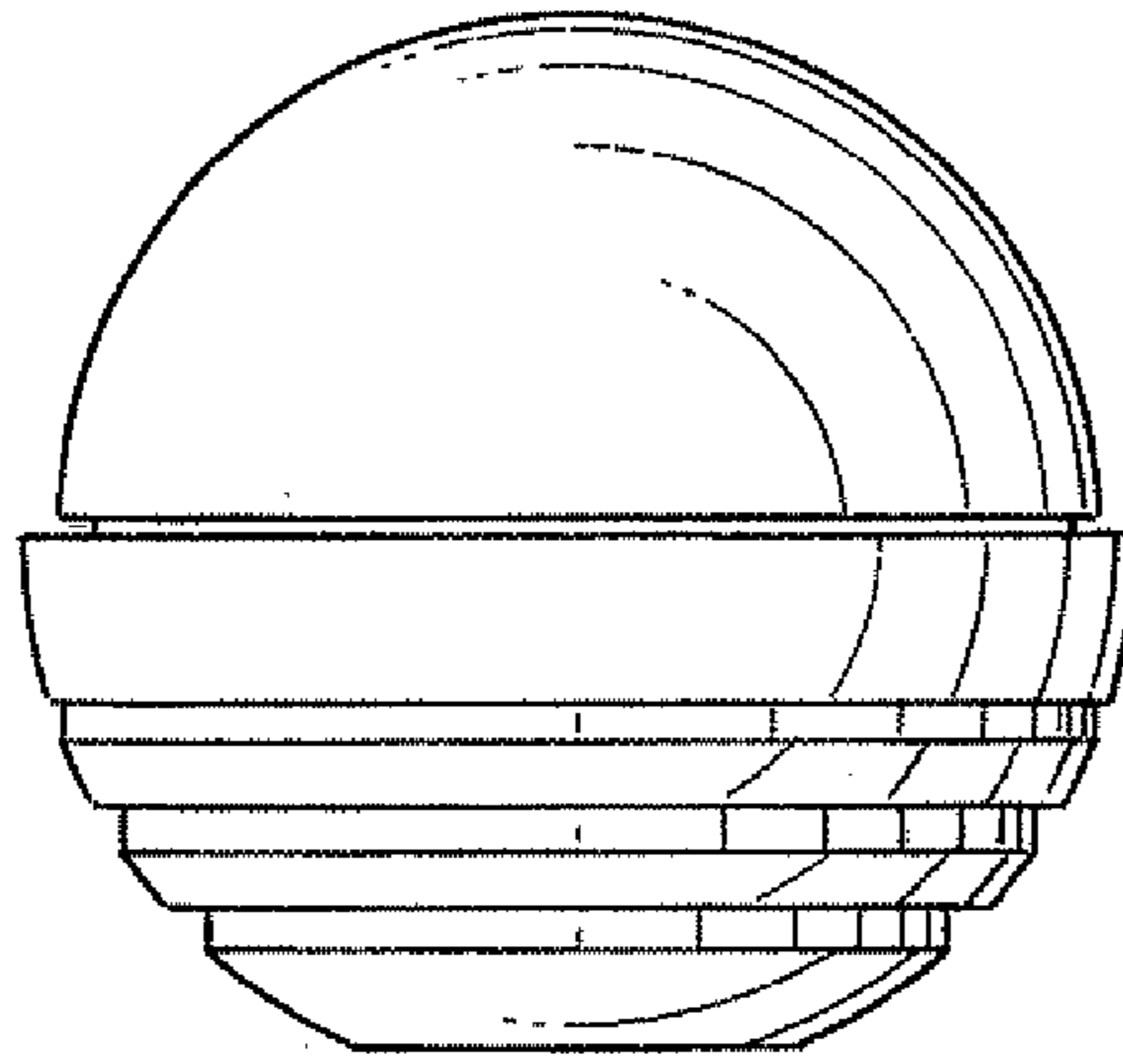

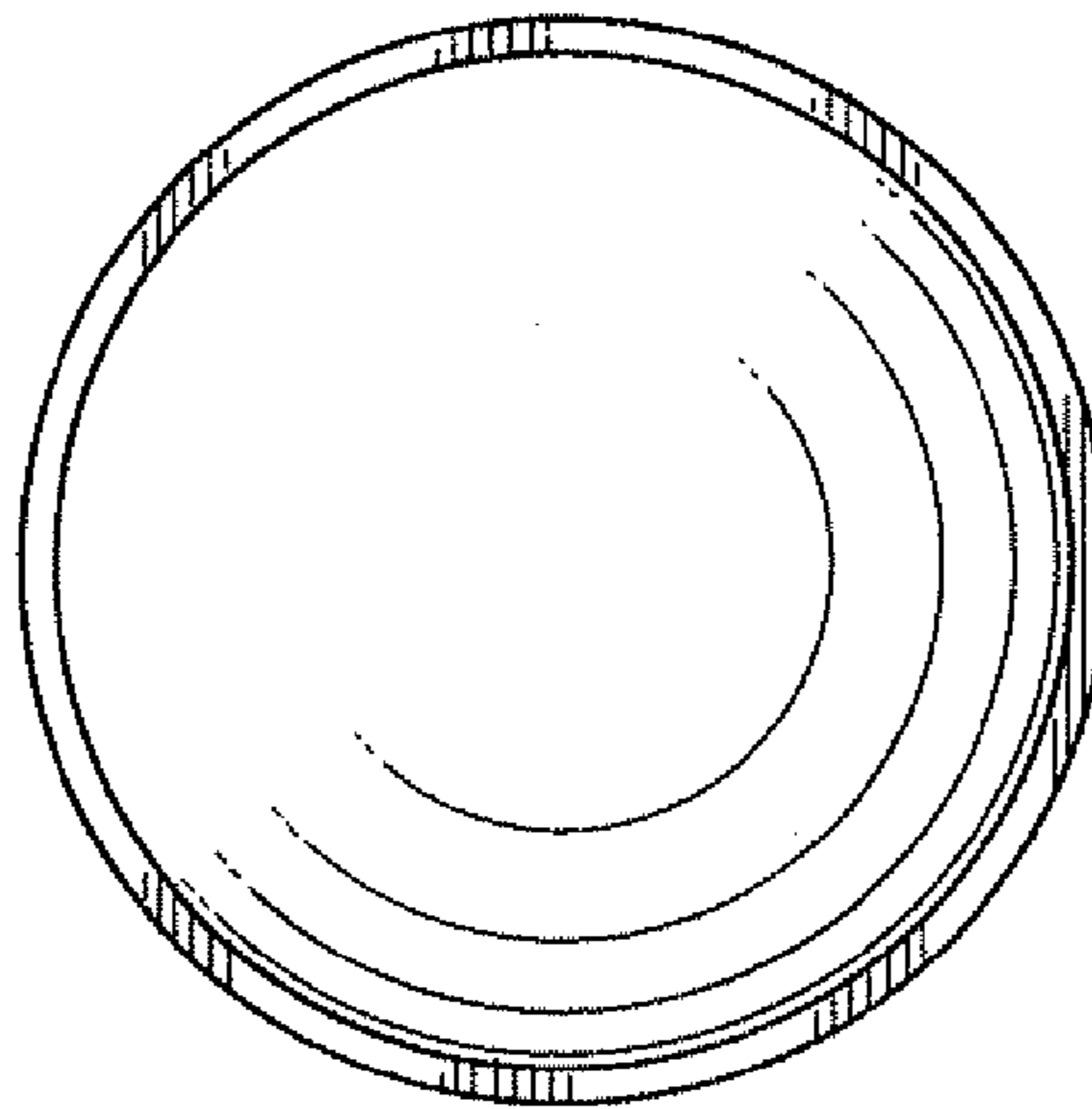
