The ornamental design for a watch case, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a watch case showing my new design;

FIG. 2 is a front elevational view thereof; the back elevational view being a mirror image of the front elevational view;

FIG. 3 is a right elevational view thereof;

FIG. 4 is a left elevational view thereof;

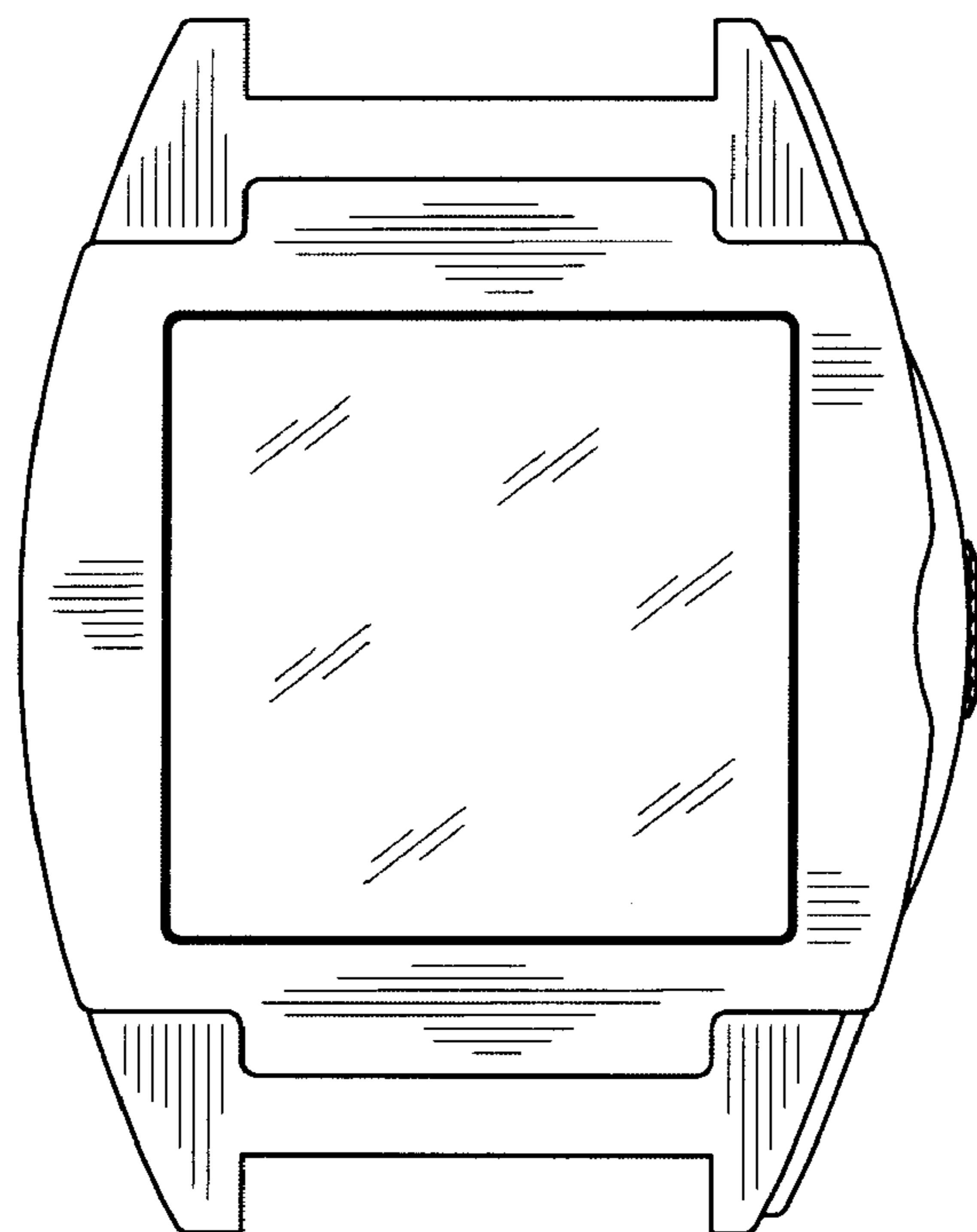
FIG. 5 is a top plan view thereof;

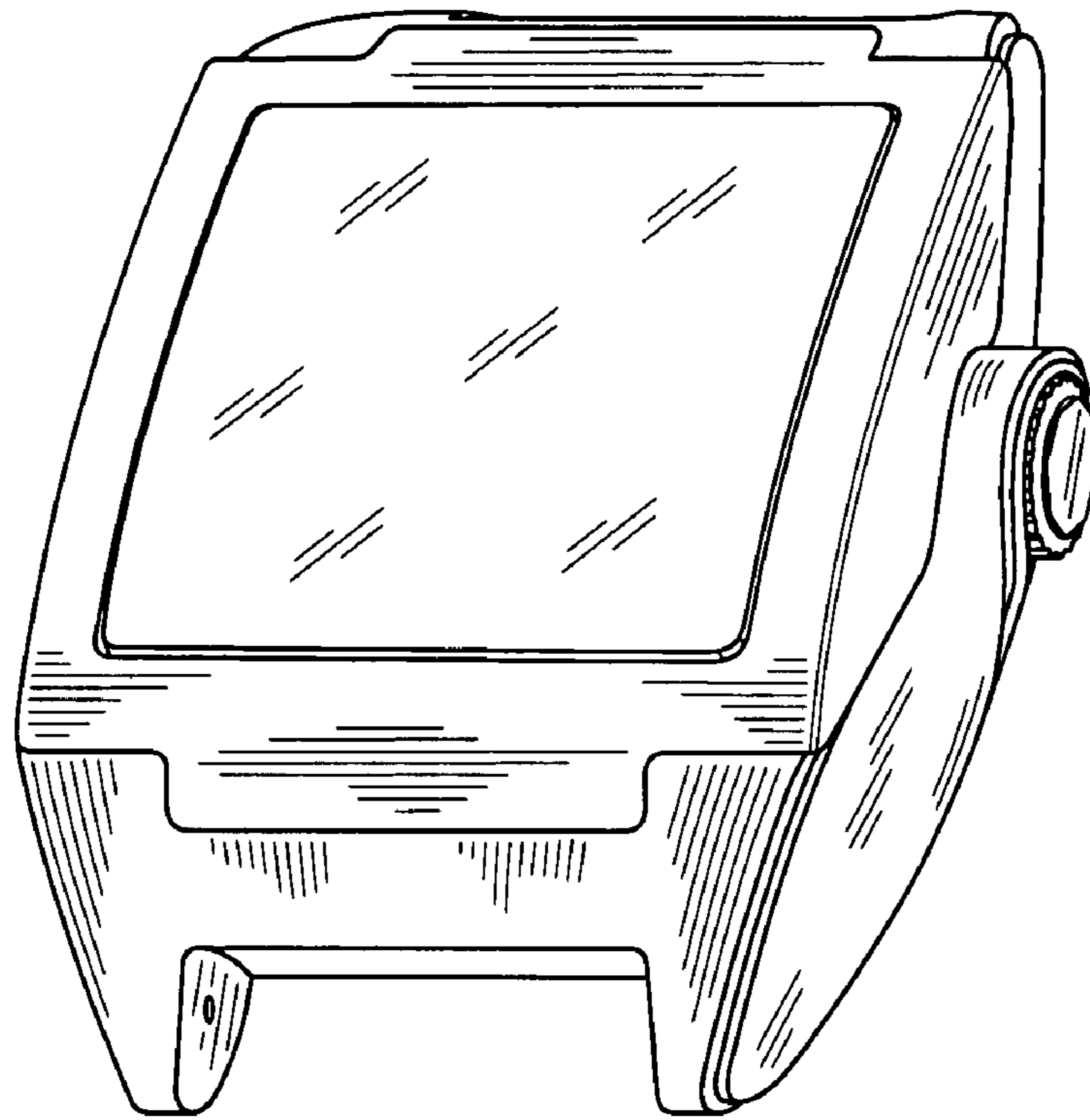

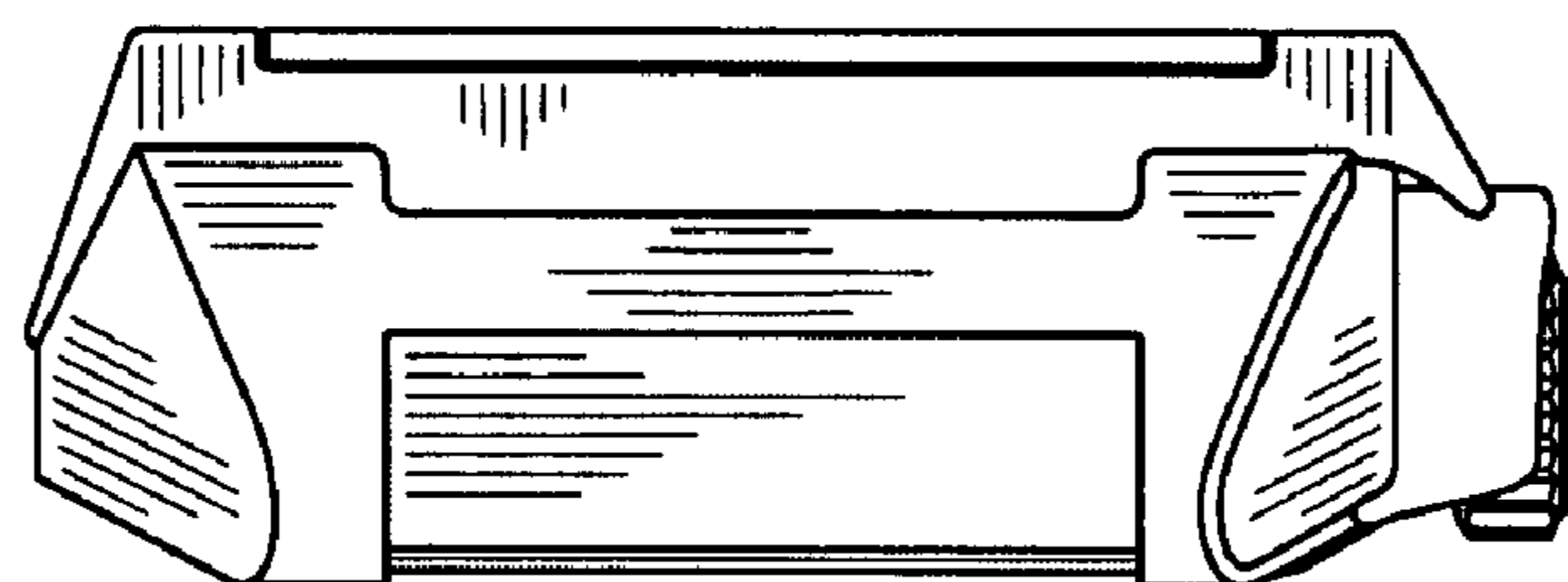

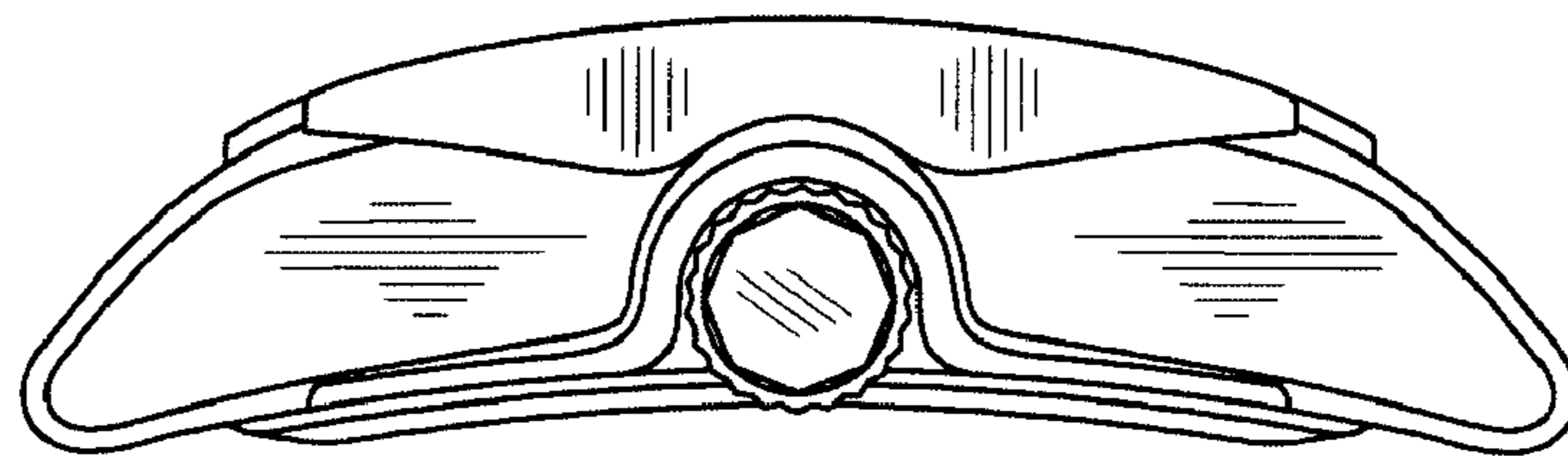

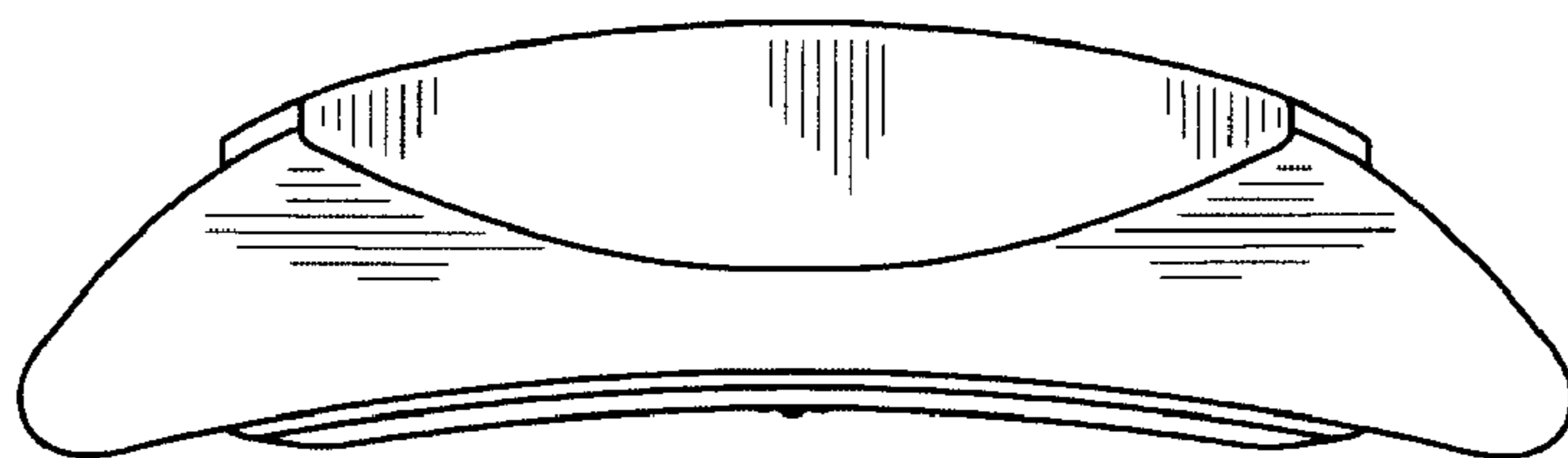

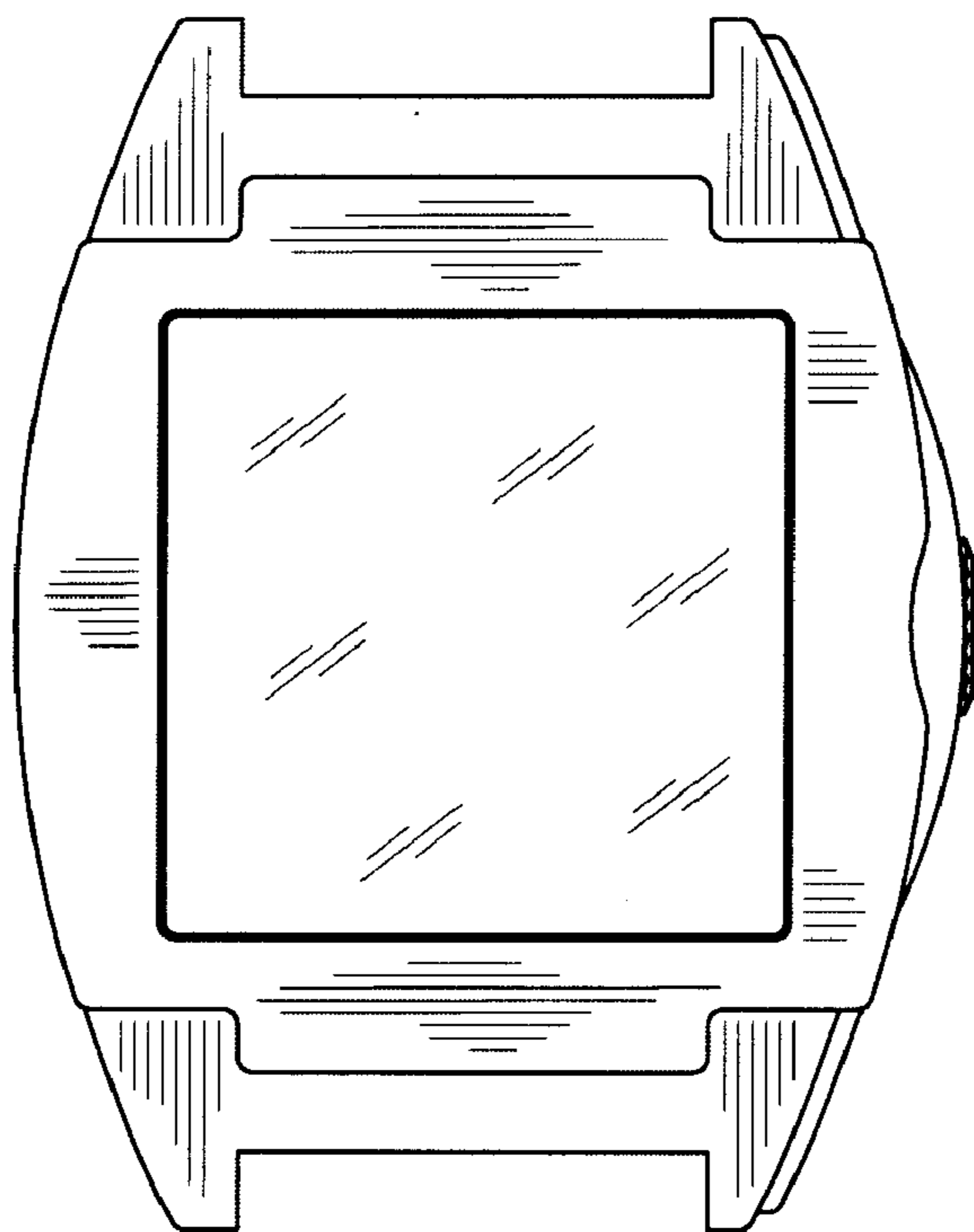

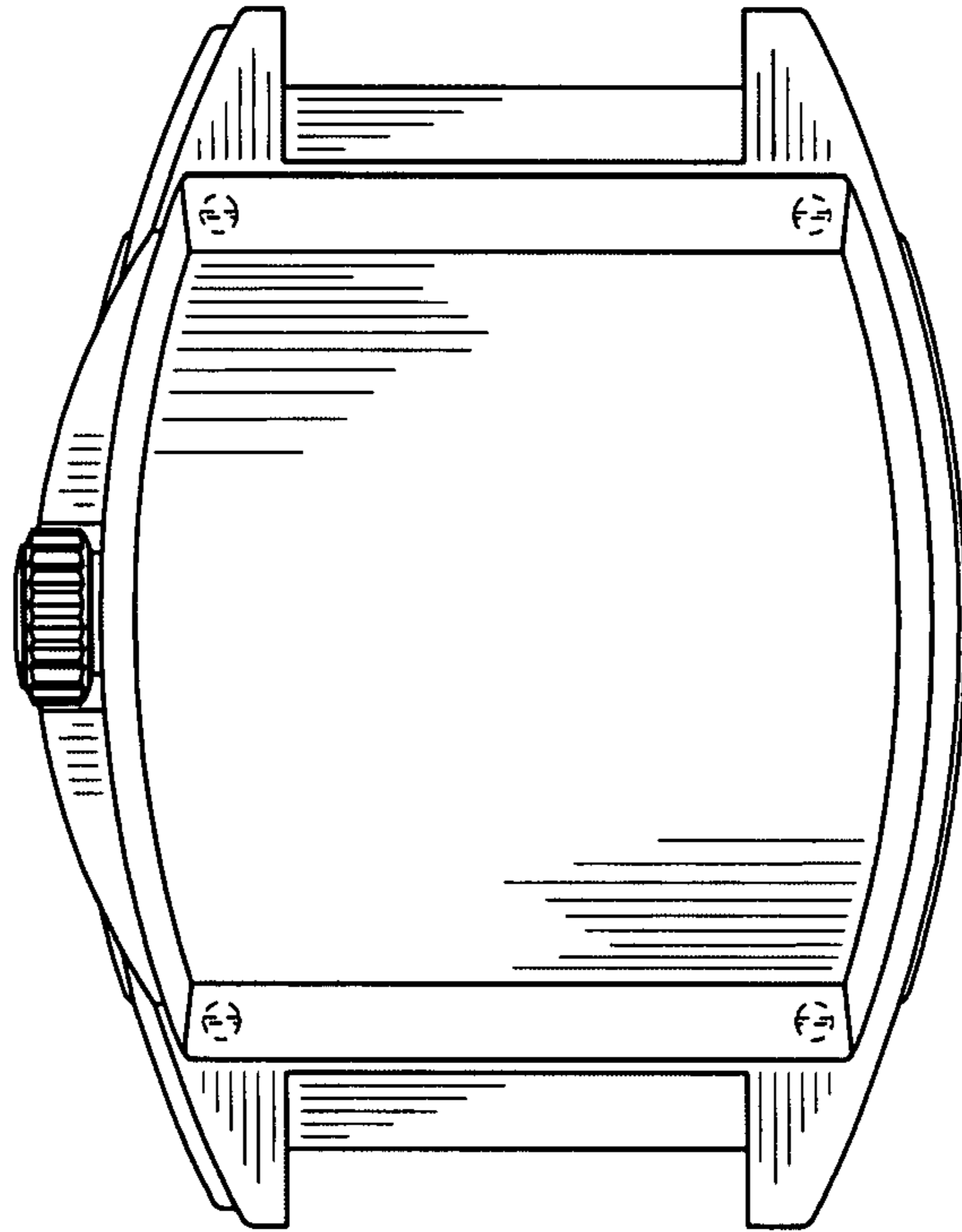

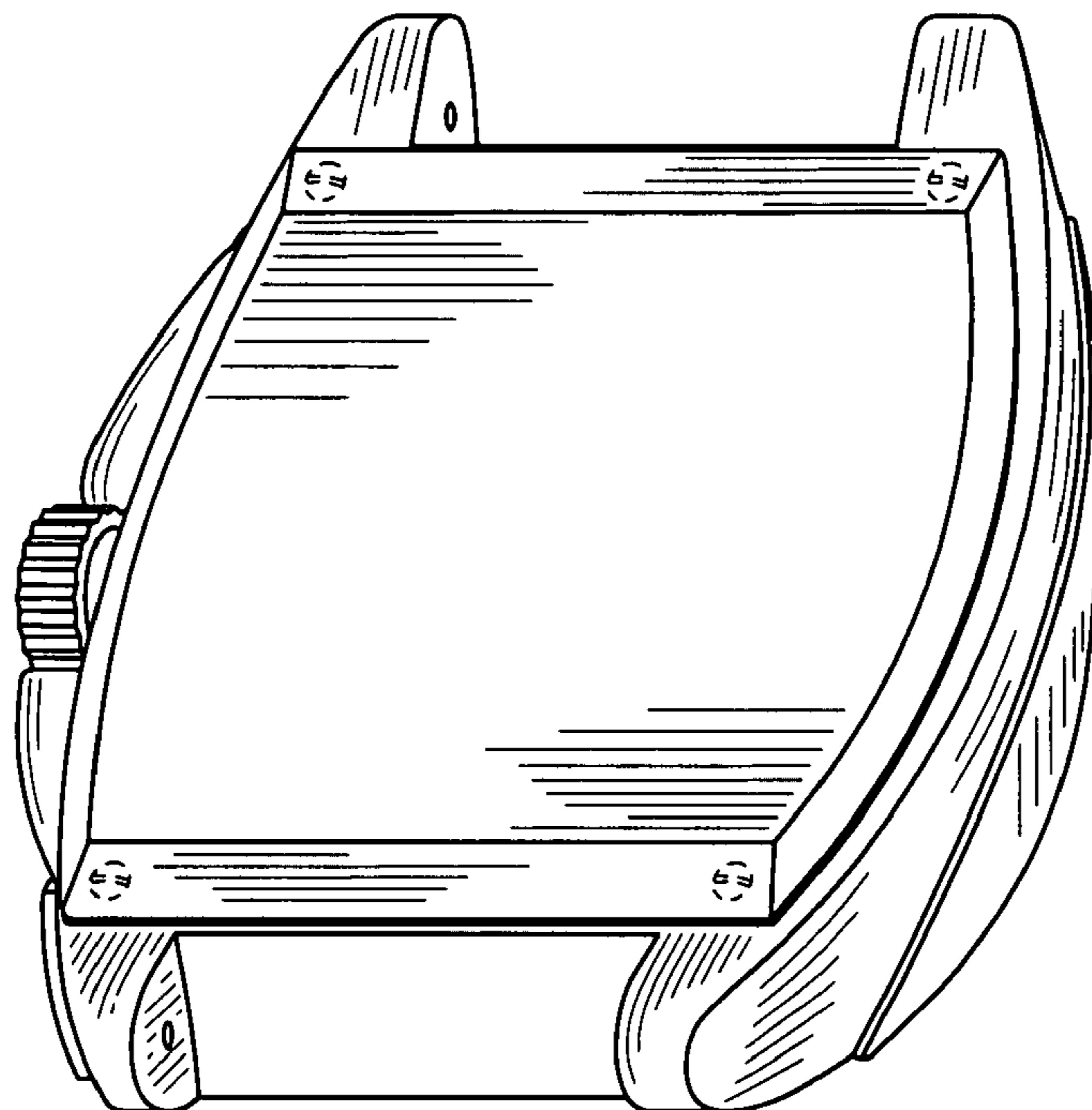
