FIG. 11 is a front perspective view thereof in a closed position; and,

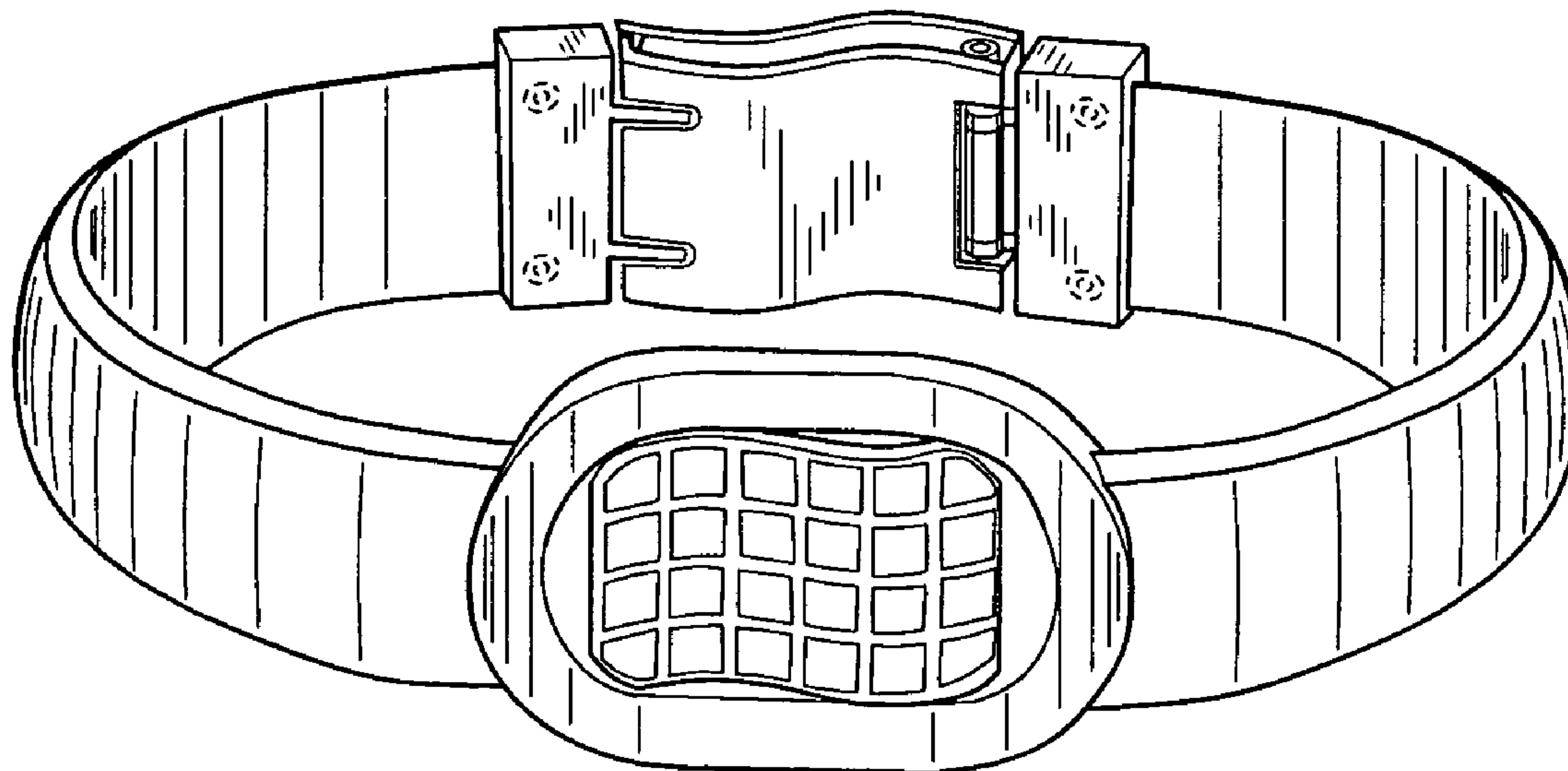

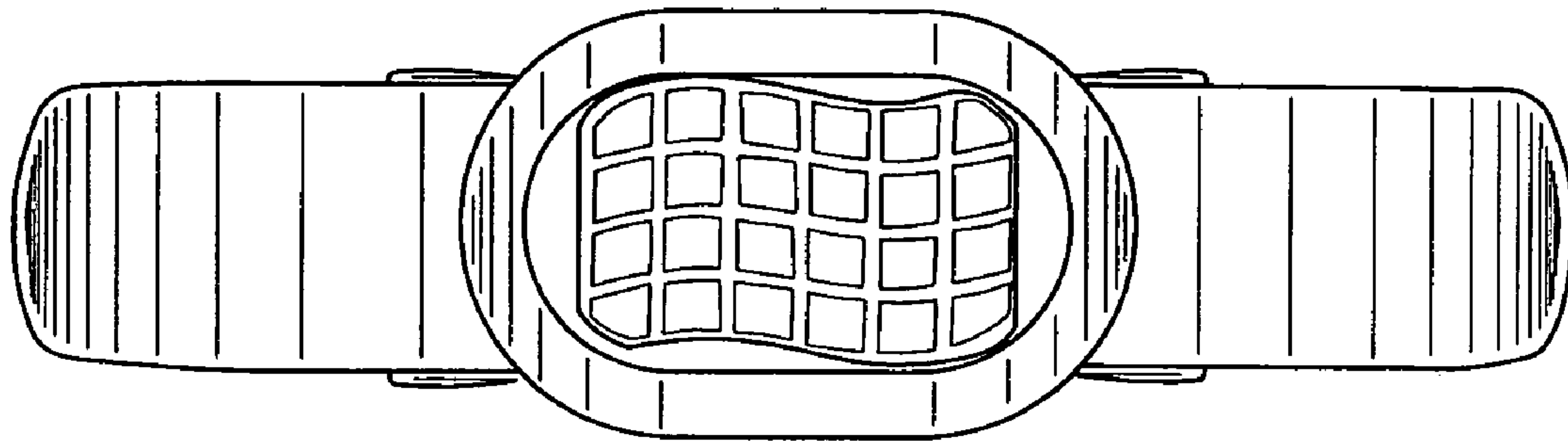

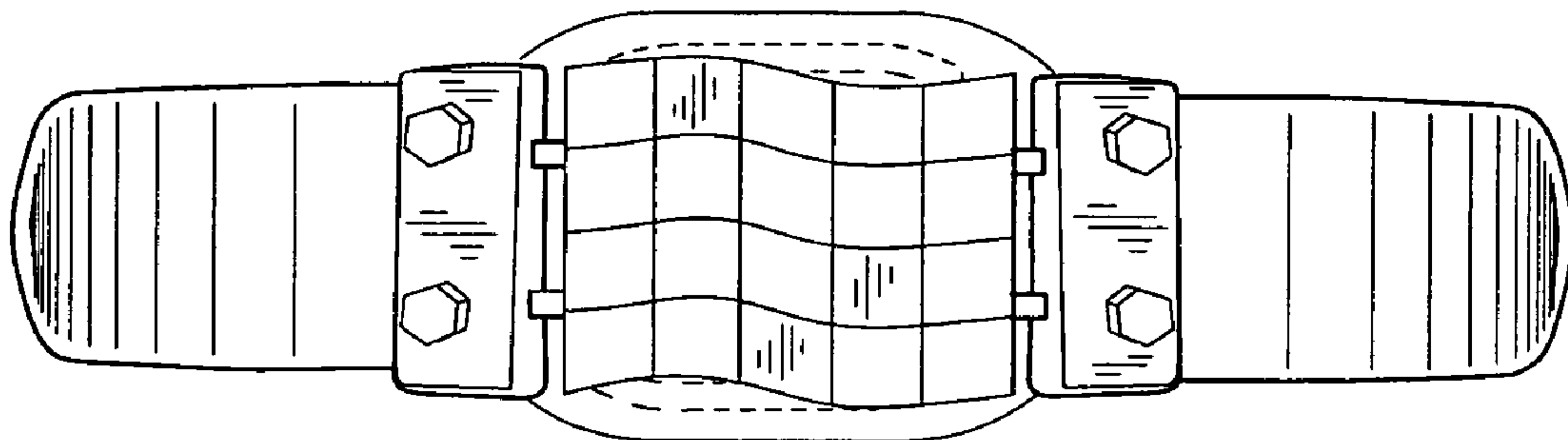

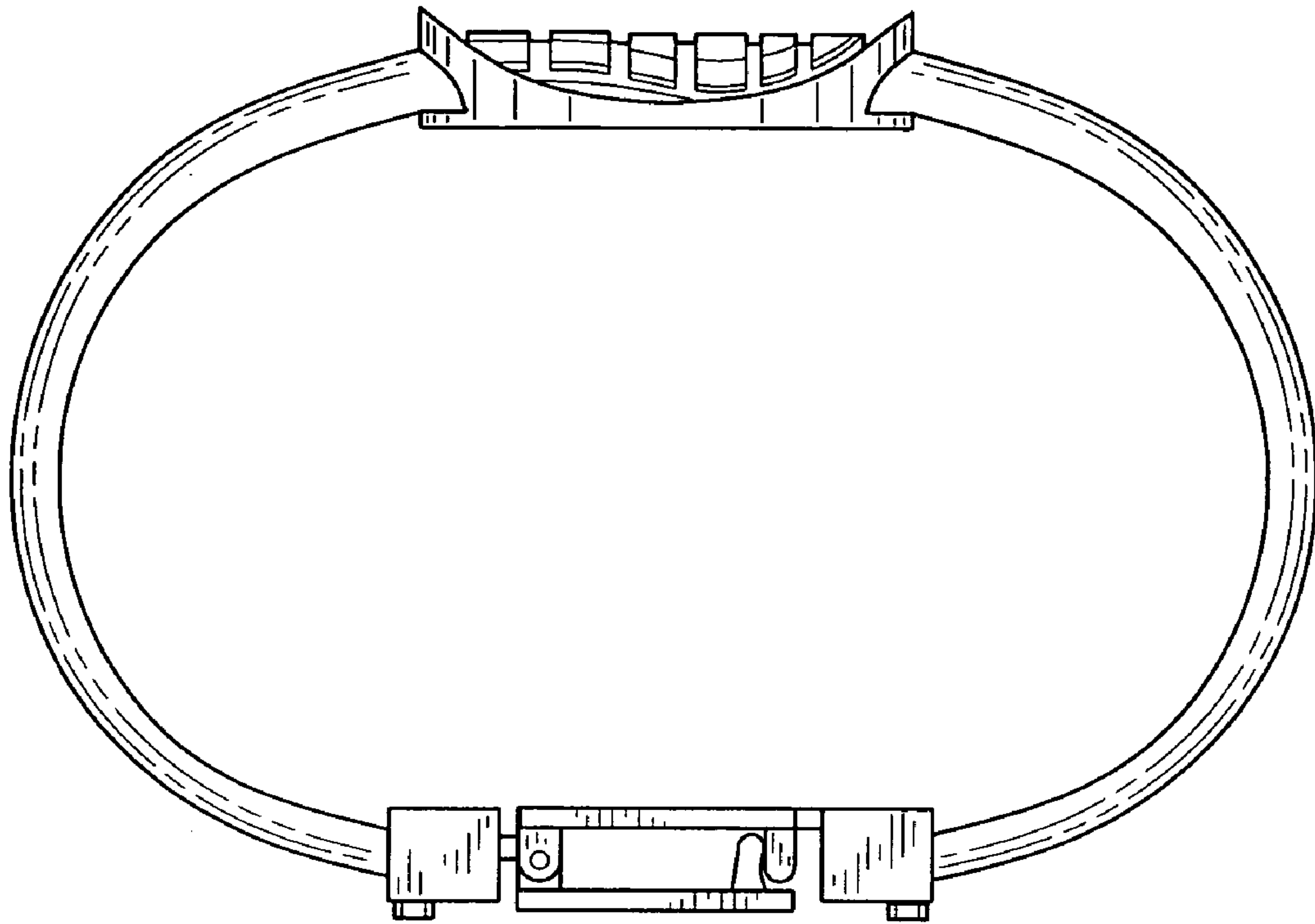

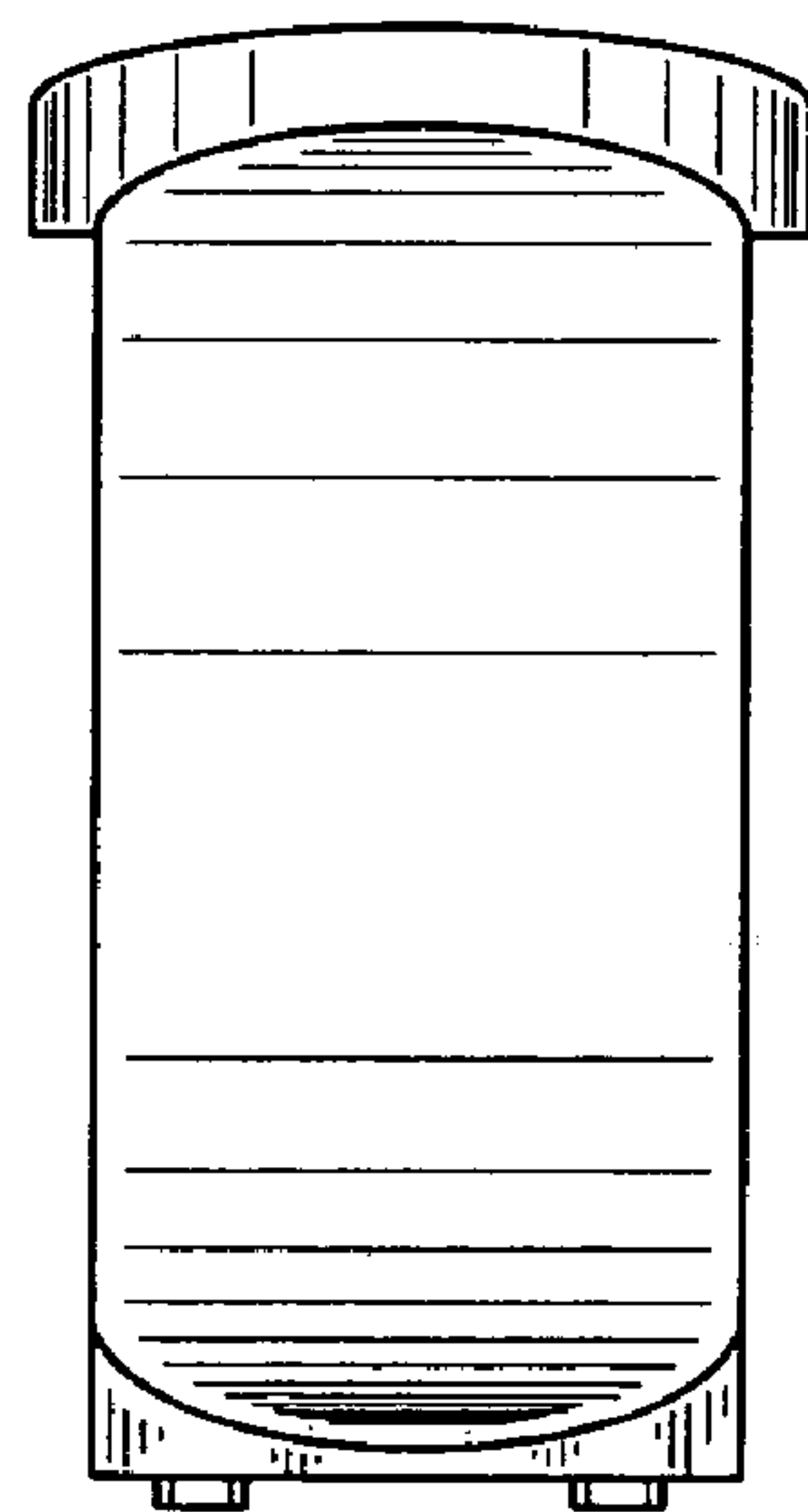

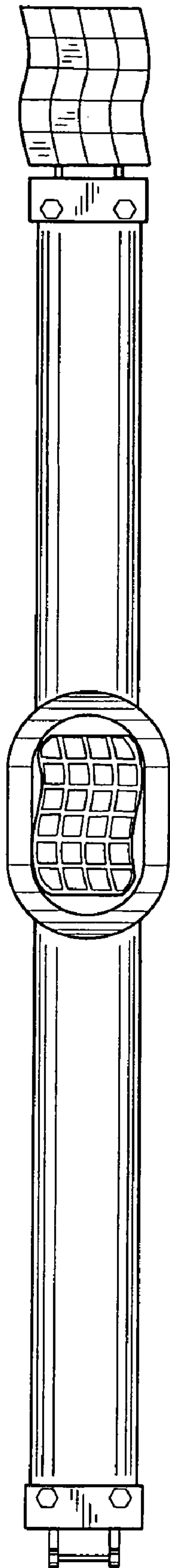

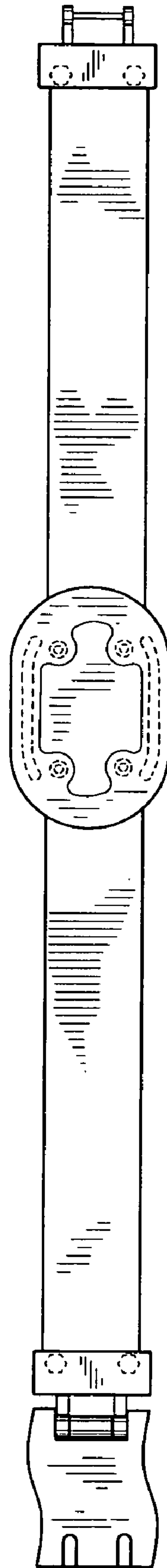

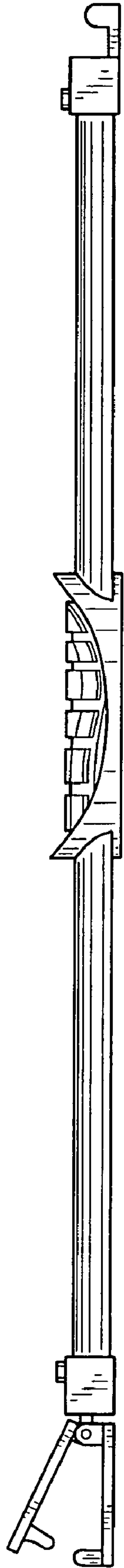

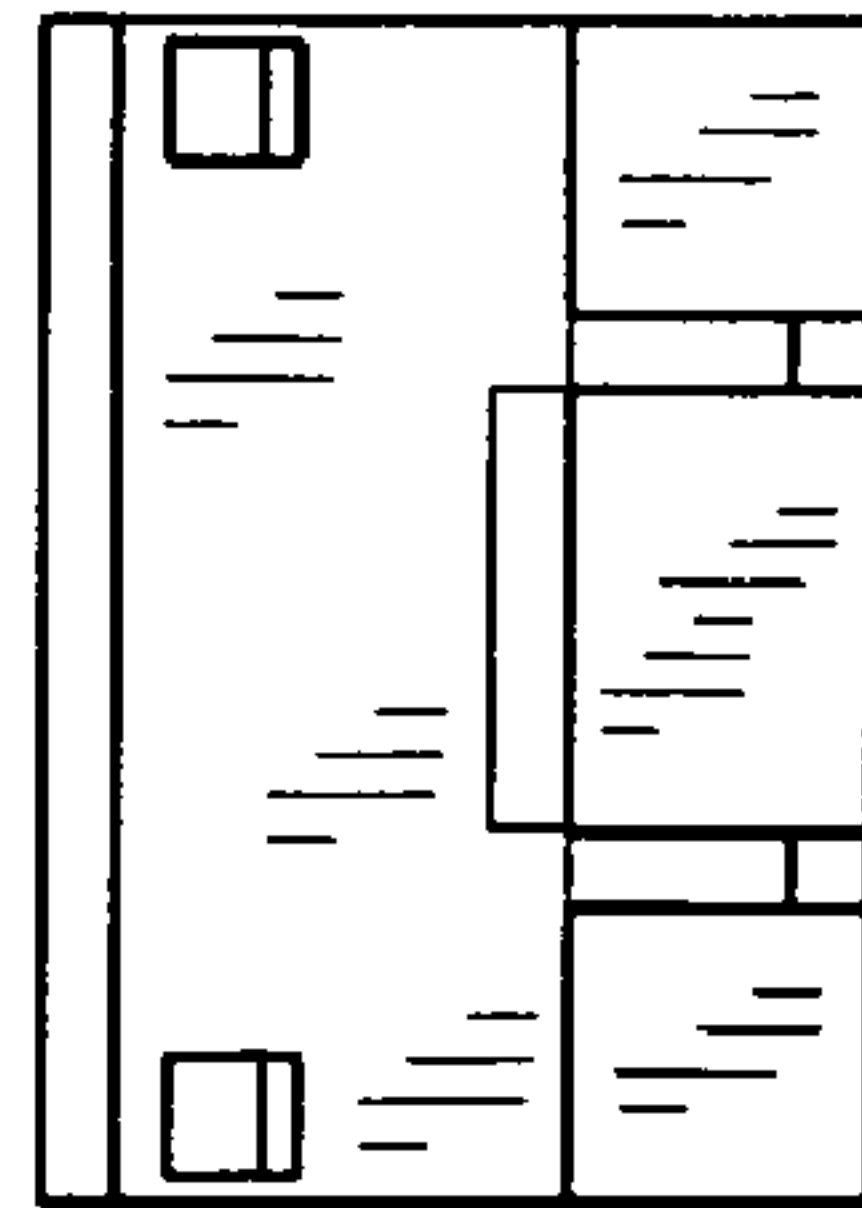

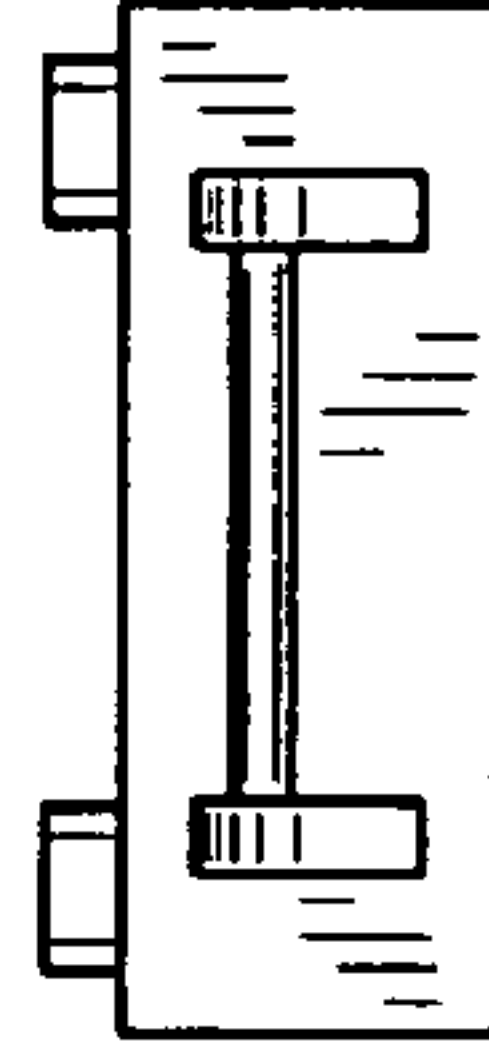

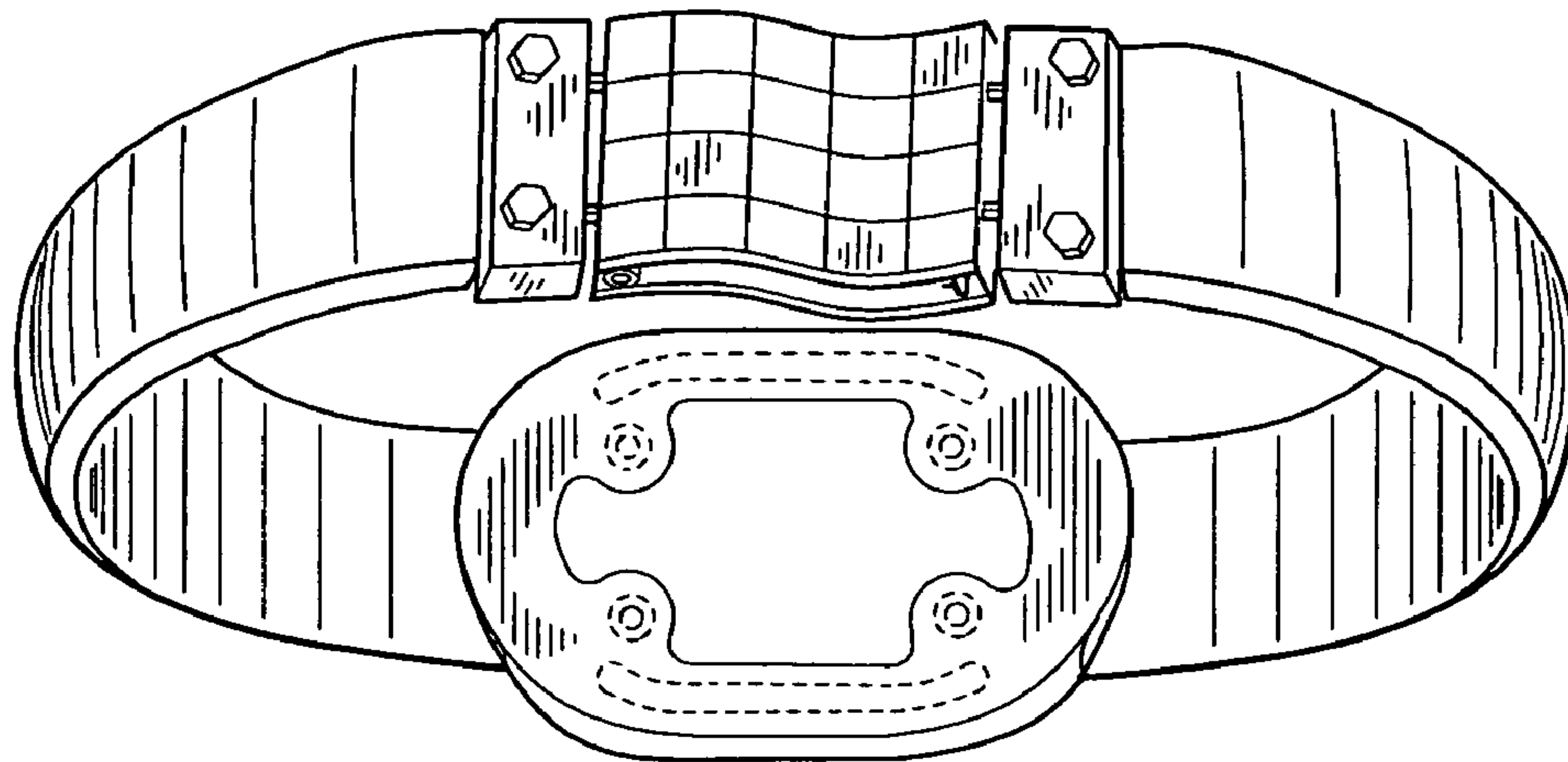

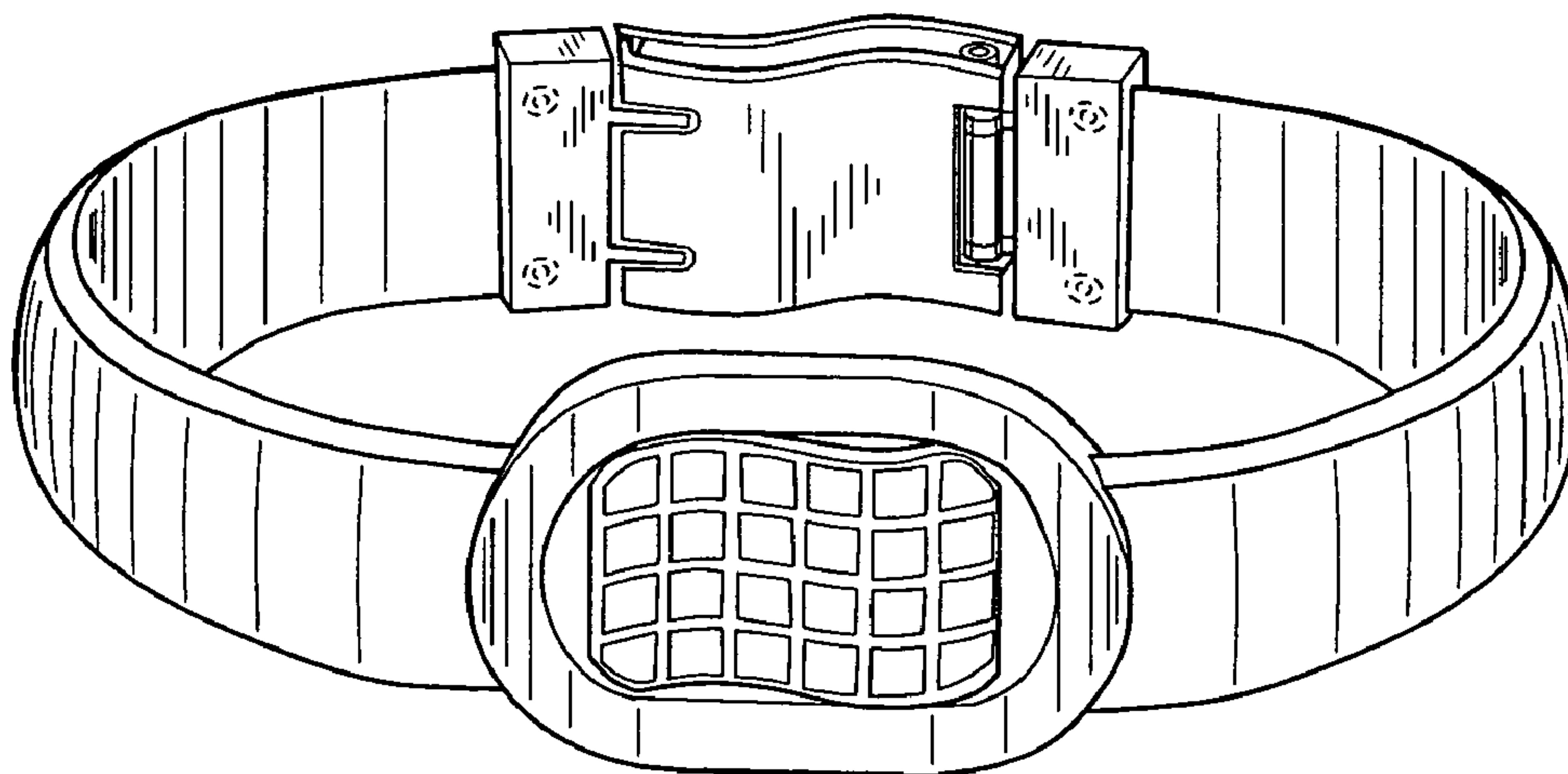

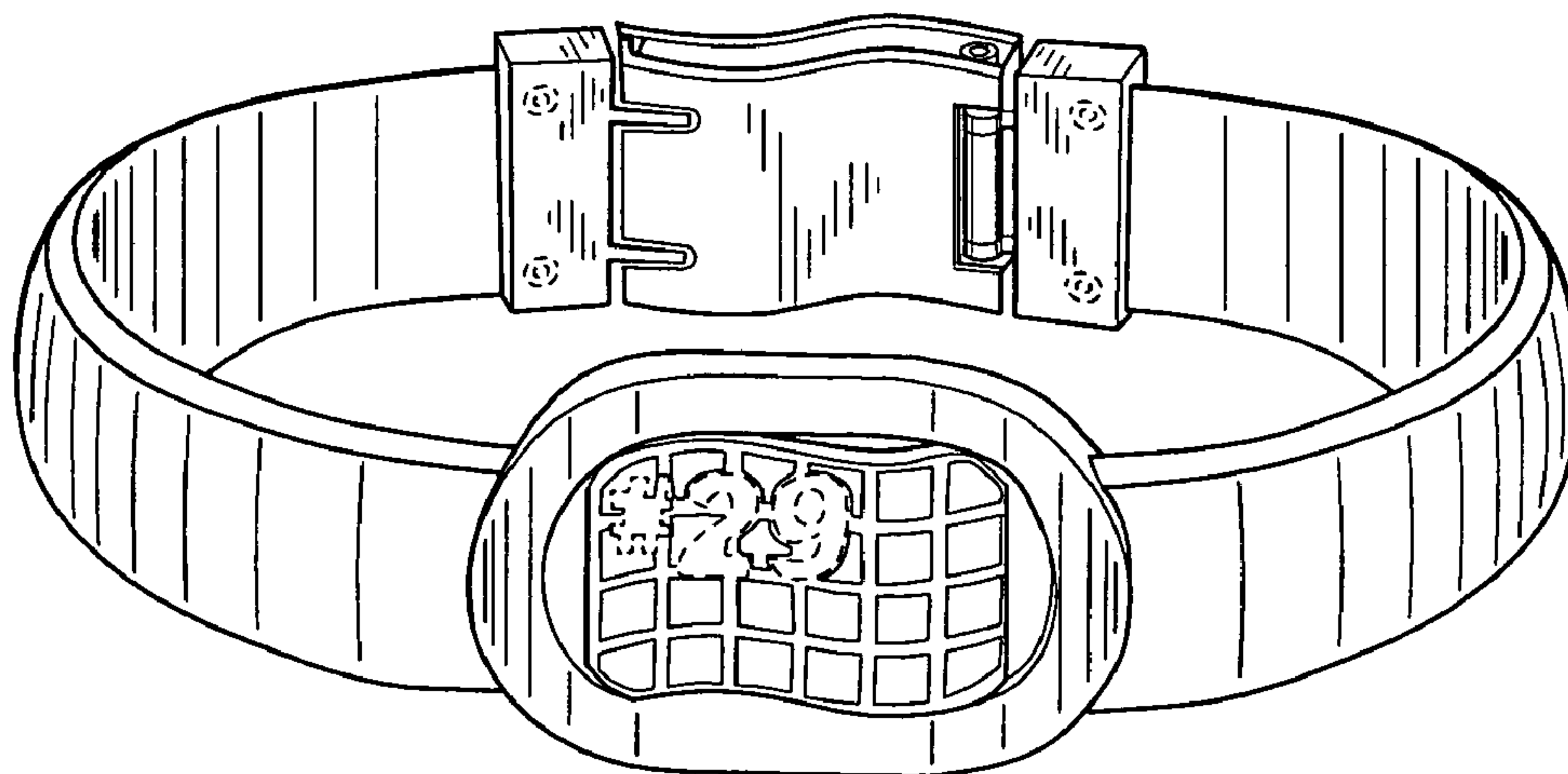
