DESCRIPTION

FIG. 1 is a perspective view of a mobile power source according to our new design;

FIG. 4 is a top plan view of the mobile power source of FIG. 1;

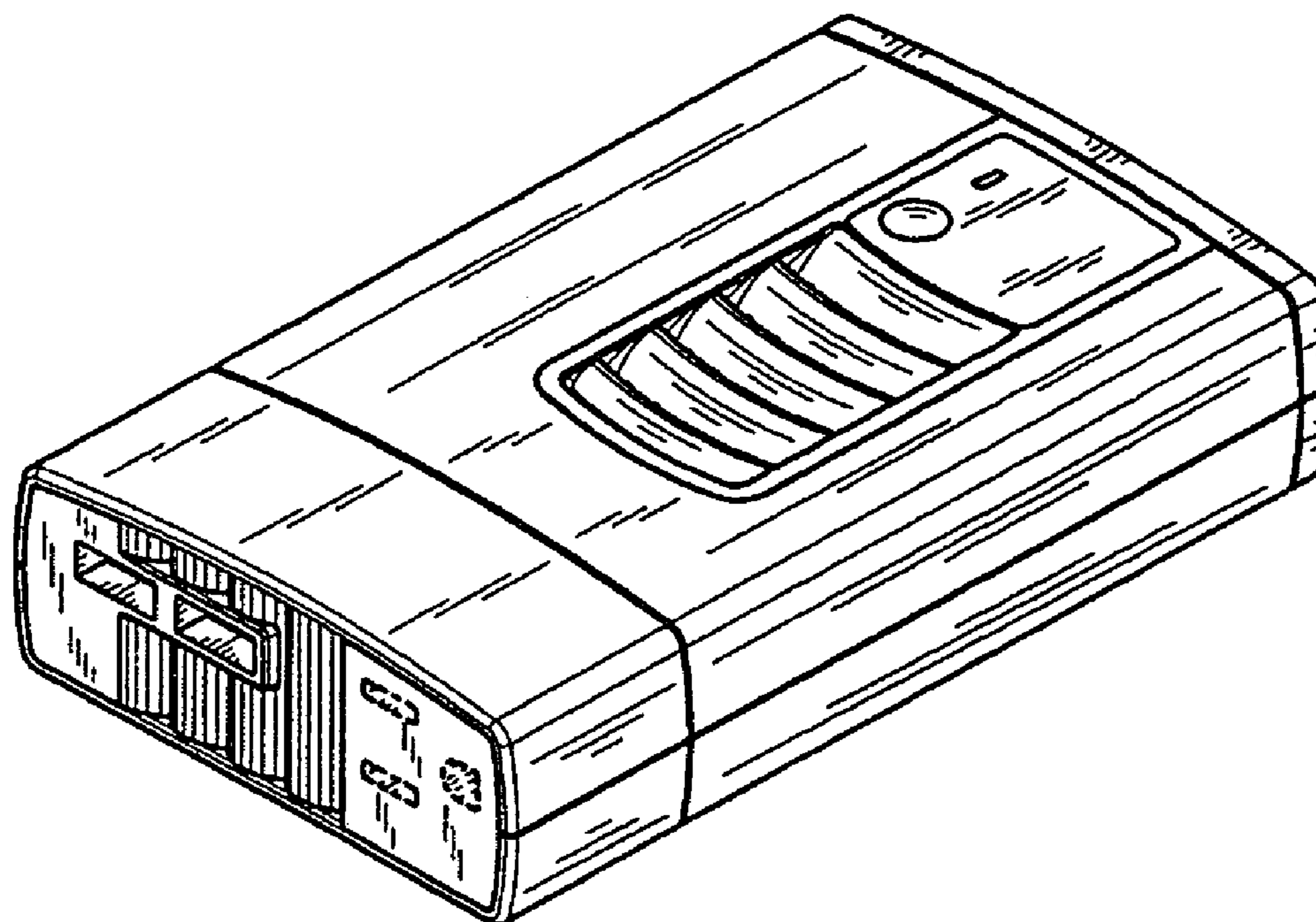
FIG. 5 is a bottom view of the mobile power source of FIG. 1;

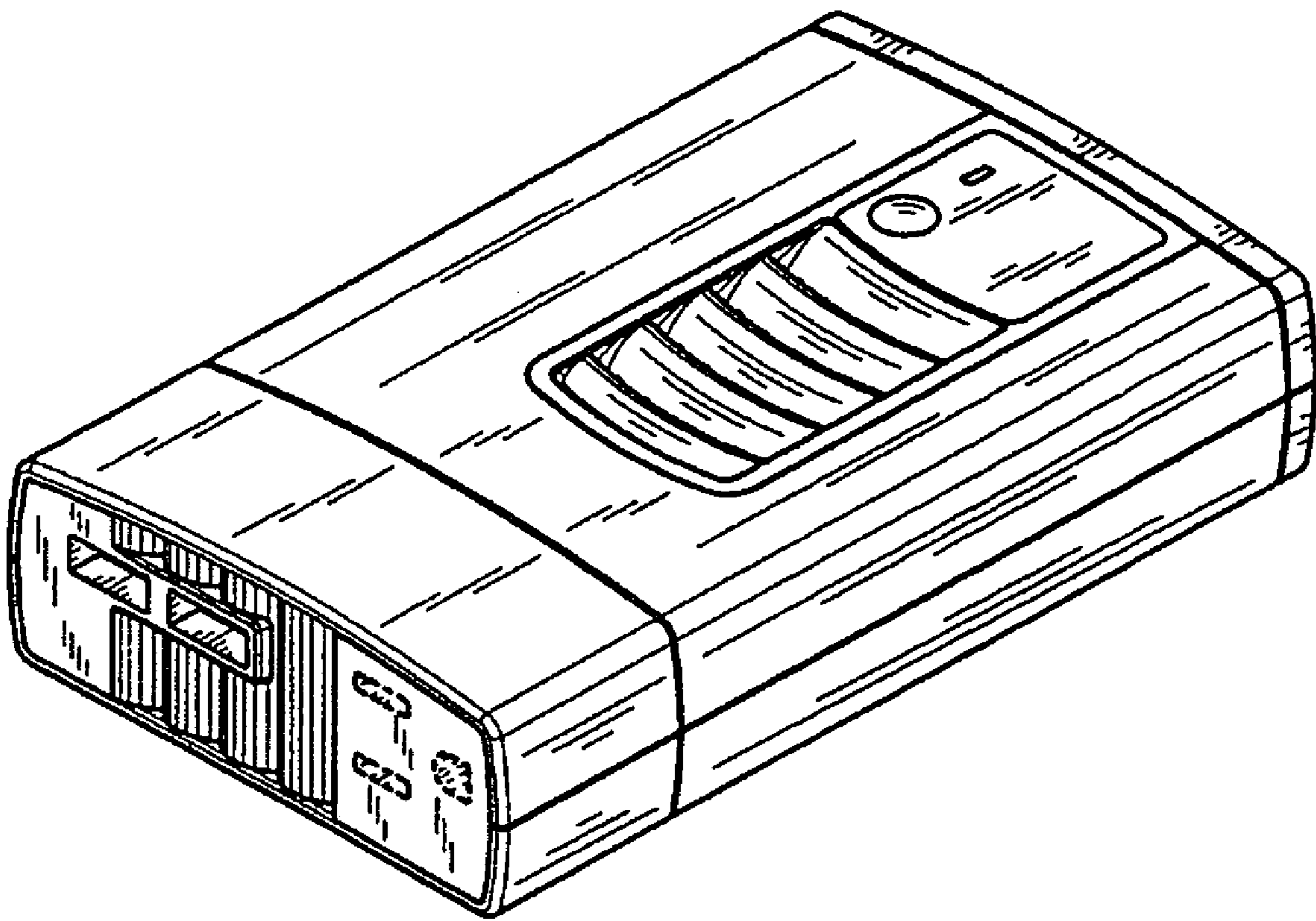

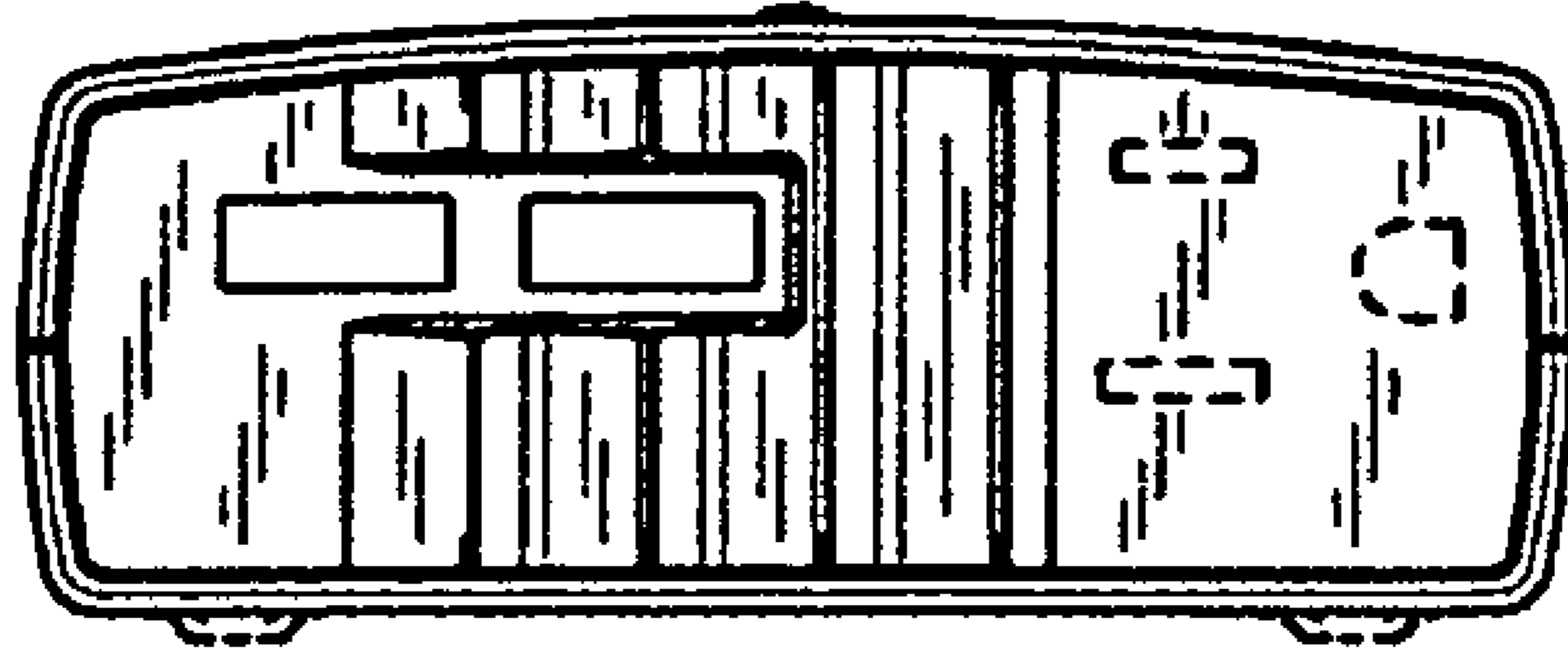

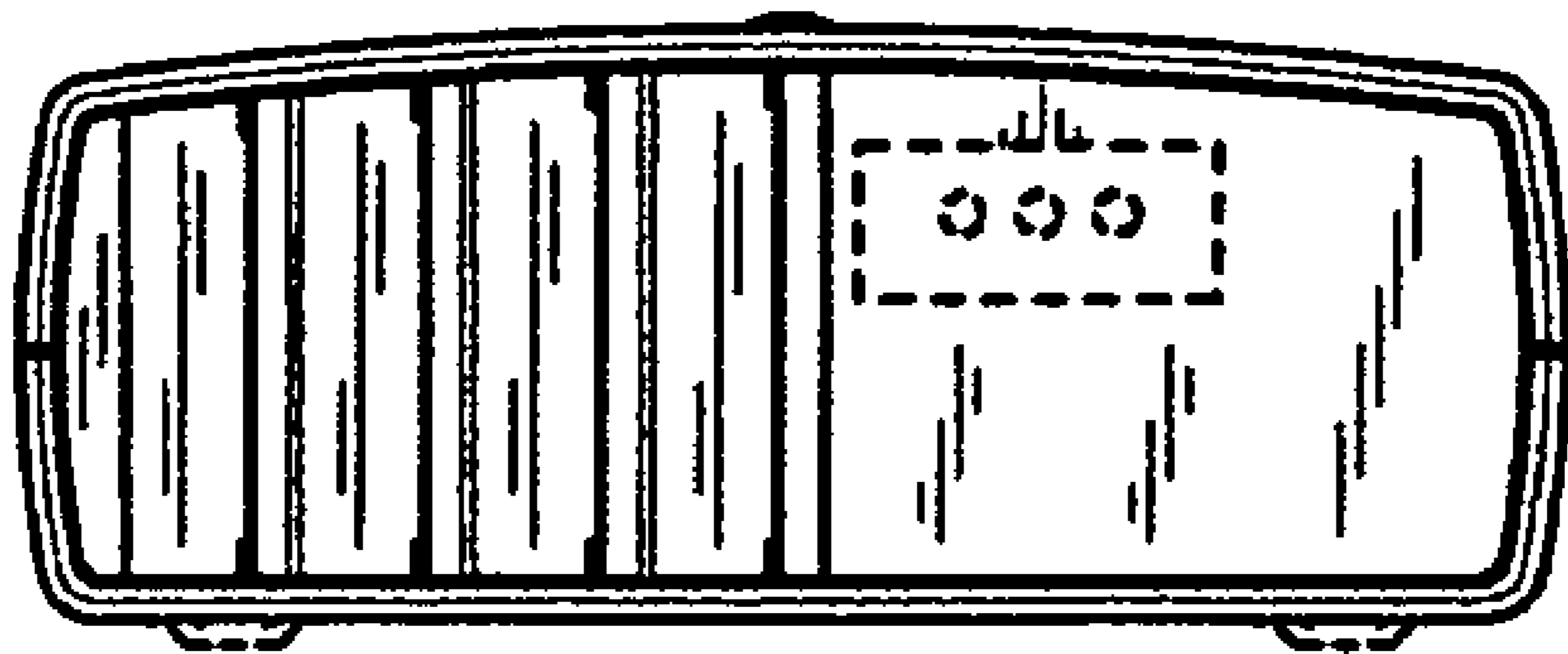

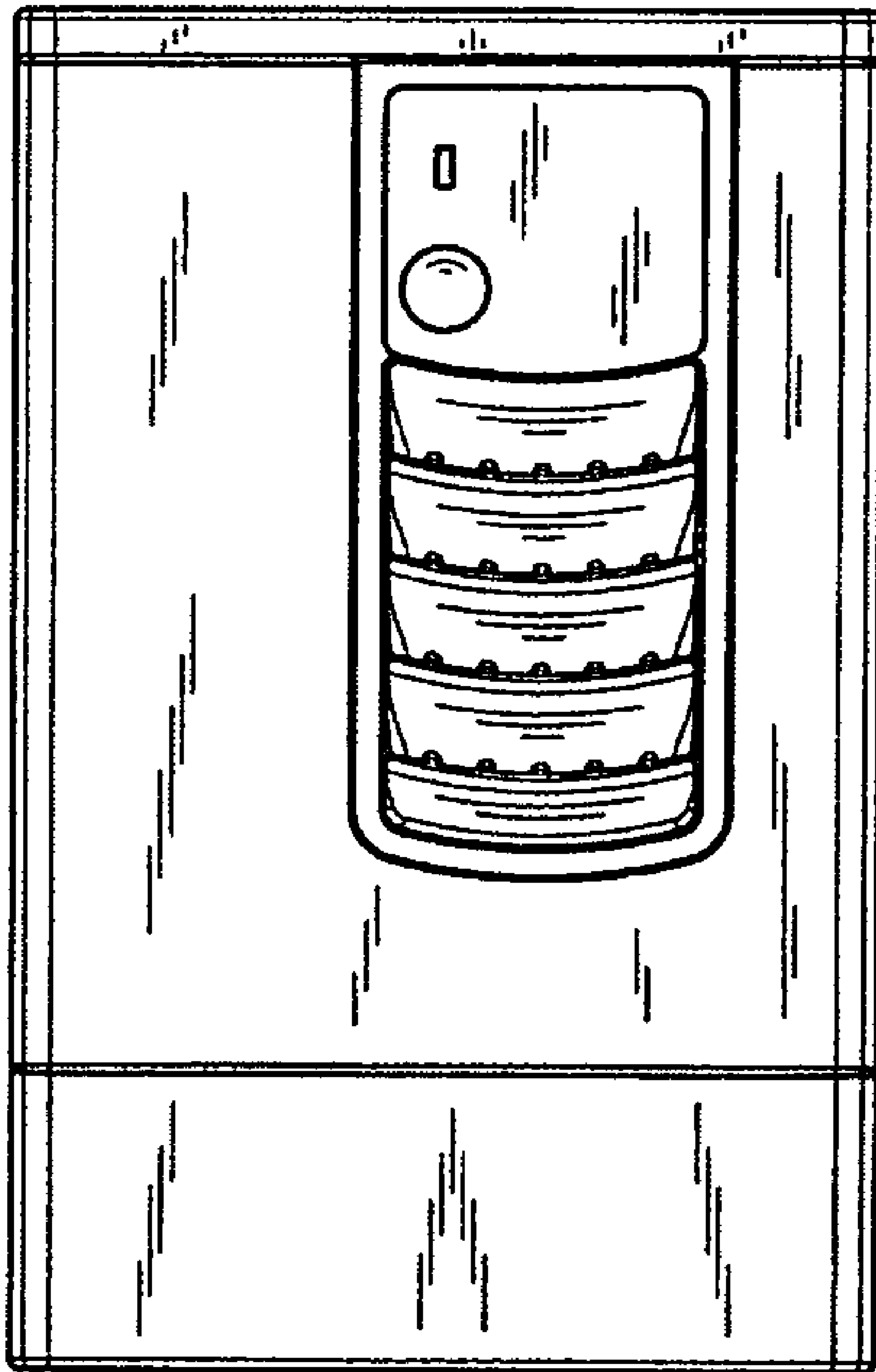

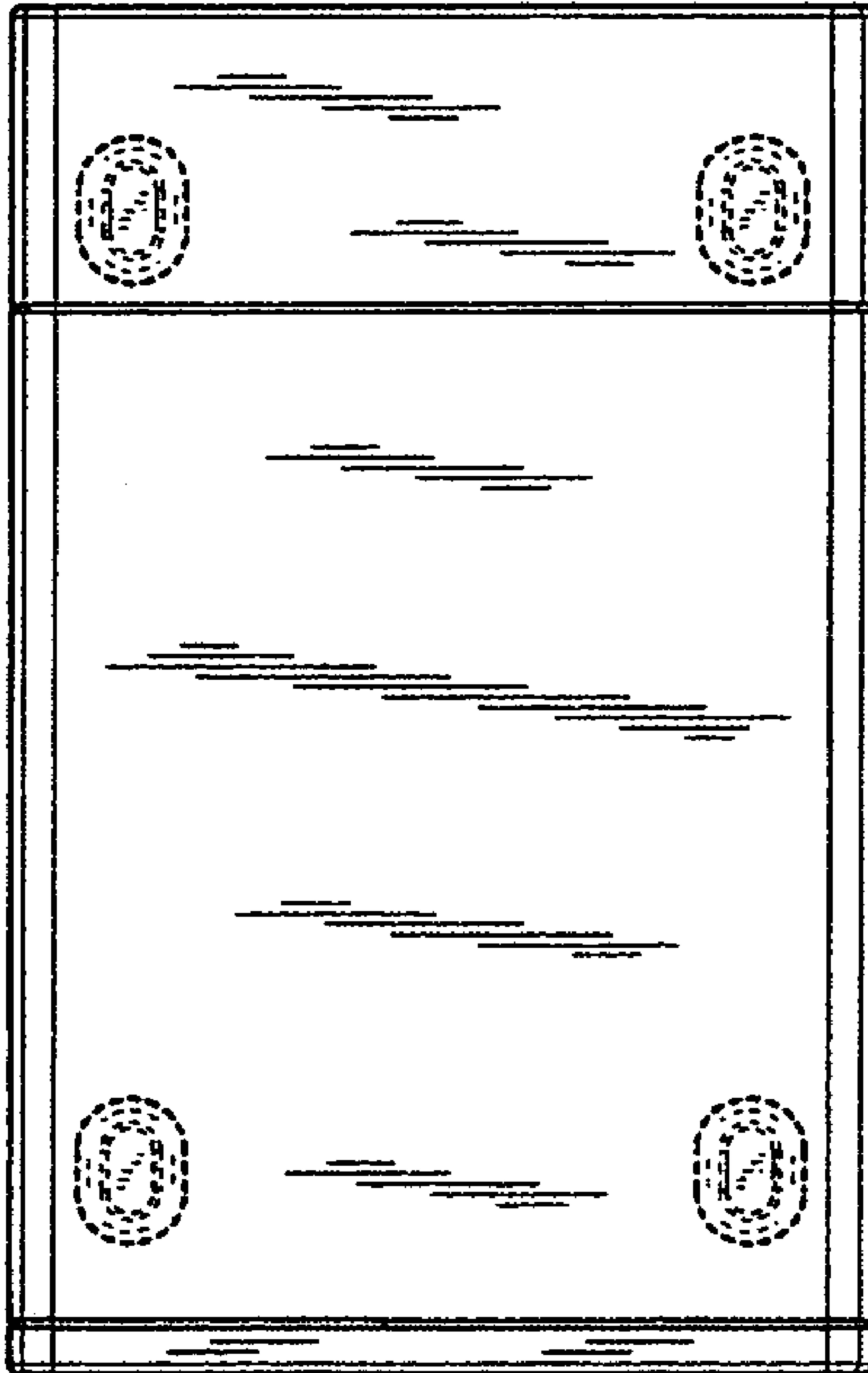

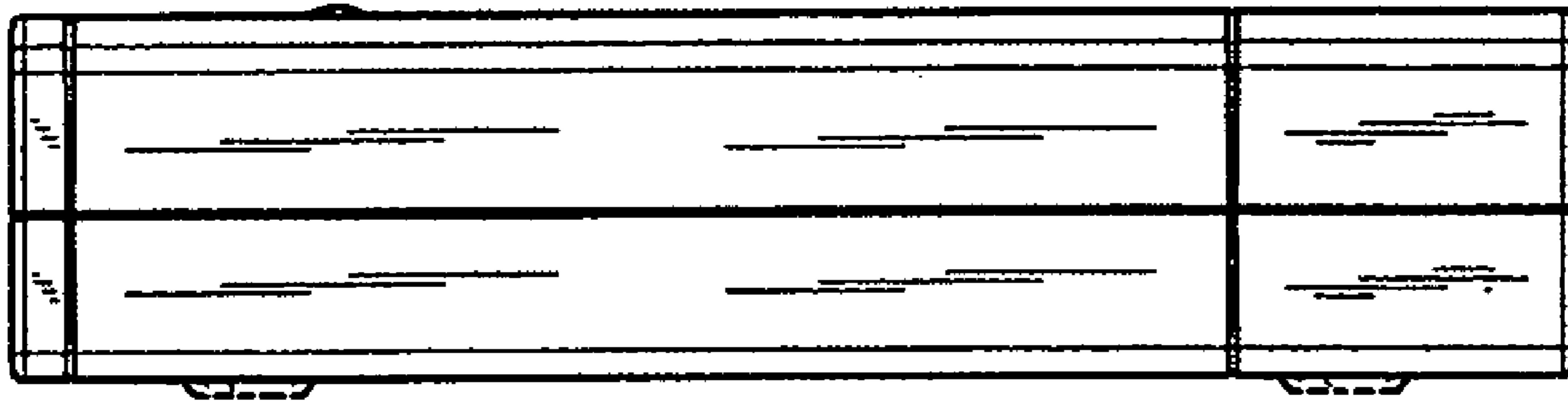

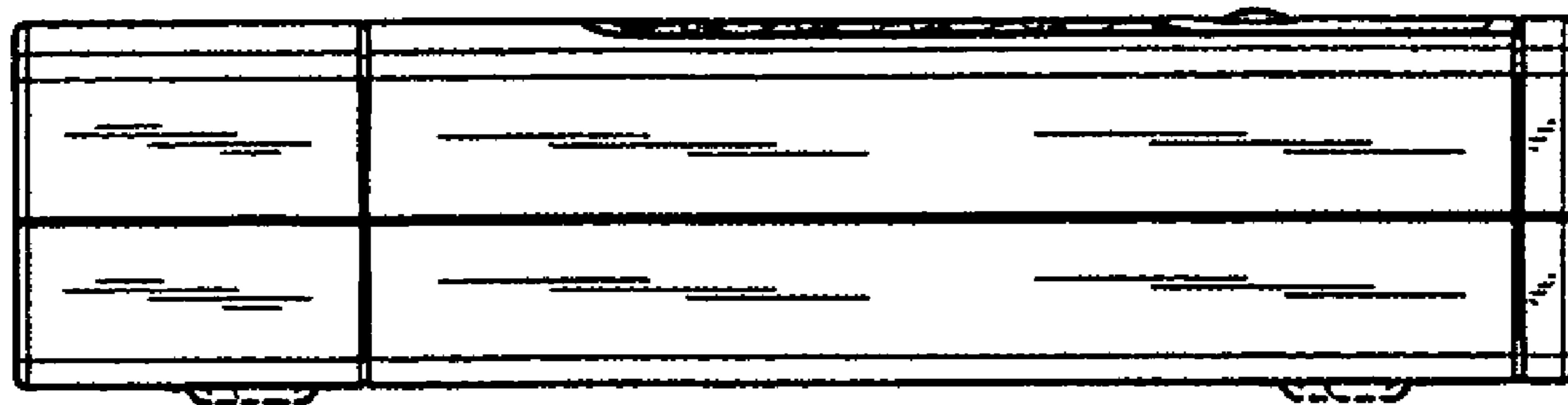
