FIG. 4 is a side elevation thereof;

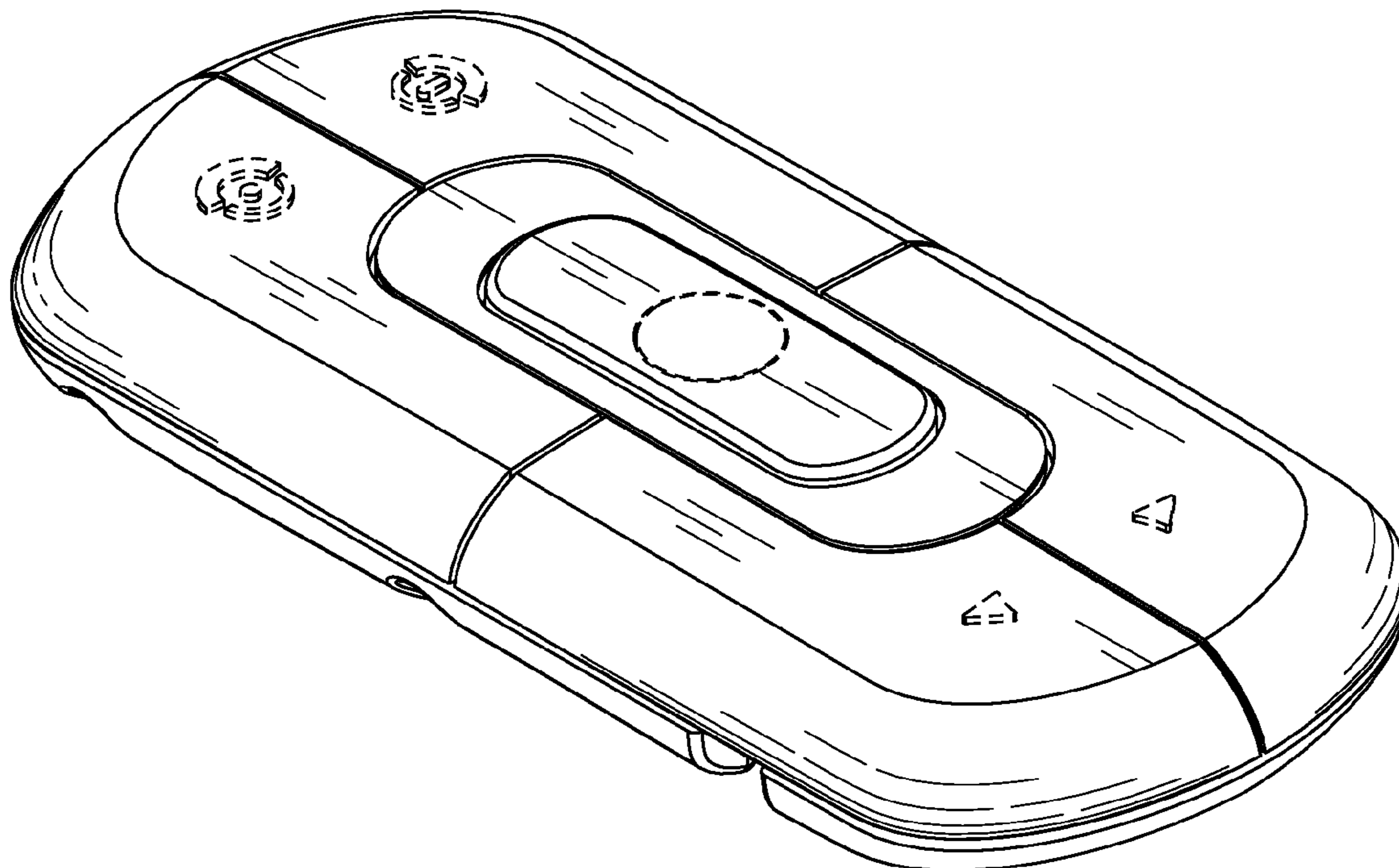
FIG. 5 is a side elevation of the side opposite that shown in FIG. 4;

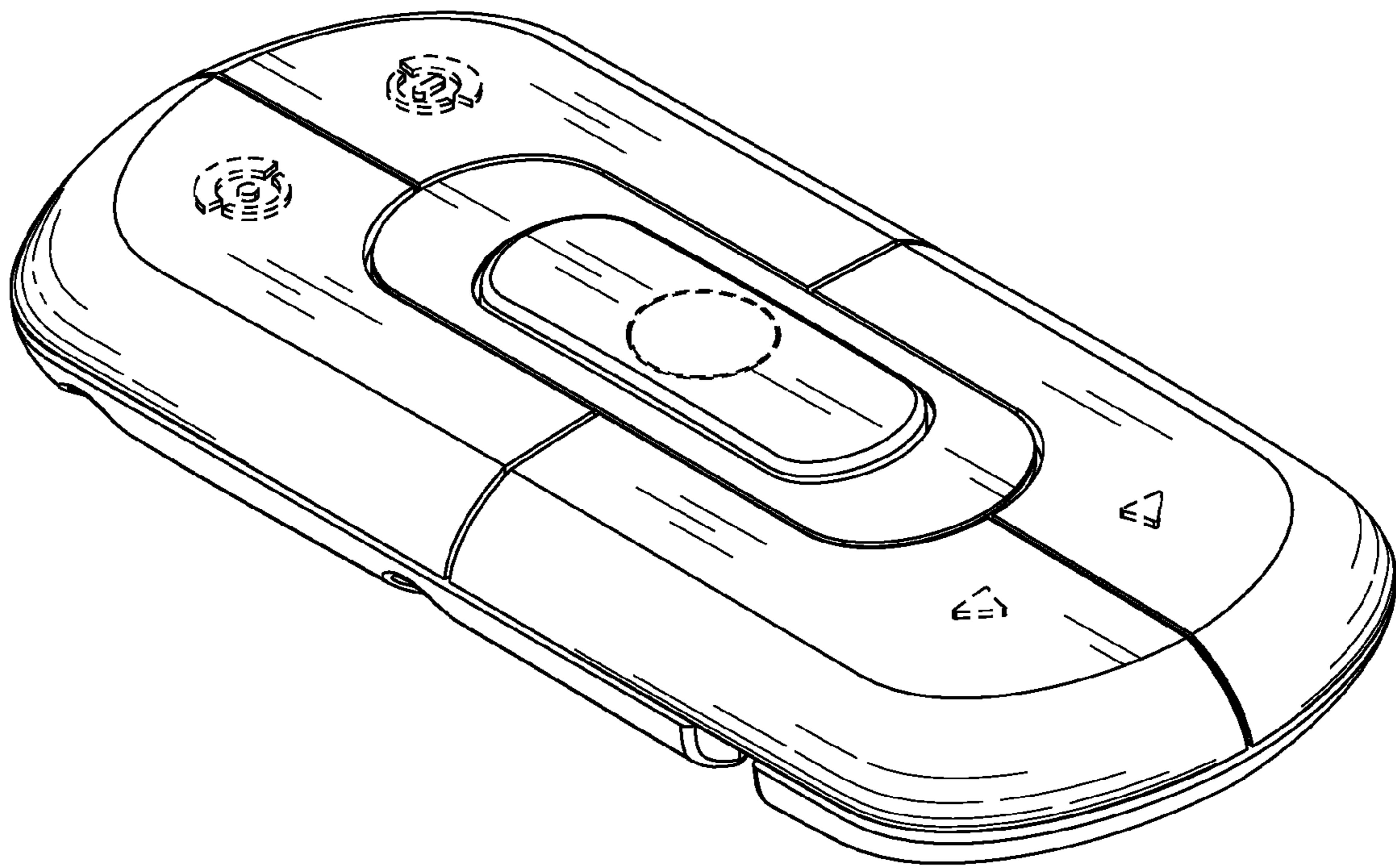

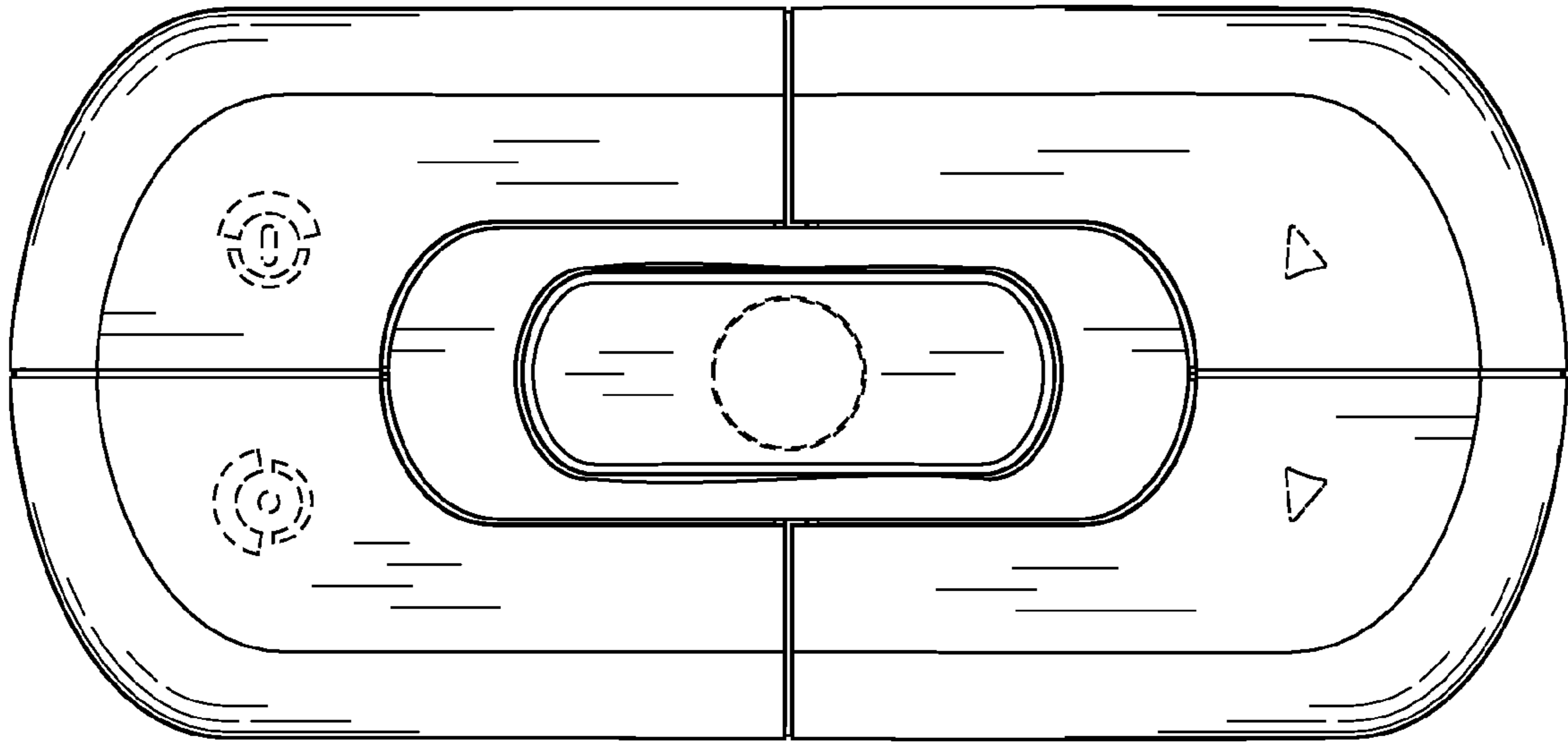

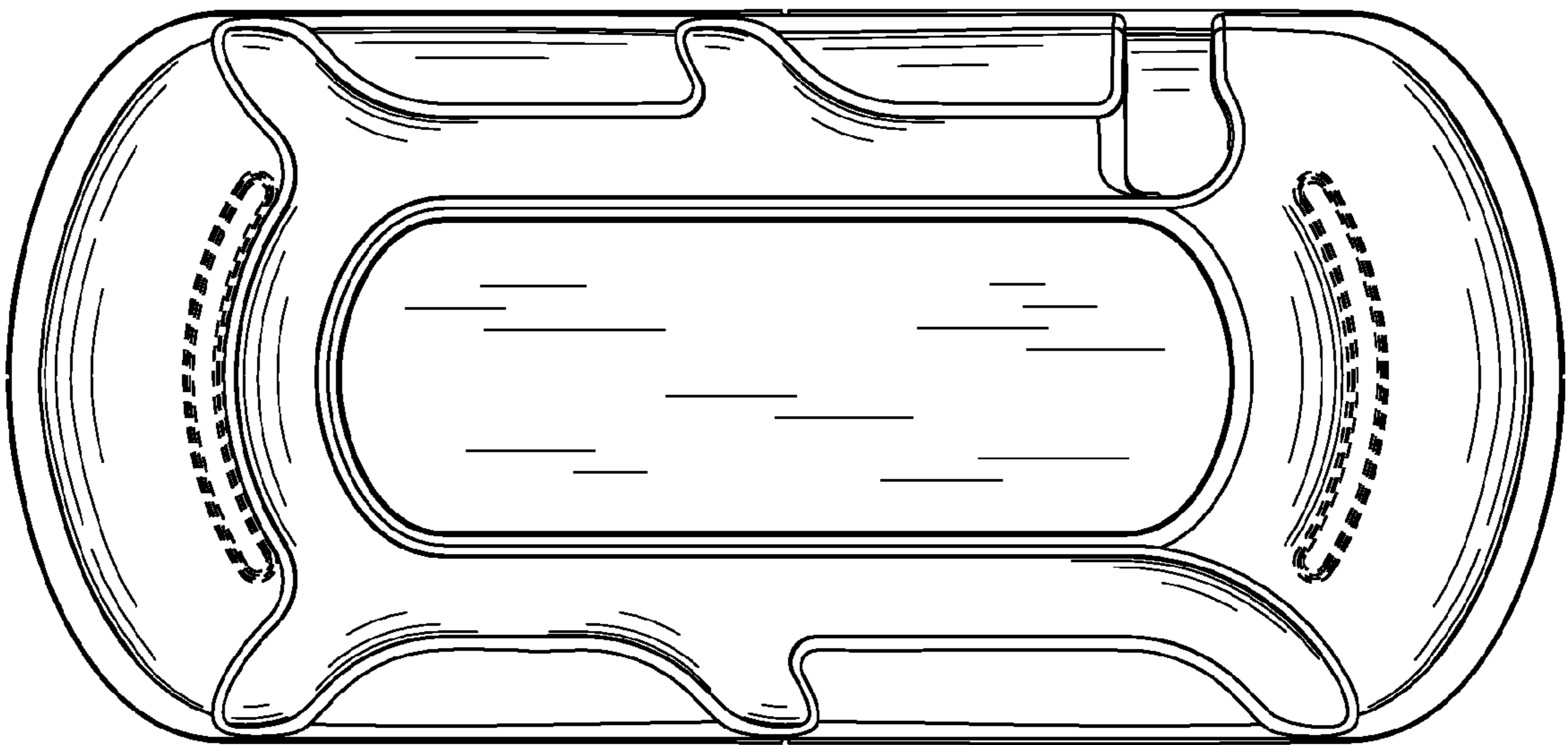

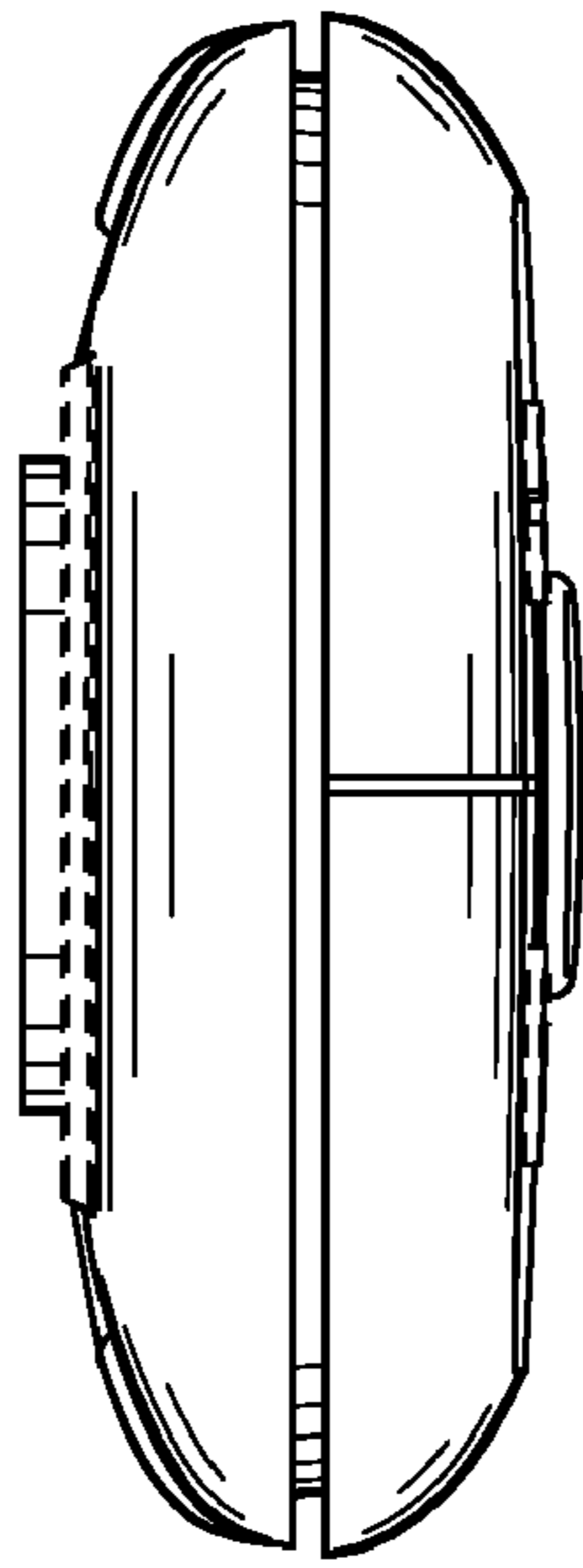

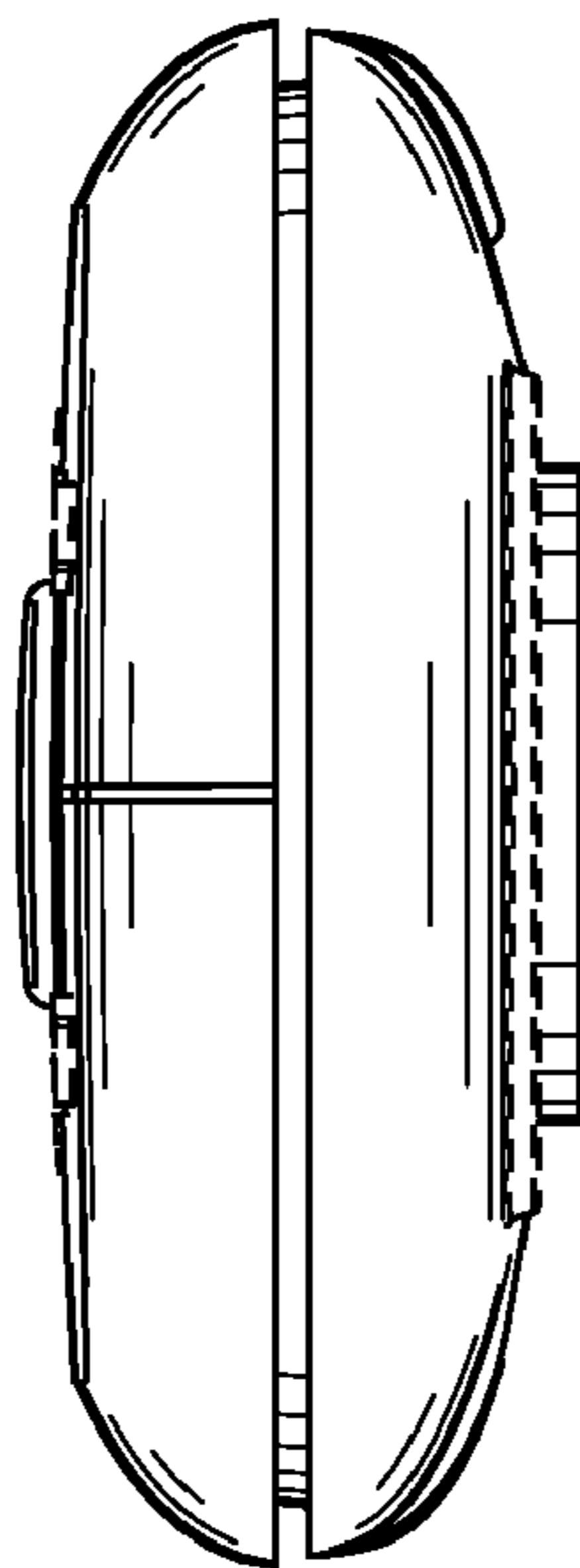

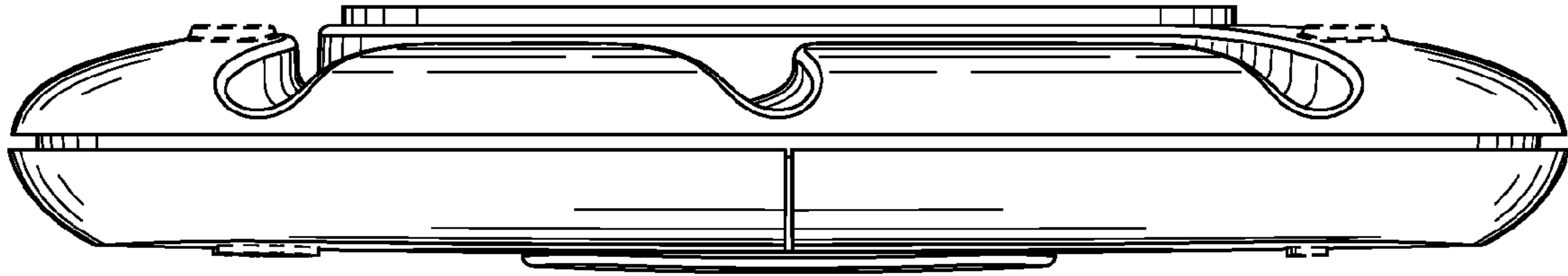

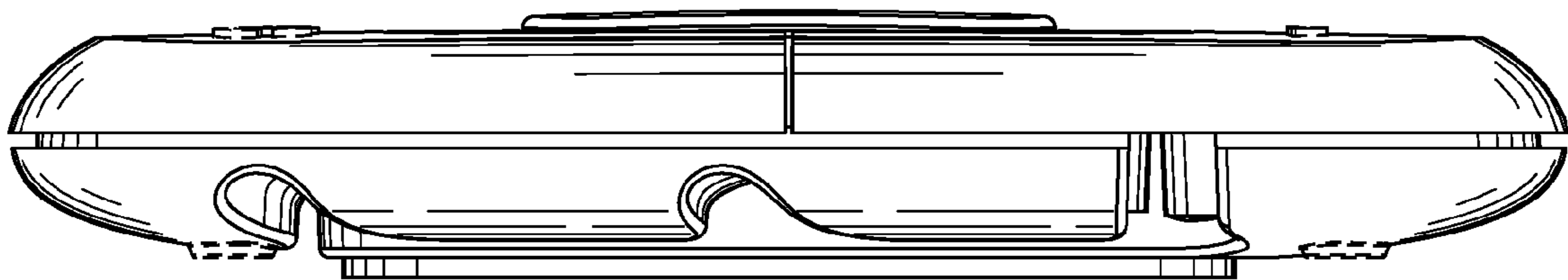
