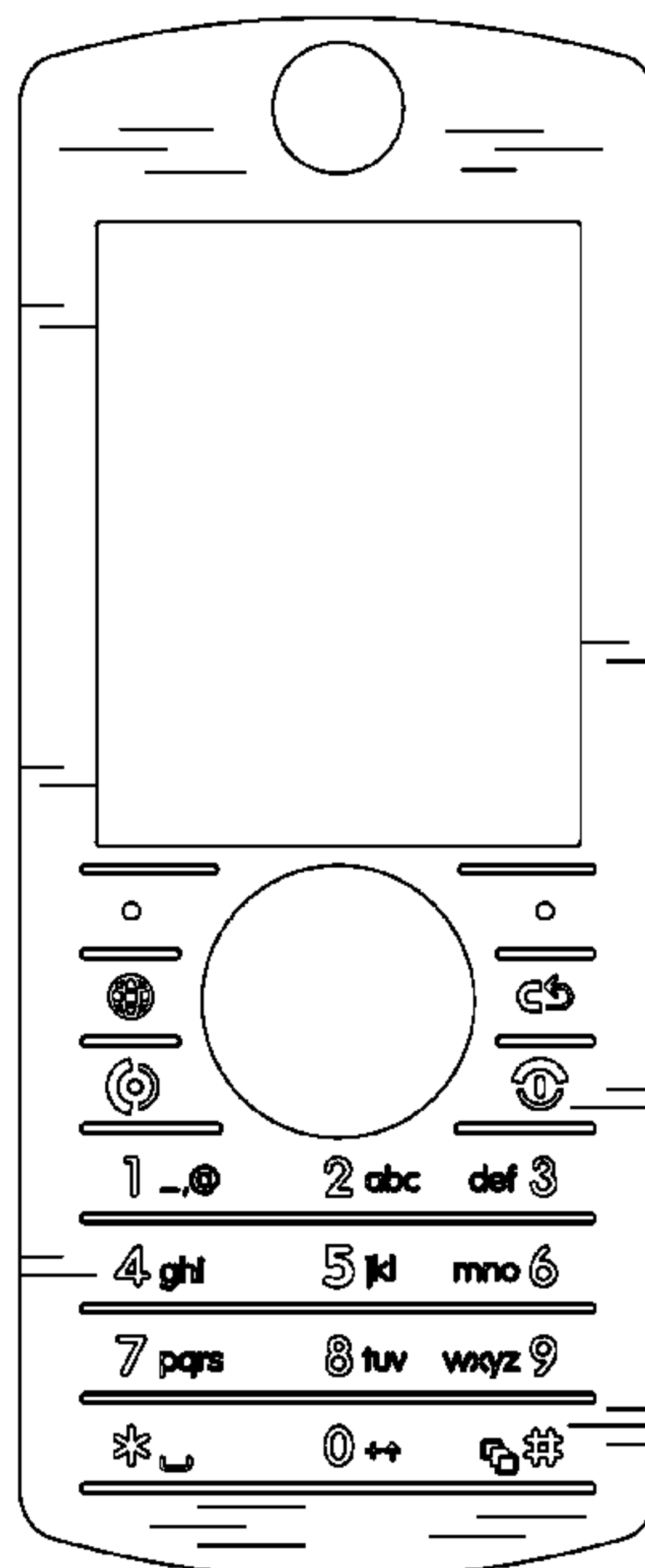
The ornamental design for a user interface, as shown and

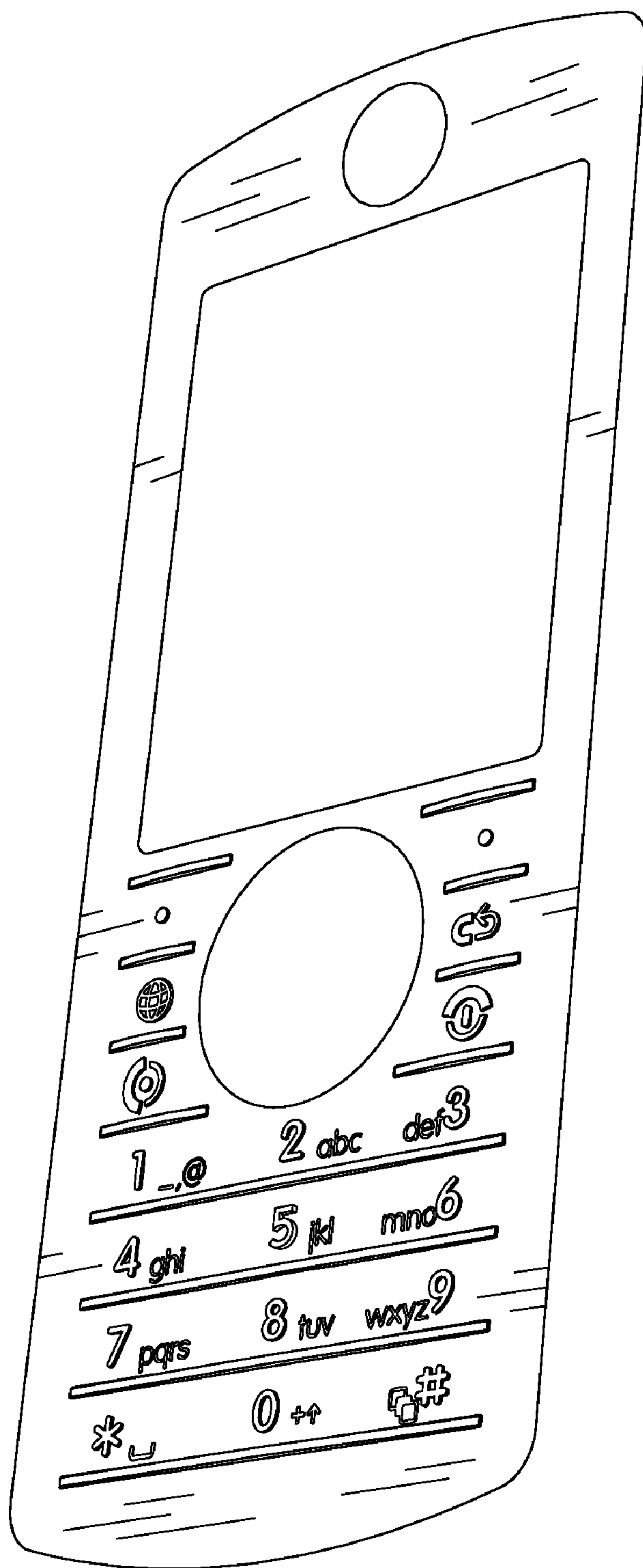

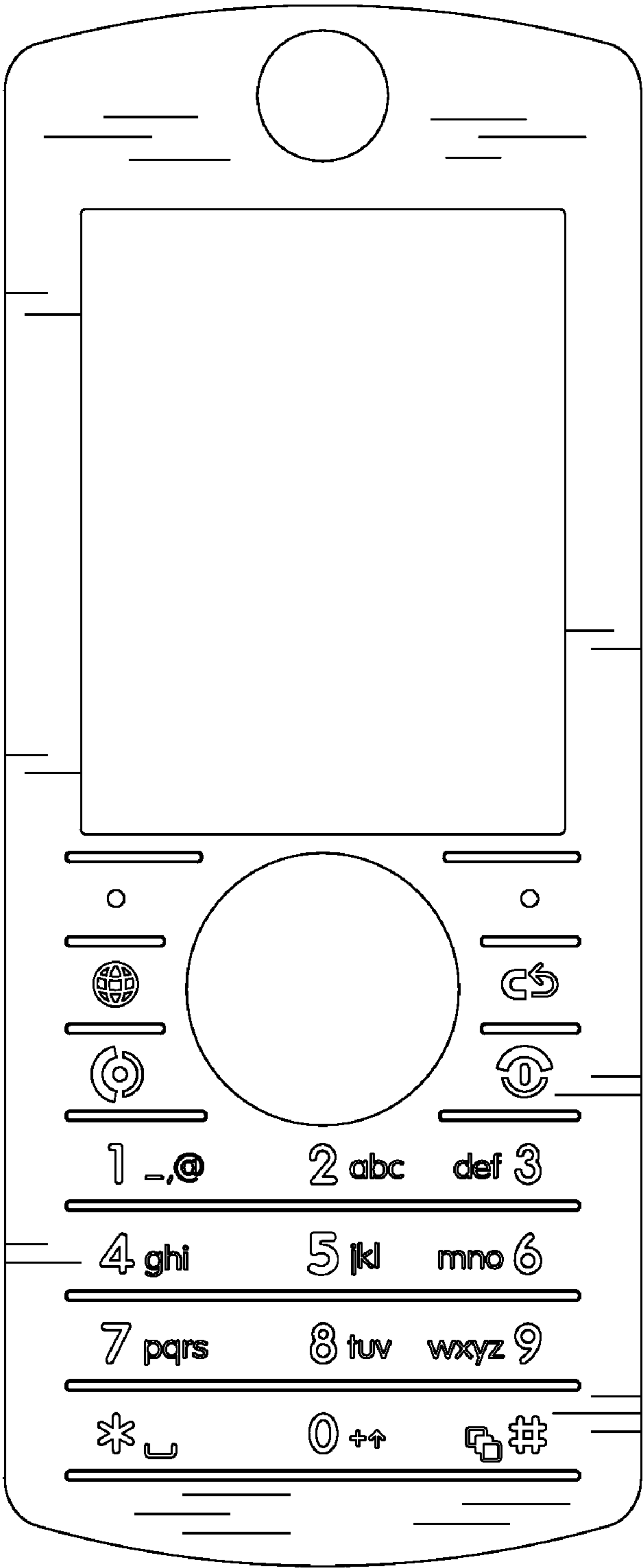
