**DESCRIPTION**

FIG. 1 is a front elevation of a toner cartridge according to the present invention;

FIG. 4 is a bottom plan view thereof;

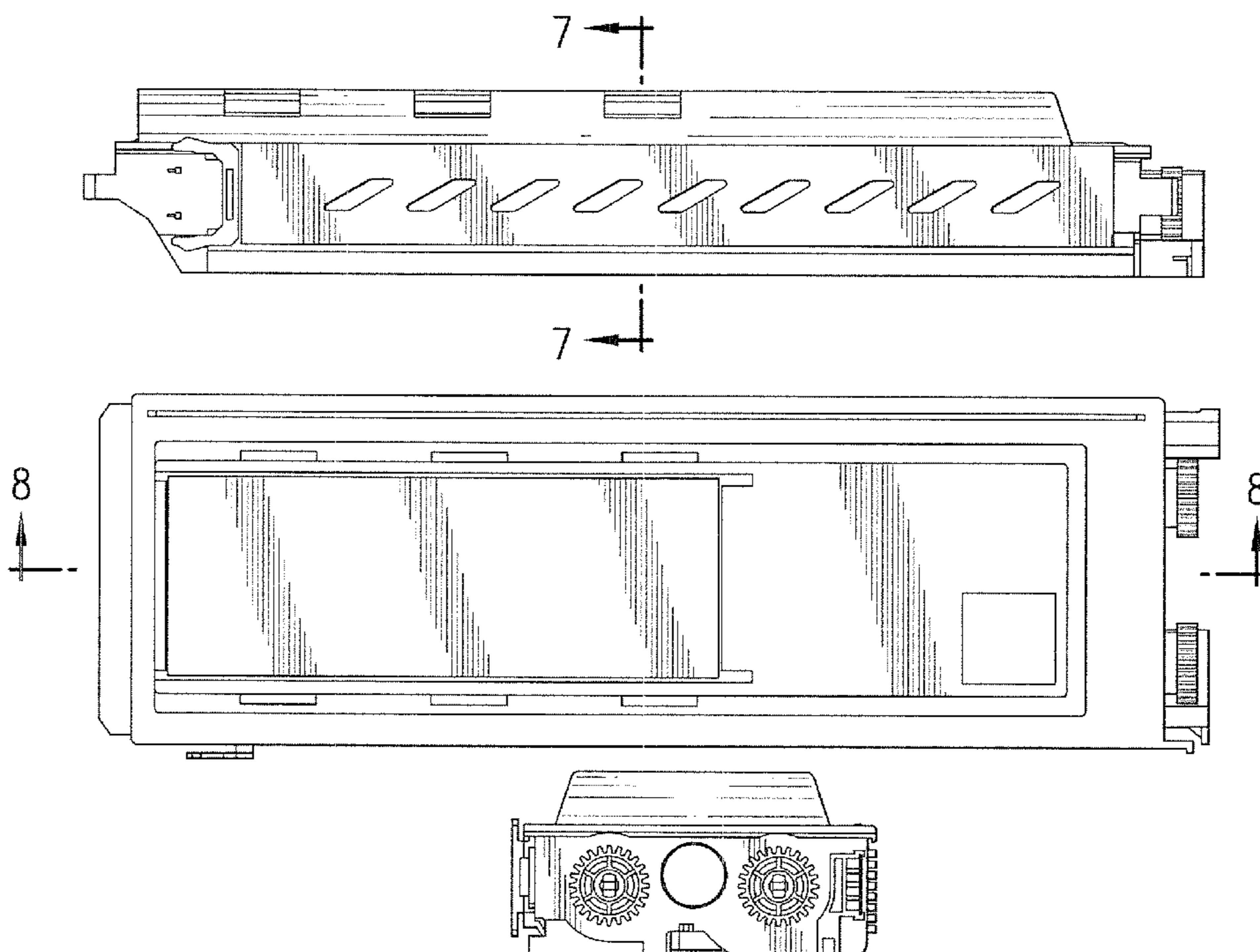
FIG. 5 is a right side elevation thereof;

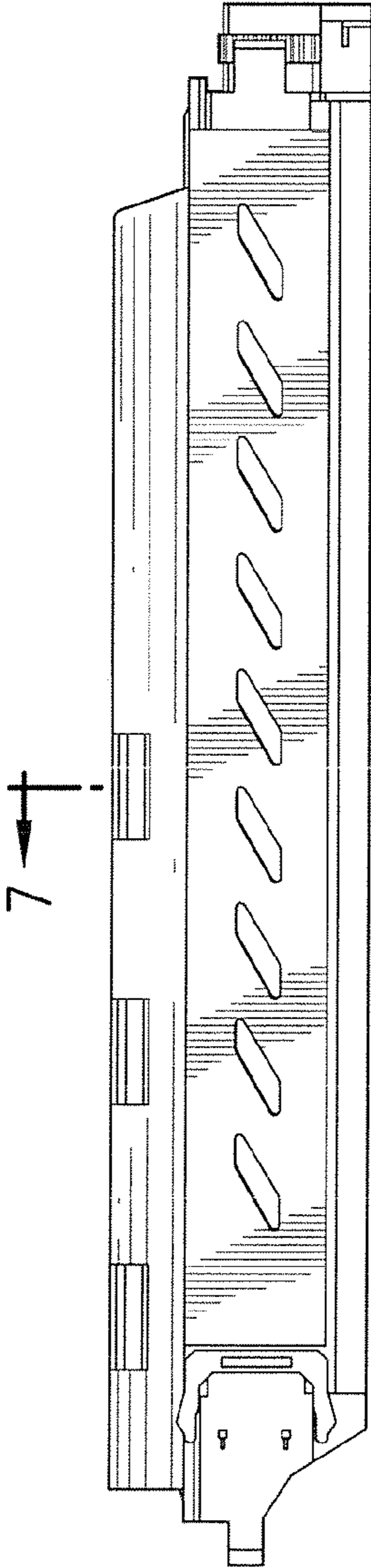

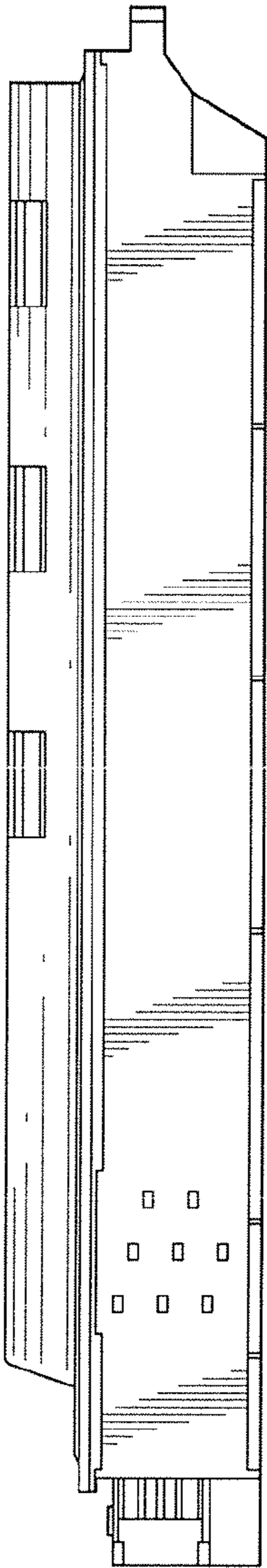

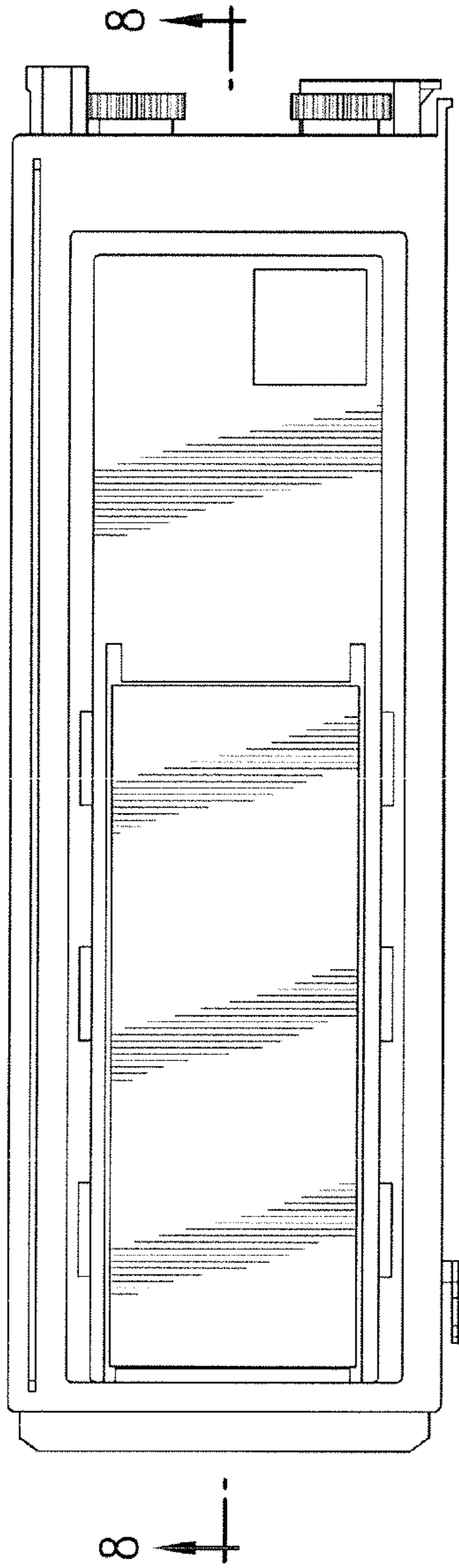

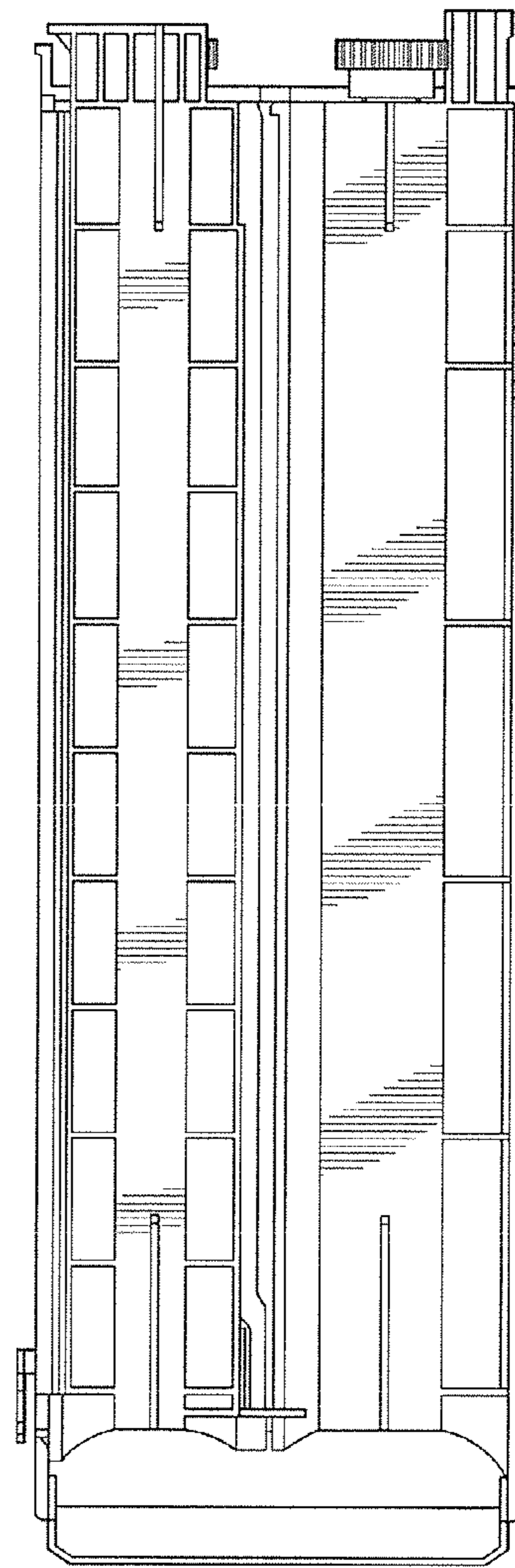

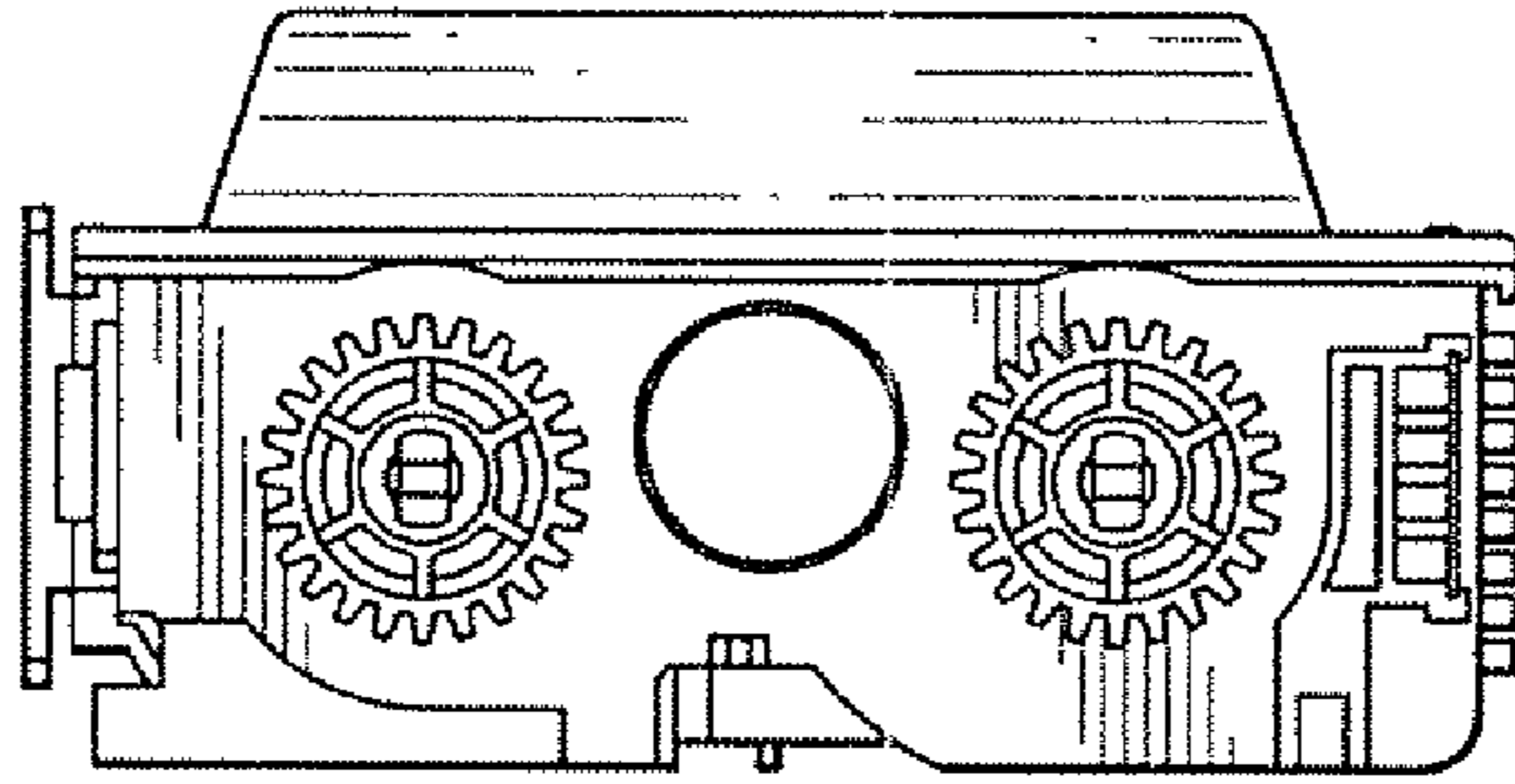

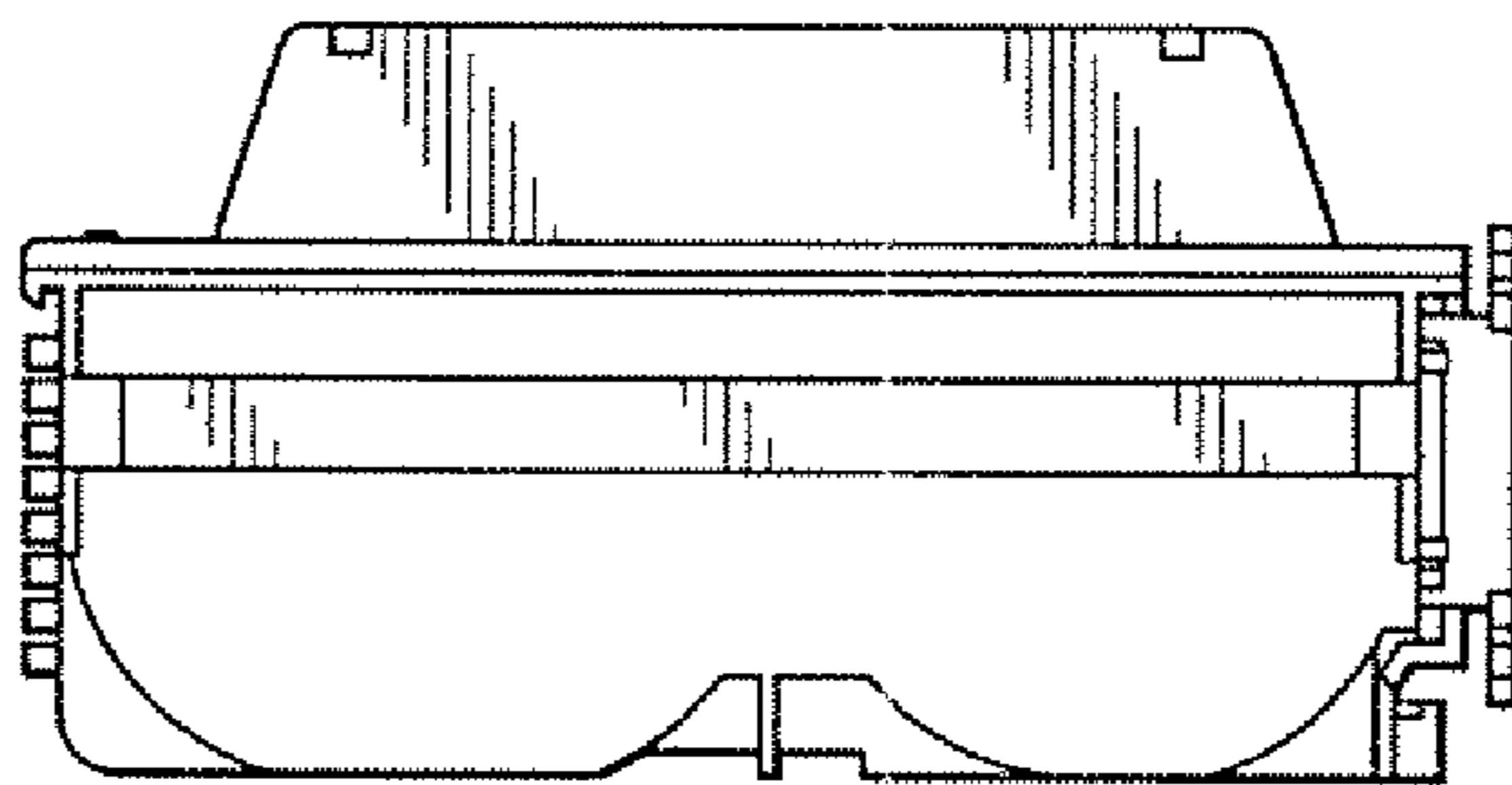

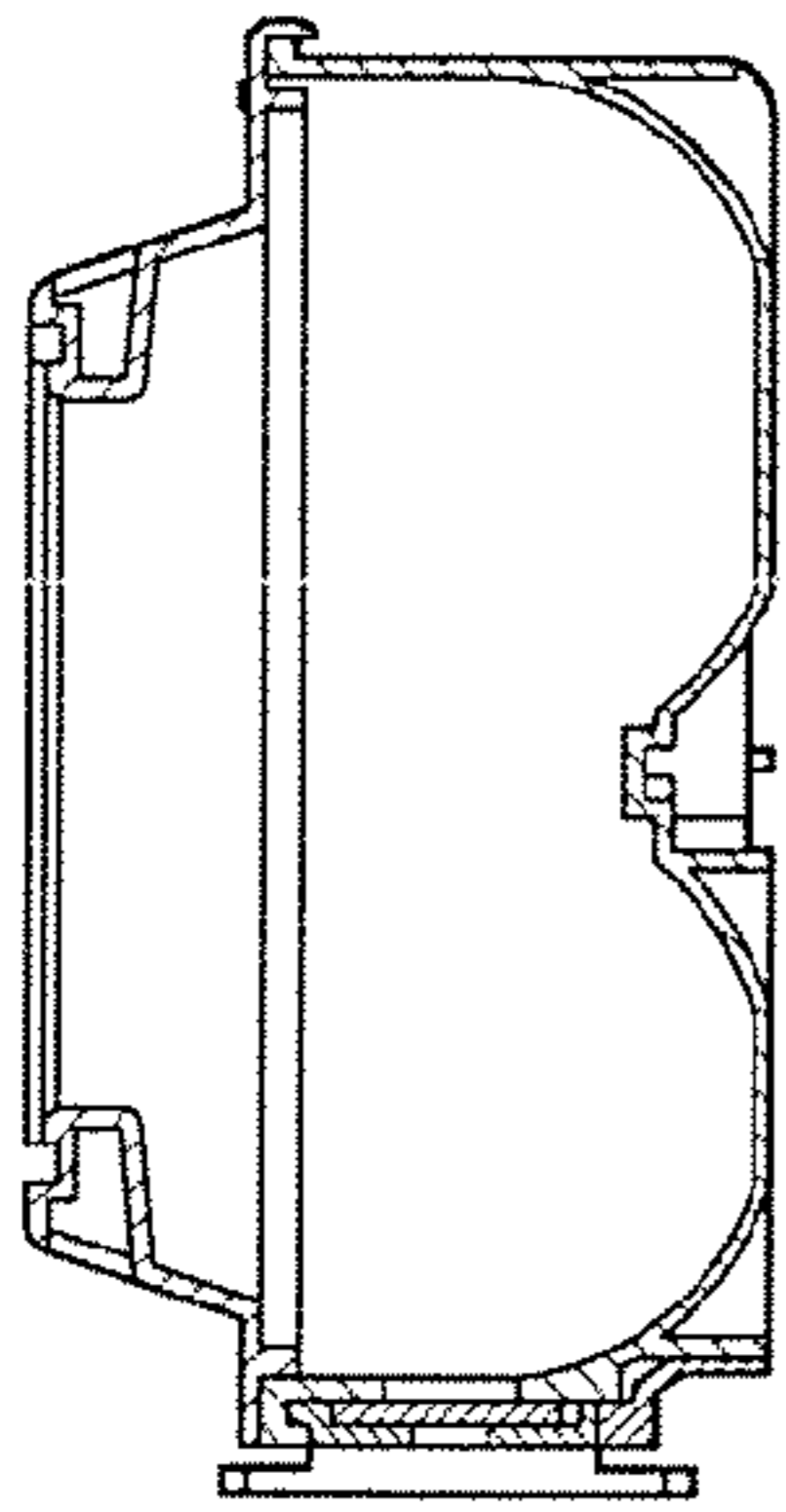

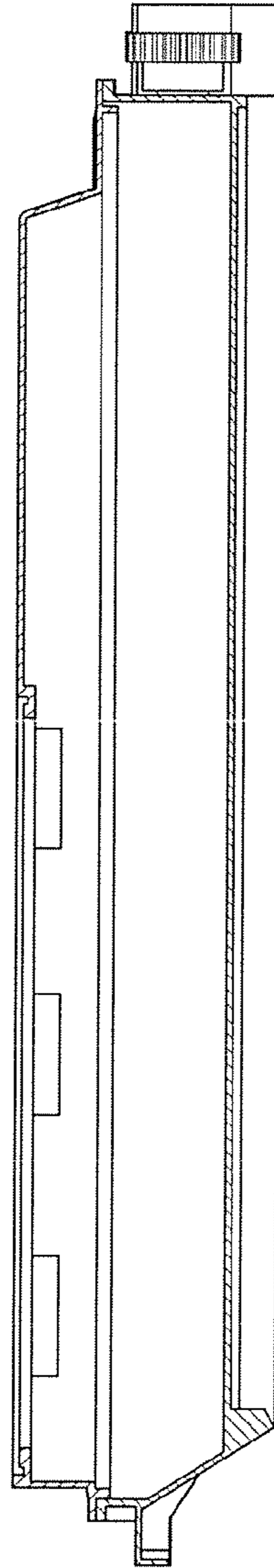
