FIG. 3 is a rear view of the envelope with multiple pockets;

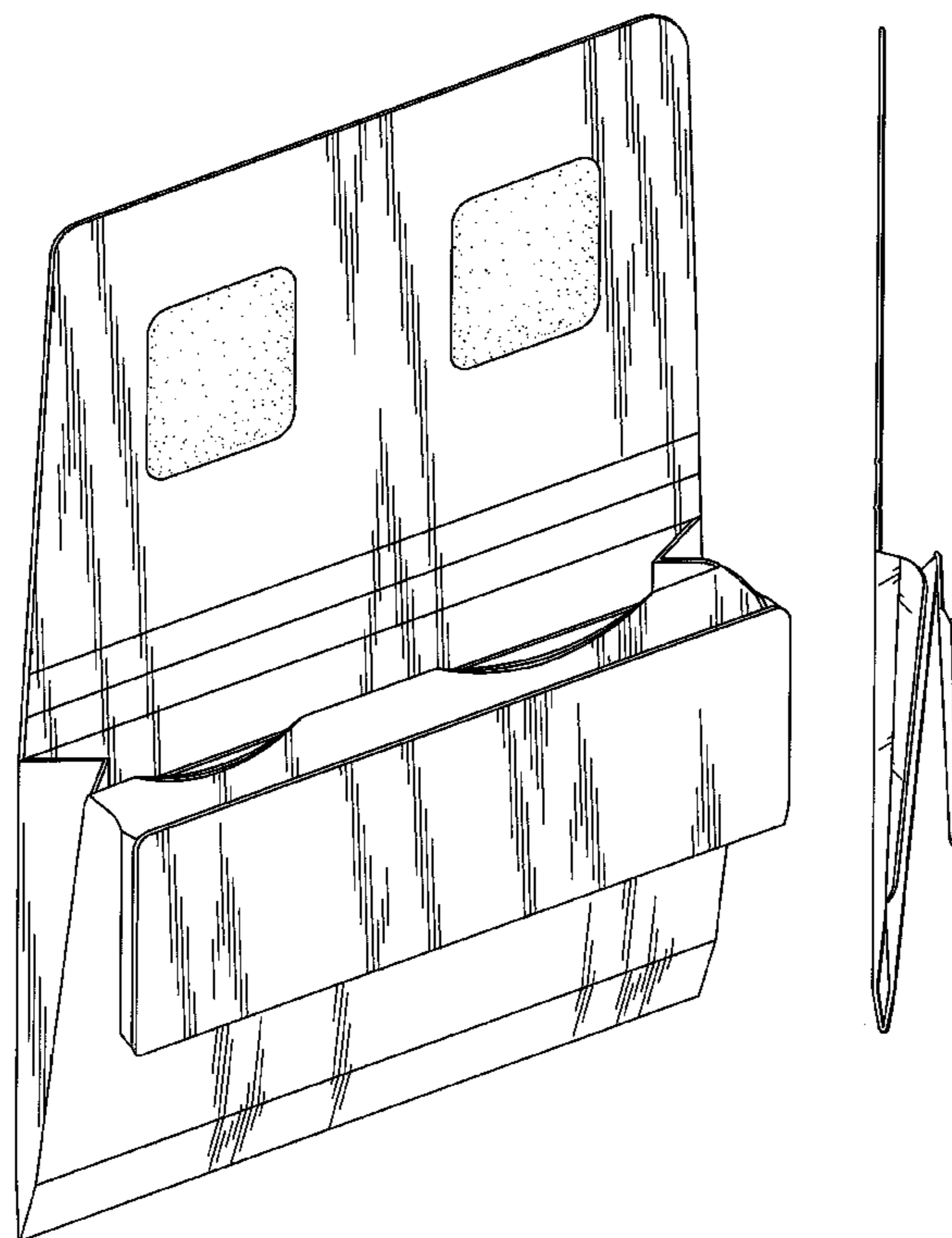
FIG. 4 is a left side view of the envelope with multiple pockets;

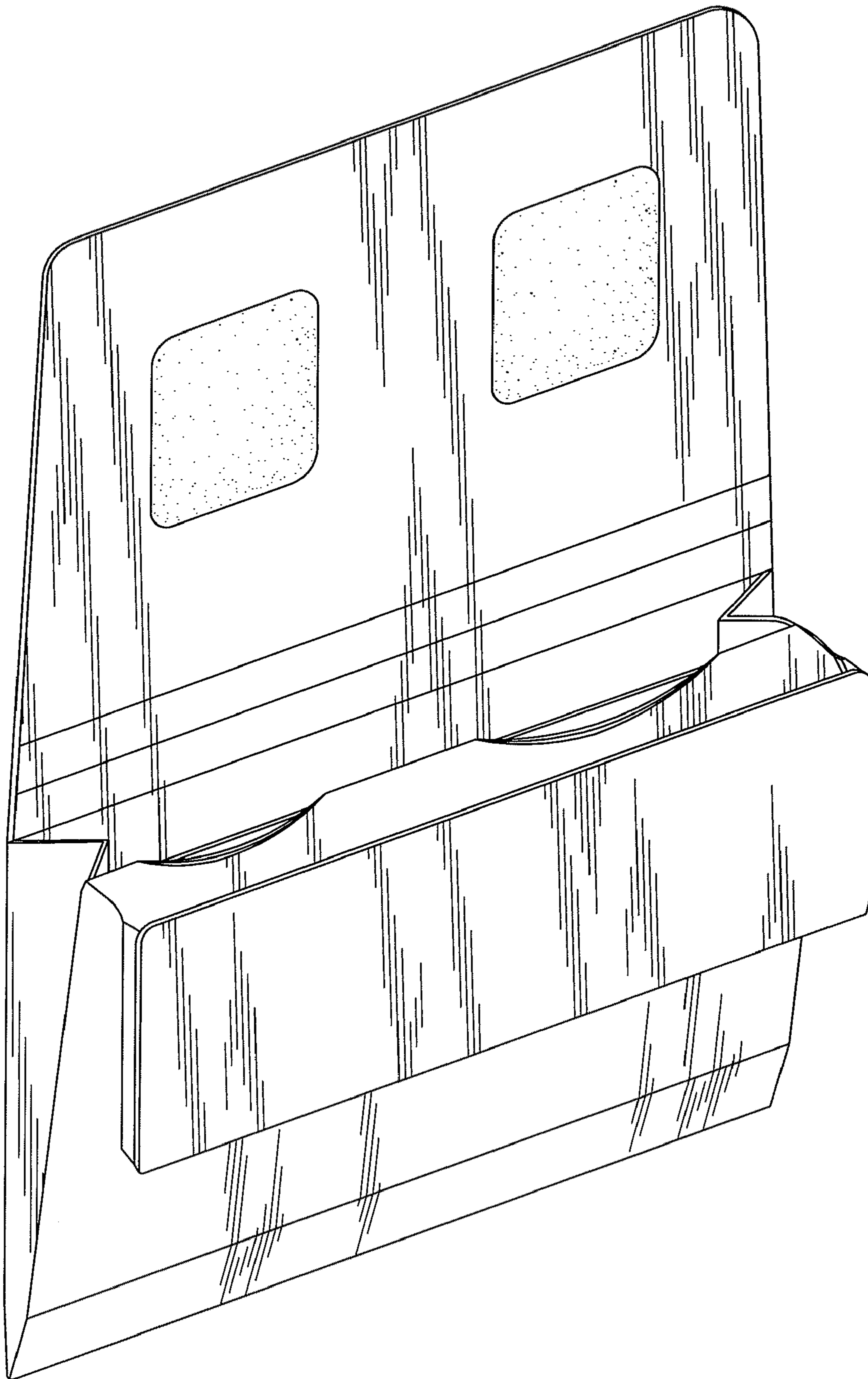

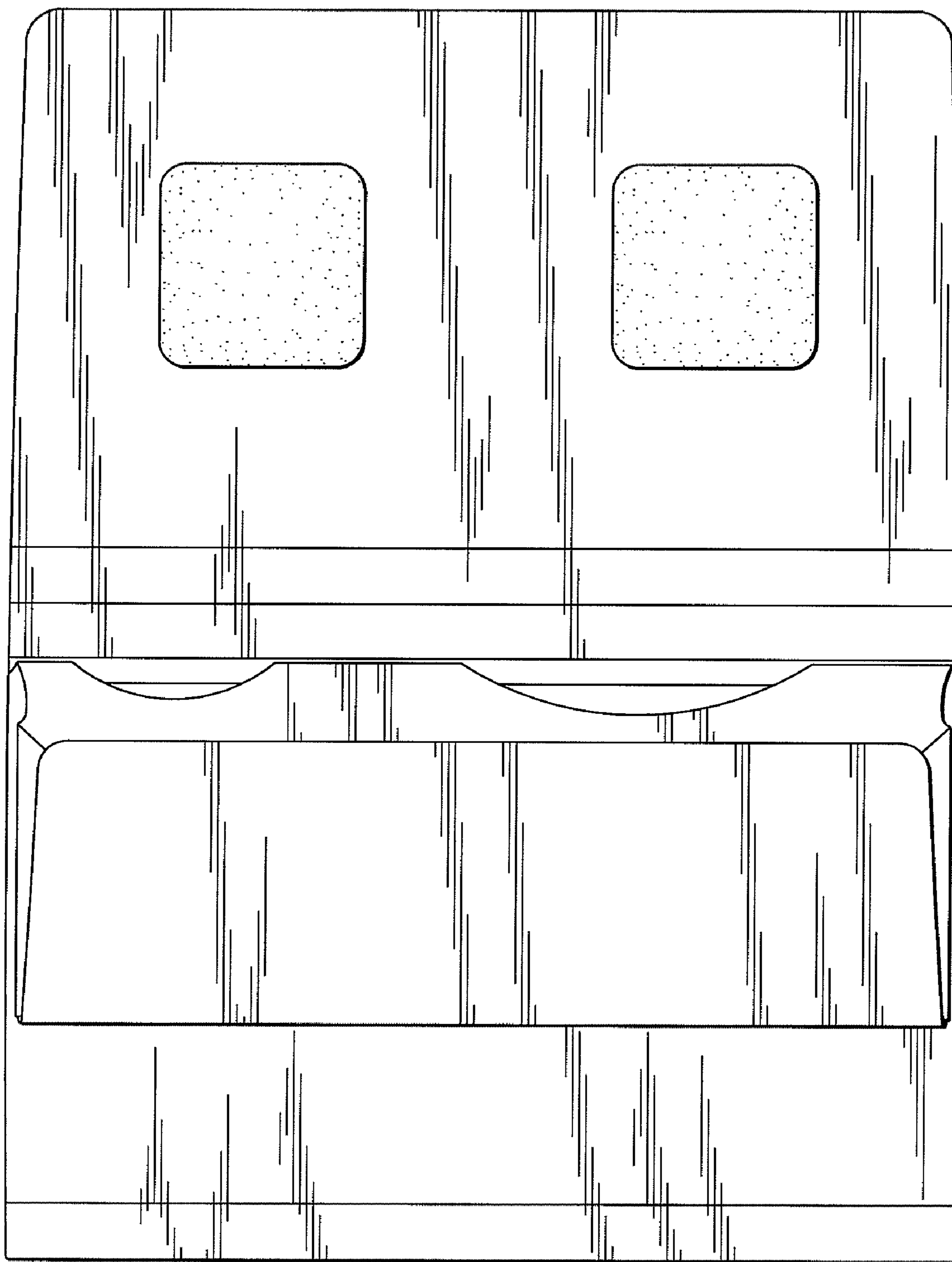

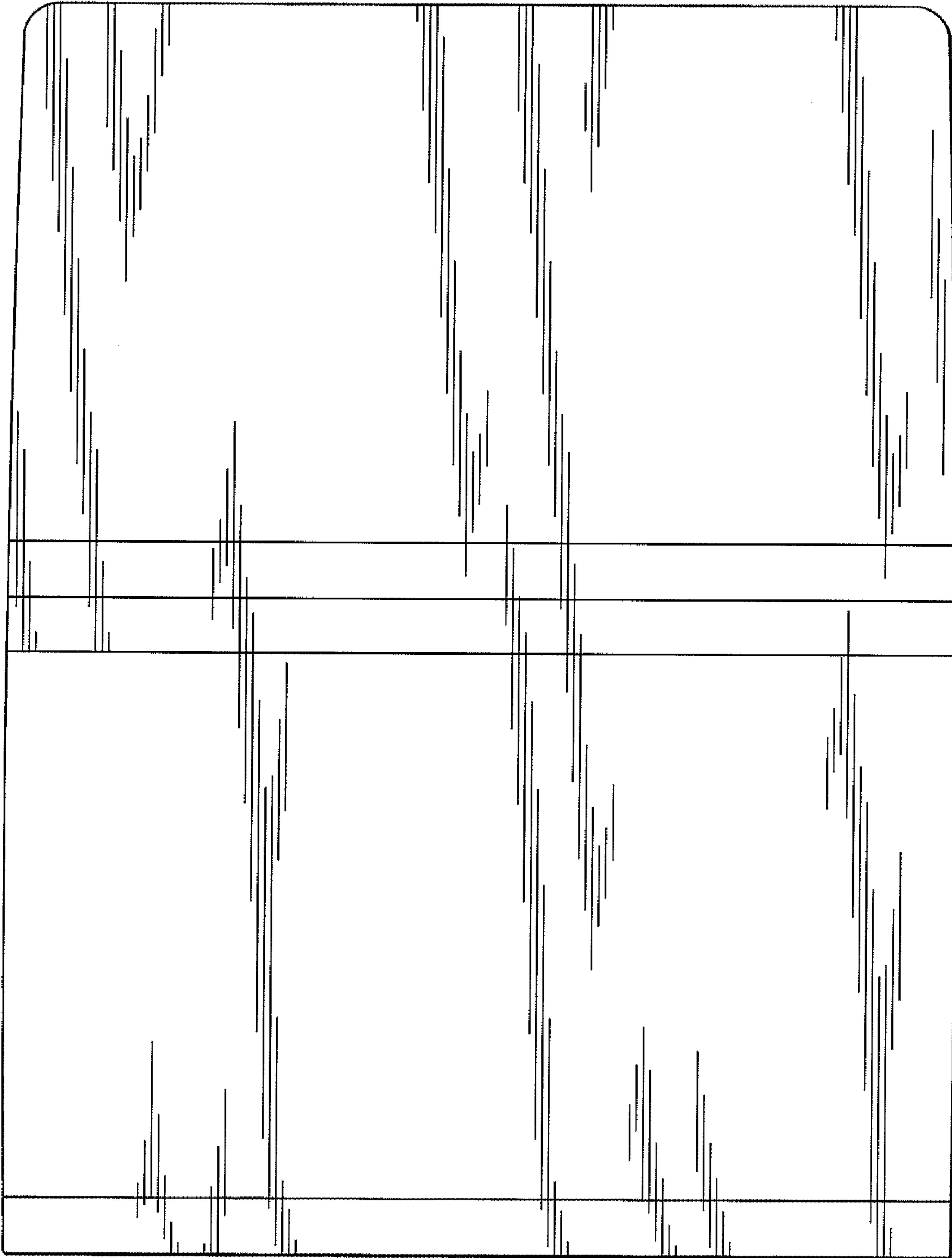

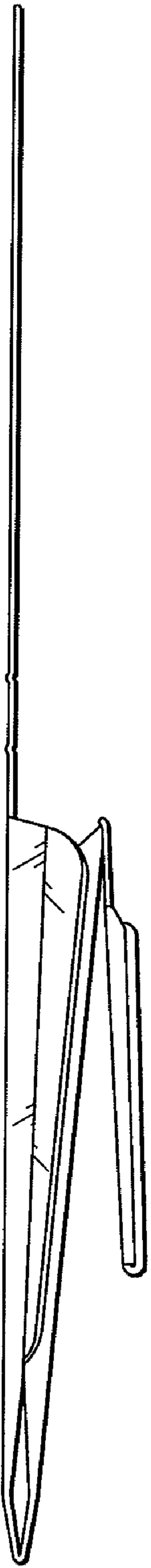

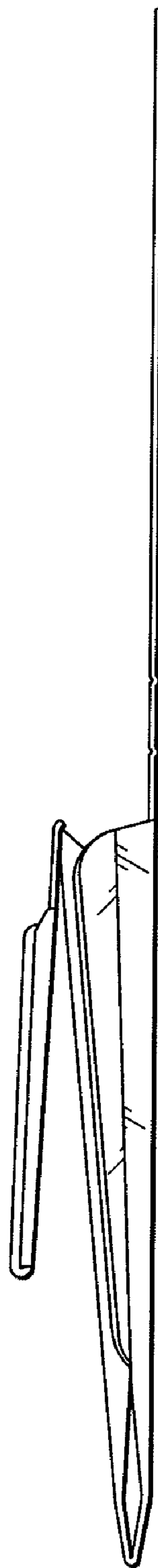

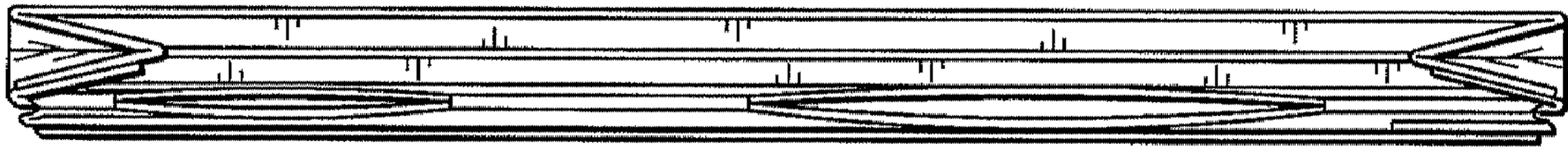

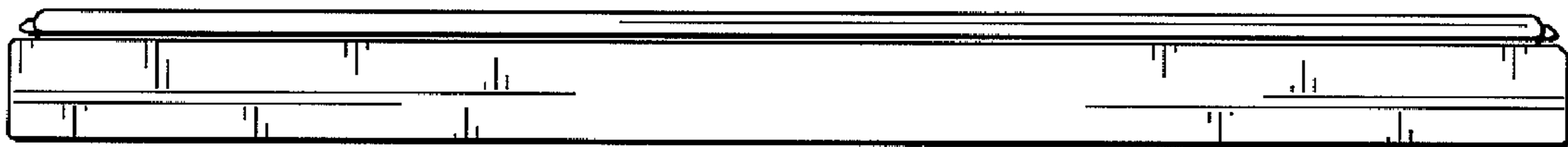
