(57) **CLAIM**

I claim the ornamental design for a pregnancy tester, as shown and described.

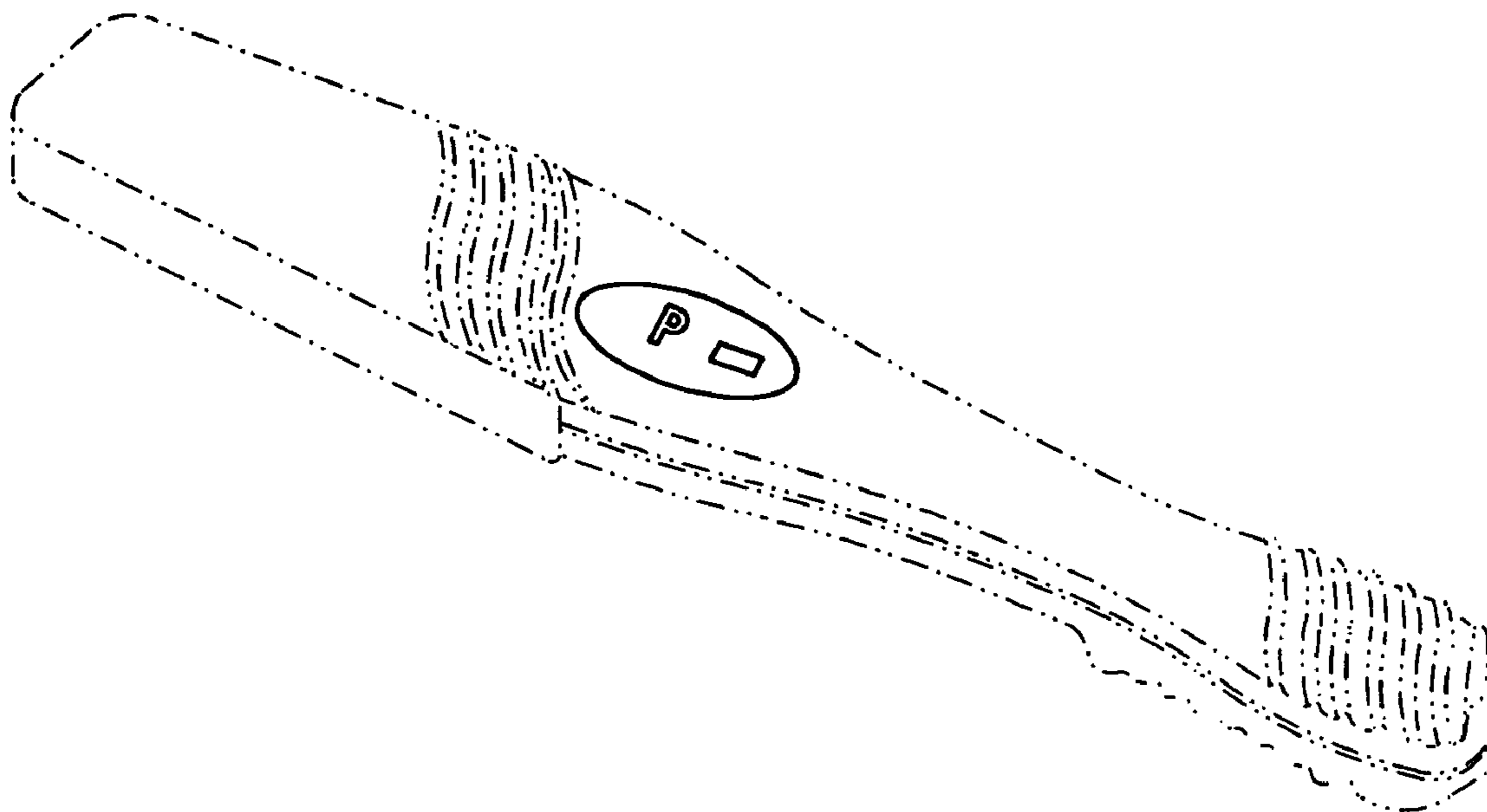

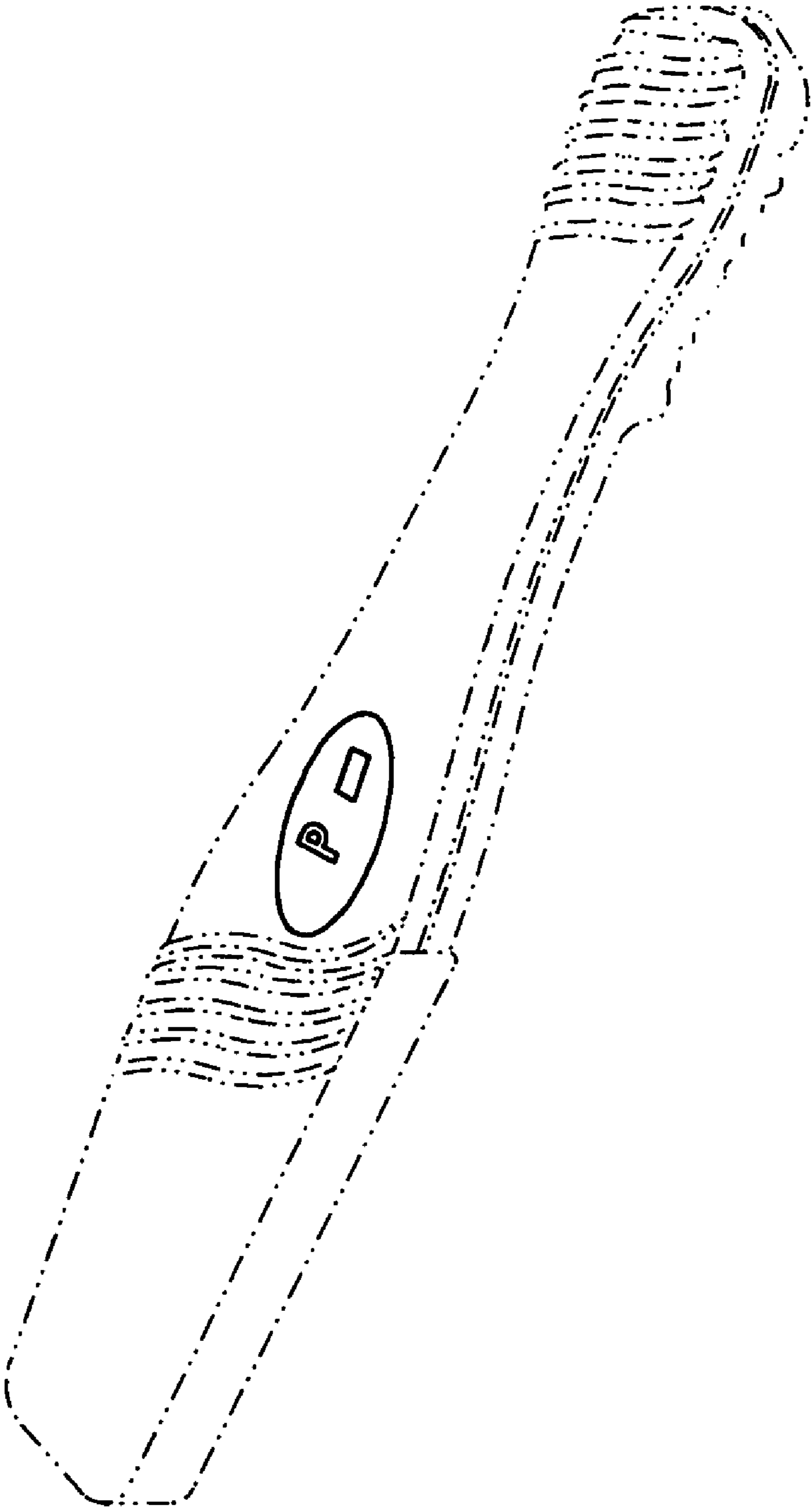
