FIG. 1 is an isometric view of the thermoplastic pallet showing my new design thereof.

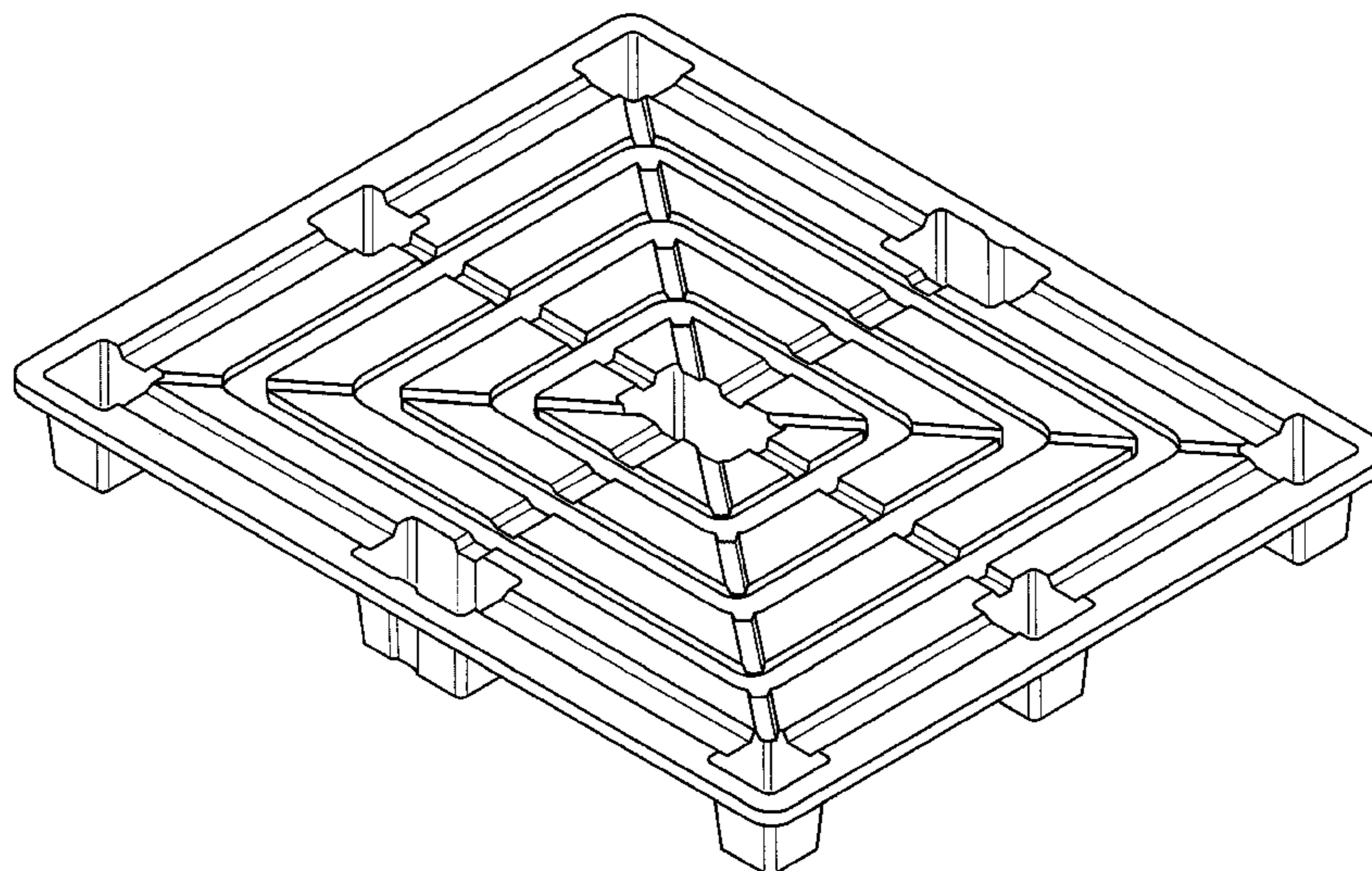
FIG. 2 is a side view of my design.

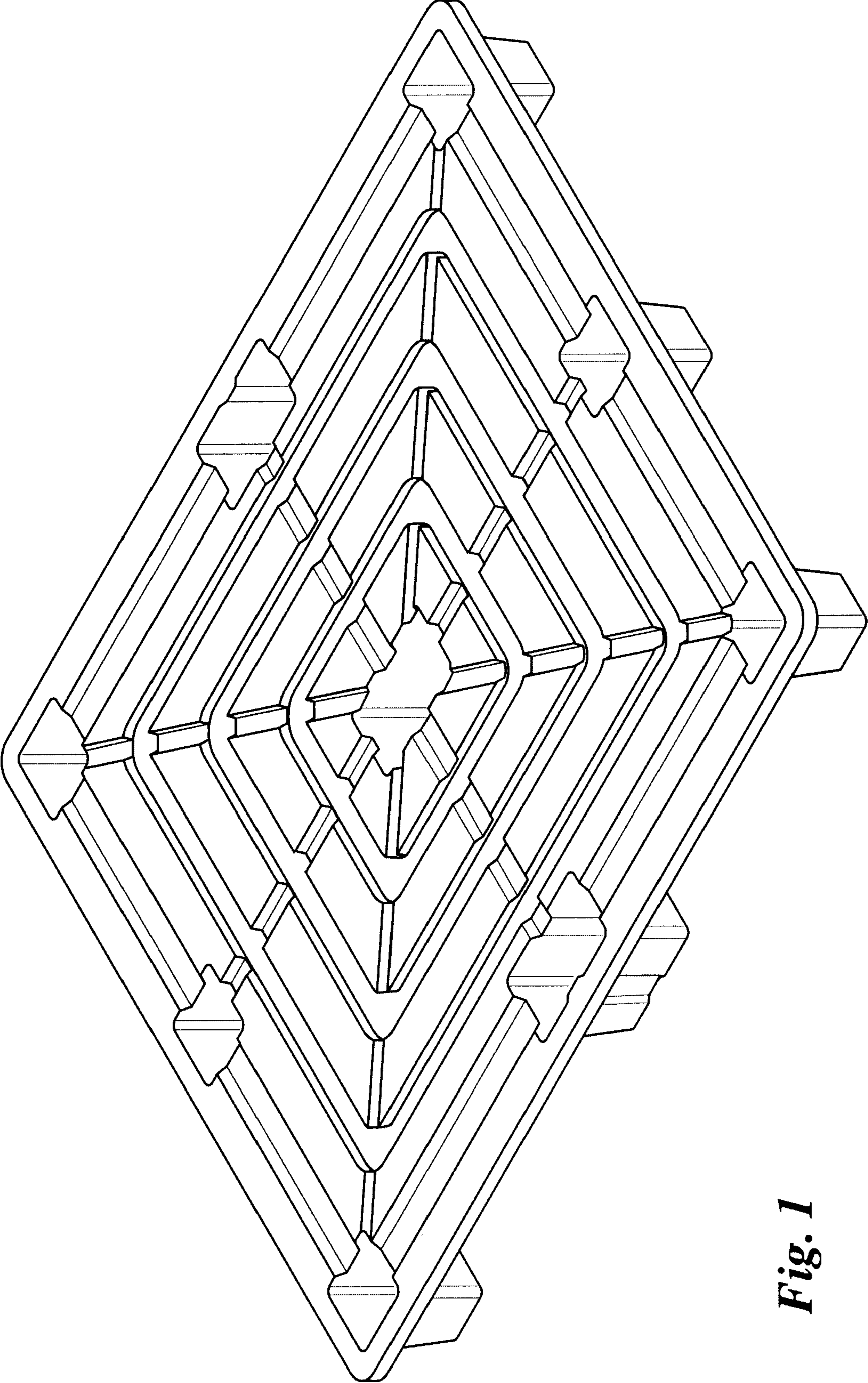

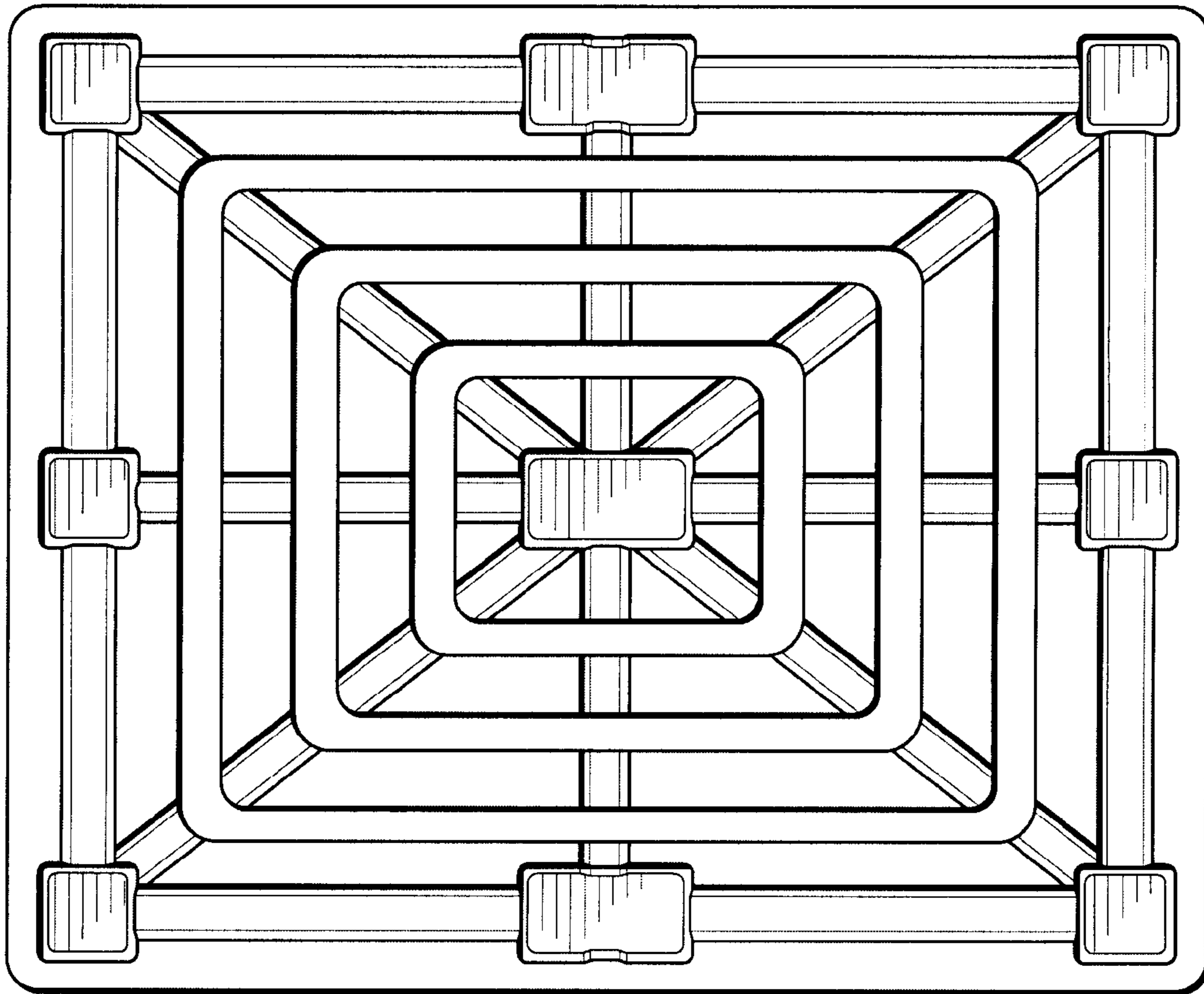

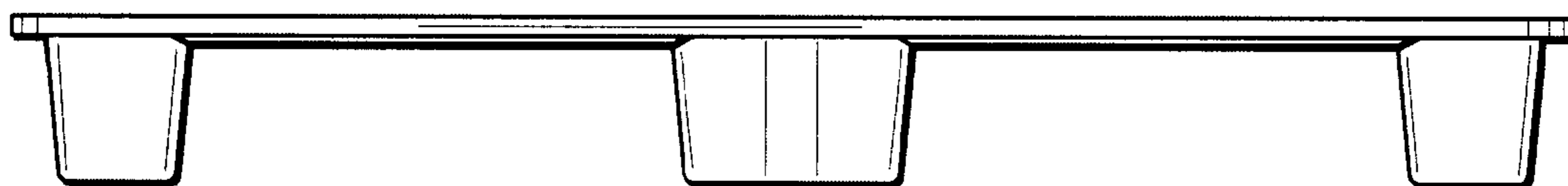

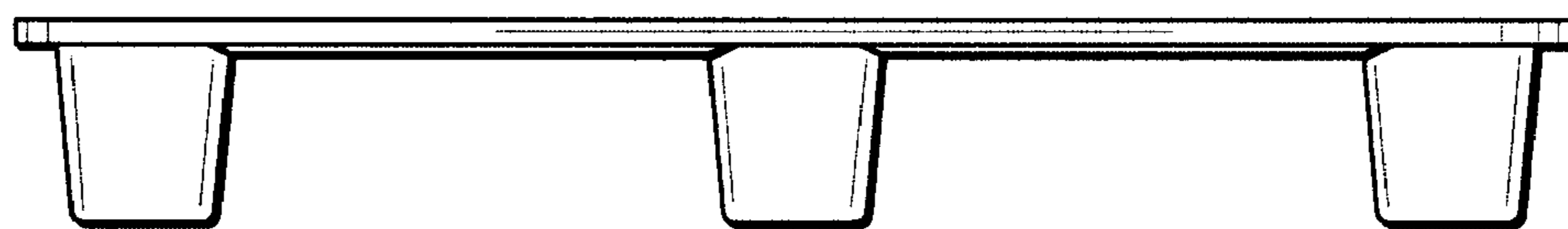

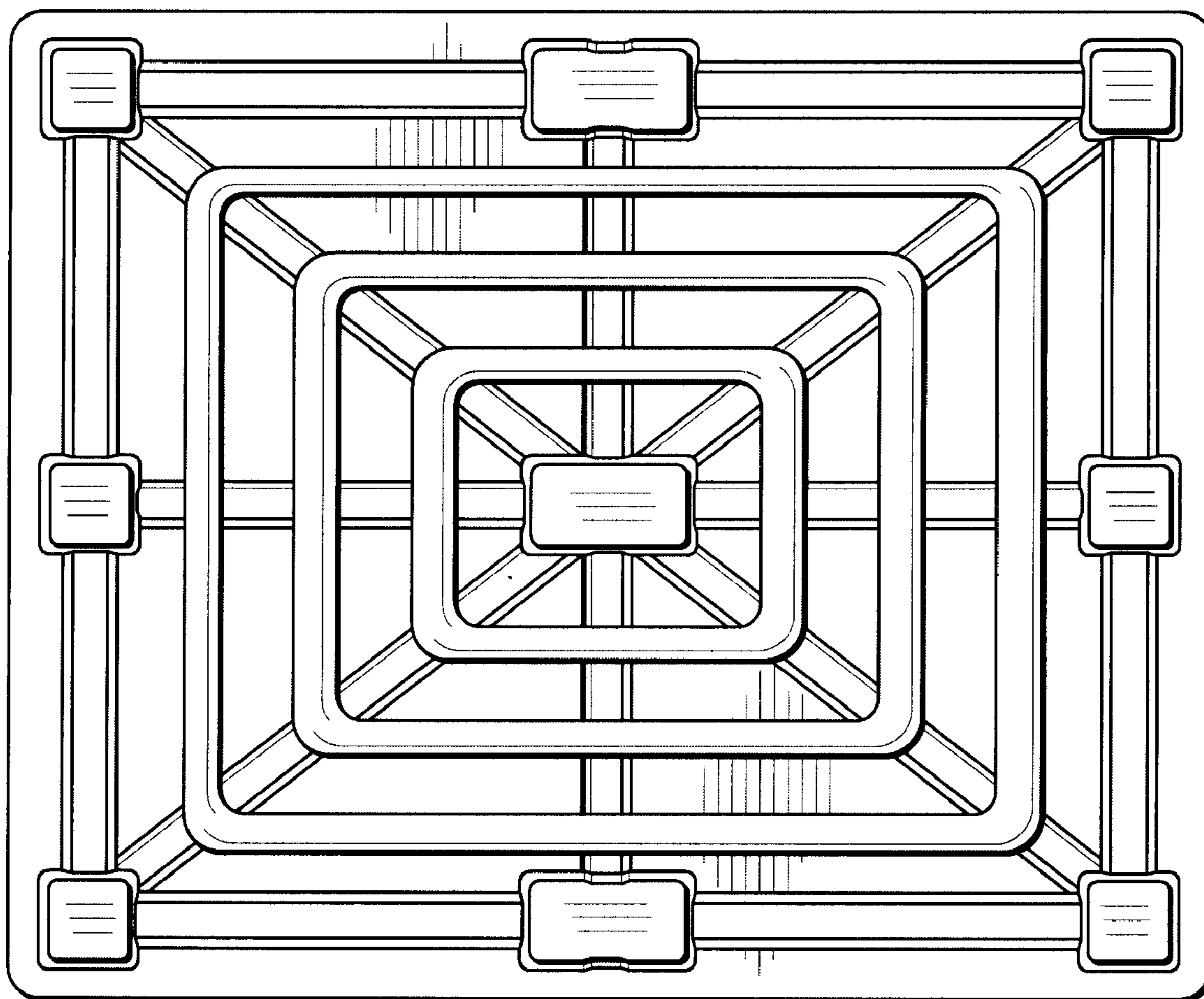
