FIG. 8 is a bottom perspective view; and,

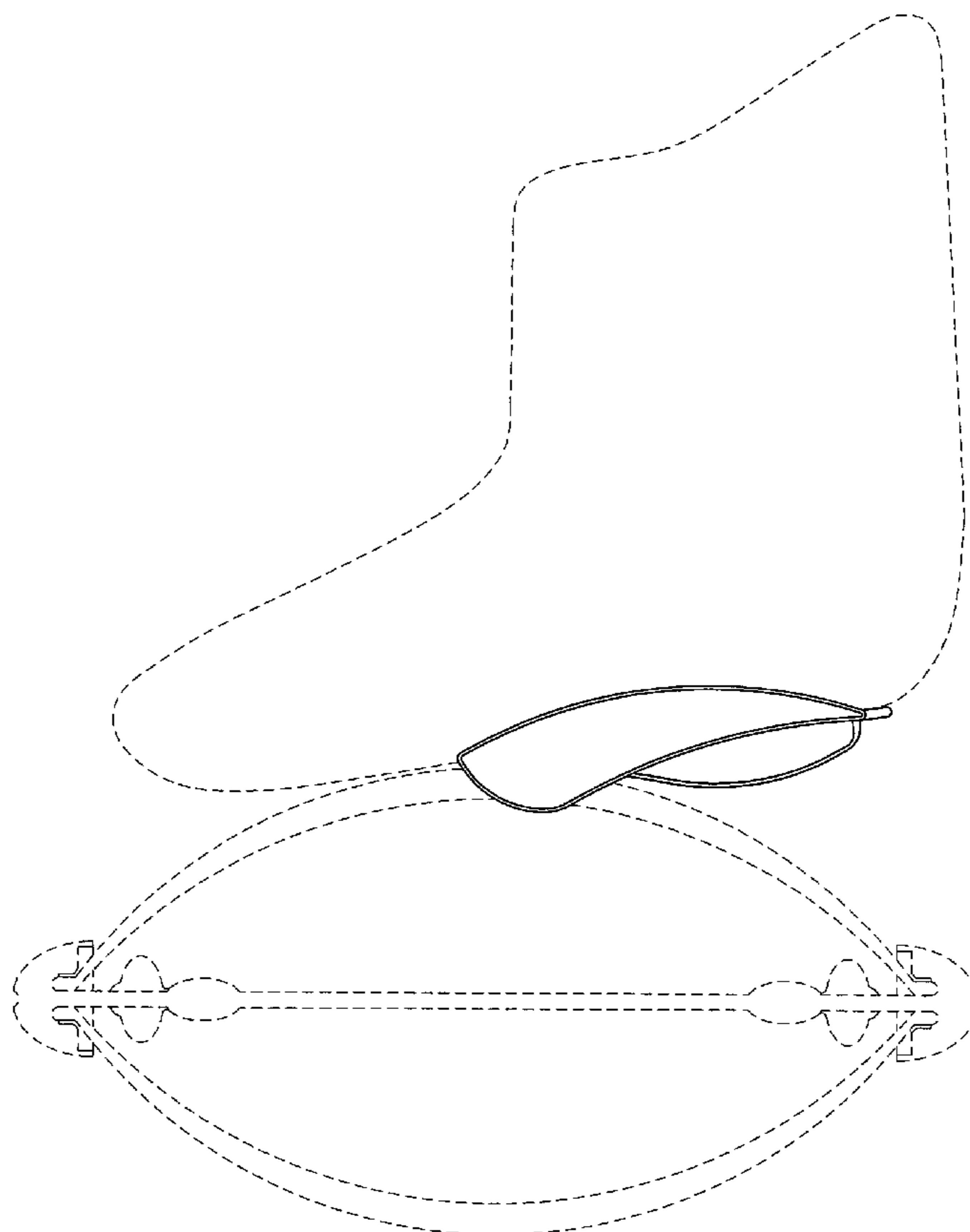
FIG. 9 is a left side elevation view and the broken disclosure of the shoe and other structure is for illustrative puposes only and forms no part of the claimed design.

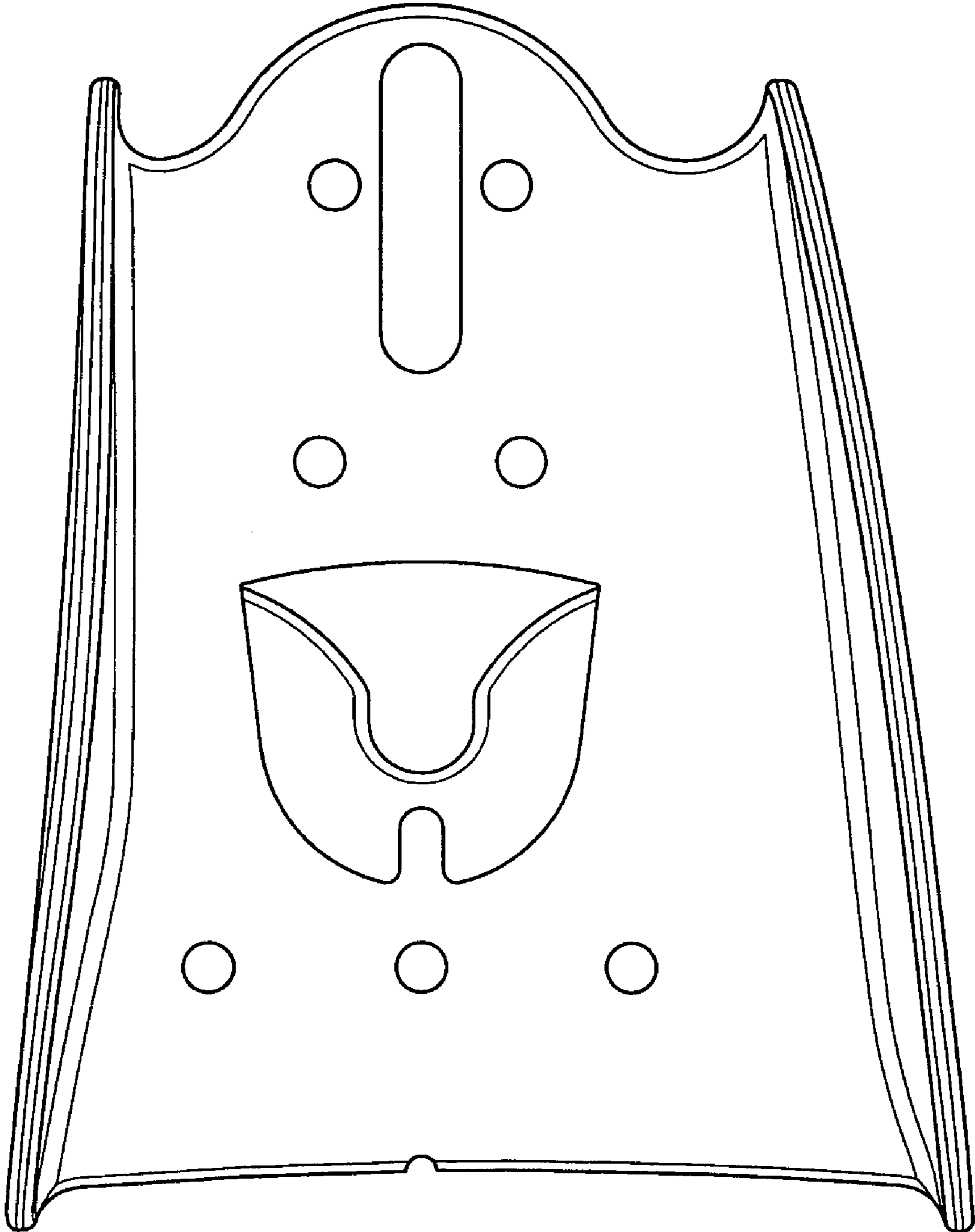

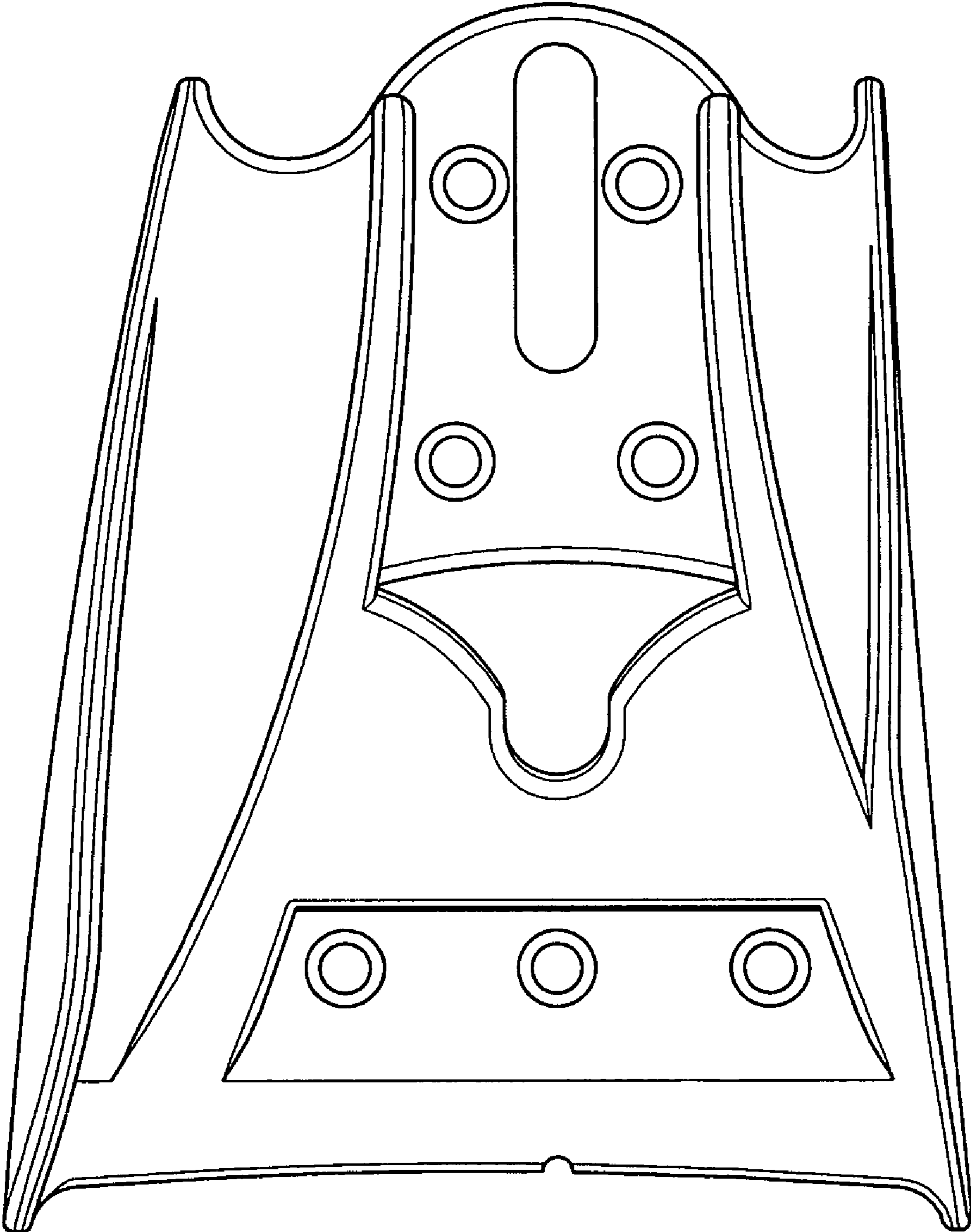

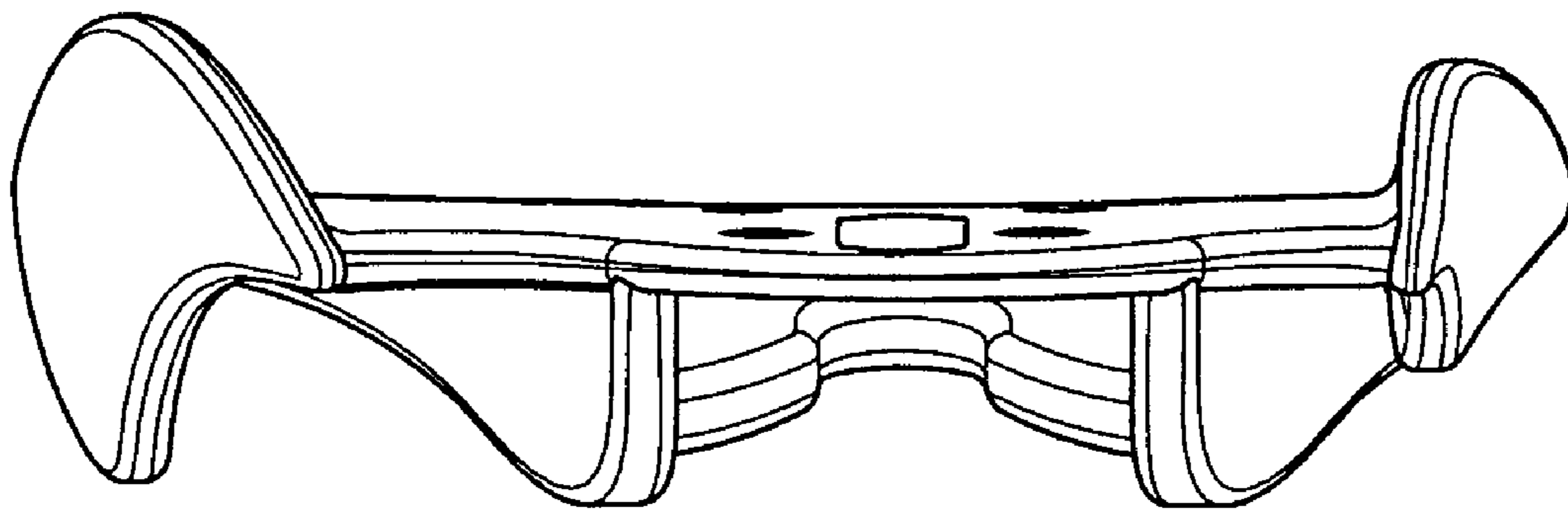

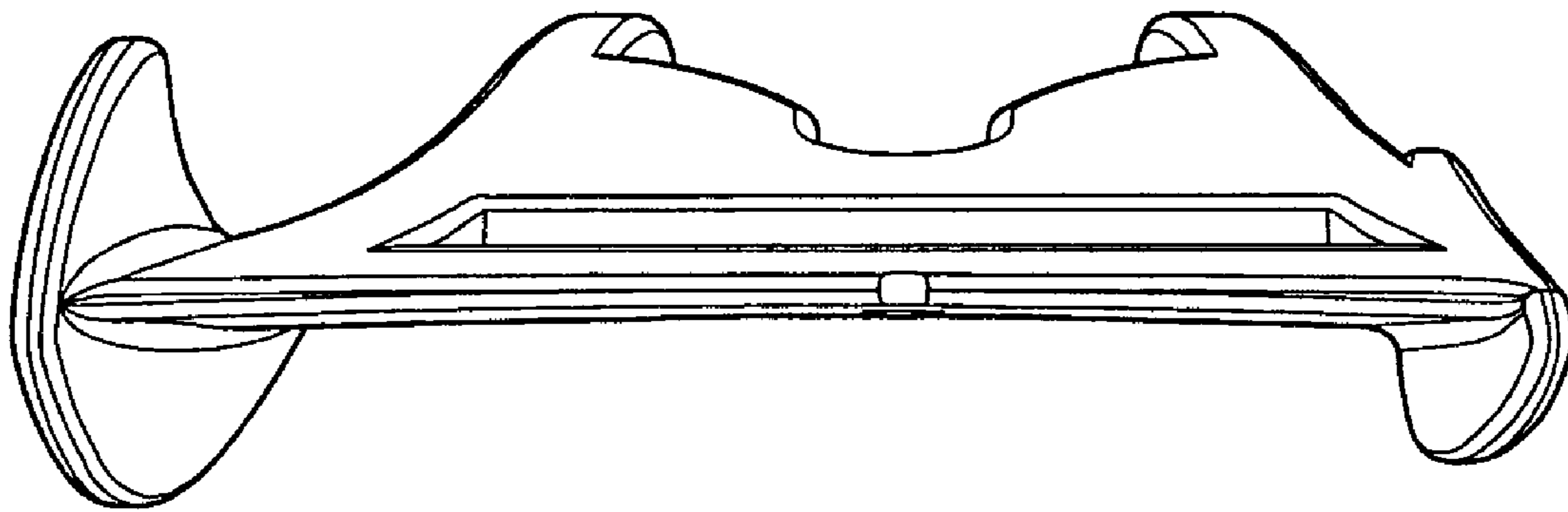

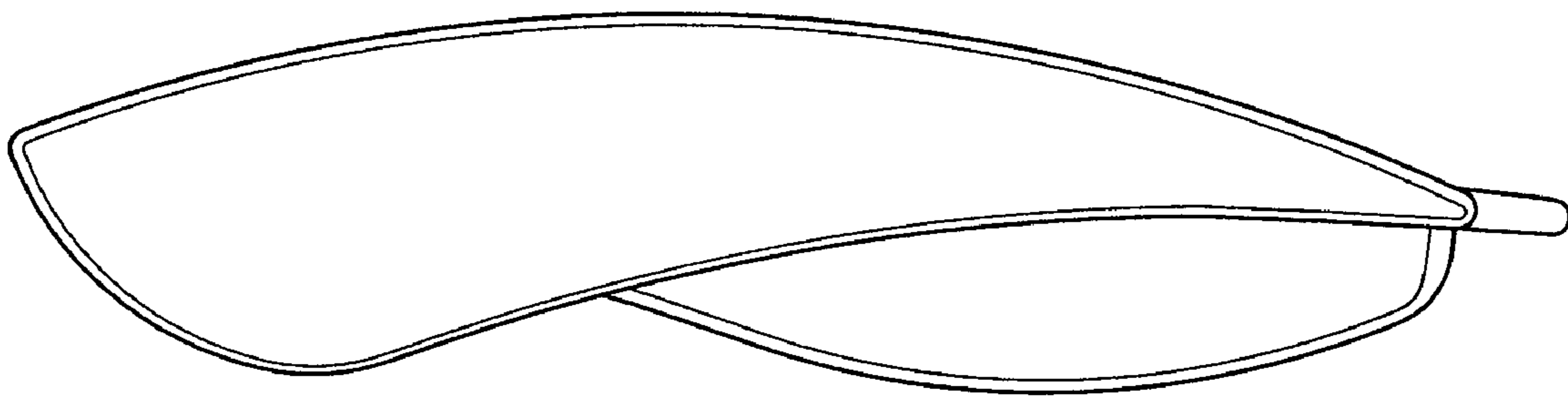

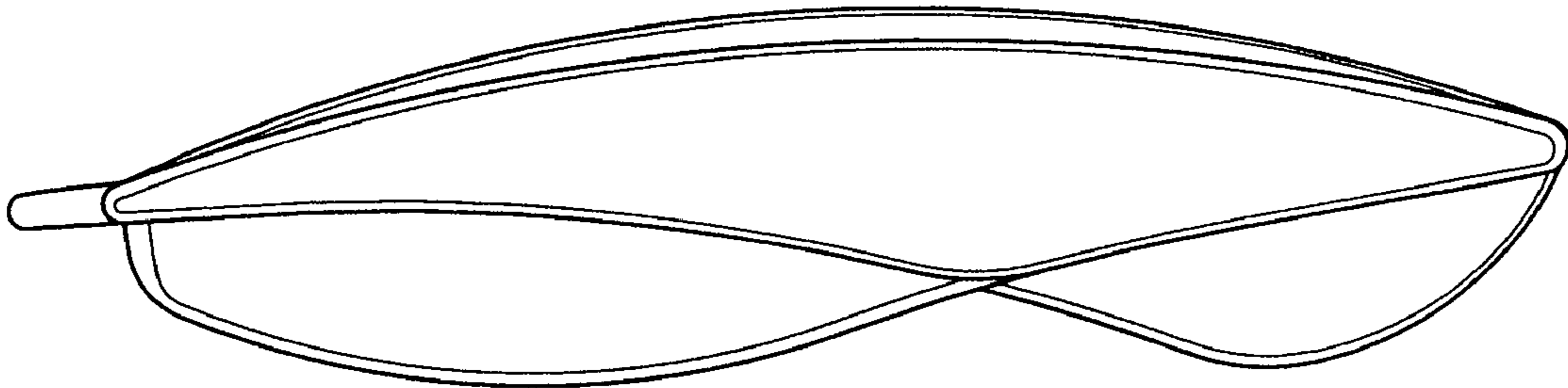

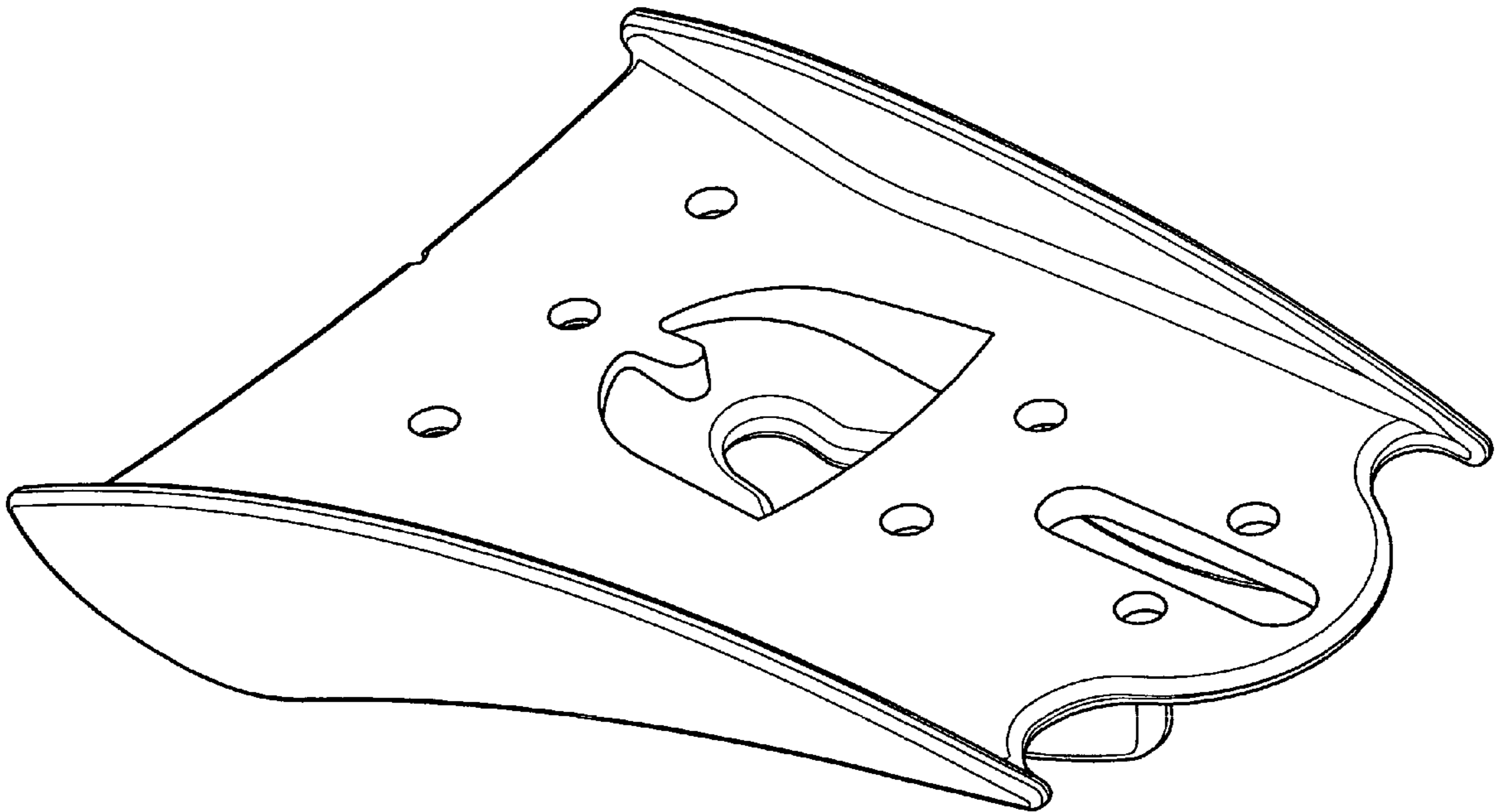

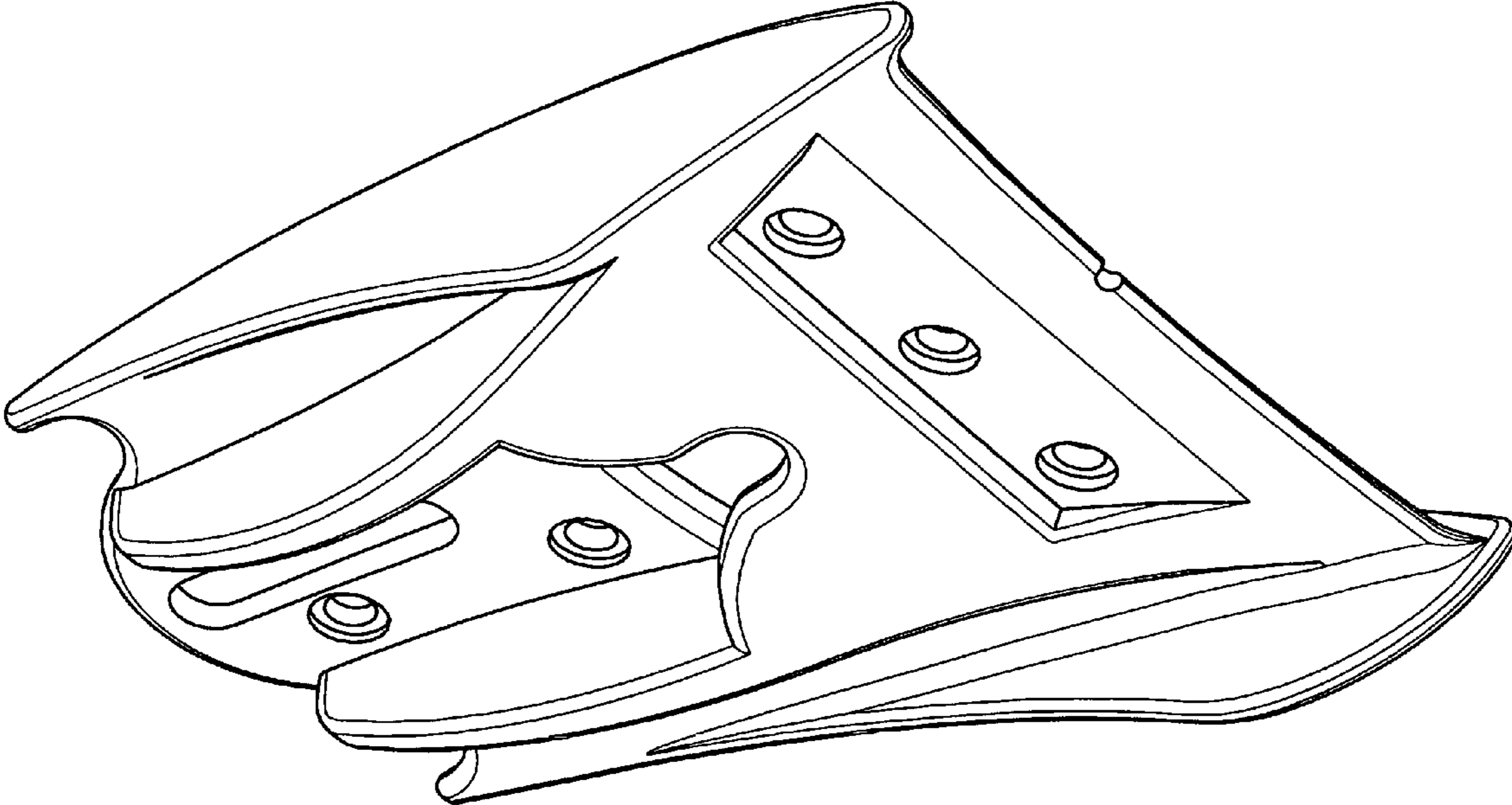
