DESCRIPTION

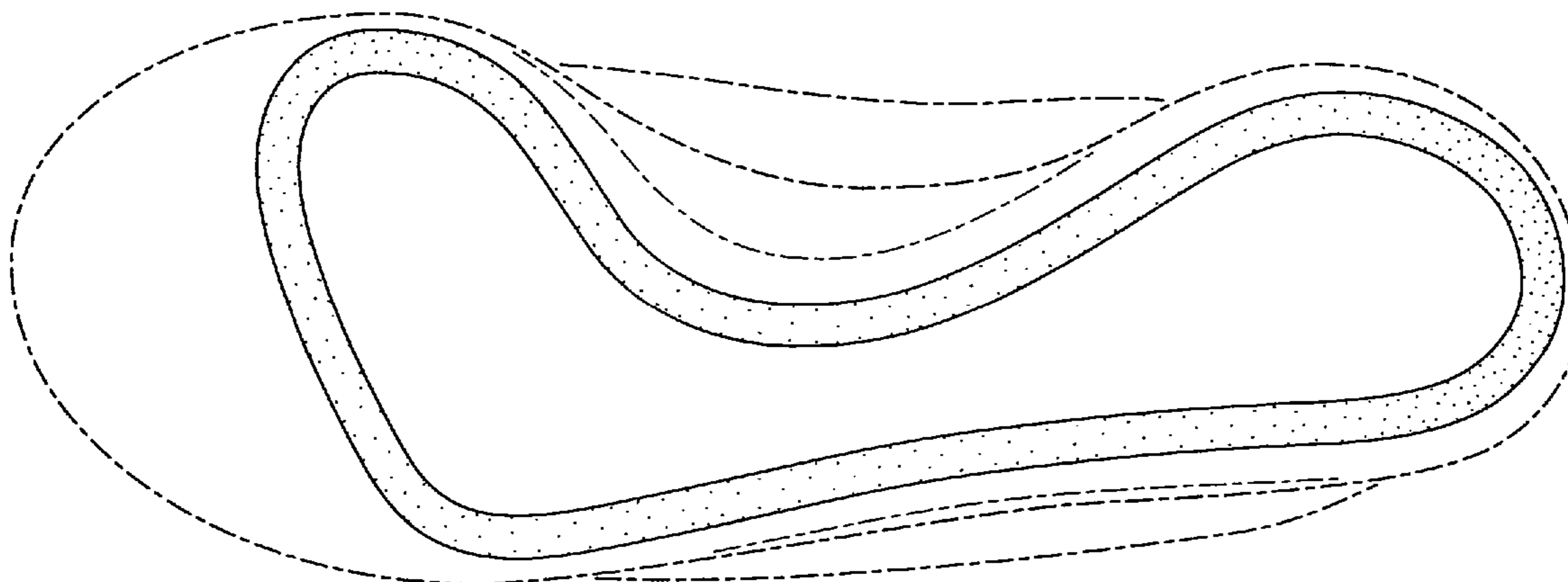
FIG. 1 is a bottom front perspective view of a shoe outsole showing my new design;

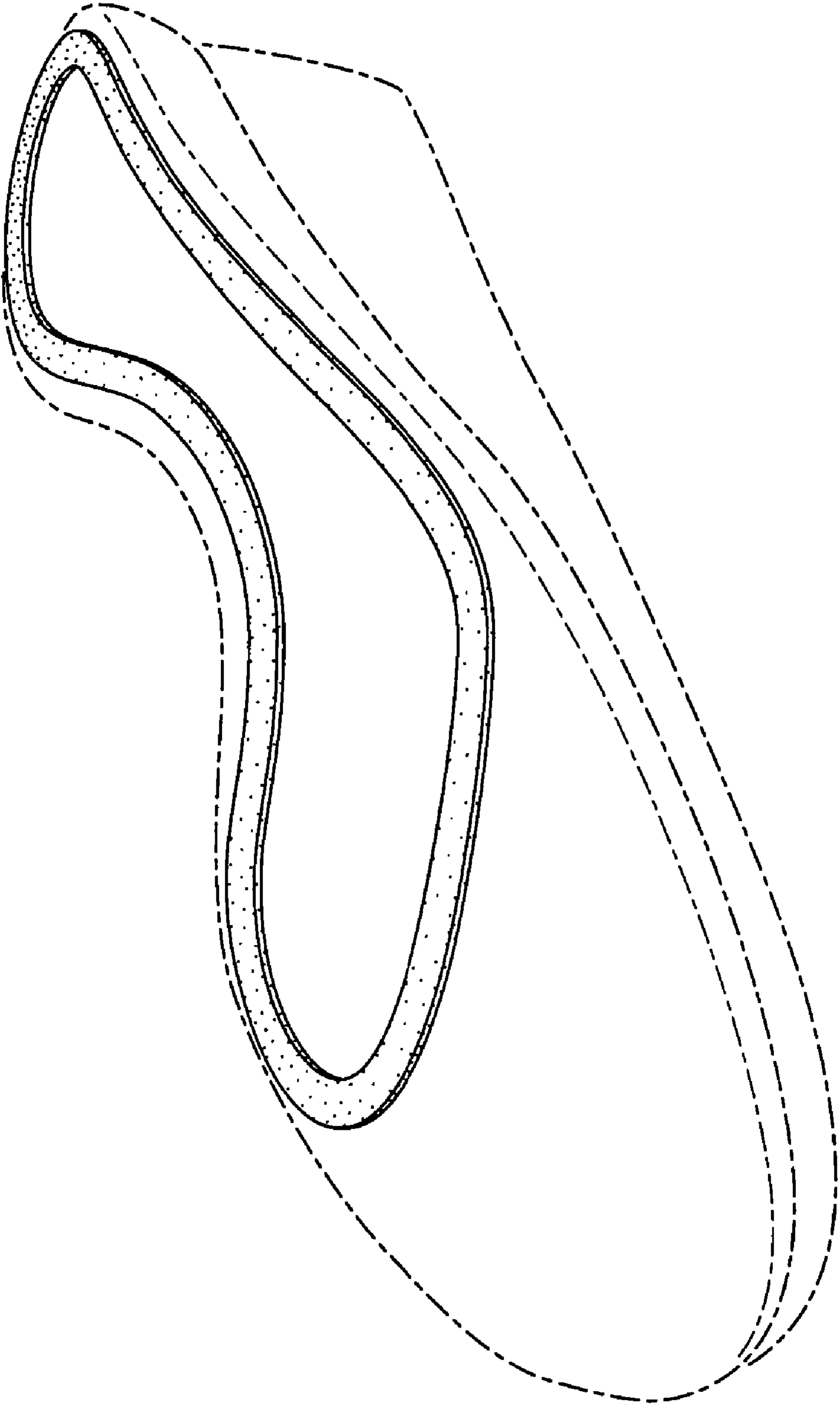

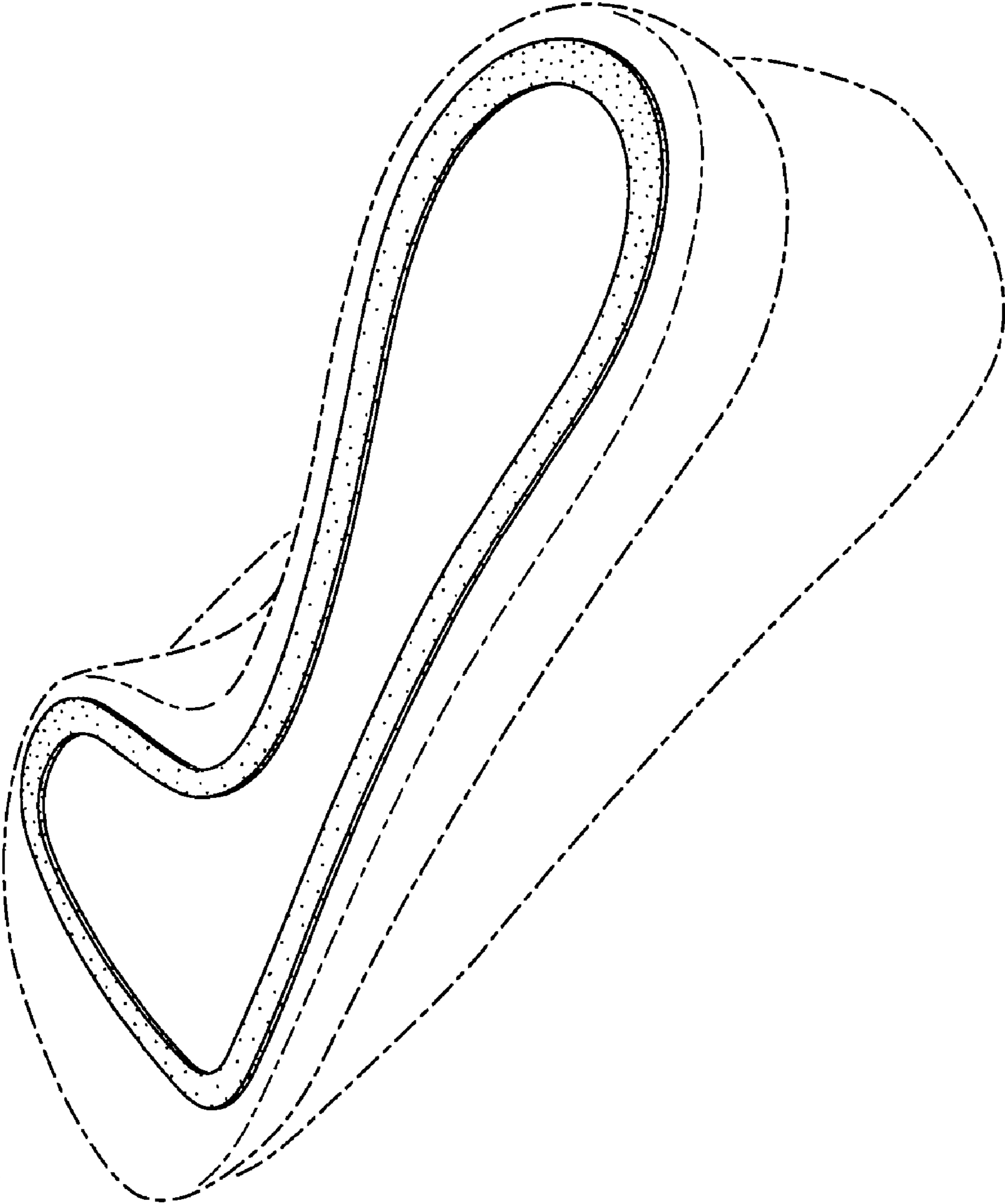

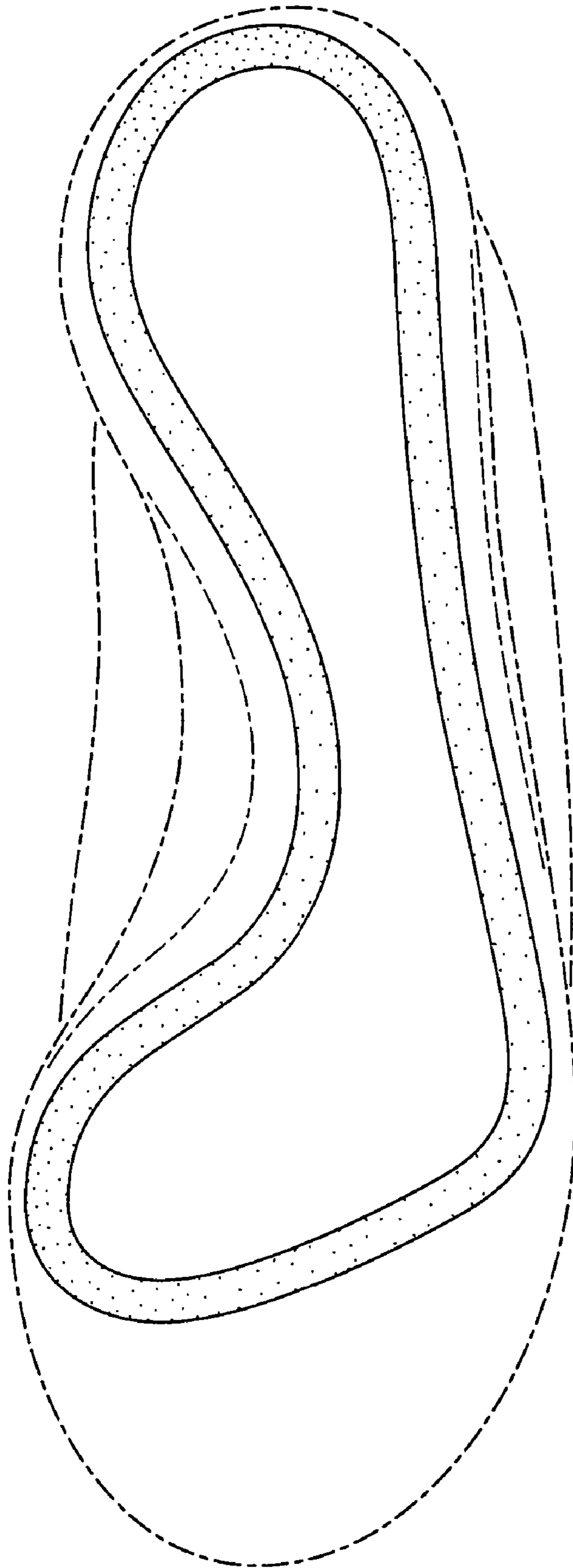
