The ornamental design for a portion of a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 4 is a left side plan view thereof;

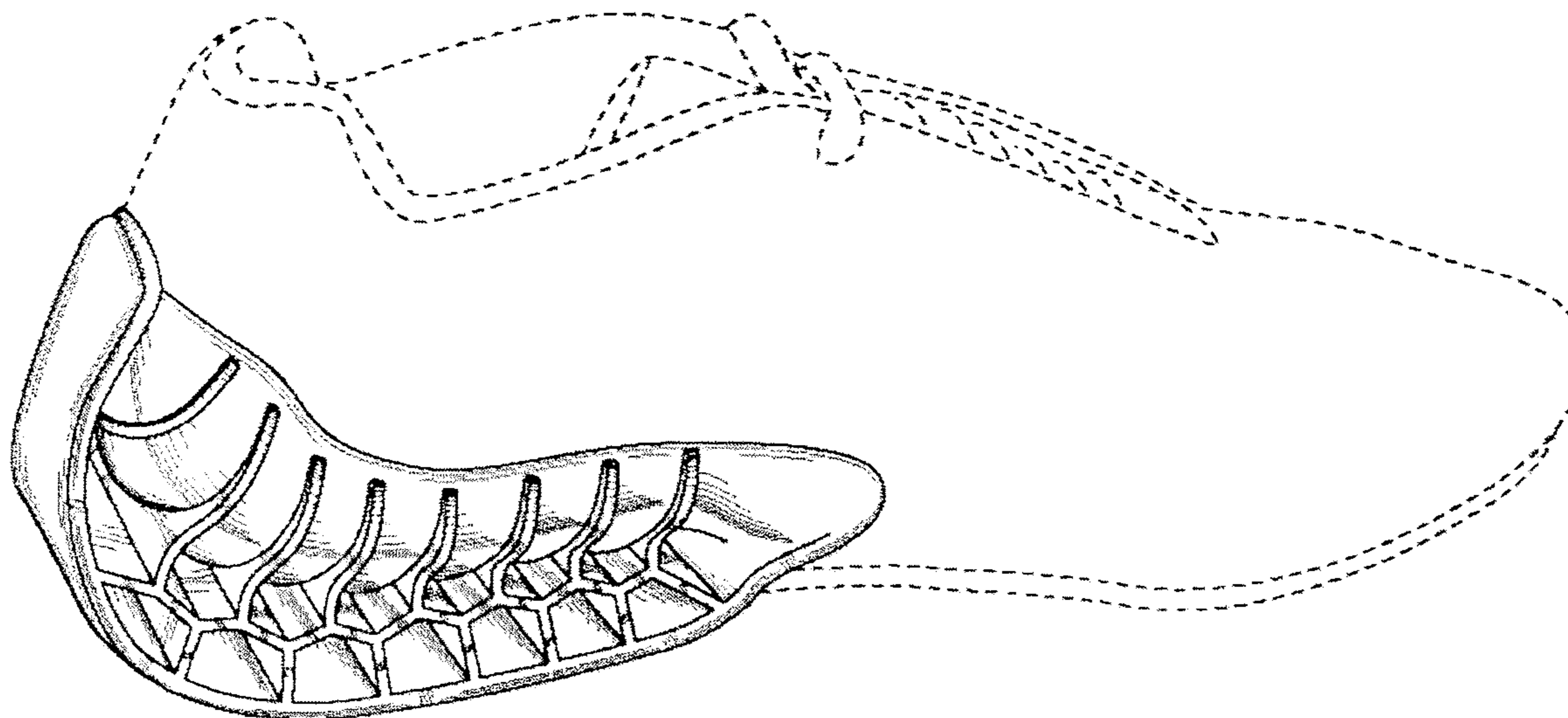
FIG. 5 is a top side plan view thereof;

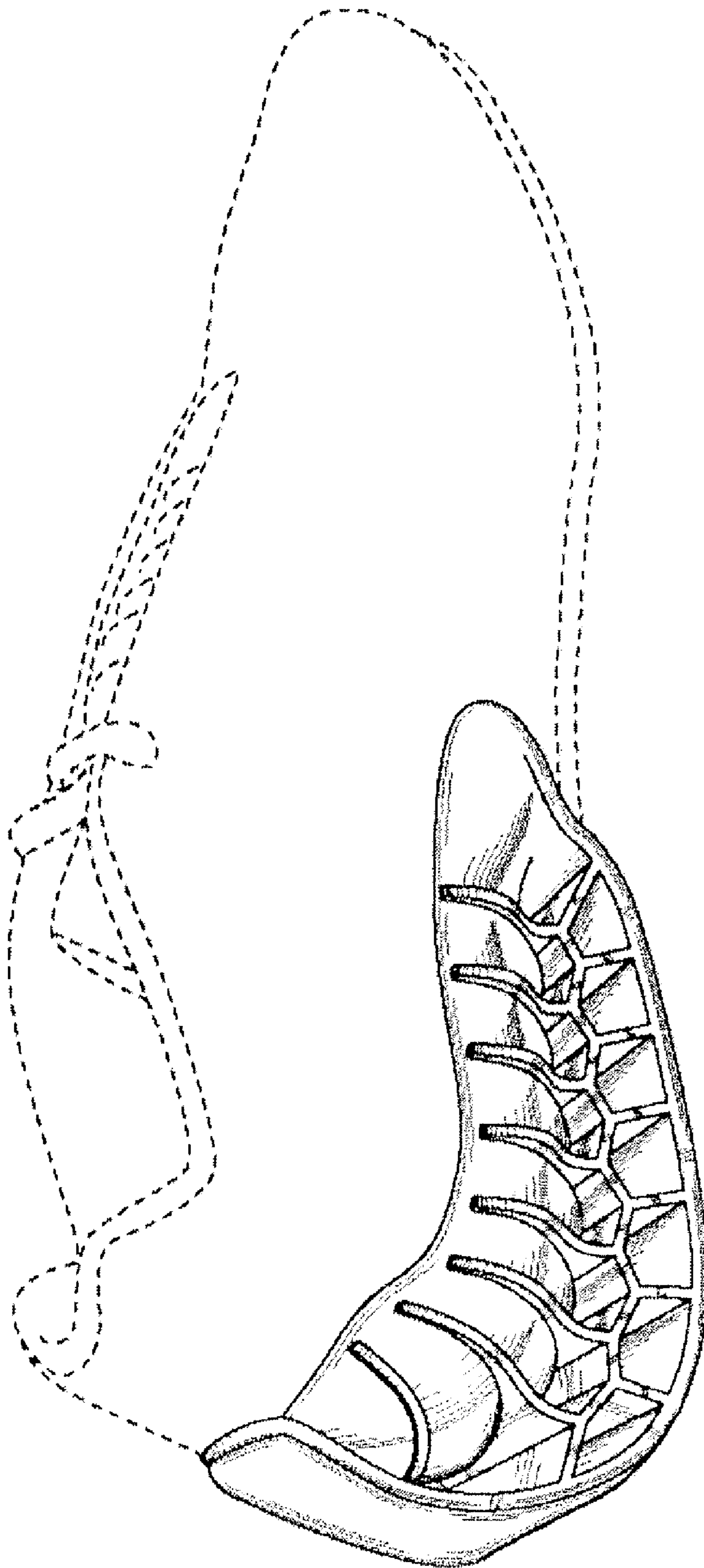

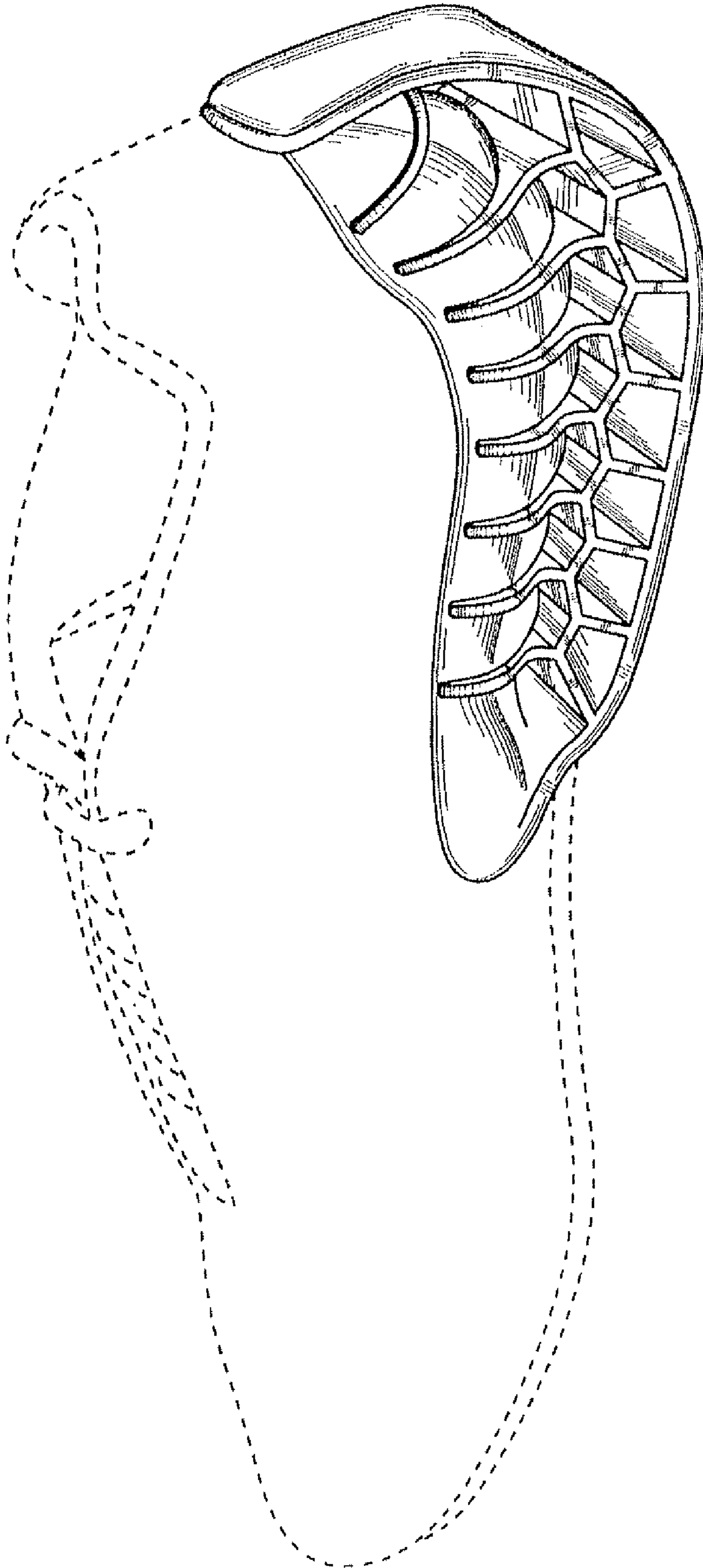

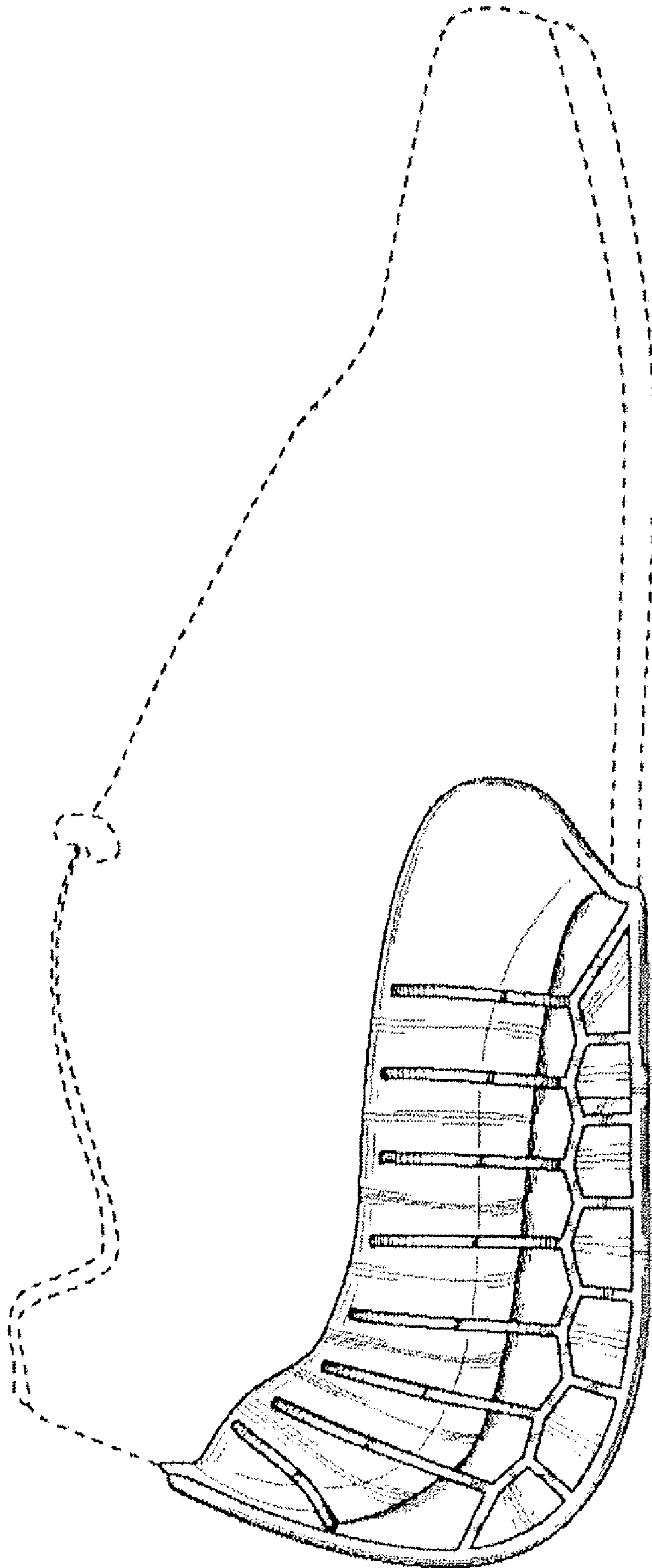

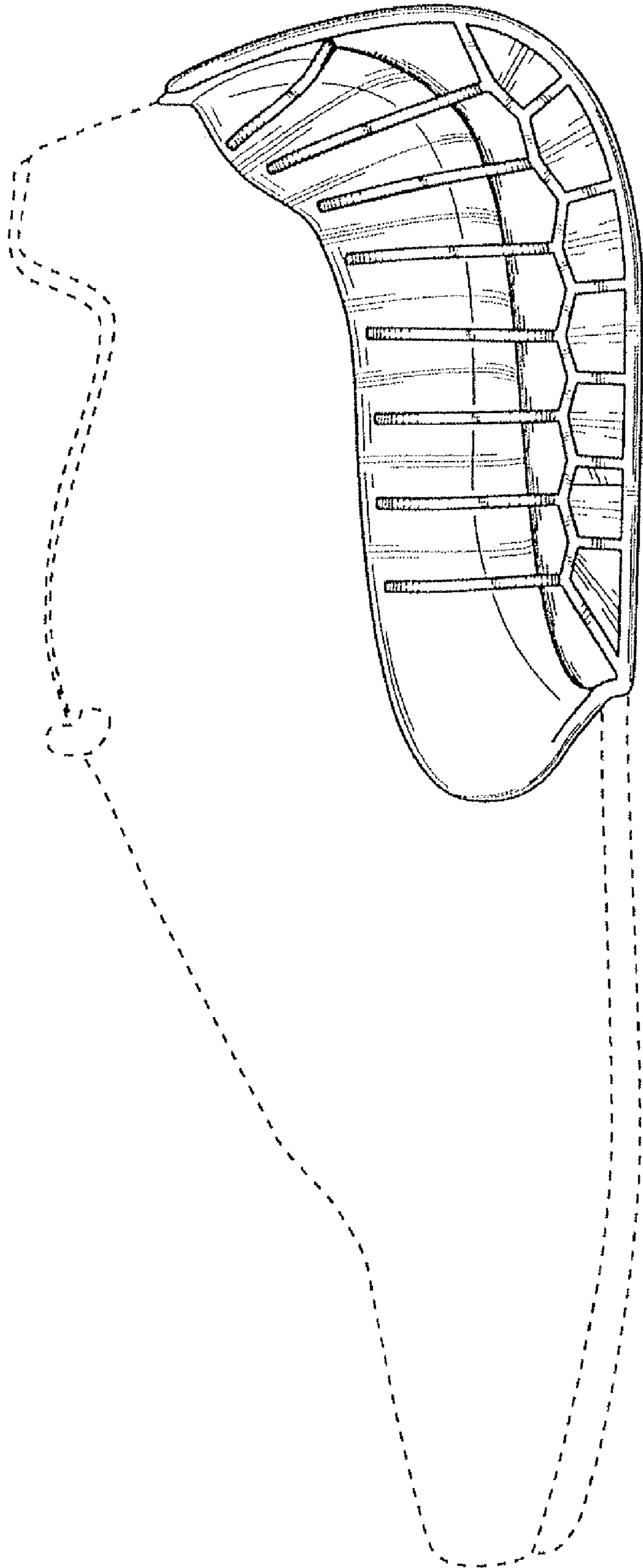

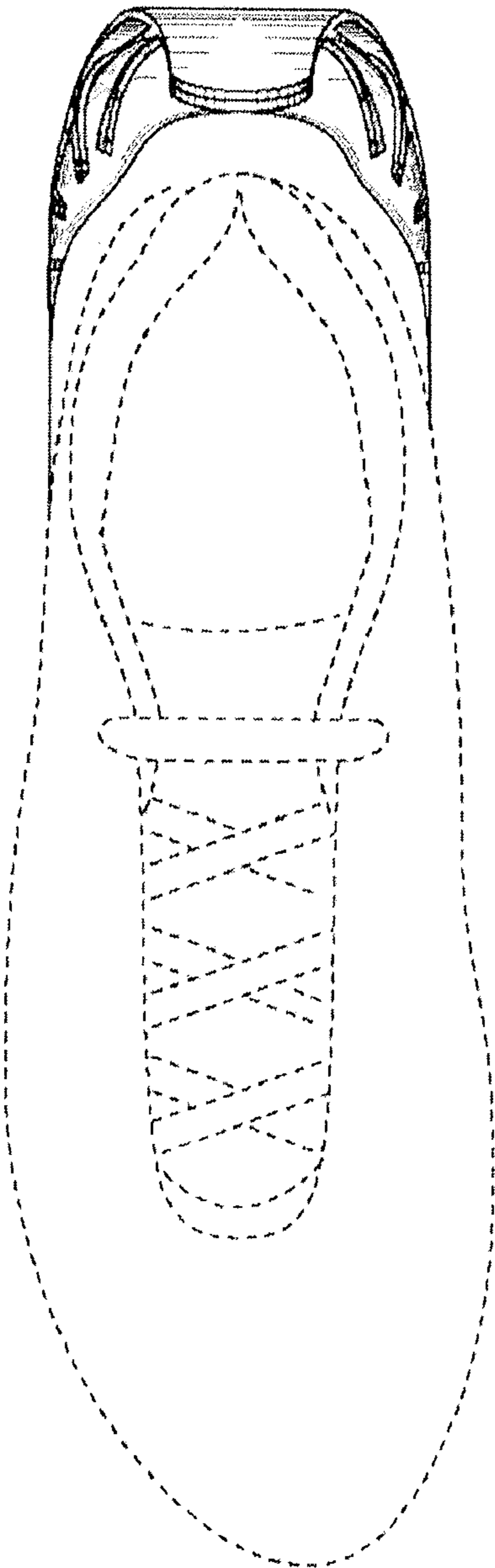

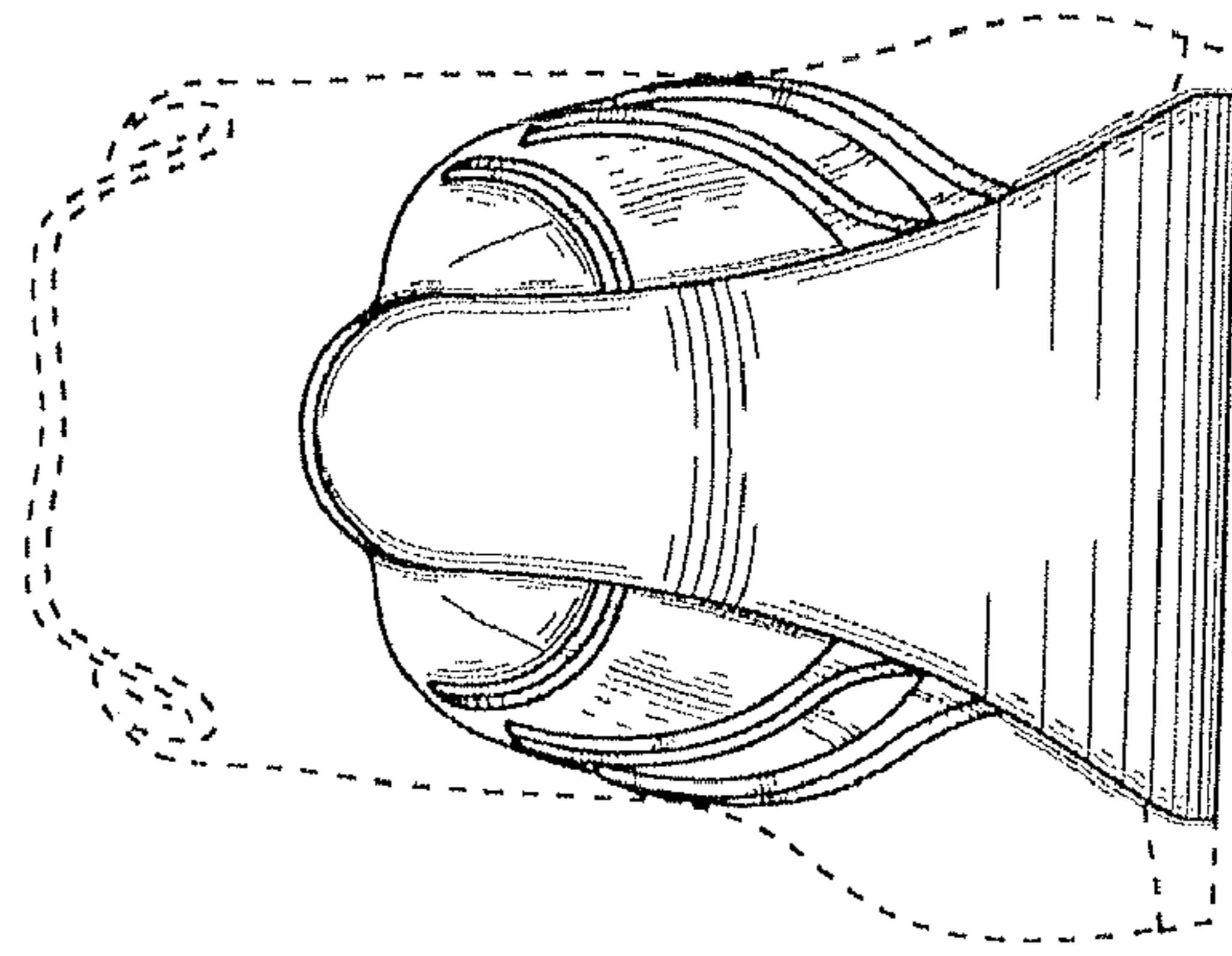

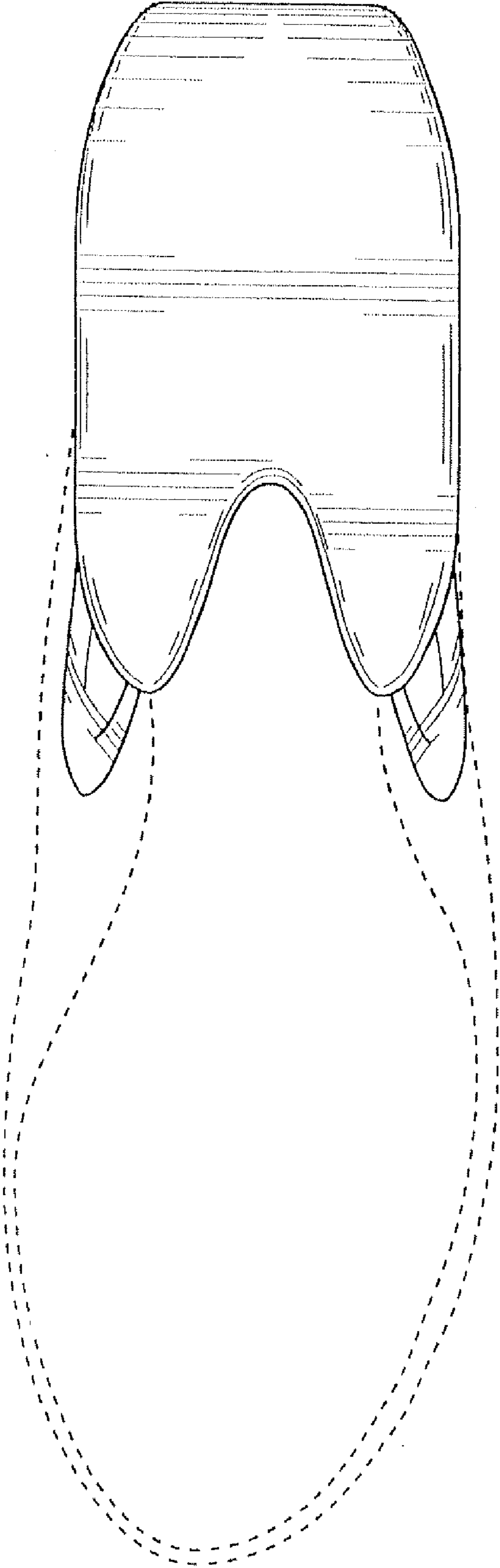
