(57) **CLAIM**

The ornamental design for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the footwear showing my new design;

FIG. 2 is a left side view of the footwear shown in FIG. 1;

FIG. 3 is a right side view of the footwear shown in FIG. 1;

FIG. 4 is a front view of the footwear shown in FIG. 1;

FIG. 5 is a front perspective view of an alternative embodiment of the footwear shown in FIG. 1;

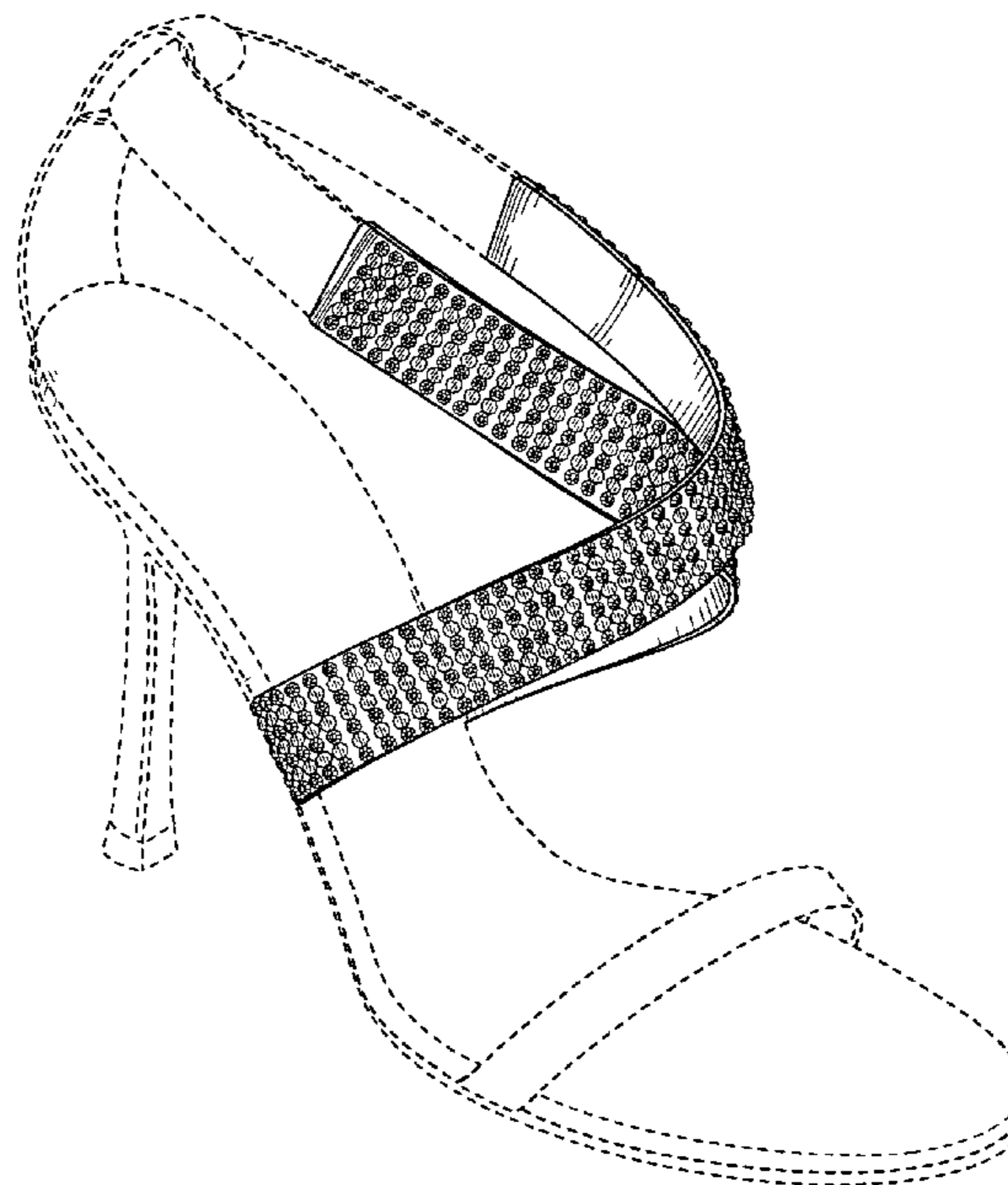
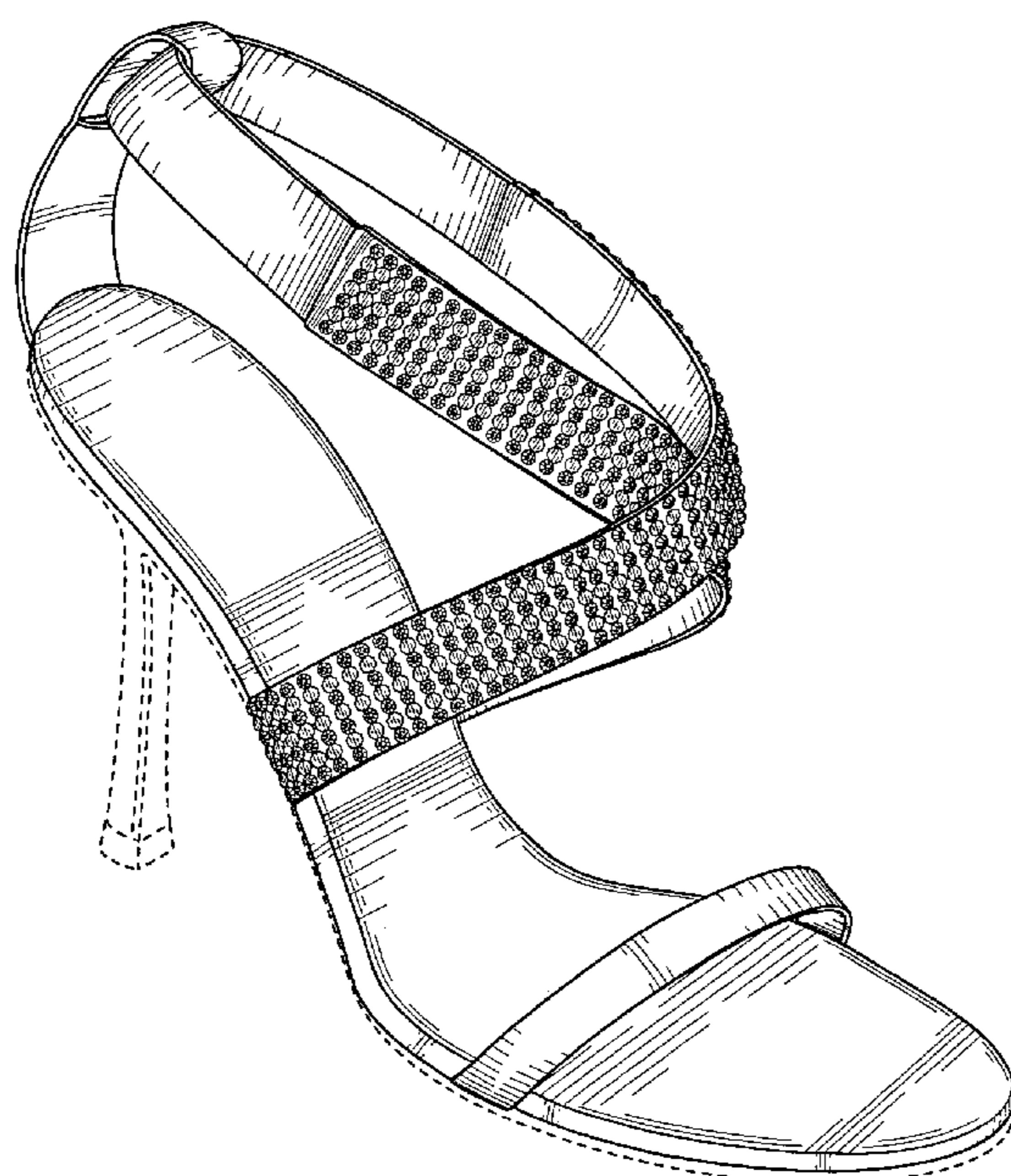
FIG. 6 is a left side view of the alternative embodiment of the footwear shown in FIG. 5;

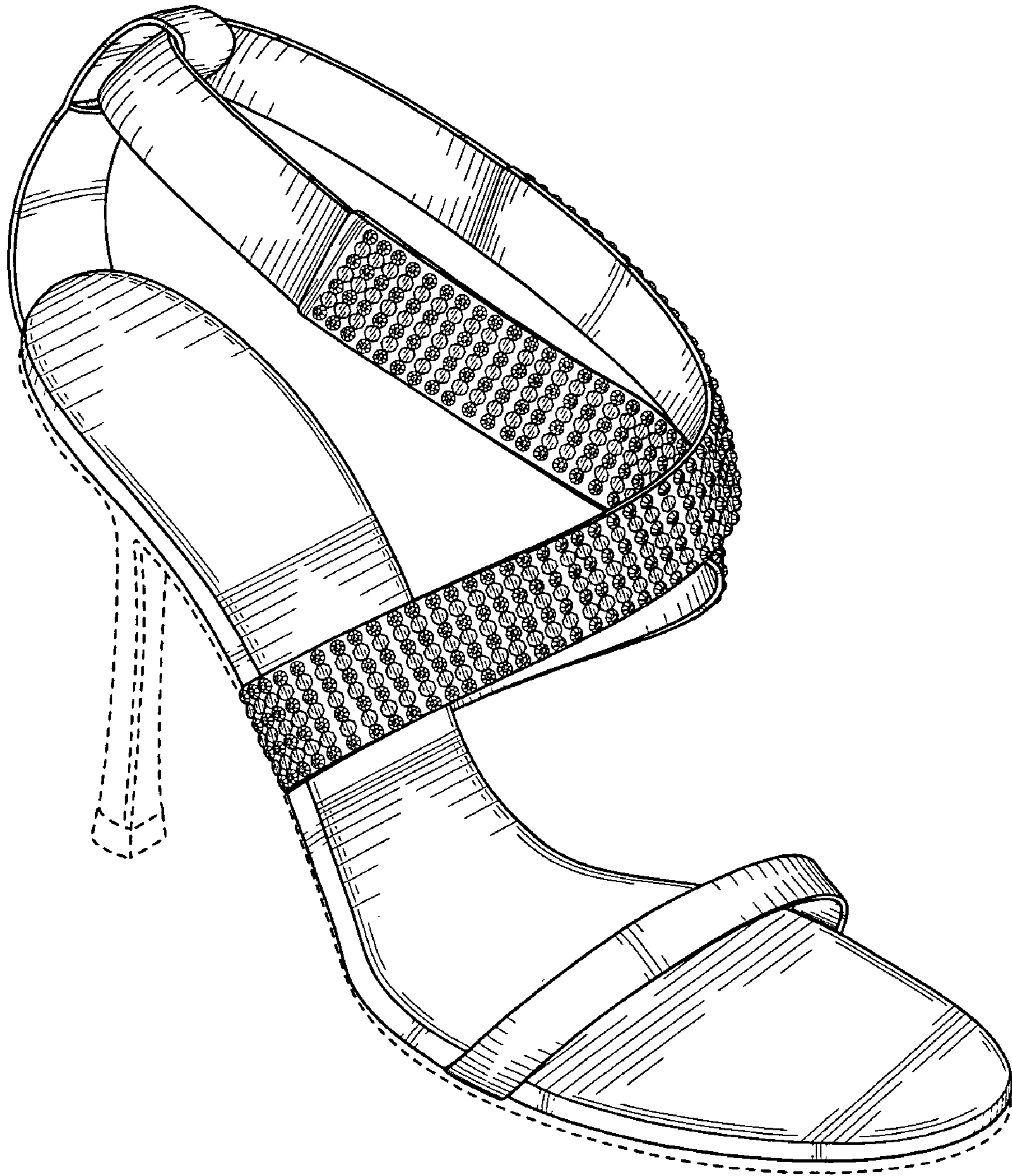

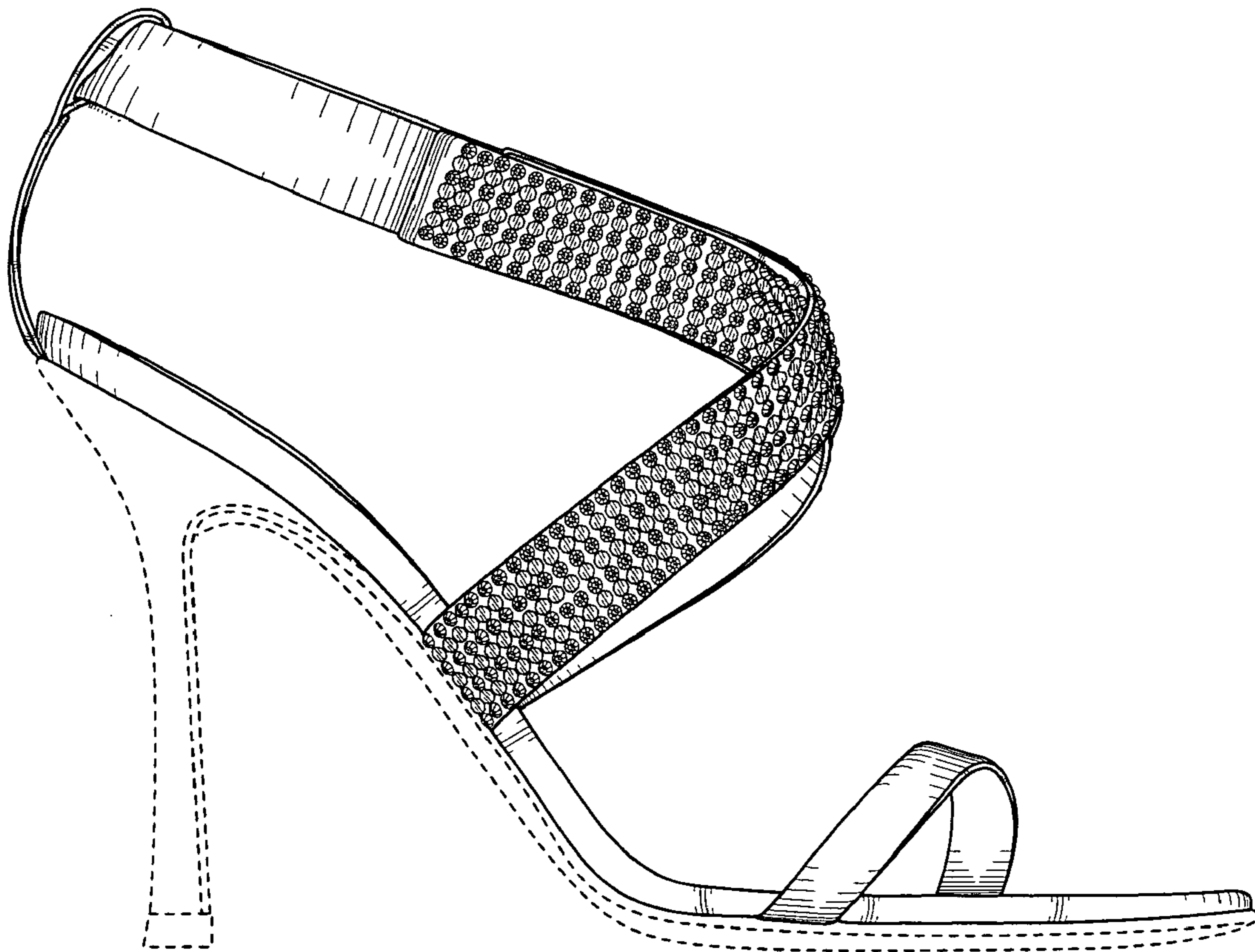

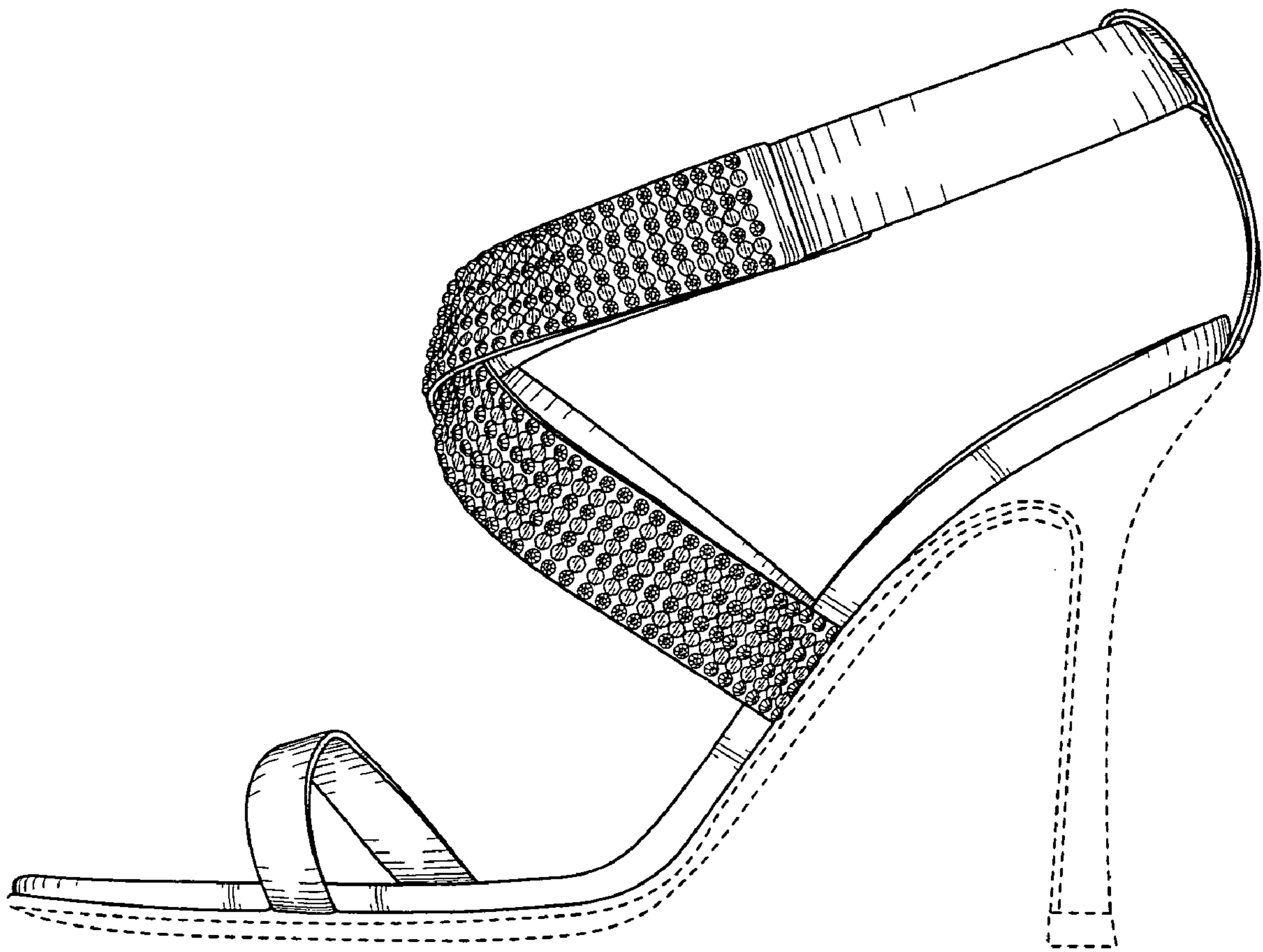

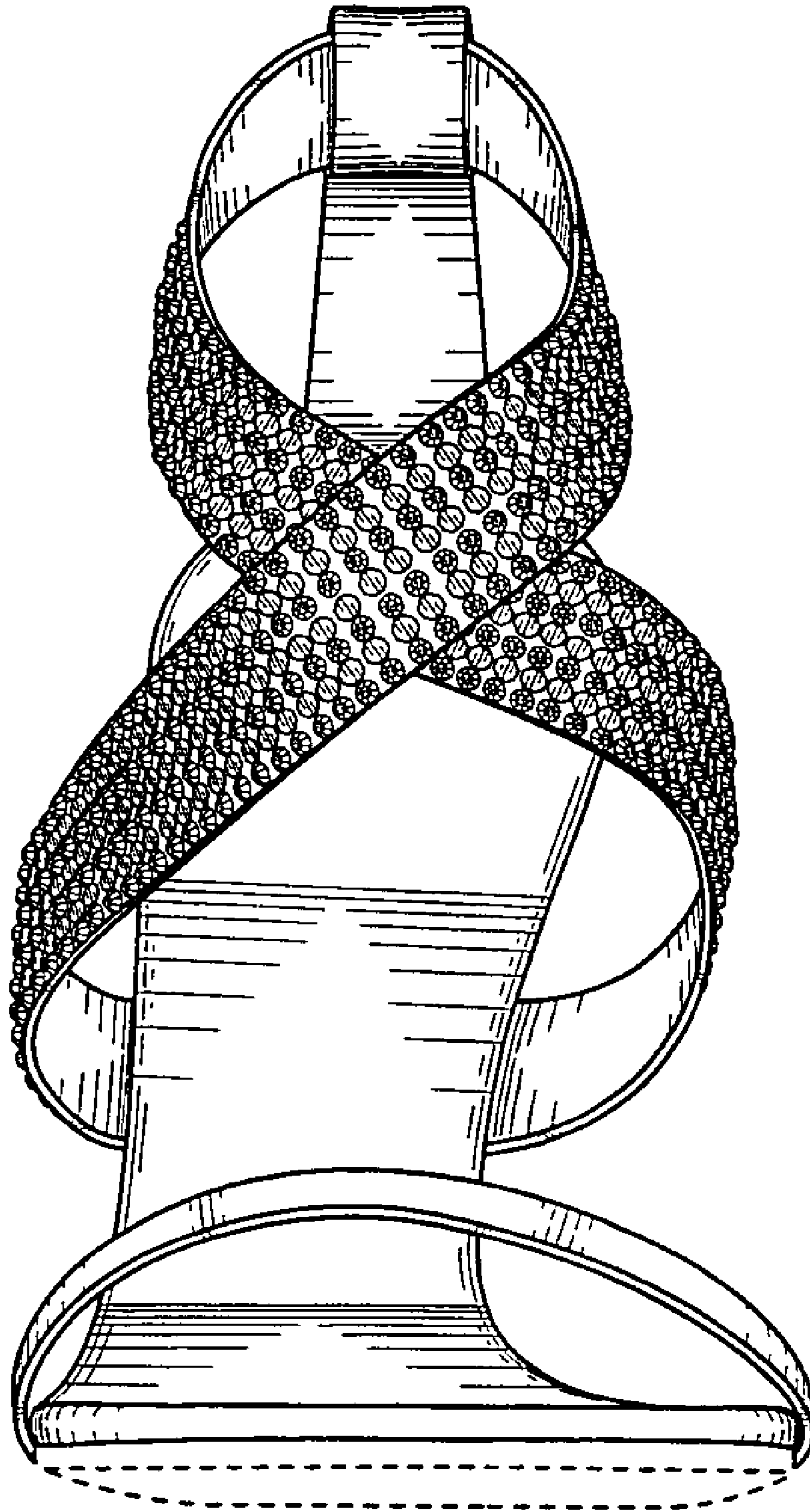

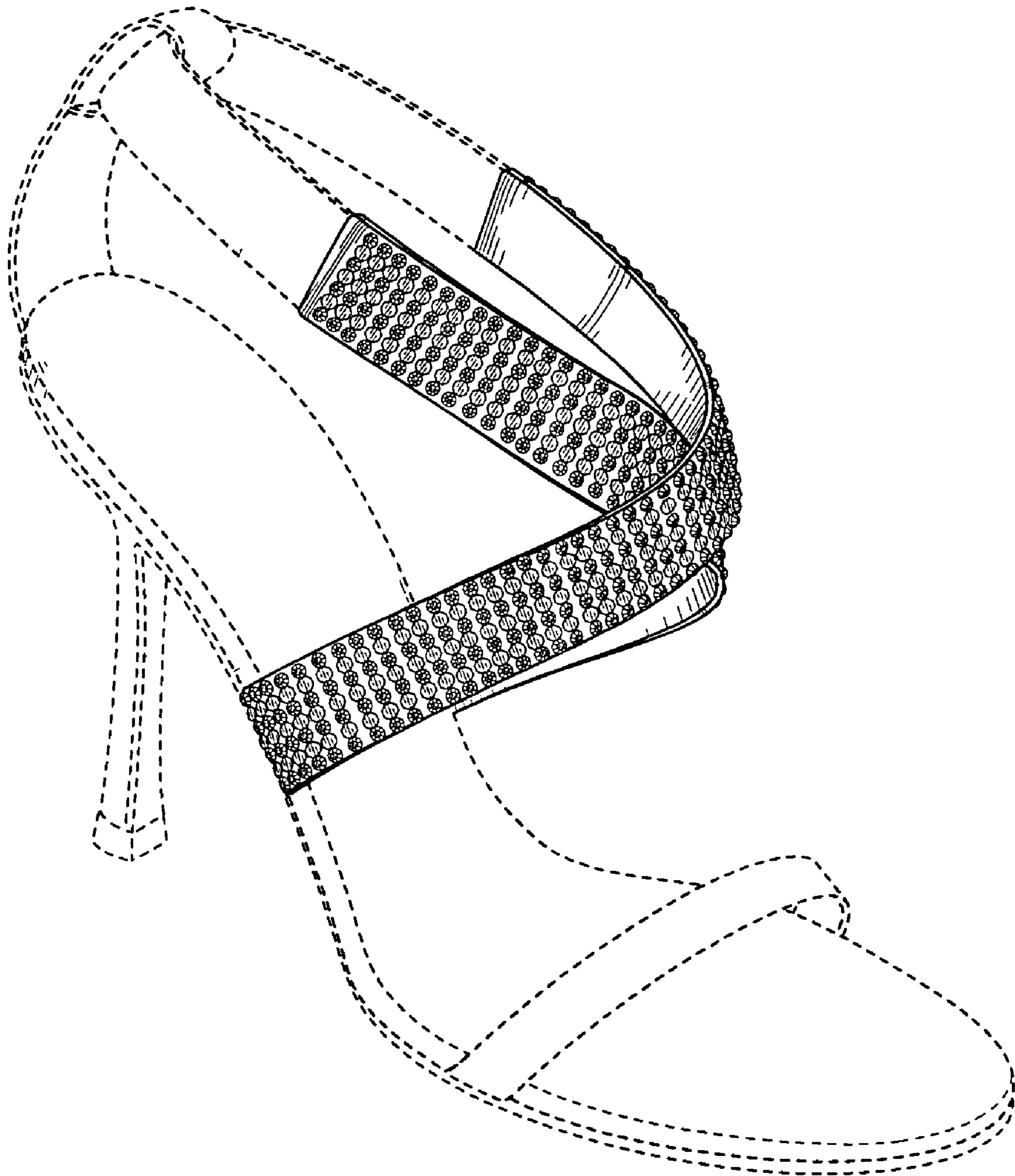

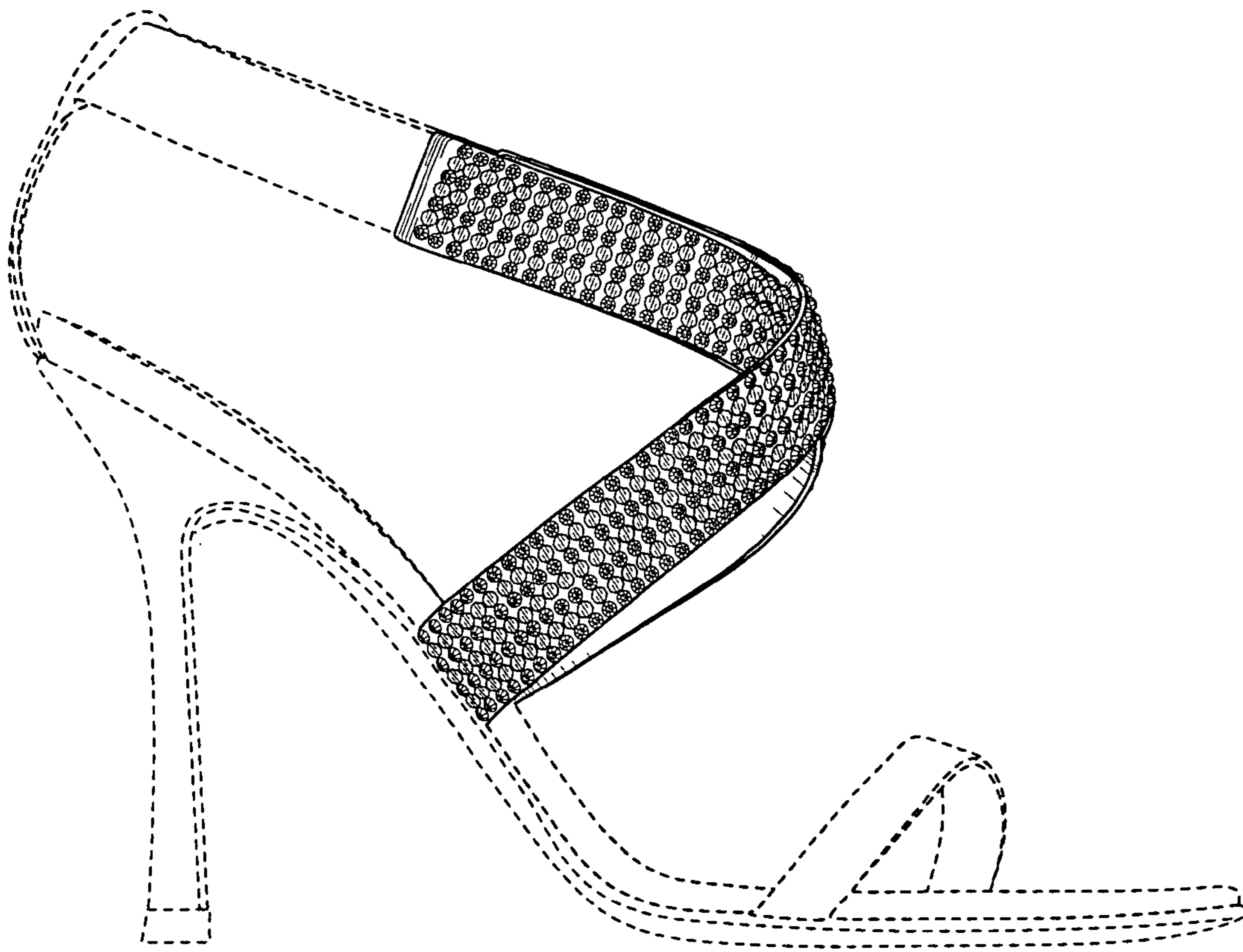

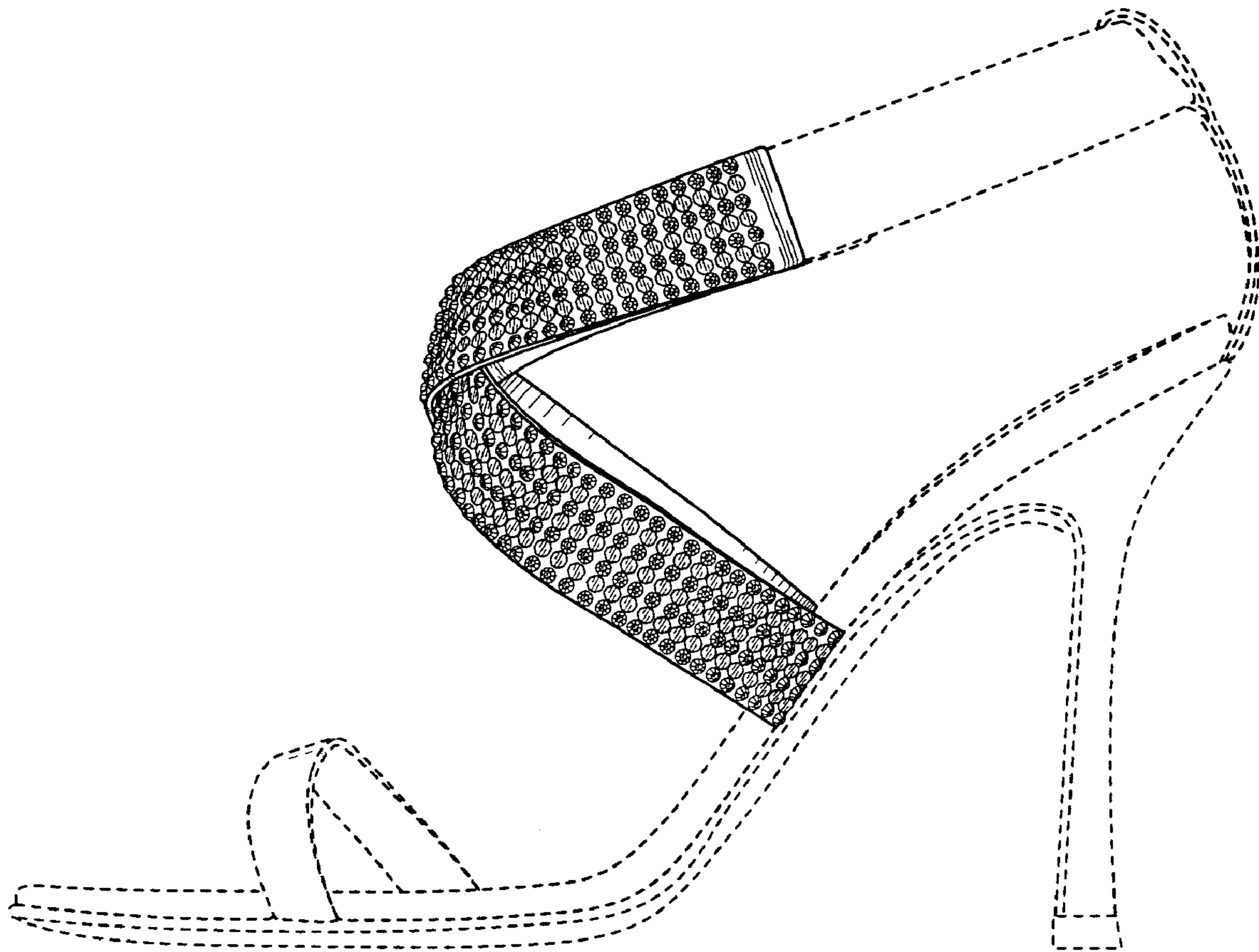

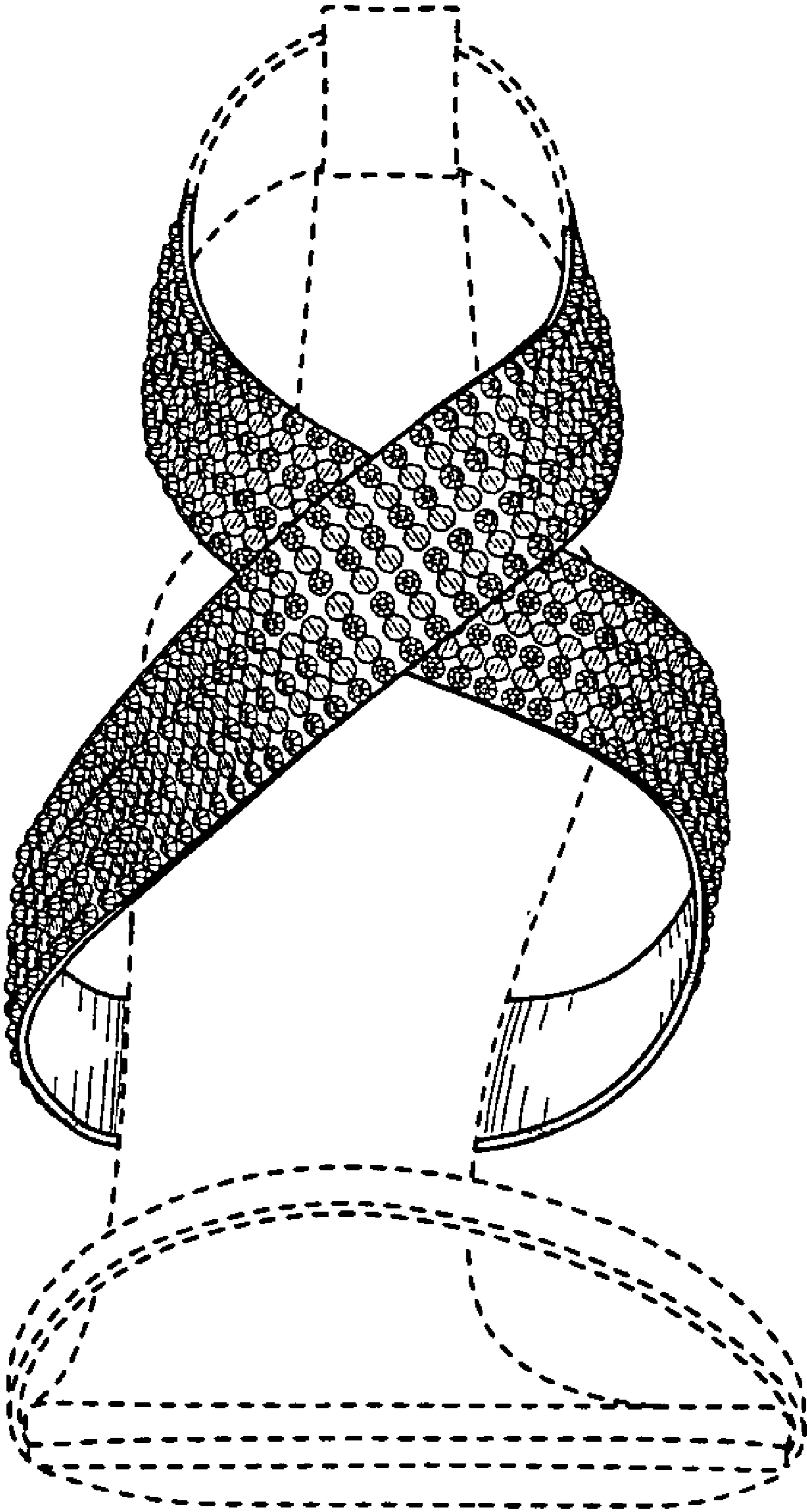
