The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

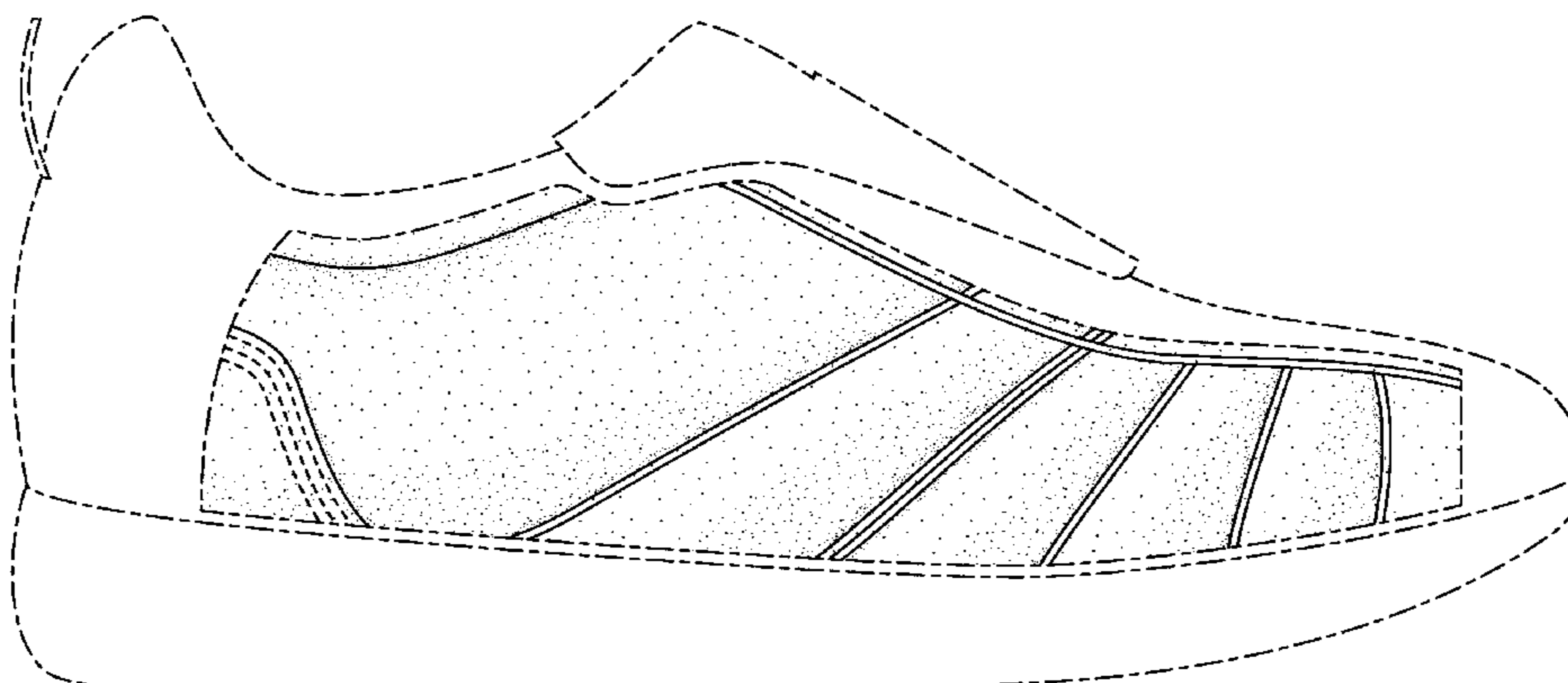
FIG. 1 is a front perspective view of a portion of a shoe upper showing my new design;

FIG. 2 is a rear perspective view thereof; and,

FIG. 3 is a side elevational view thereof.

The uneven broken line immediately adjacent to the shaded area represents an unclaimed boundary of the design. The even broken line showings within the shaded area represent stitching. The uneven broken line showings of the remainder of the shoe are for illustrative purposes only and they form no part of the claimed design.

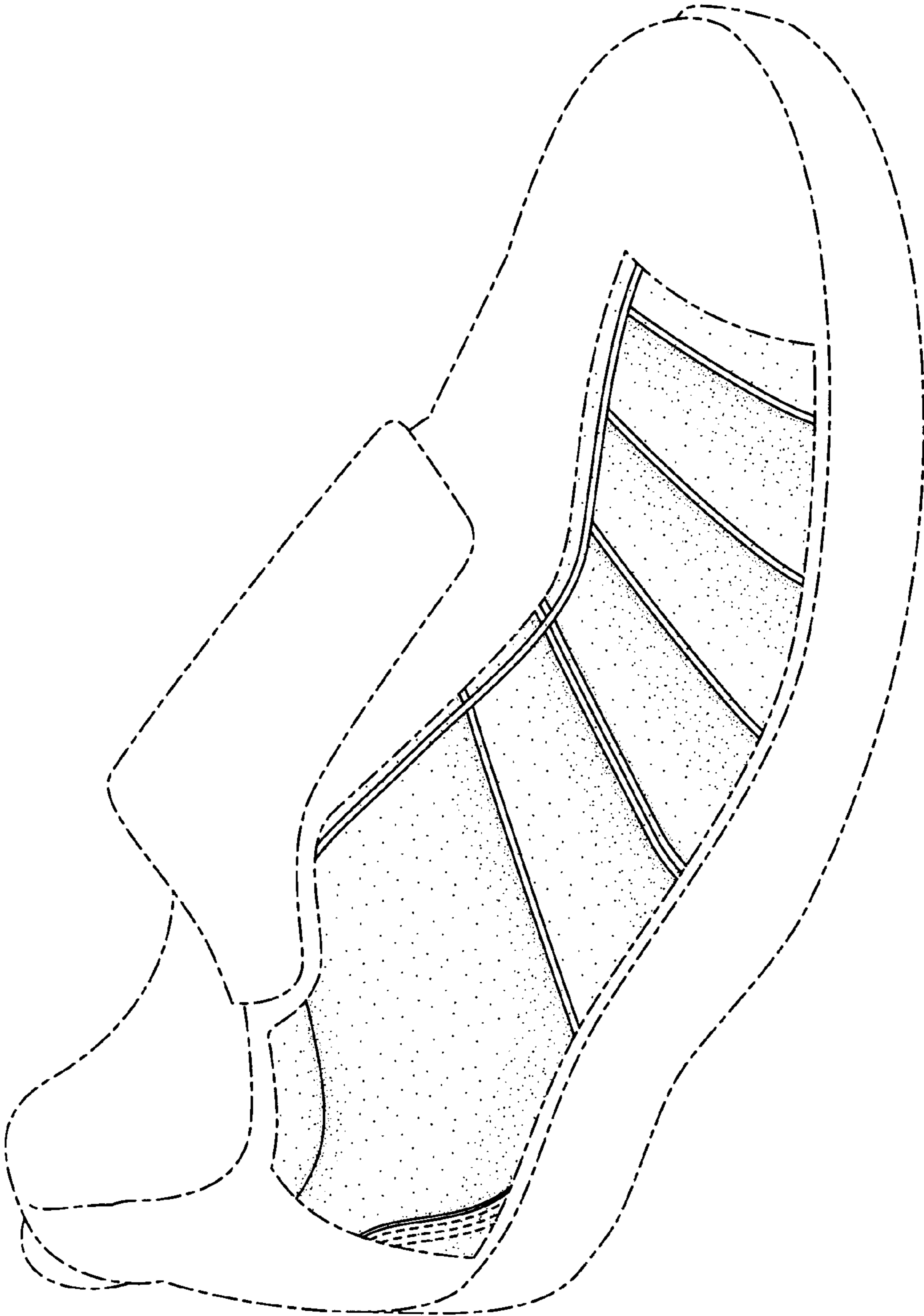

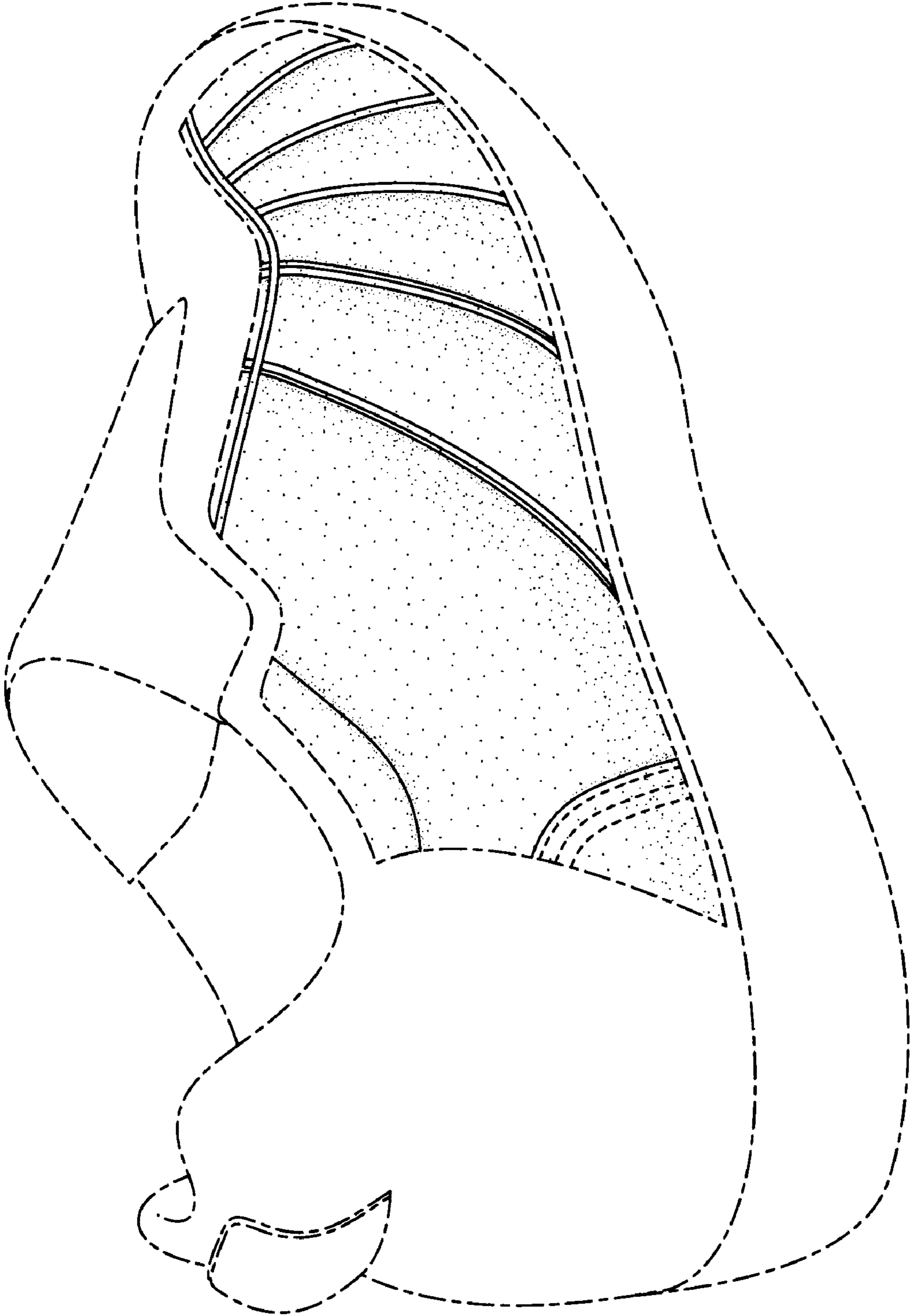

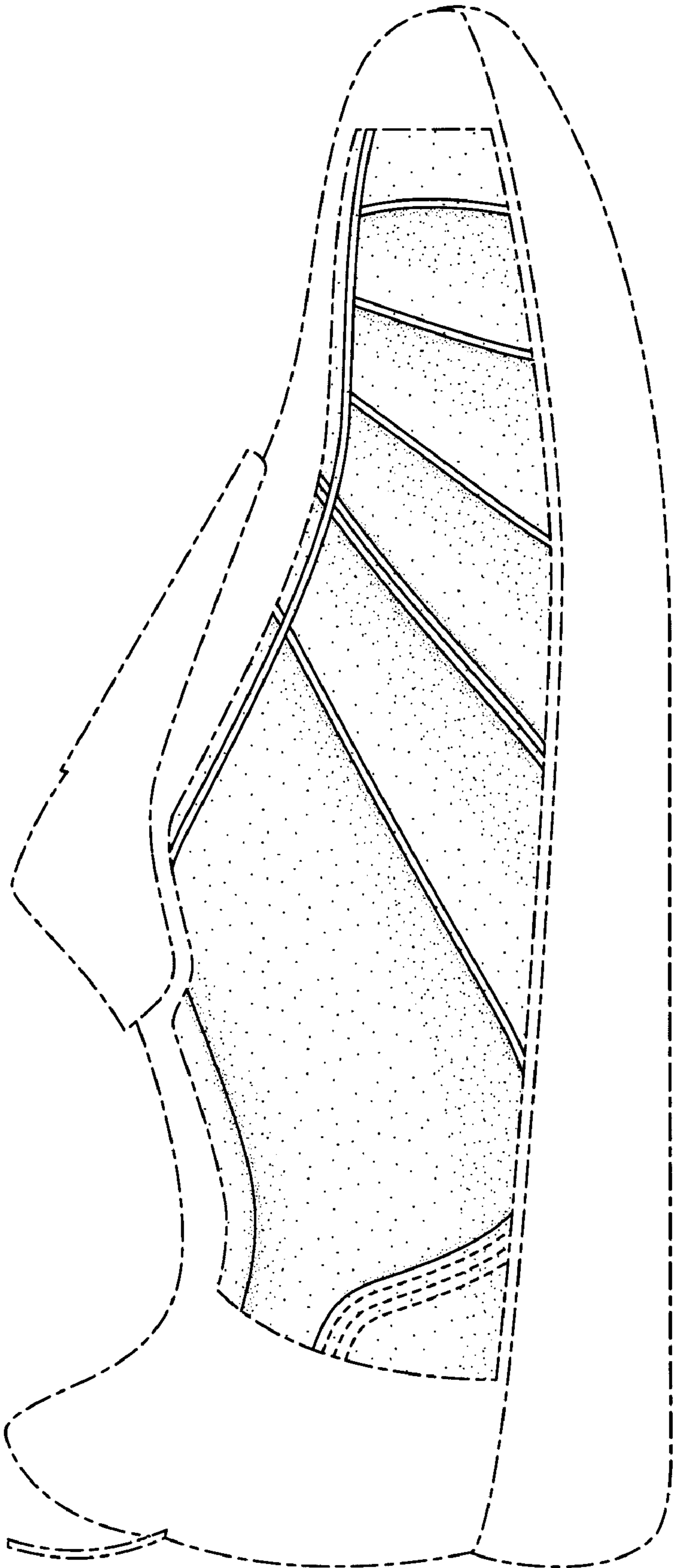
