DESCRIPTION

FIG. 1 is a perspective view of the container of the invention.

FIG. 2 is a front elevation of the container shown in FIG. 1.

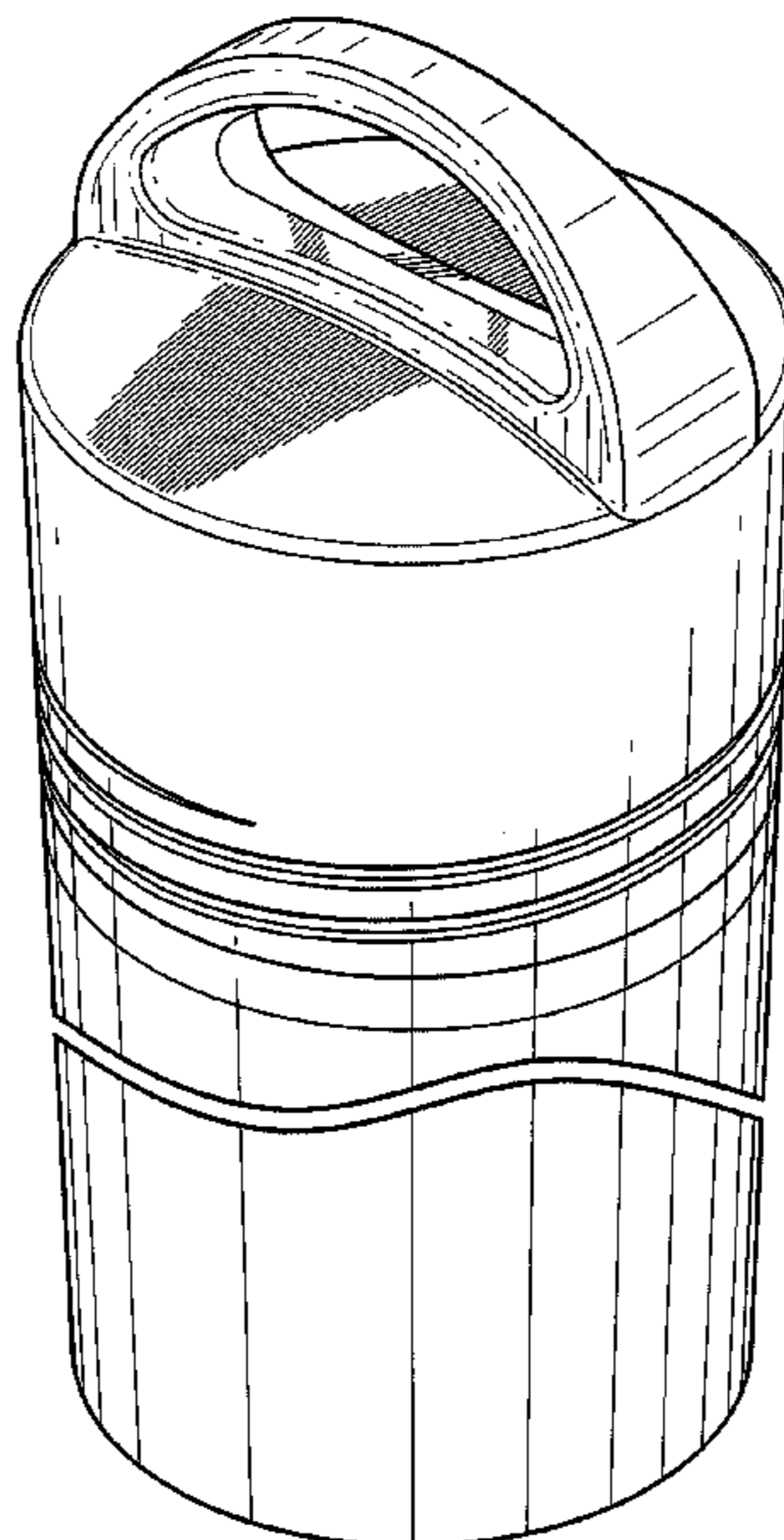
FIG. 3 is a side elevation of the container shown in FIG. 1.

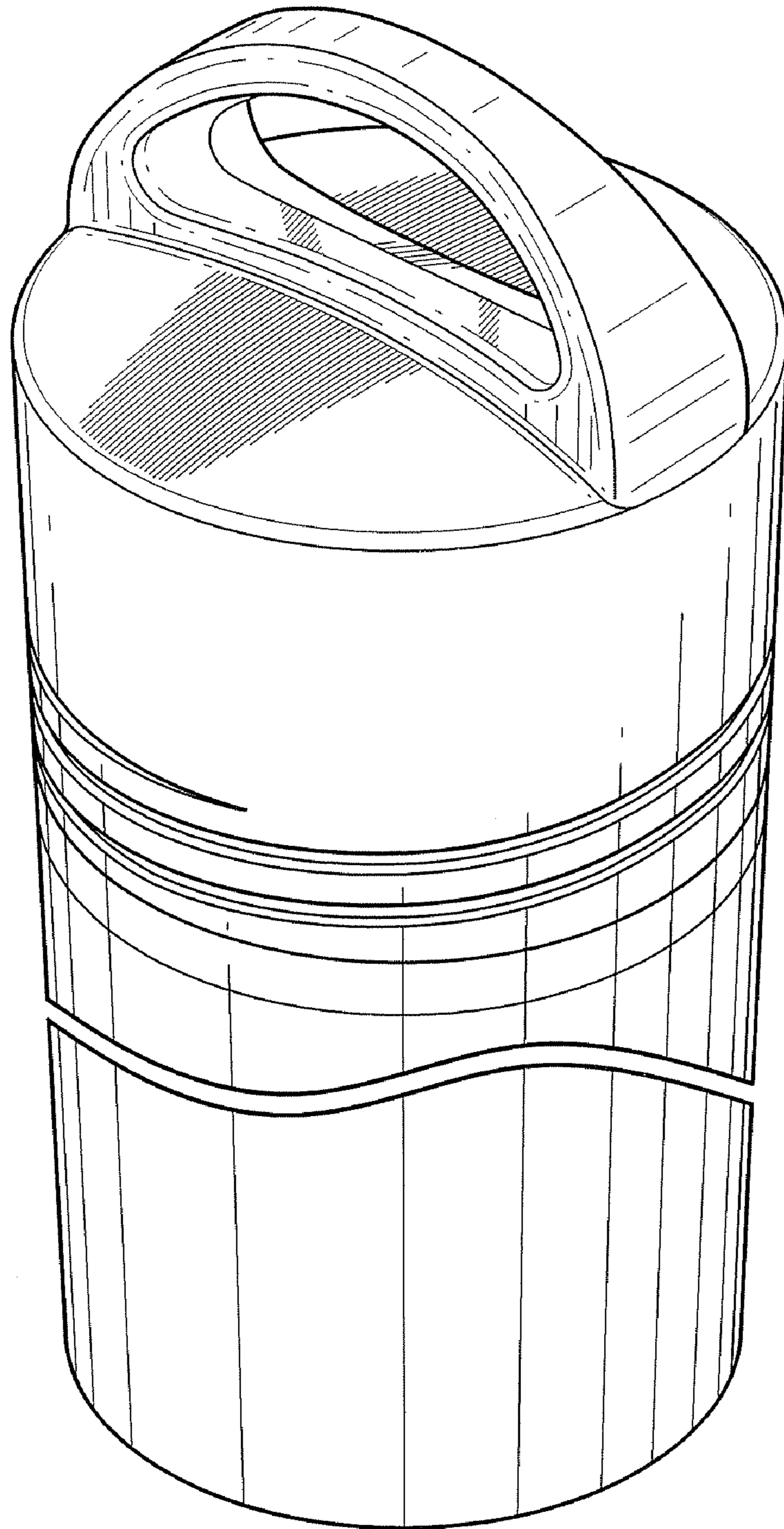

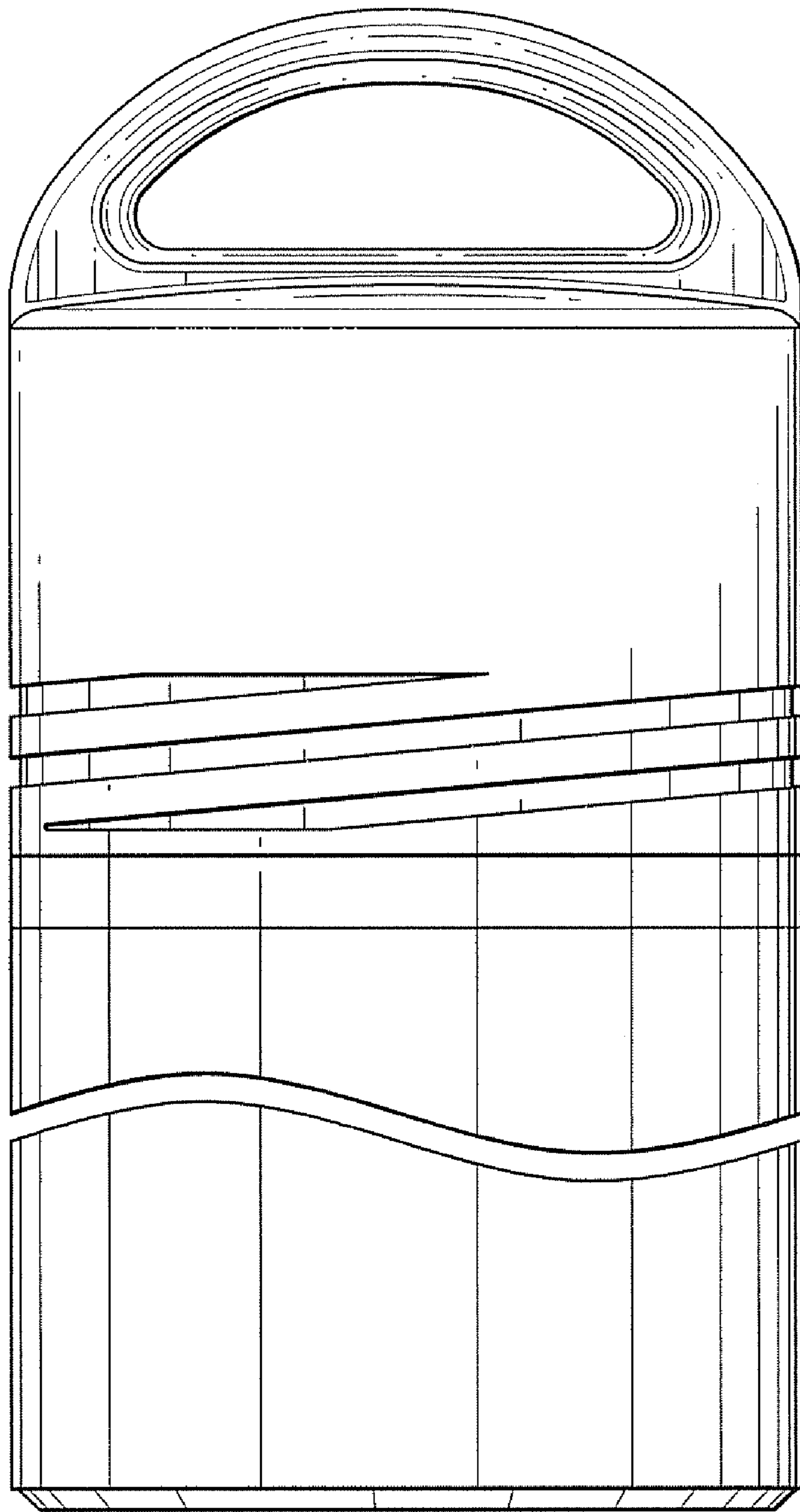

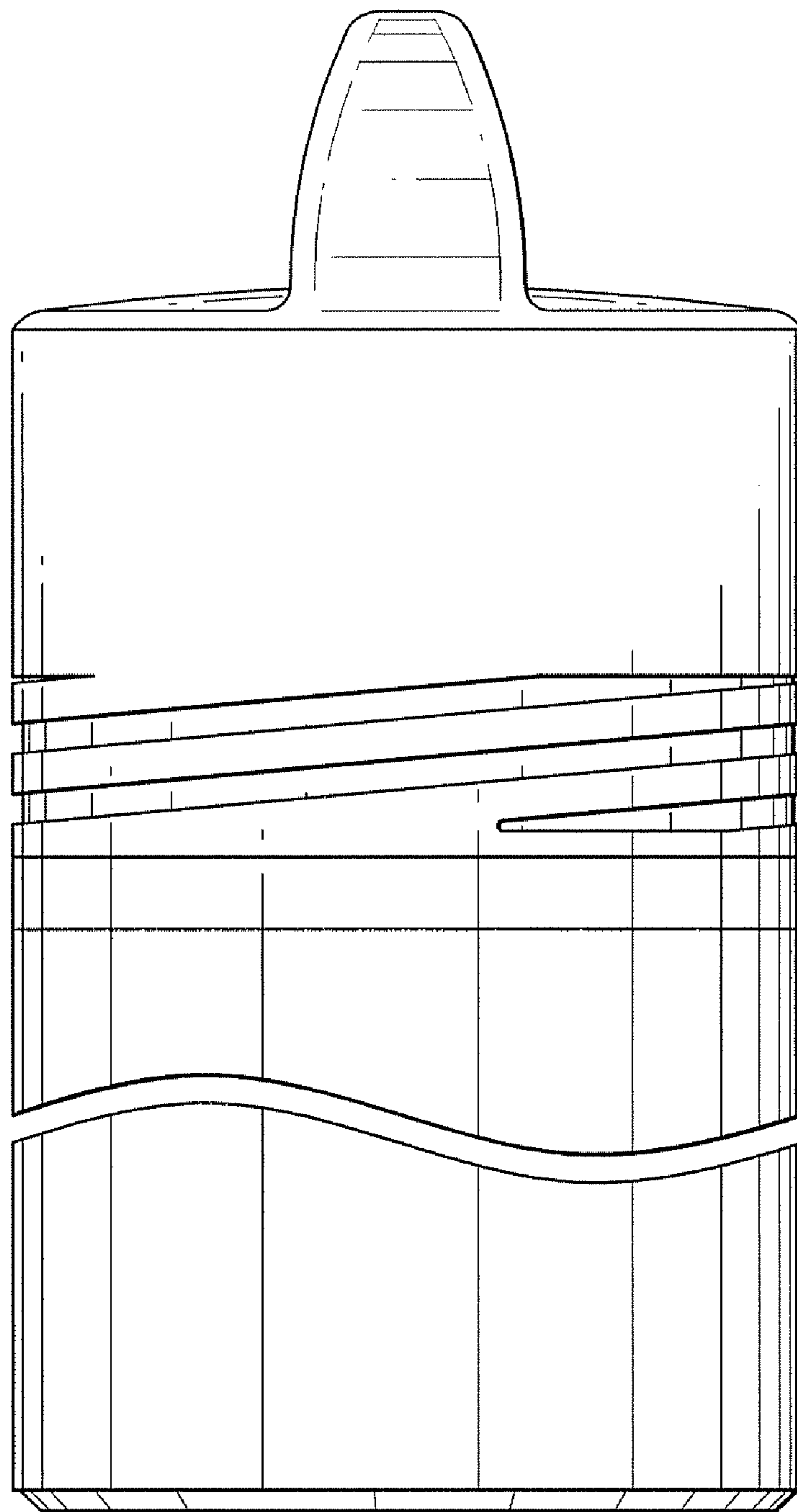

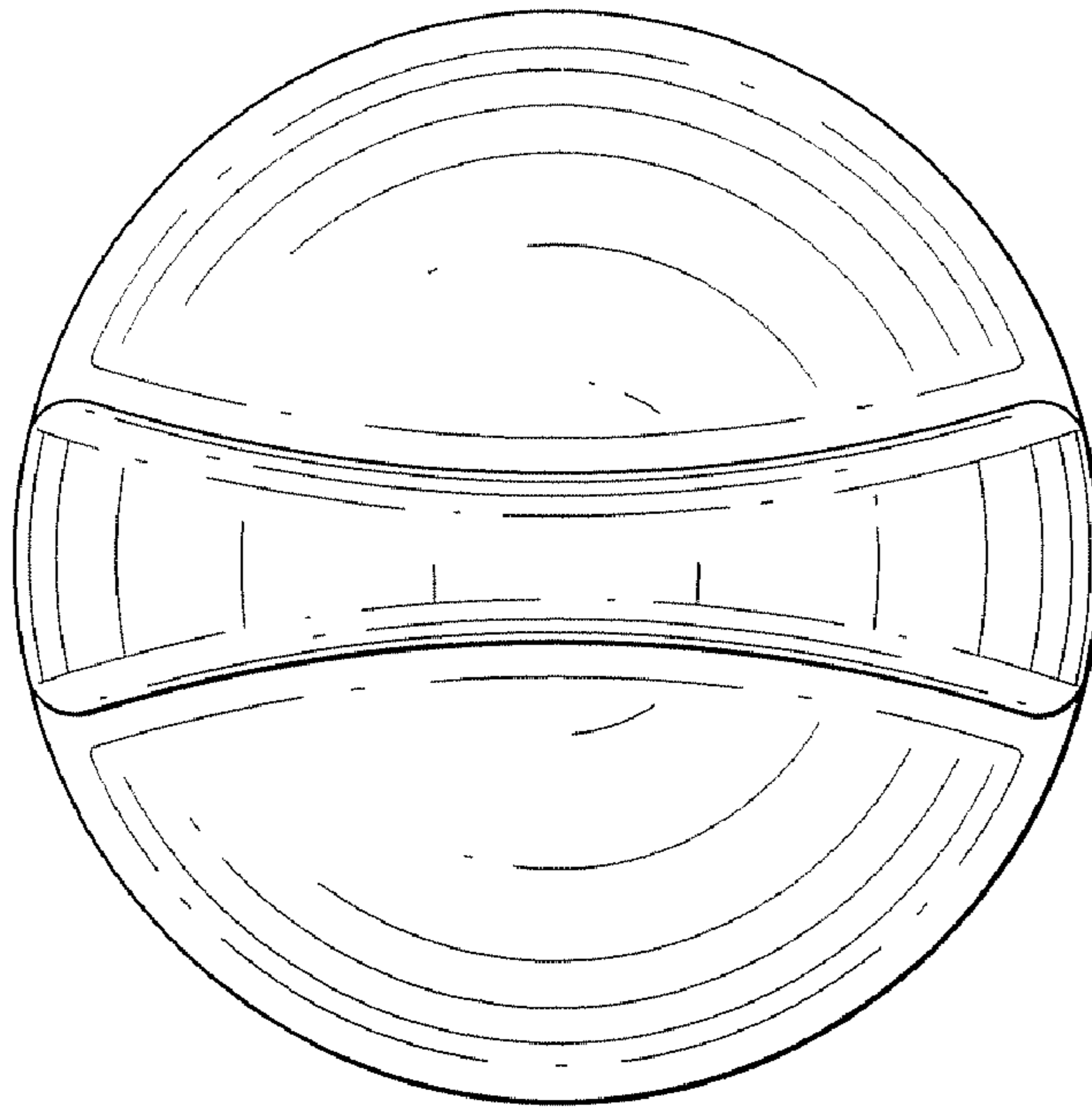

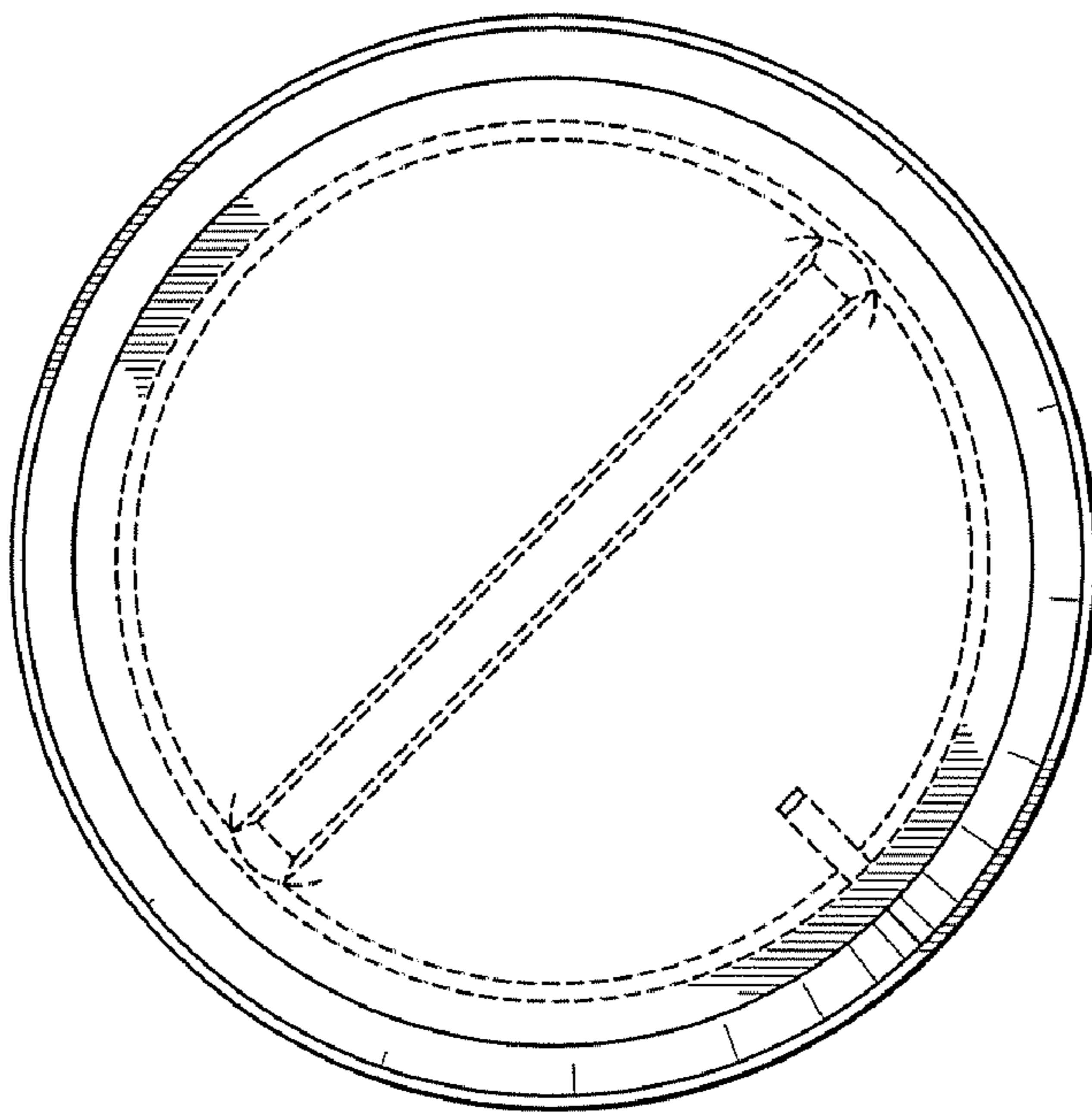
