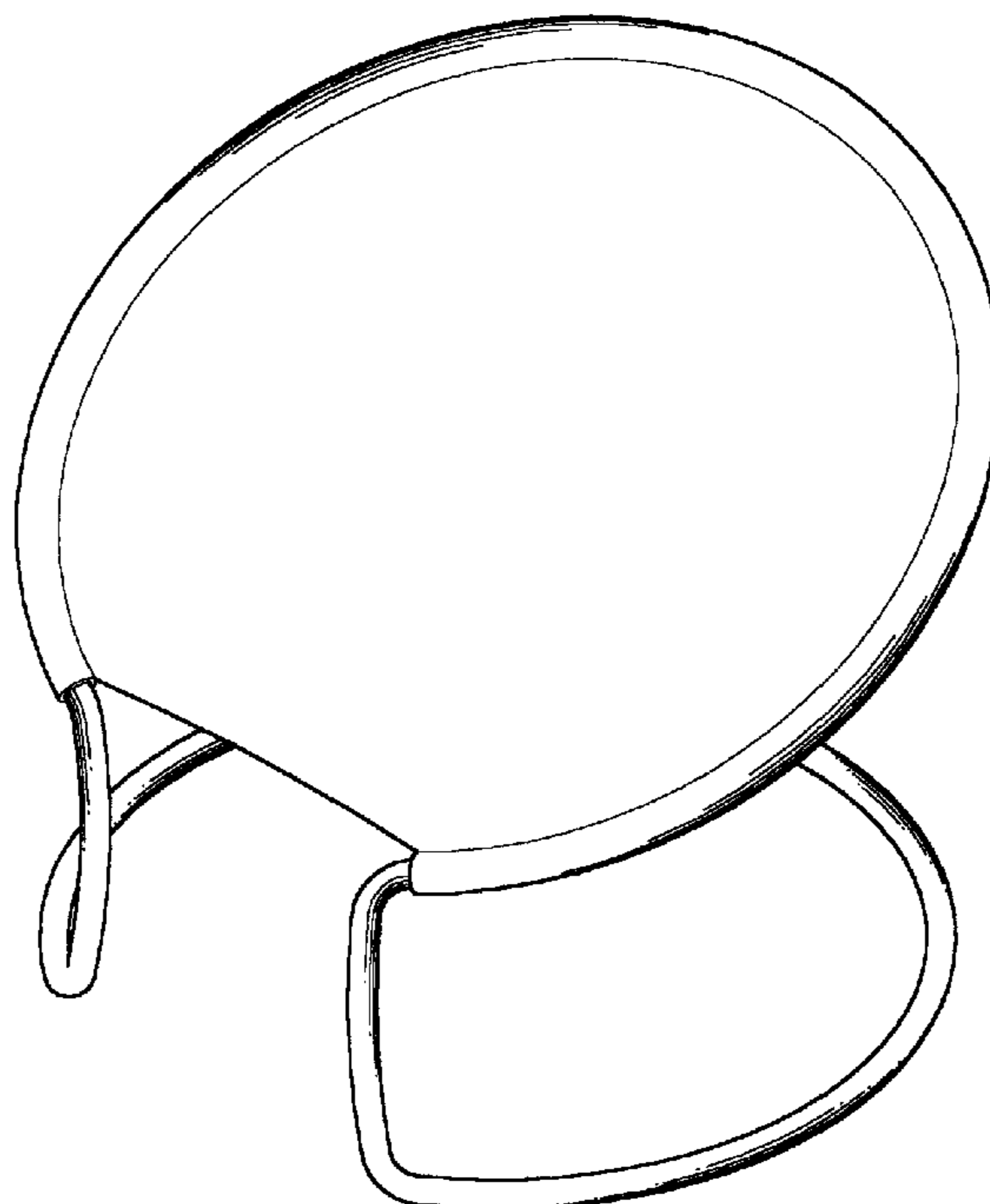
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a quiche chair showing the new design;

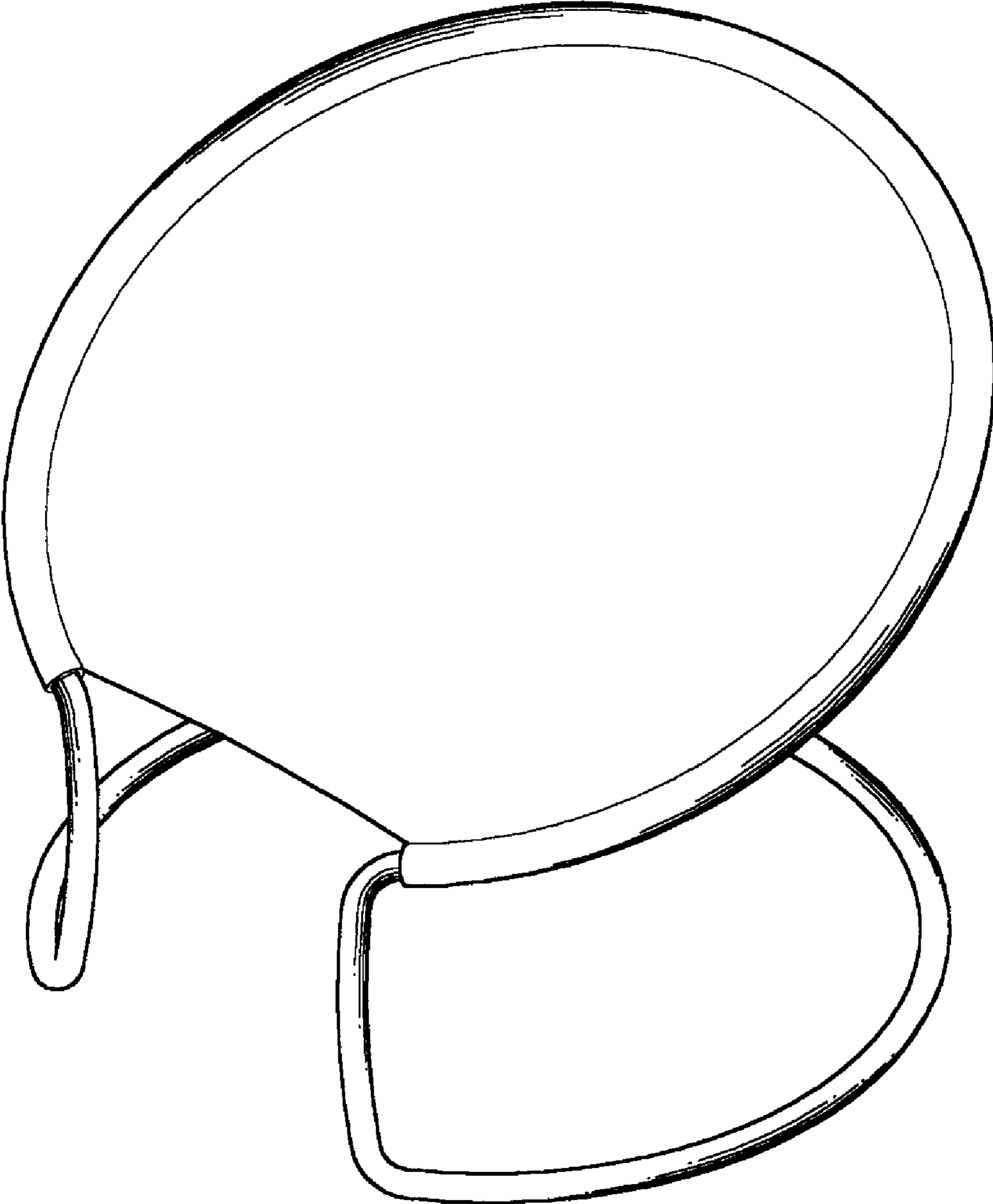

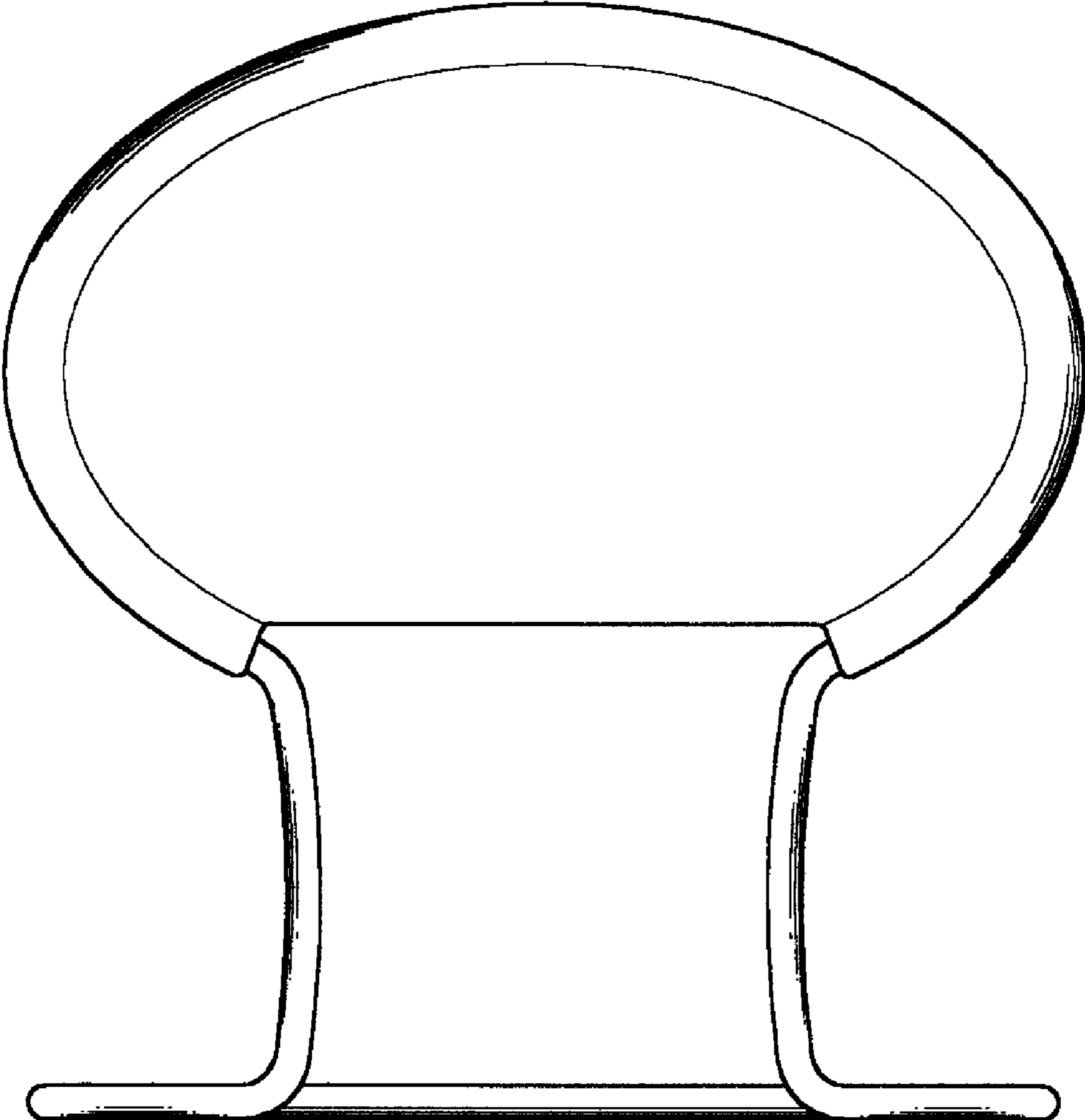

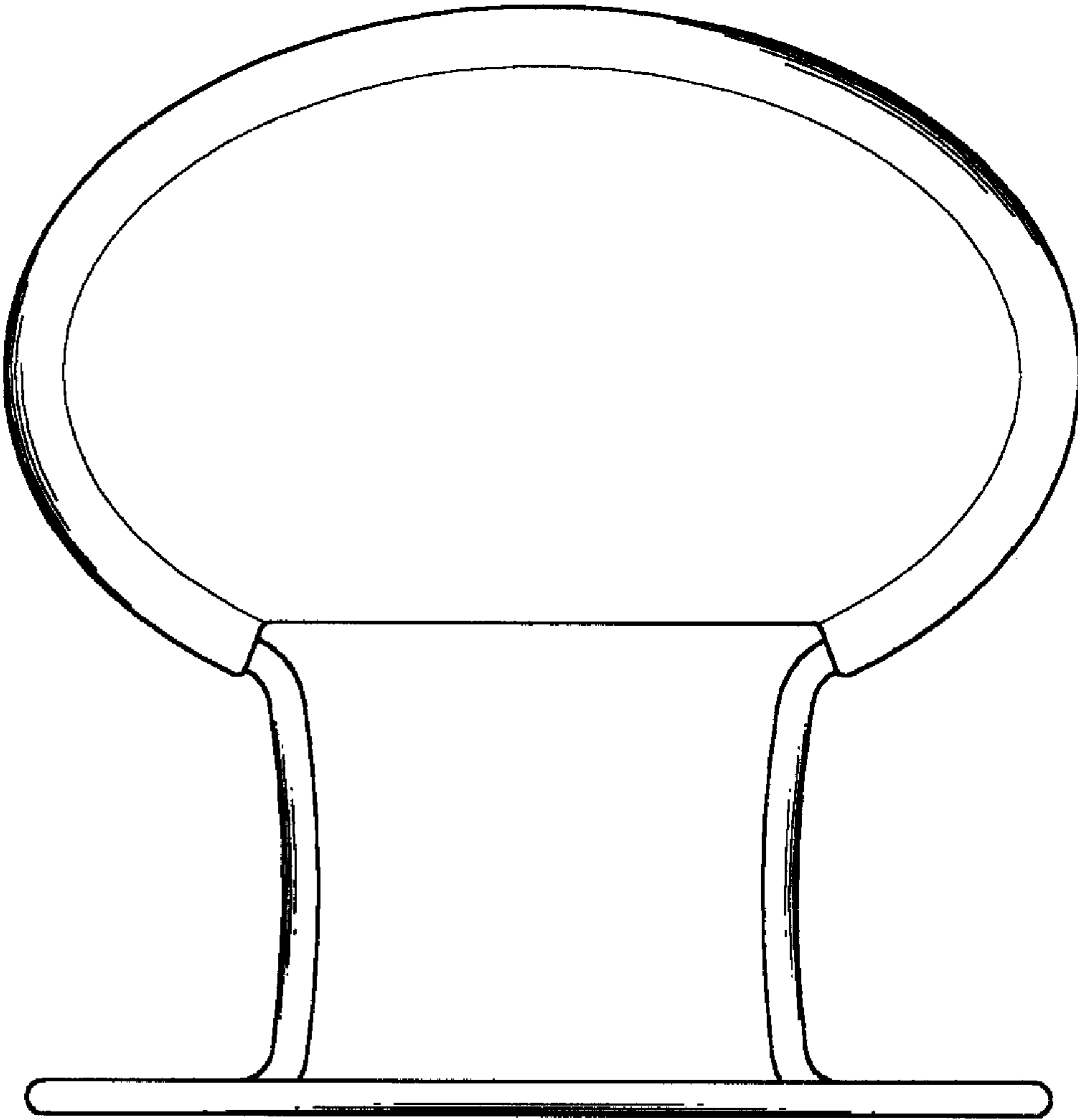

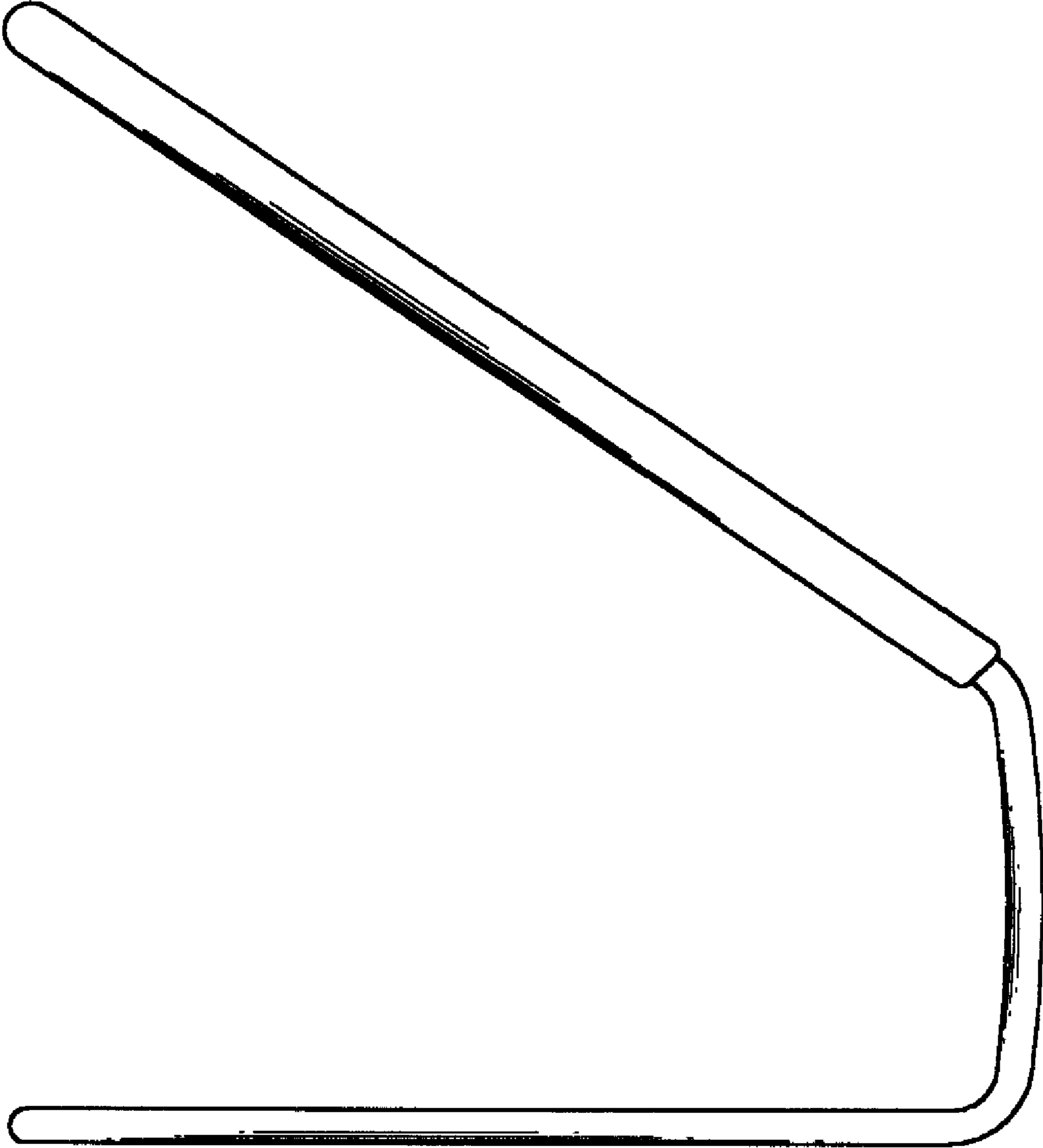

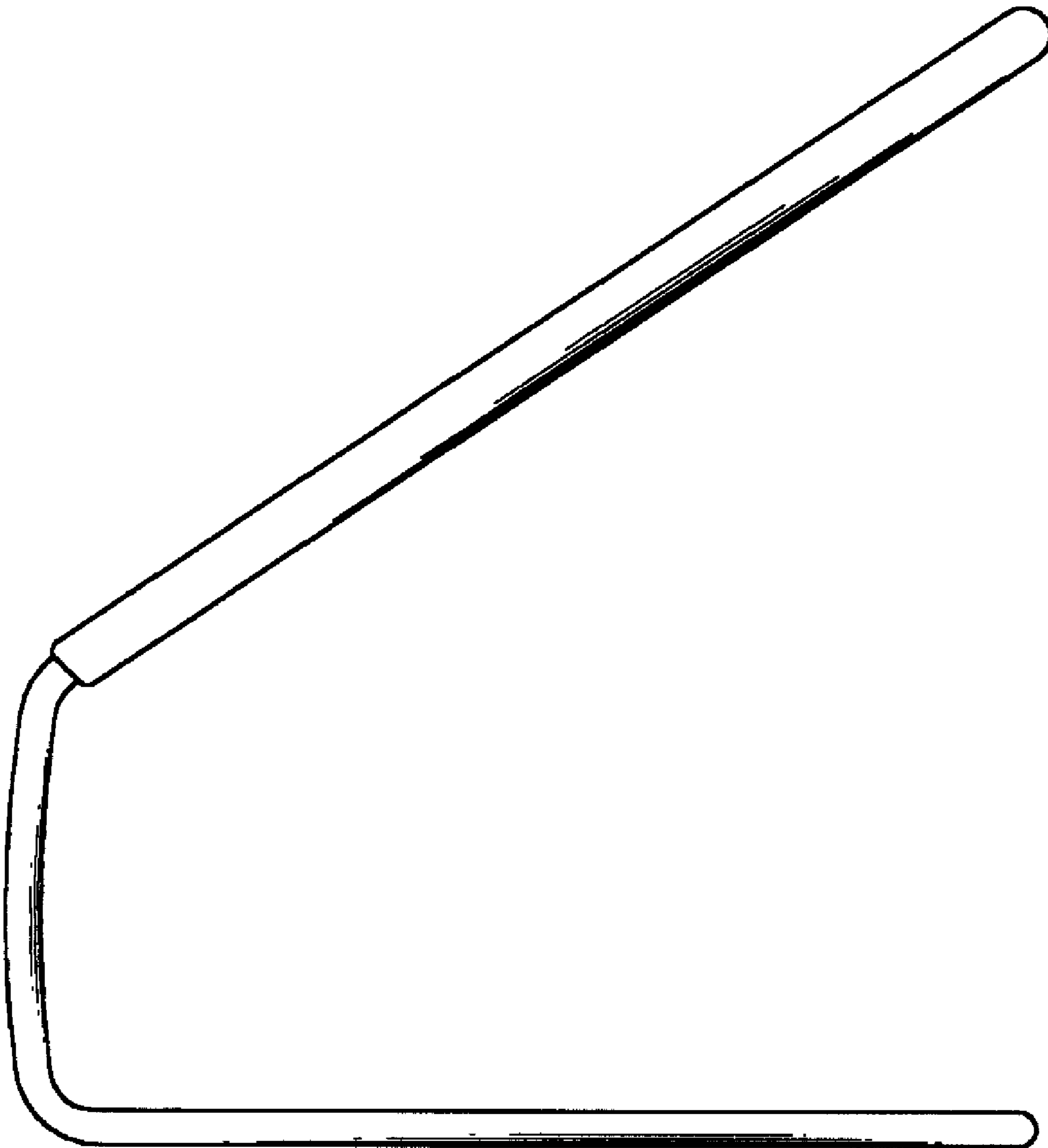

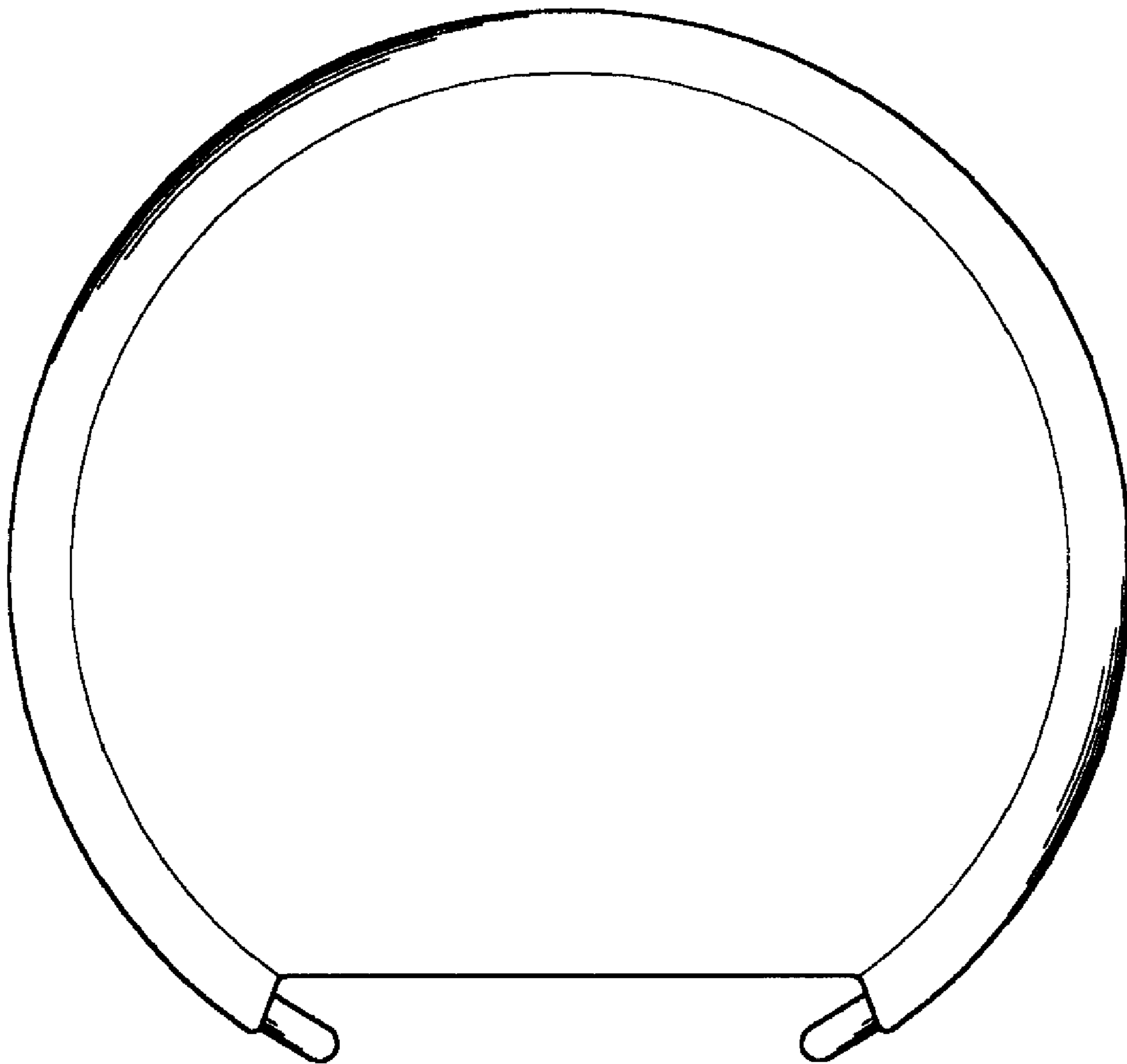

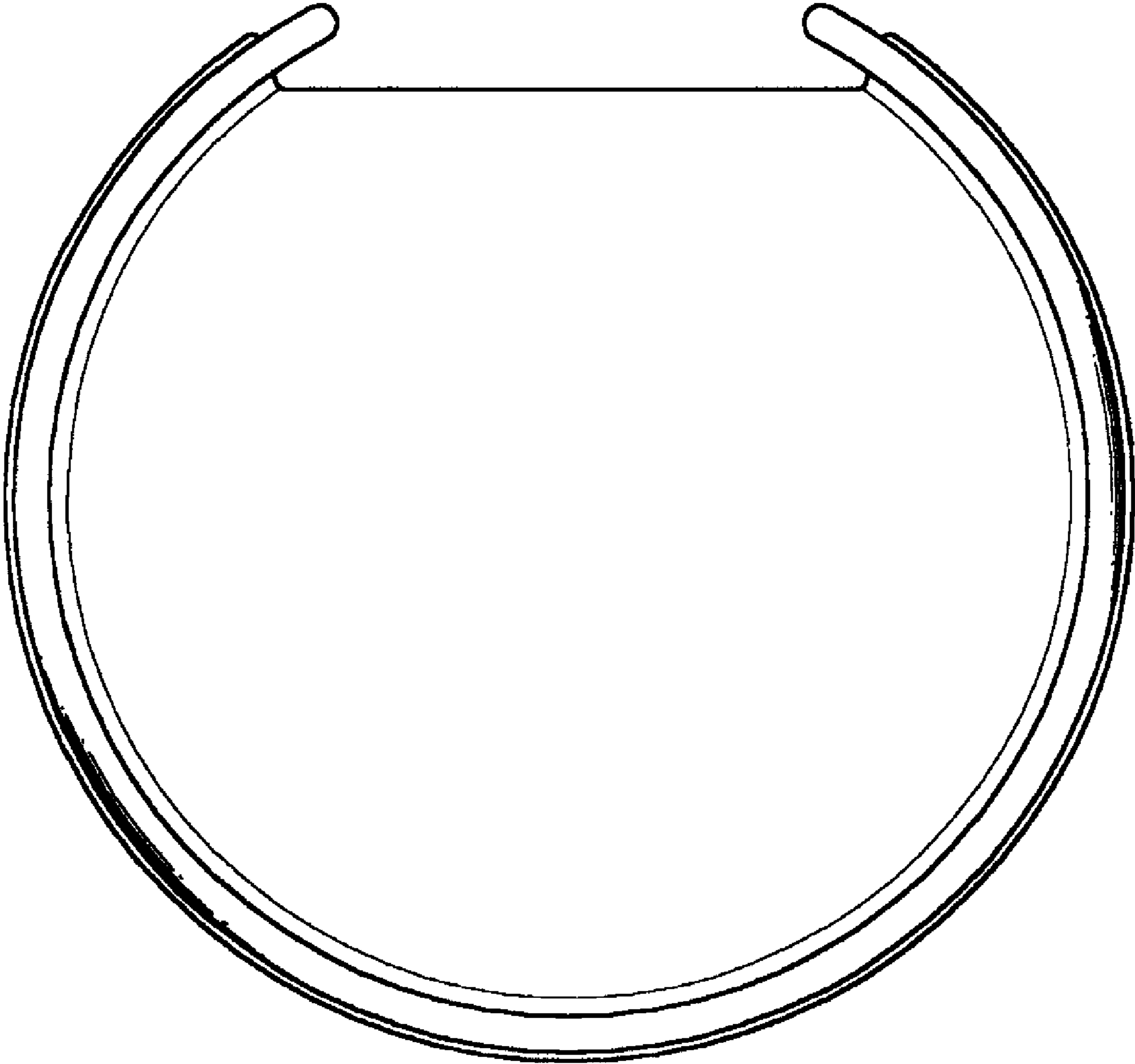
