(57) **CLAIM**

I claim the ornamental design for an ottoman, as shown and described.

DESCRIPTION

FIG. 1 is a first front perspective view of an ottoman, showing my new design;

FIG. 2 is a second front perspective view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a side elevation view thereof taken from the right of FIG. 4;

FIG. 6 is a side elevation view thereof taken from the left of FIG. 4;

FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

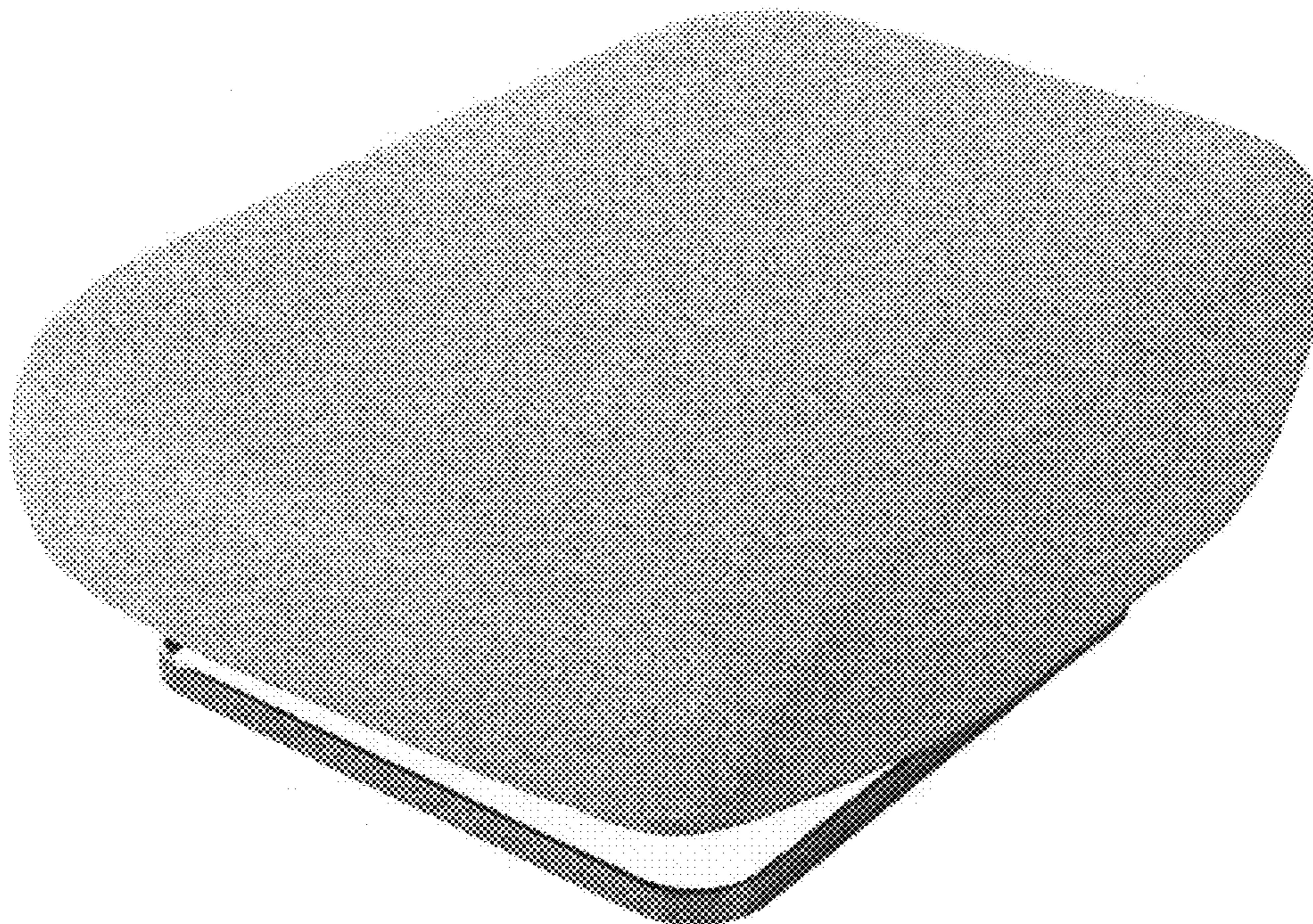

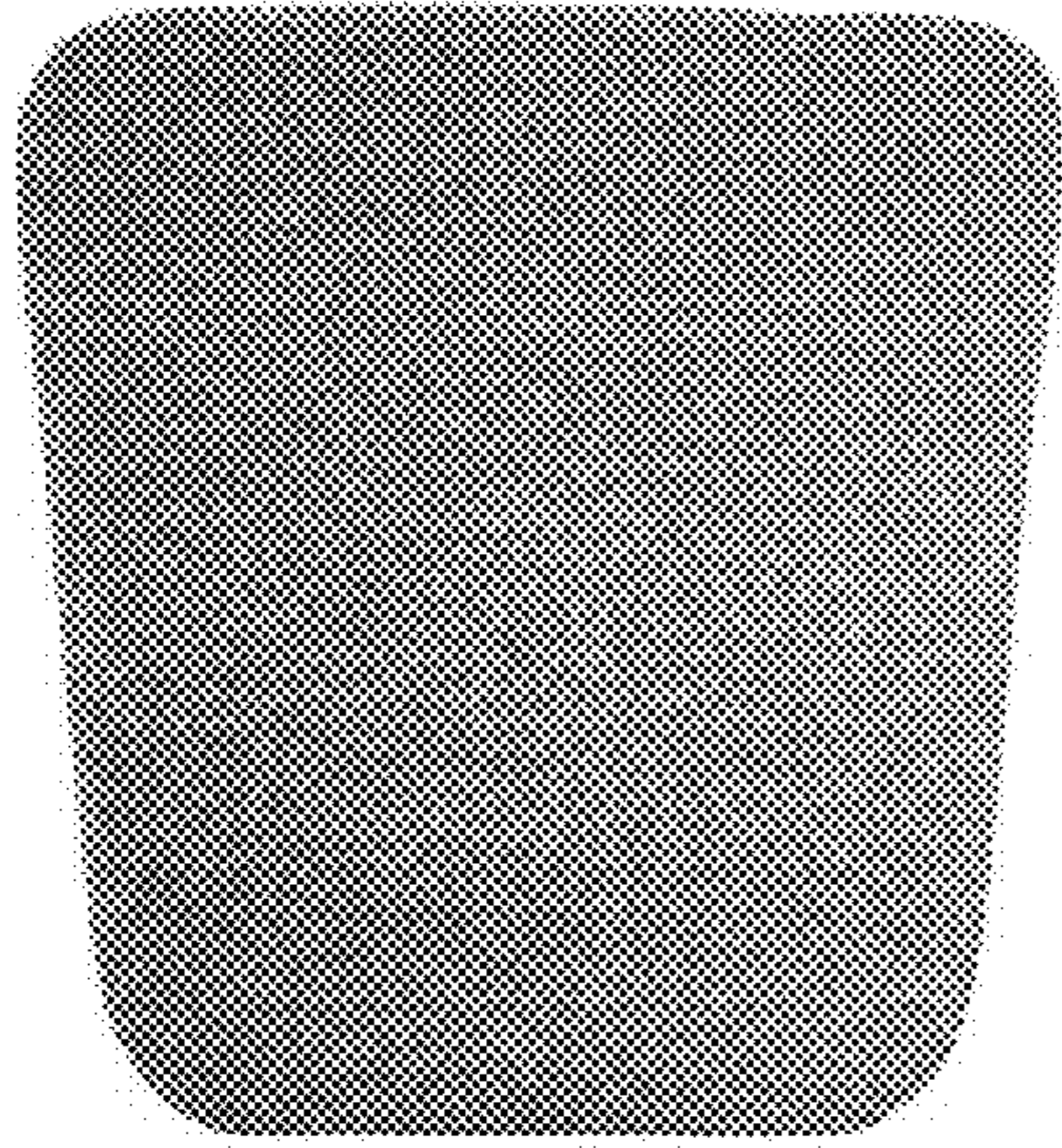

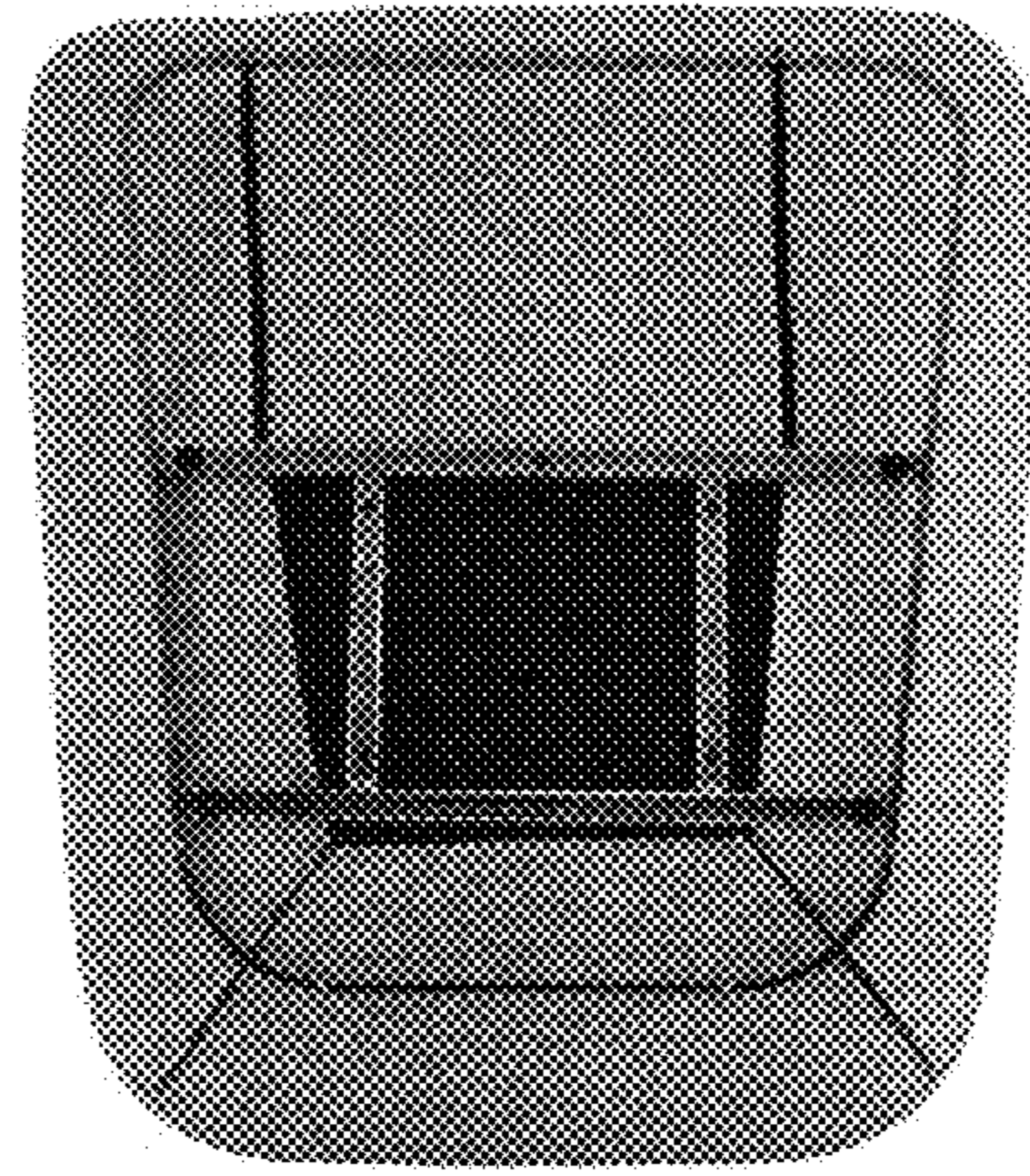

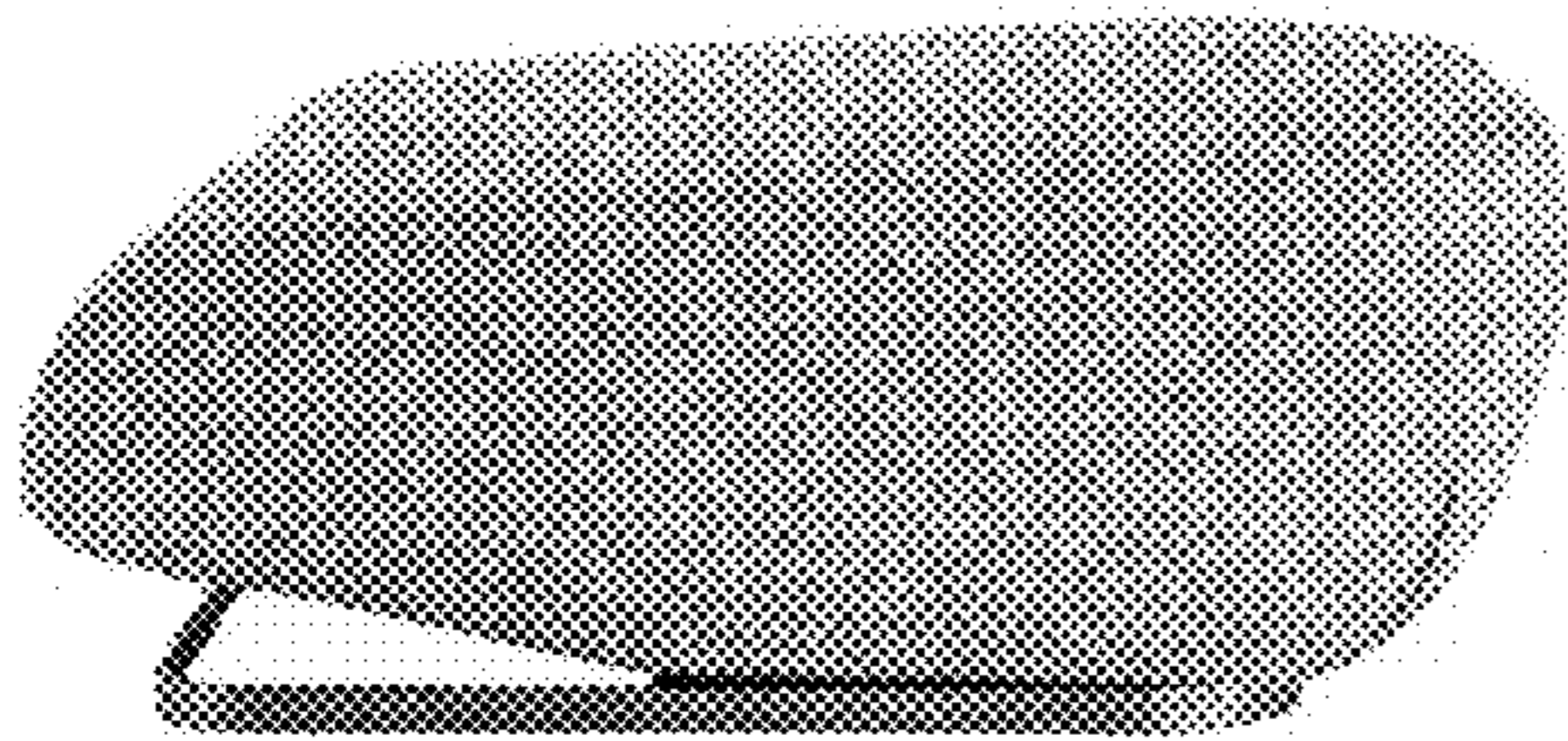

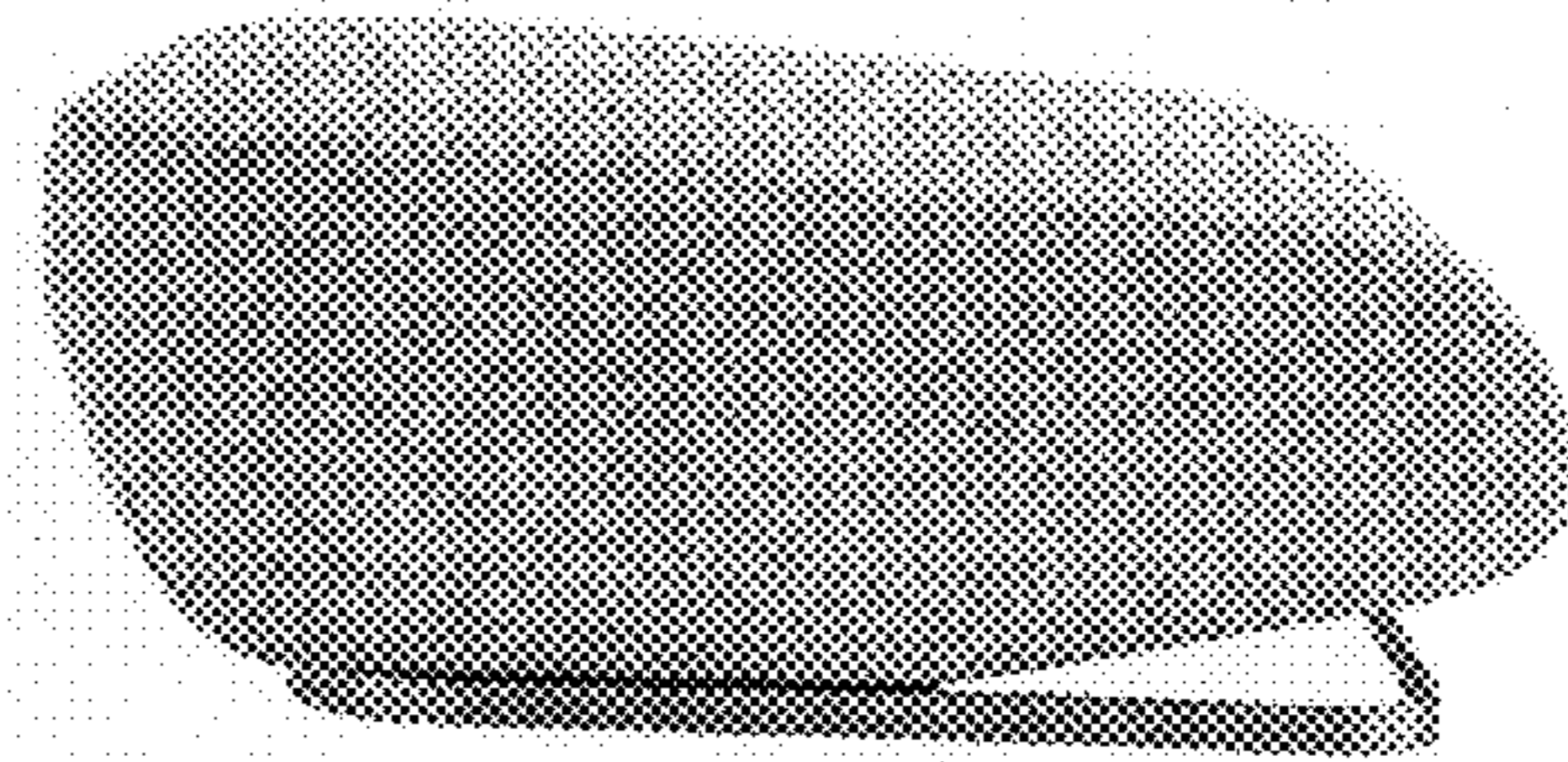

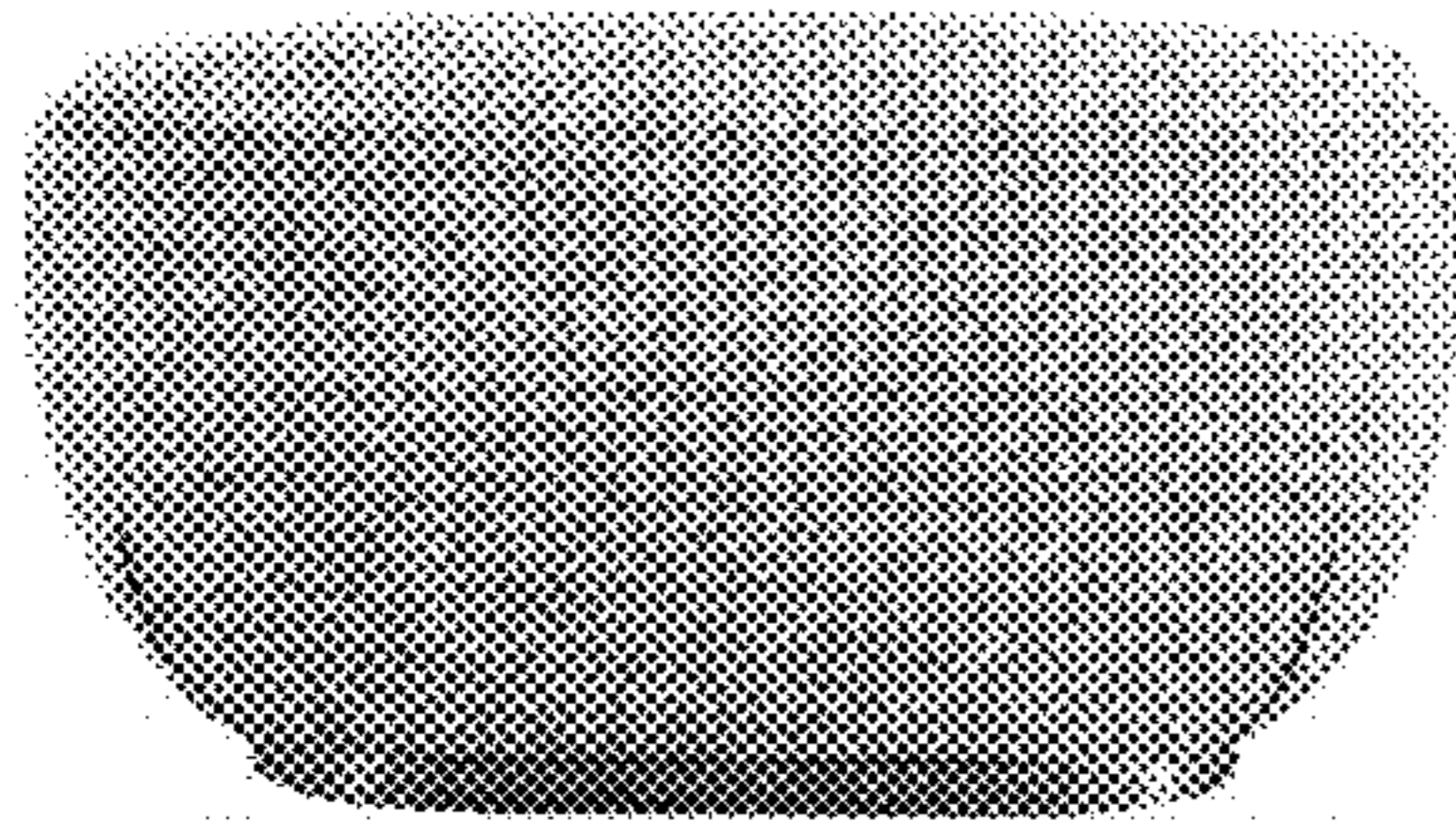

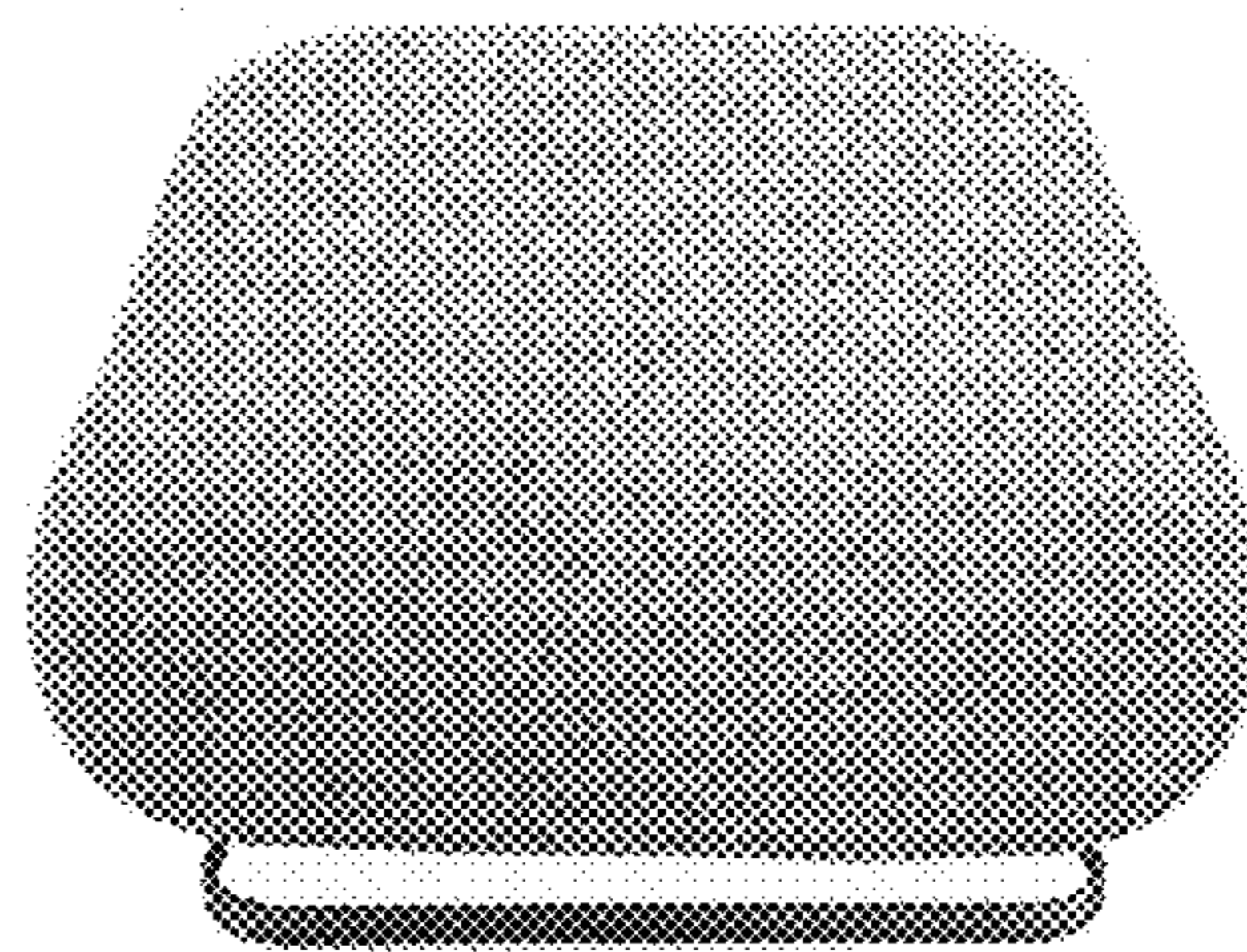

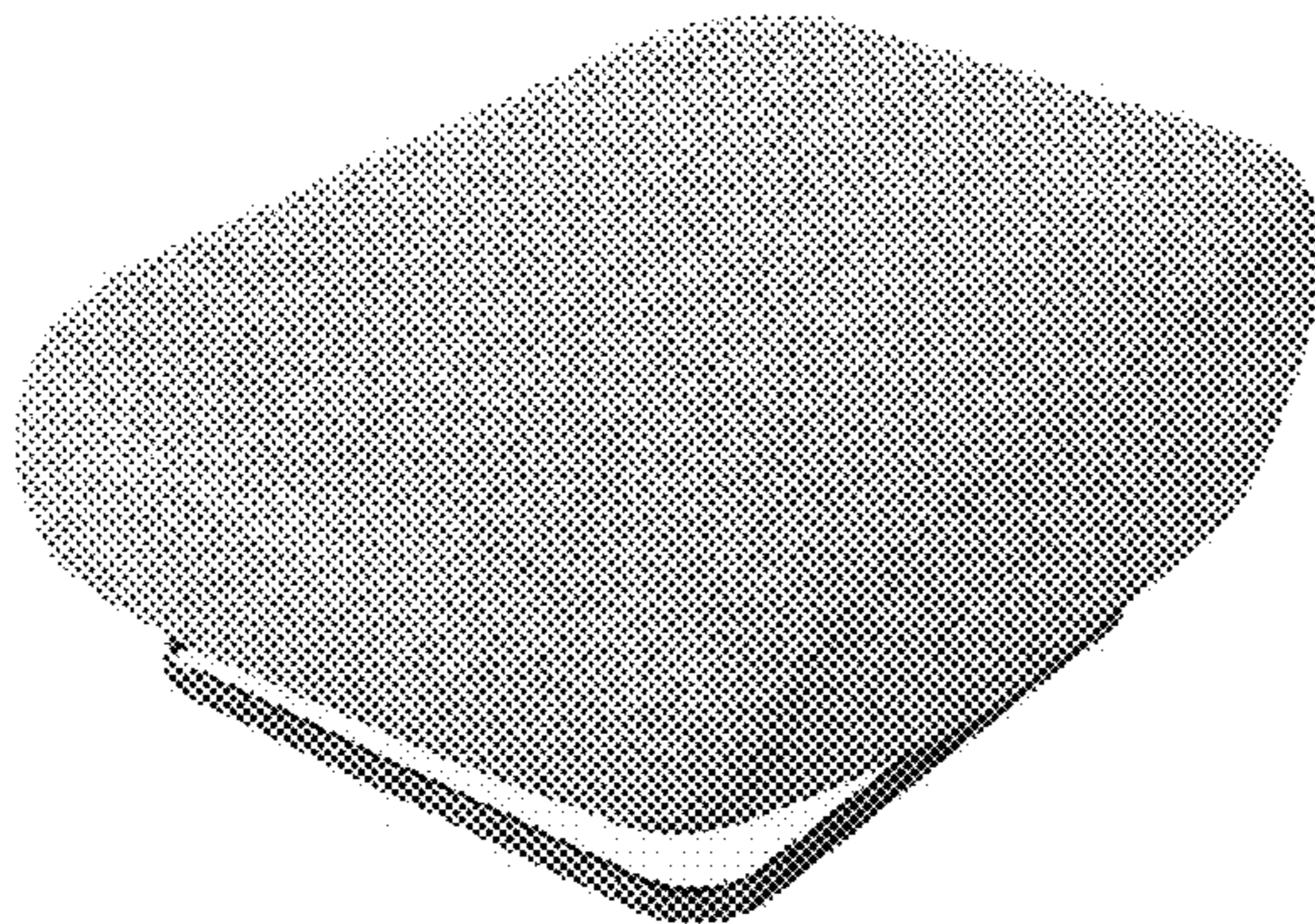
