FIG. 1 is a front perspective view showing my new design;

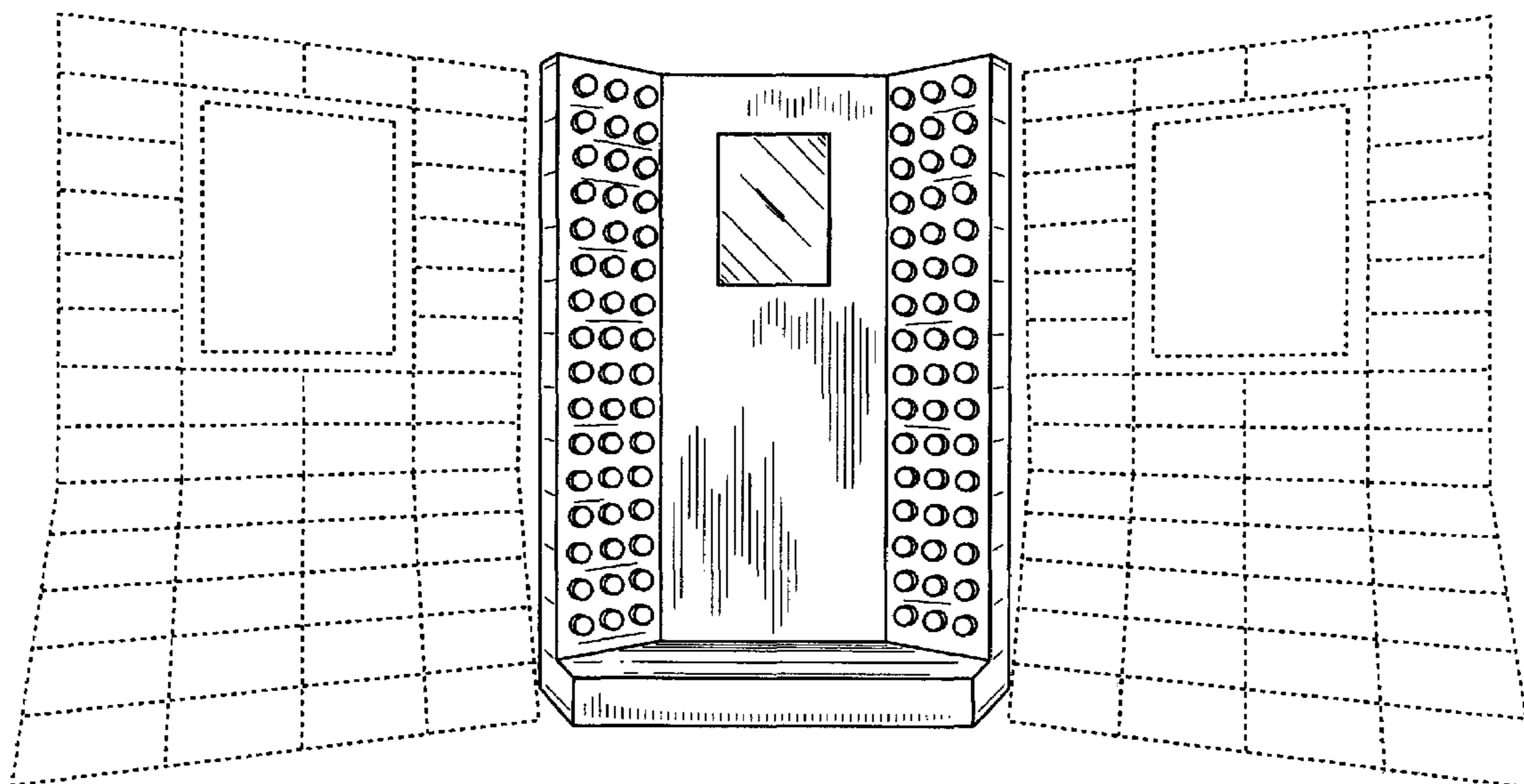
FIG. 2 is a front left side perspective view;

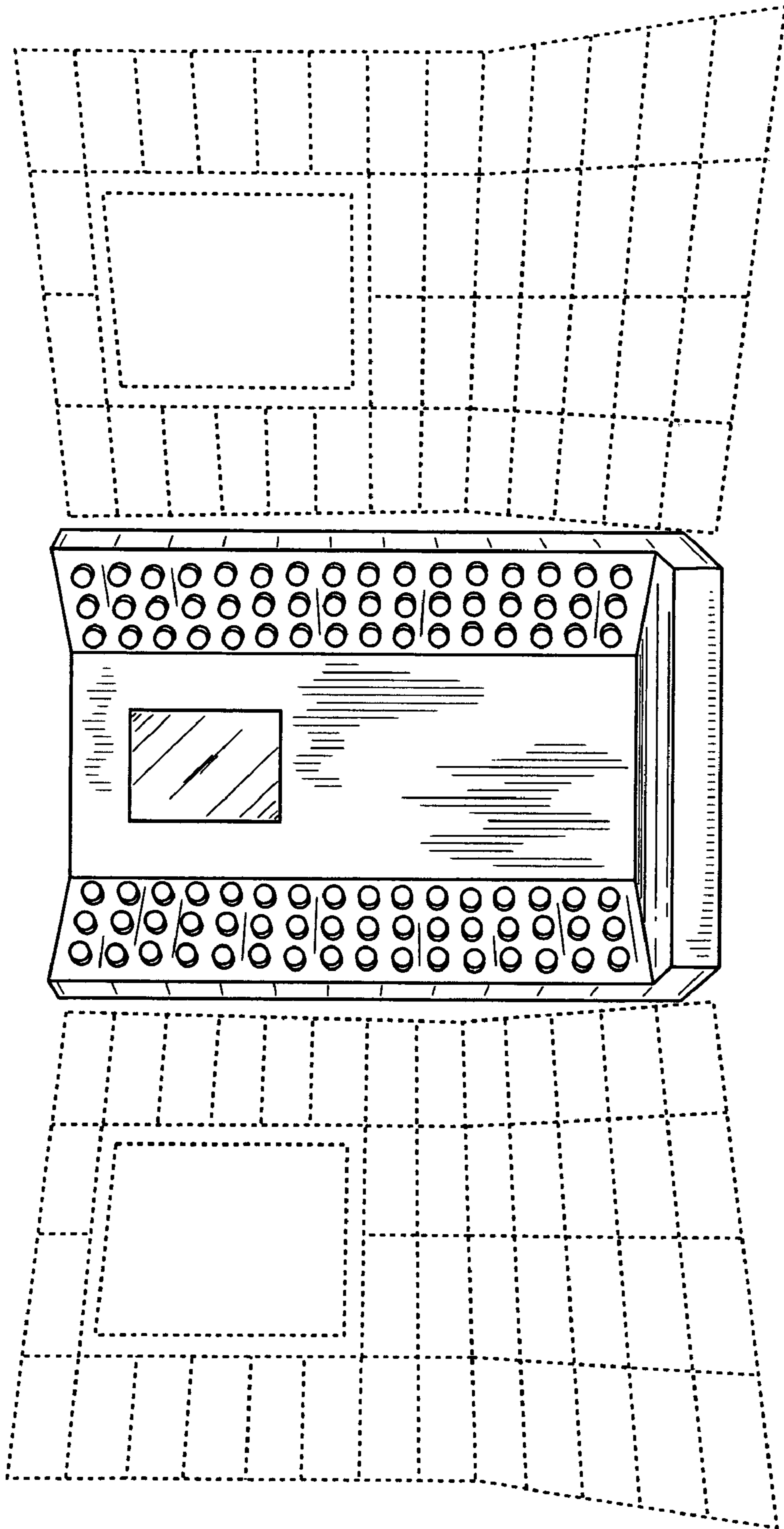
FIG. 3 is a front right side perspective view; and,

FIG. 4 is a top plan view of FIG. 1.

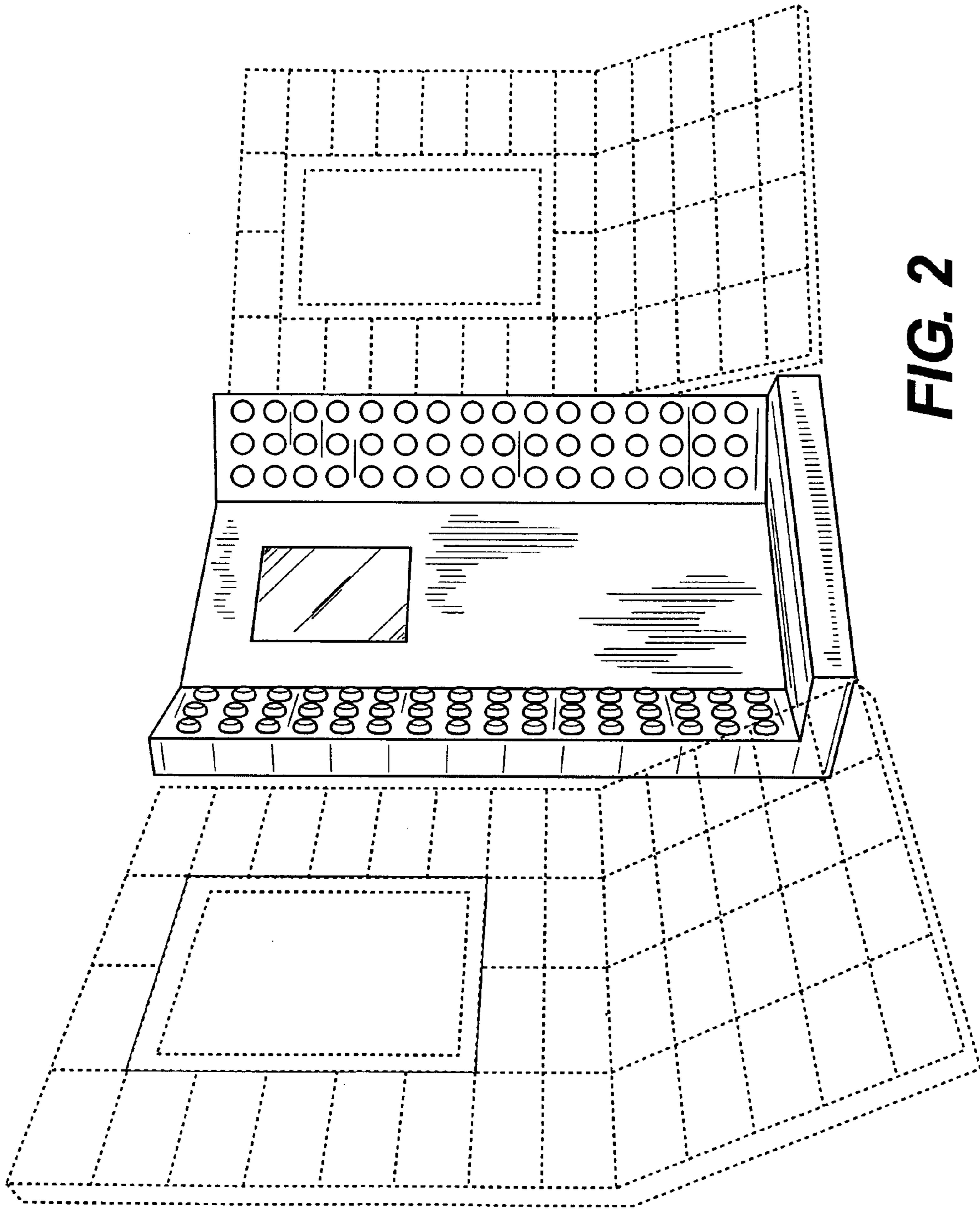

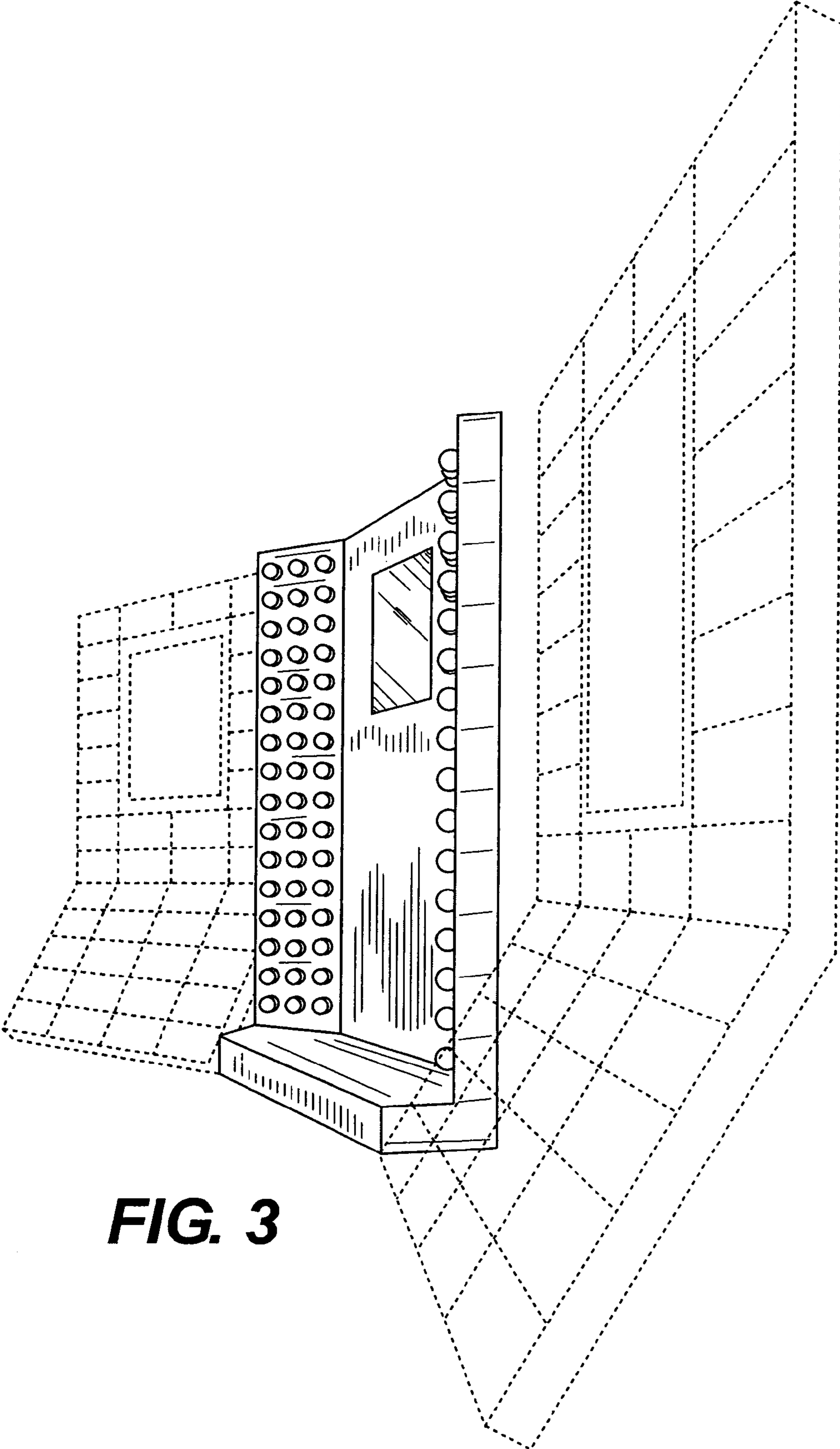




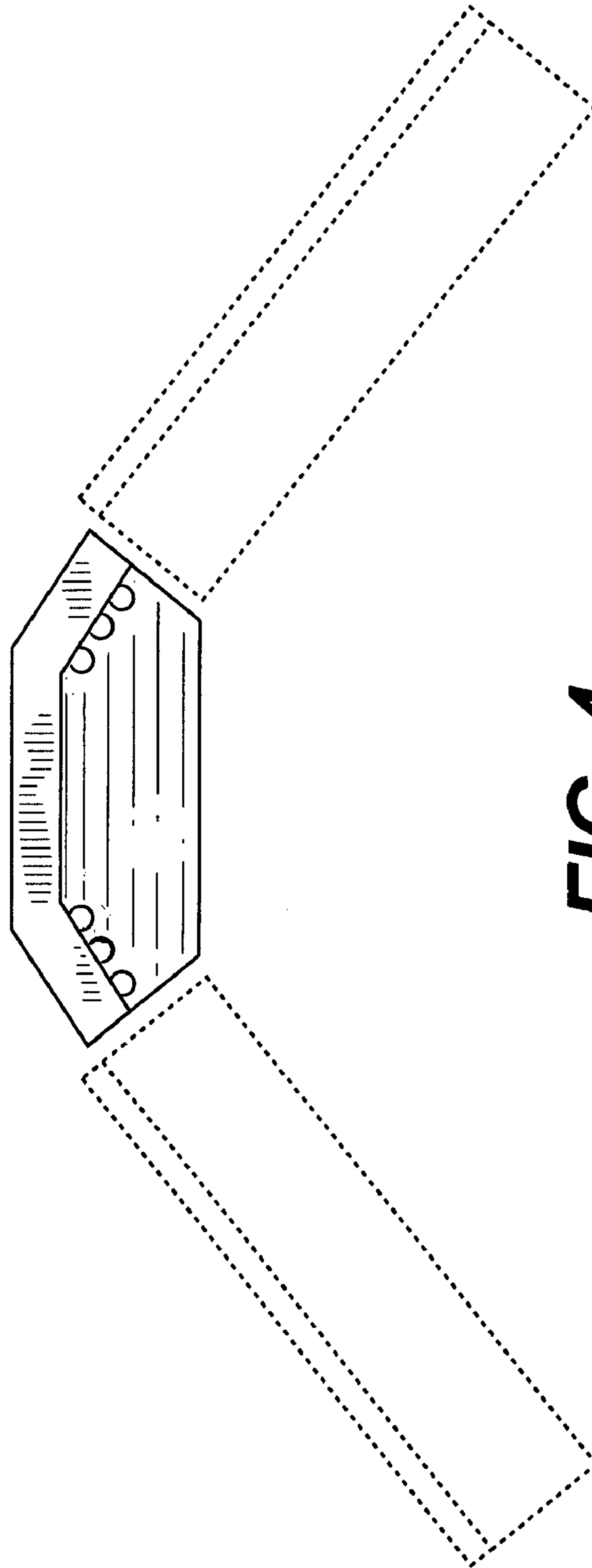
