FIG. 3 is a back view of a product display, according to an embodiment of the invention.

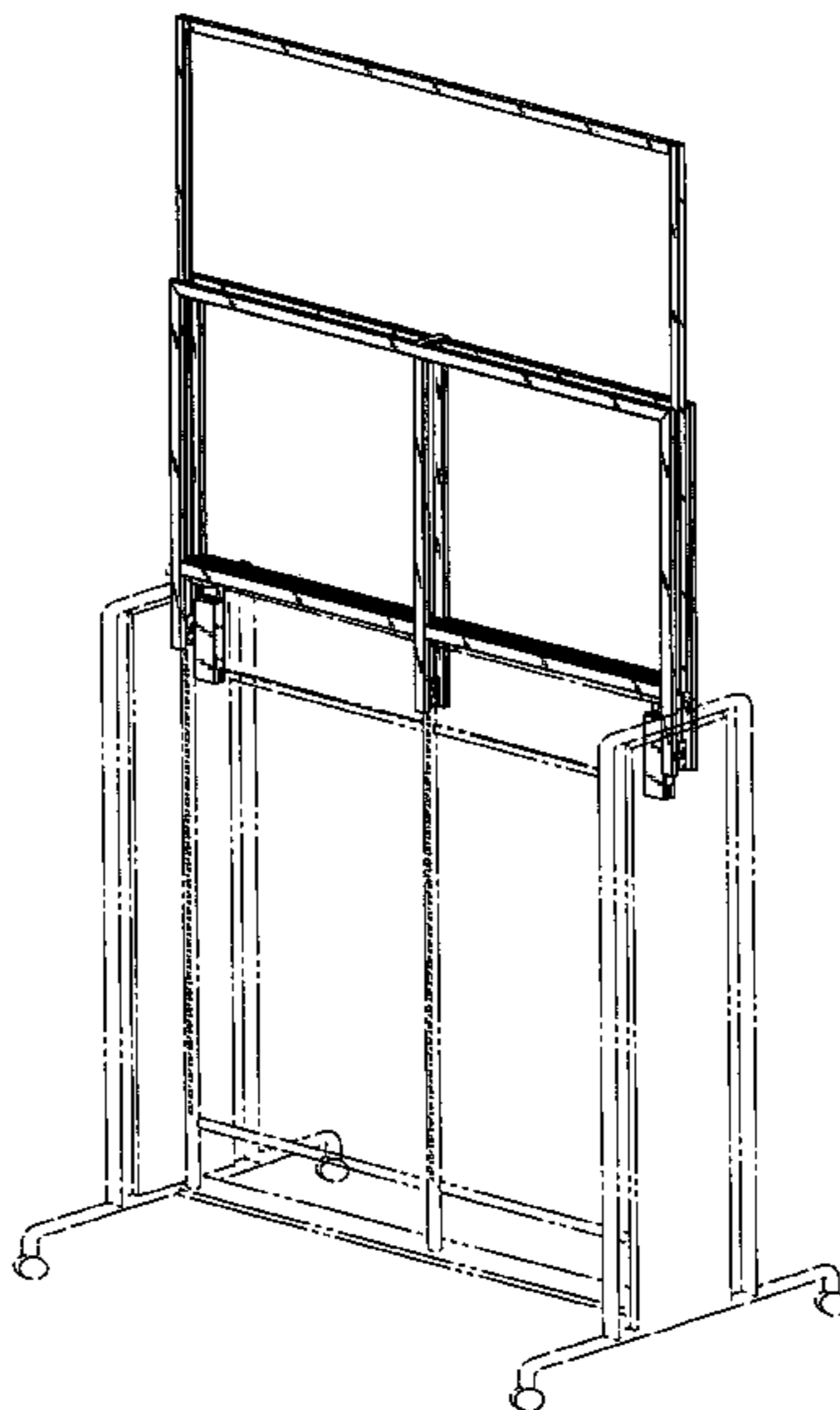

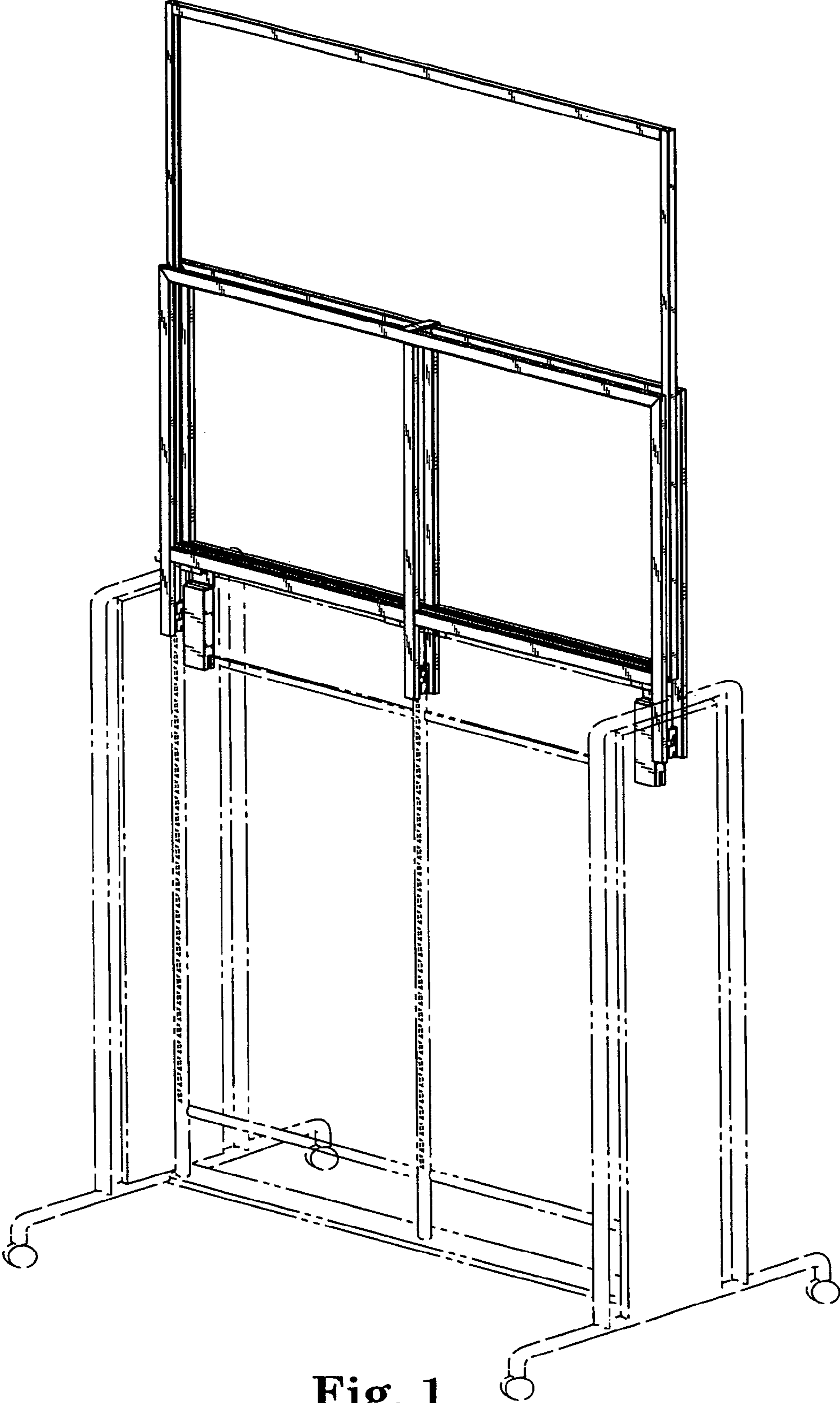

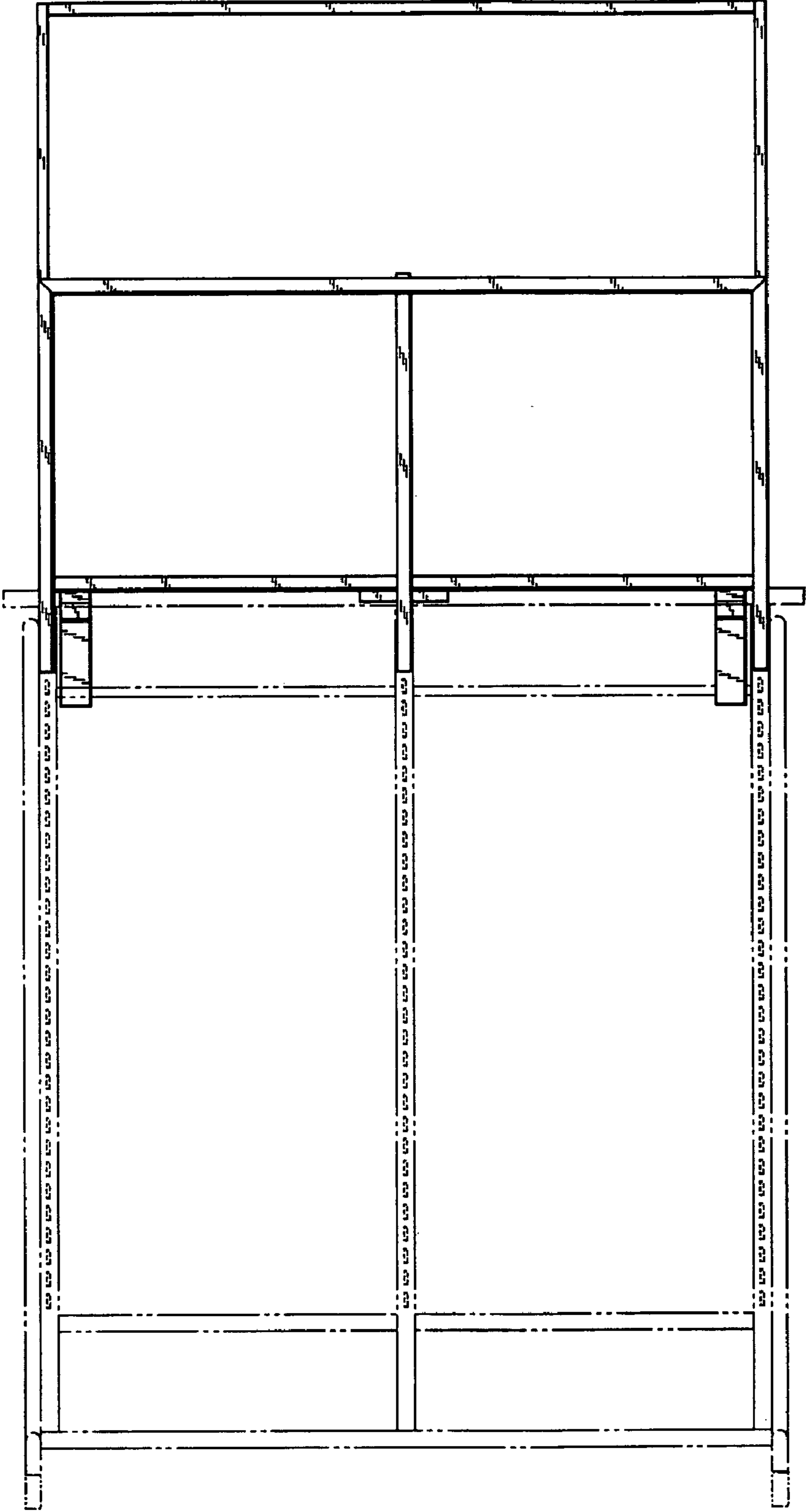

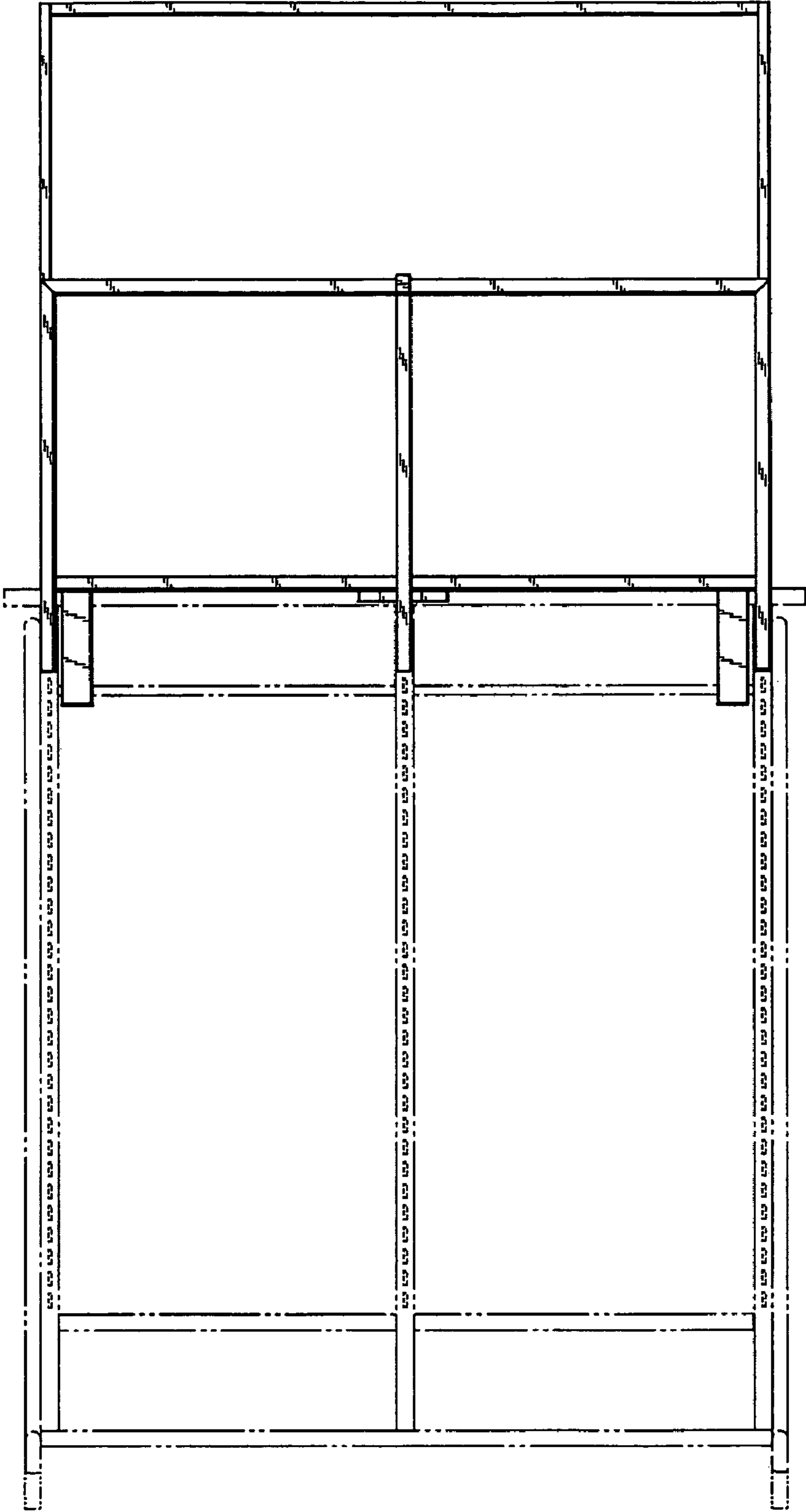

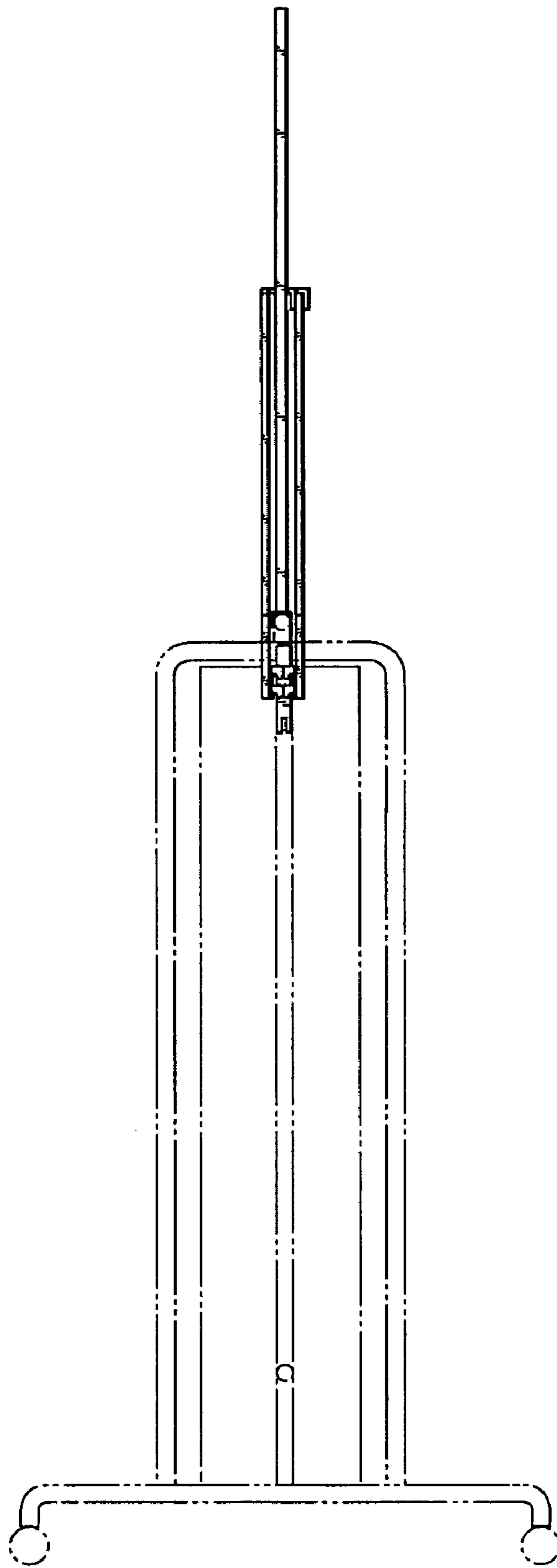

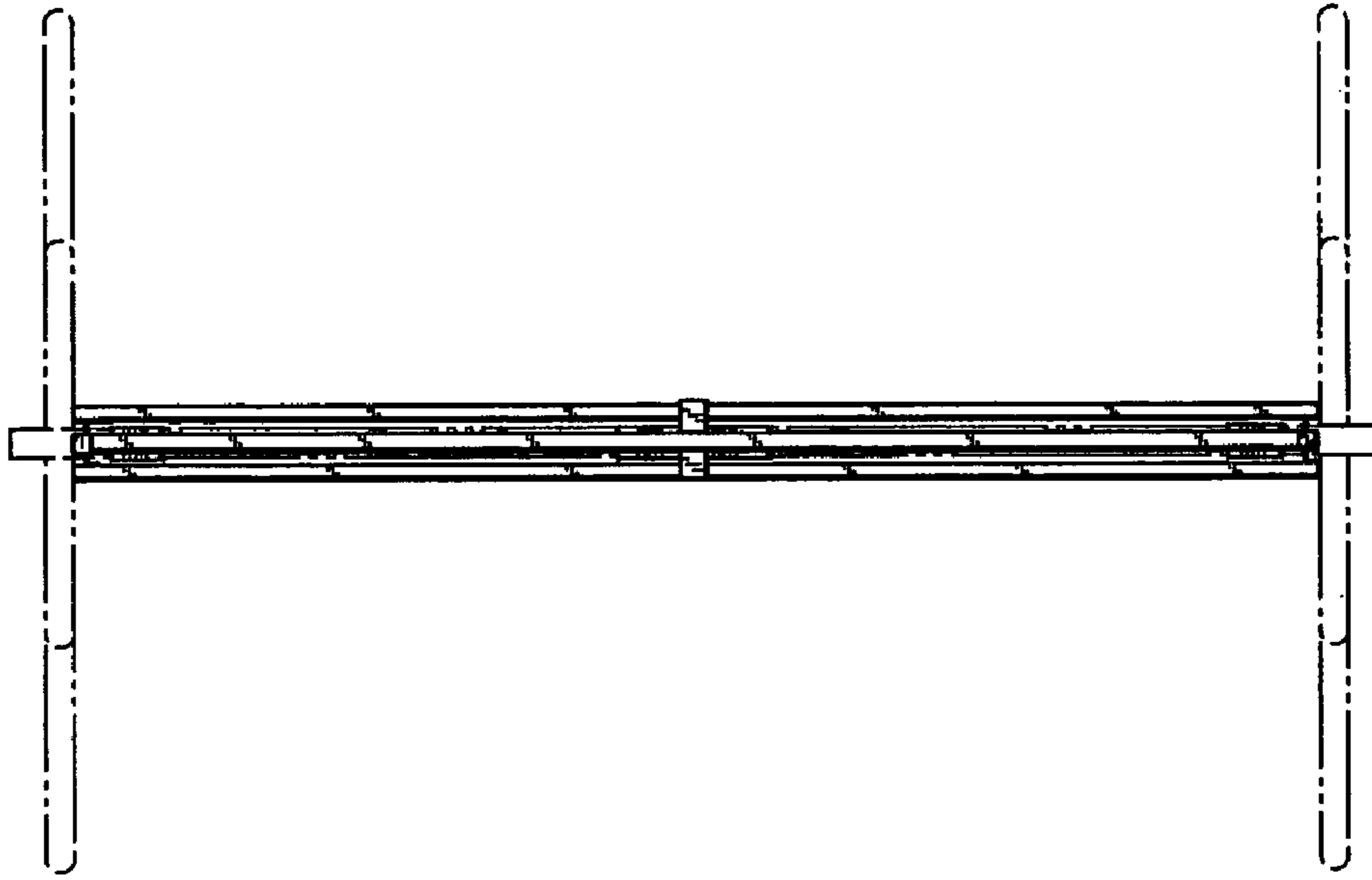

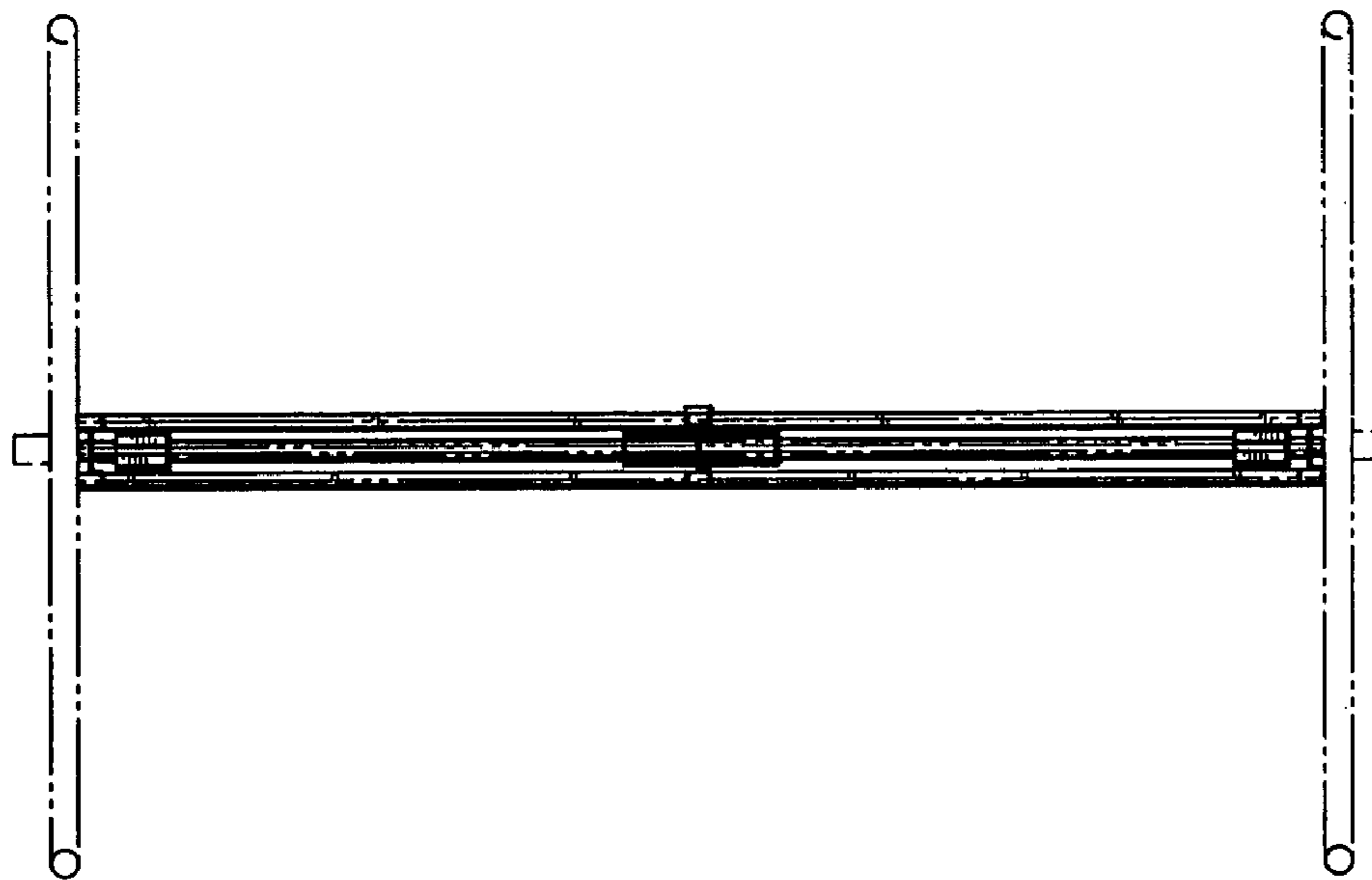
