FIG. 1 is a perspective view of the warmer steamer of the present invention;

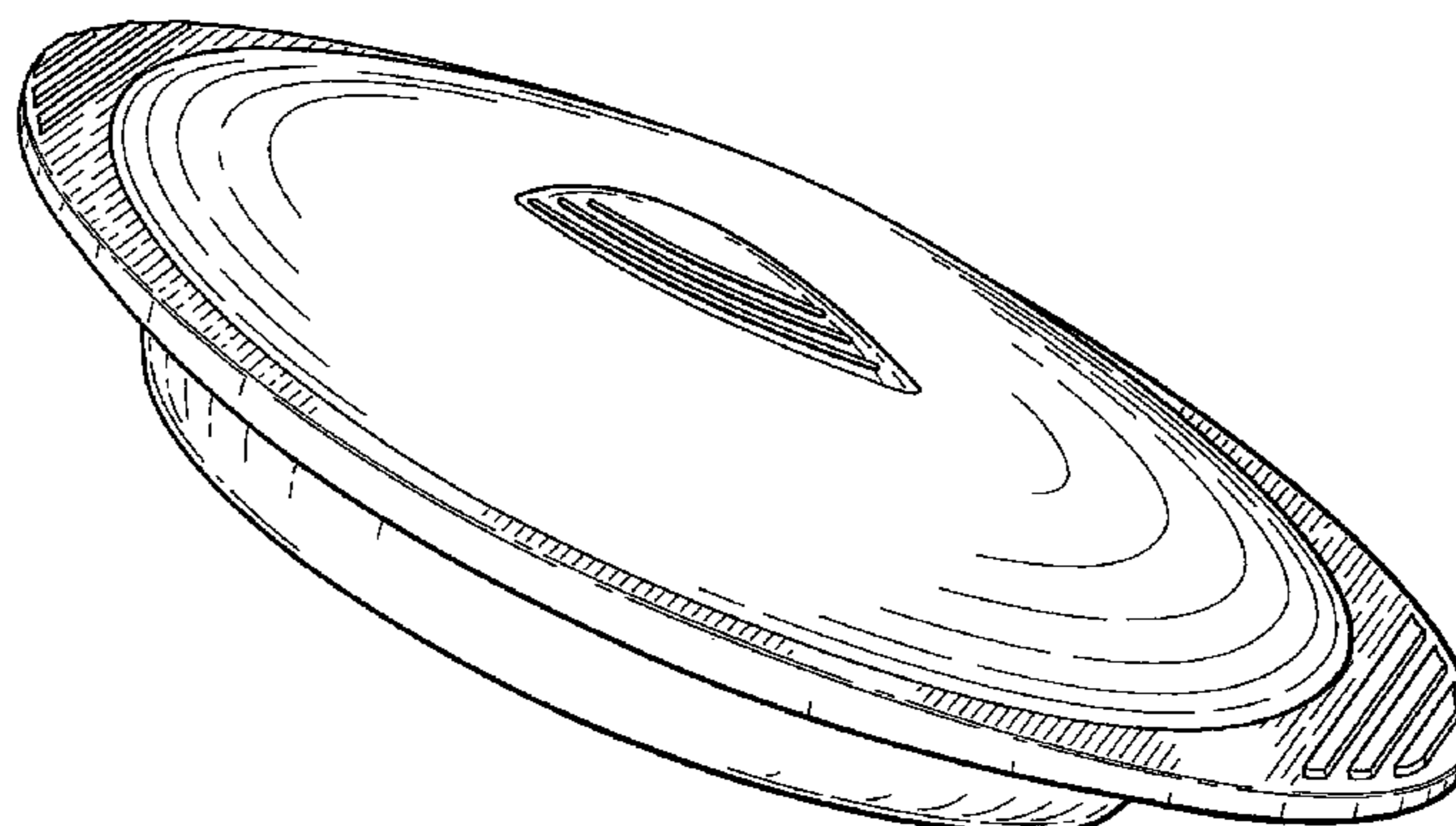
FIG. 2 is a side elevational view thereof;

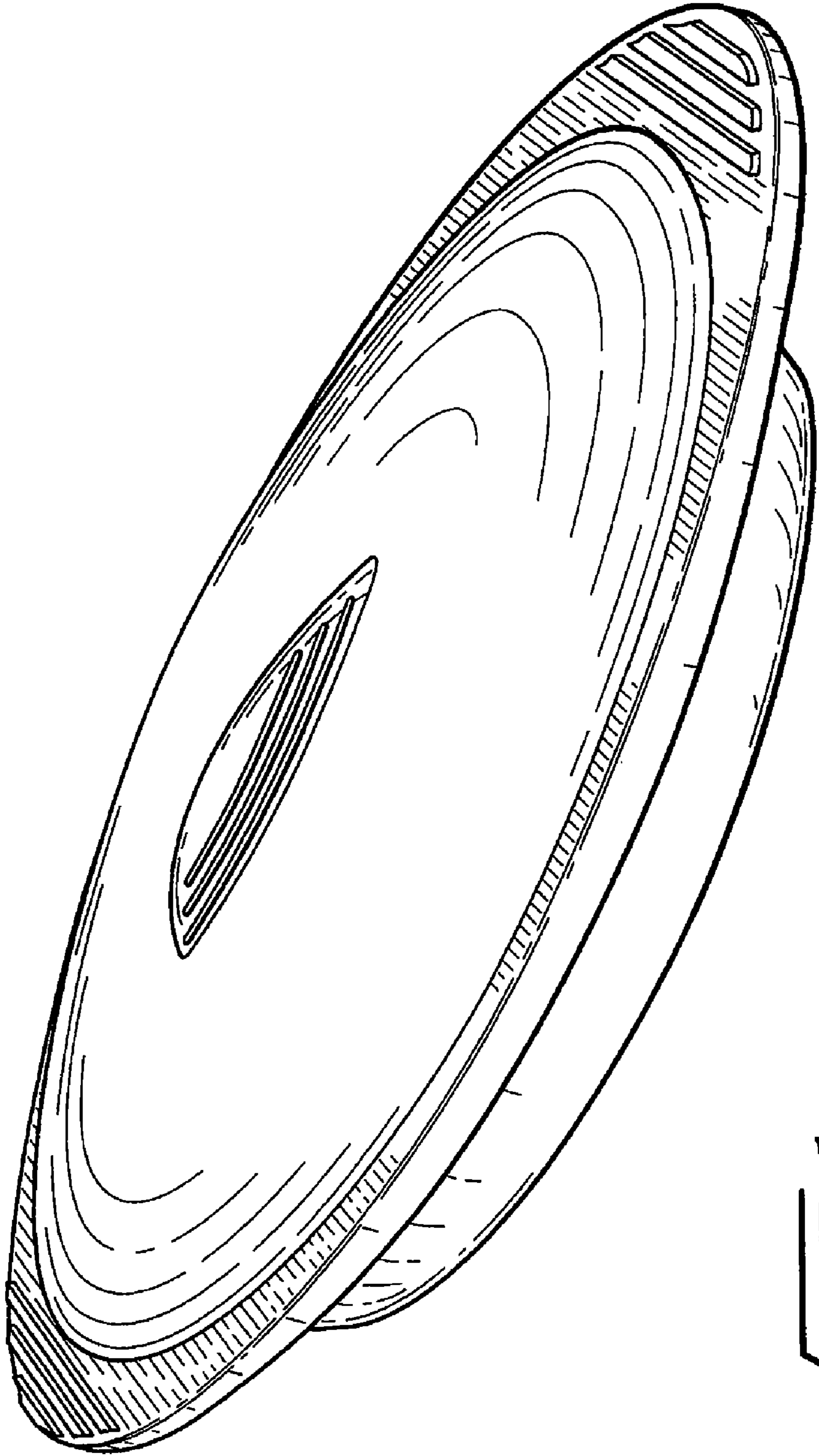

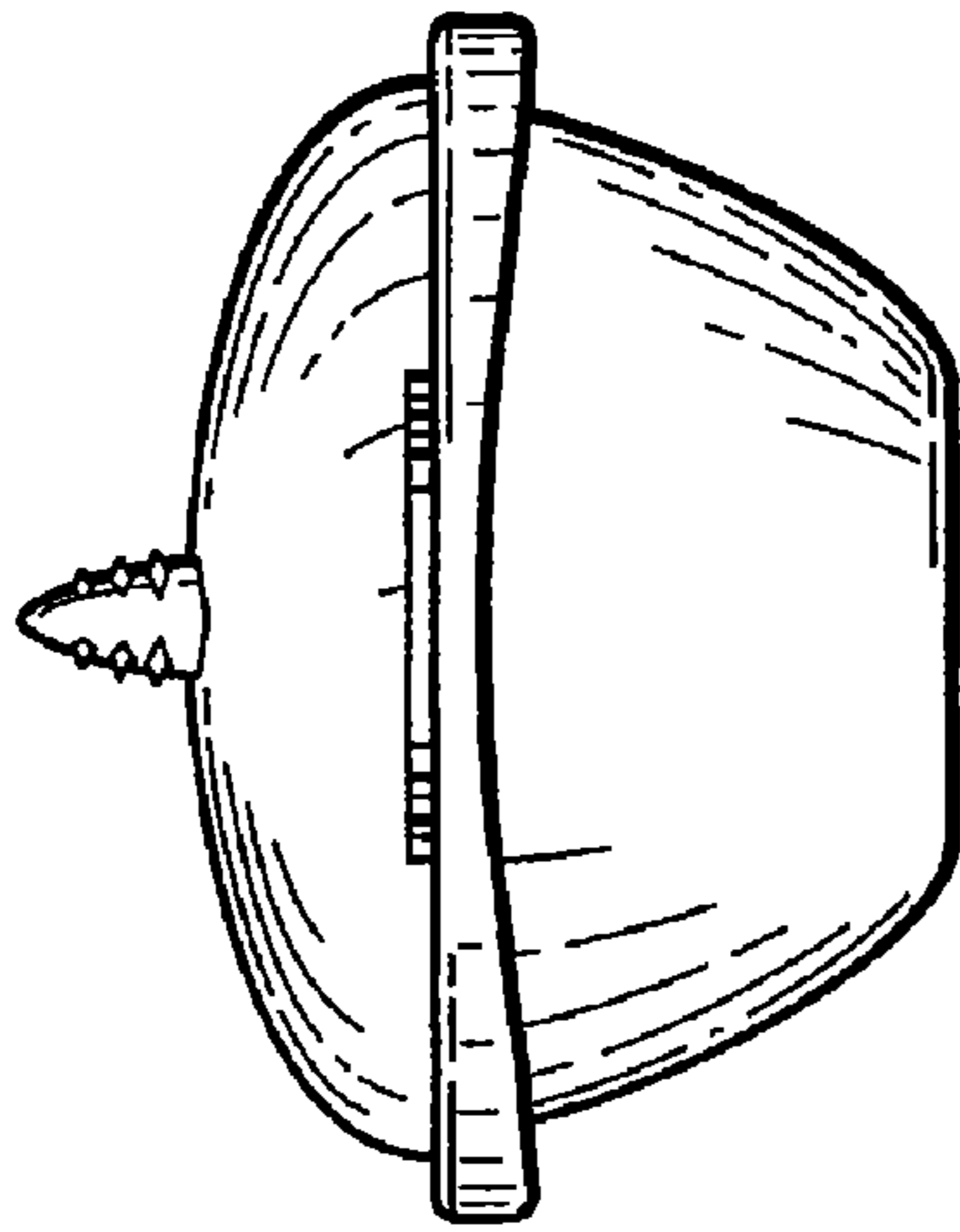
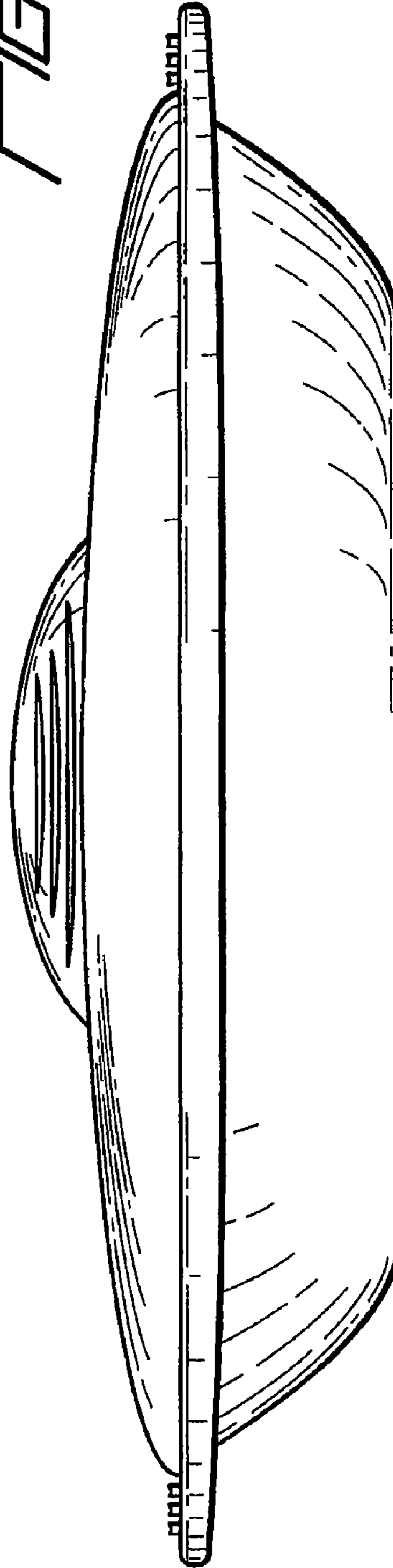

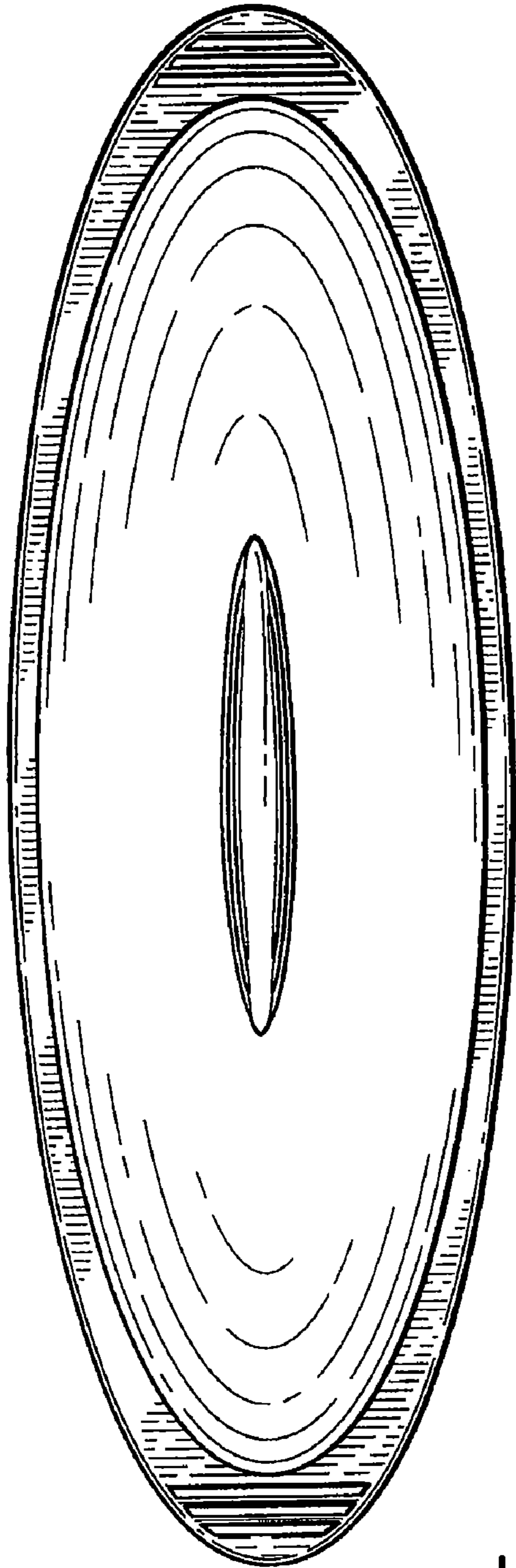

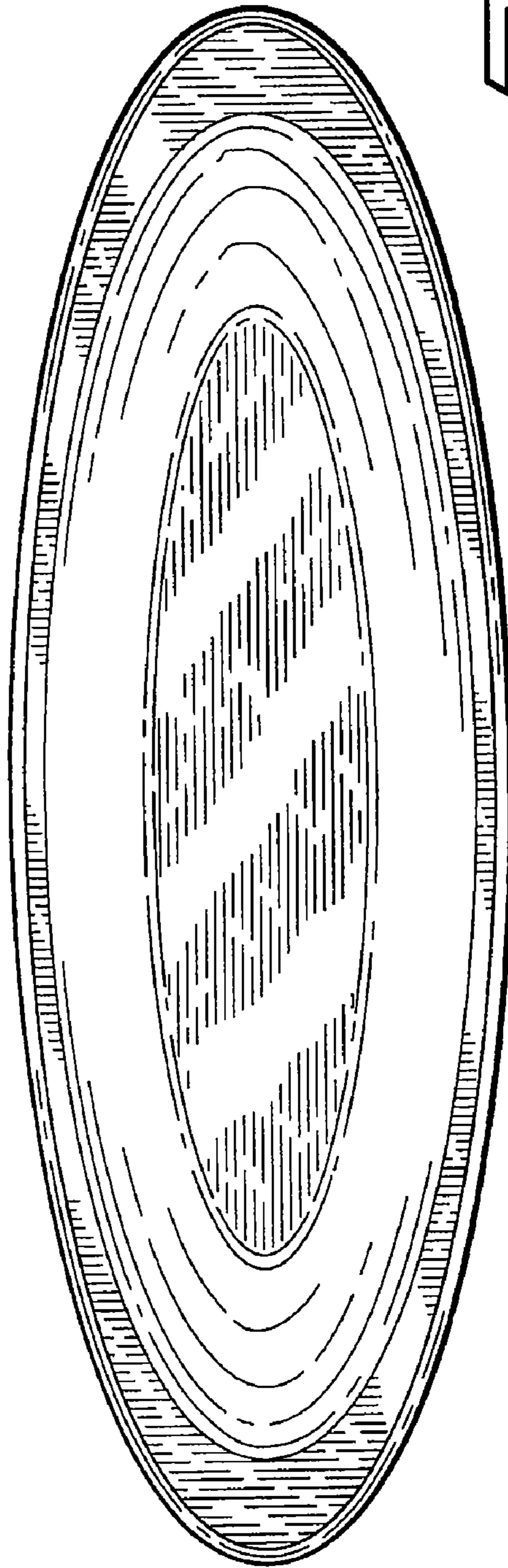
