(57) **CLAIM**

The ornamental design for a foldable spoon, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a foldable spoon showing the new design in a folded orientation;

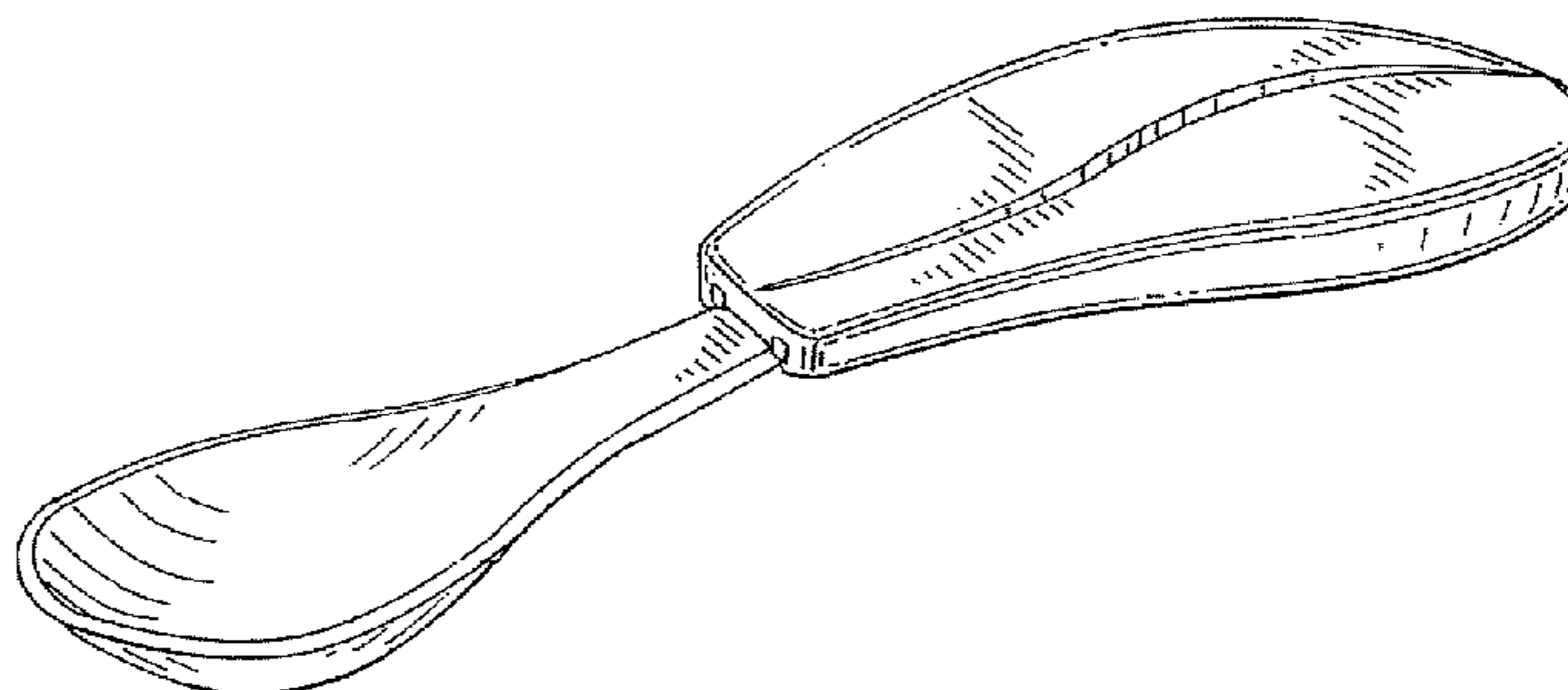
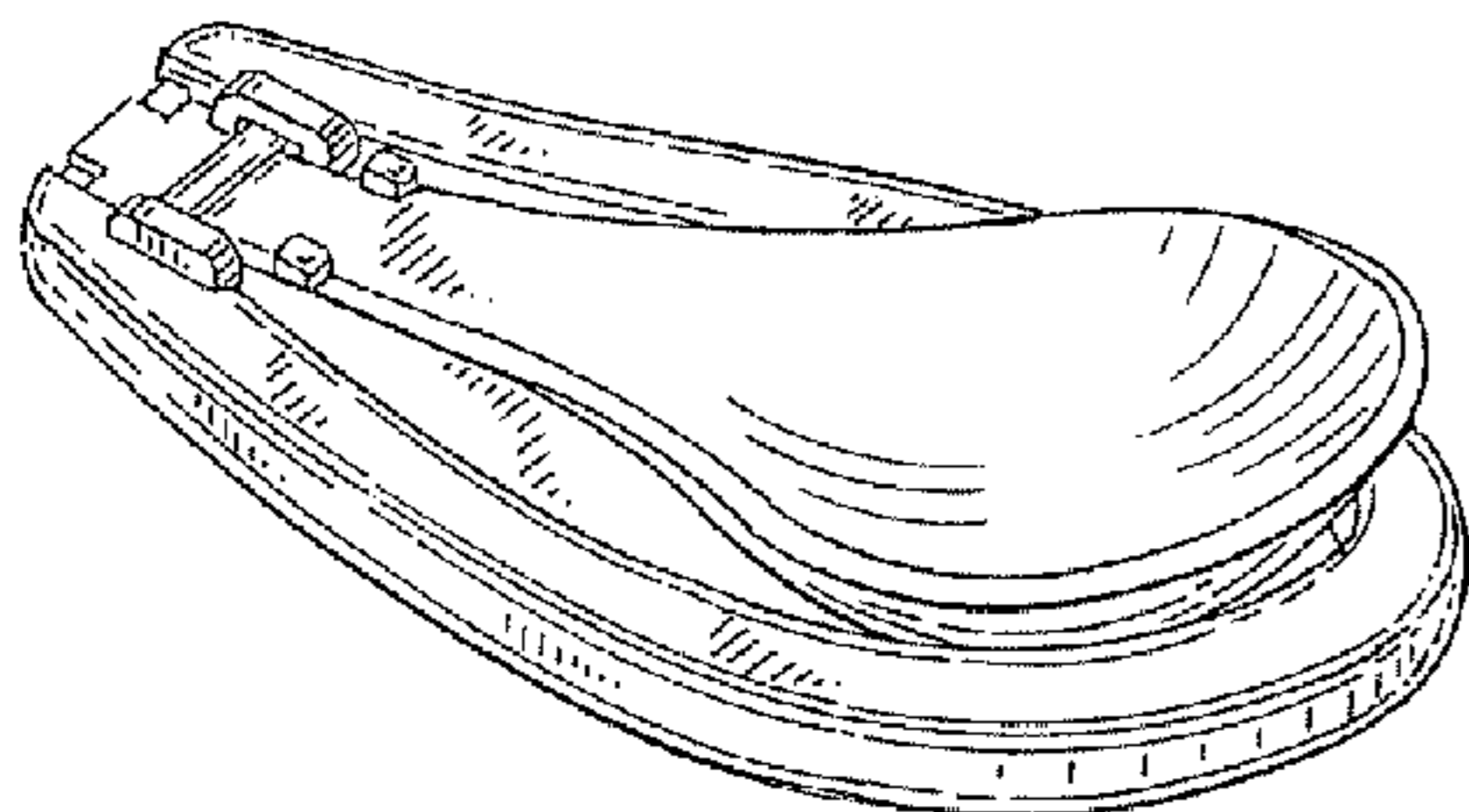

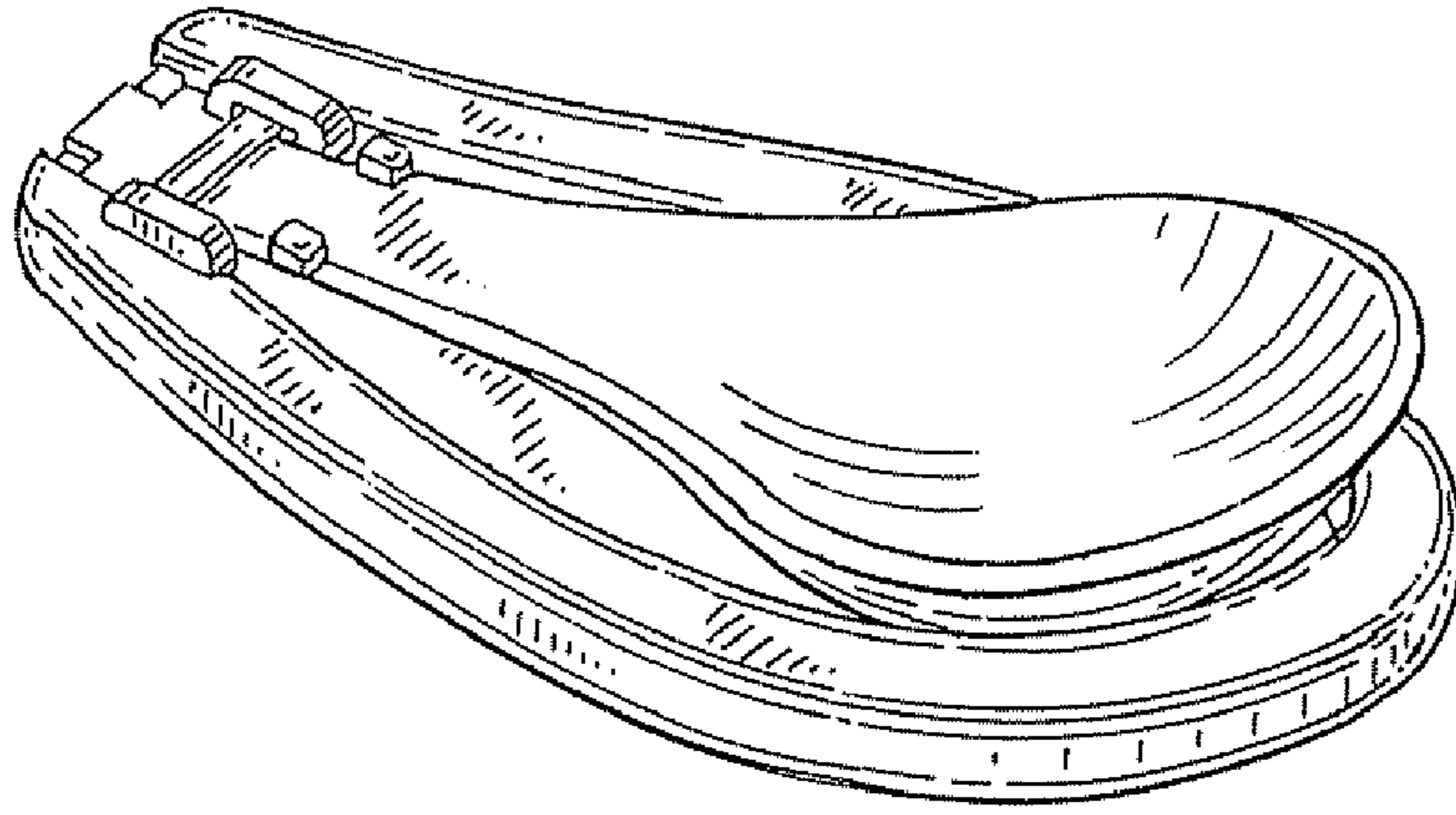

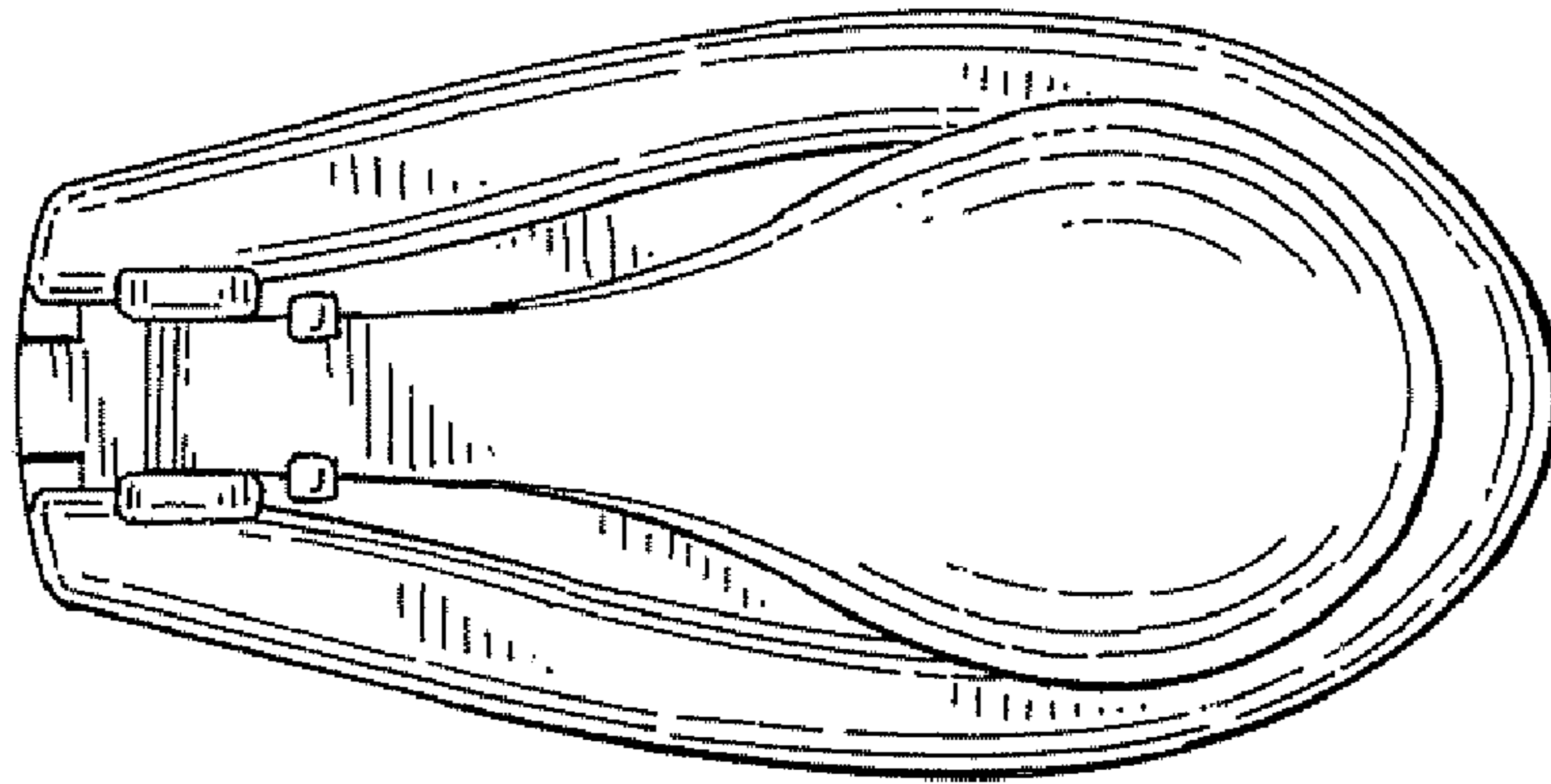

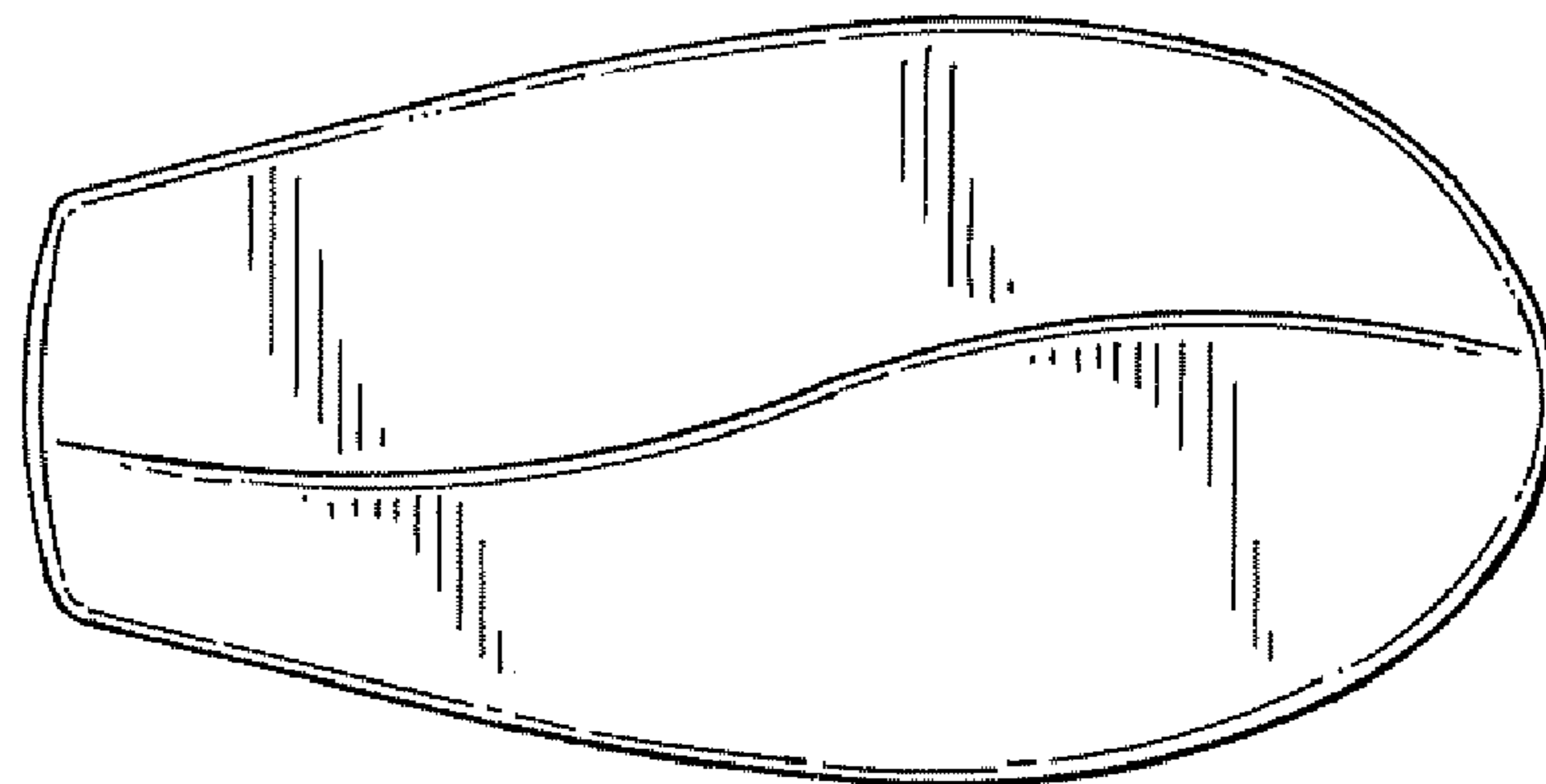

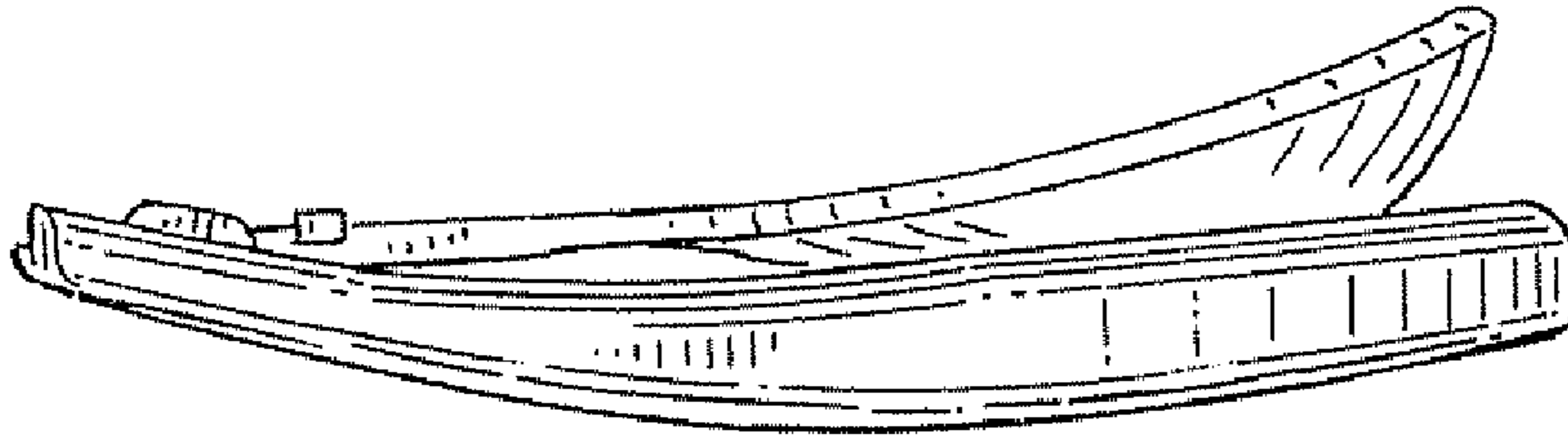

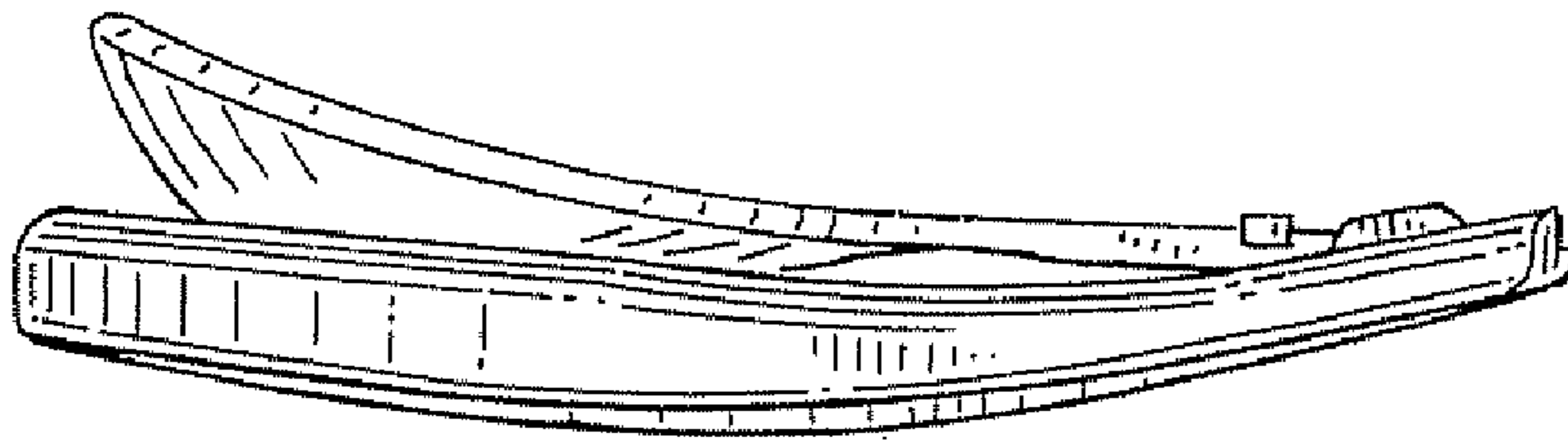

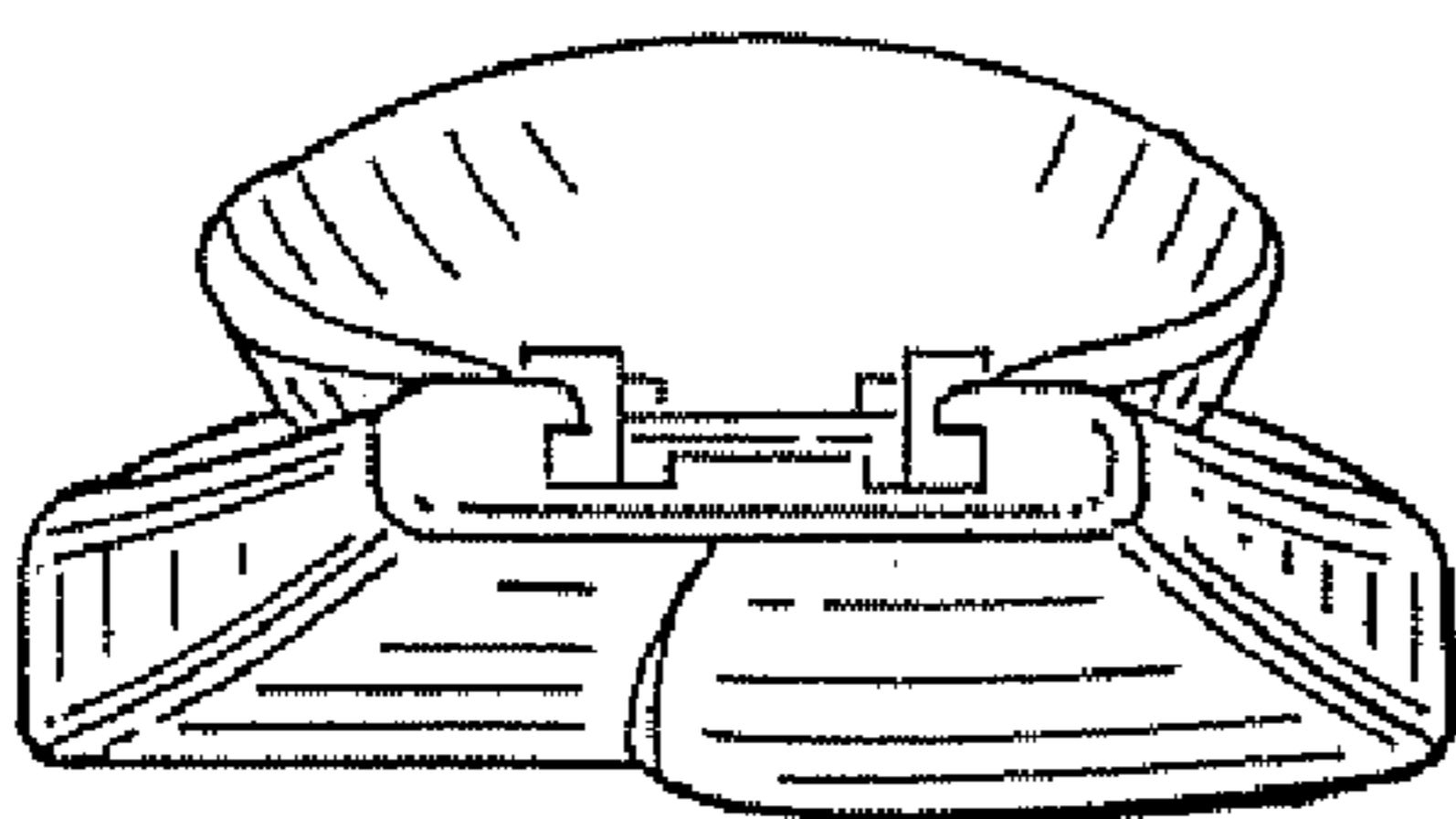
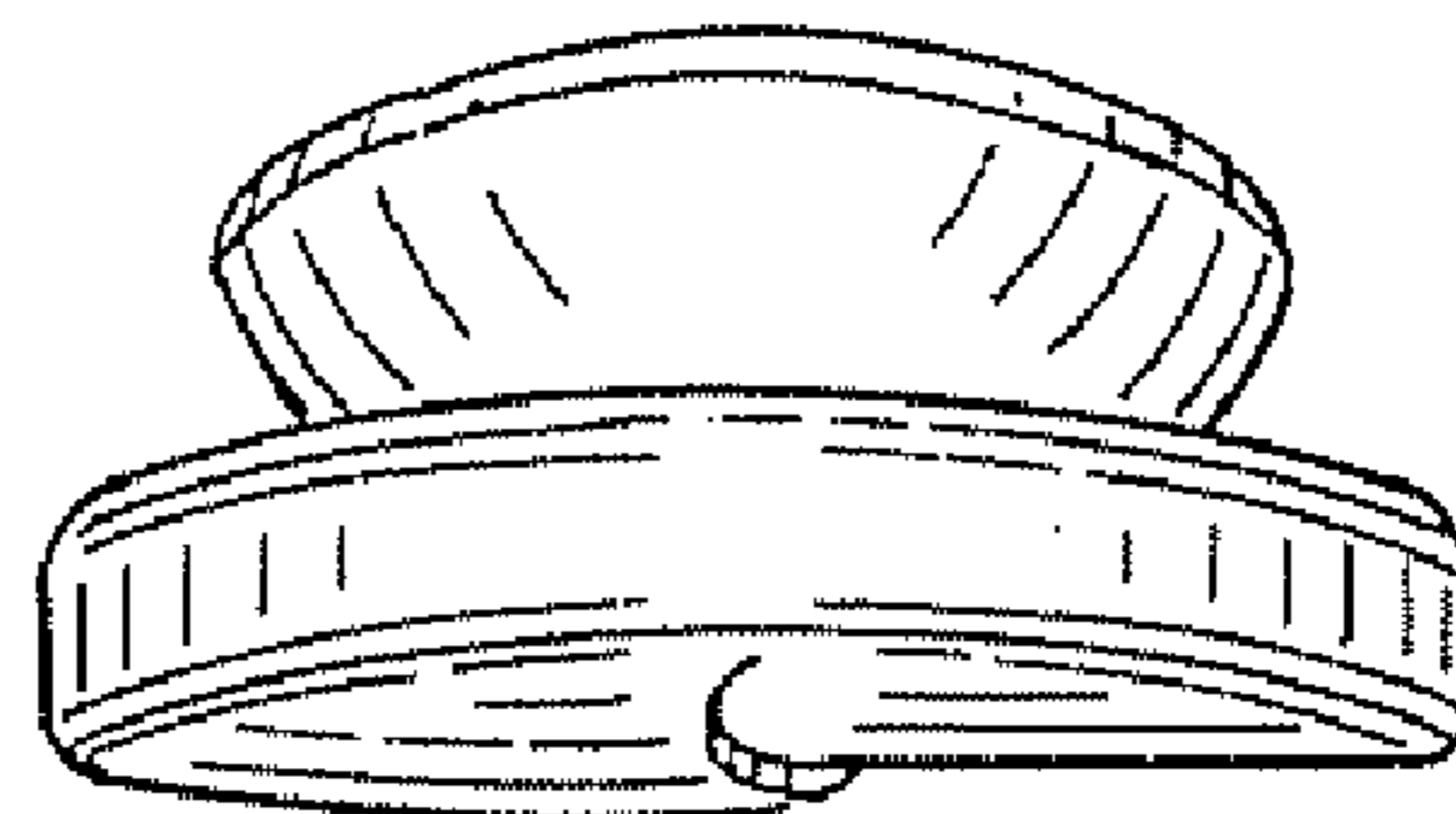

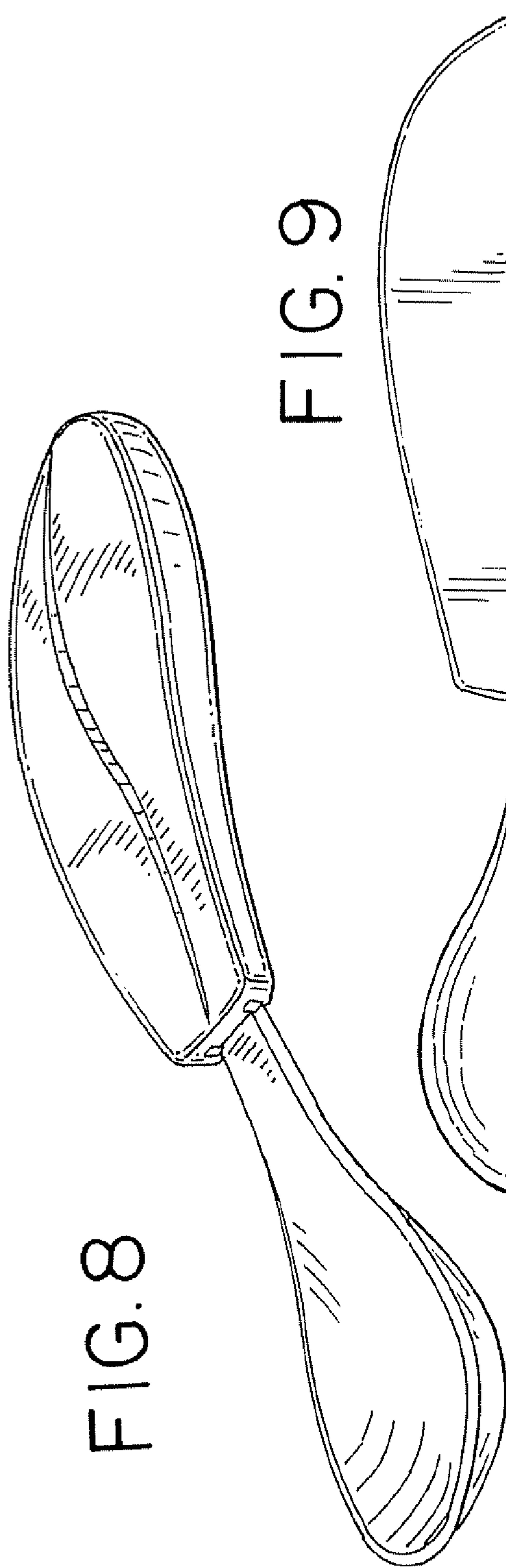

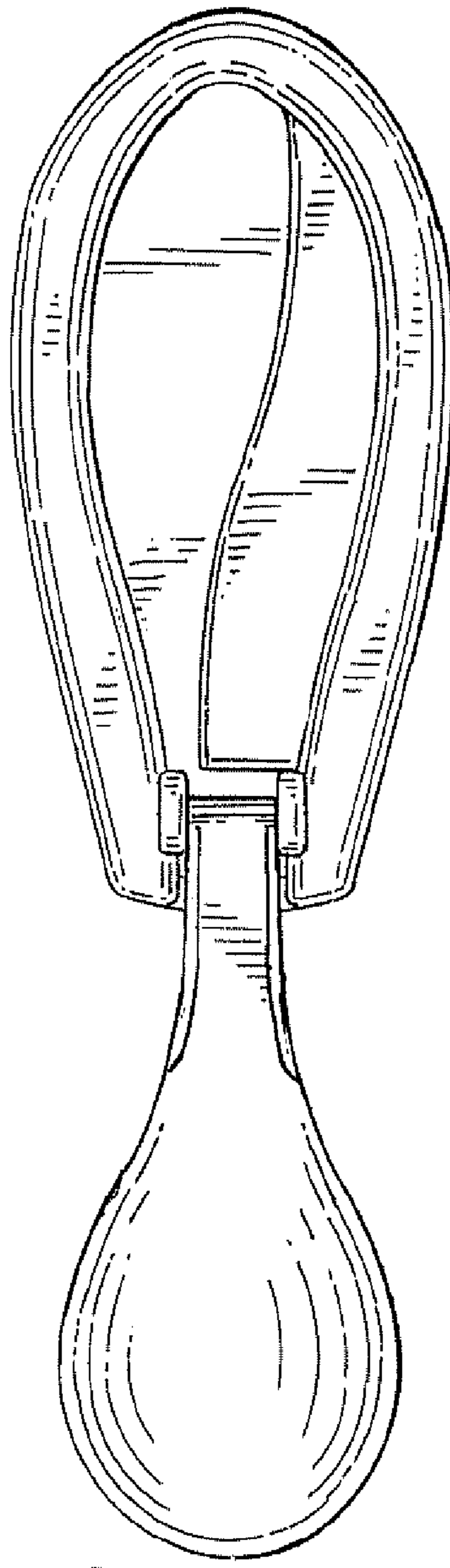
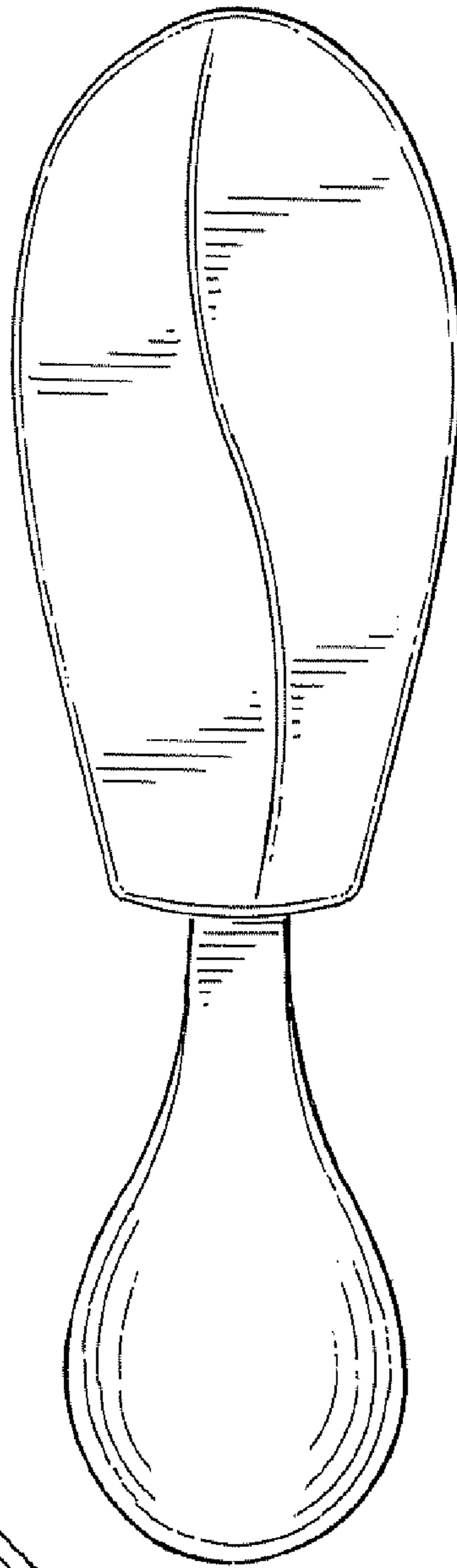

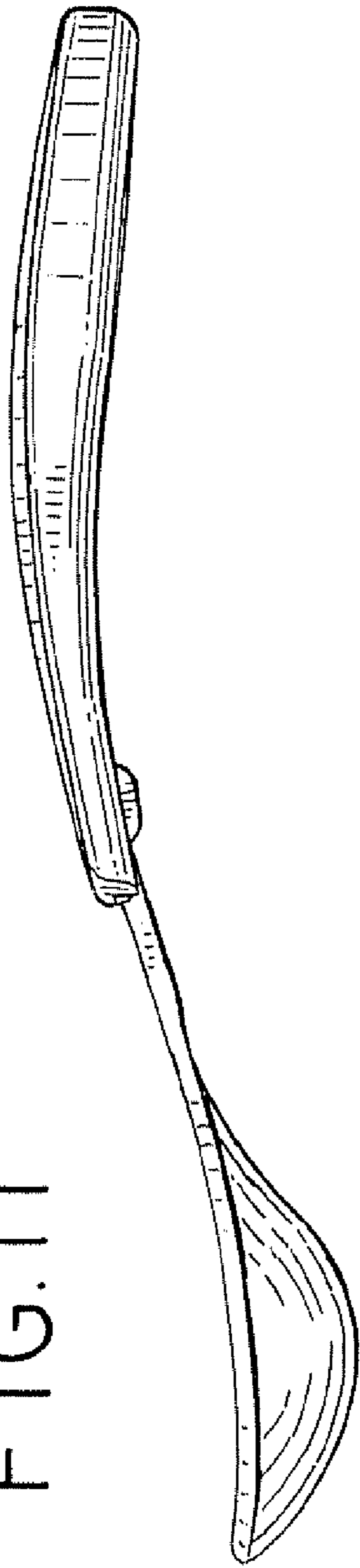

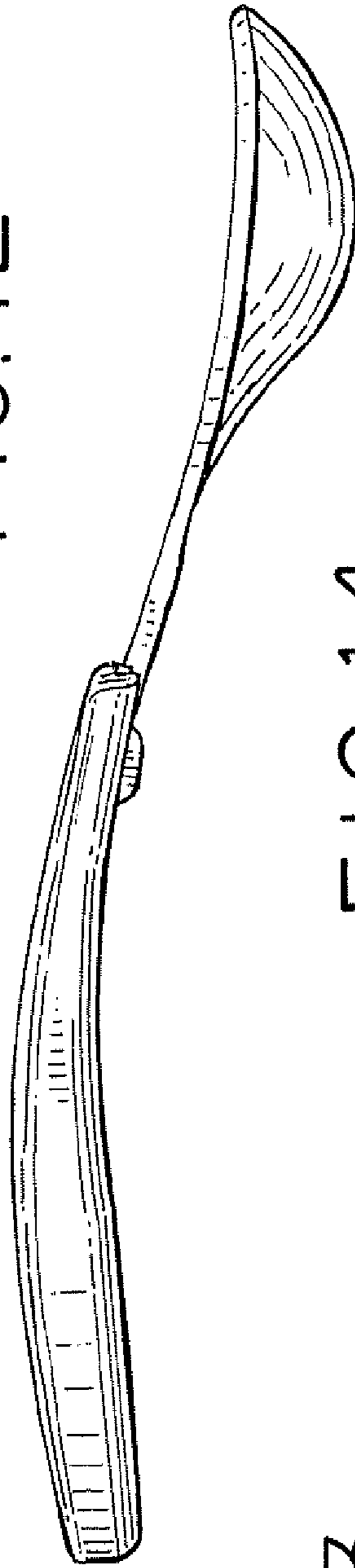

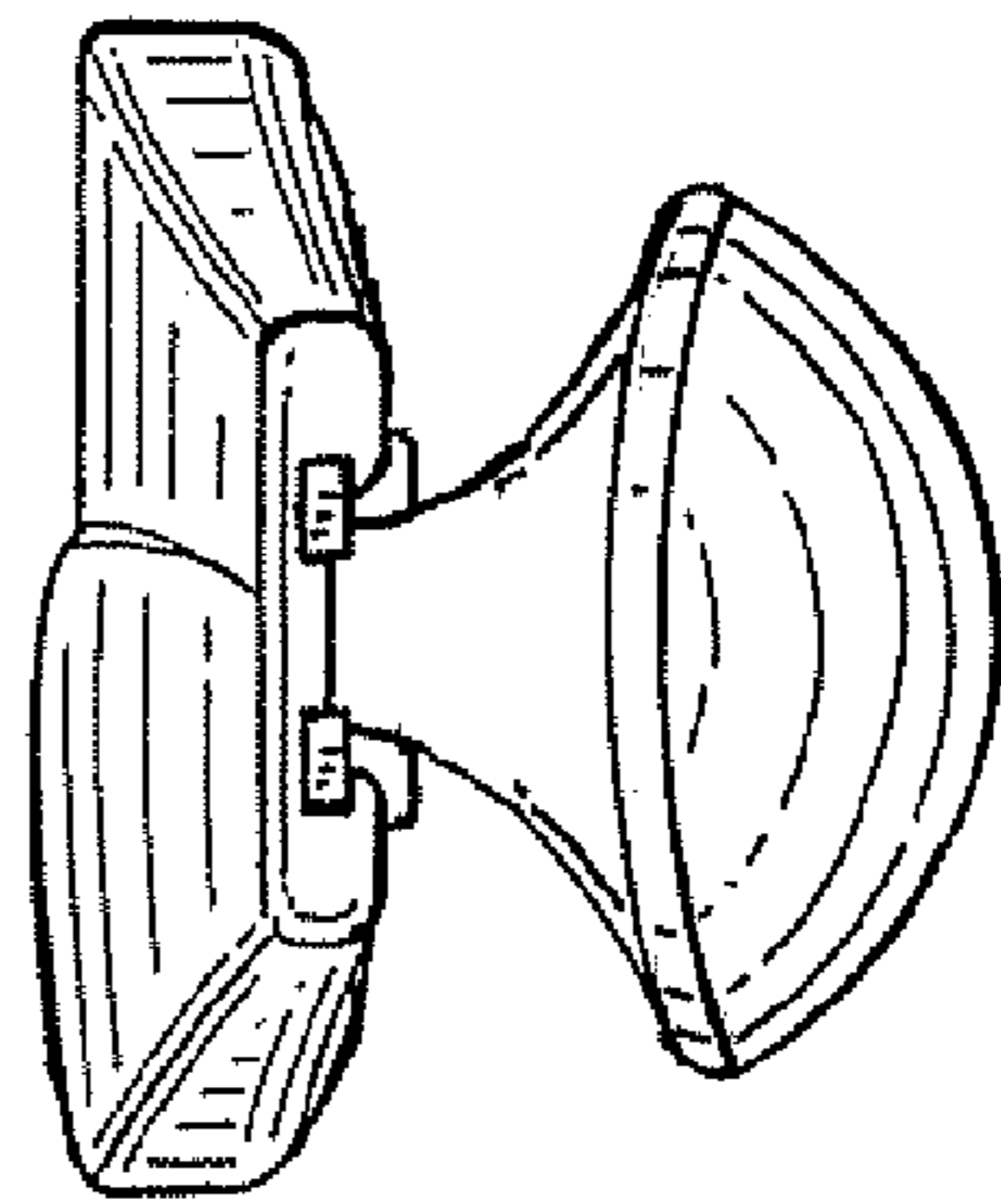
