FIG. 3 is a rear elevational view of our bottle;

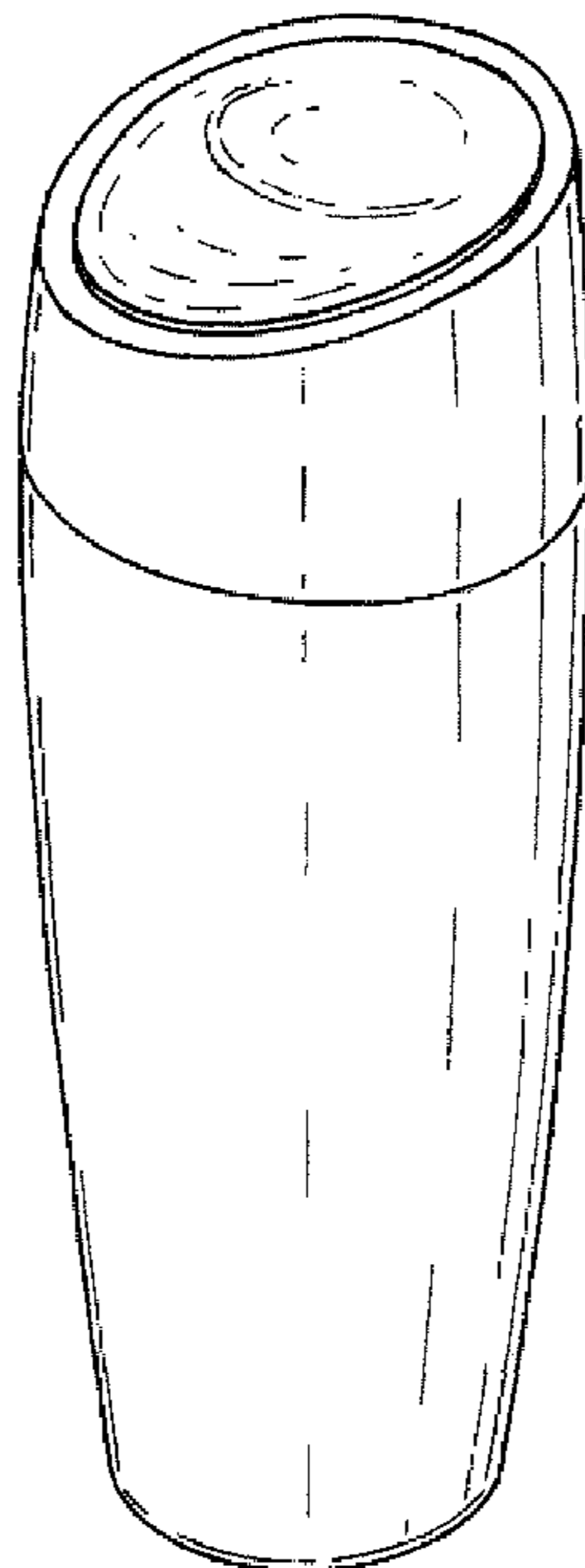
FIG. 4 is a top plan view of our bottle;

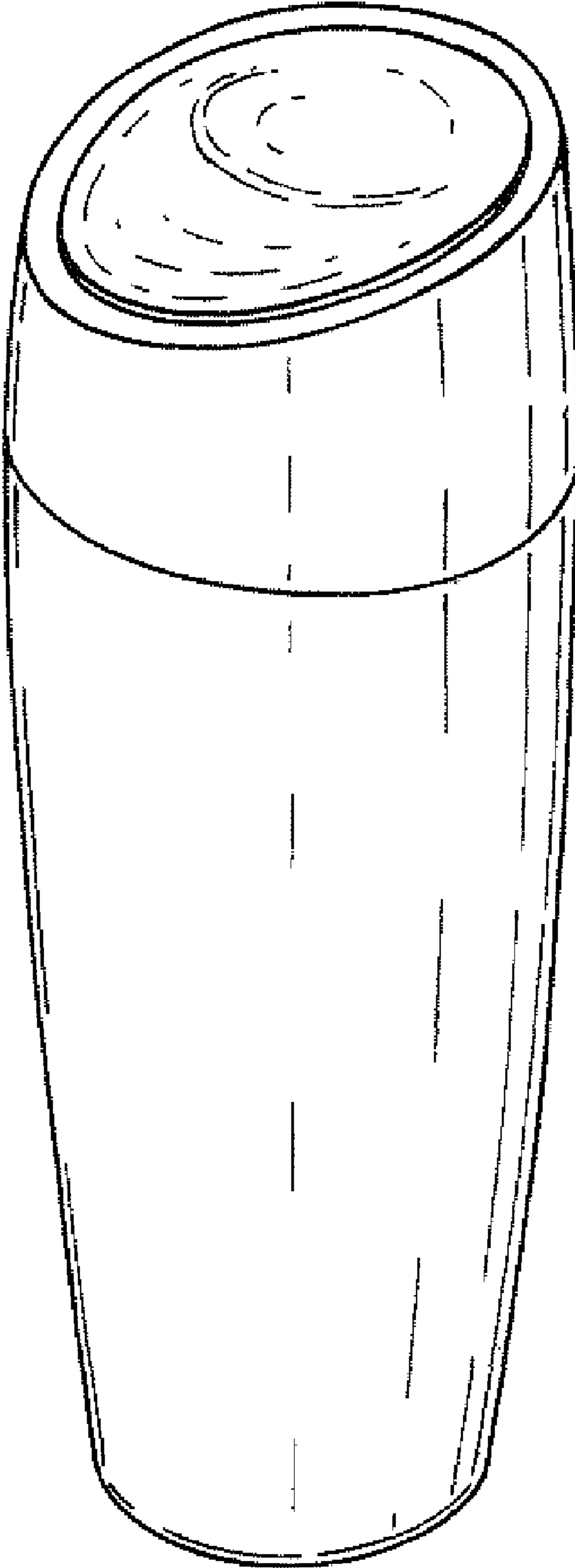

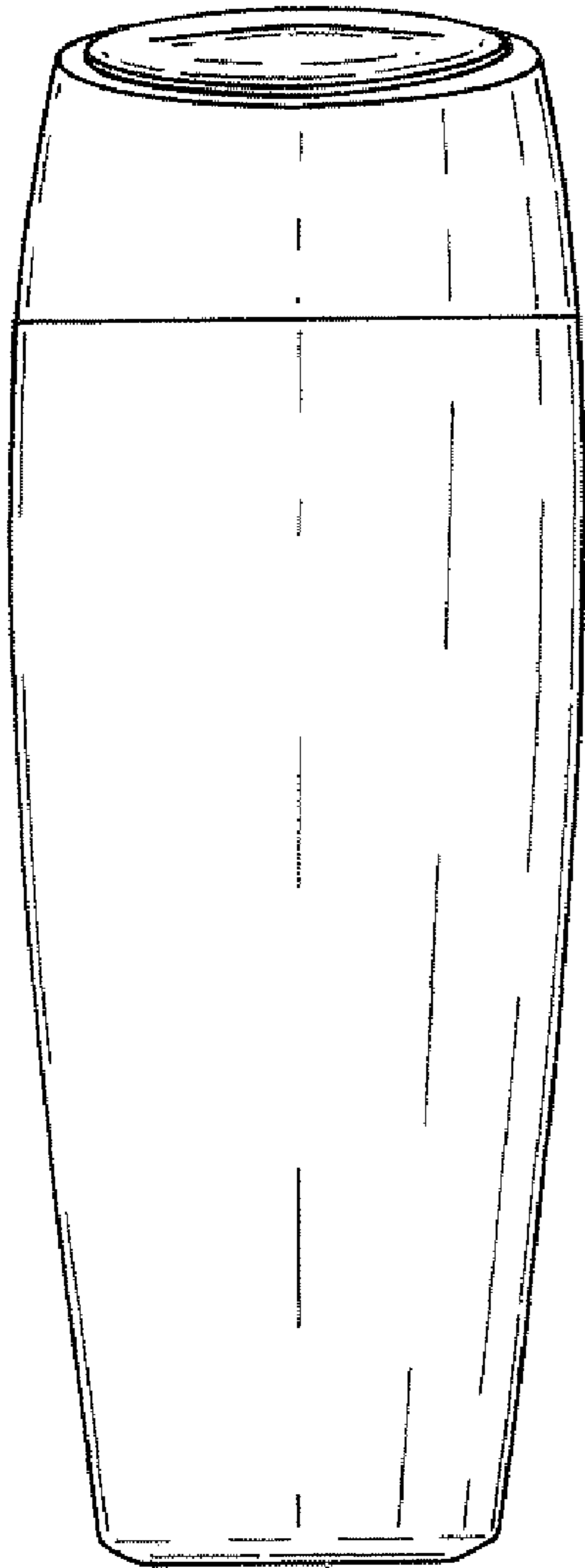

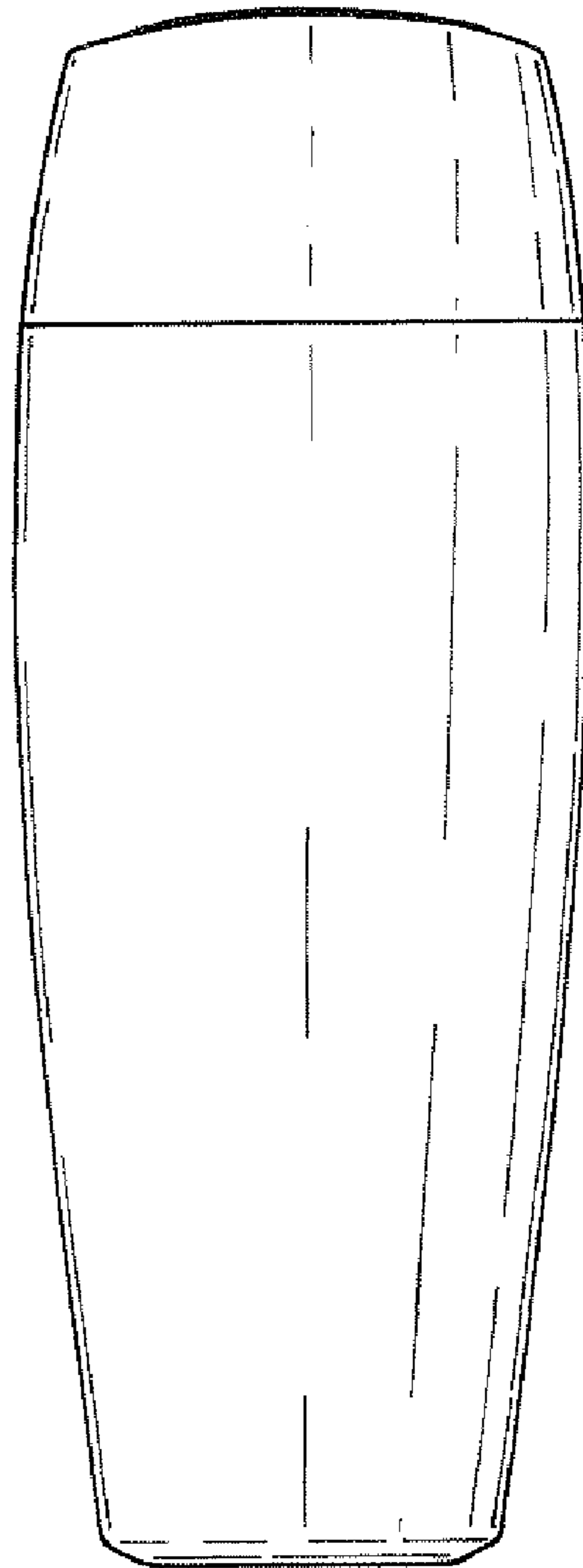

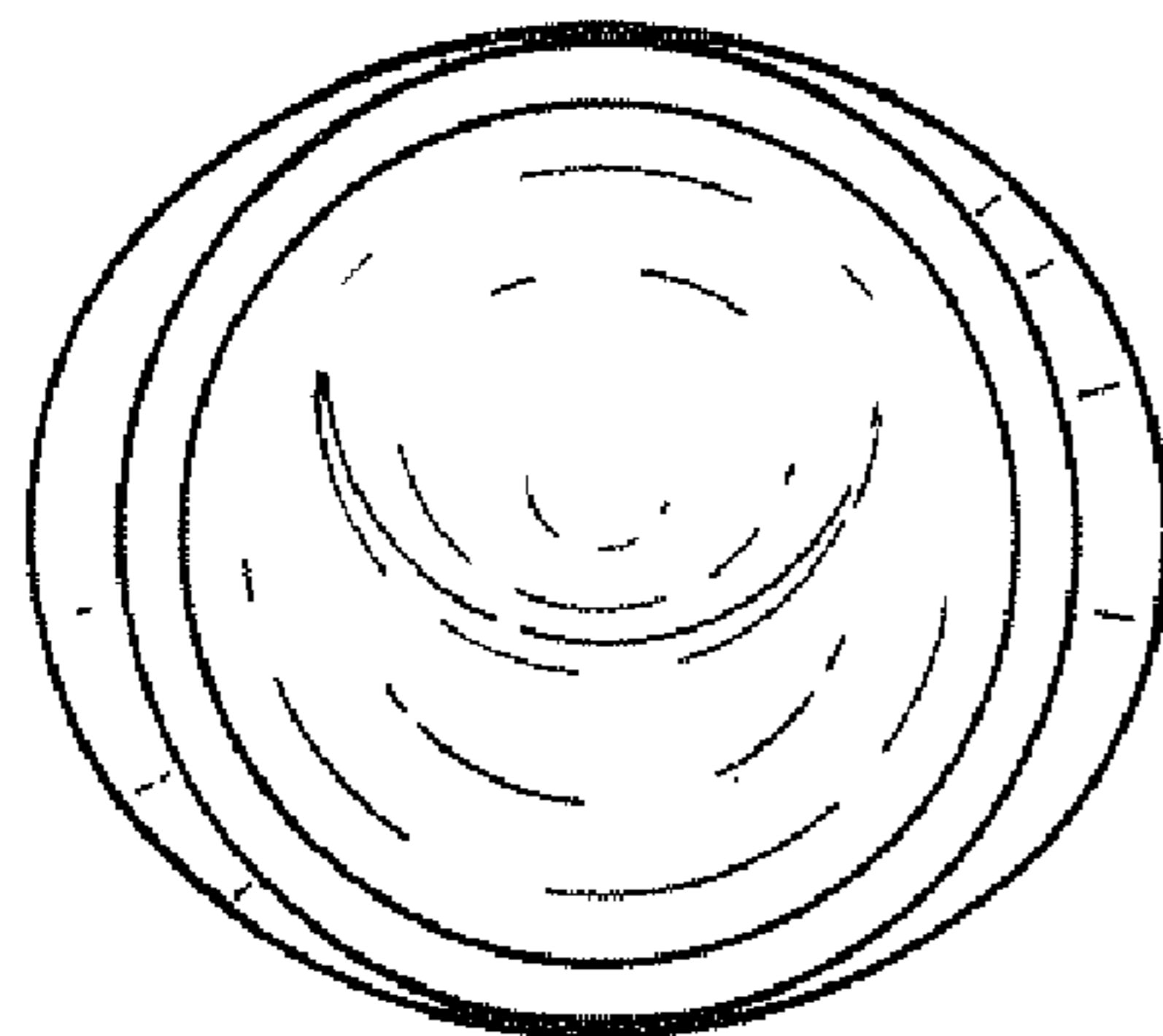

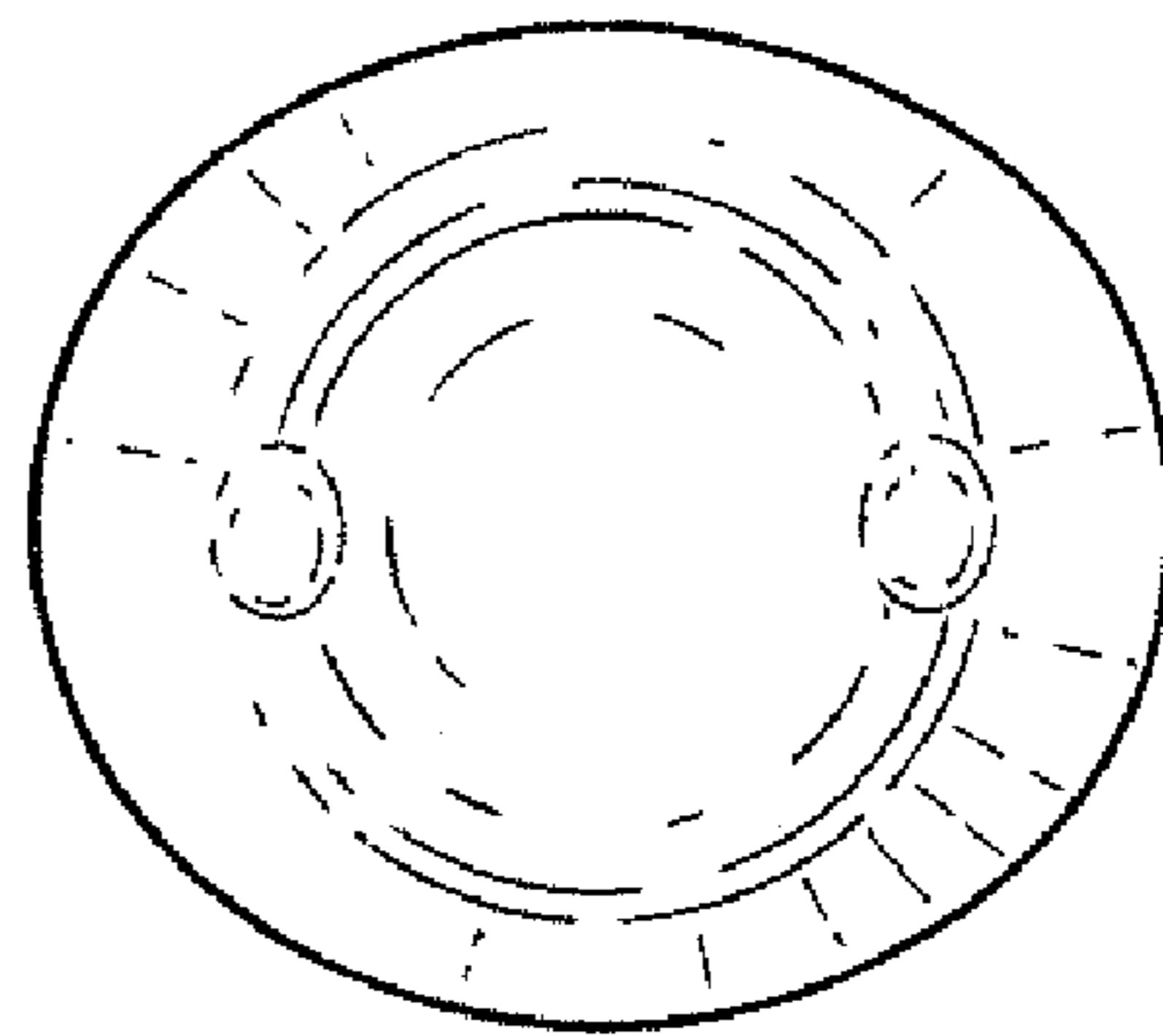

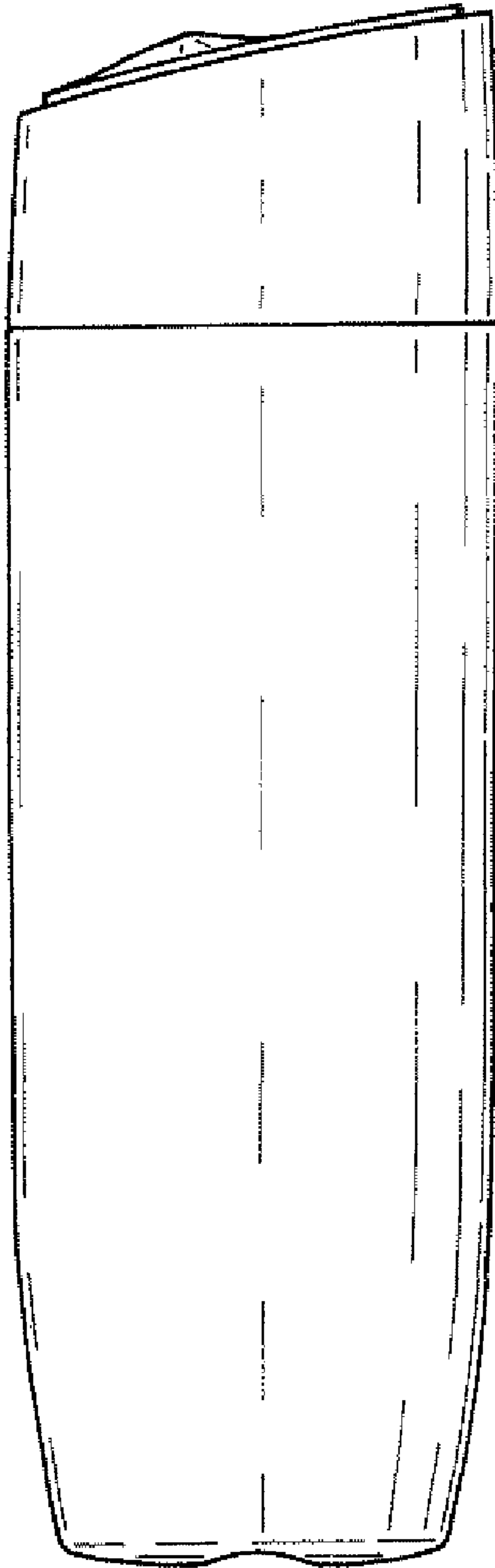

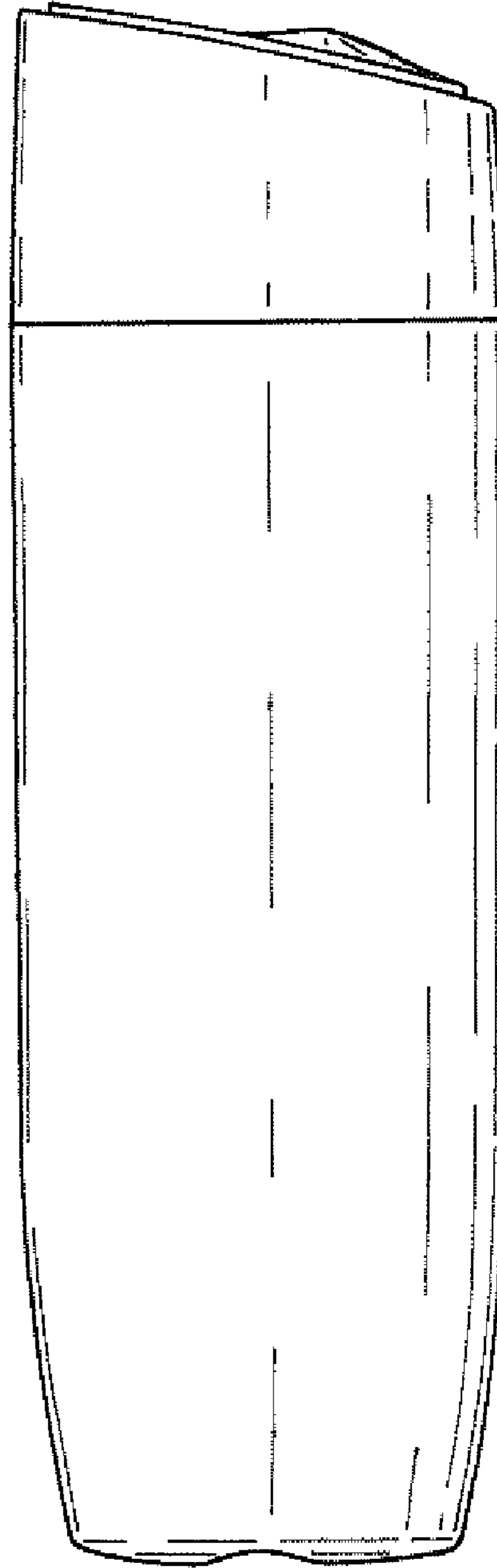
