(57) **CLAIM**

The ornamental design for a cosmetic bottle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view showing our new design for a cosmetic bottle;

FIG. 2 is a front elevation view of the cosmetic bottle shown in FIG. 1;

FIG. 3 a right side elevation view of the cosmetic bottle shown in FIG. 1, the left side elevation view being identical thereto;

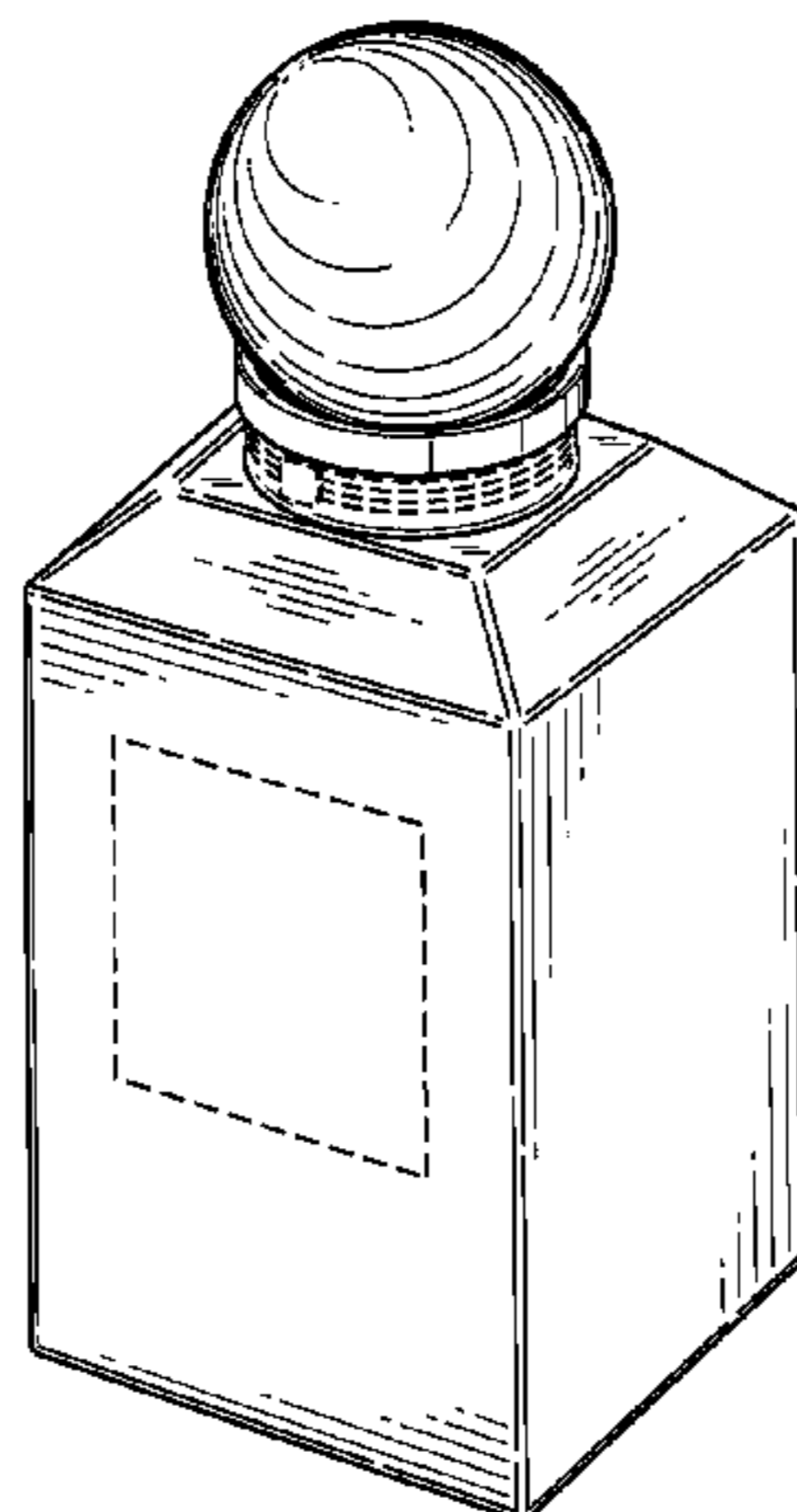
FIG. 4 is a rear elevation view of the cosmetic bottle shown in FIG. 1;

FIG. 5 is a top plan view of the cosmetic bottle shown in FIG. 1; and,

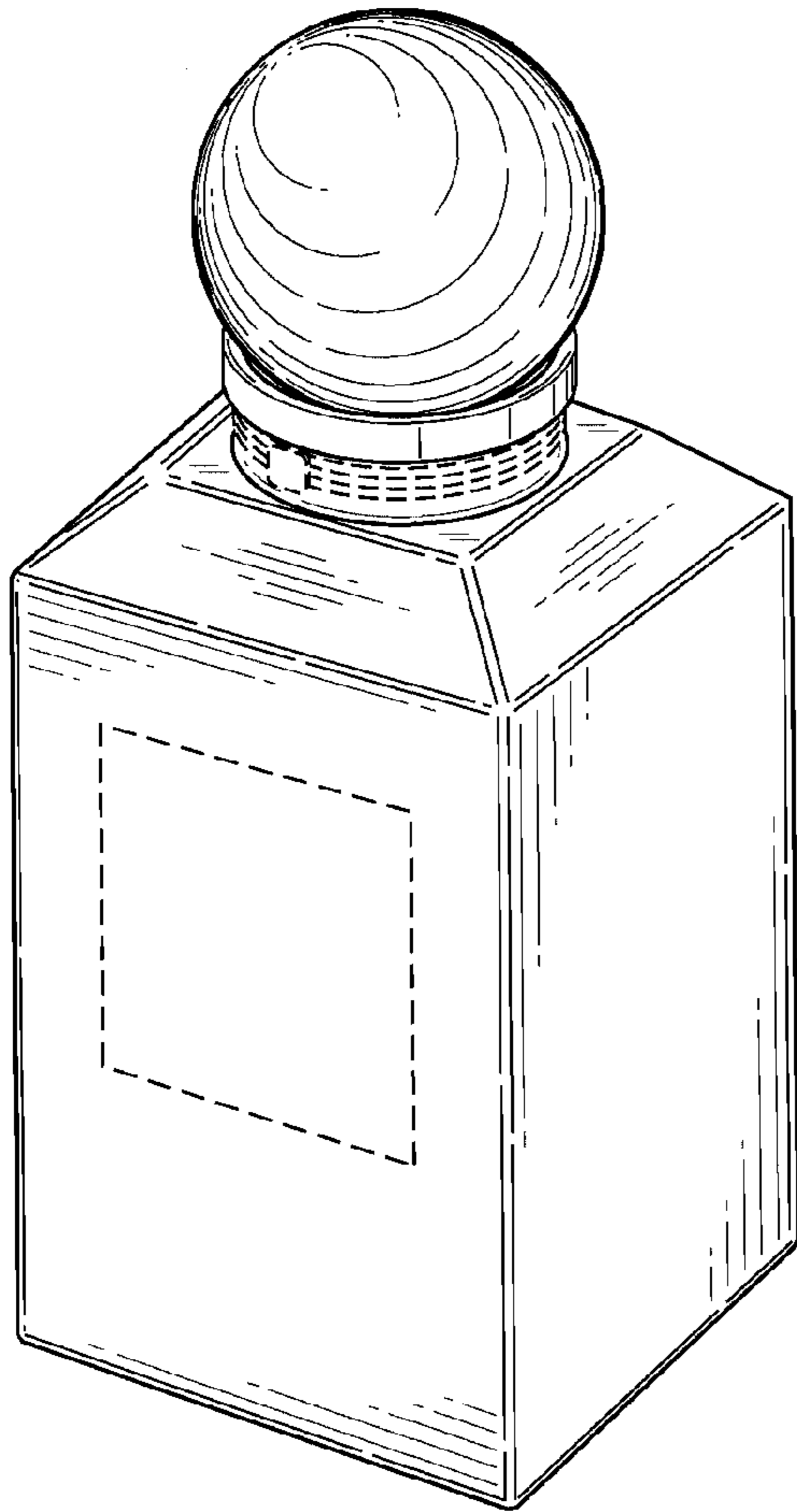

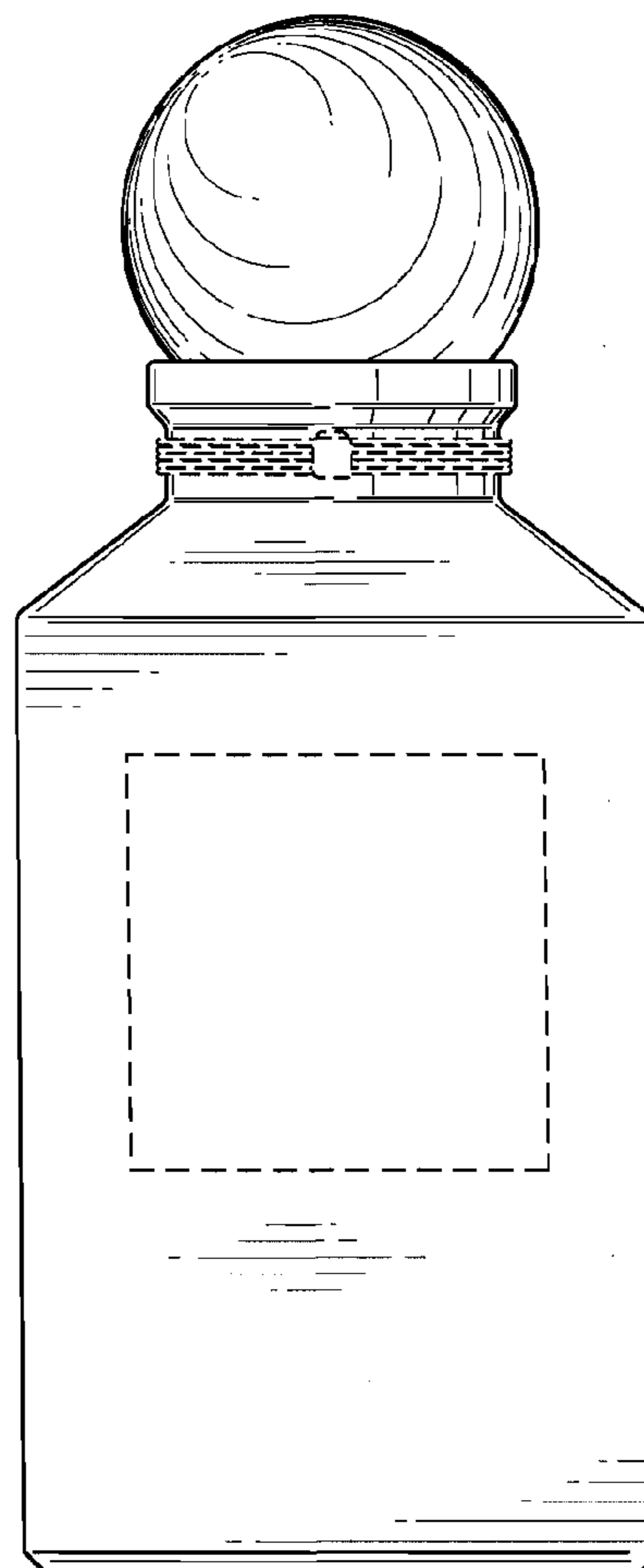

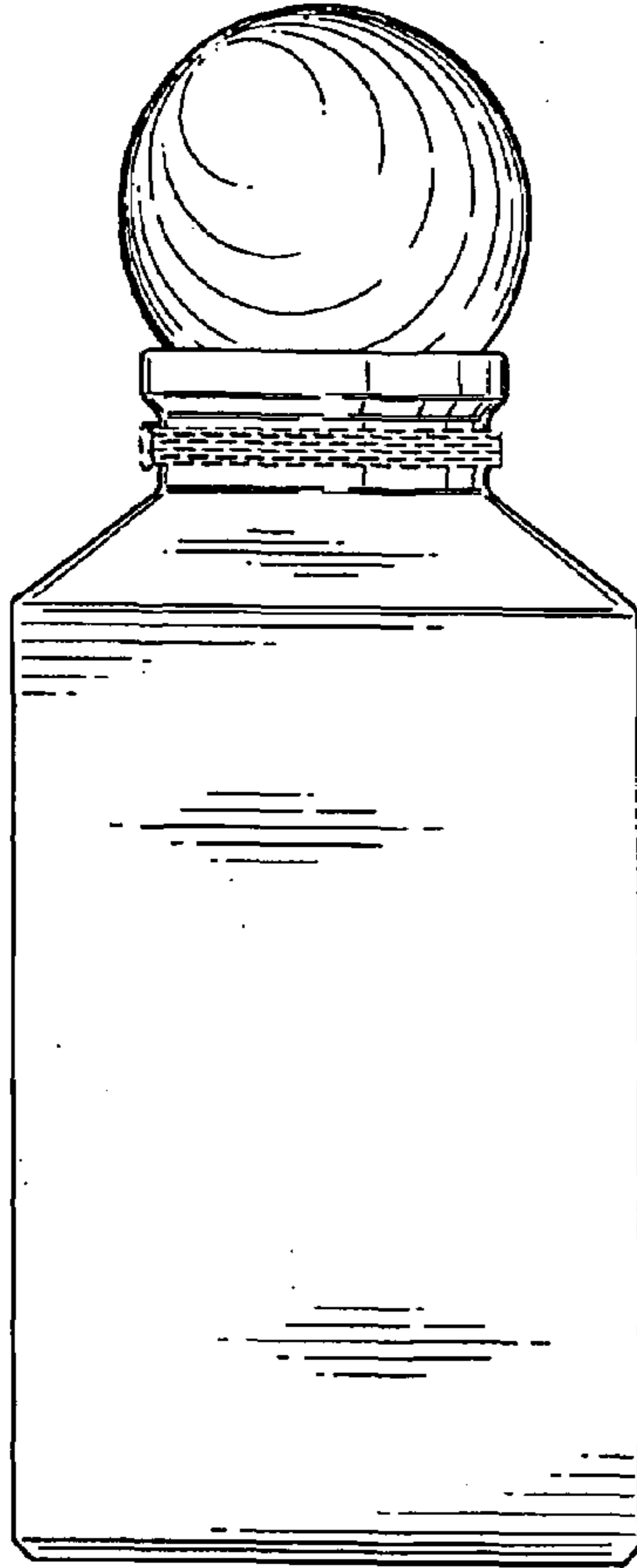

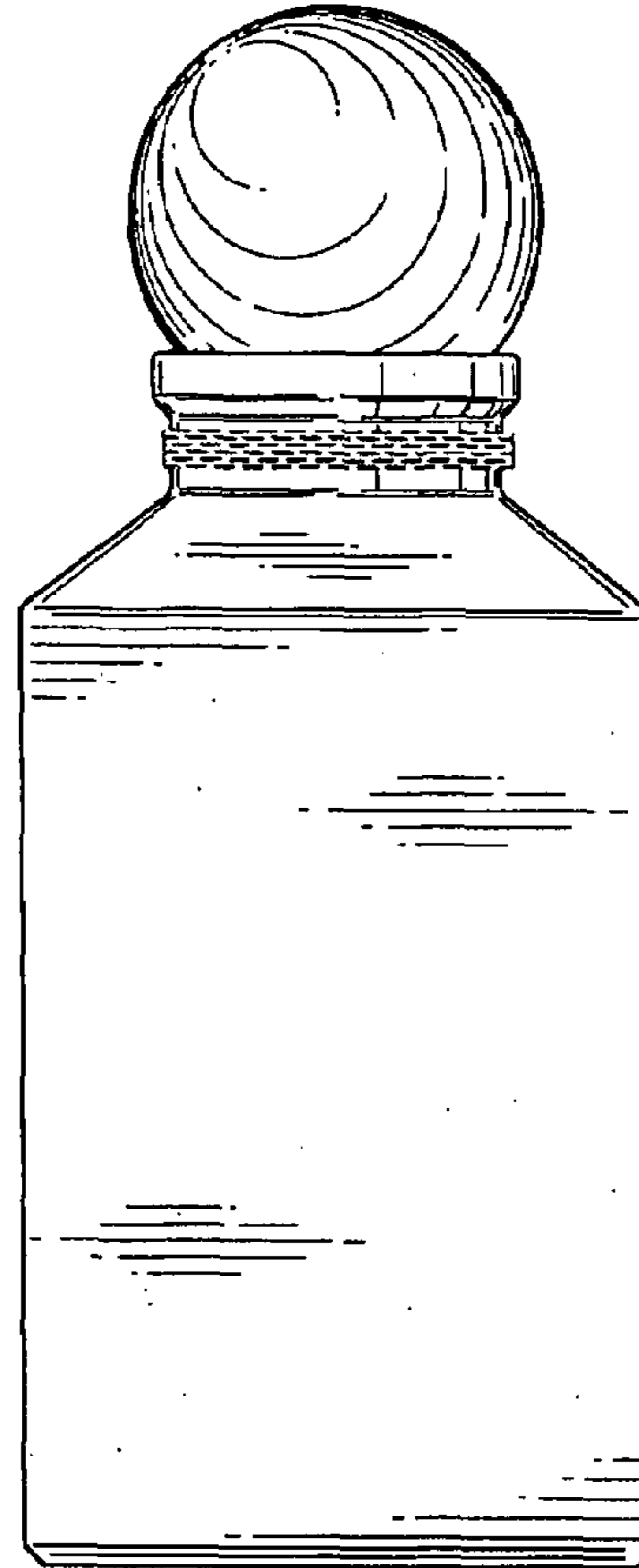

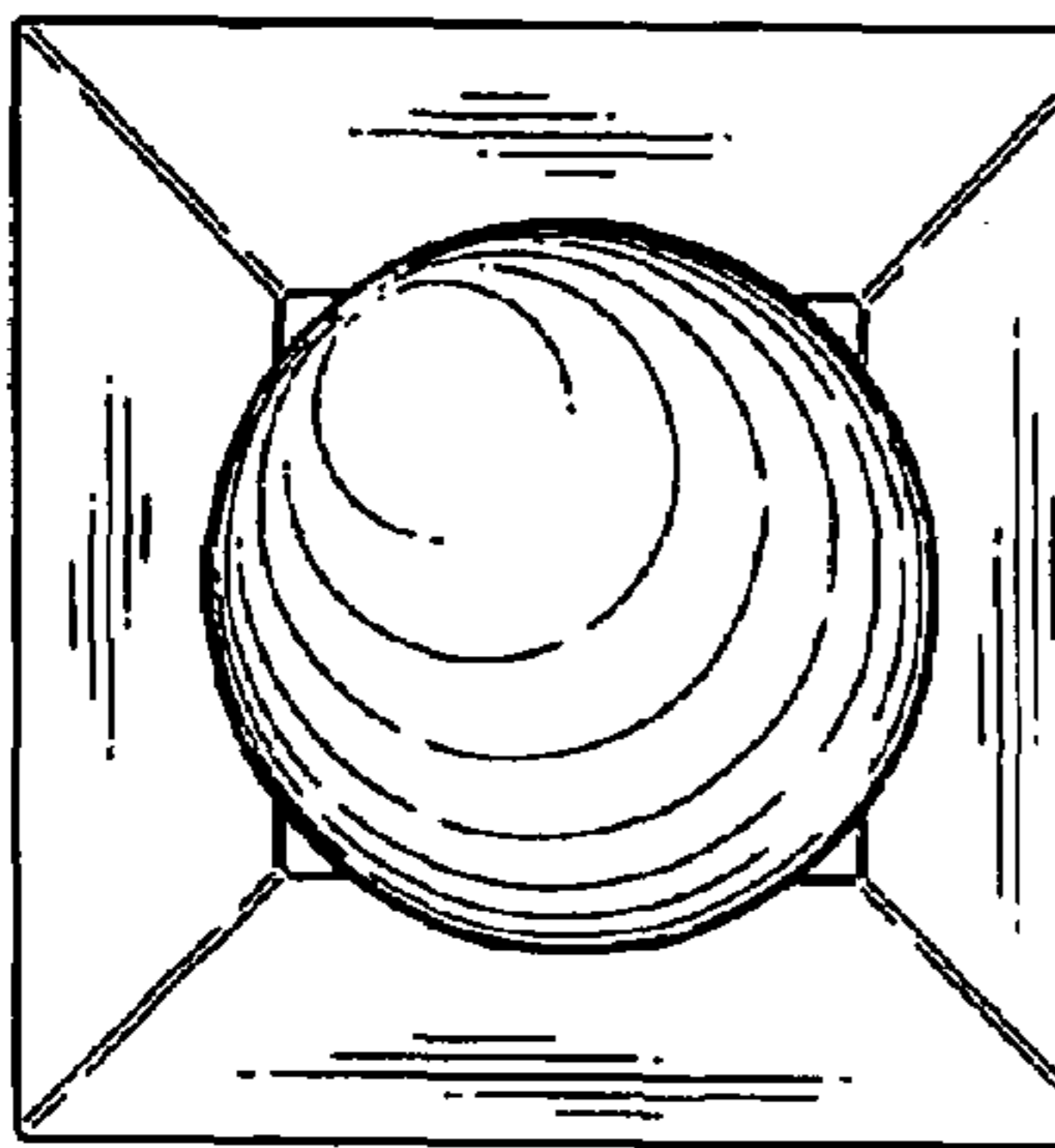

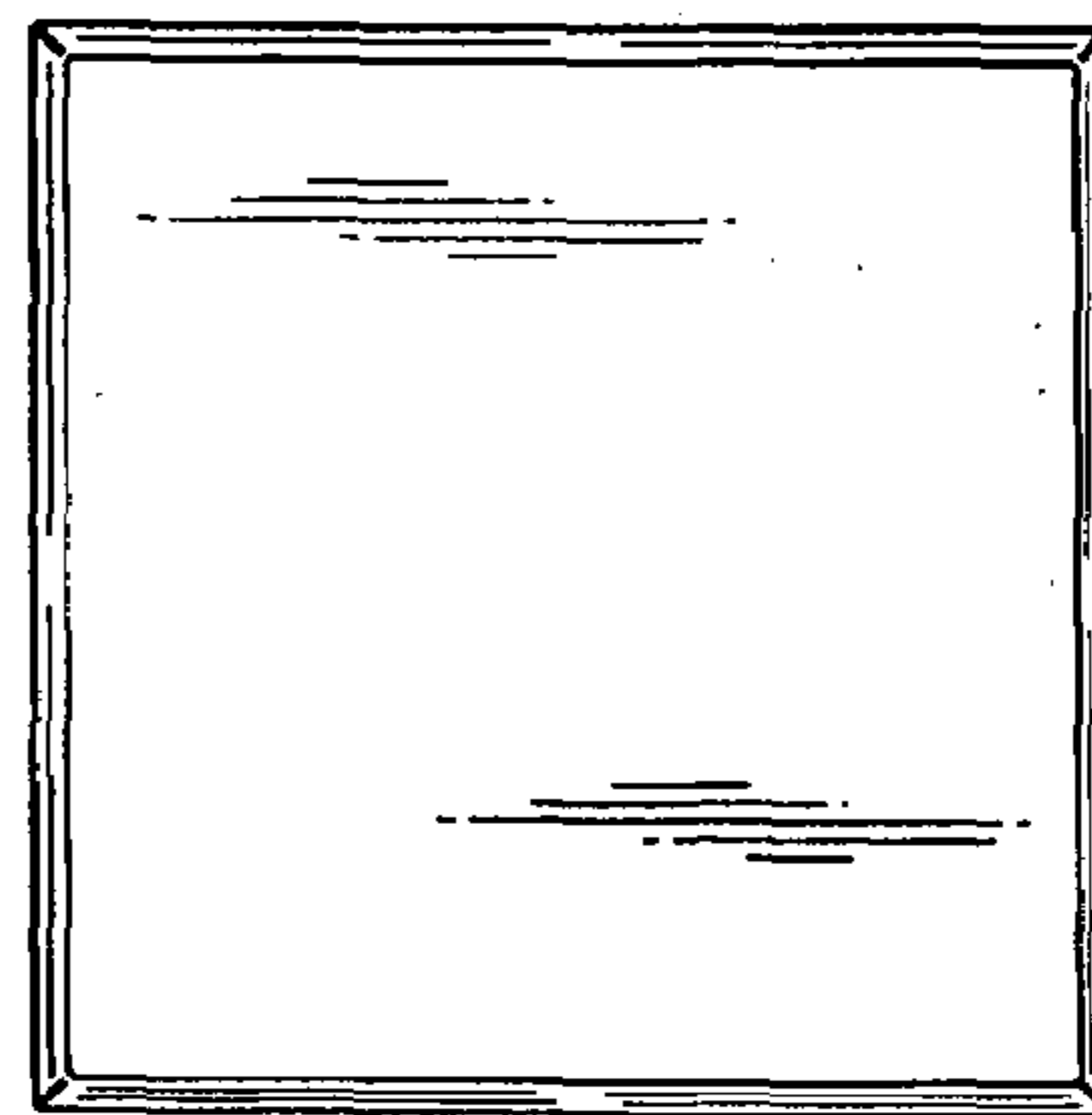
