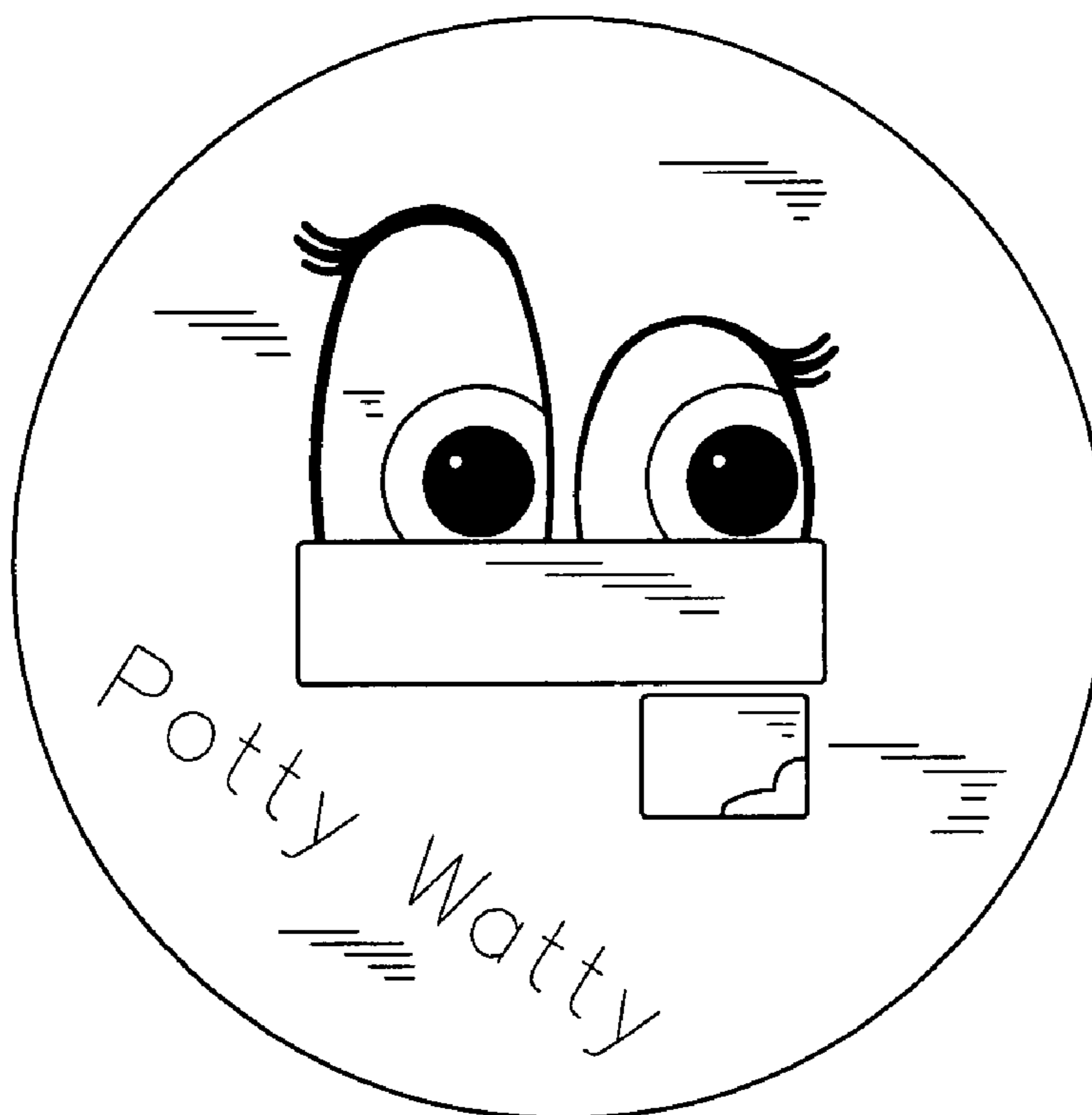
The ornamental design for a timepiece face, as shown.

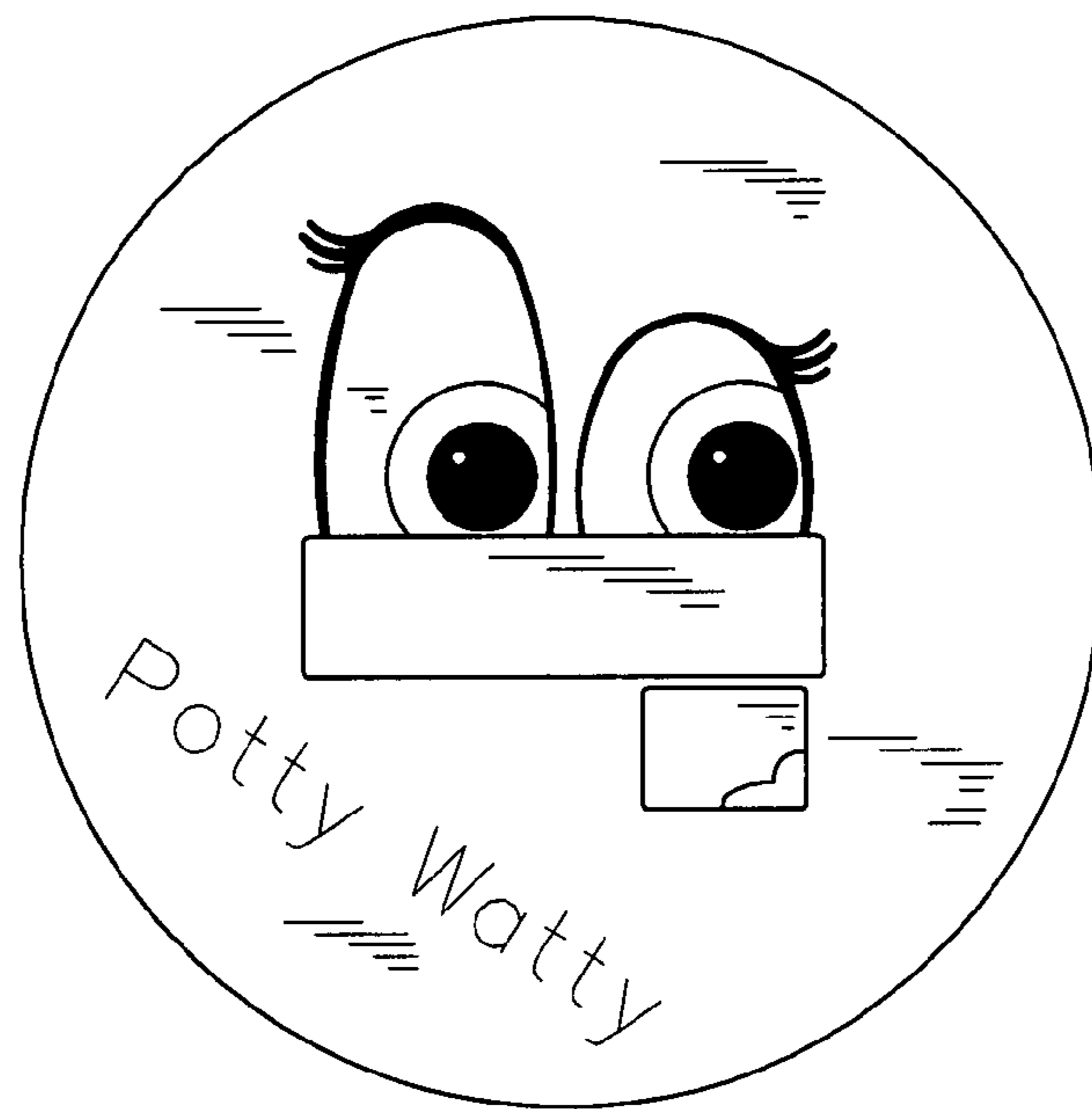
