(57) **CLAIM**

The ornamental design for a bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bracelet showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left elevational view thereof;

FIG. 5 is a front elevational view thereof, the opposite rear elevational view comprising a mirror image thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a perspective view of thereof, in use.

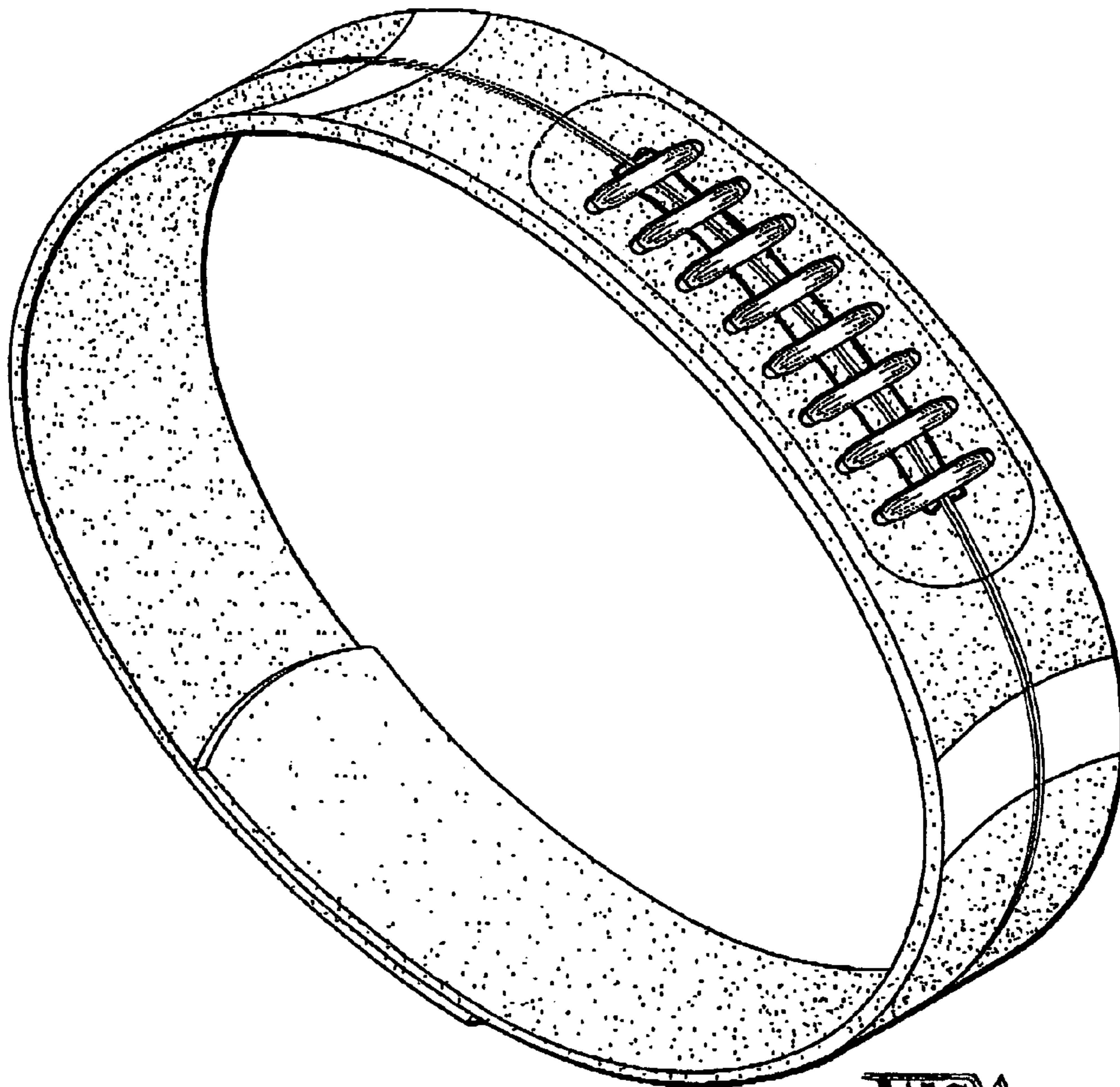

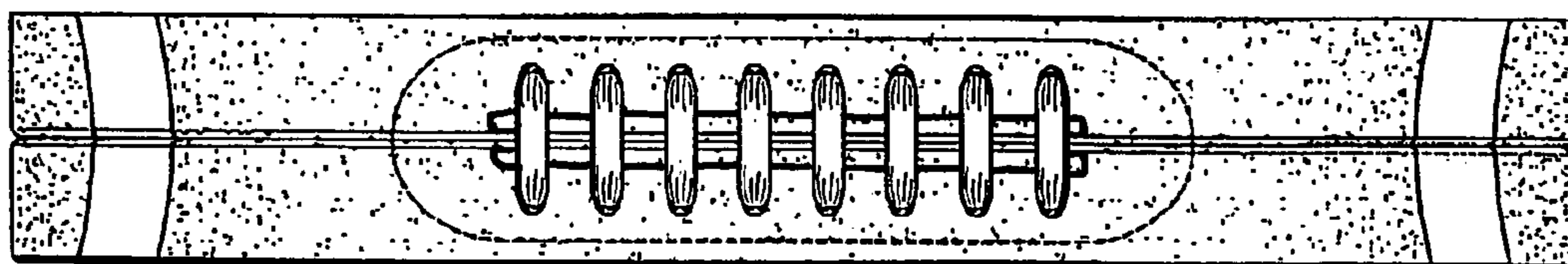

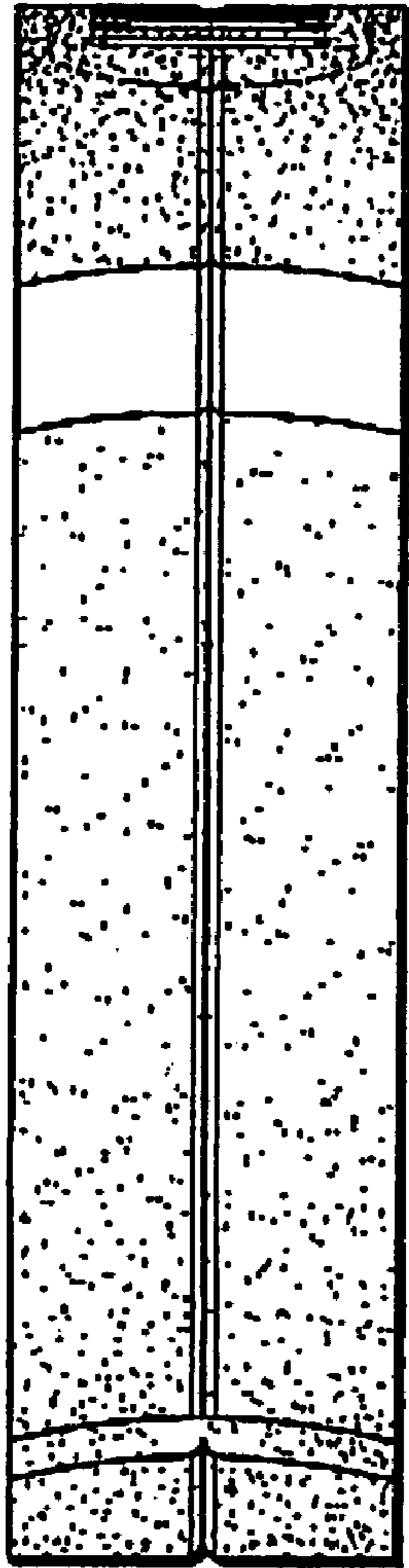

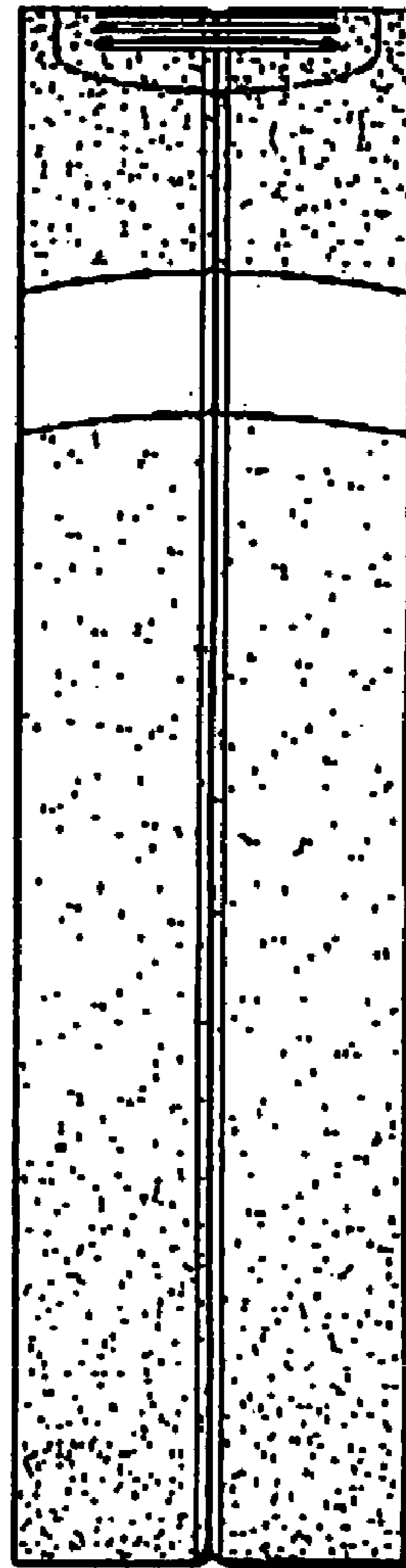

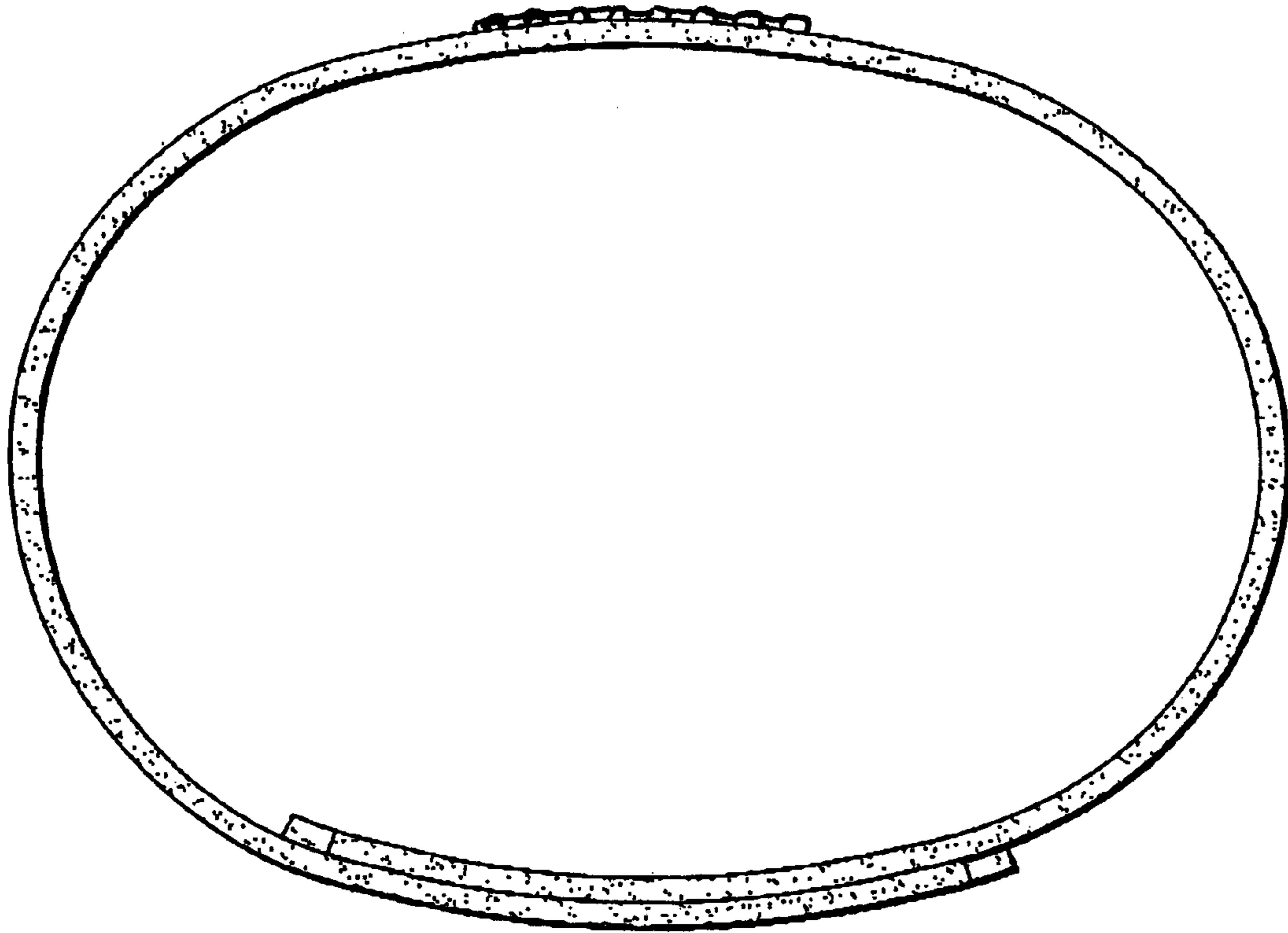
