FIG. 11 is an upper right front perspective view of a third embodiment;

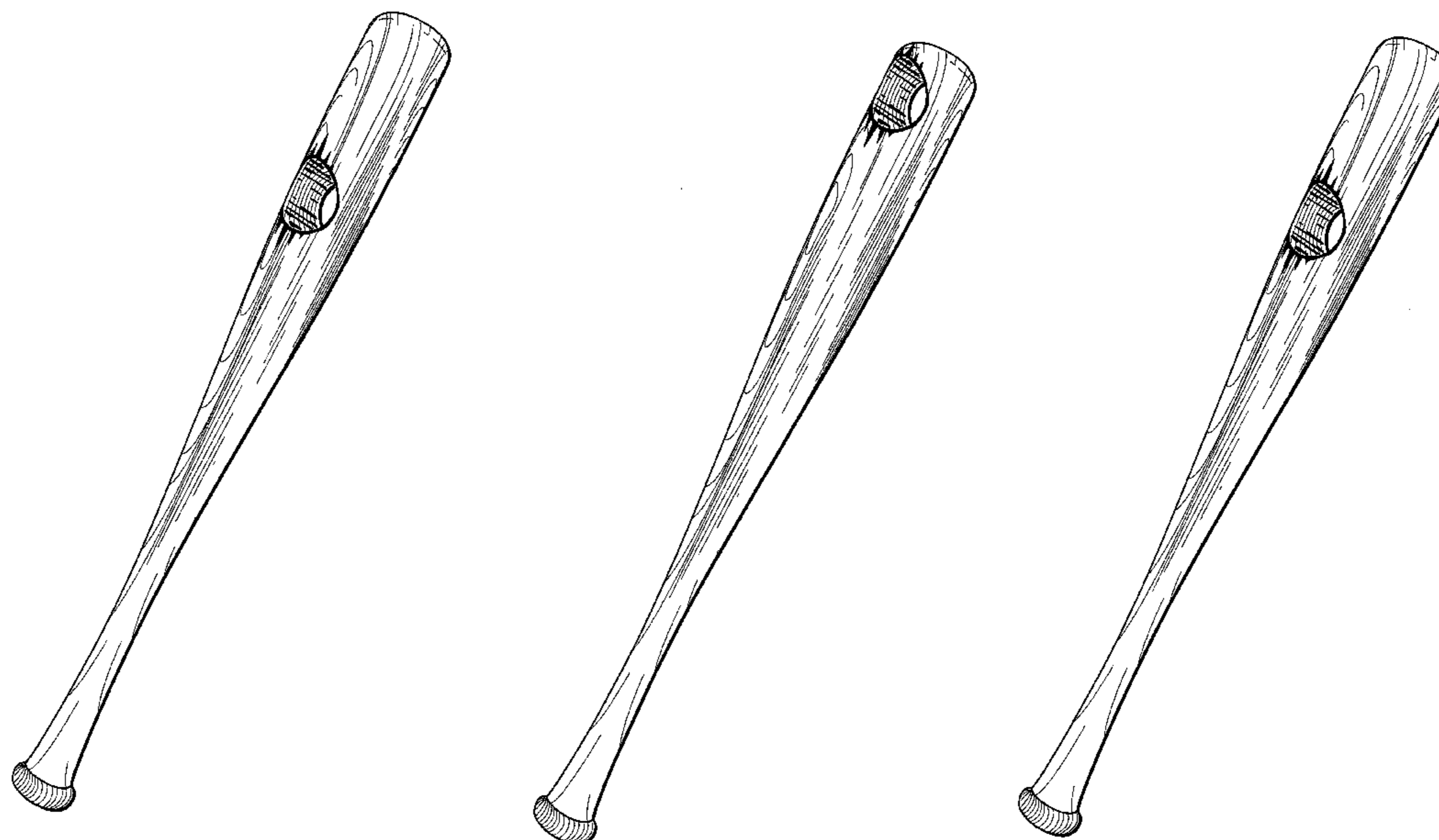
FIG. 12 is a front elevational view thereof;

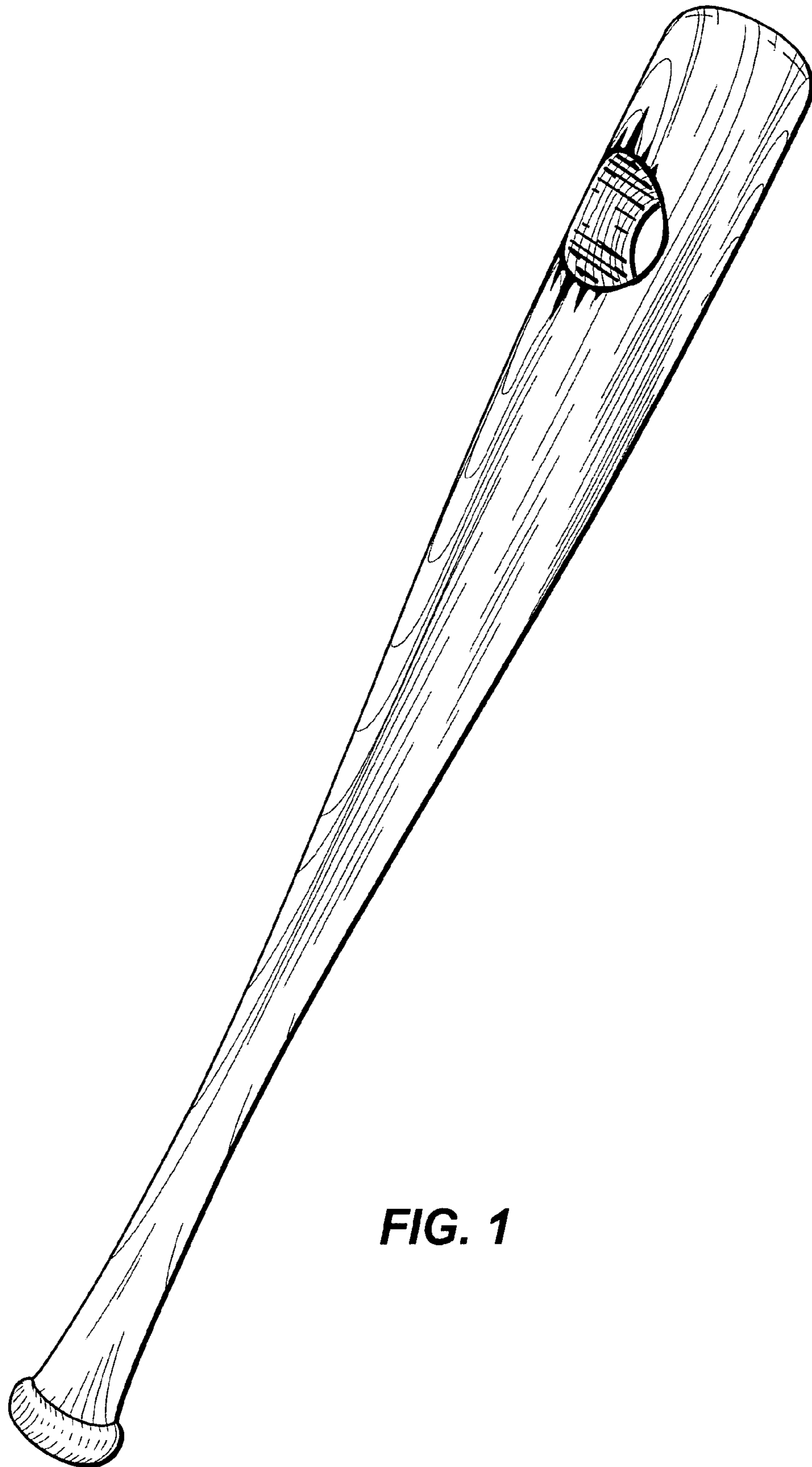

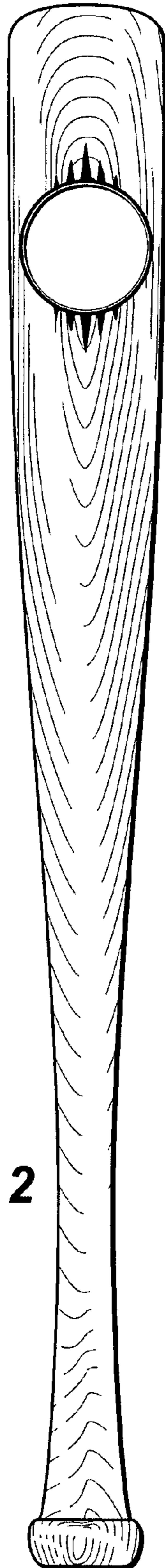

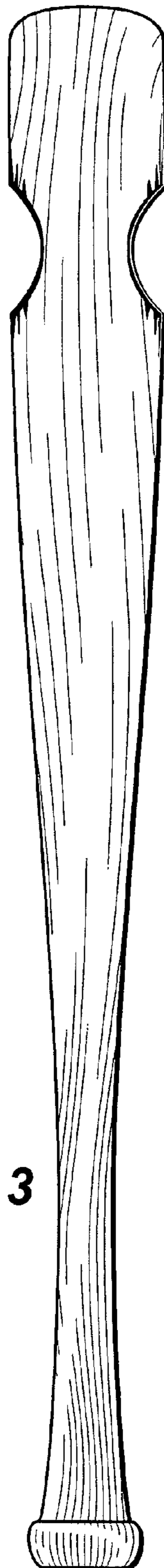

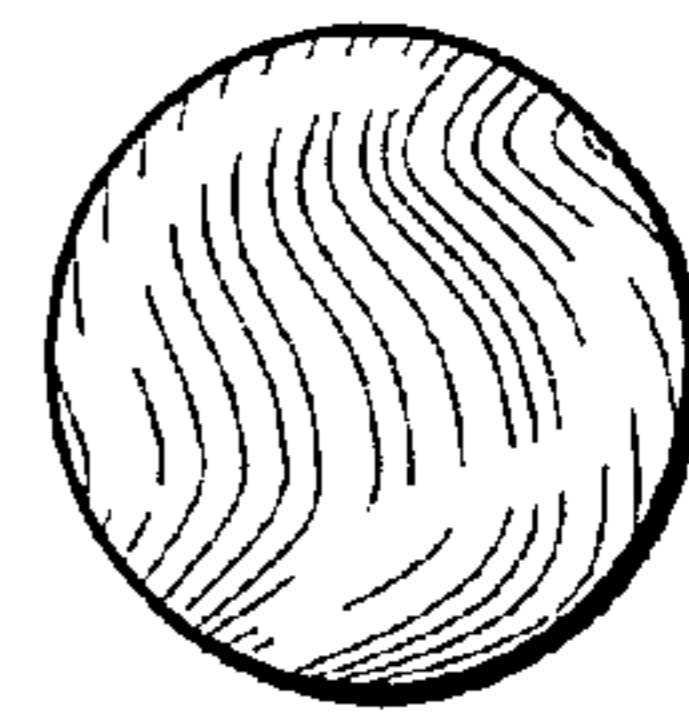

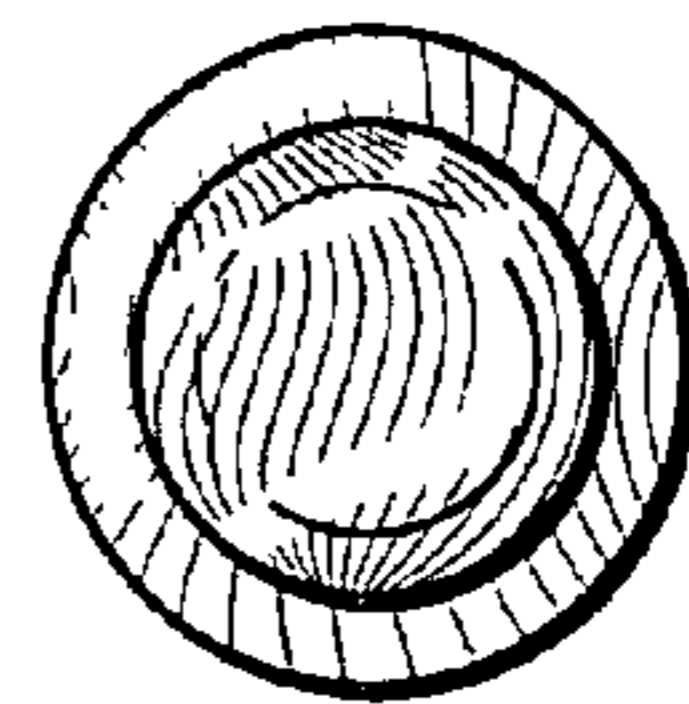

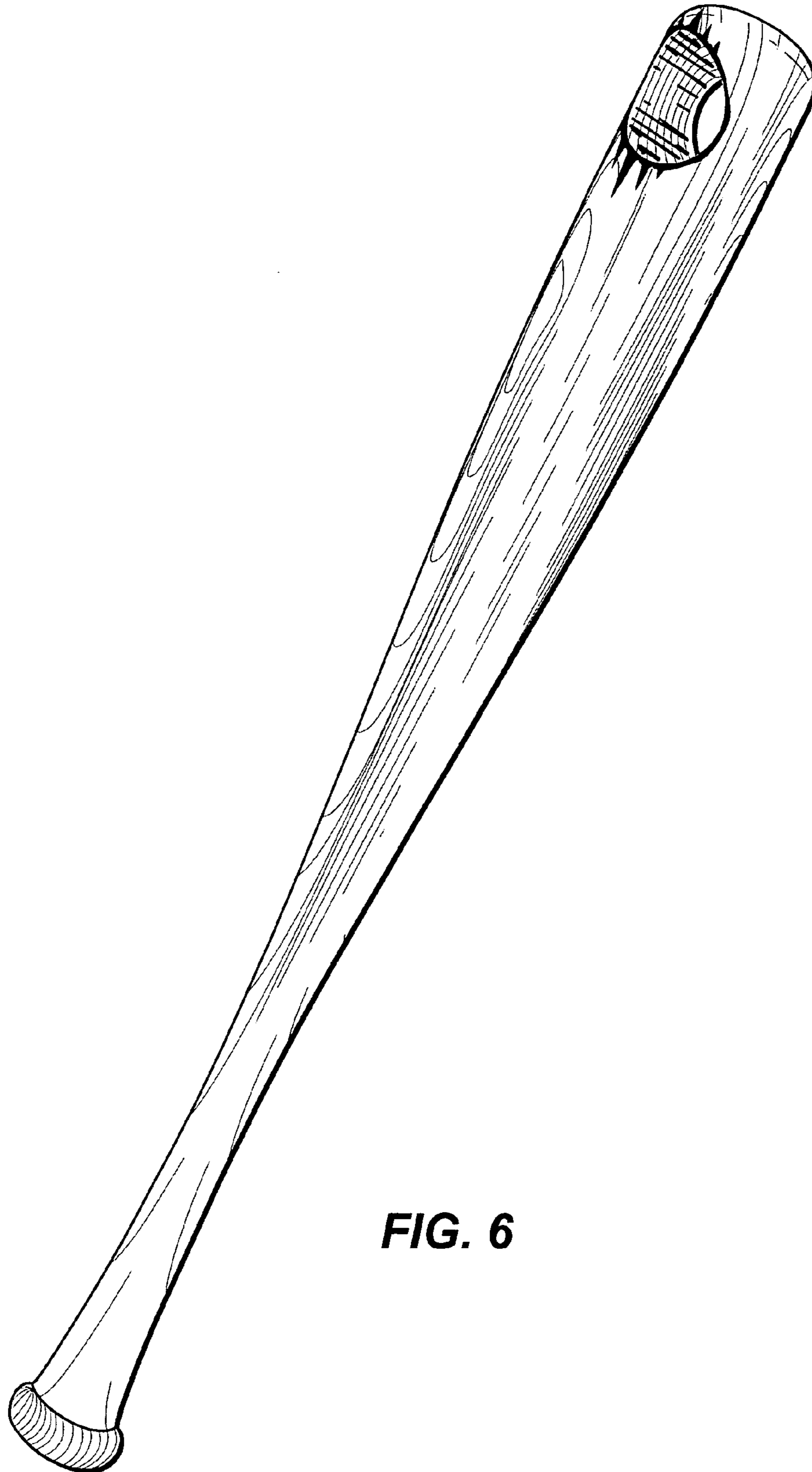

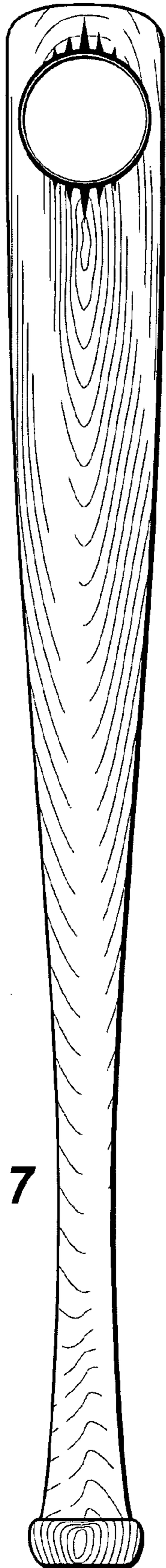

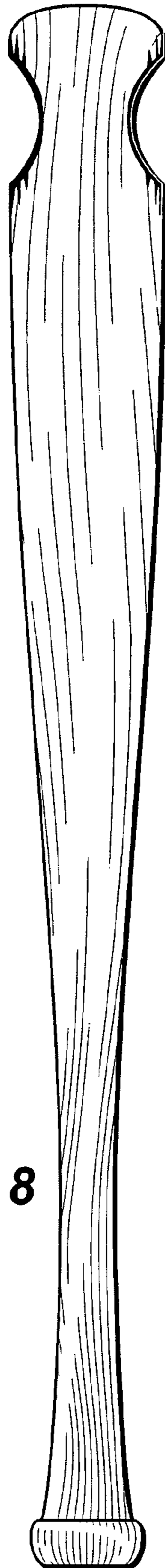

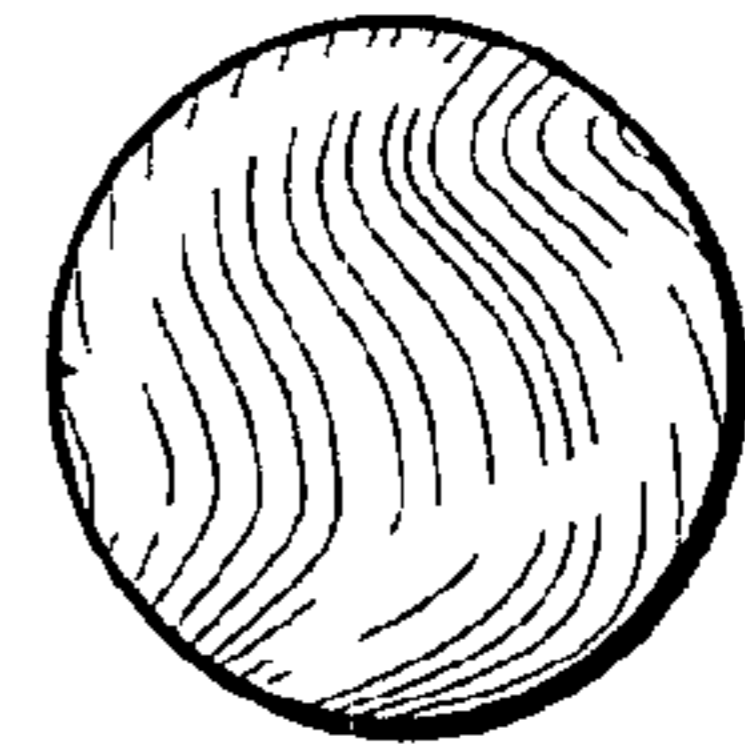

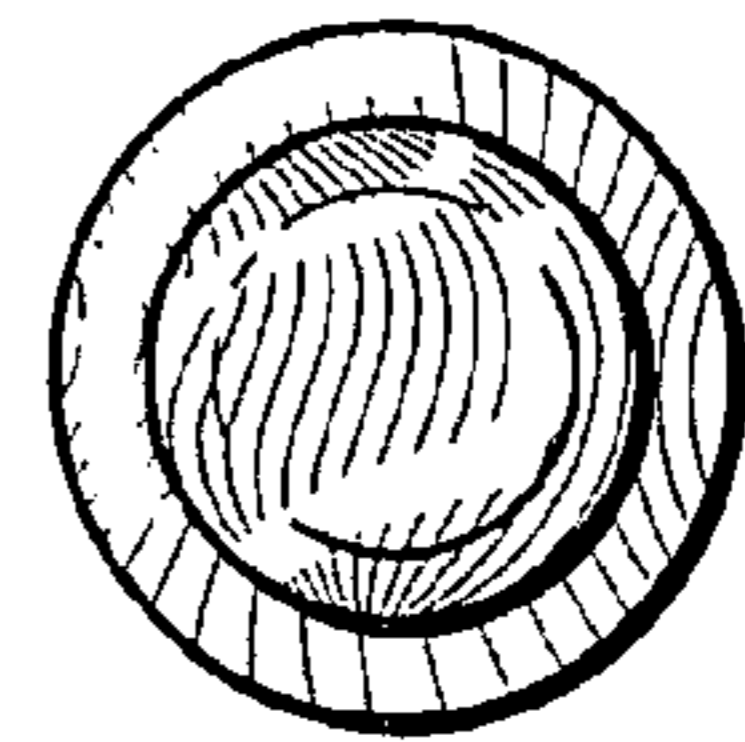

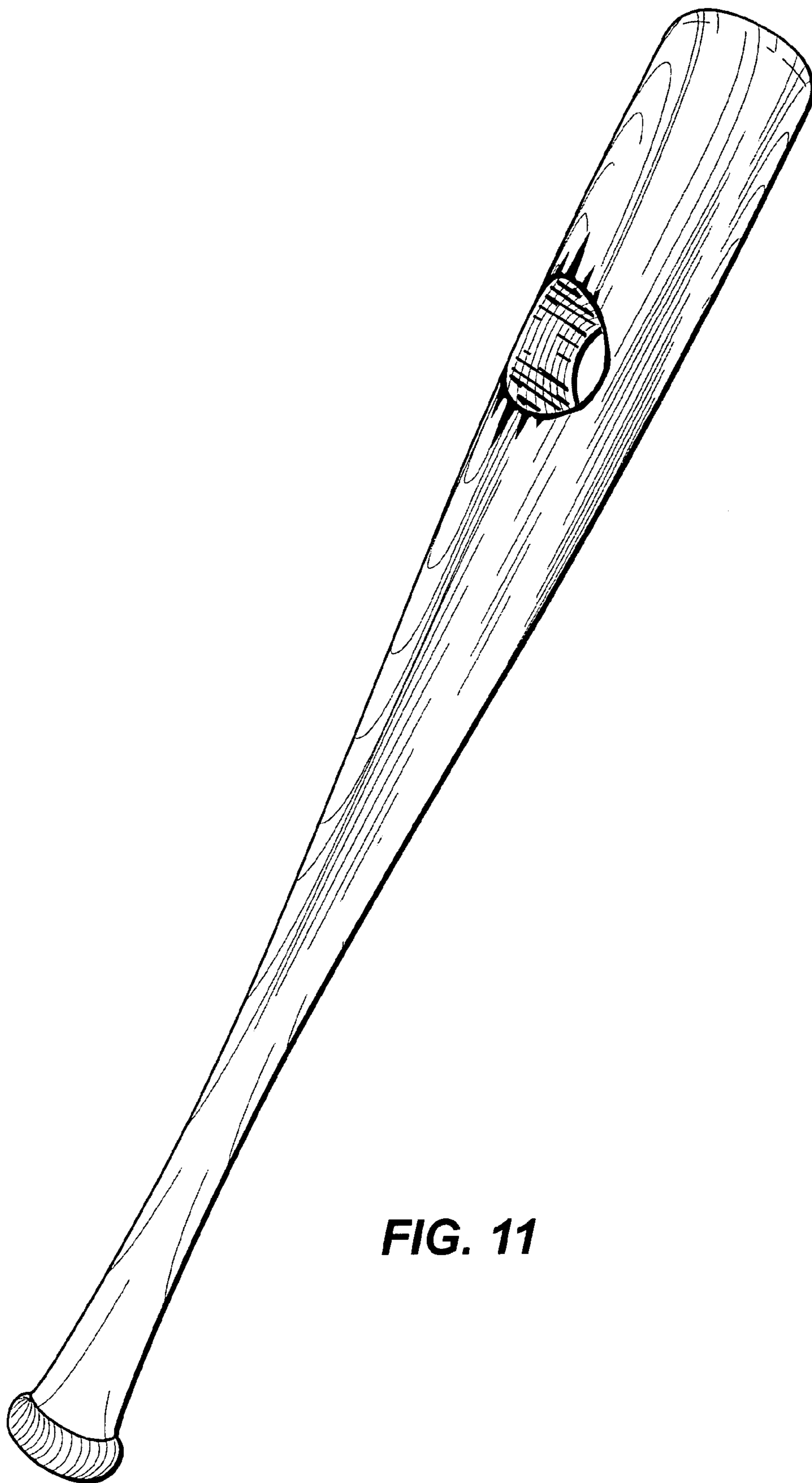

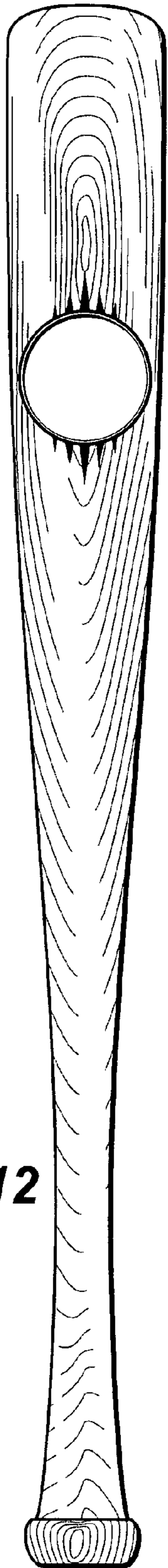

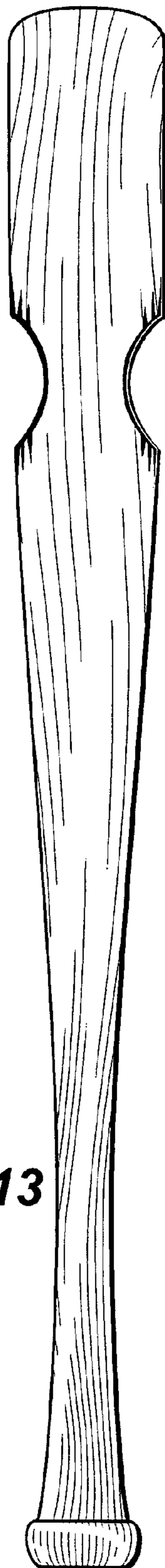

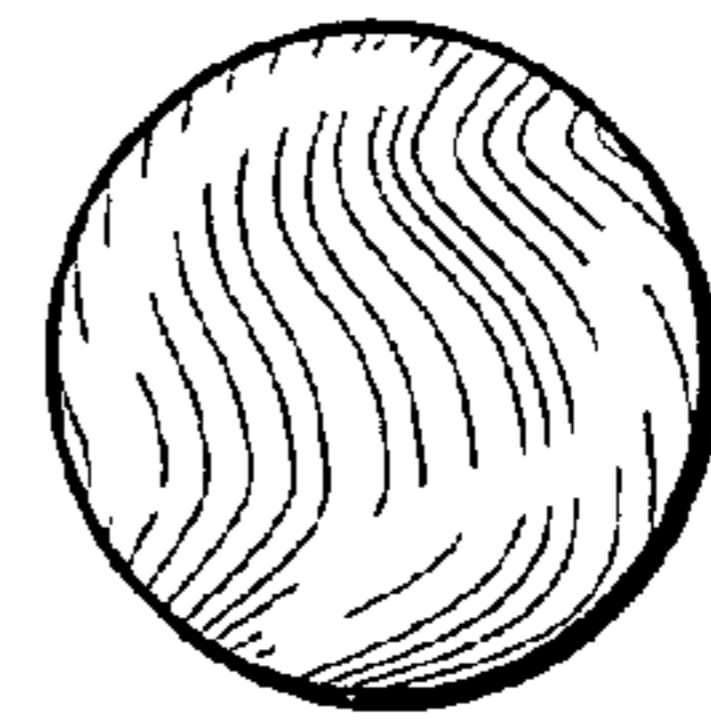

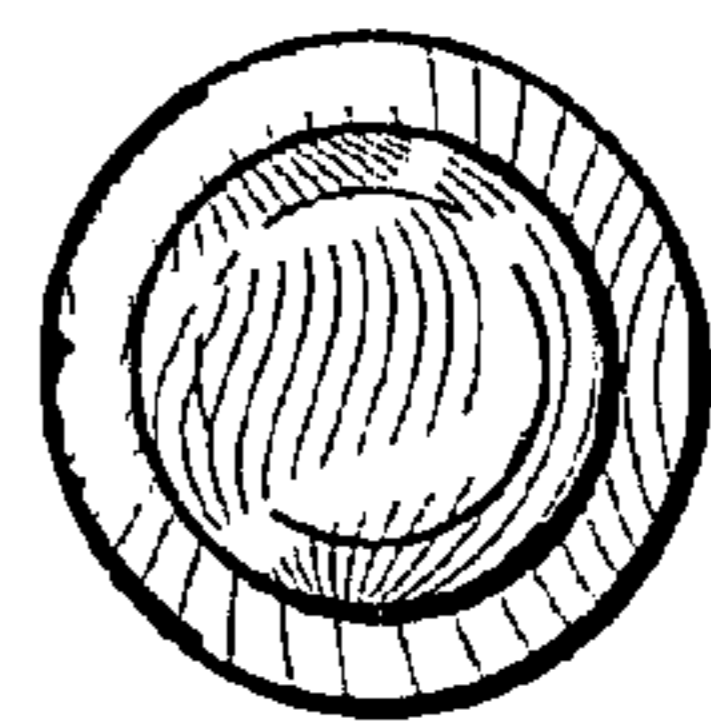
