1;

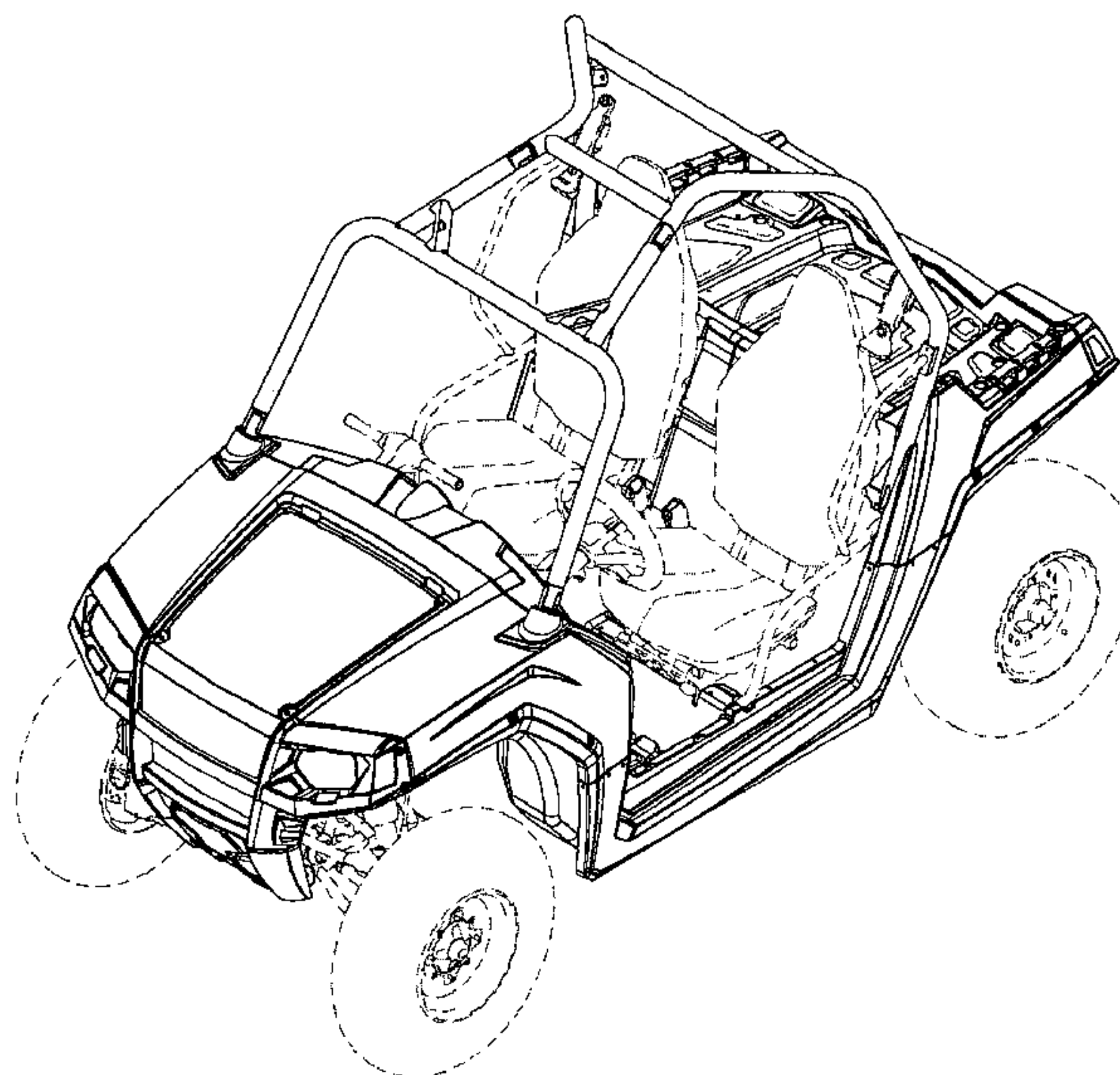
FIG. 5 is a bottom view of the all terrain vehicle shown in

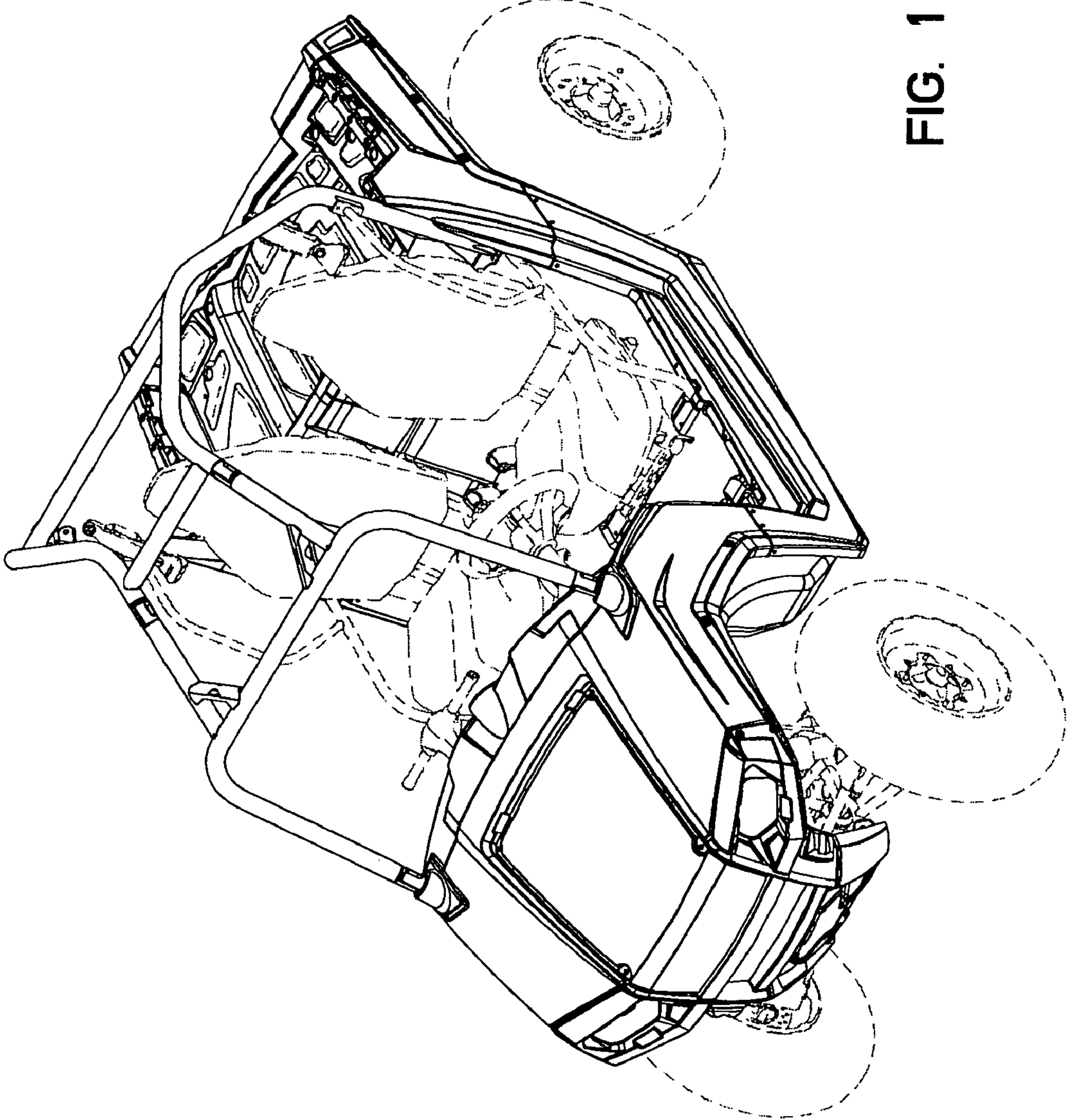

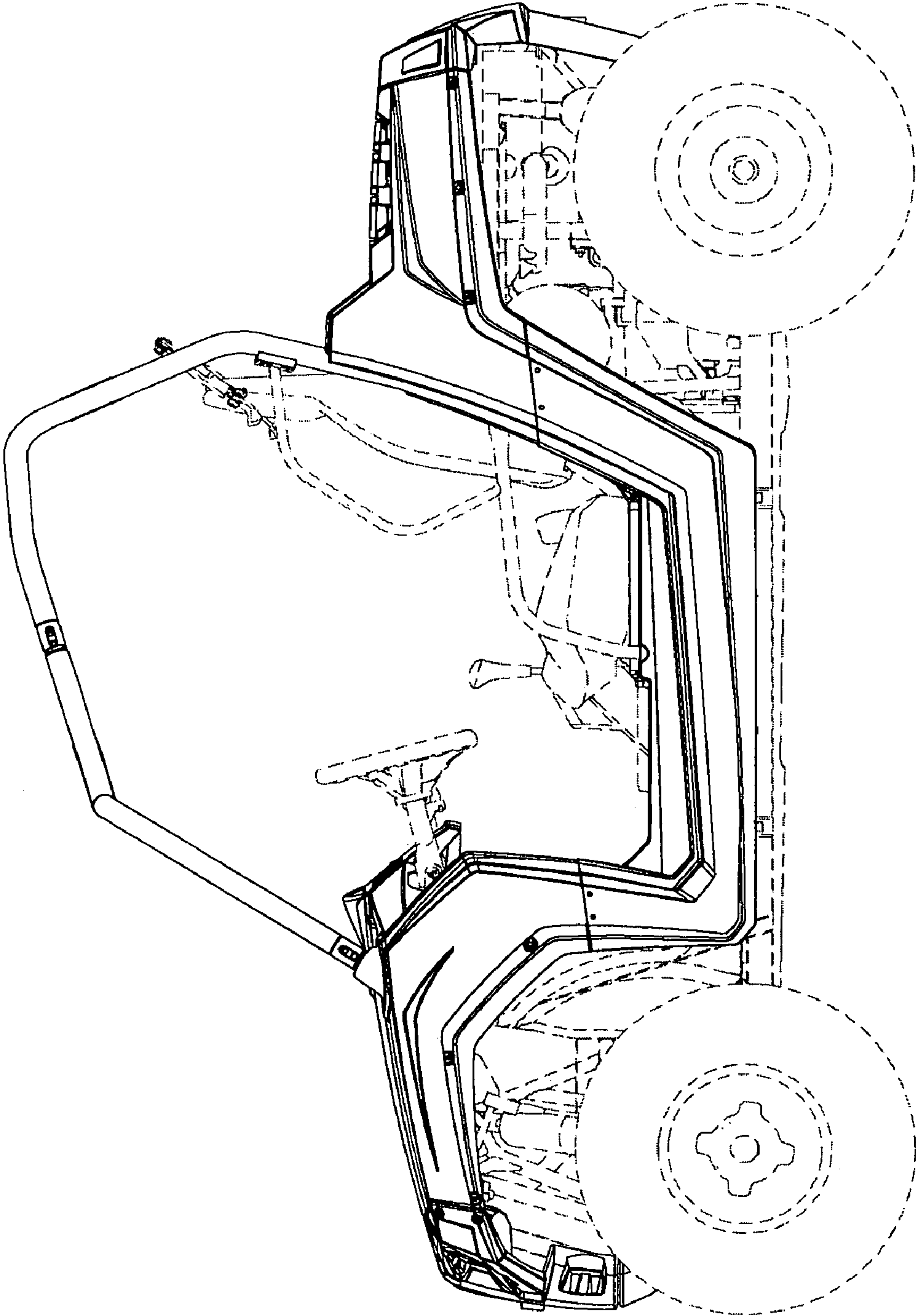

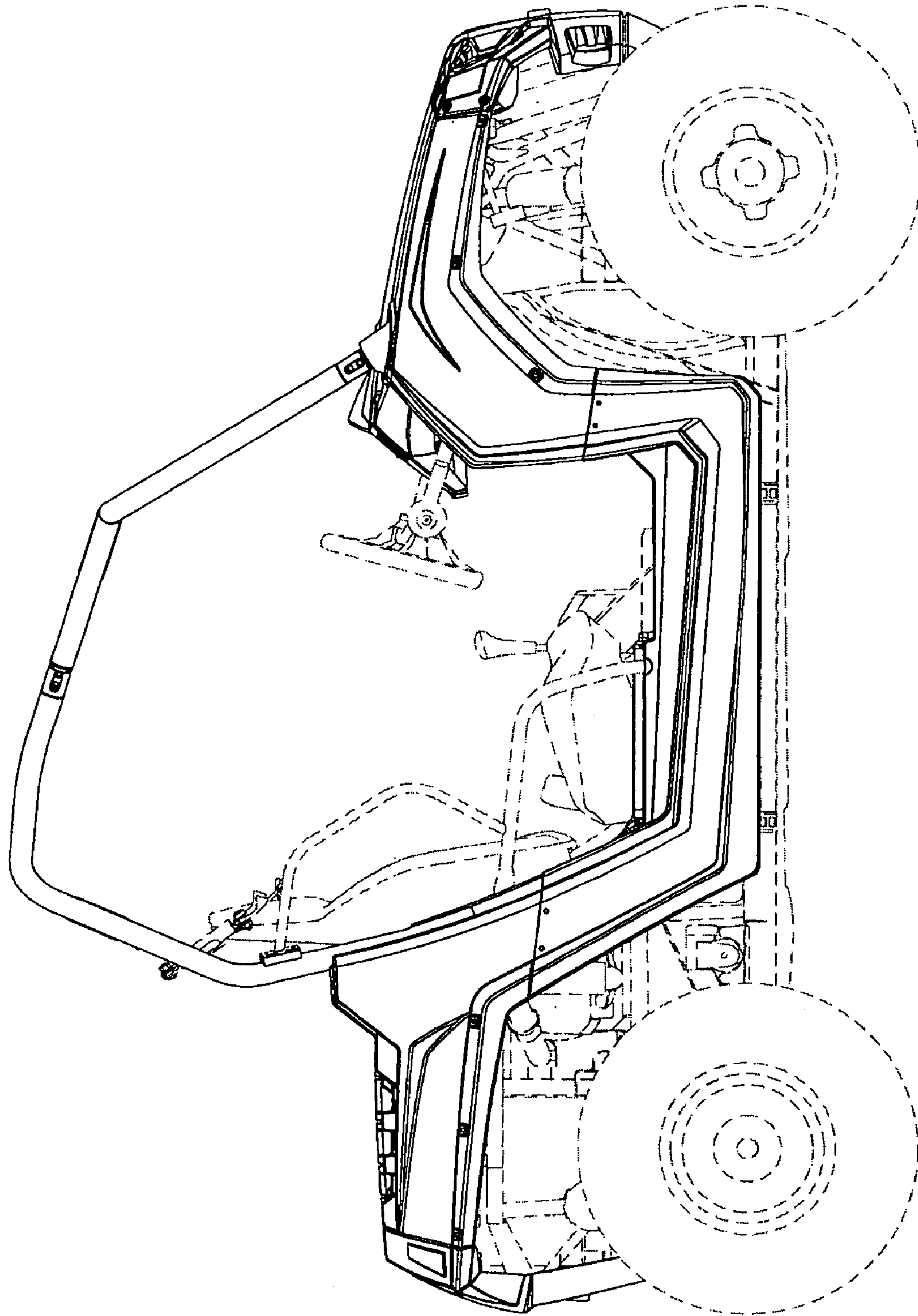

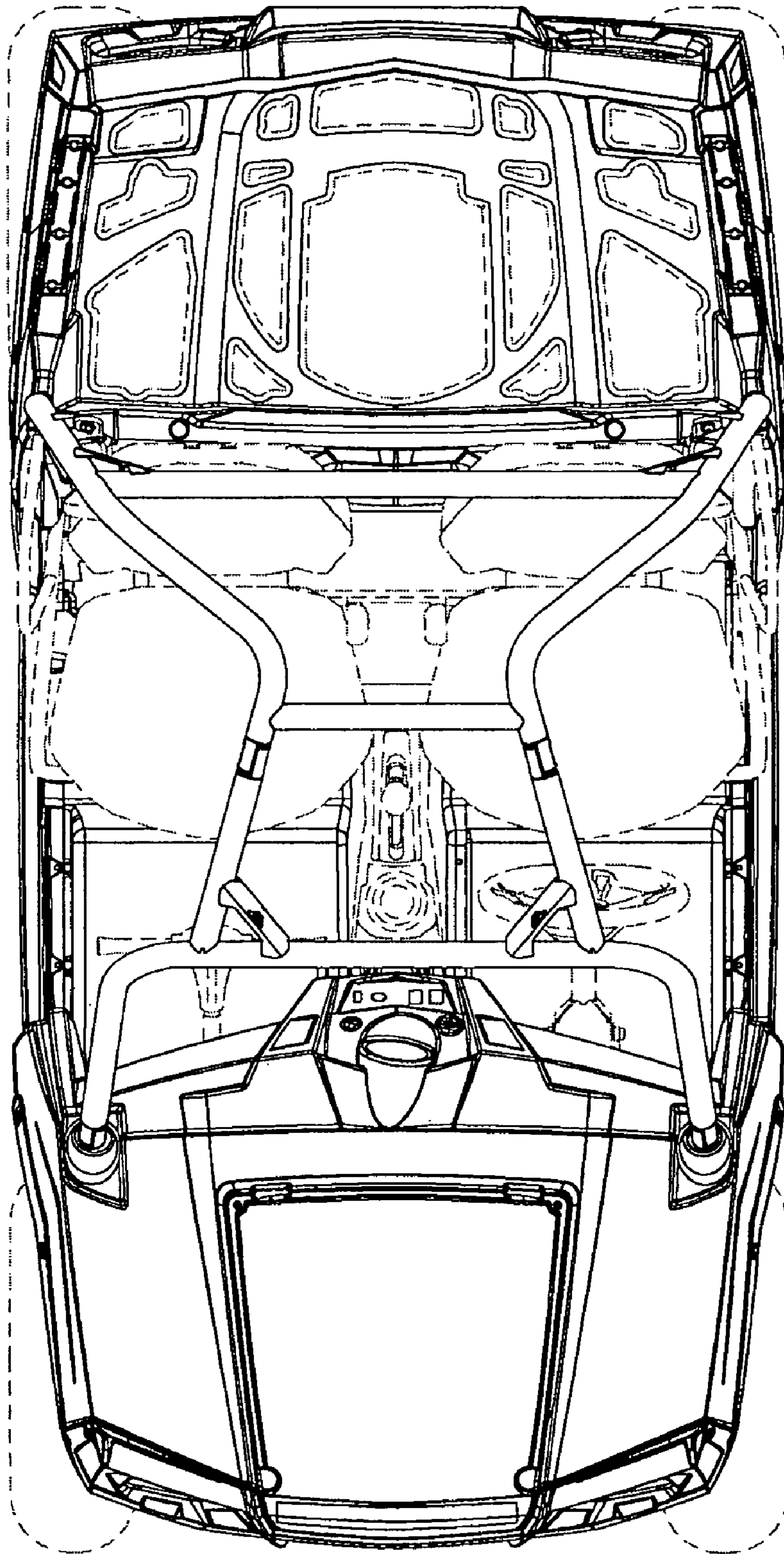

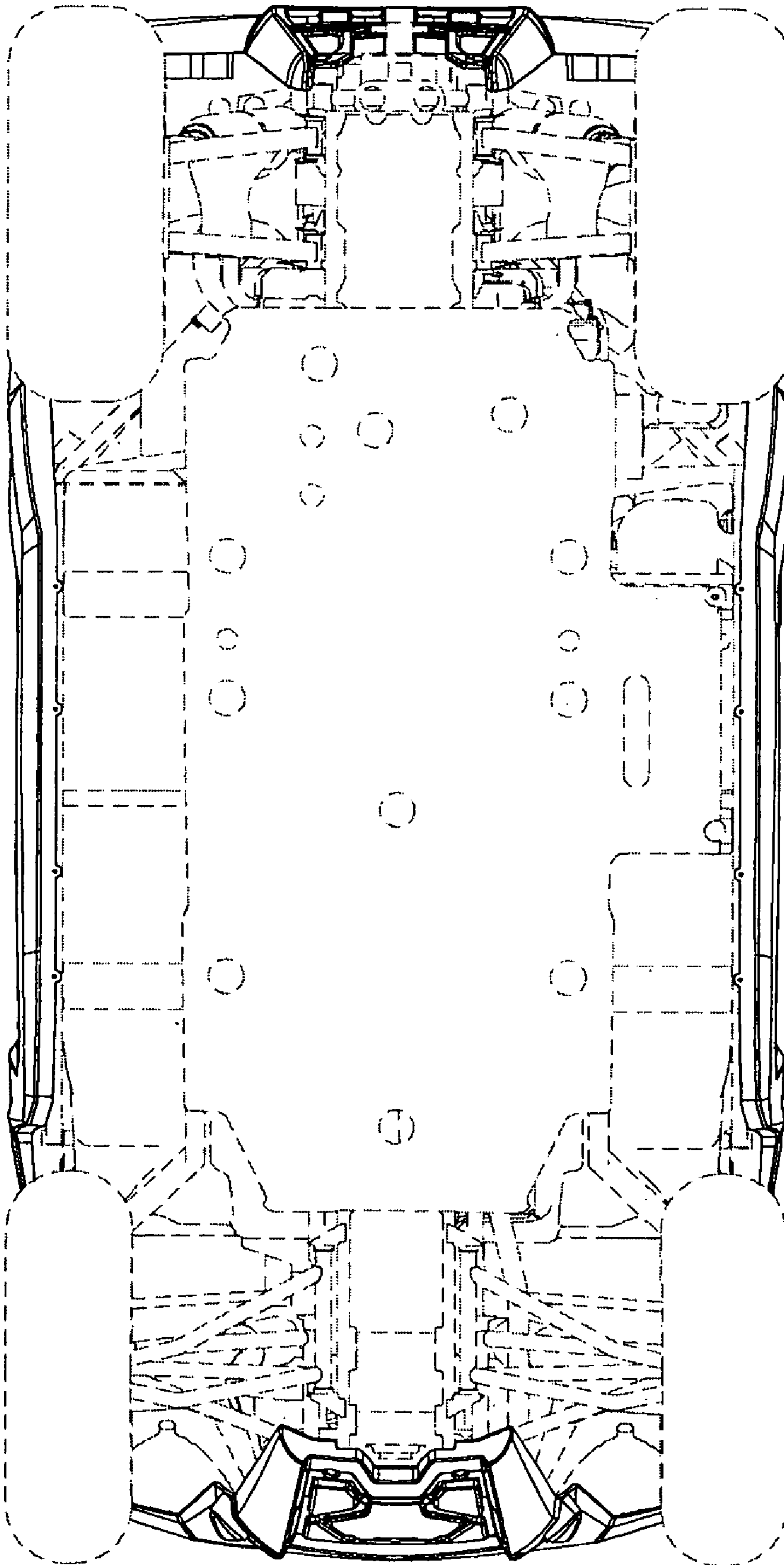

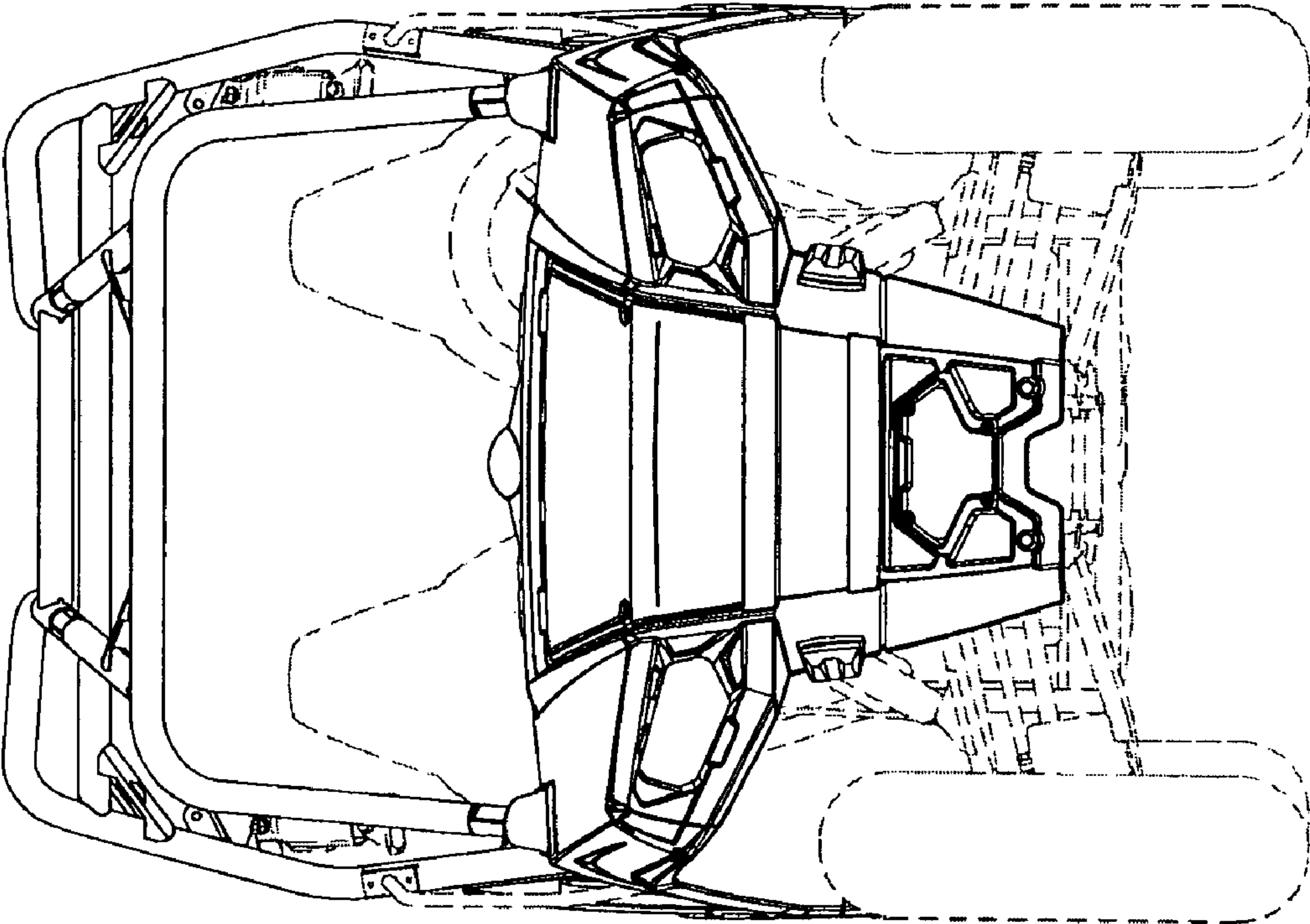

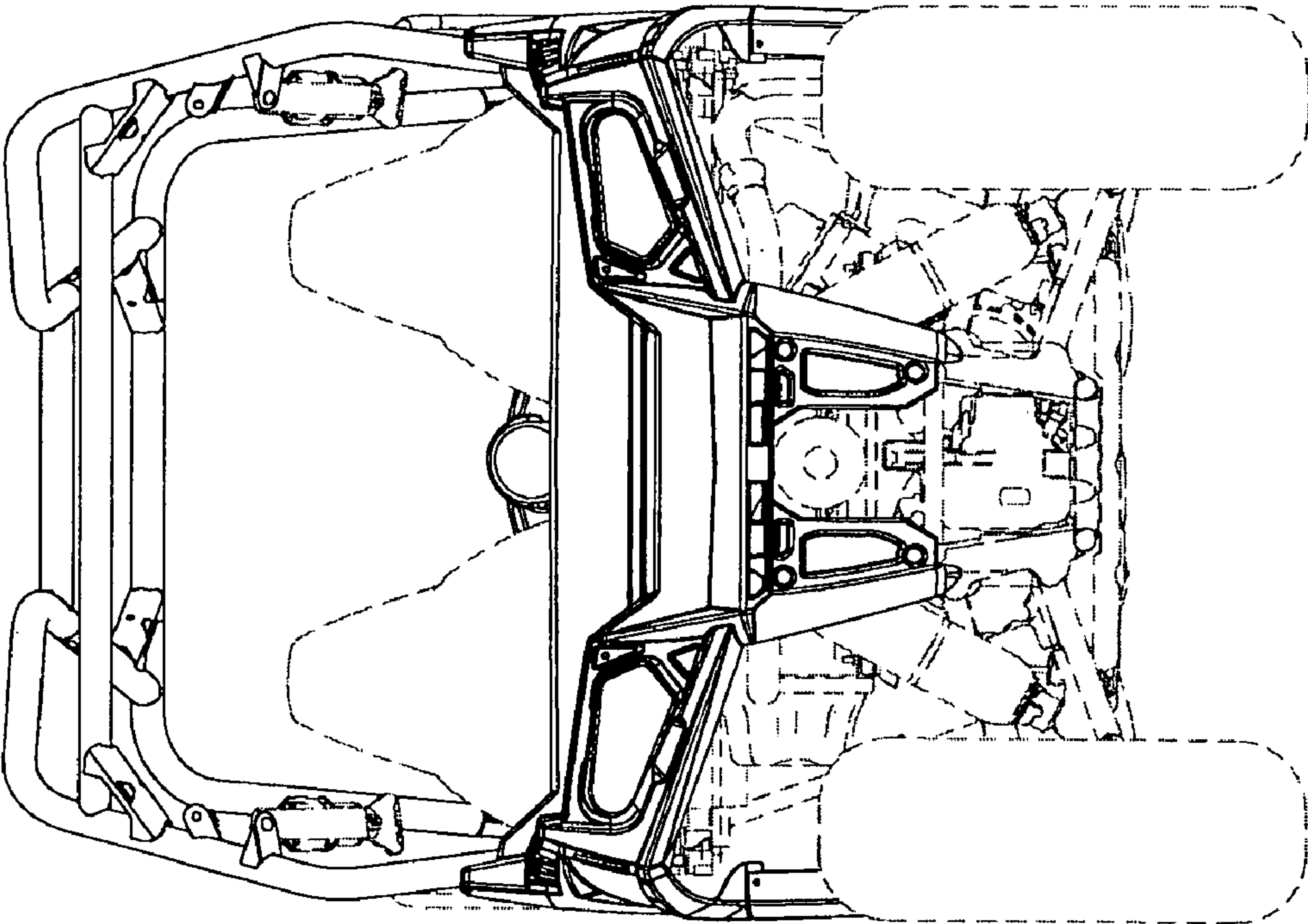
