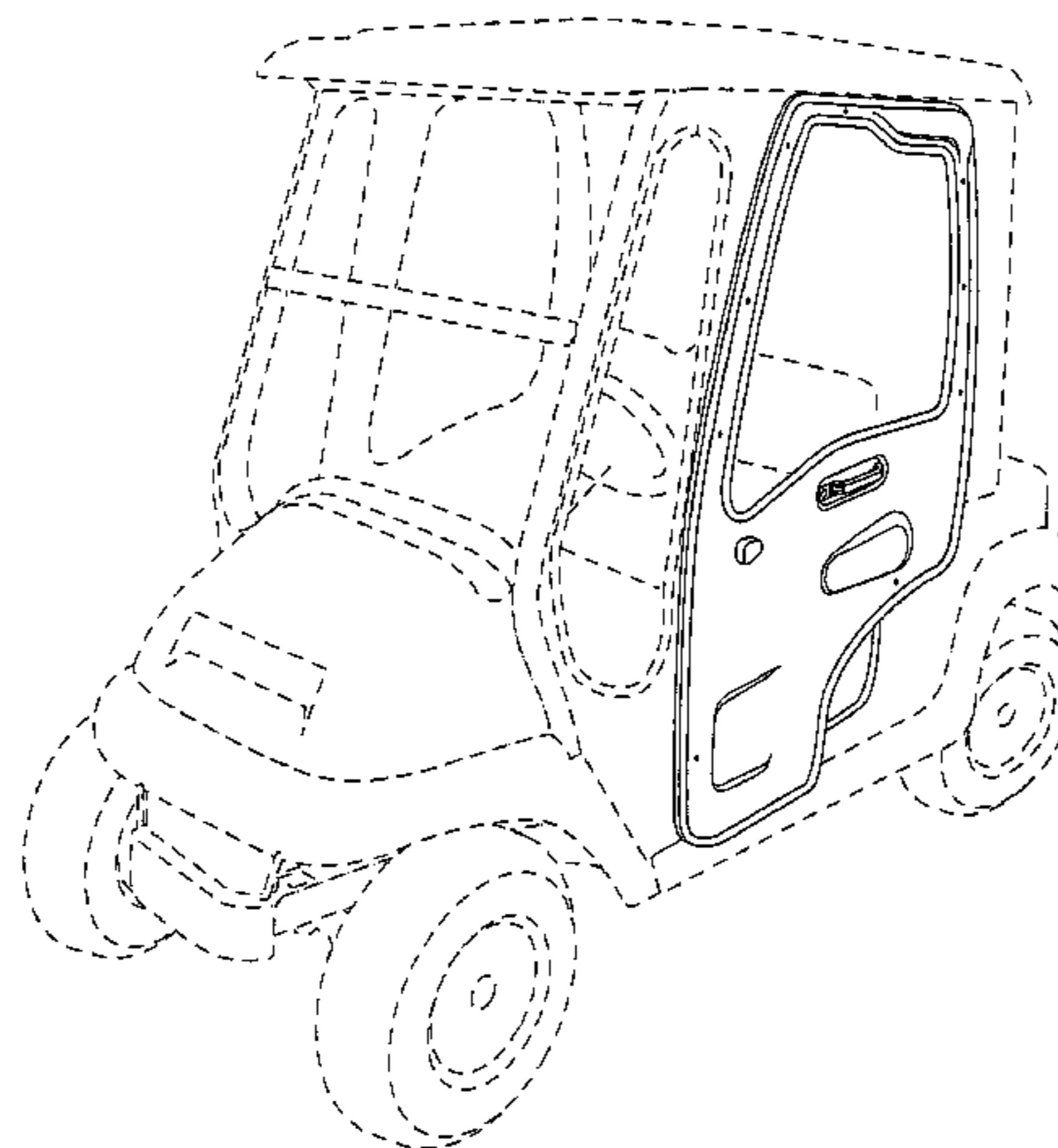
(57) **CLAIM**

The ornamental design for a door for utility vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the door for utility vehicle of the present invention;  
FIG. 2 is a front view of the door of the present invention;  
FIG. 3 is a side view of the door of the present invention;  
FIG. 4 is an opposite side view of the door of the present invention;  
FIG. 5 is a top view of the door of the present invention;  
FIG. 6 is a bottom view of the door of the present invention;  
FIG. 7 is a perspective view of the door of the present invention in an open position on a golf cart; and,  
FIG. 8 is a perspective view of the door of the present invention in a closed position on a golf cart.

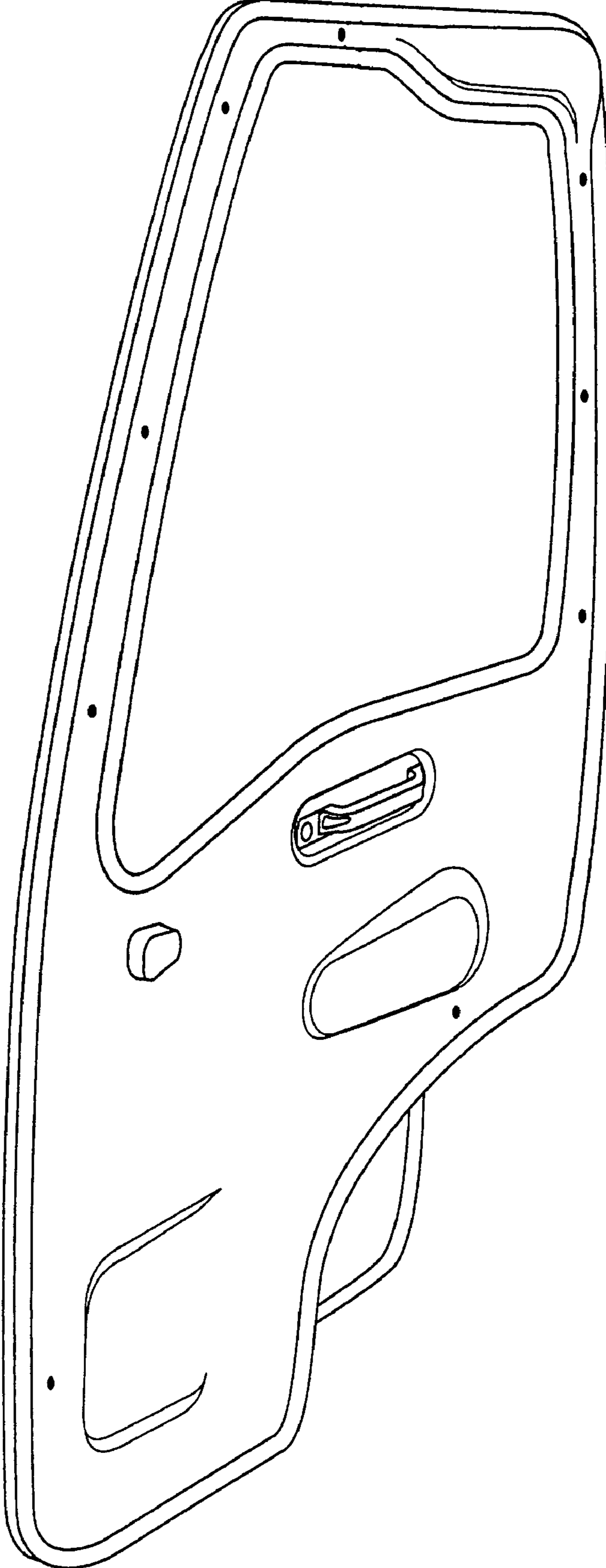

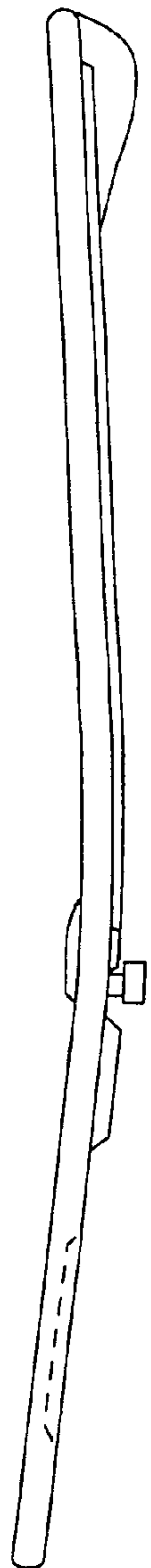
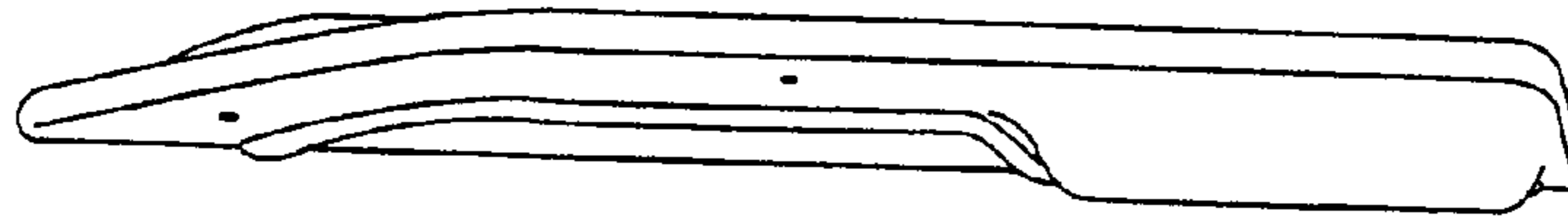

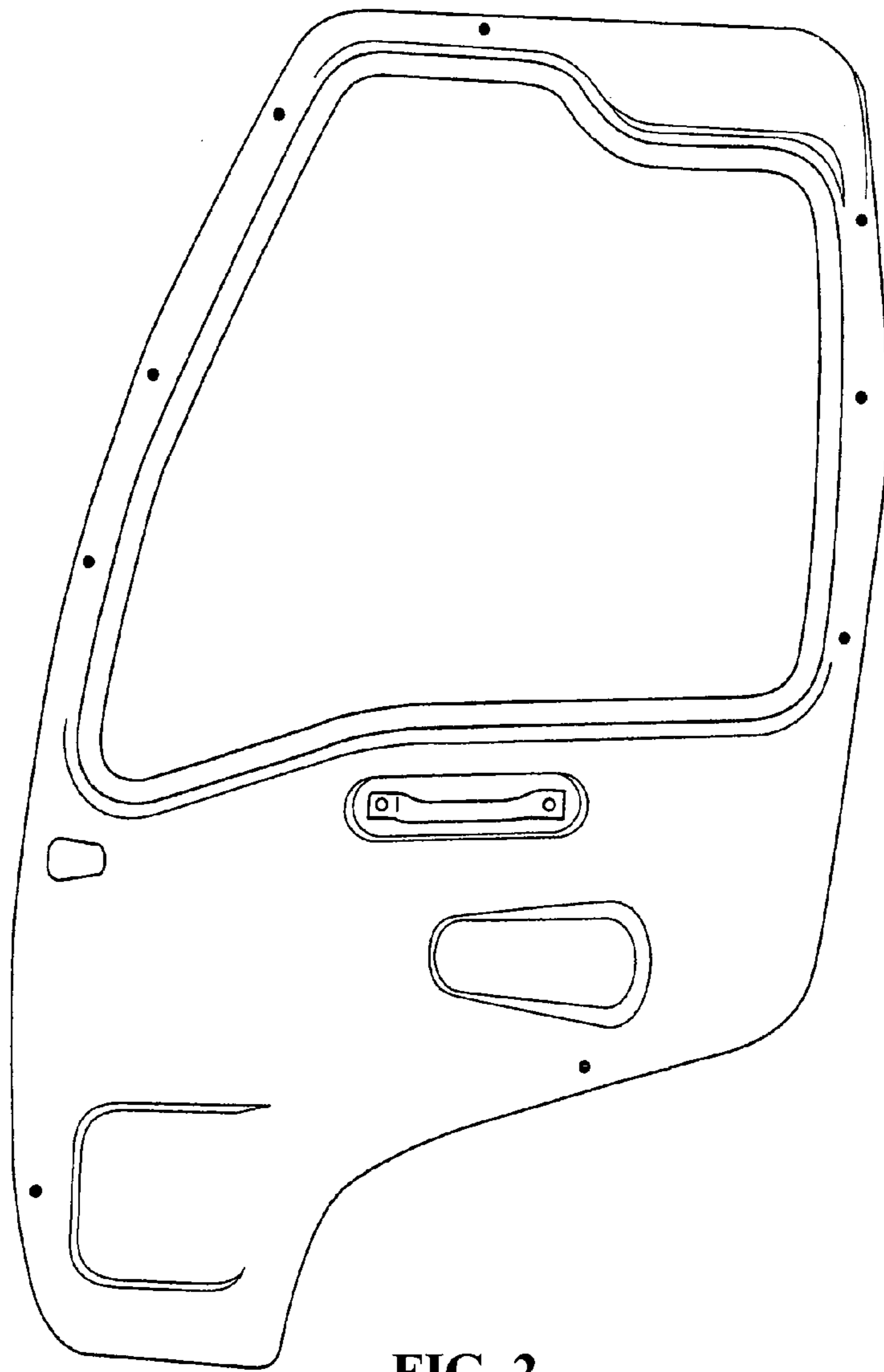

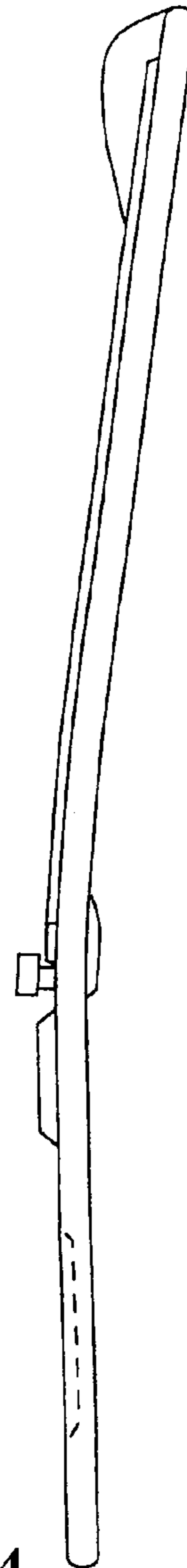

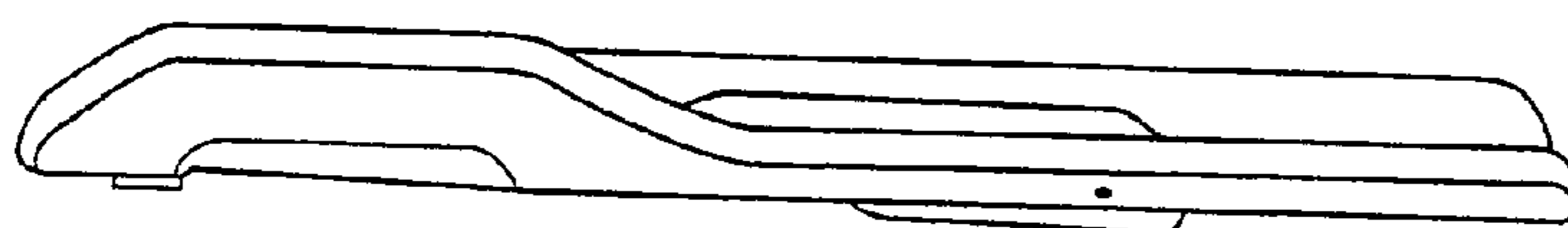

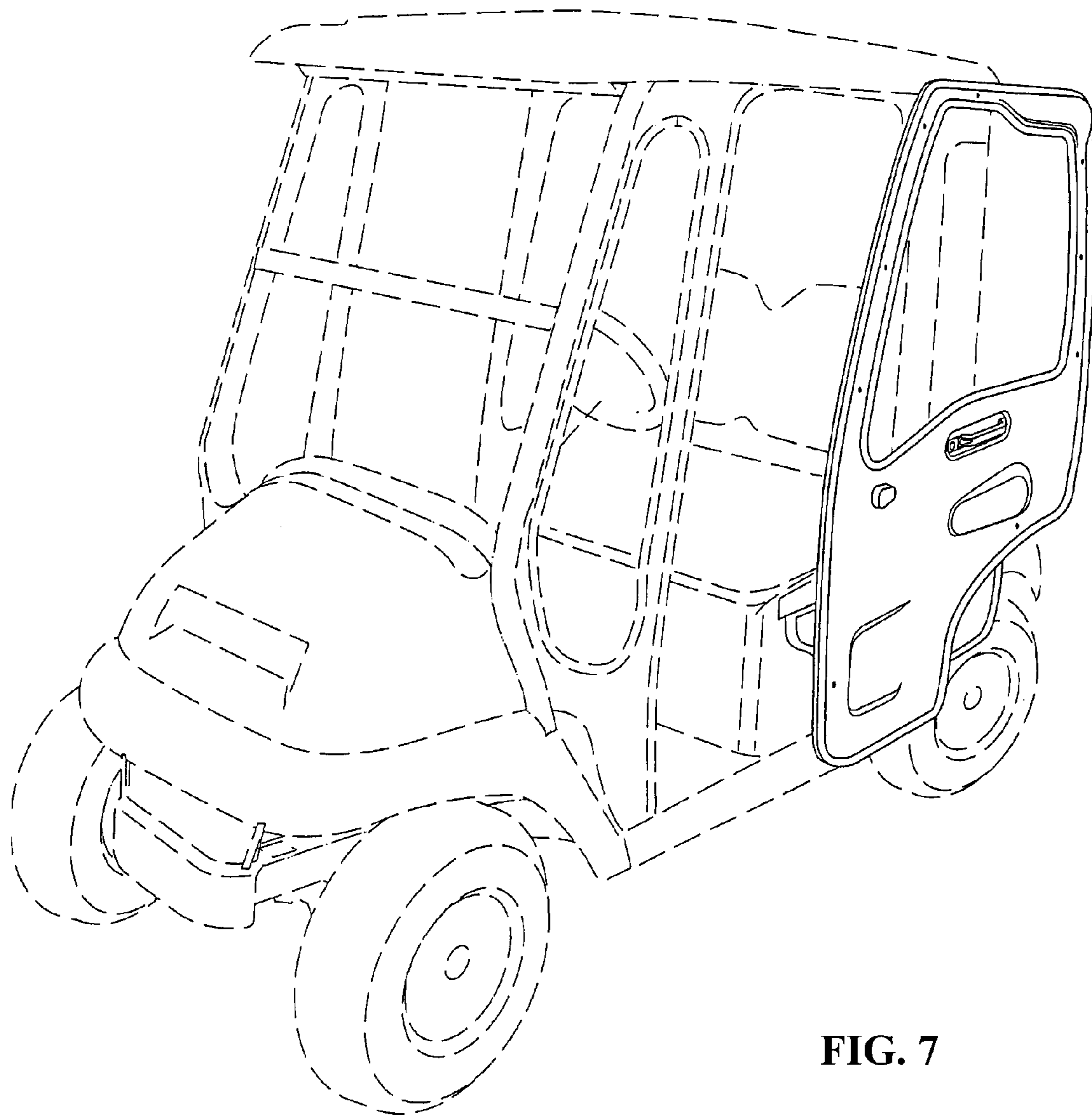

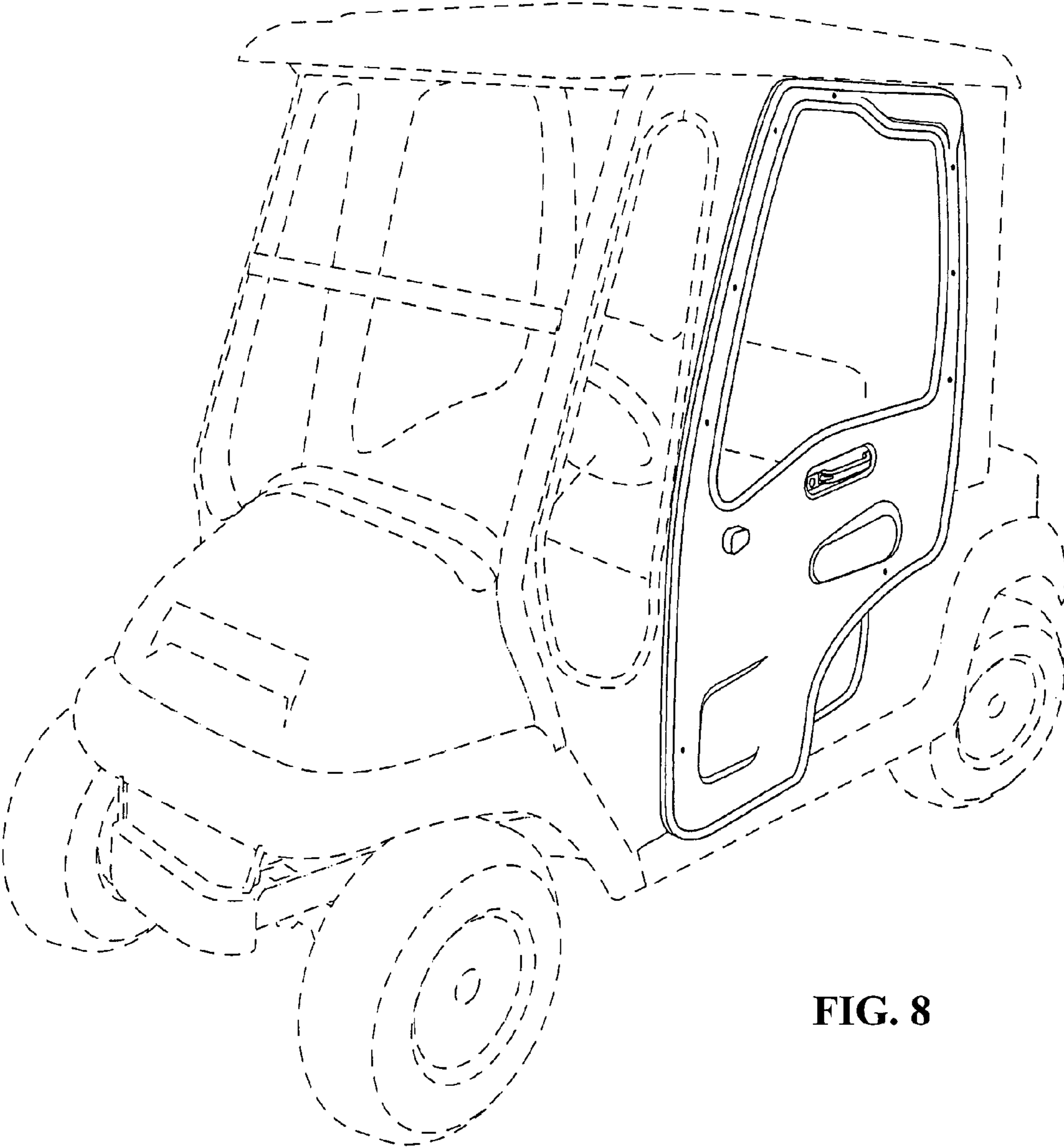
