(57) **CLAIM**

The ornamental design for a writing instrument refill, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing our new design for a writing instrument refill;

FIG. 2 is a right side elevational view of the writing instrument refill of FIG. 1;

FIG. 3 is a left side elevational view of the writing instrument refill of FIG. 1;

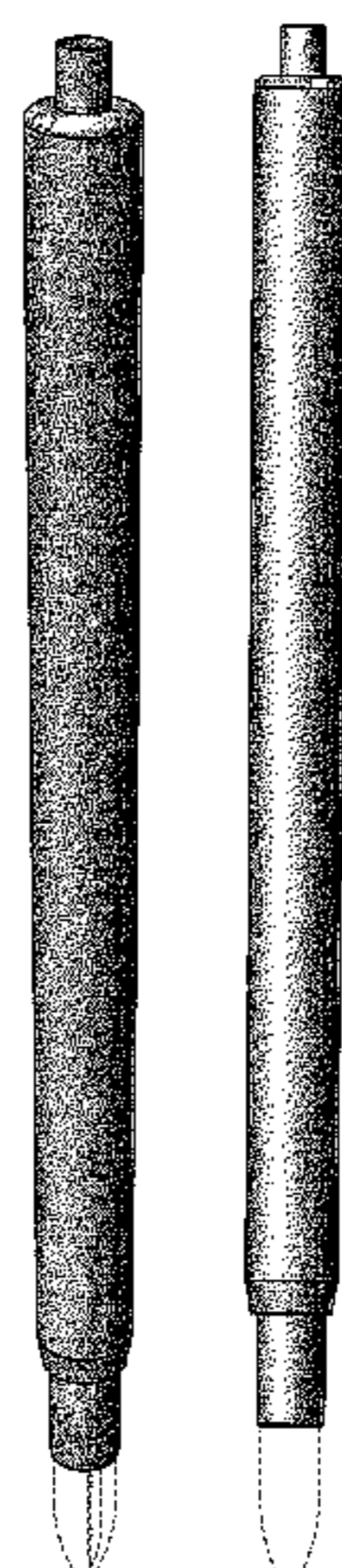
FIG. 4 is a rear view of the writing instrument refill of FIG. 1;

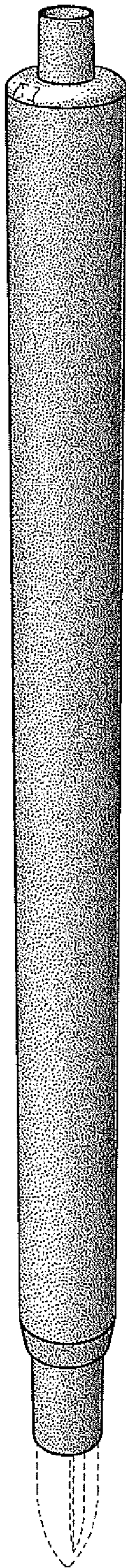

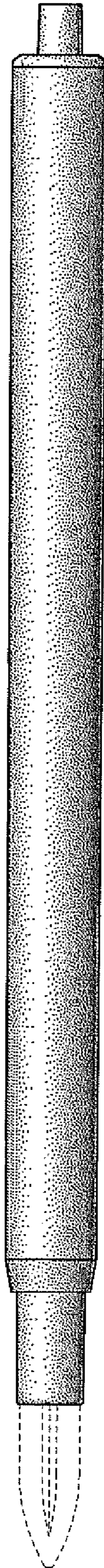

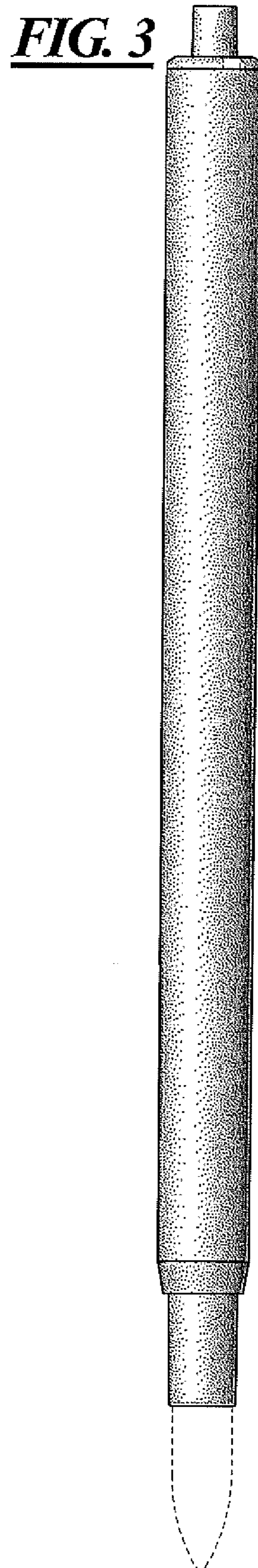

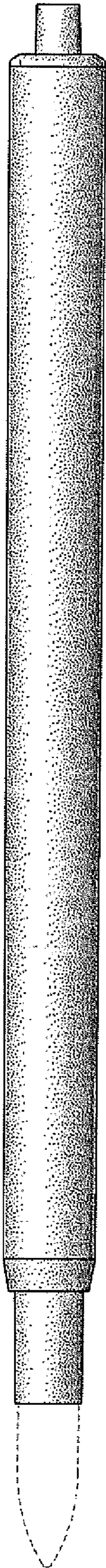

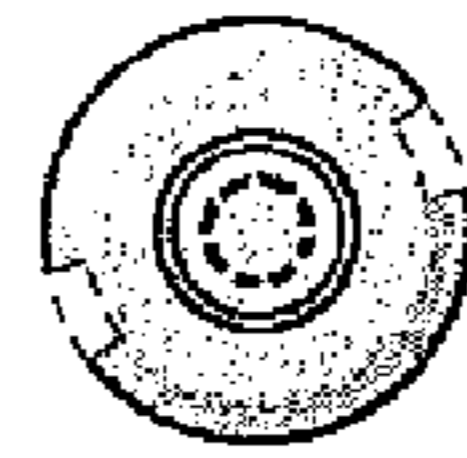

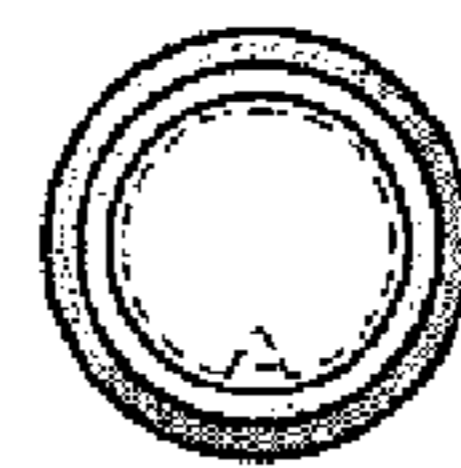
