FIG. 9 is a top view thereof;

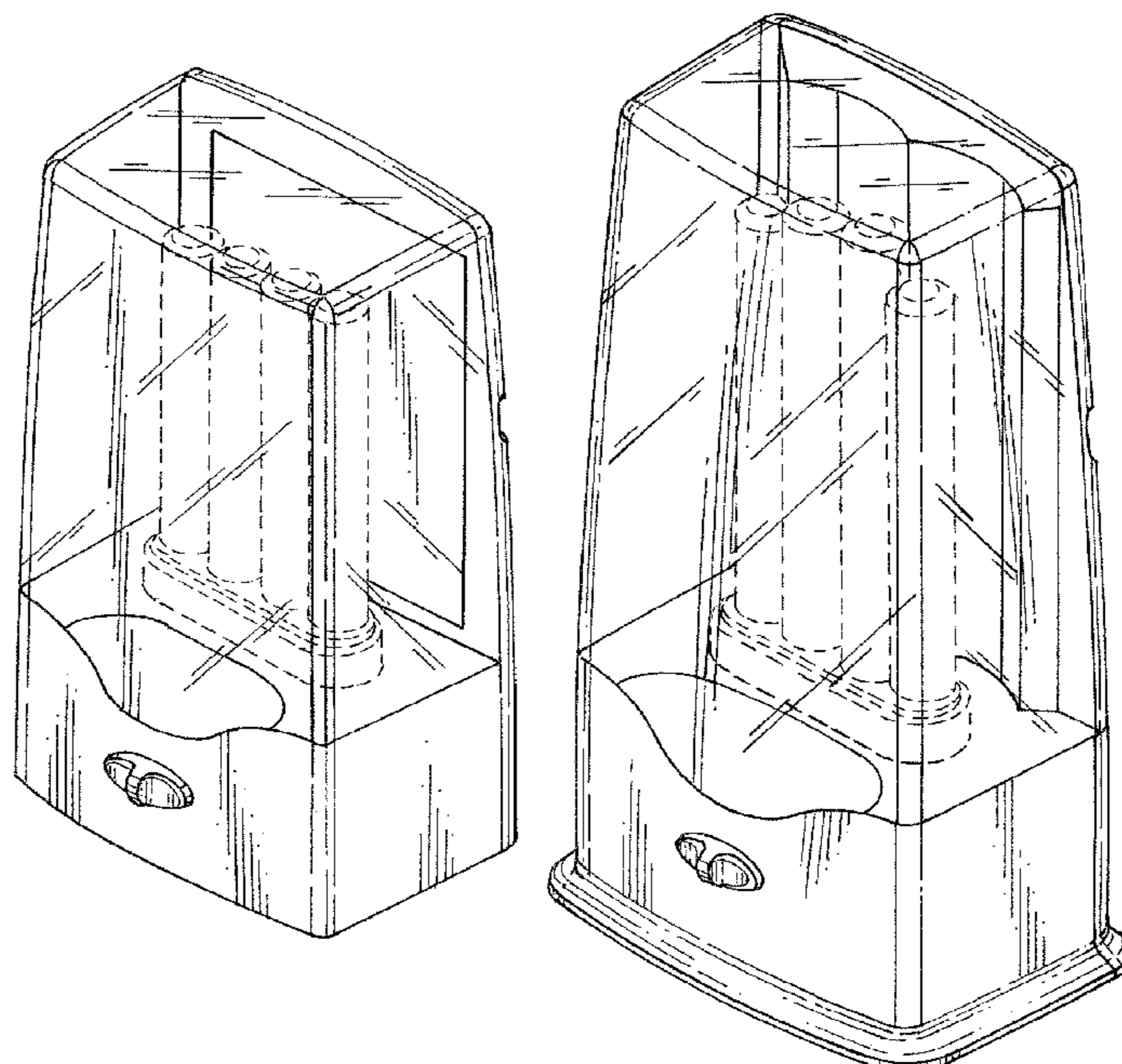
FIG. 10 is a front view thereof;

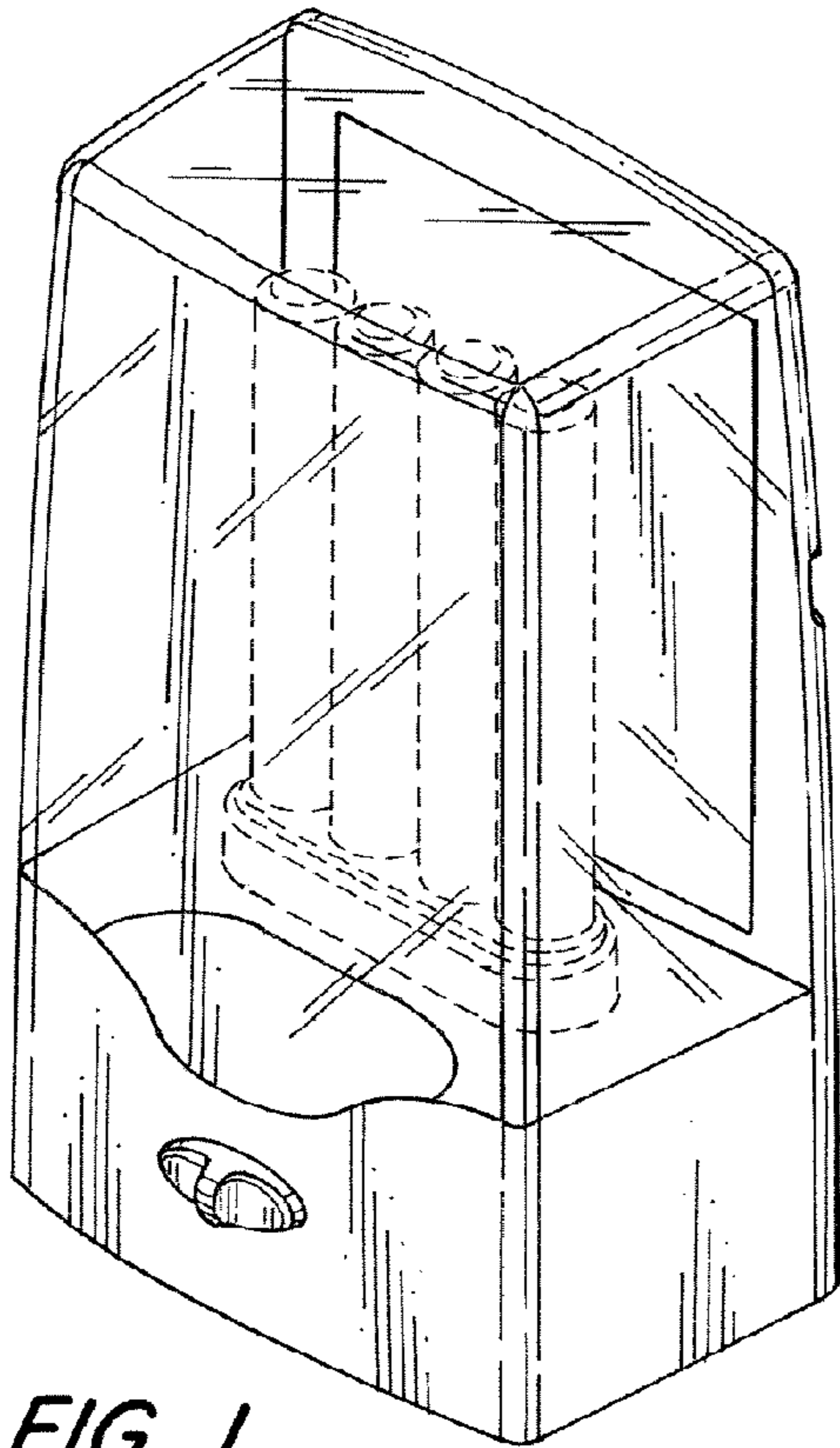

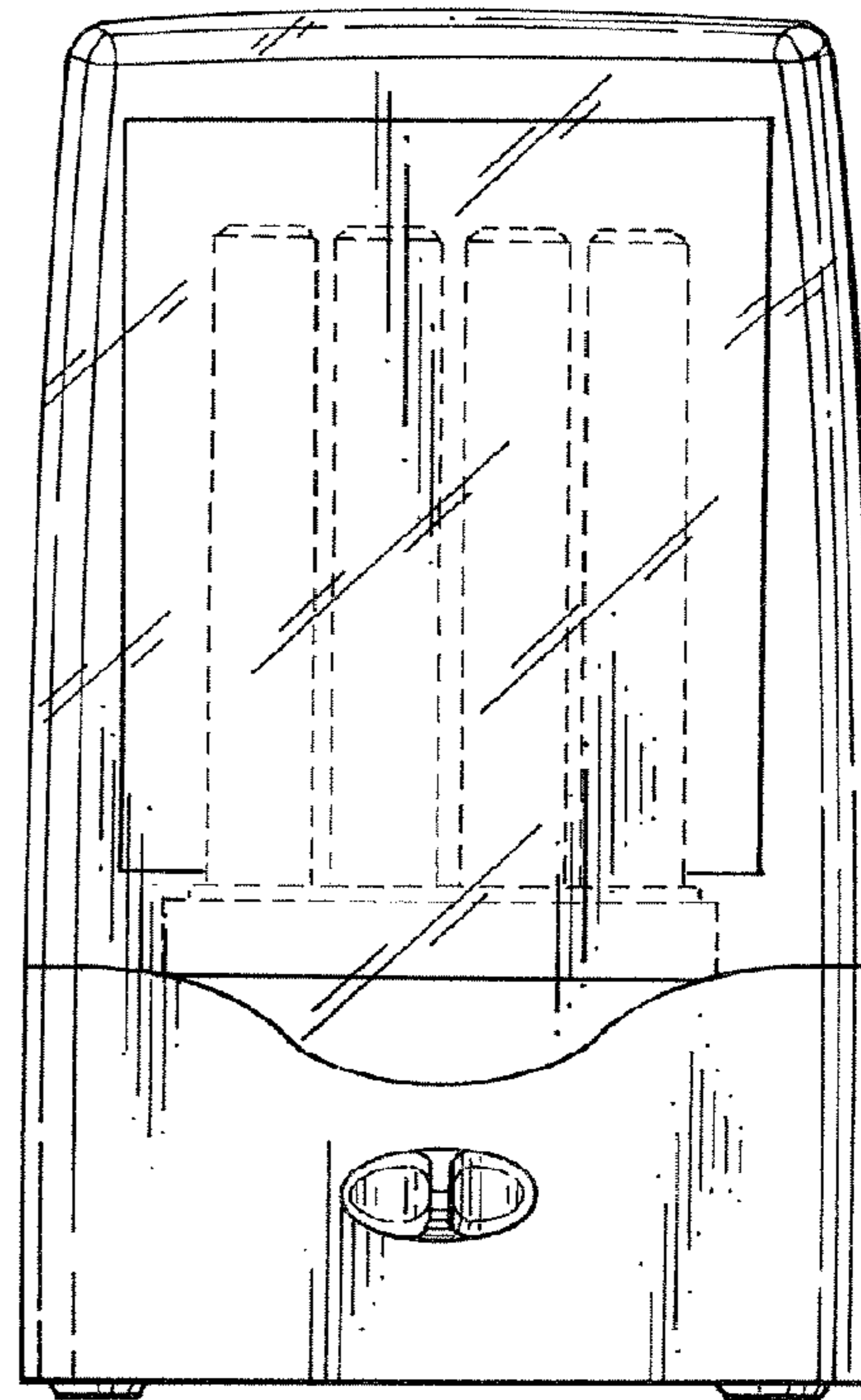

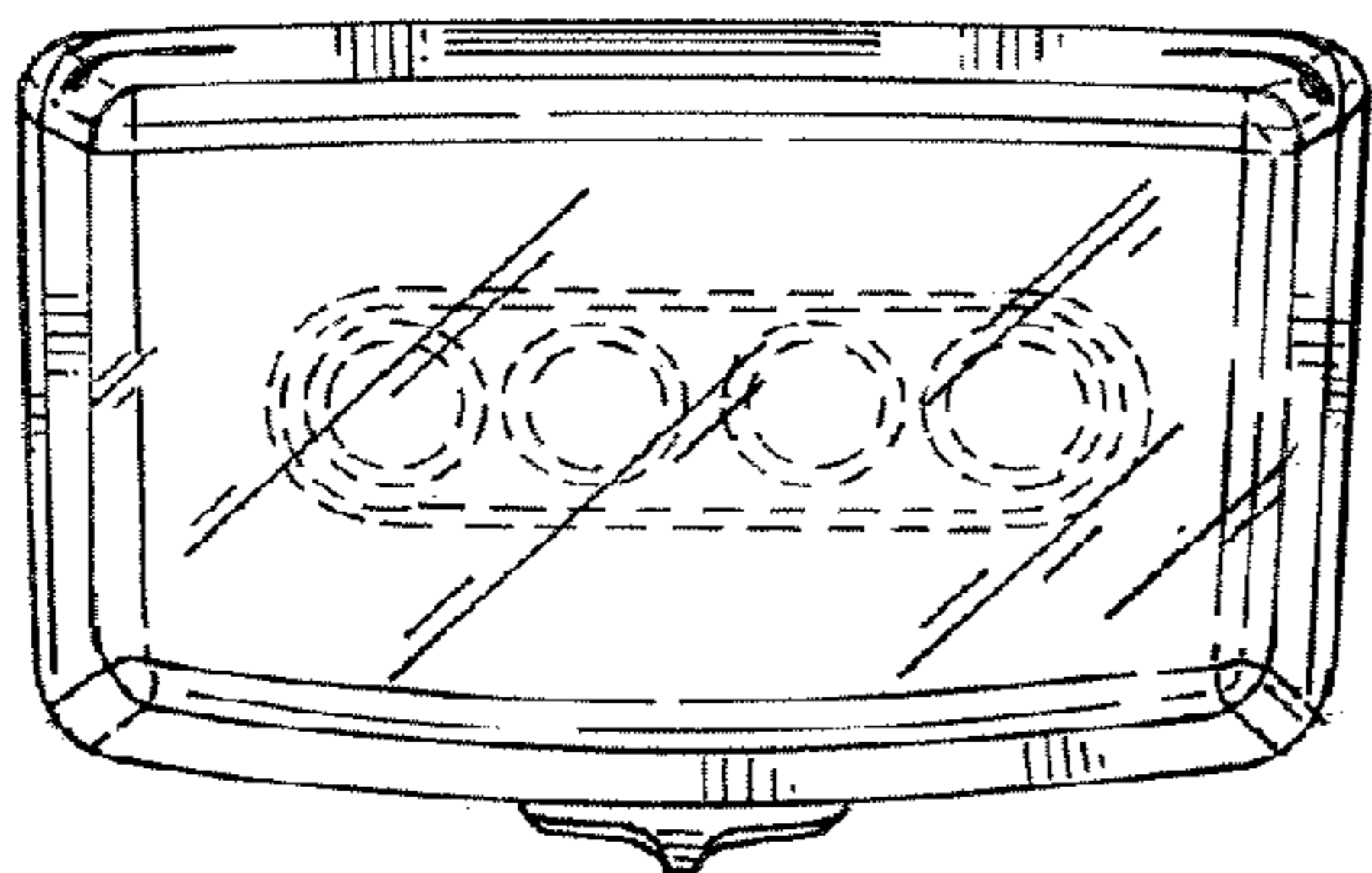

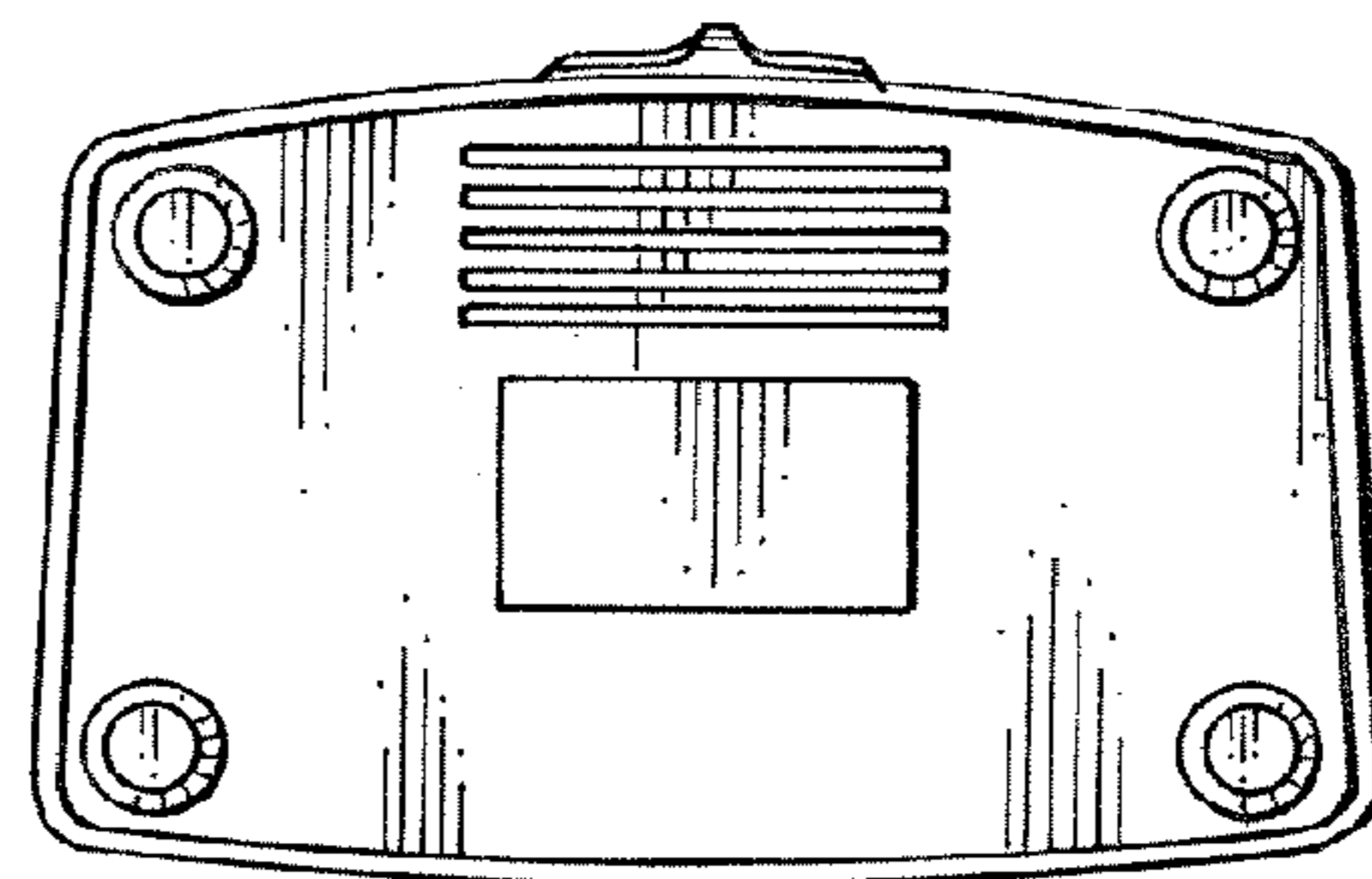

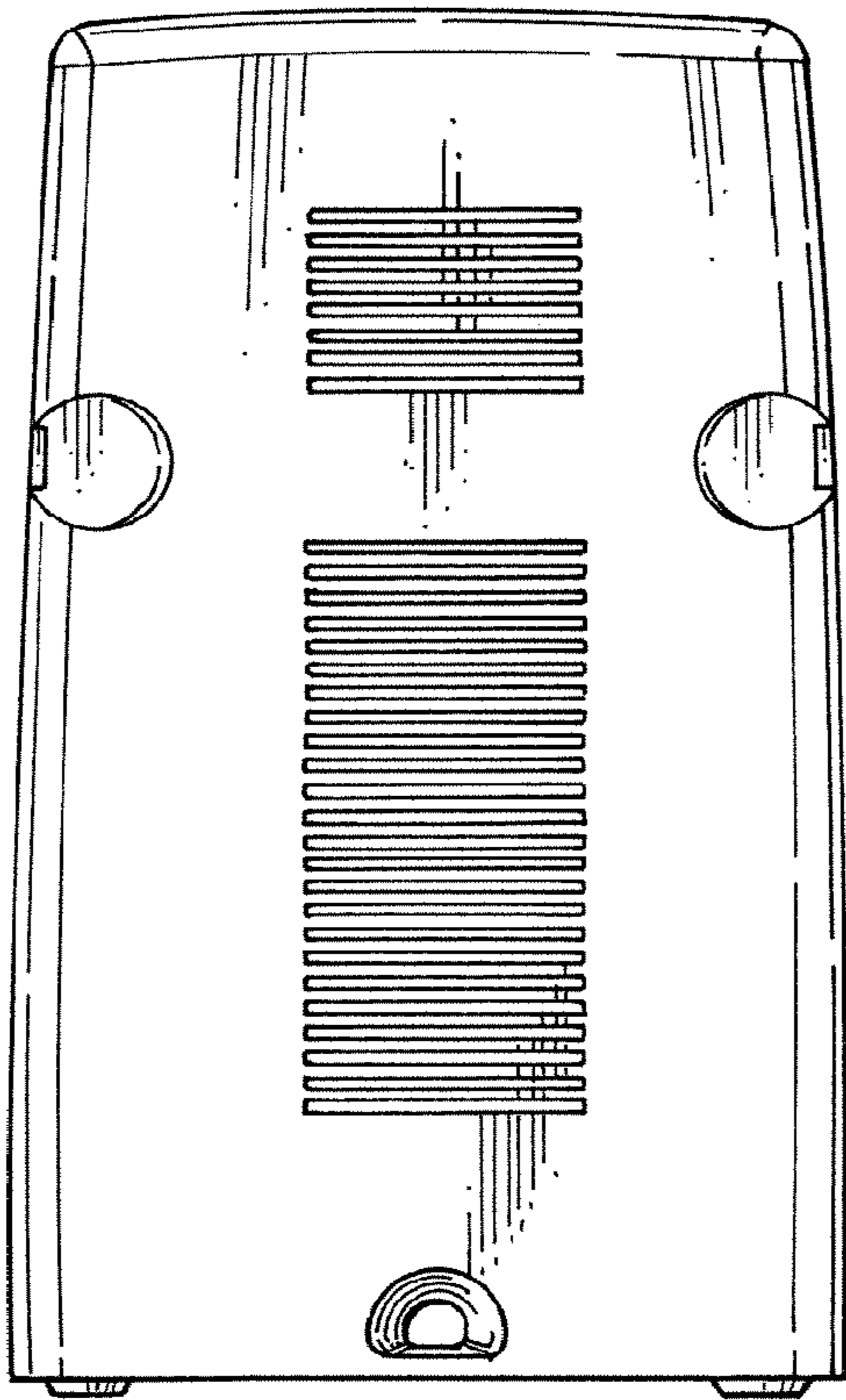

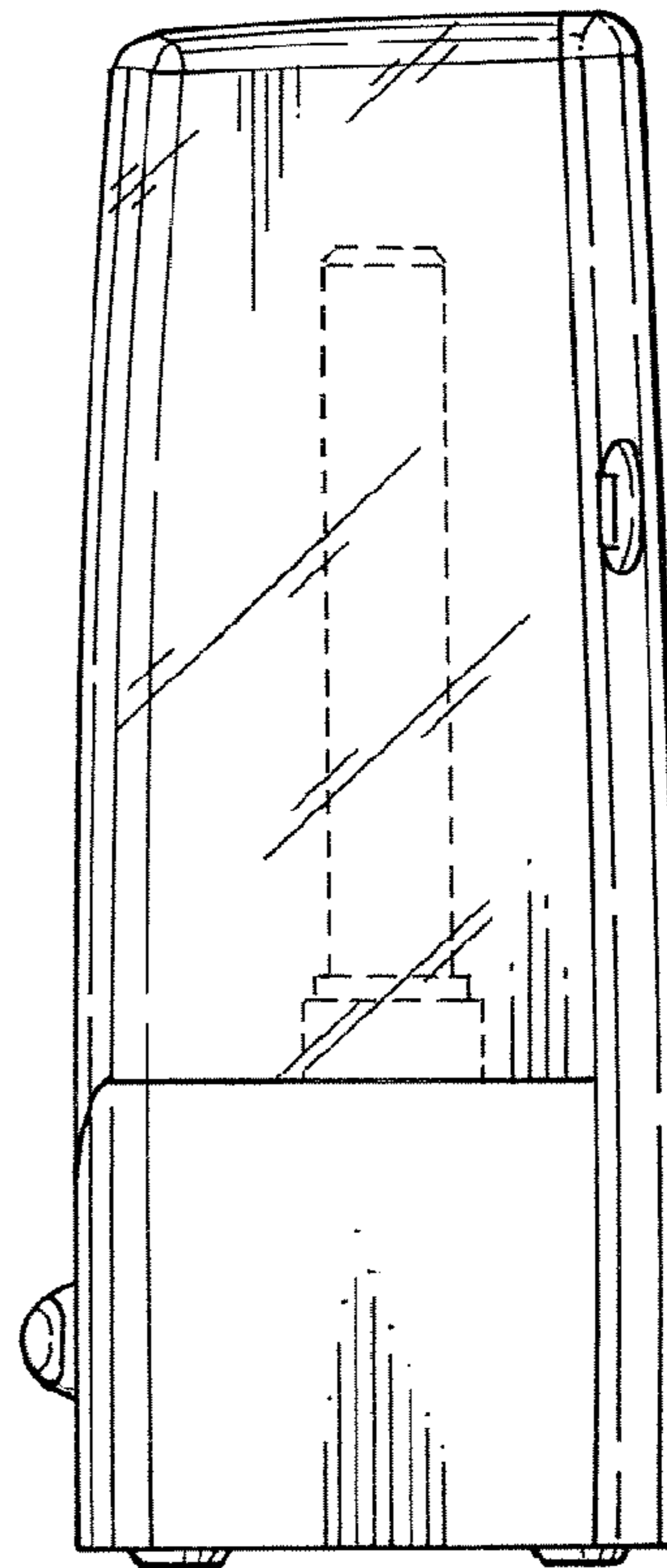

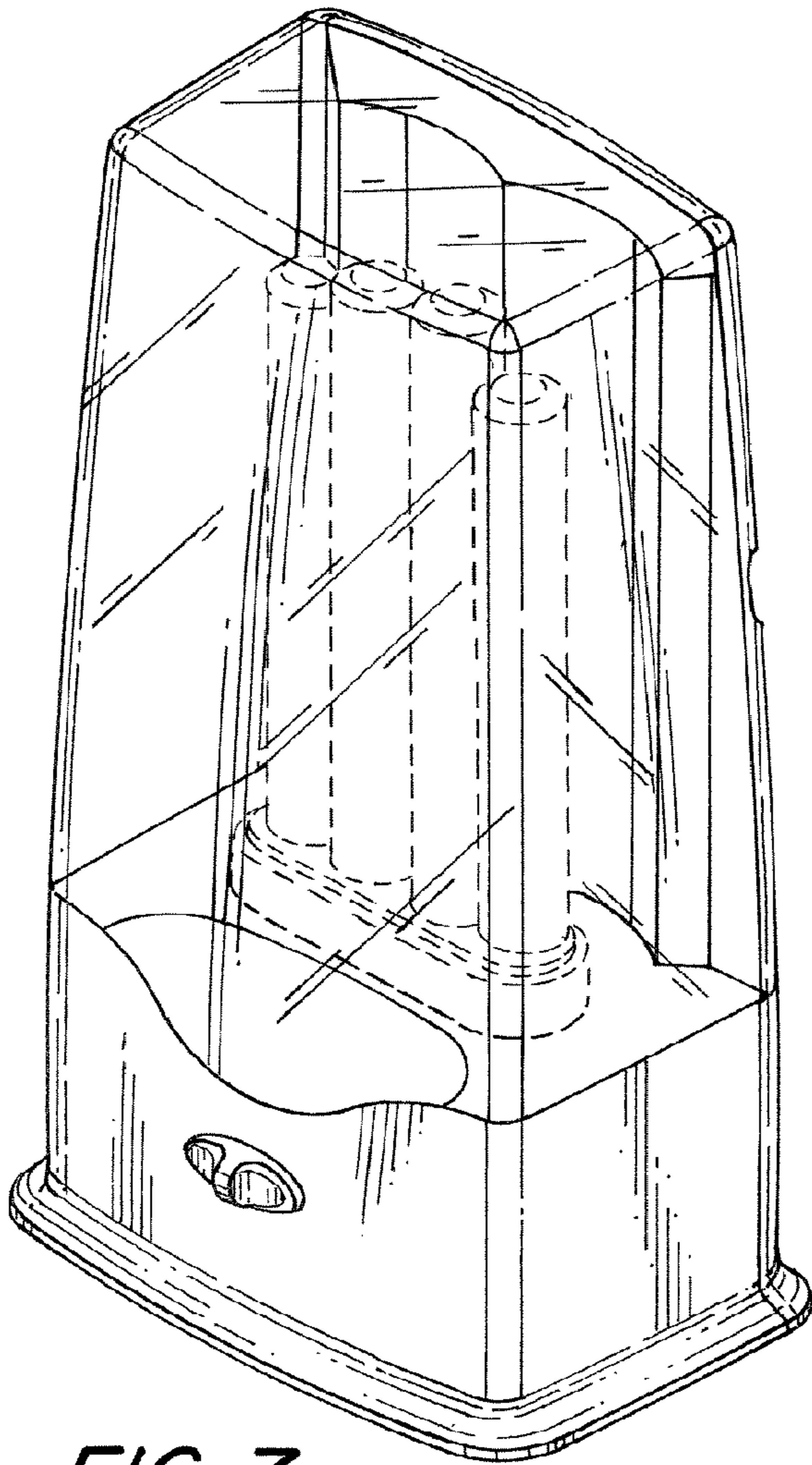

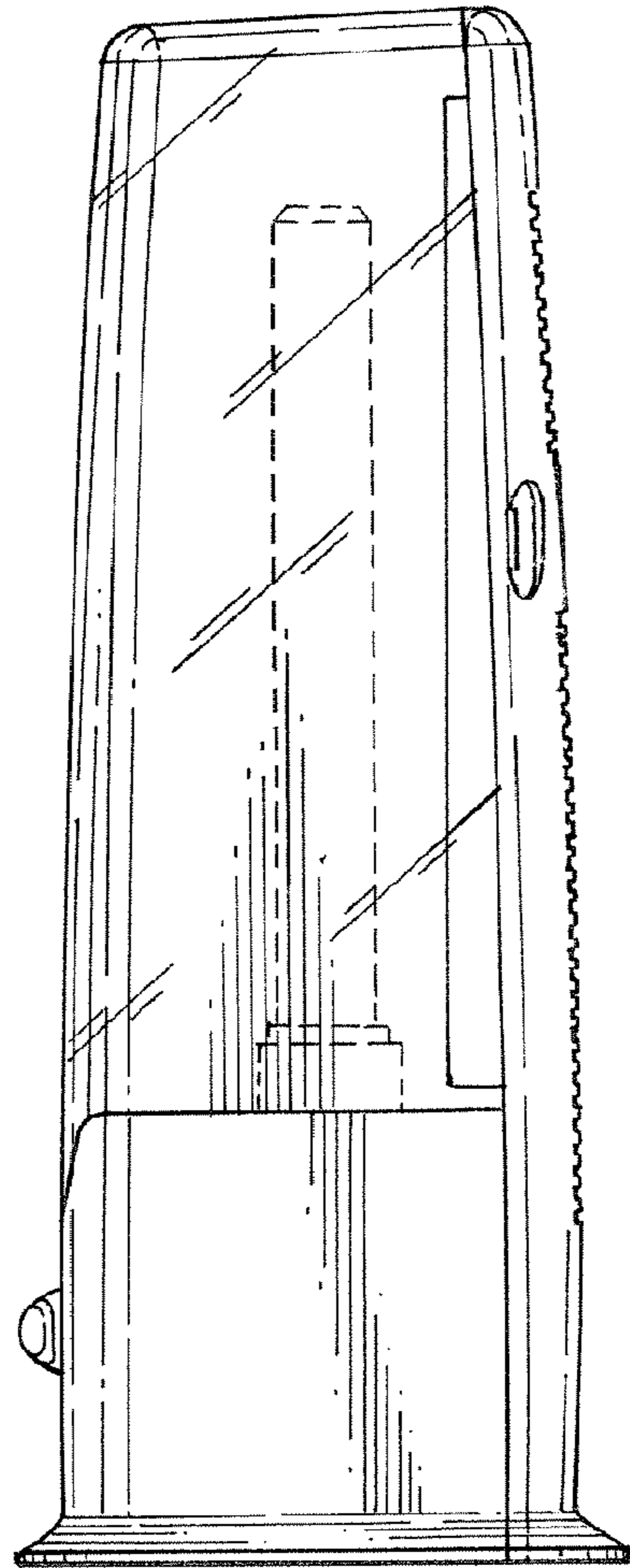

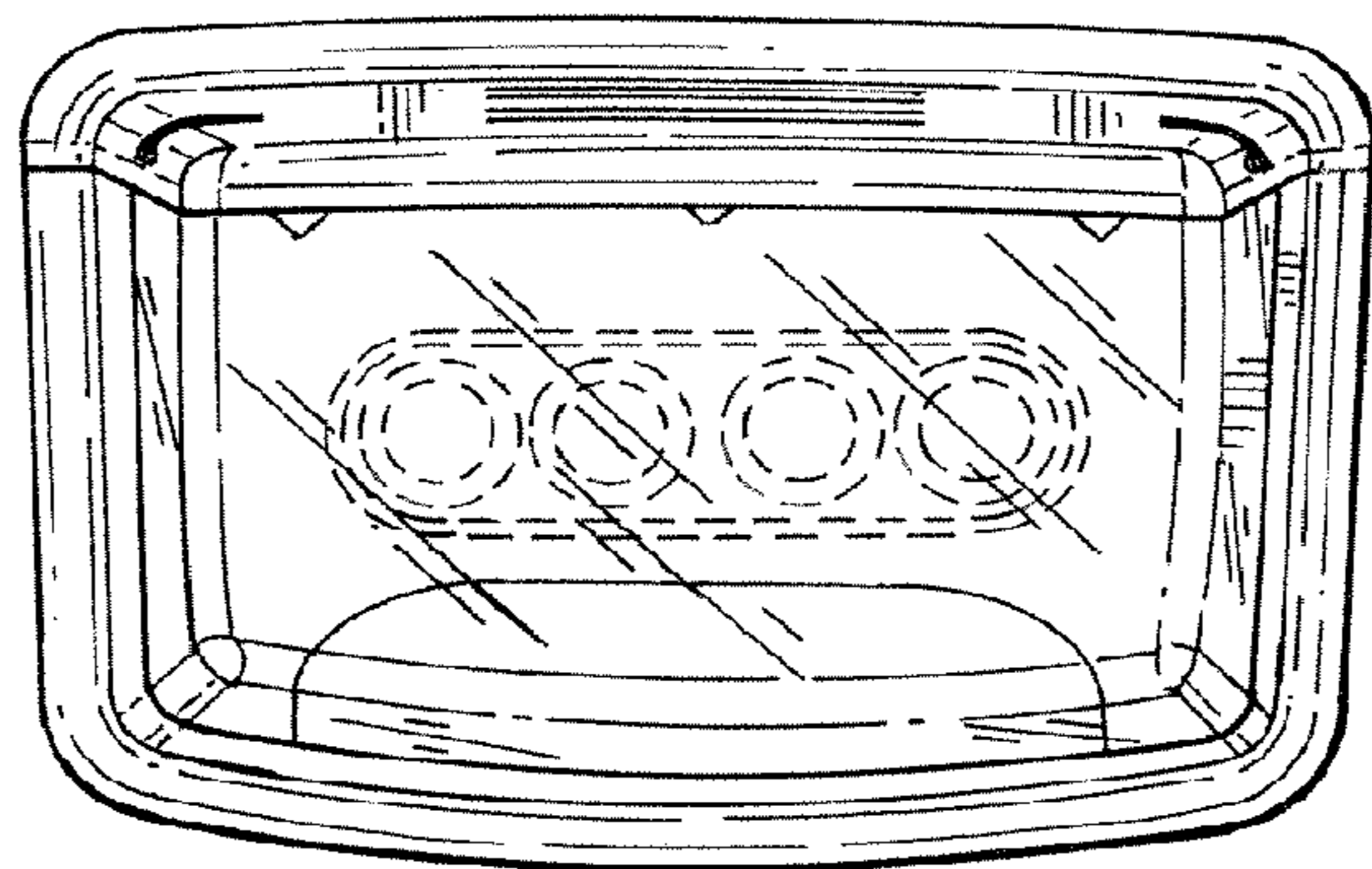

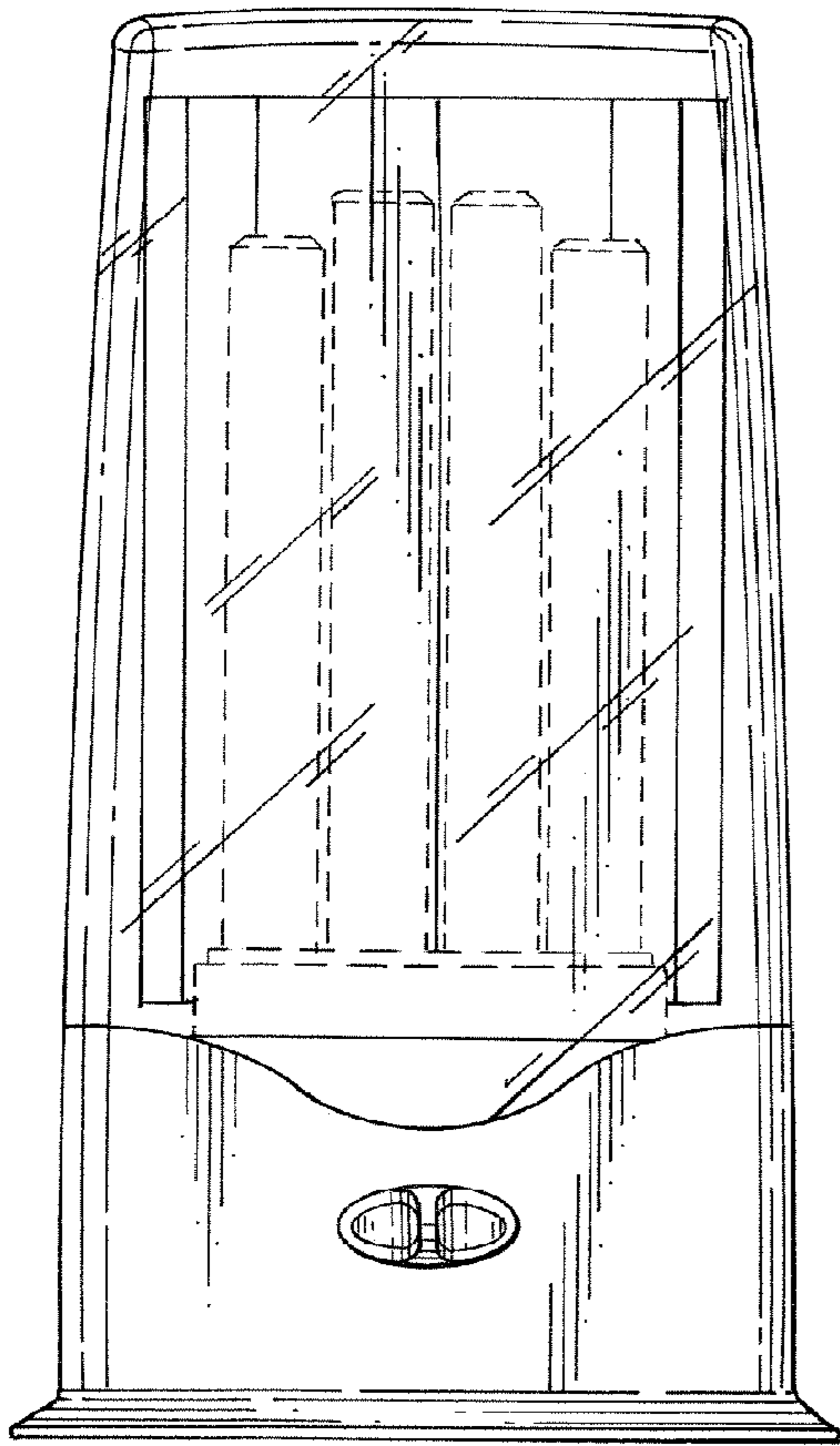

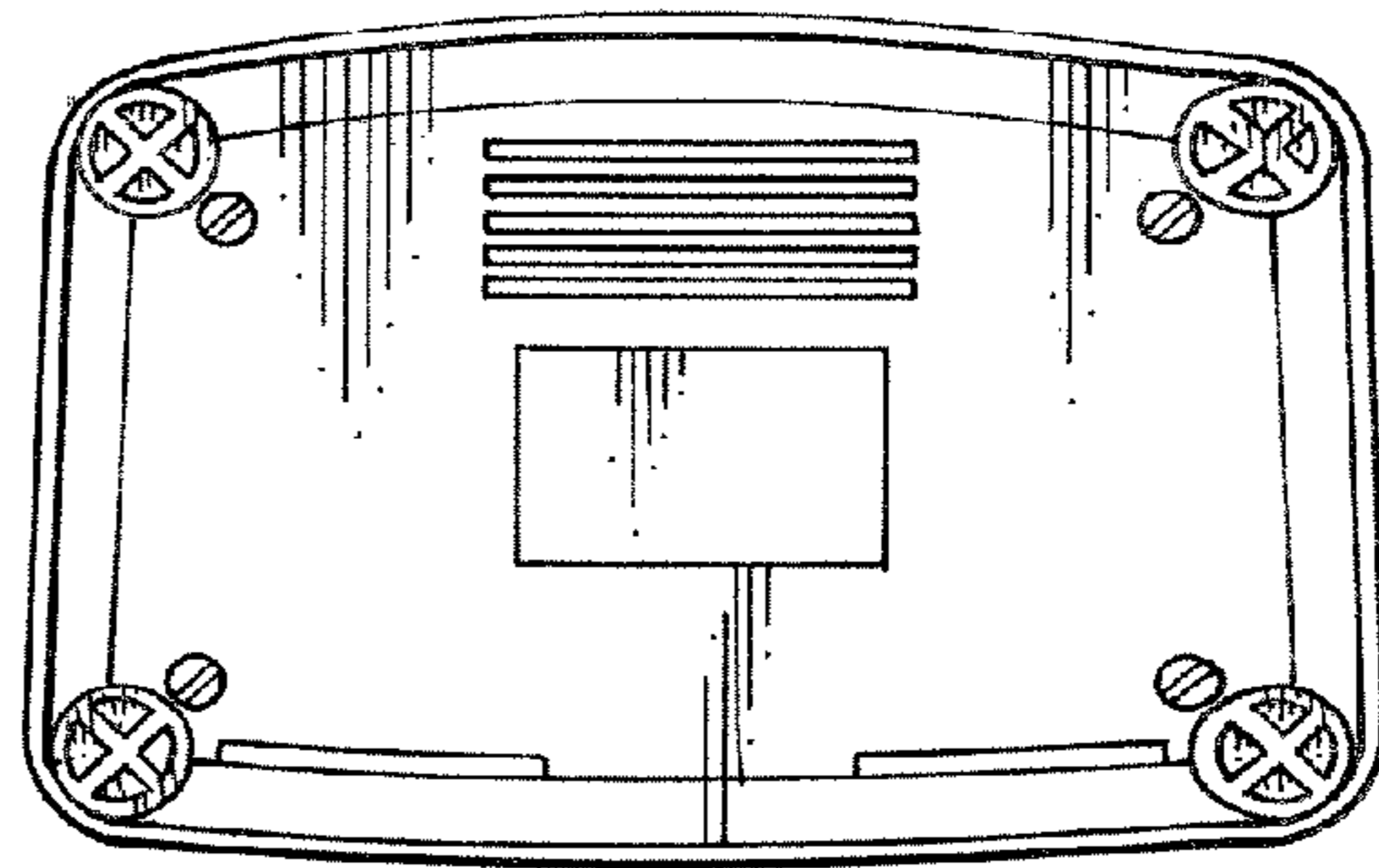

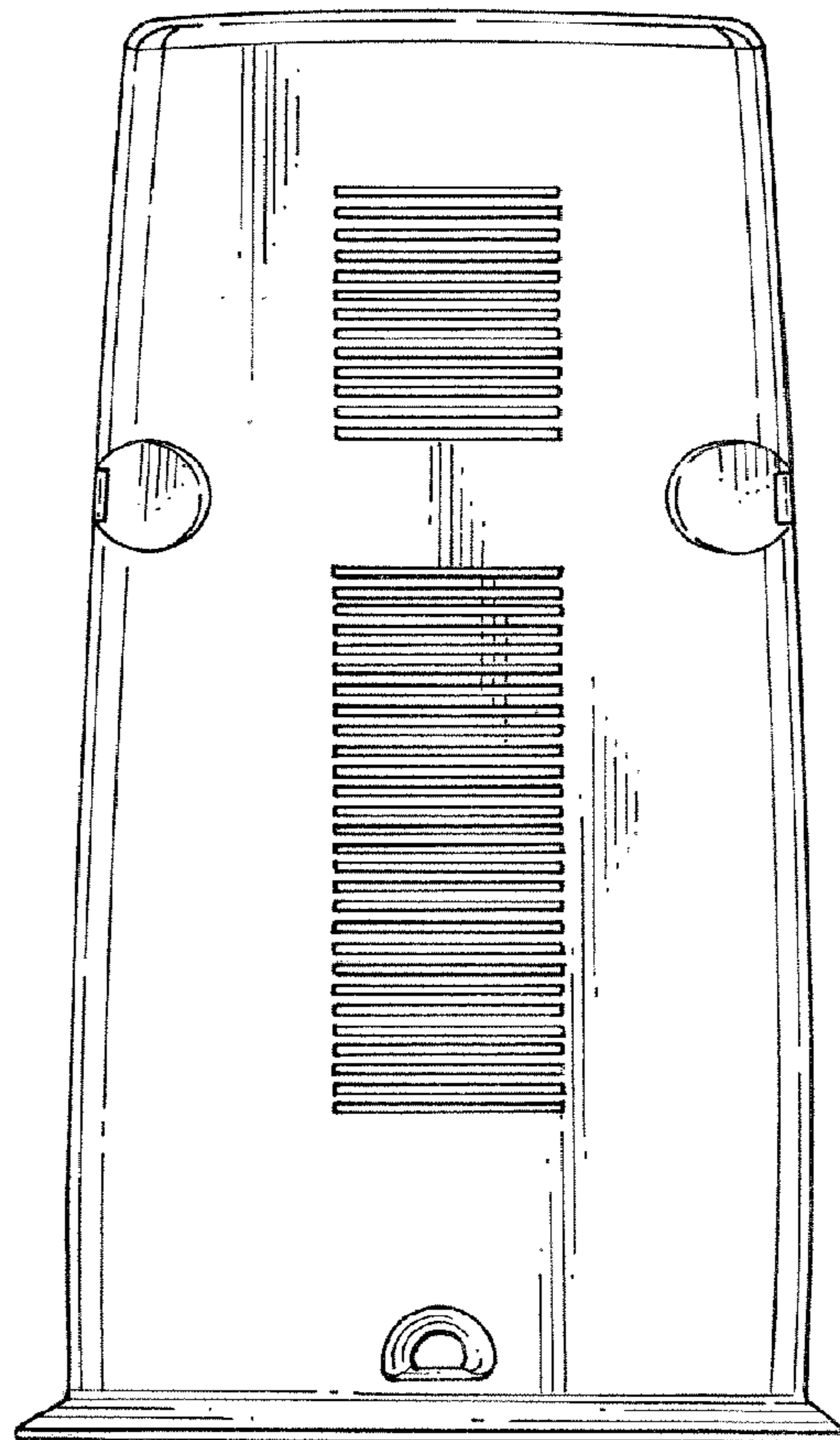
