DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of the face protector.

FIG. 2 is a front elevational view of the face protector.

FIG. 3 is a right side elevational view of the face protector.

FIG. 4 is a rear elevational view of the face protector.

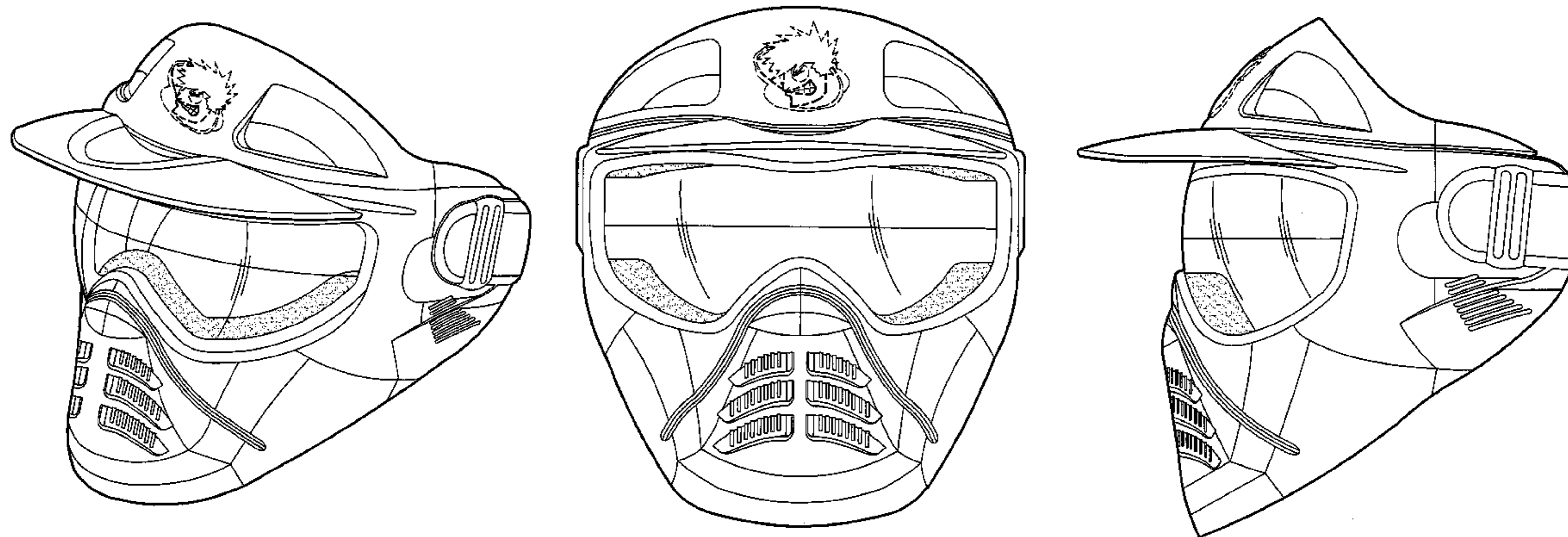
FIG. 5 is a left side elevational view of the face protector.

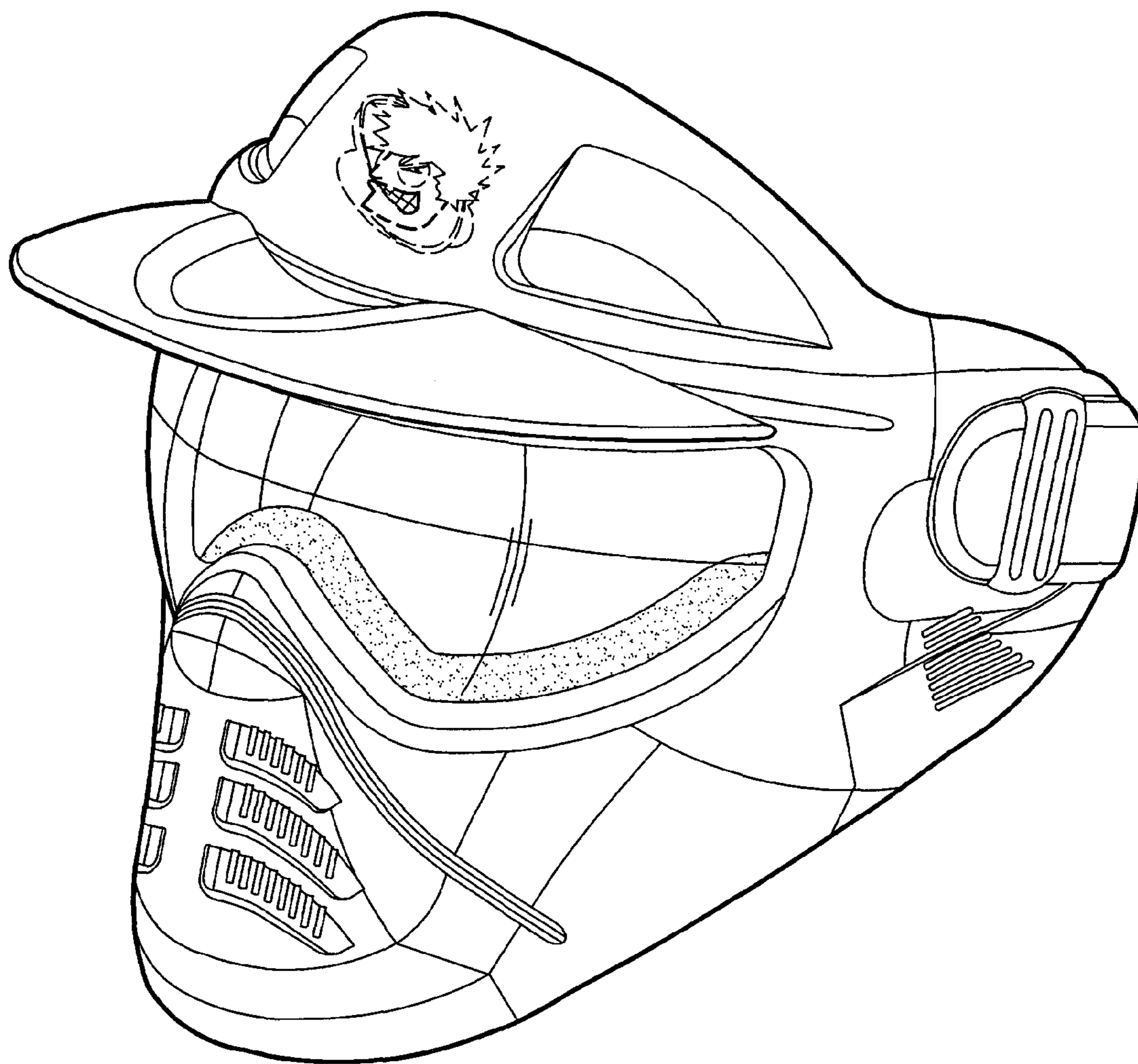

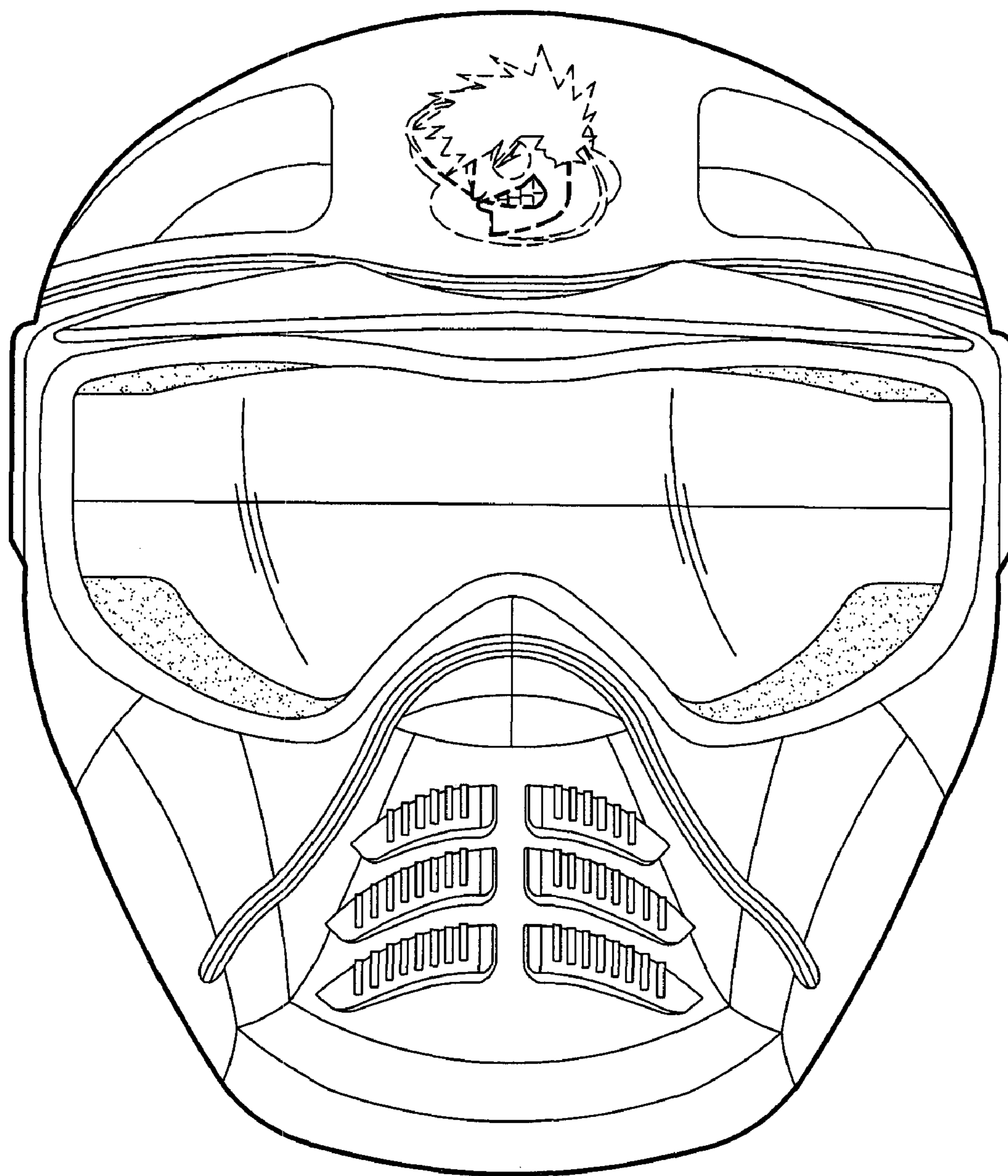

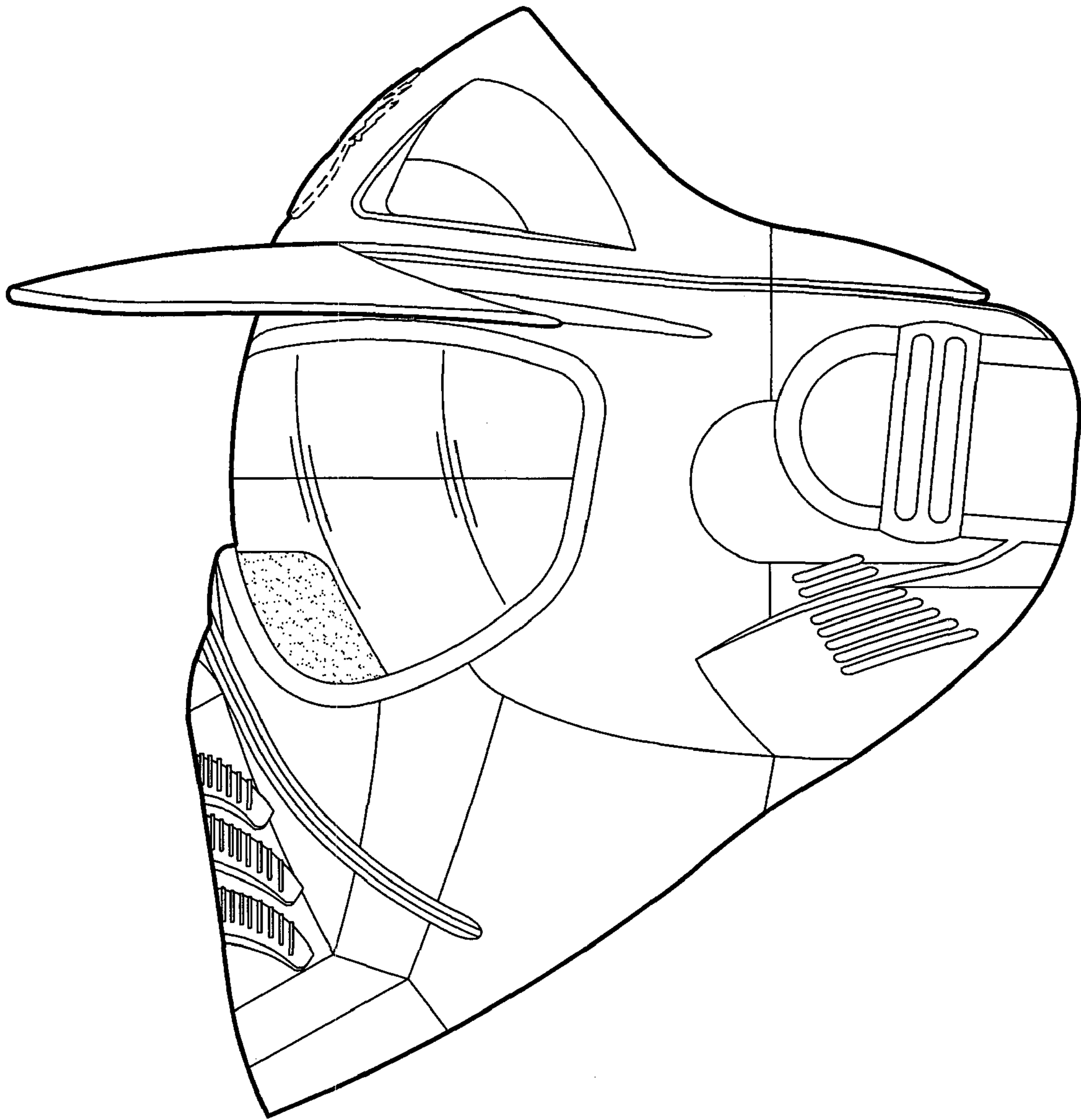

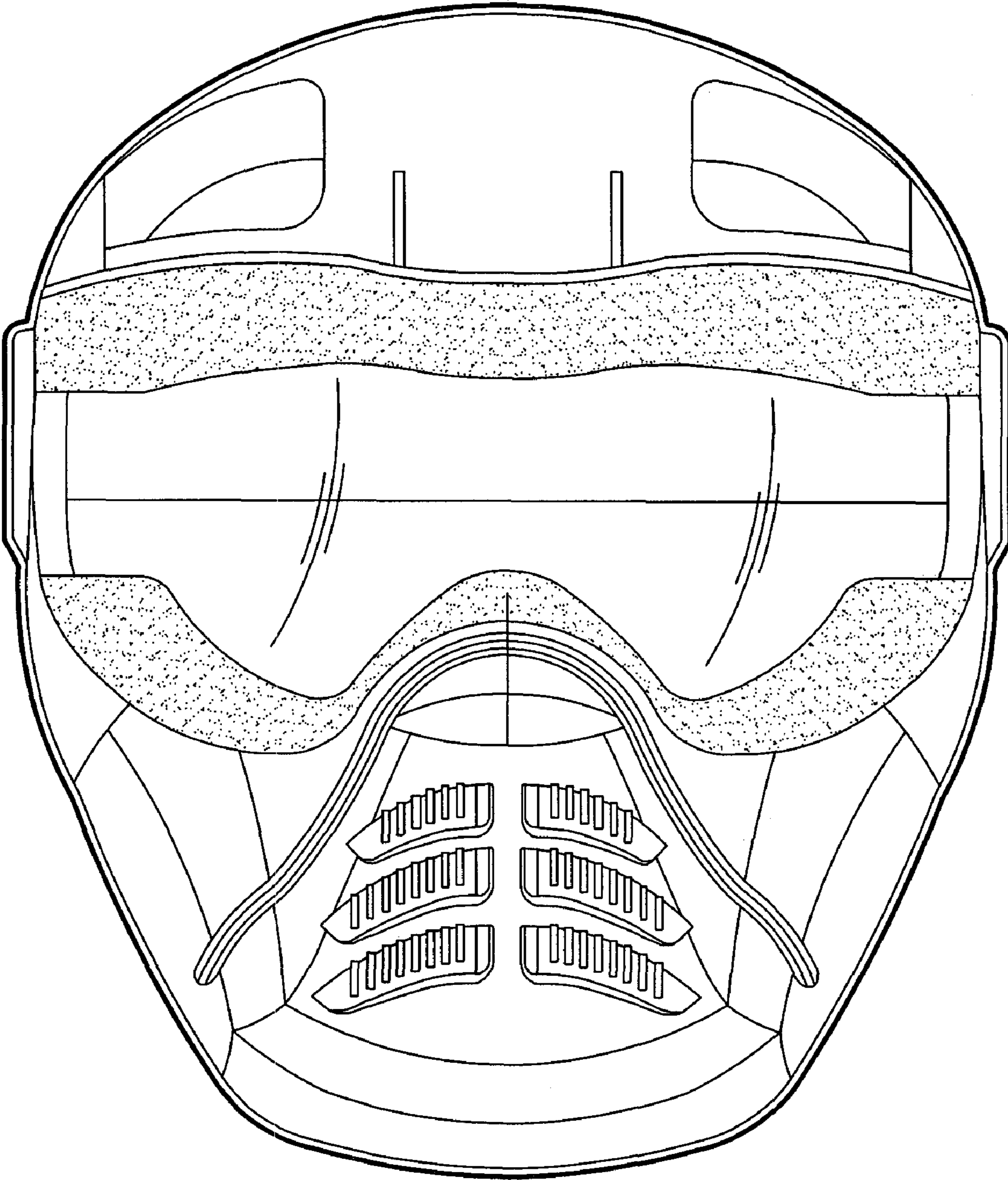

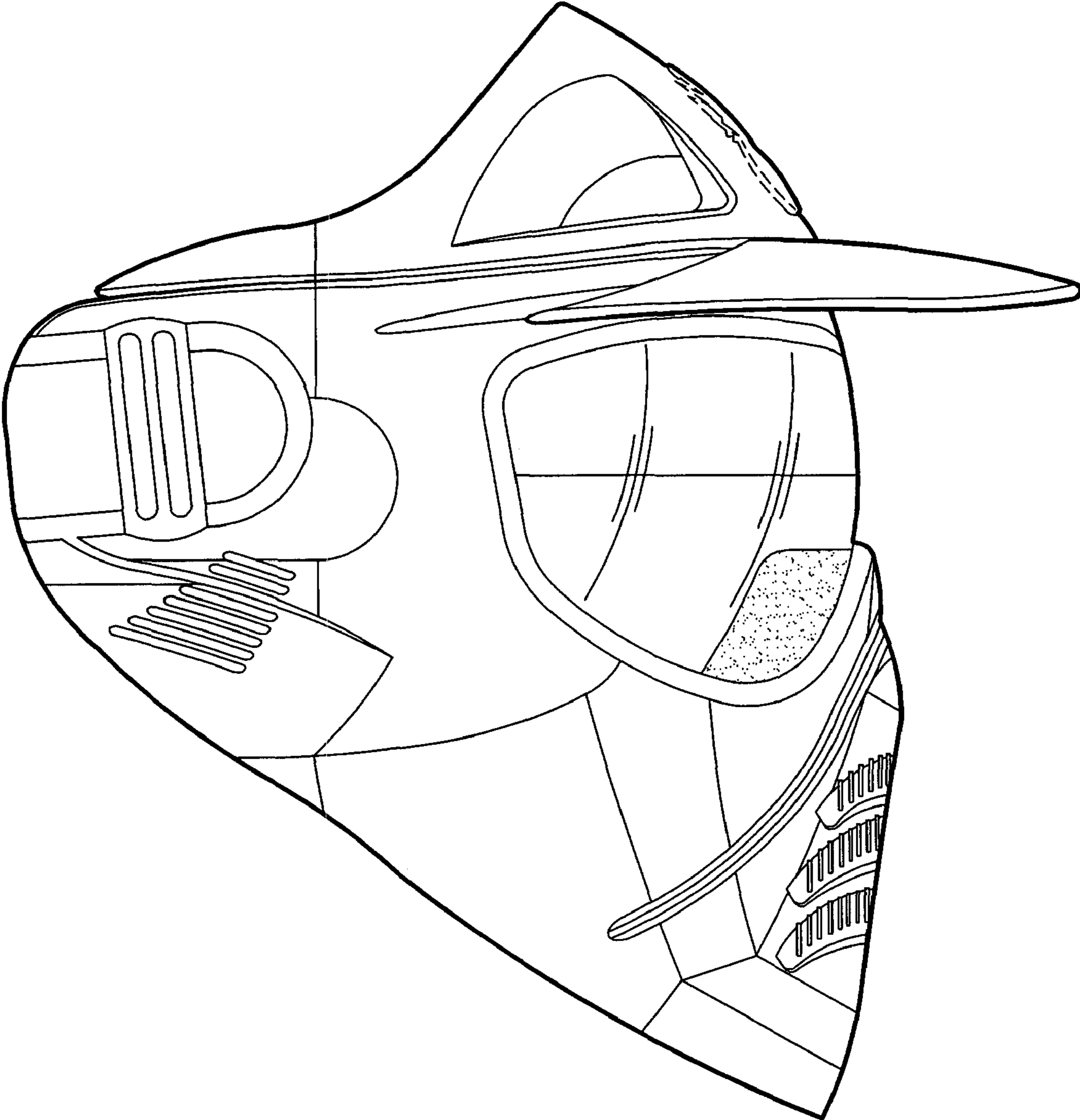

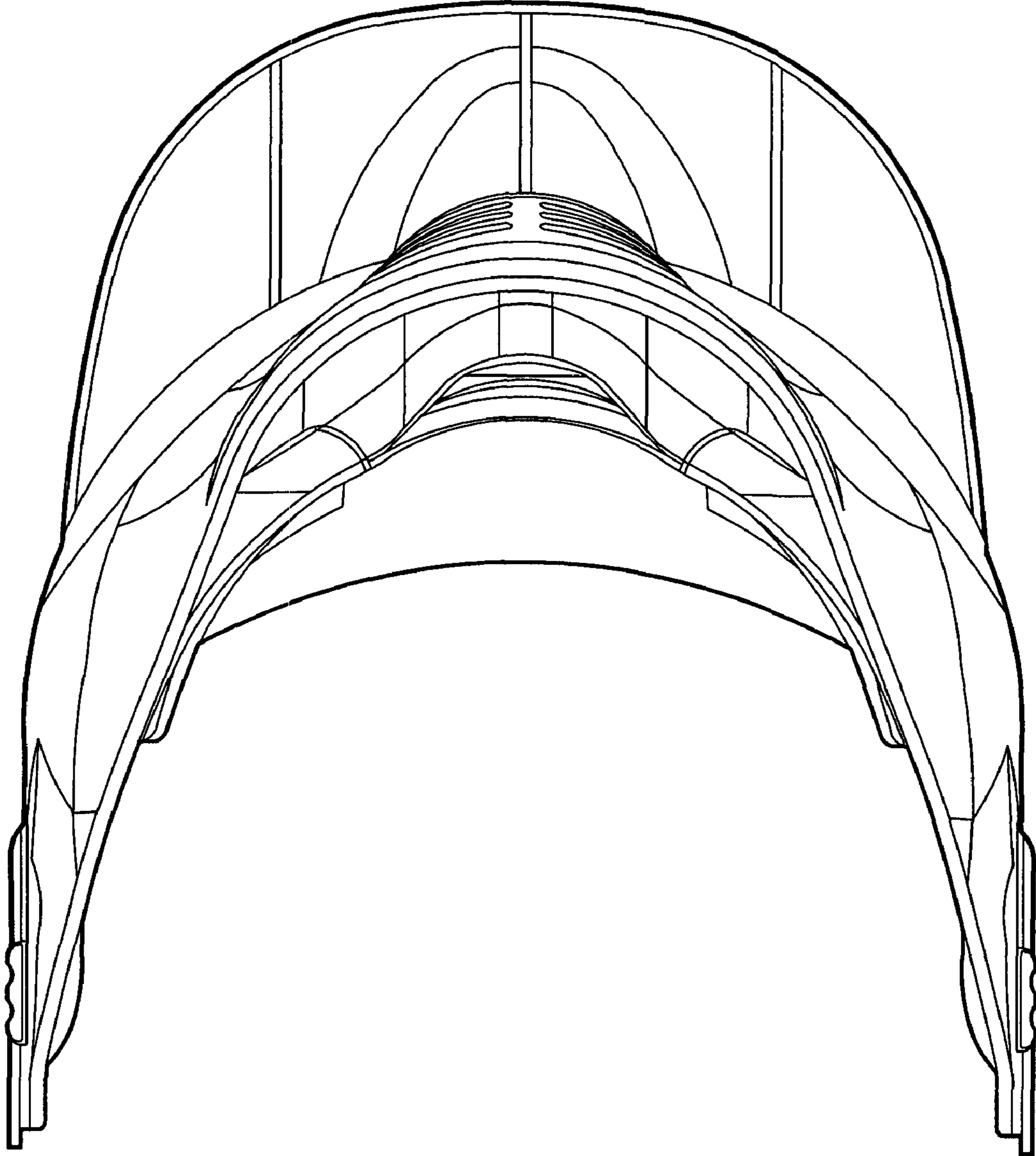

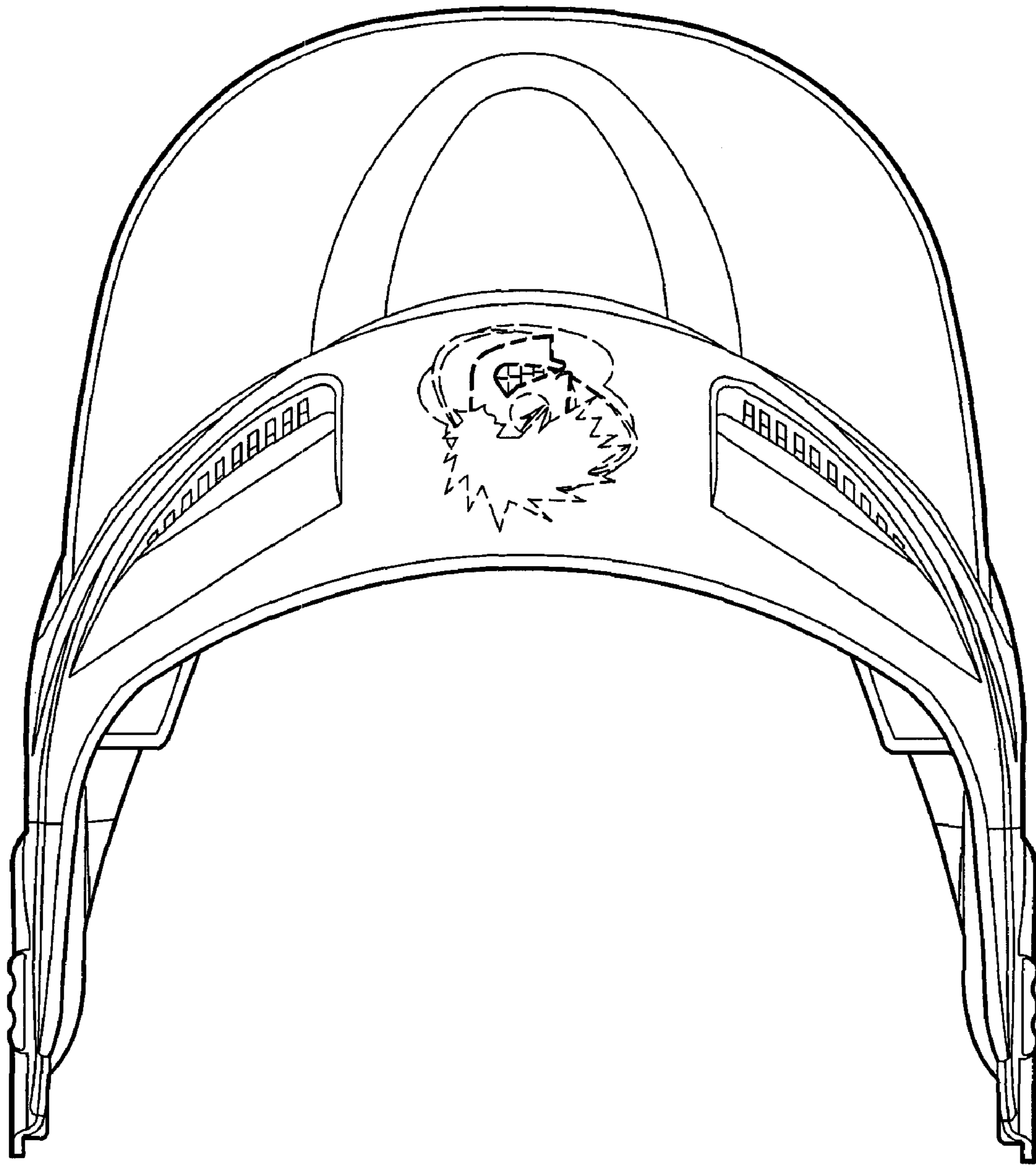
