DESCRIPTION

FIG. 1 is an isometric view of the top, front and one side view of the foot guard of the present invention;

FIG. 2 is a plan view from the top thereof;

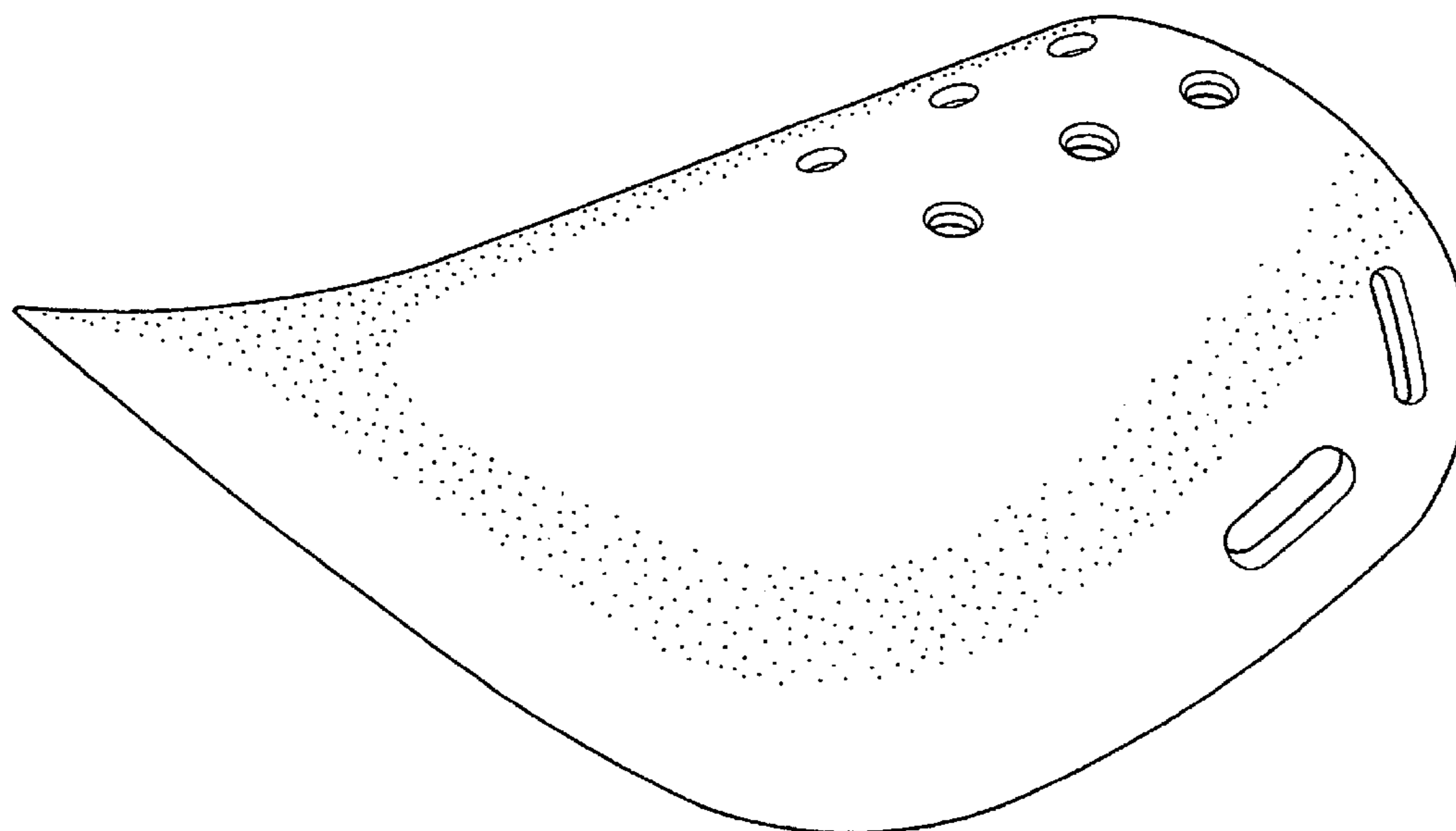
FIG. 3 is a plan view thereof from underneath;

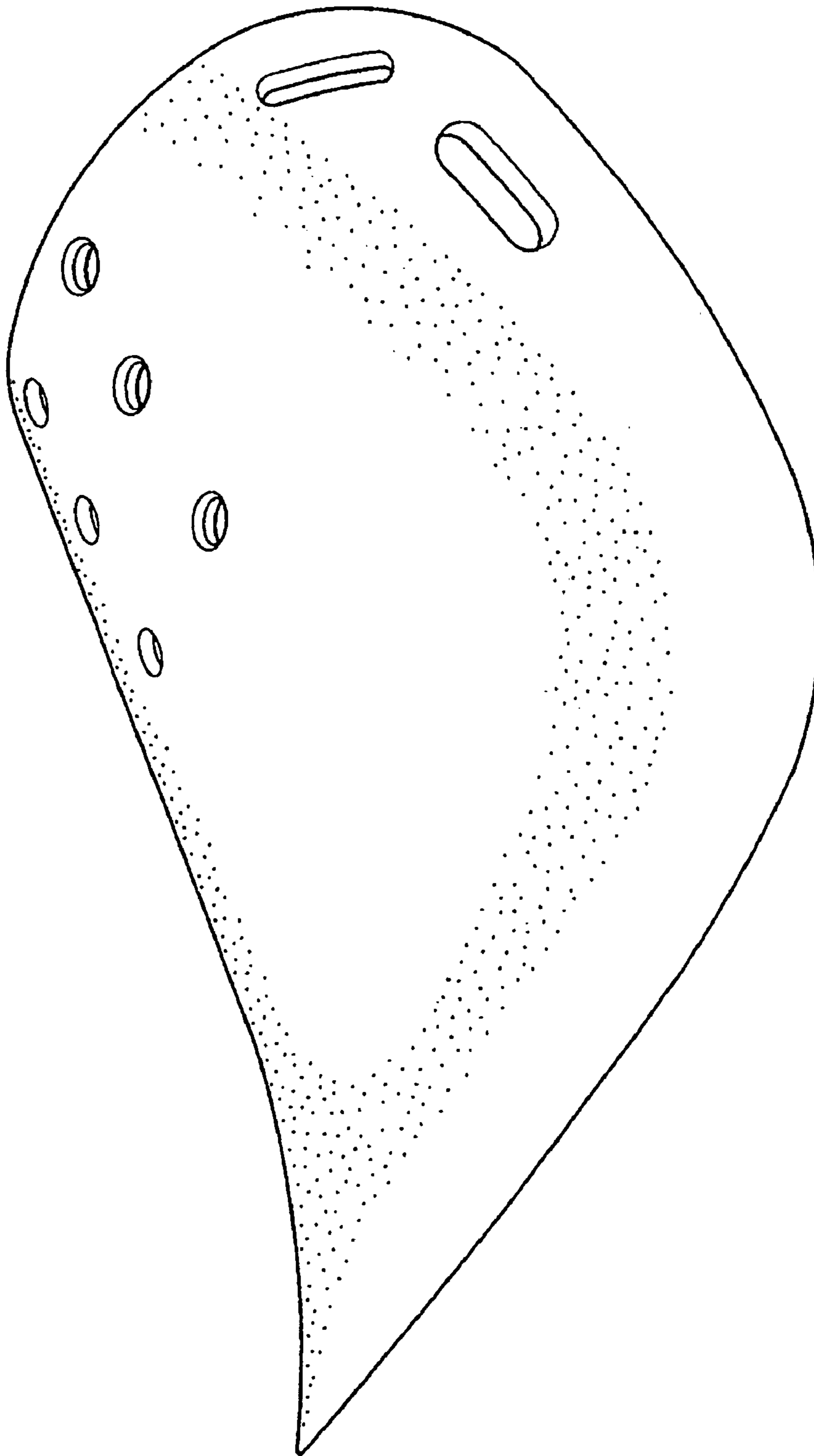

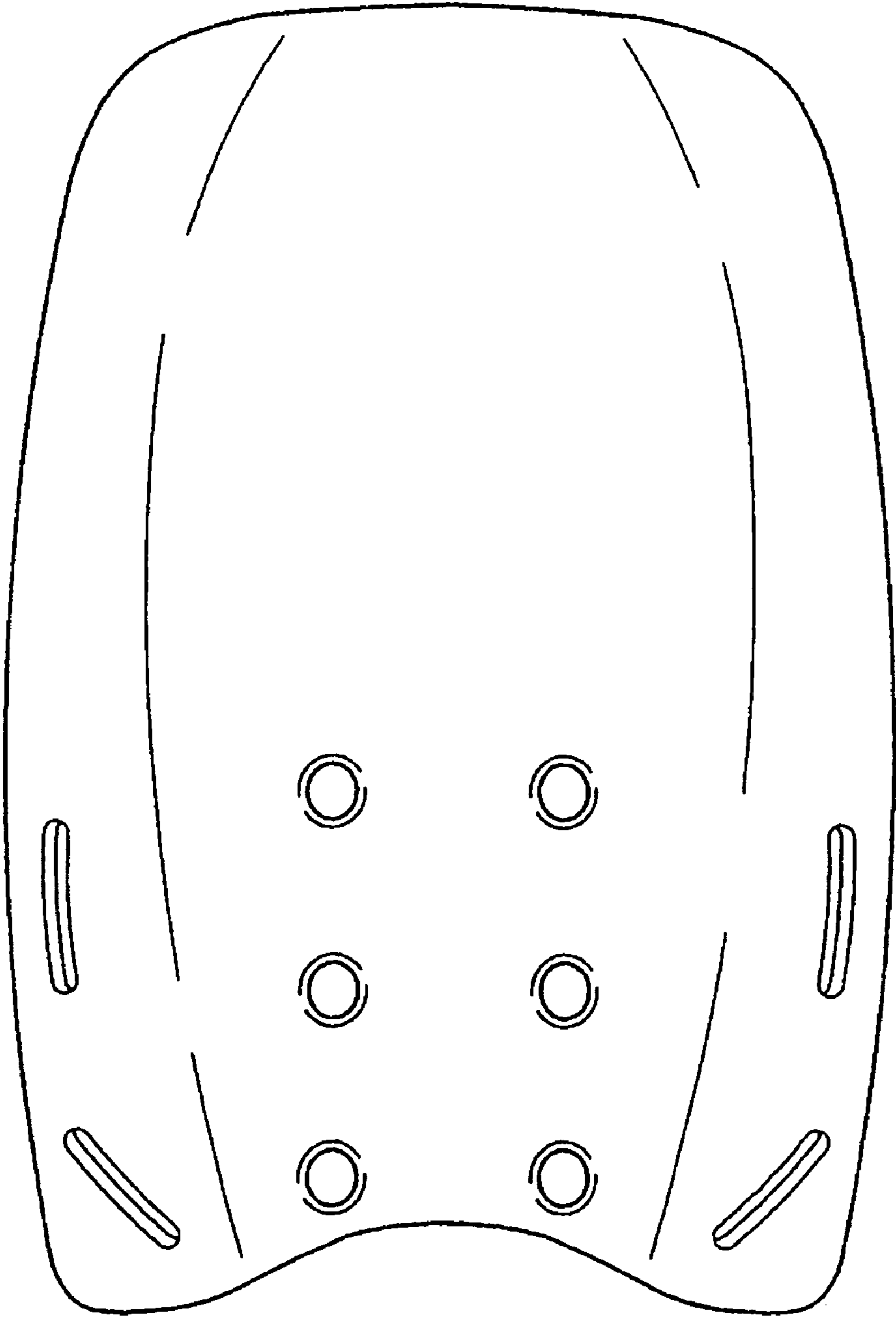

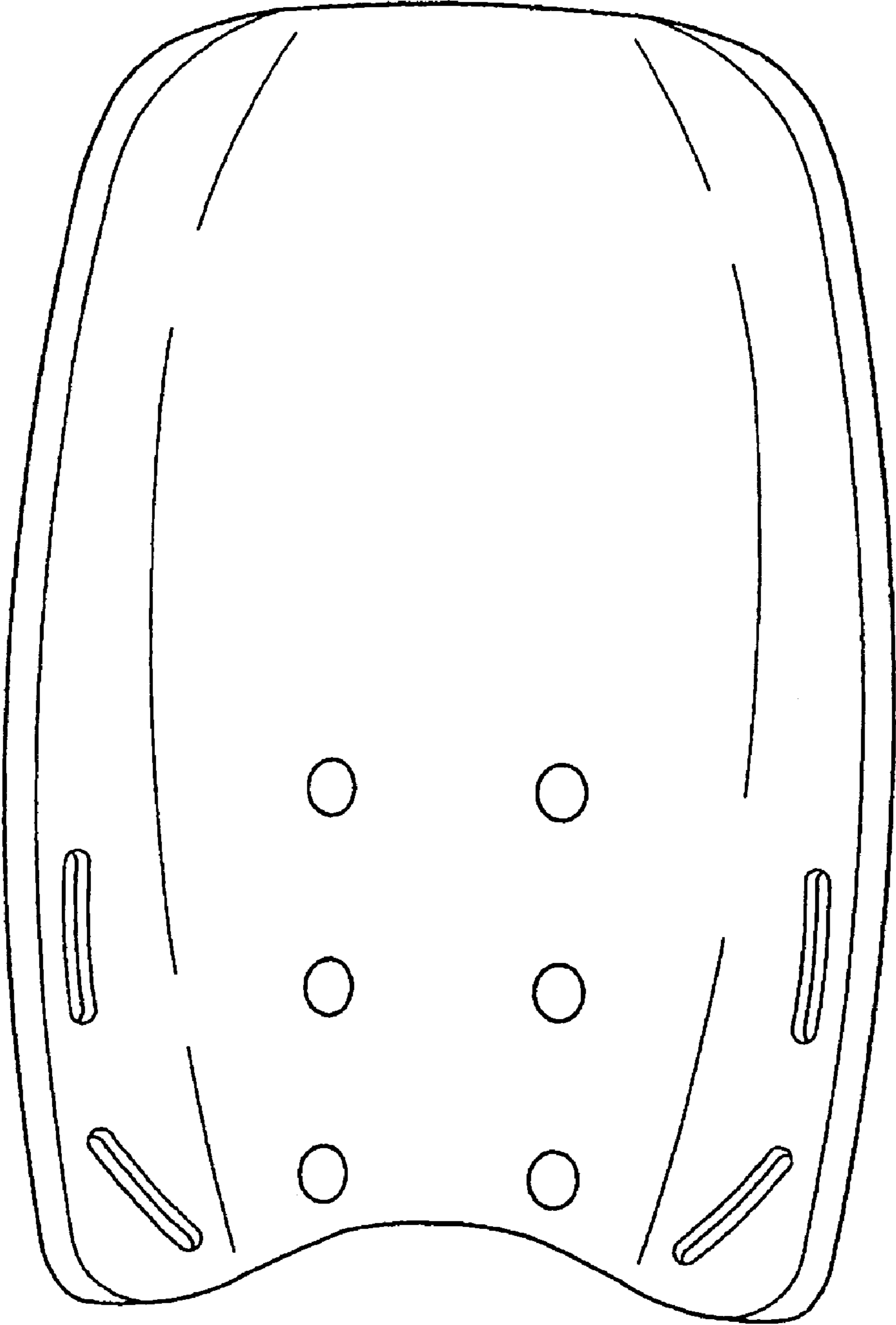

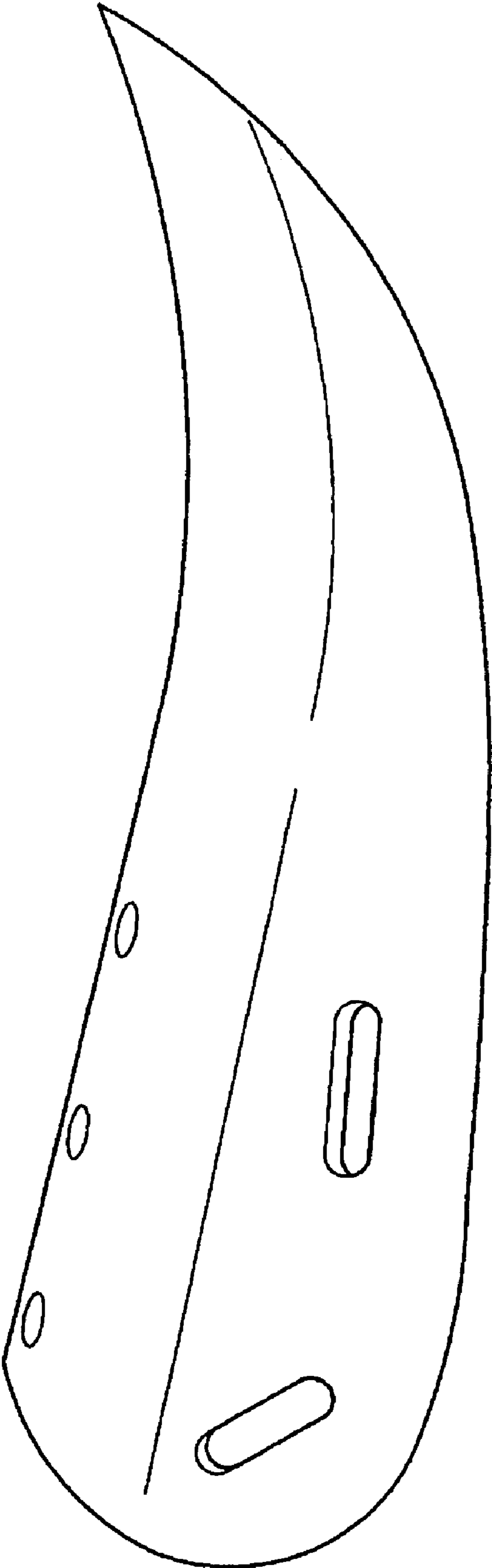

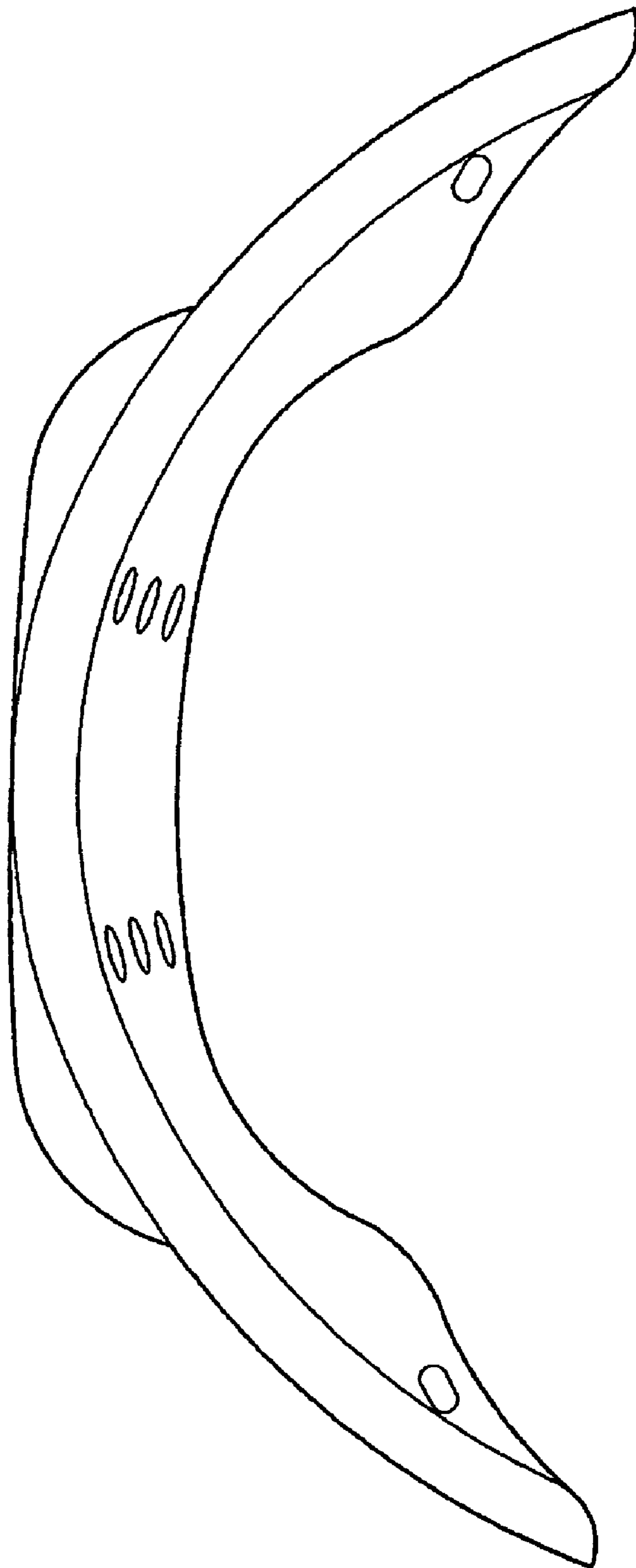

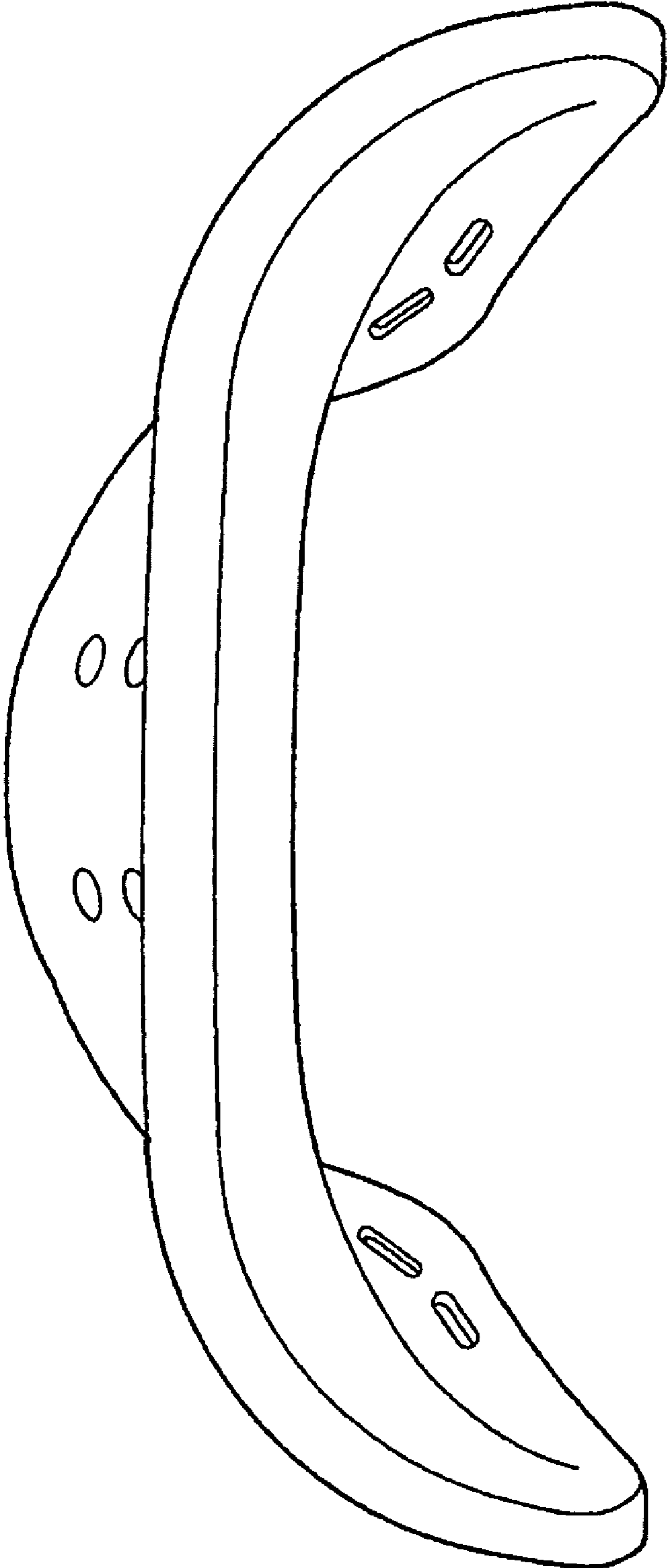
