**DESCRIPTION**

FIG. 17 is a first side view of the iron of FIG. 15;

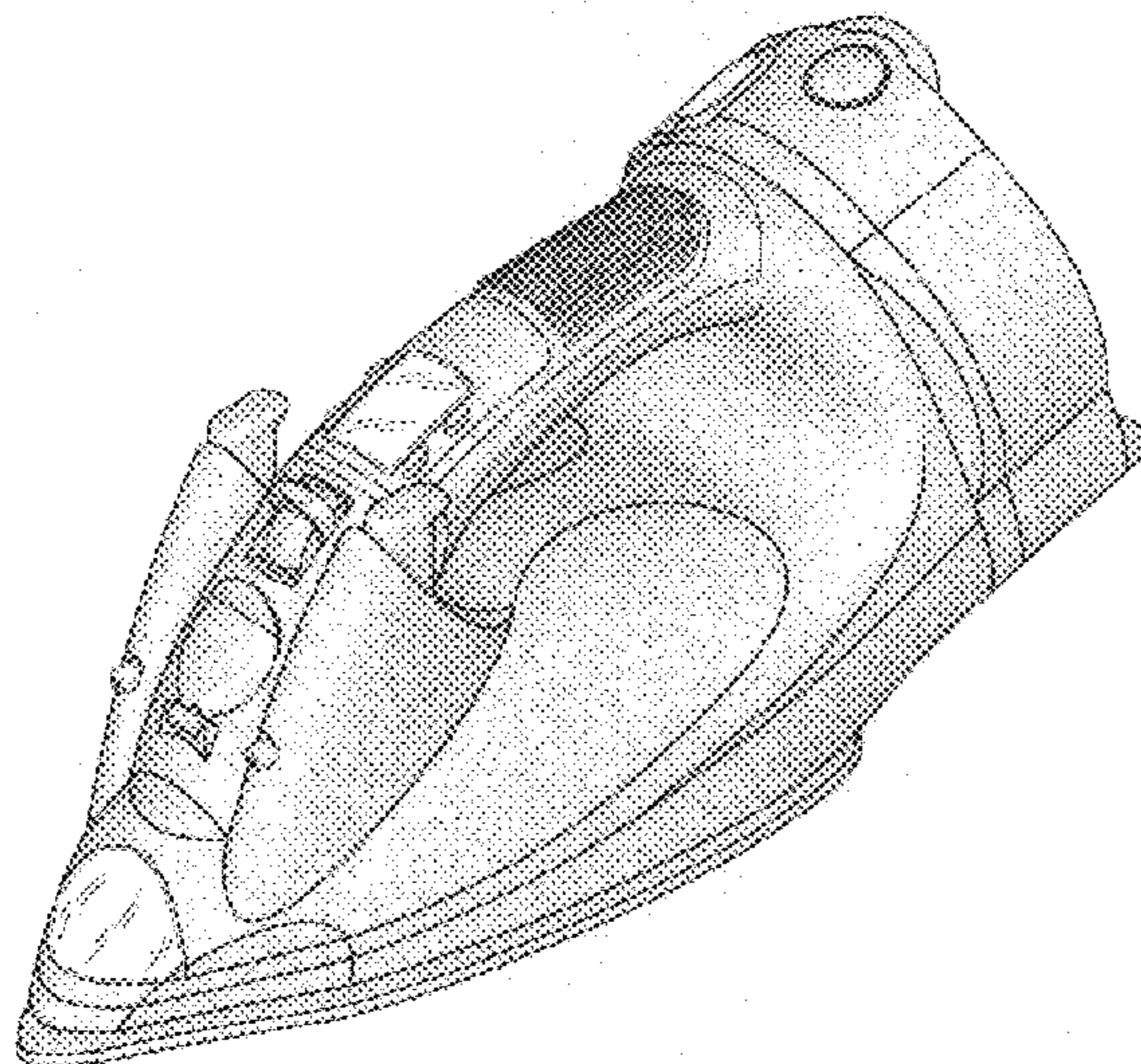
FIG. 18 is a second side view of the iron of FIG. 15, opposite to the first side view of FIG. 17;

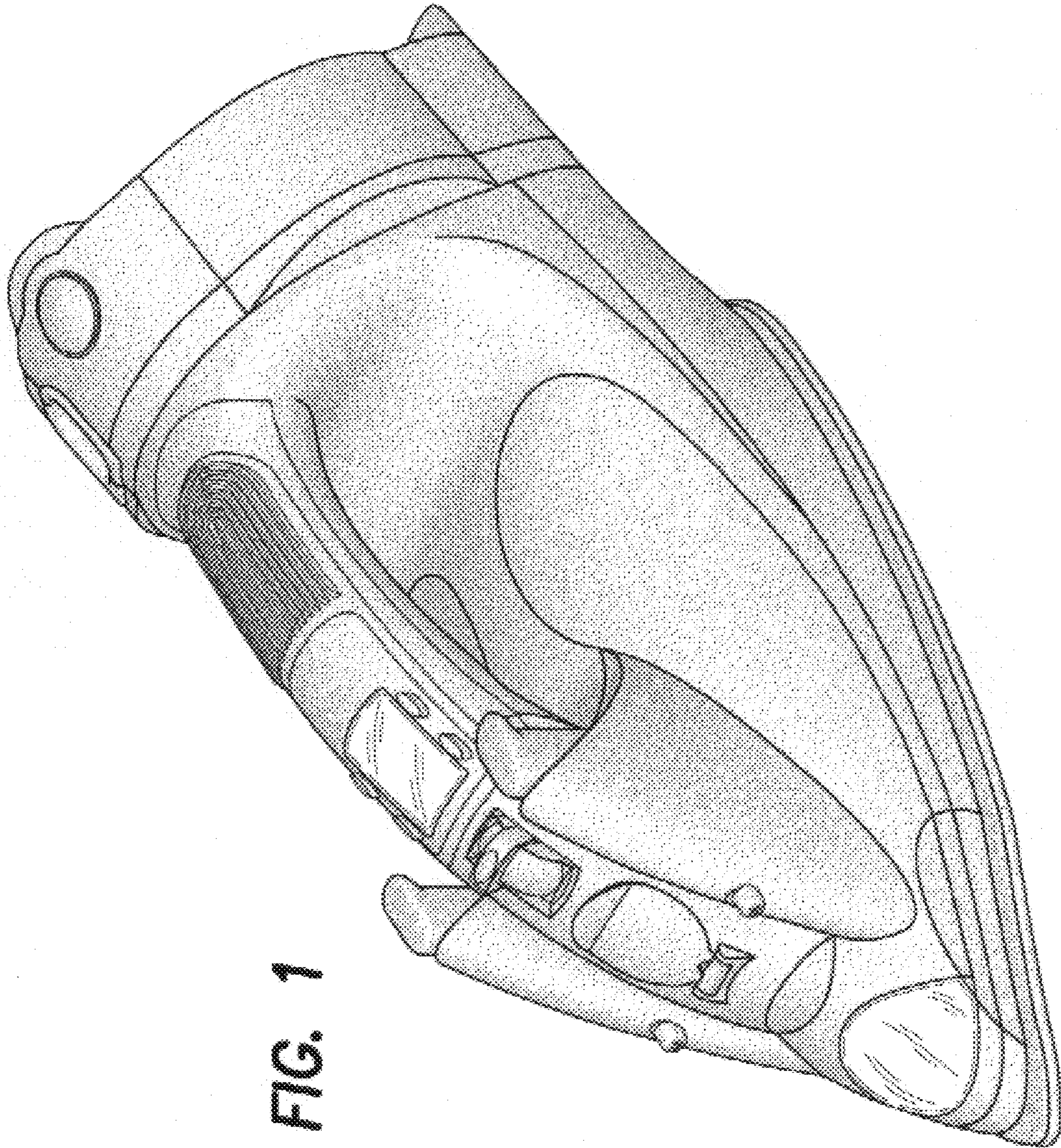

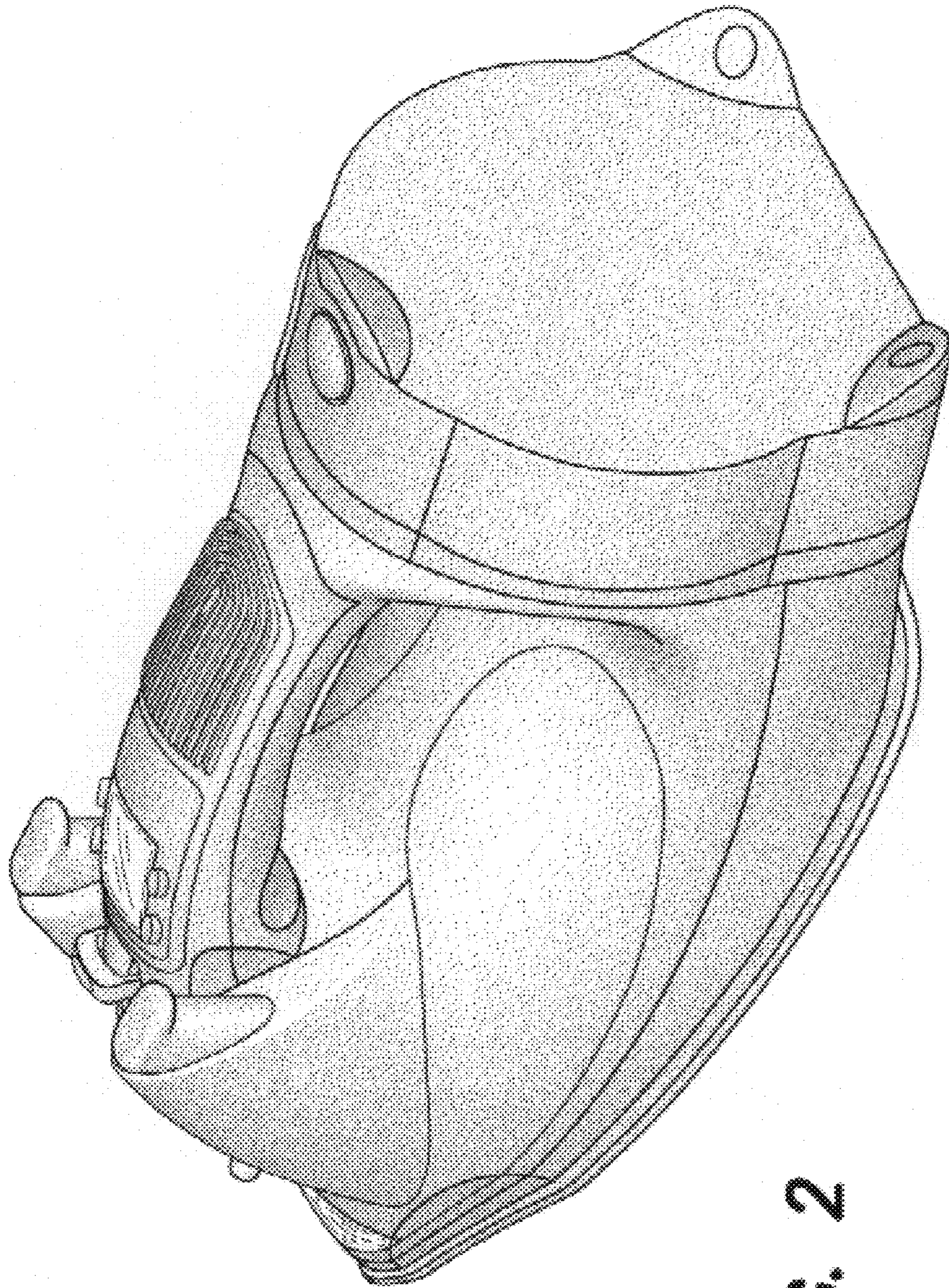
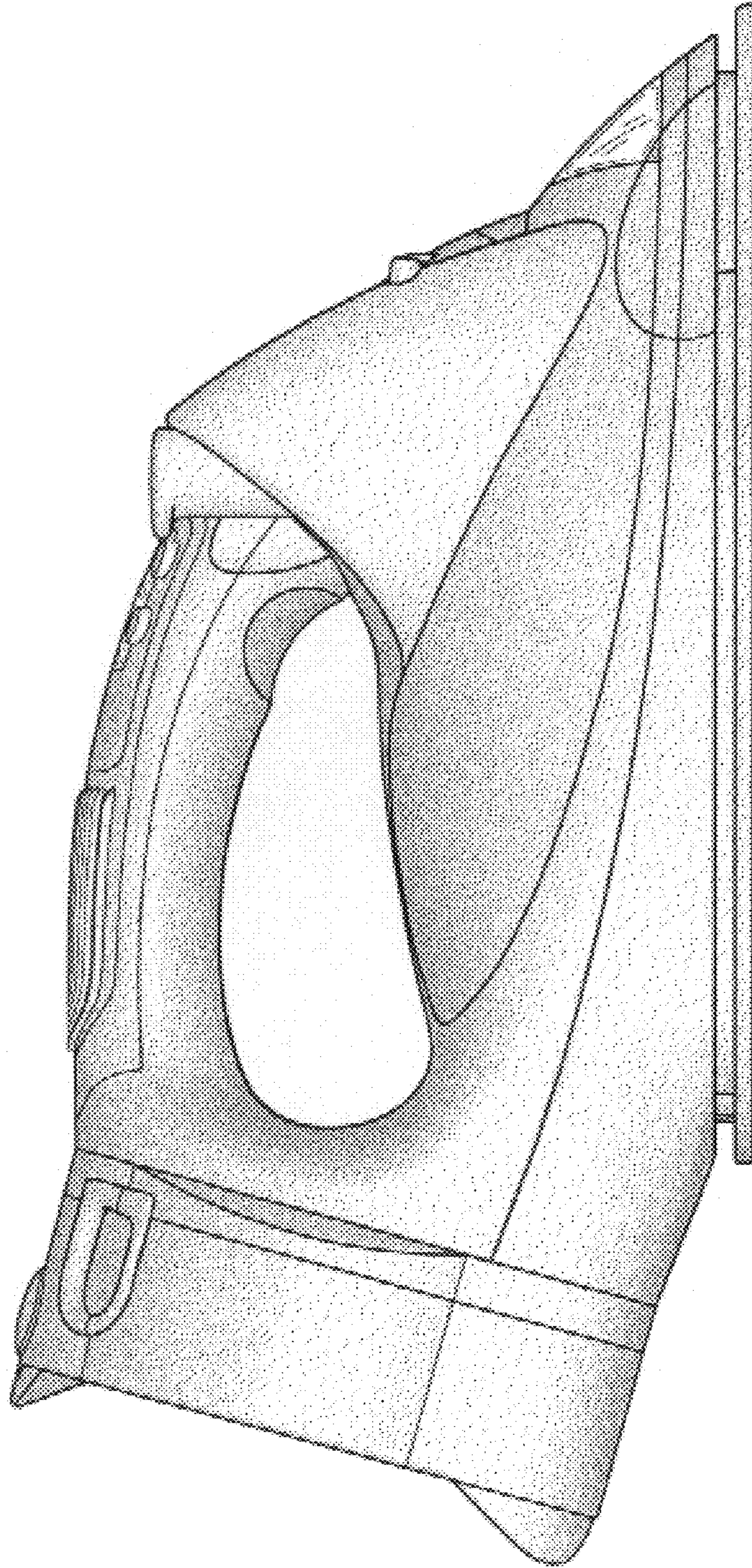

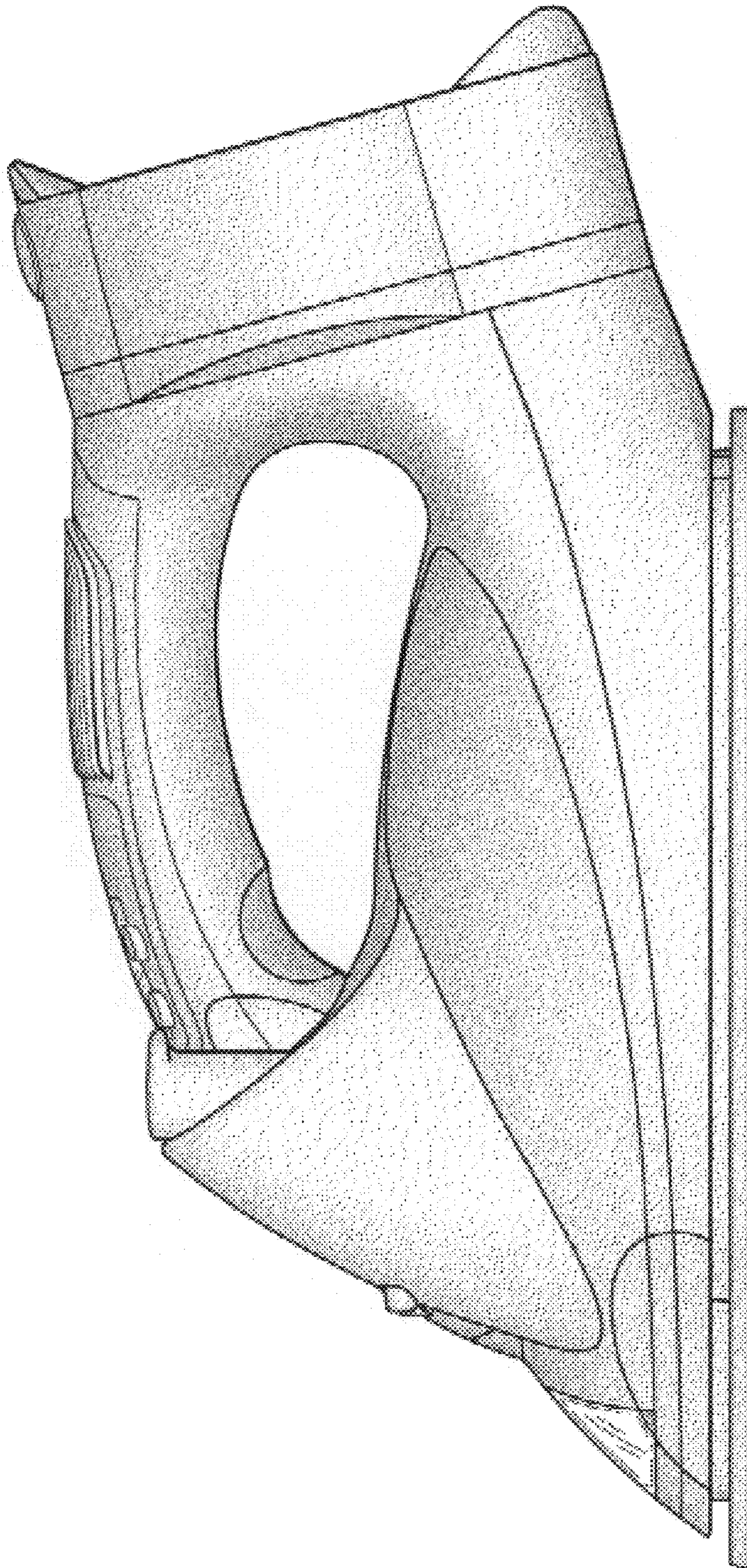

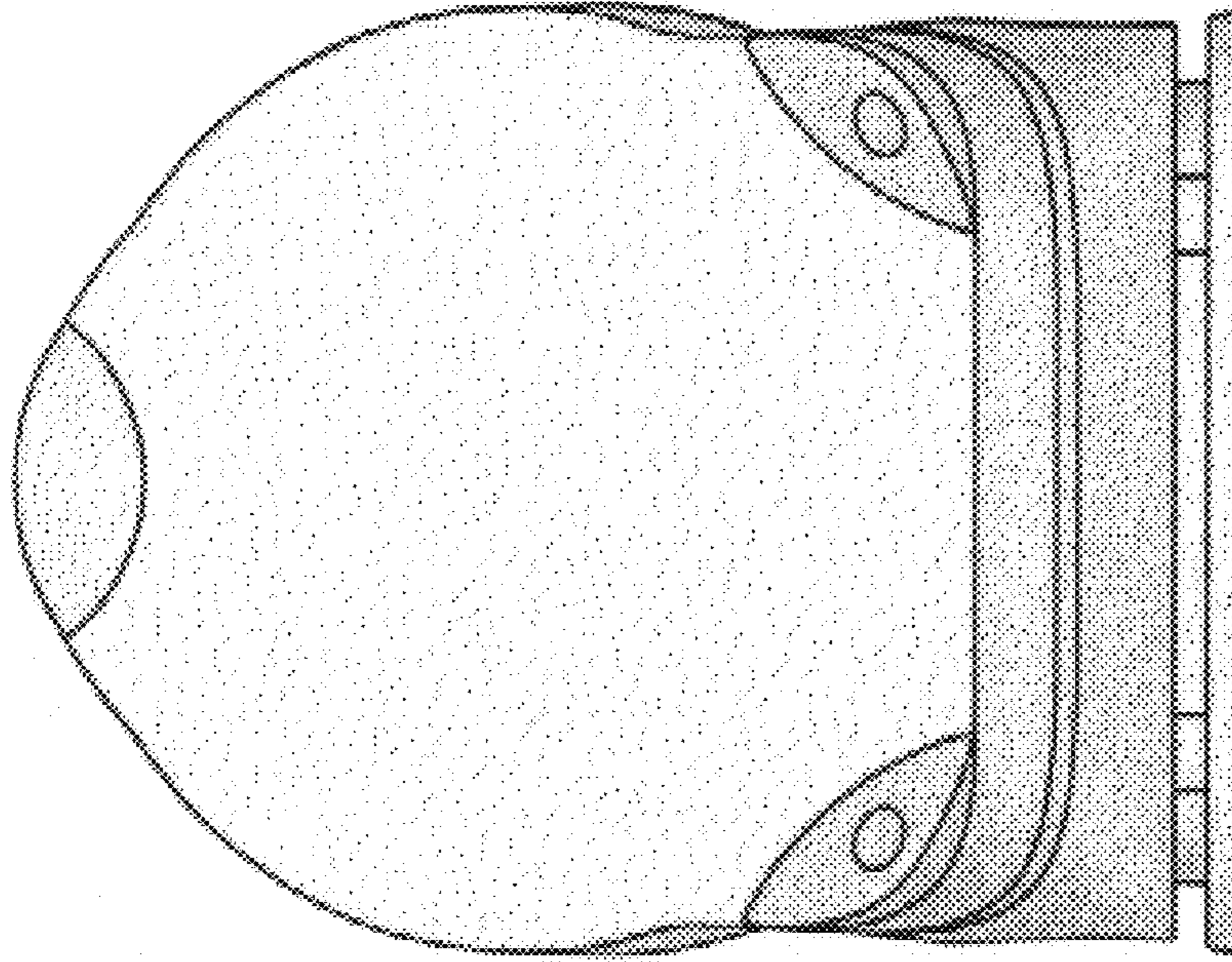

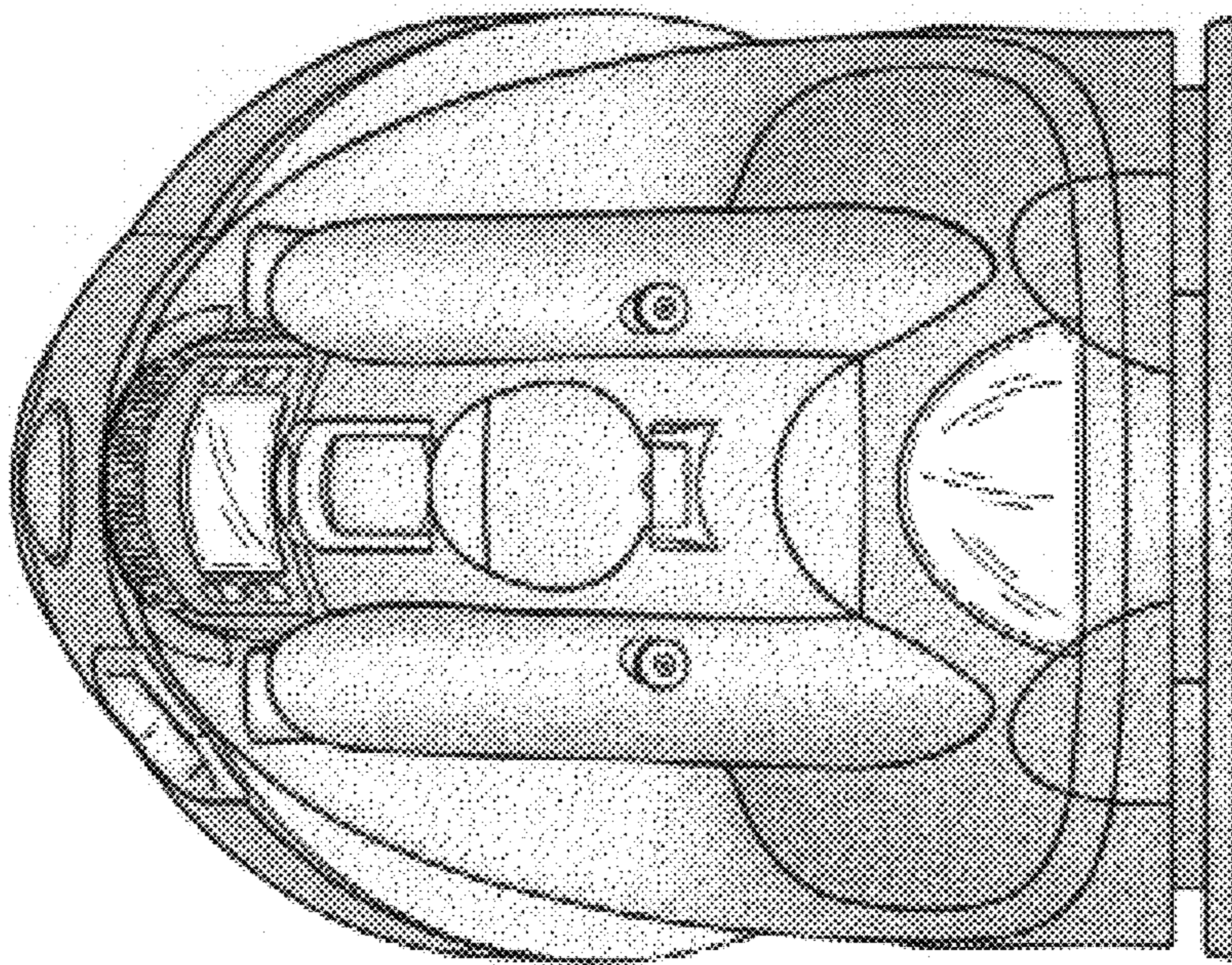

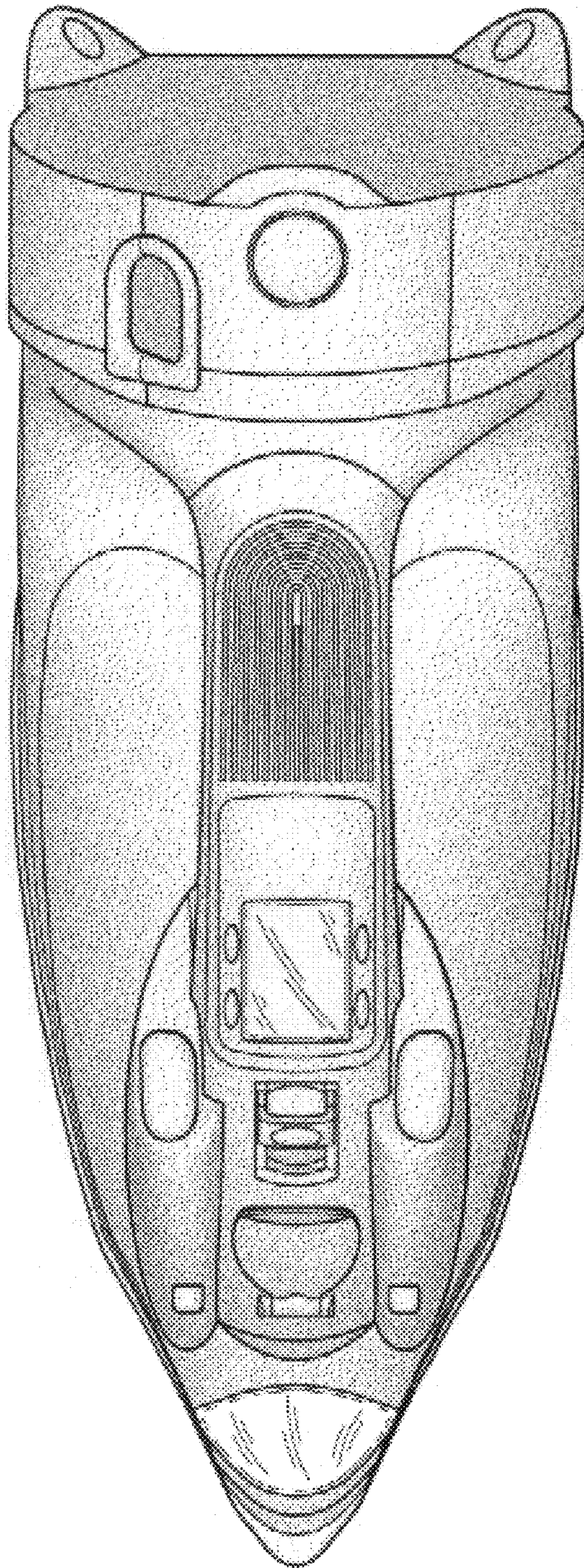

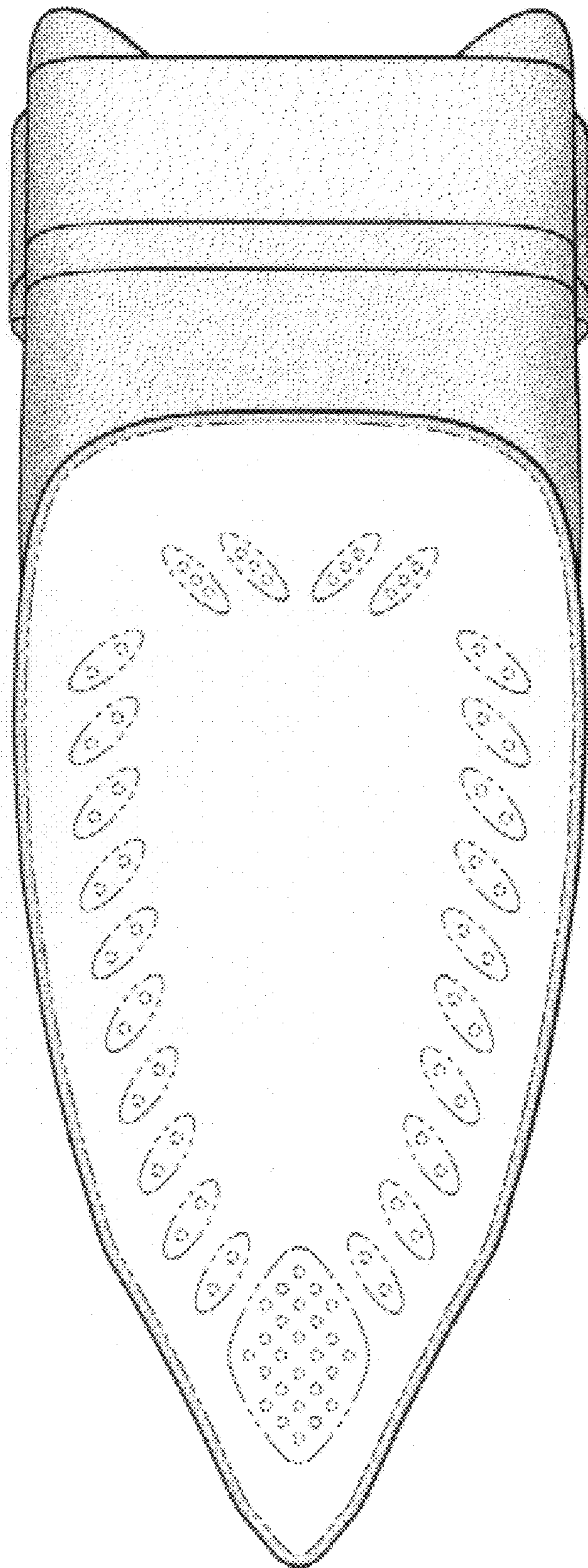

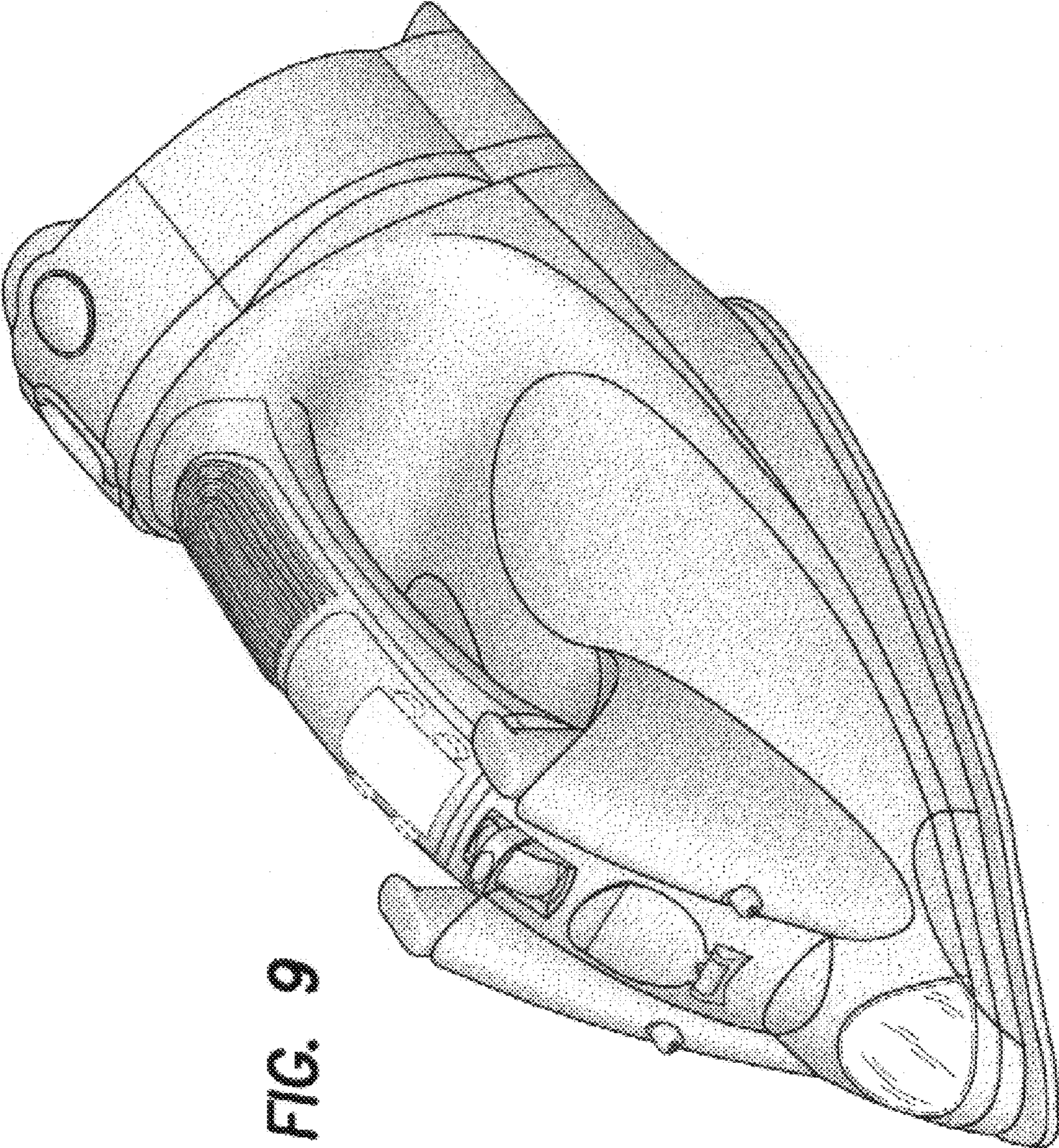

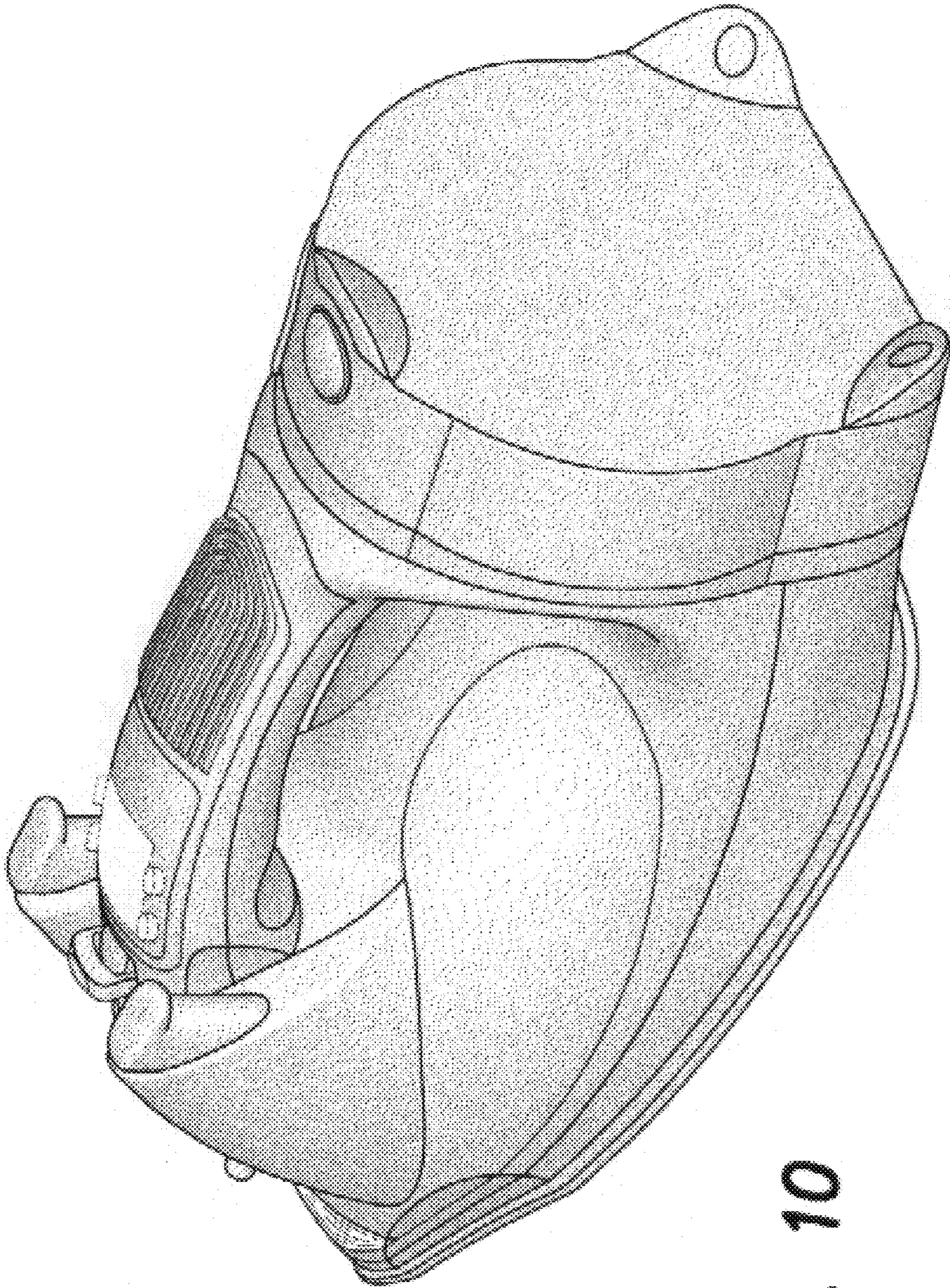

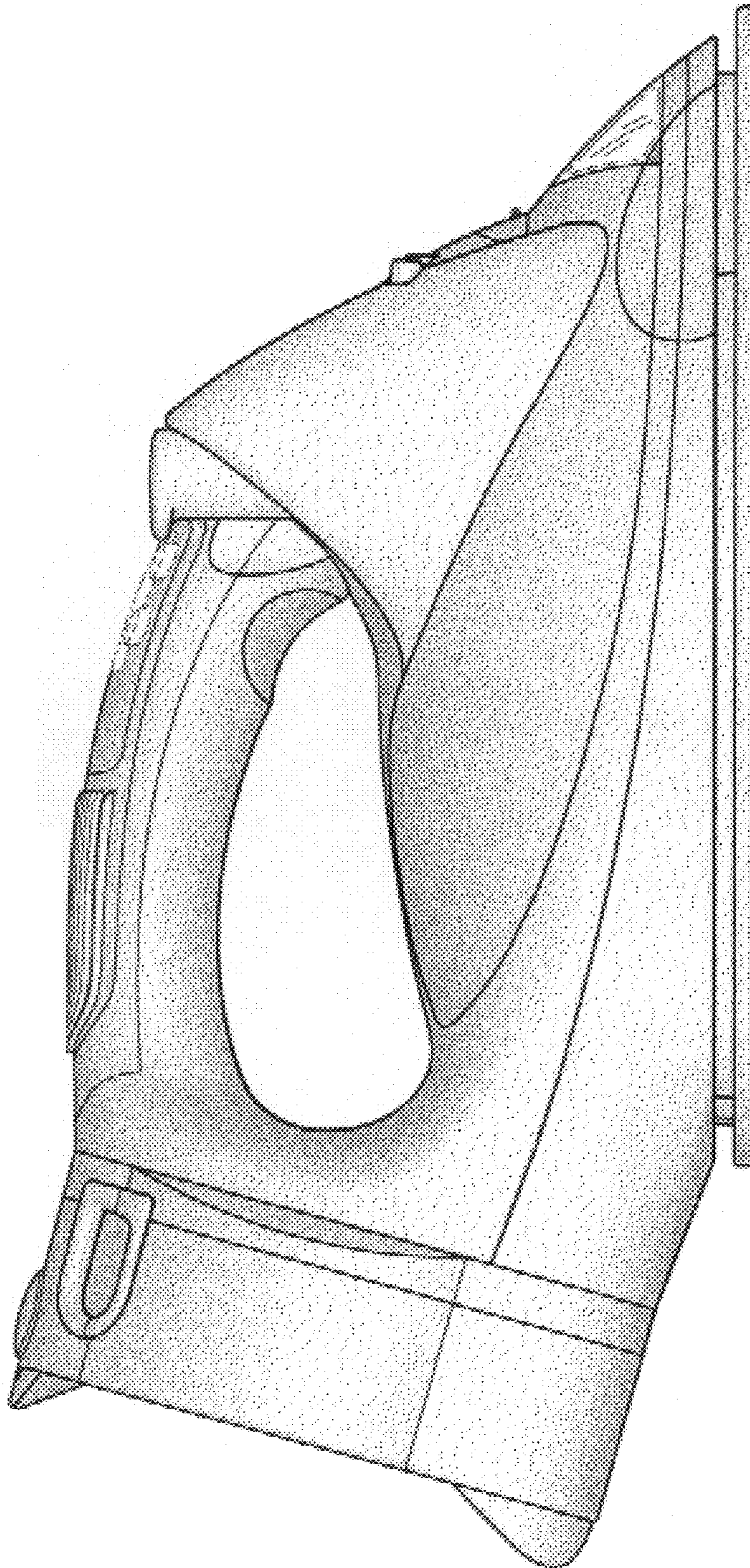

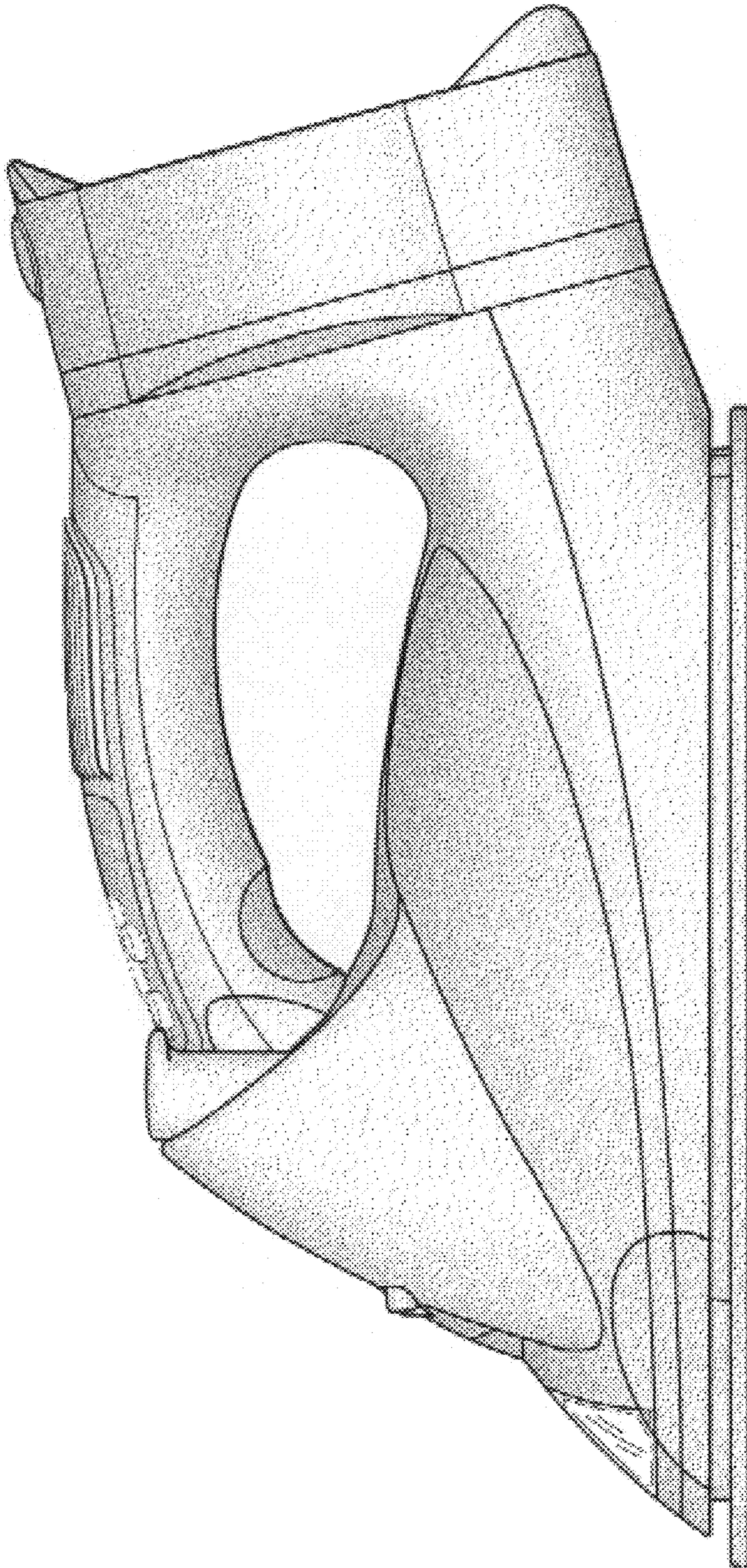

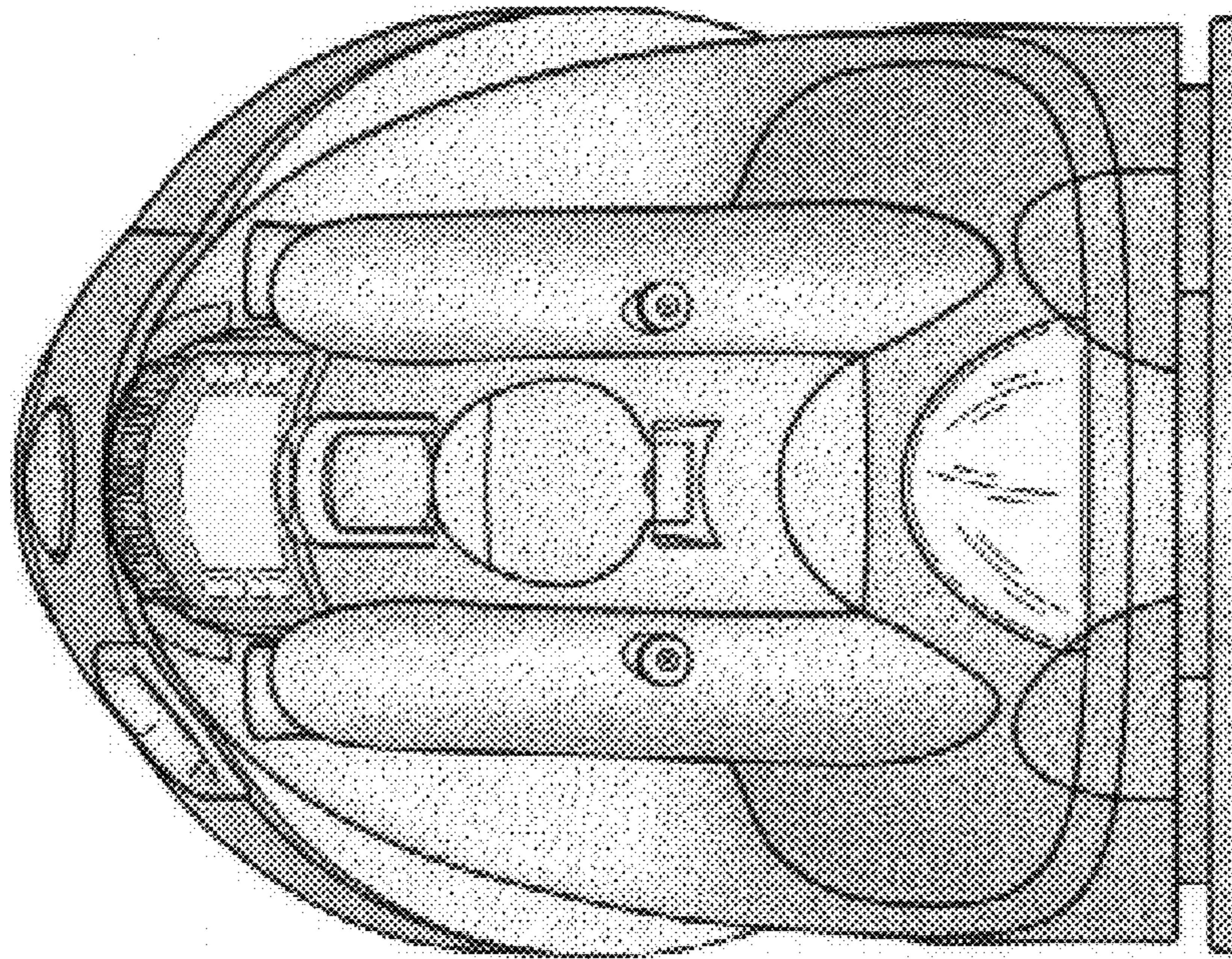

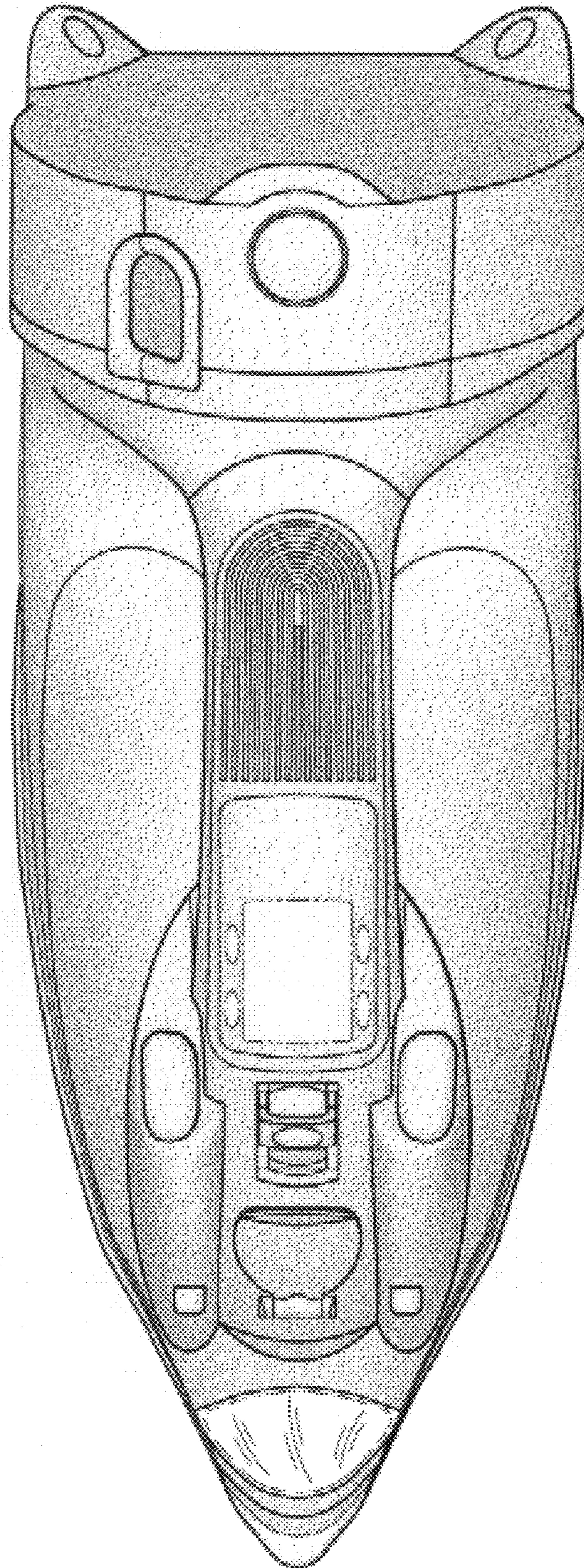

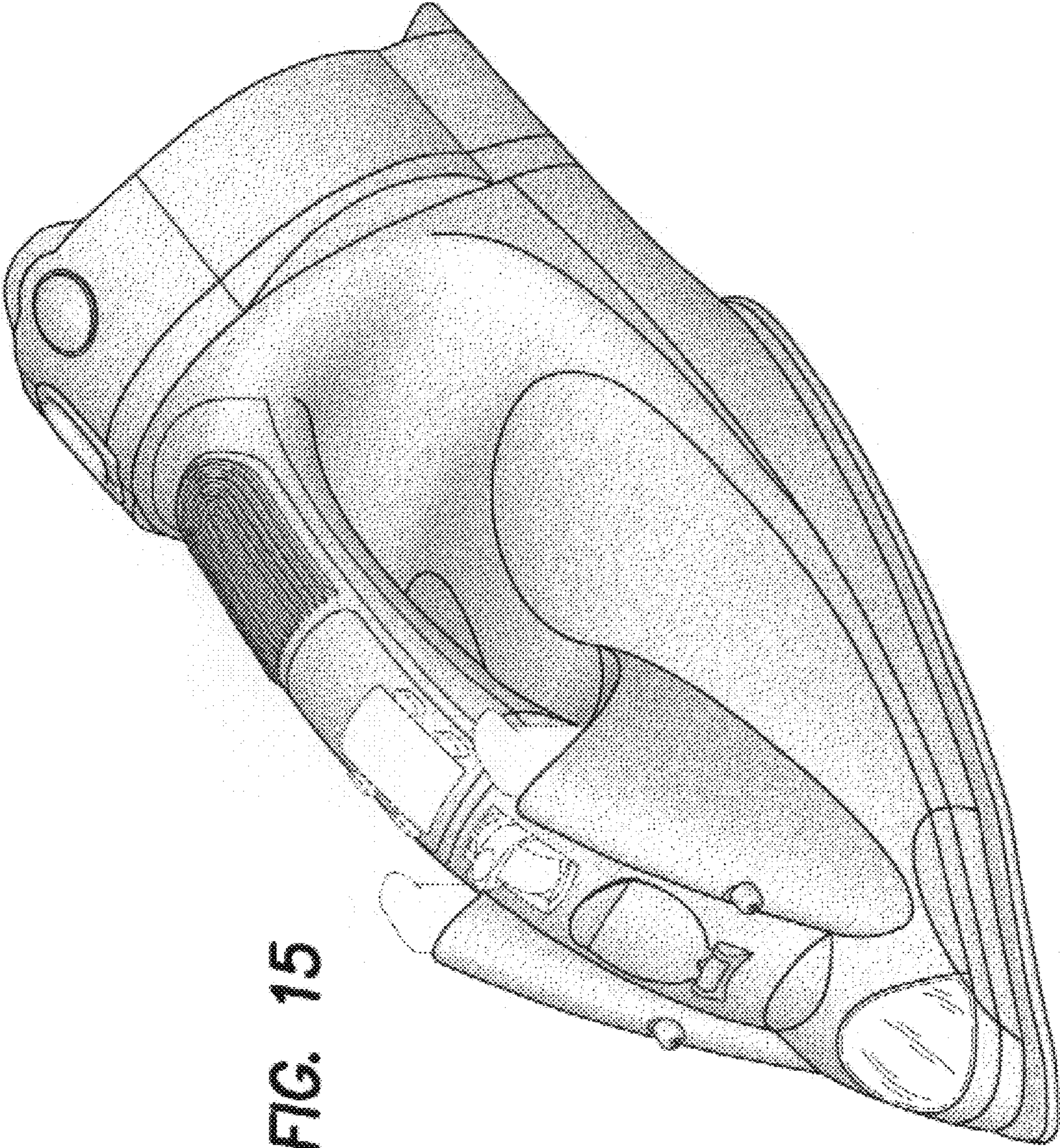

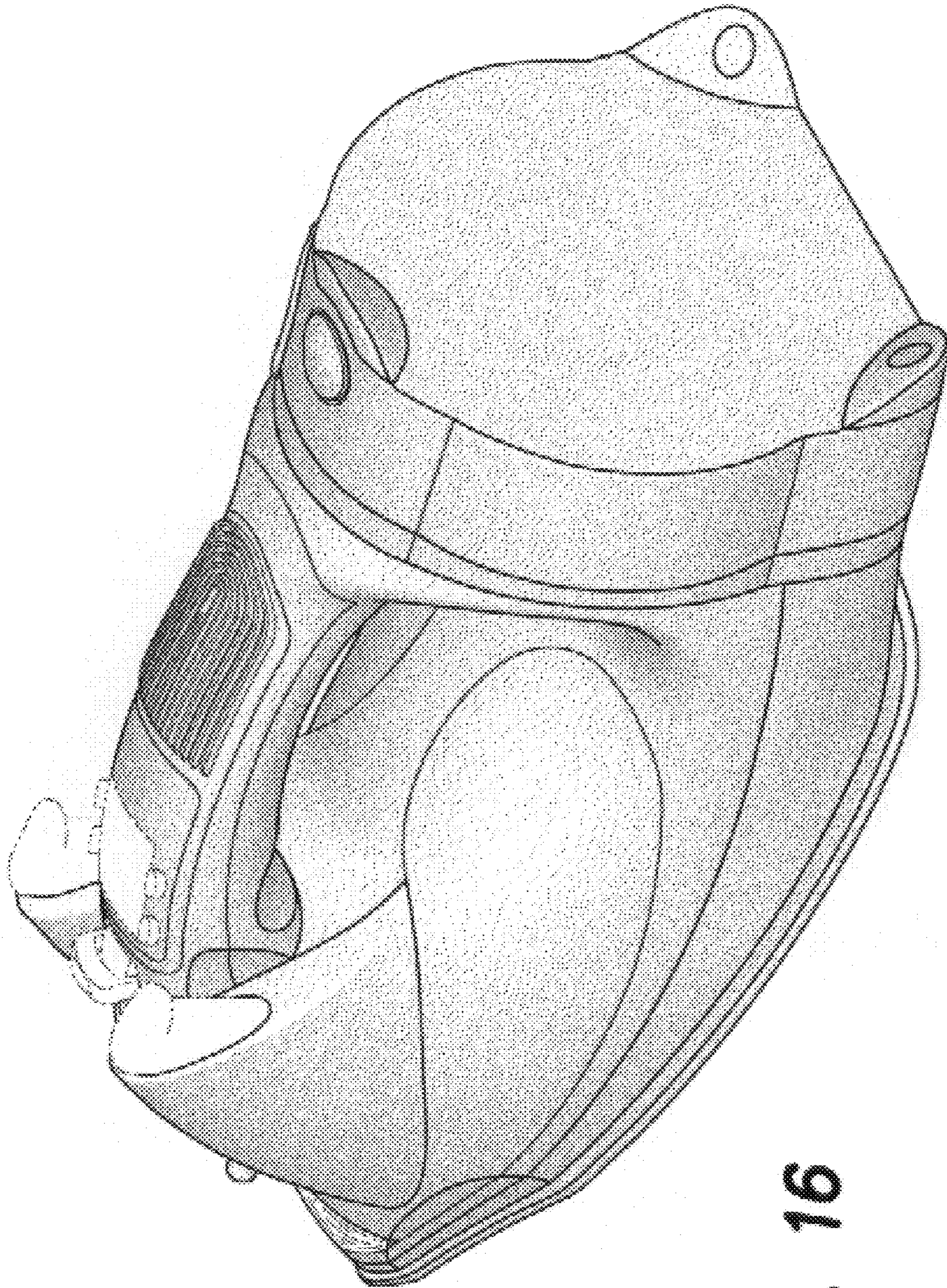

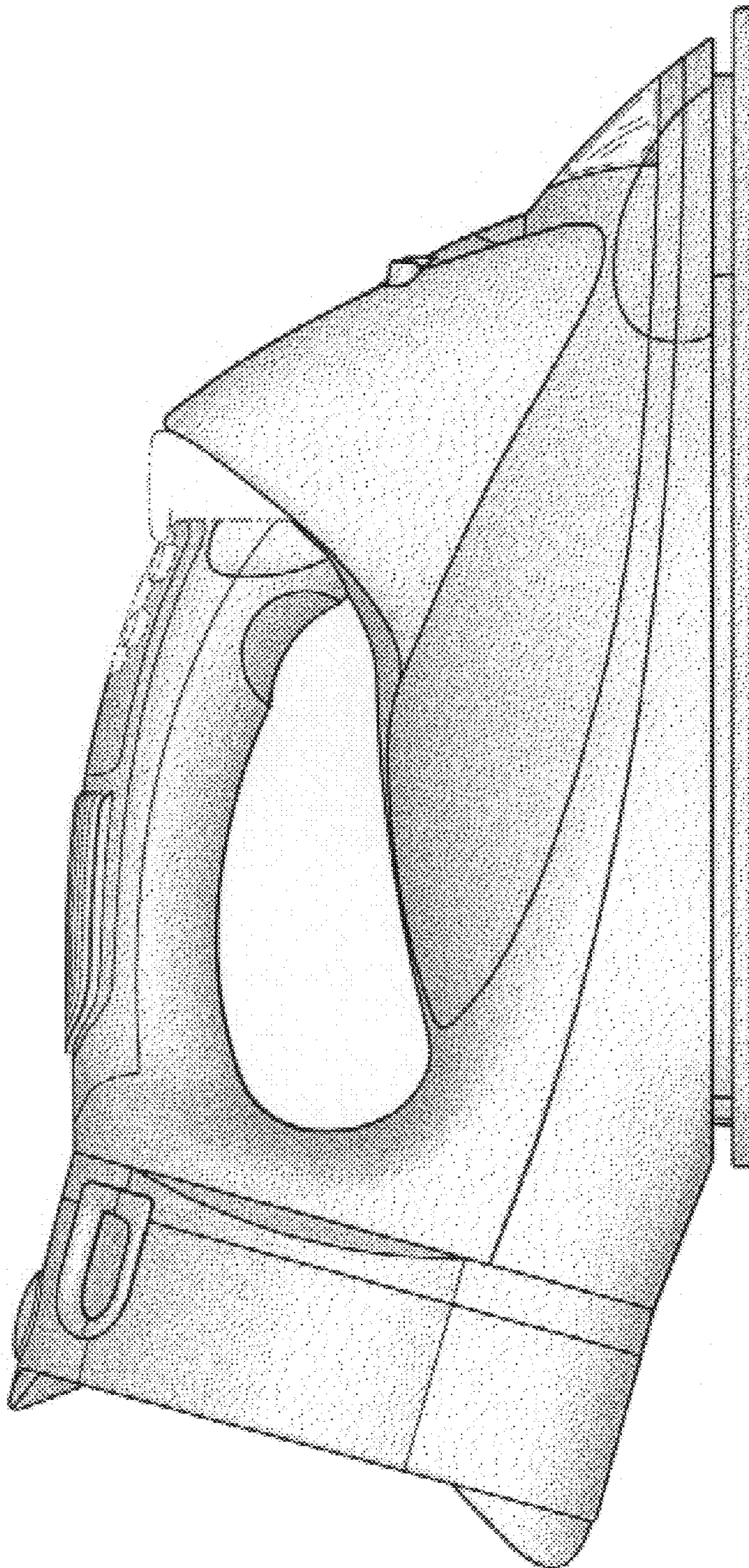

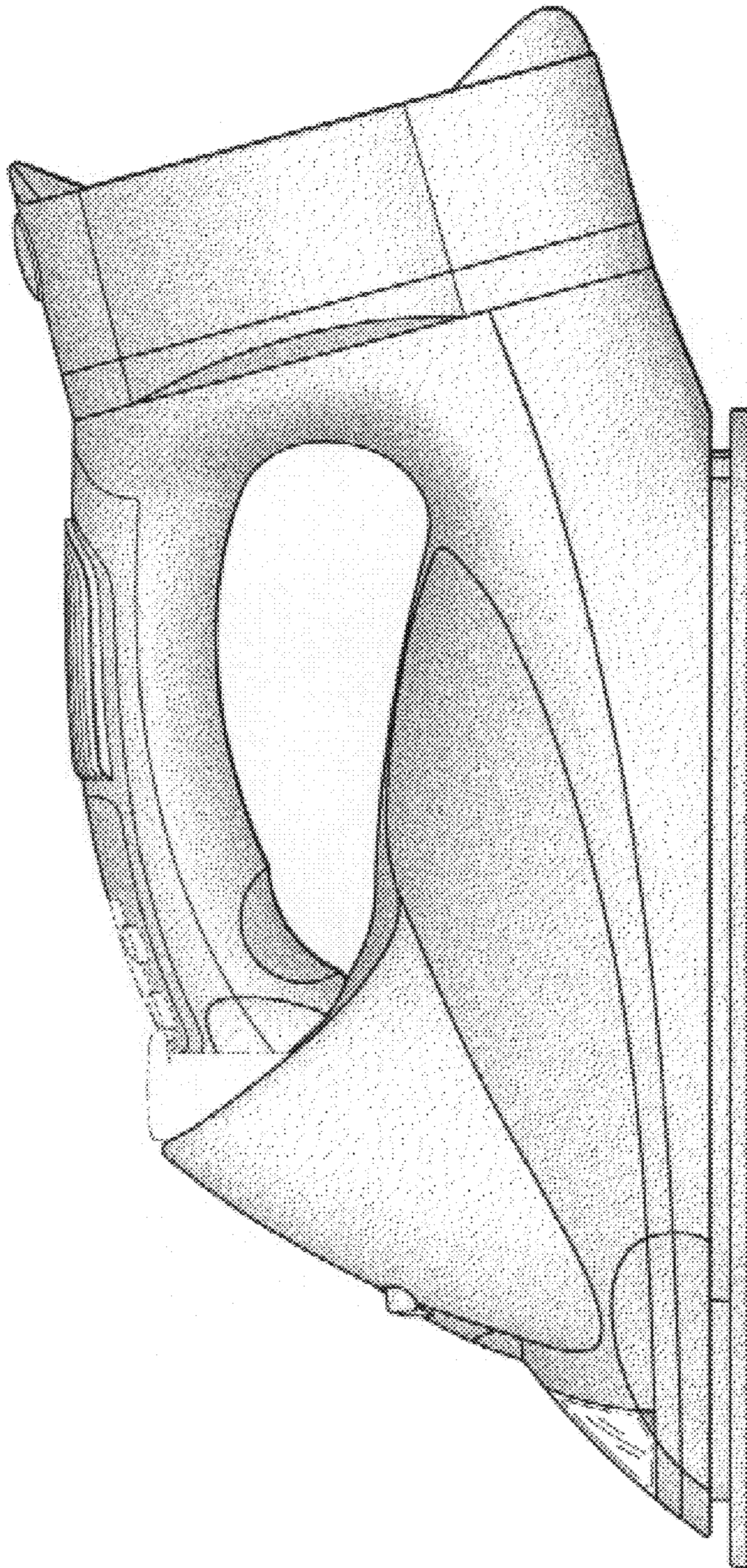

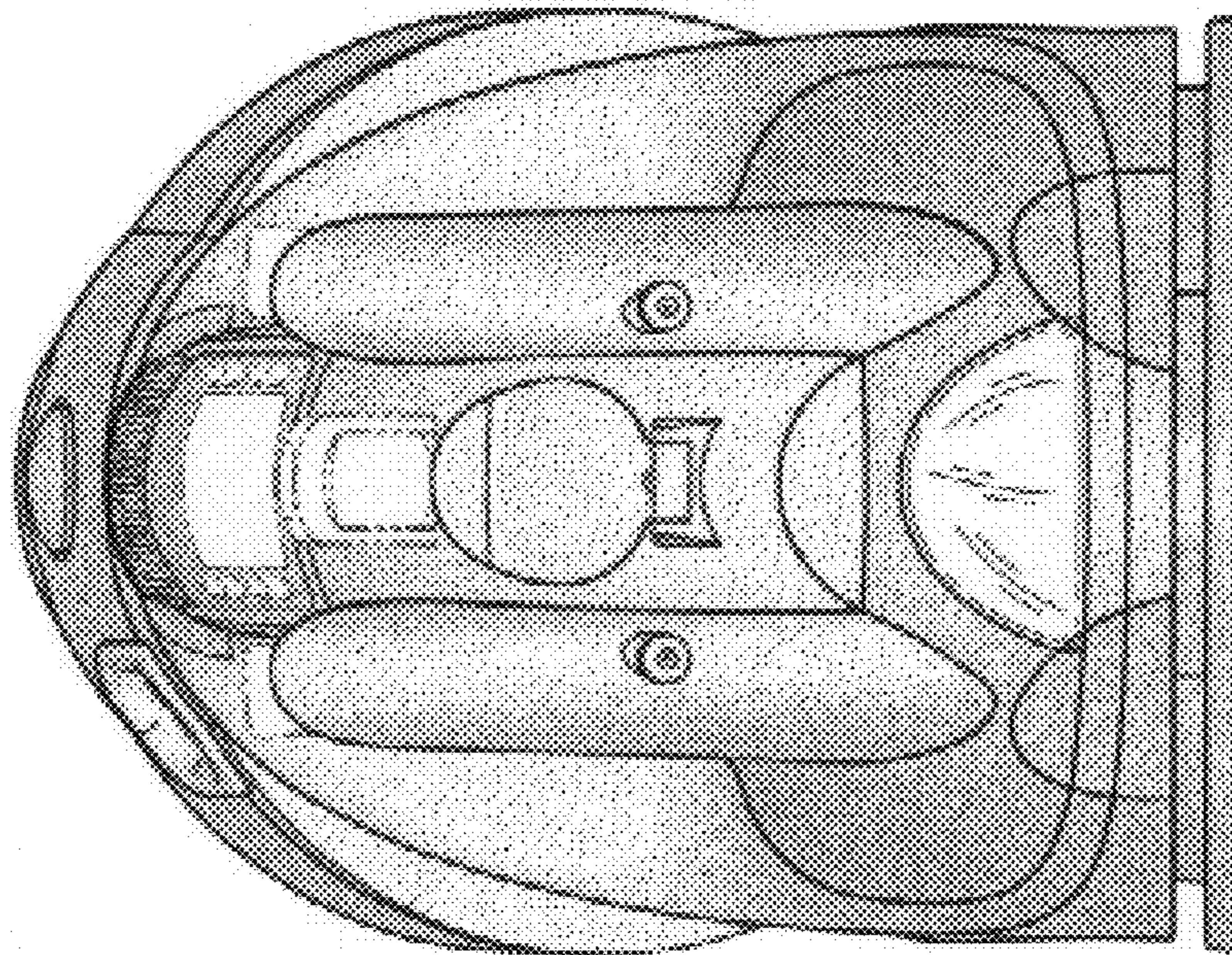

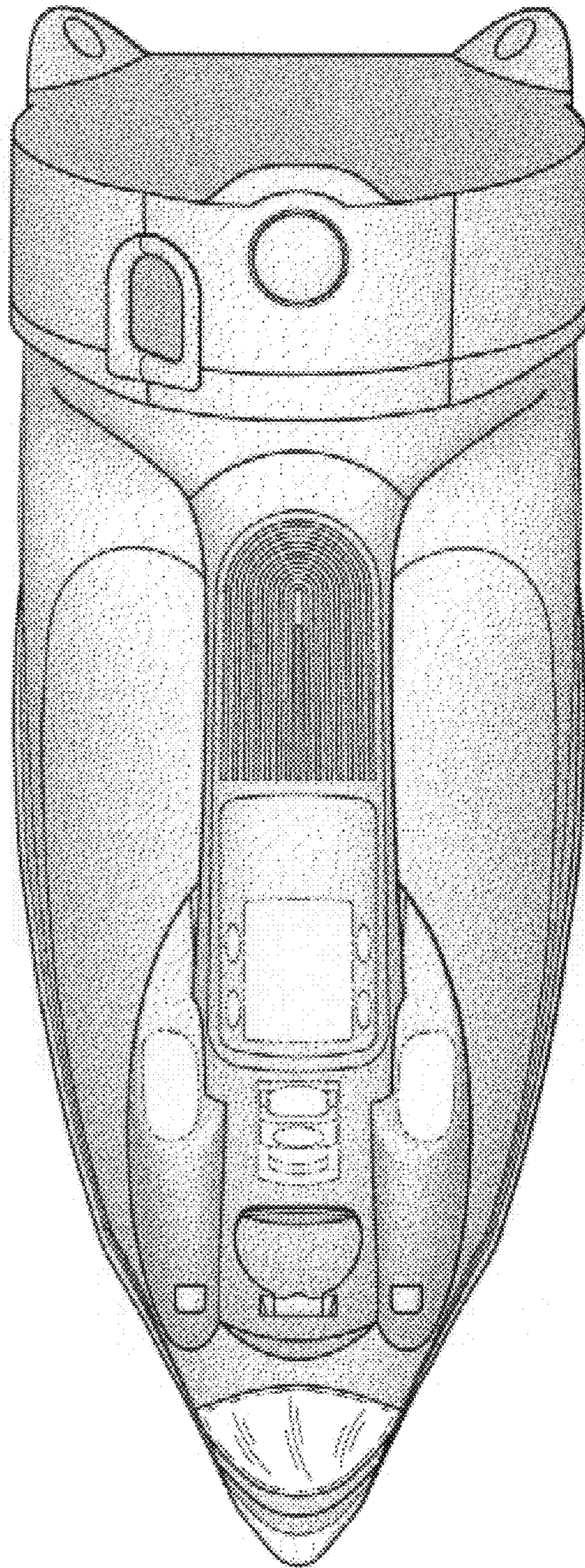
