**DESCRIPTION**

FIG. 8 is a back elevational view thereof;

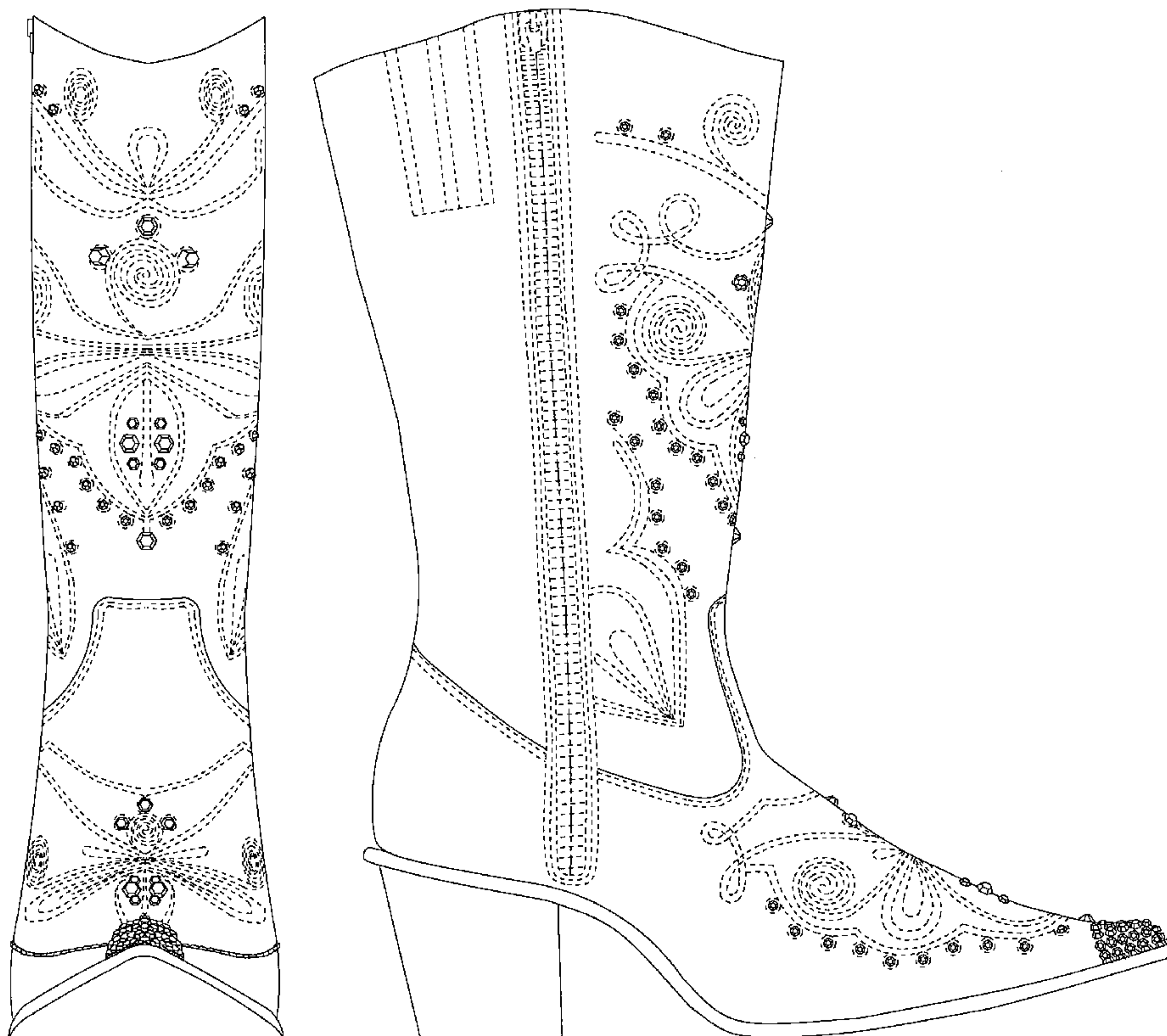
FIG. 9 is a left side elevational view thereof;

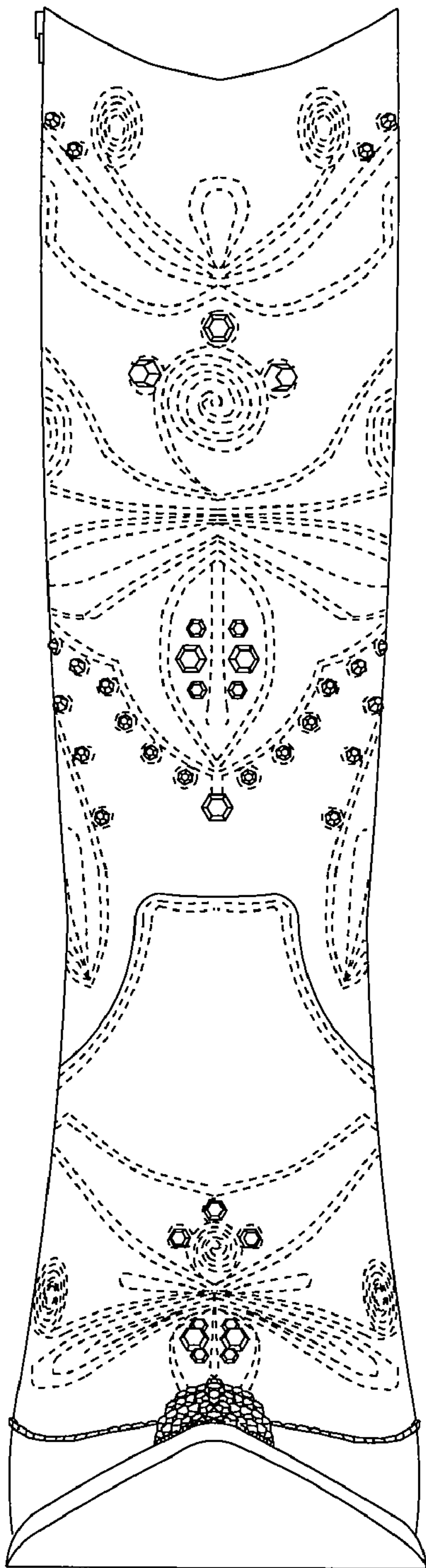

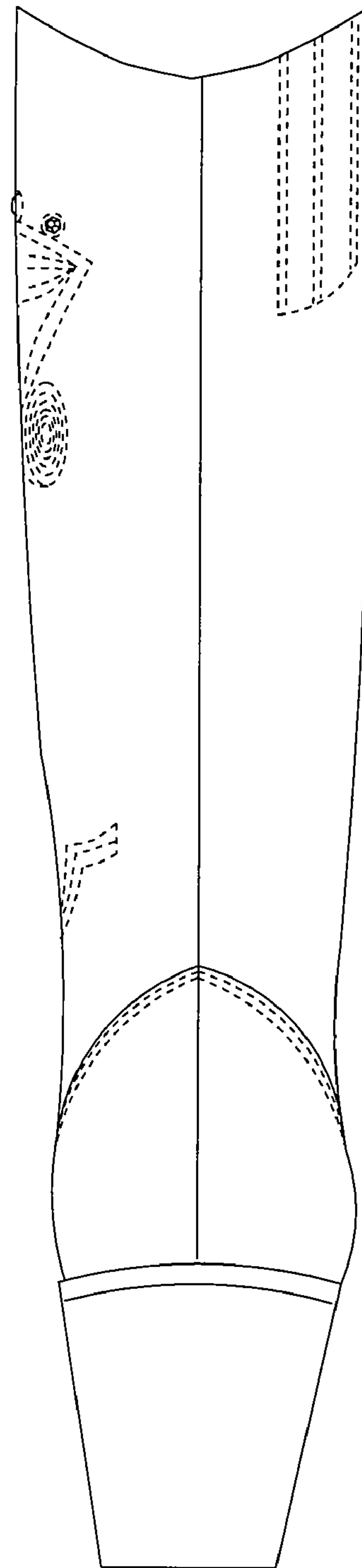

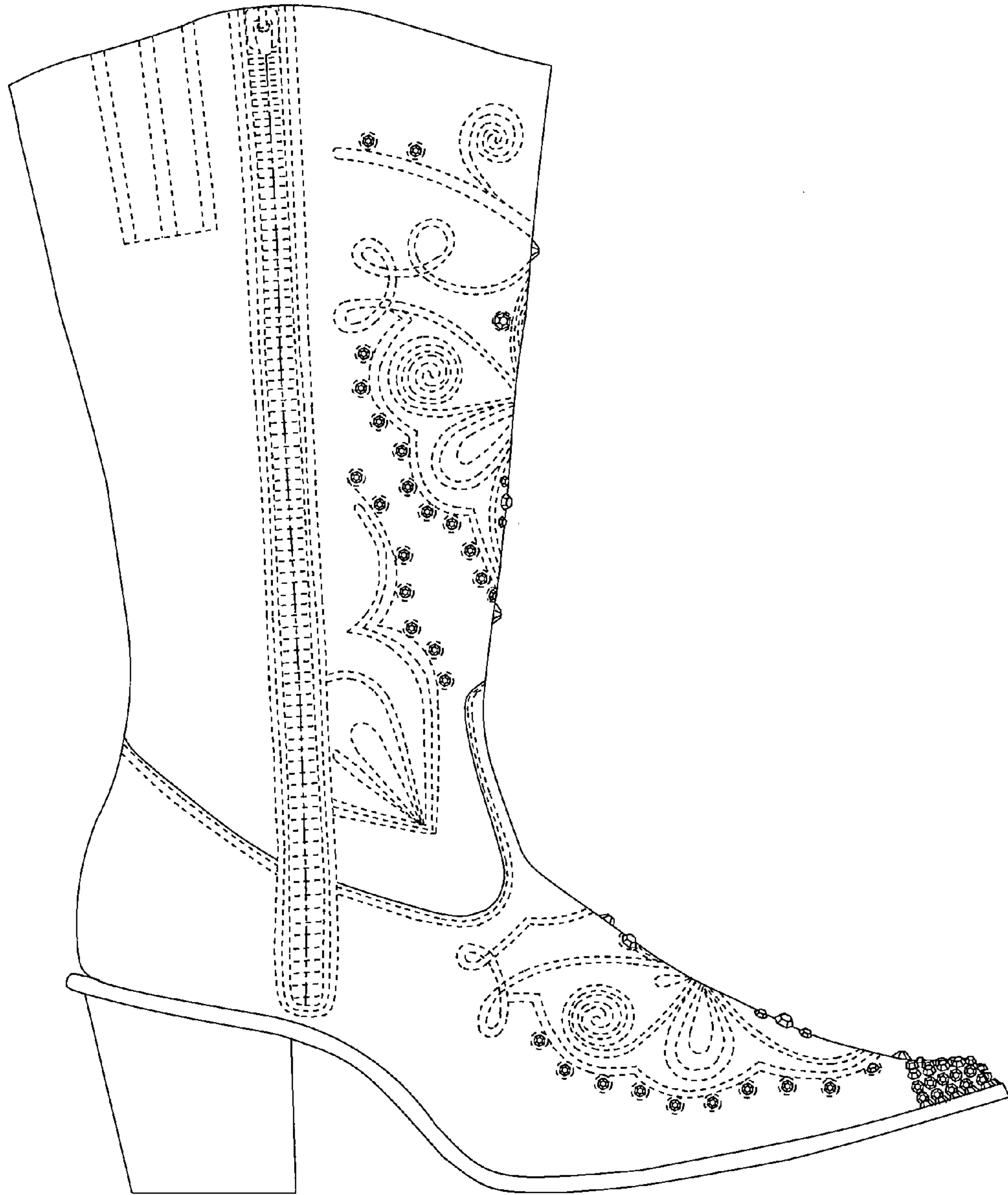

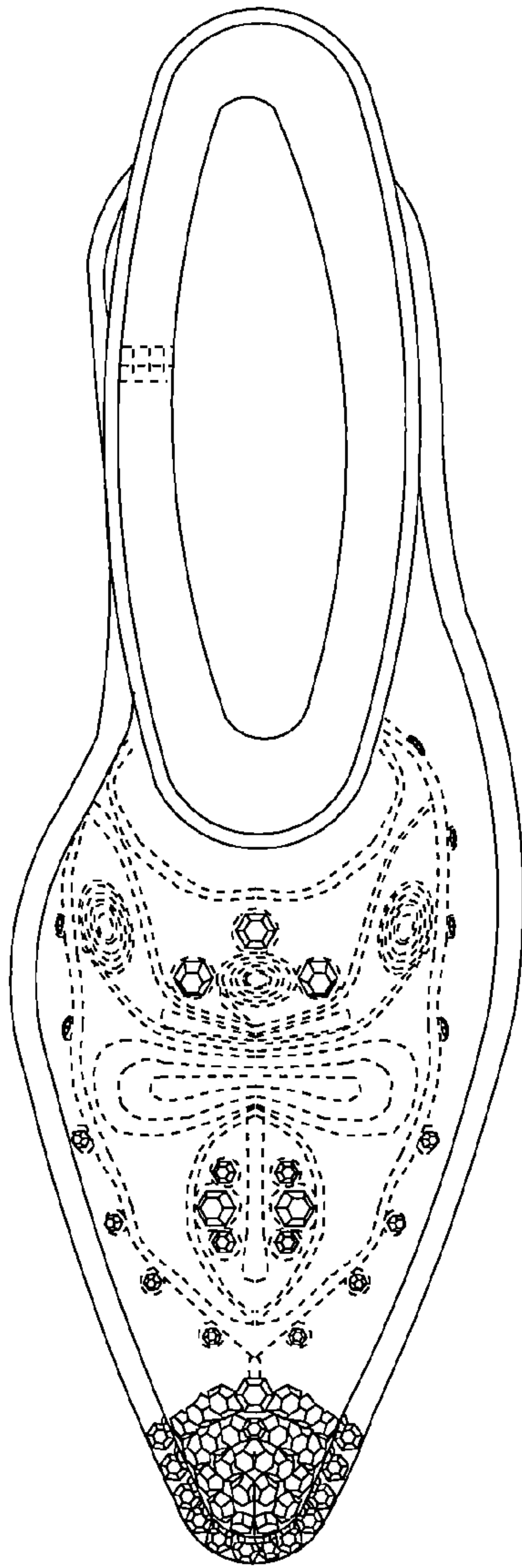

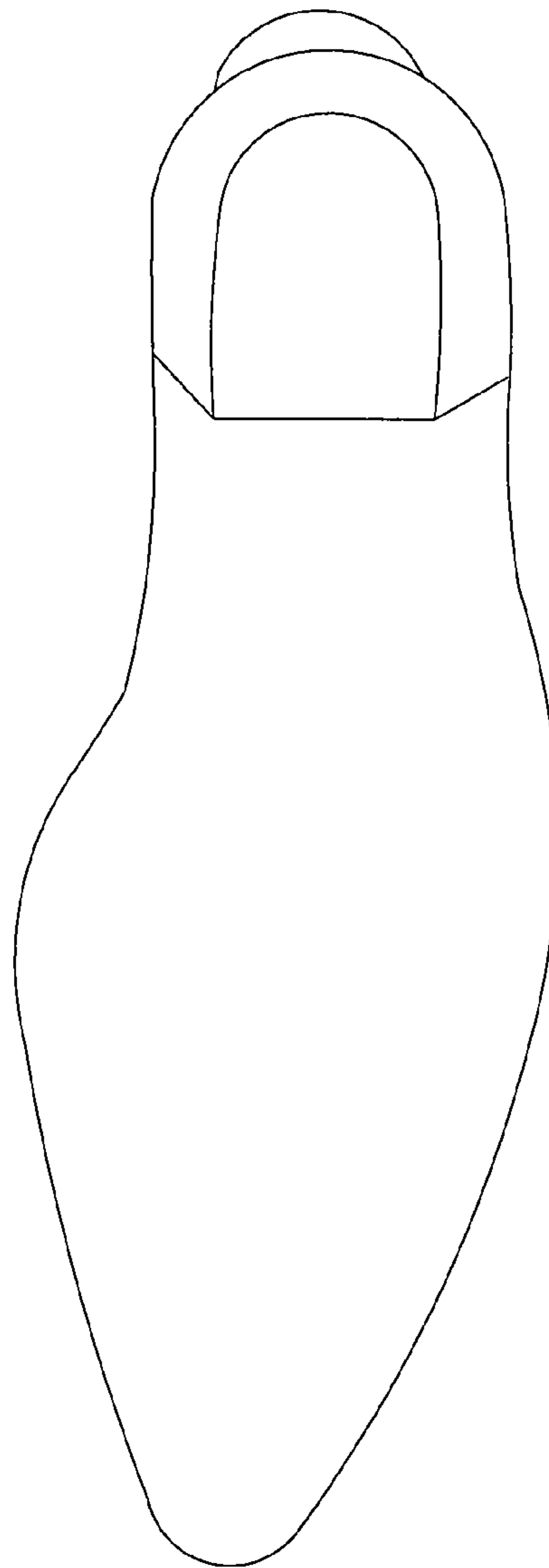

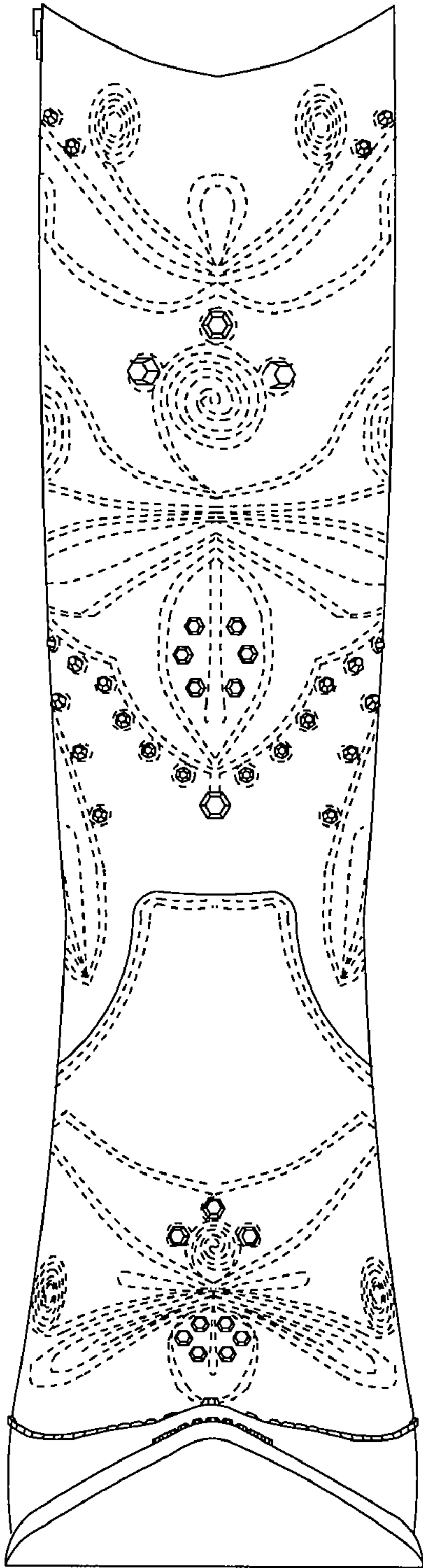

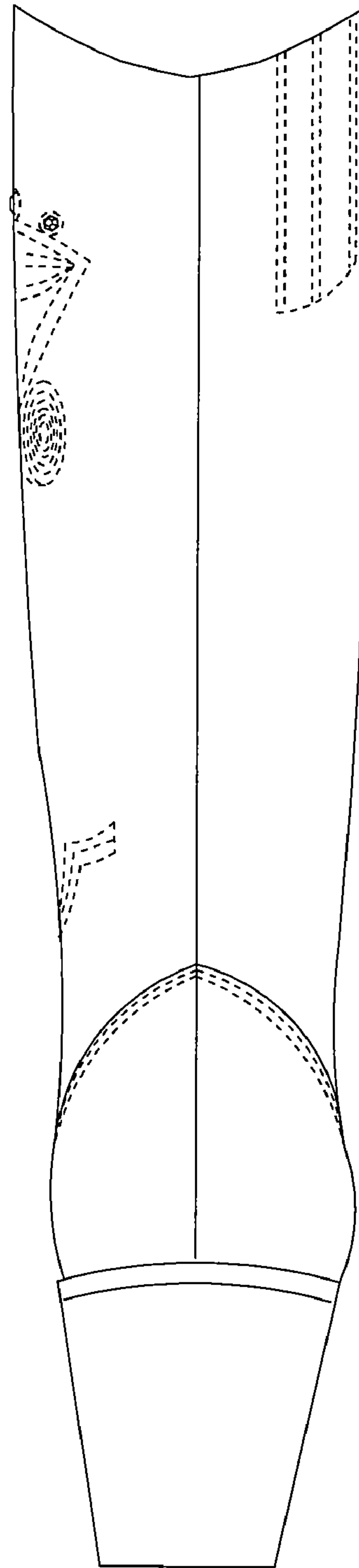

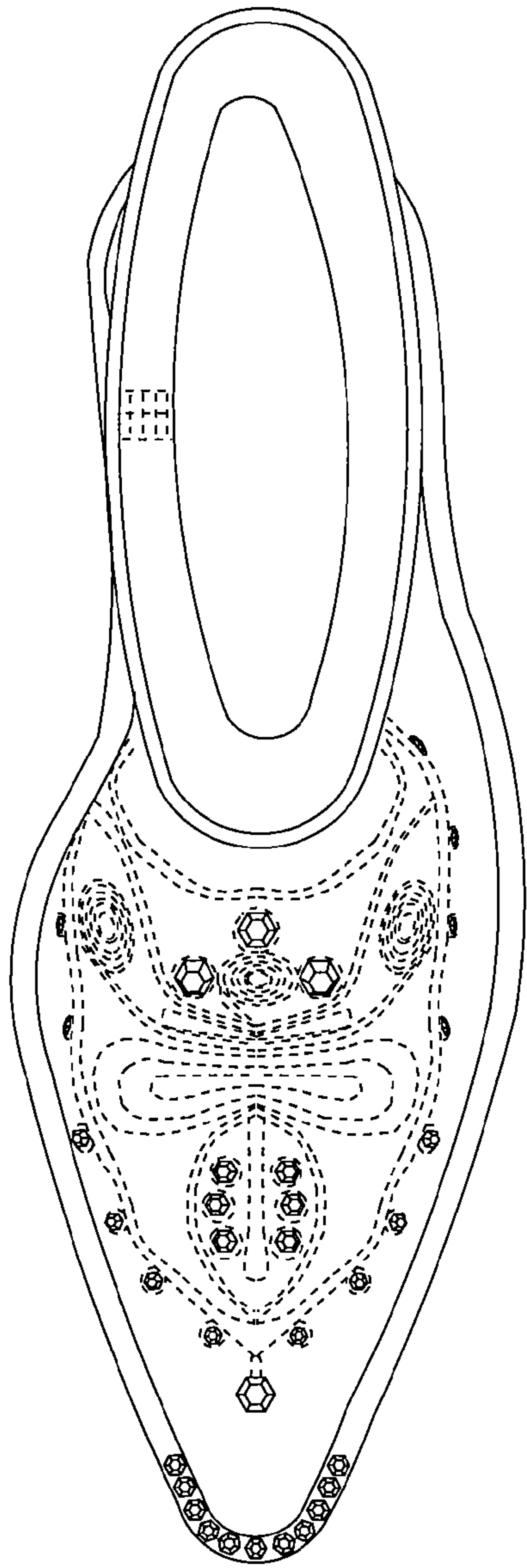

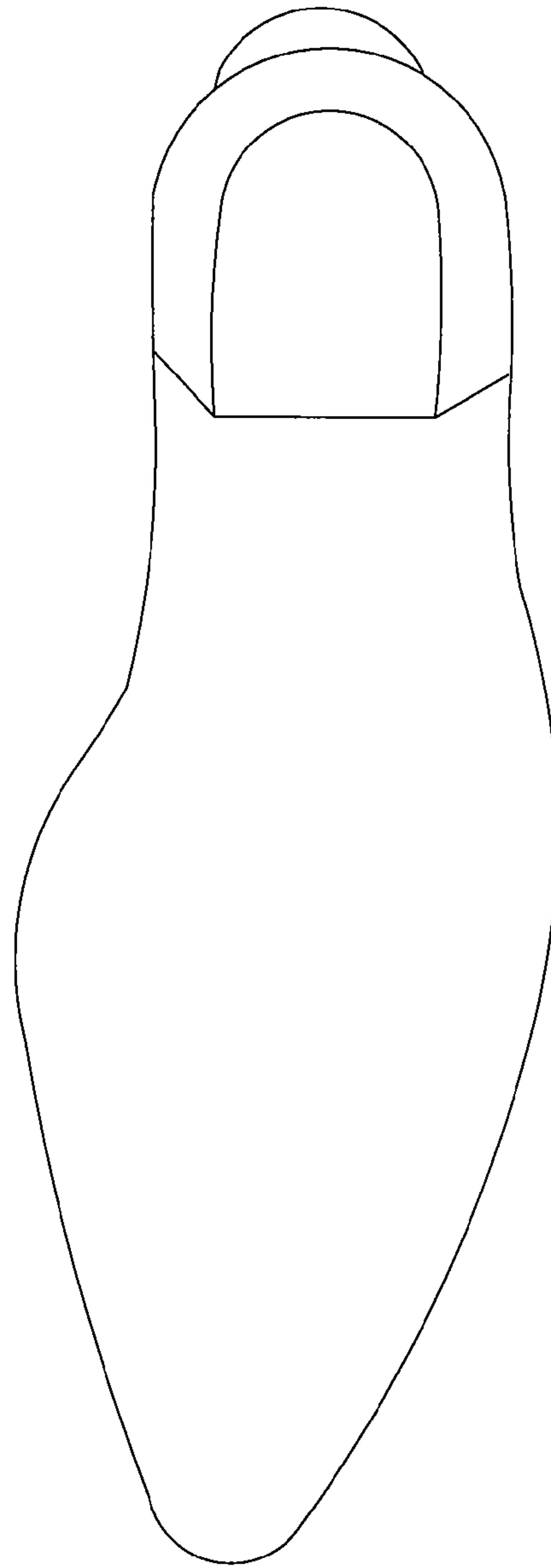
