(57) **CLAIM**

The ornamental design for a tow strap carrier and dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tow strap carrier and dispenser in accordance with my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear perspective view thereof;

FIG. 4 is a rear elevational view thereof;

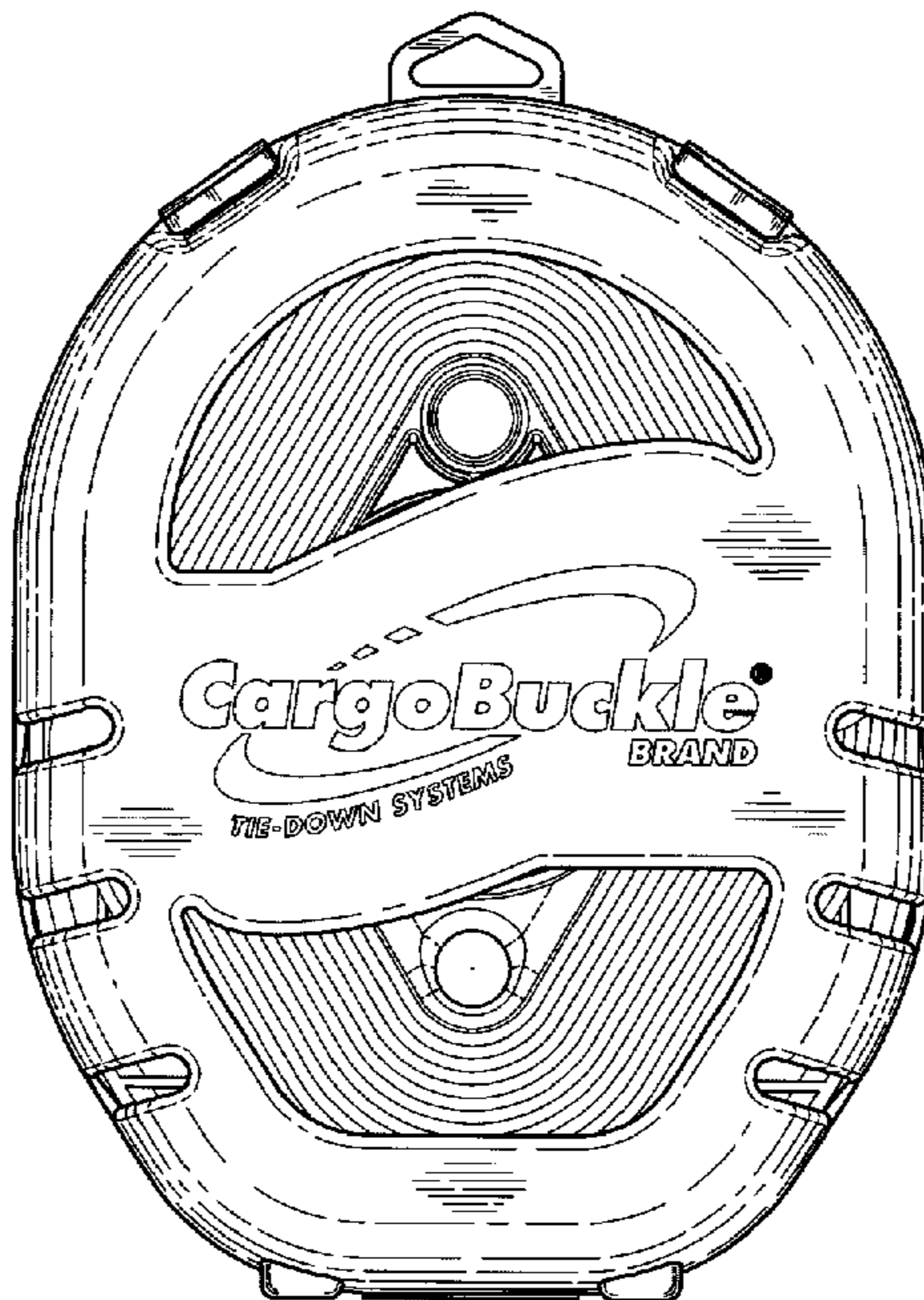
FIG. 5 is a right side elevational view thereof, the left and right sides of the tow strap carrier and dispenser of FIG. 1 being mirror images of one another;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

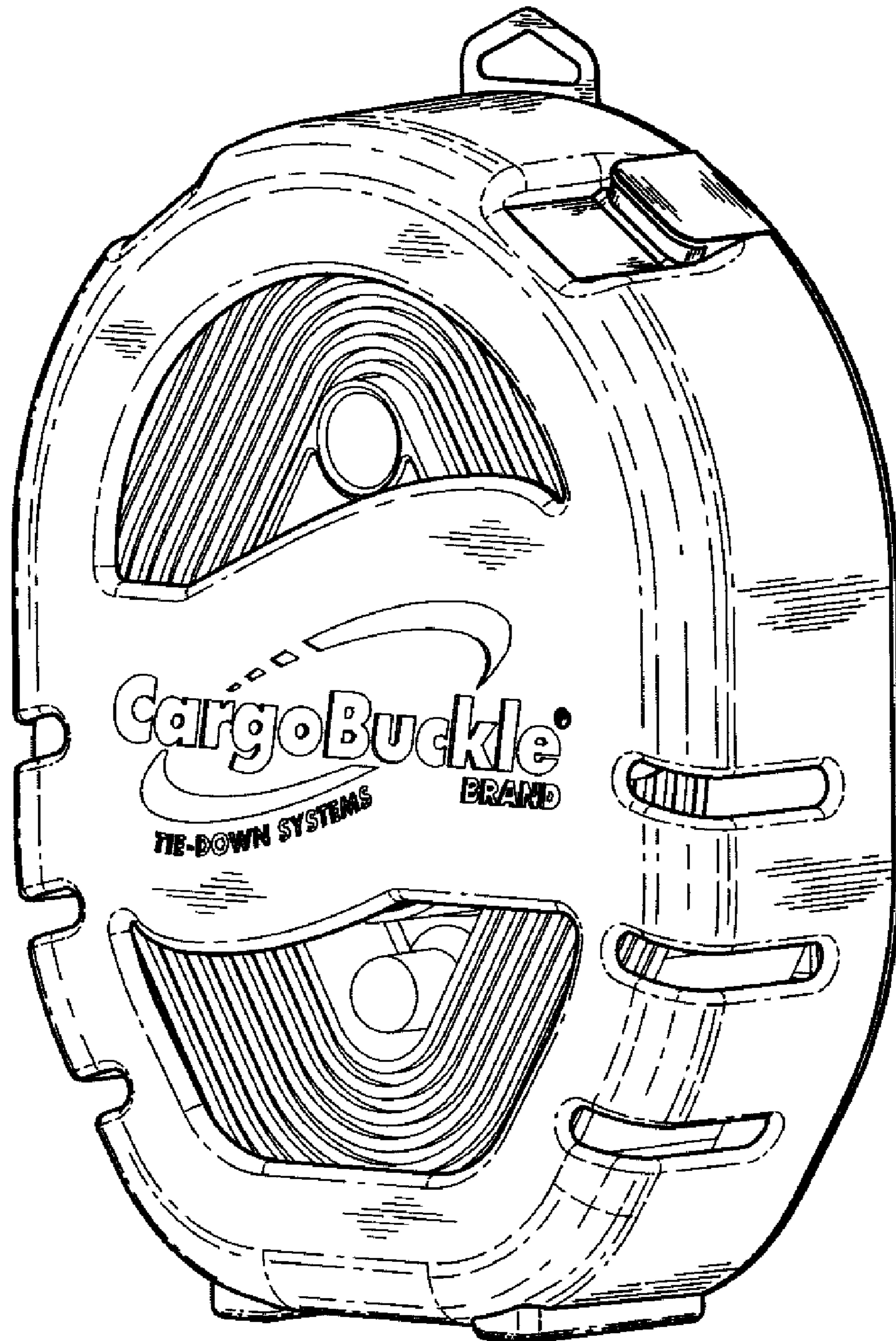

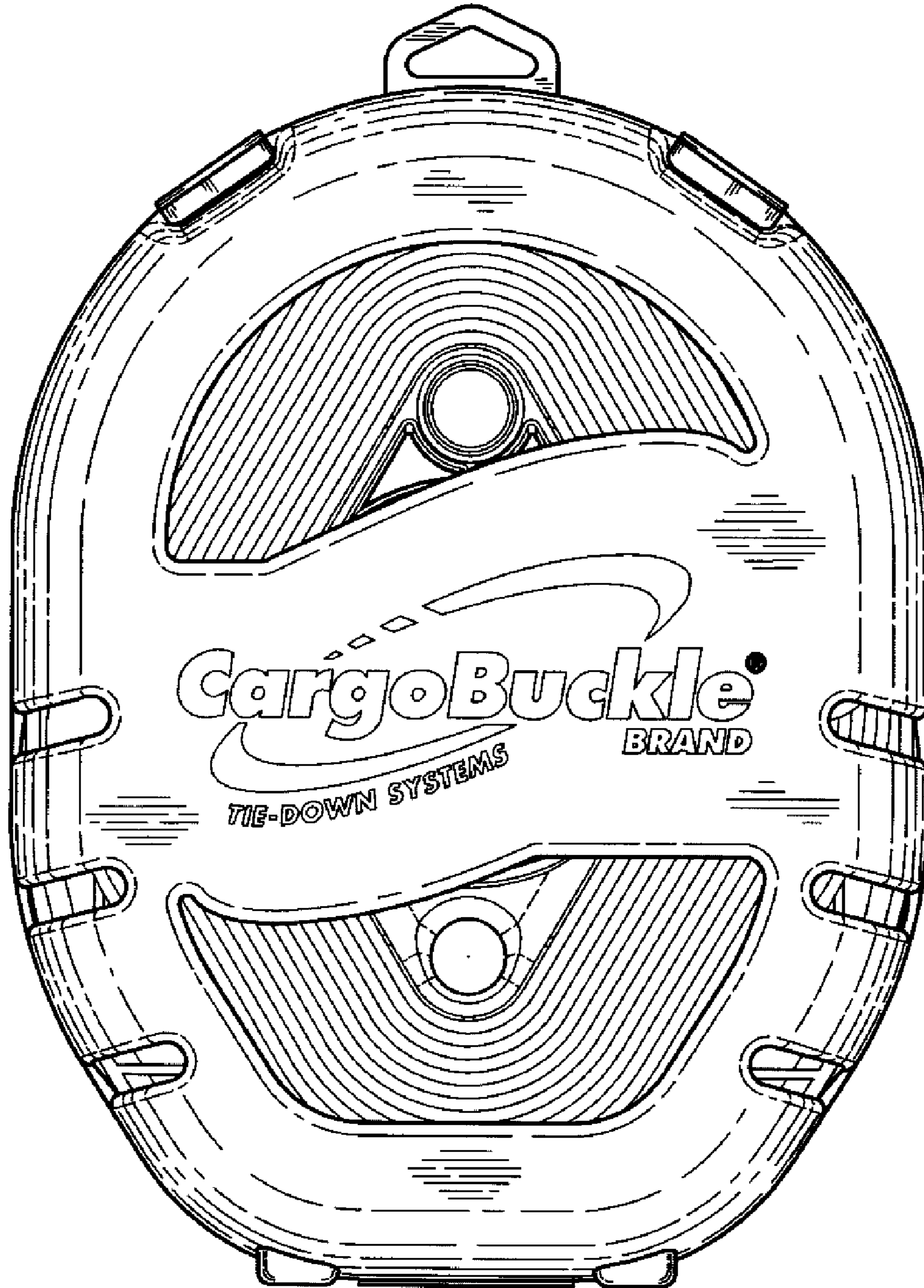

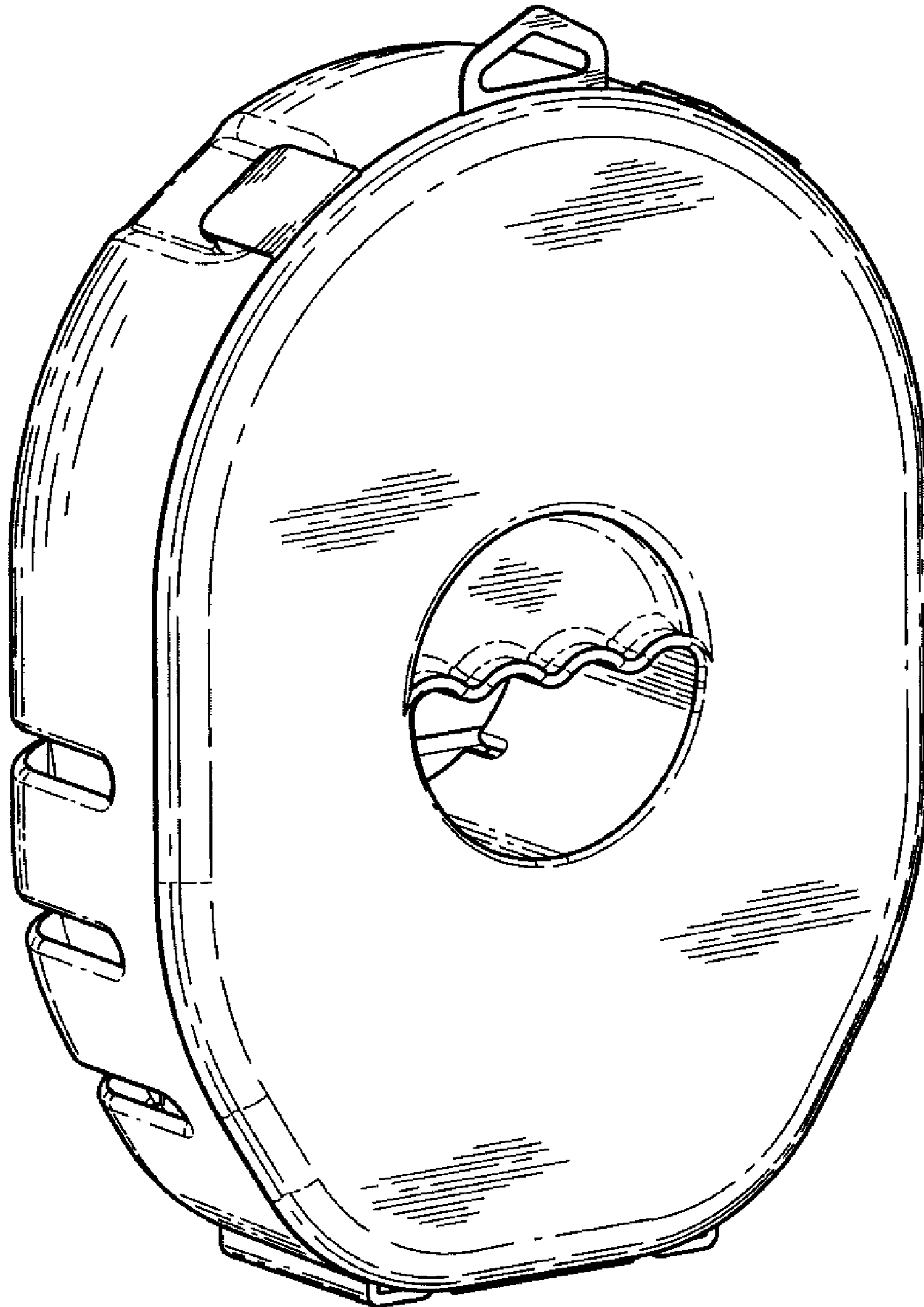

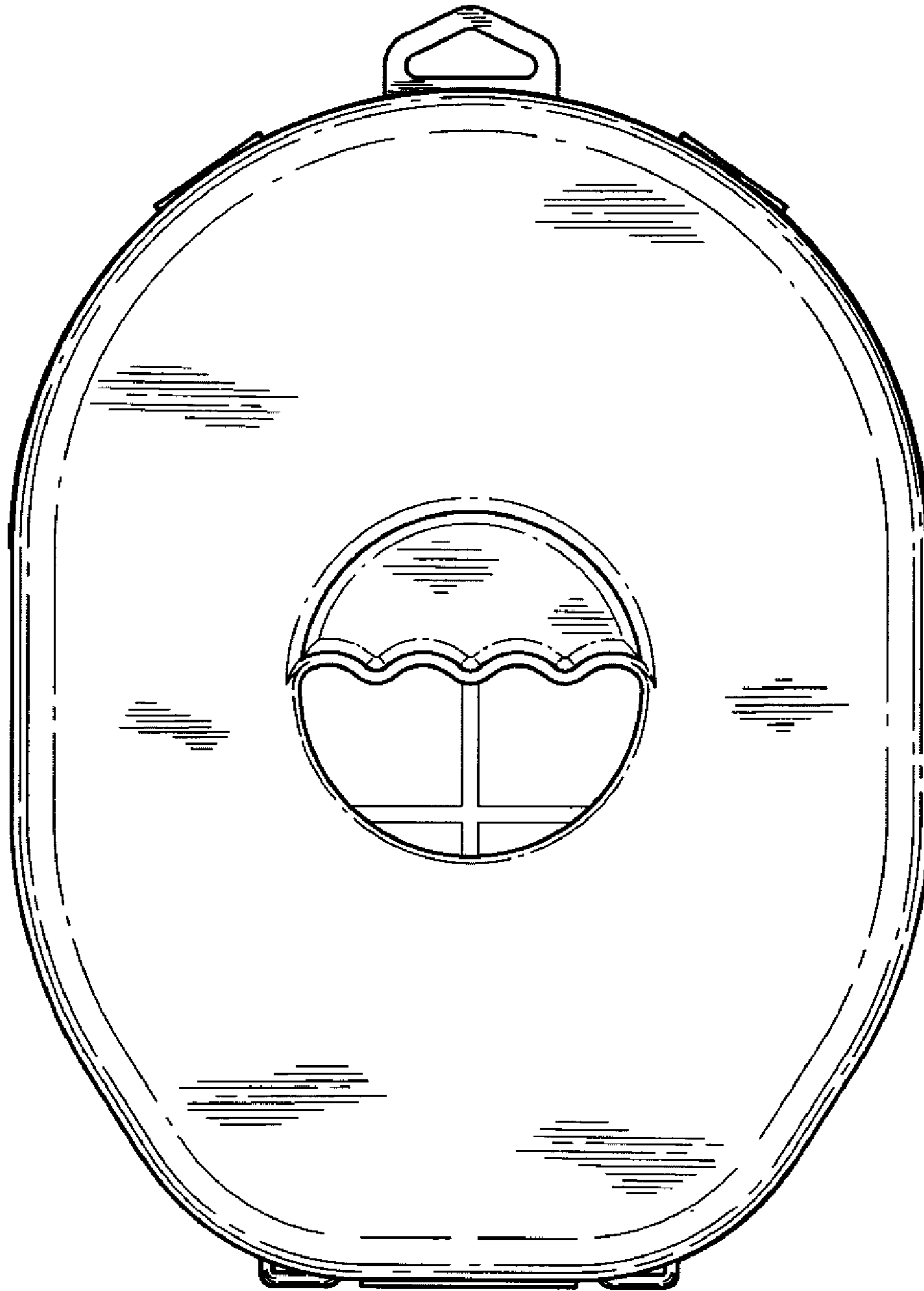

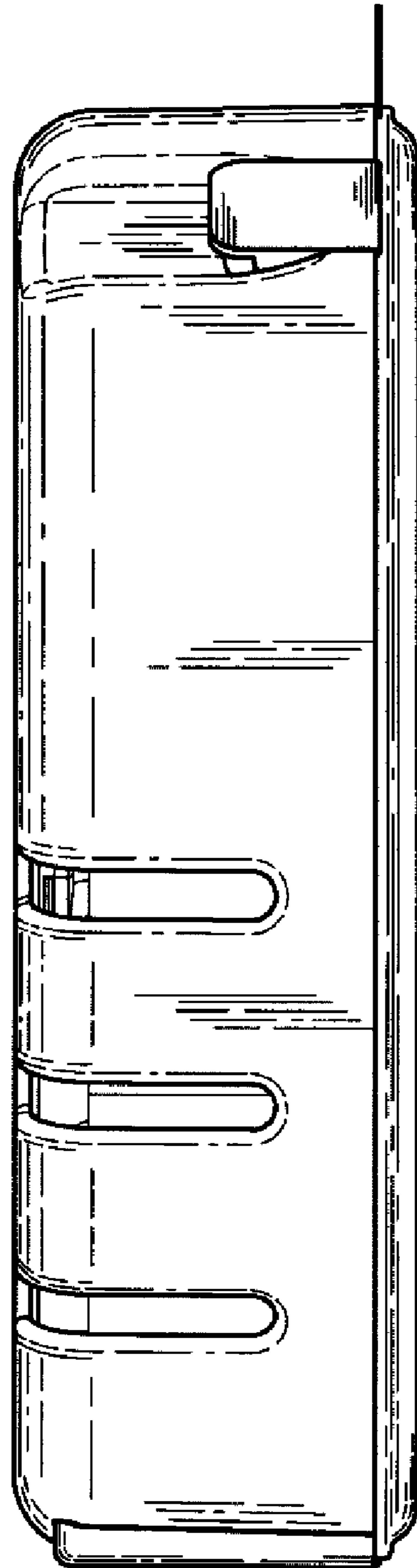

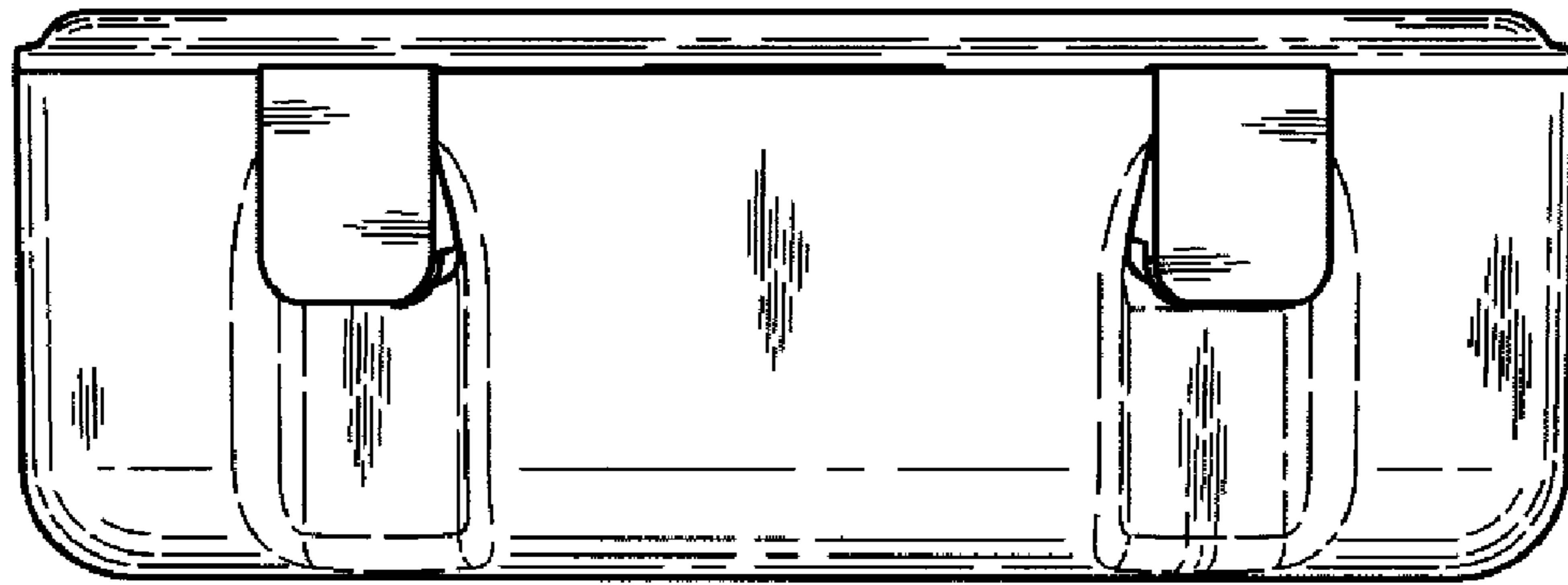

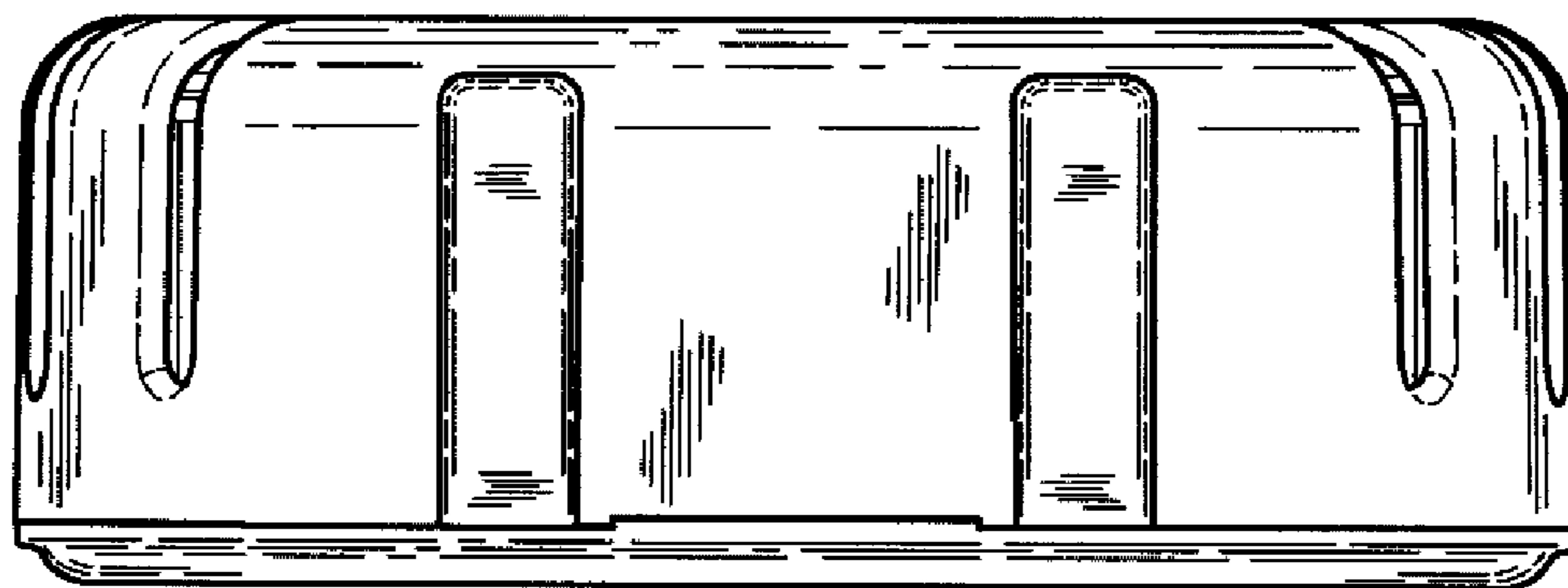
