FIG. 3 is back view of the chair shown in FIG. 1;

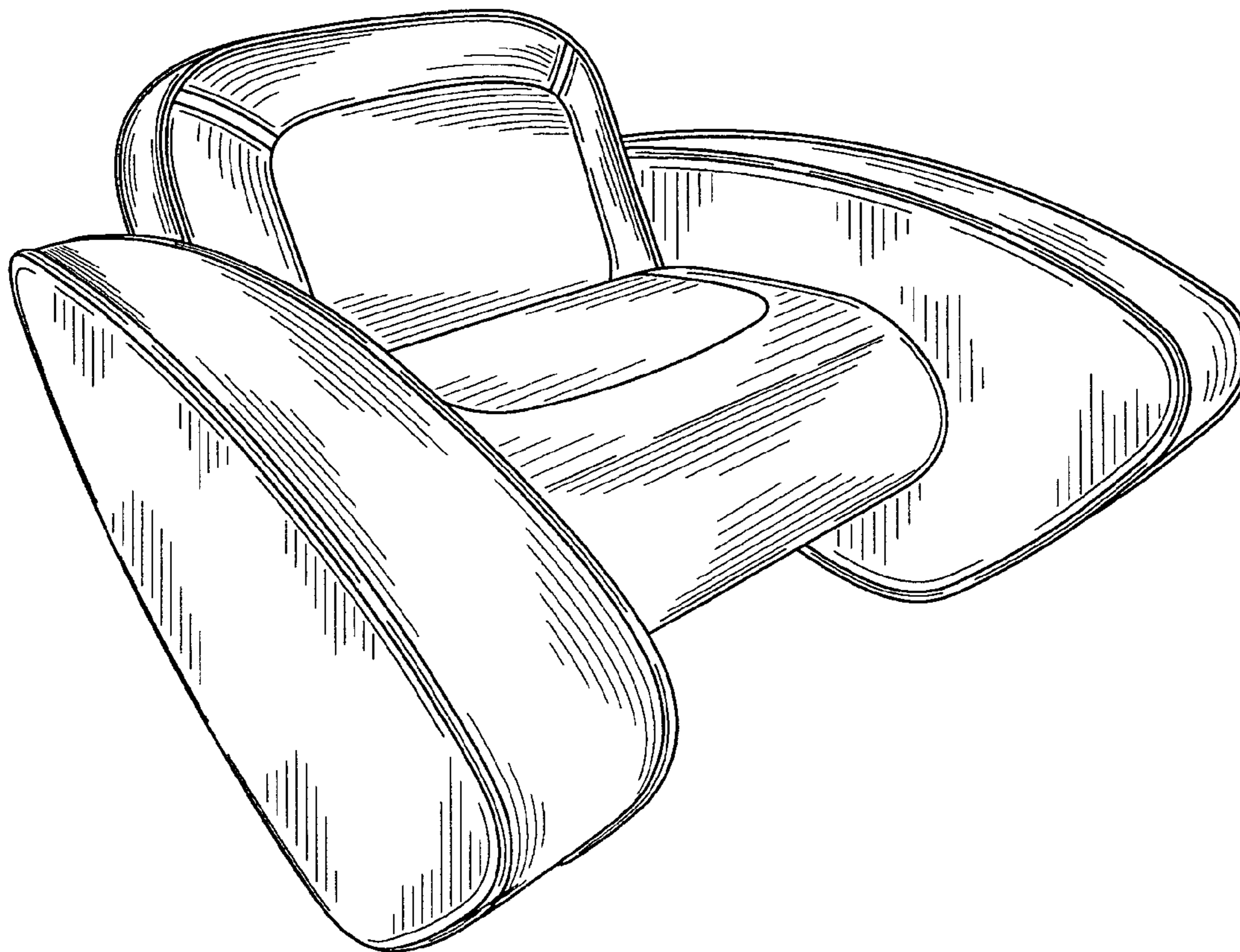
FIG. 4 is left side view of the chair shown in FIG. 1;

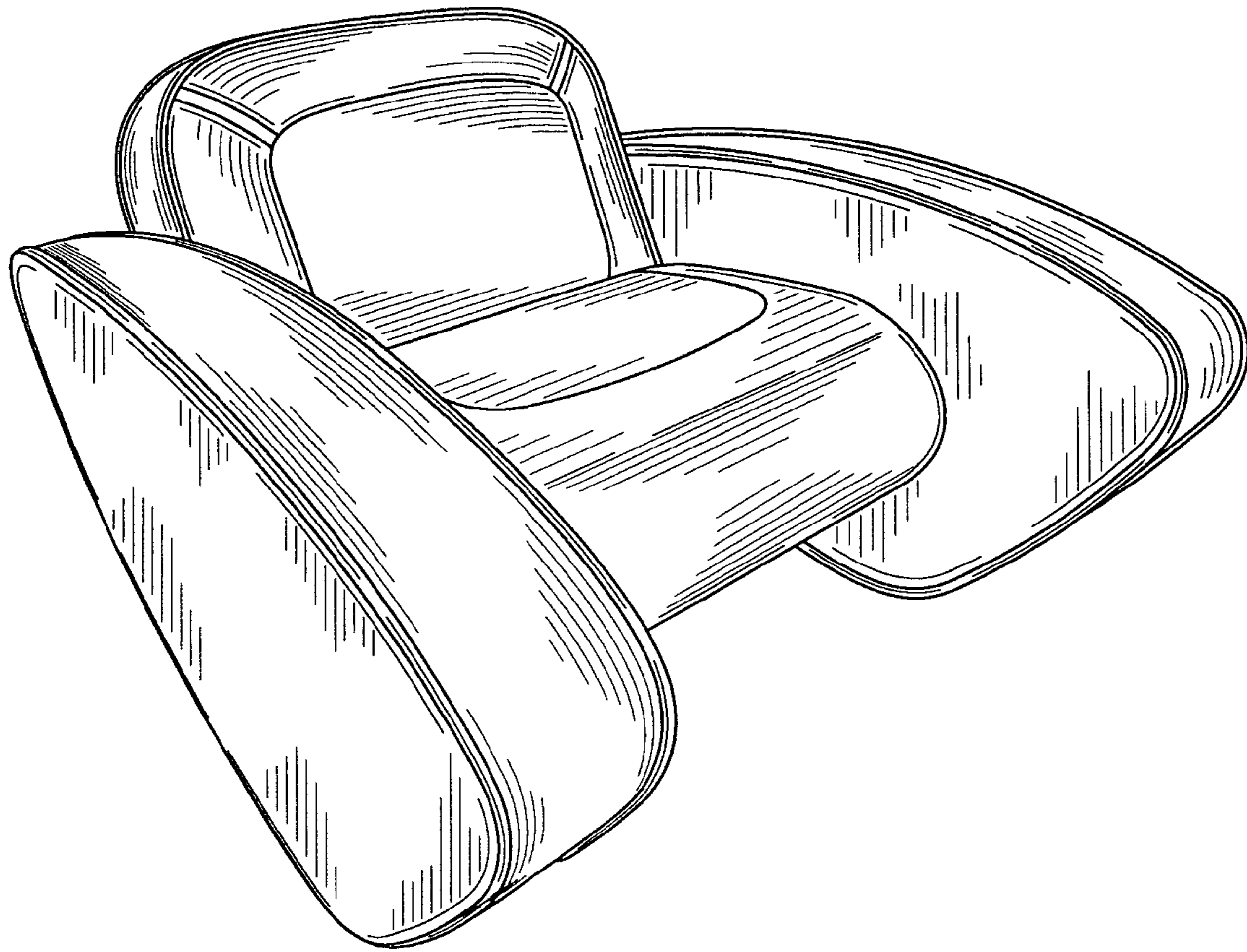

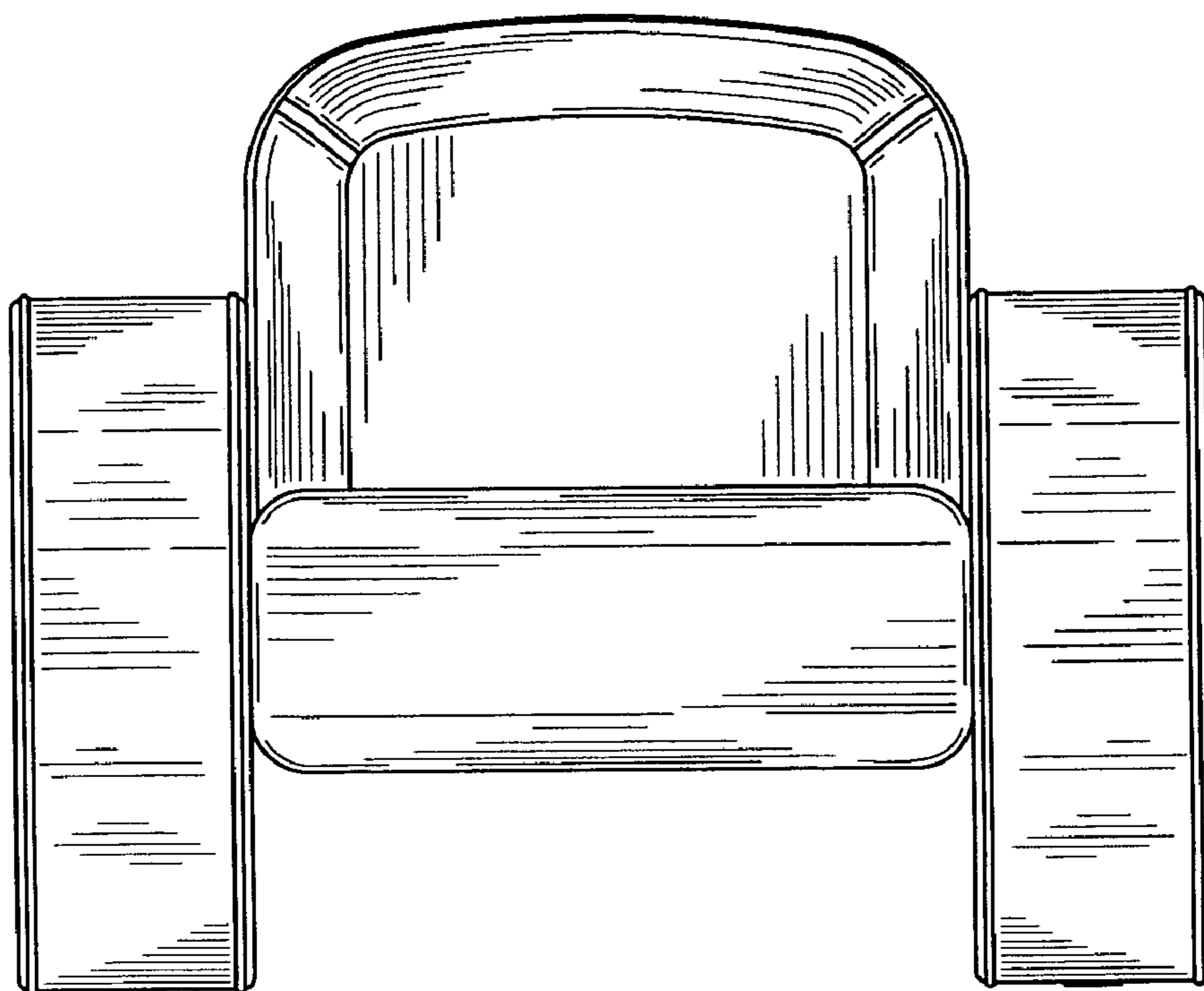

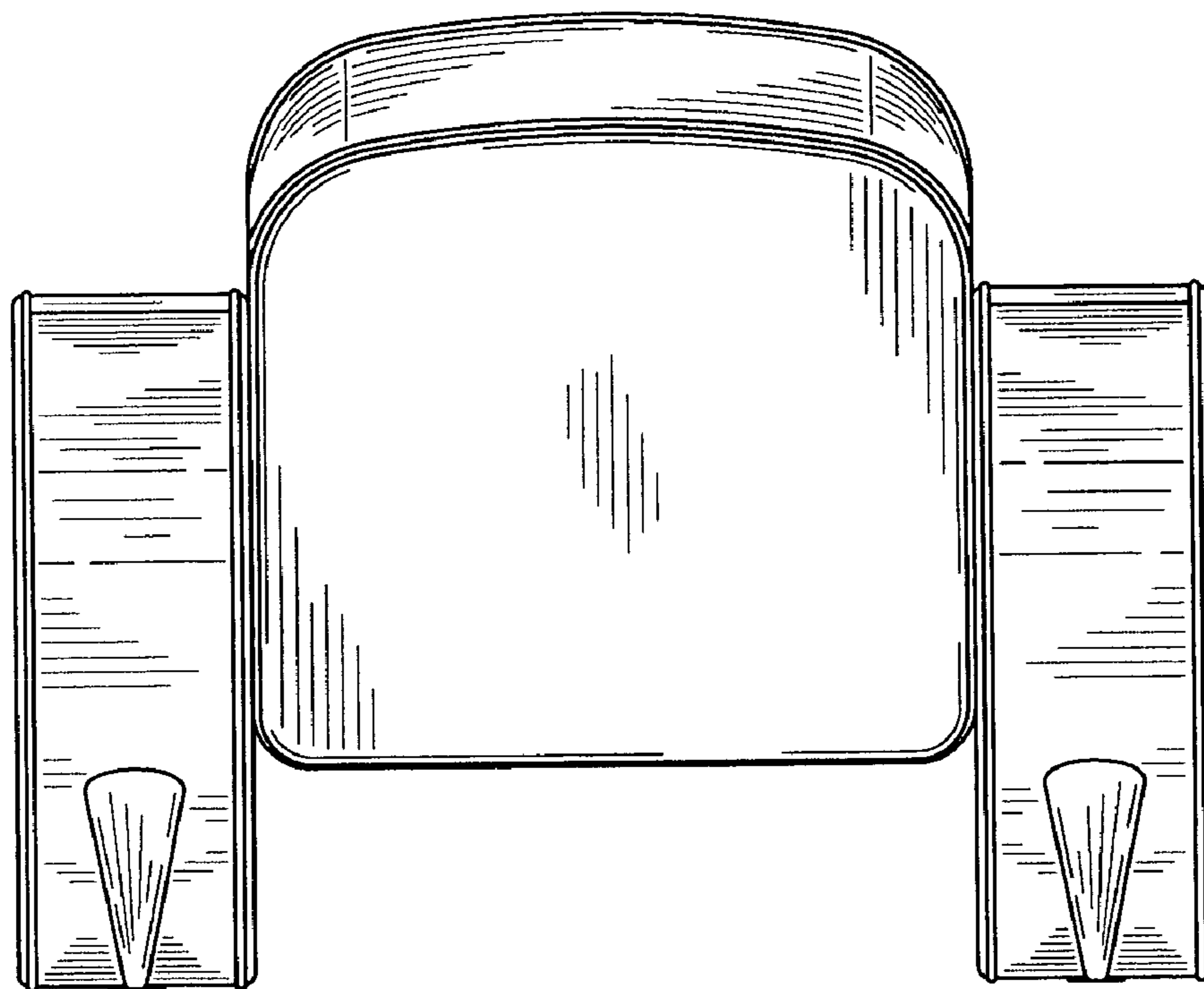

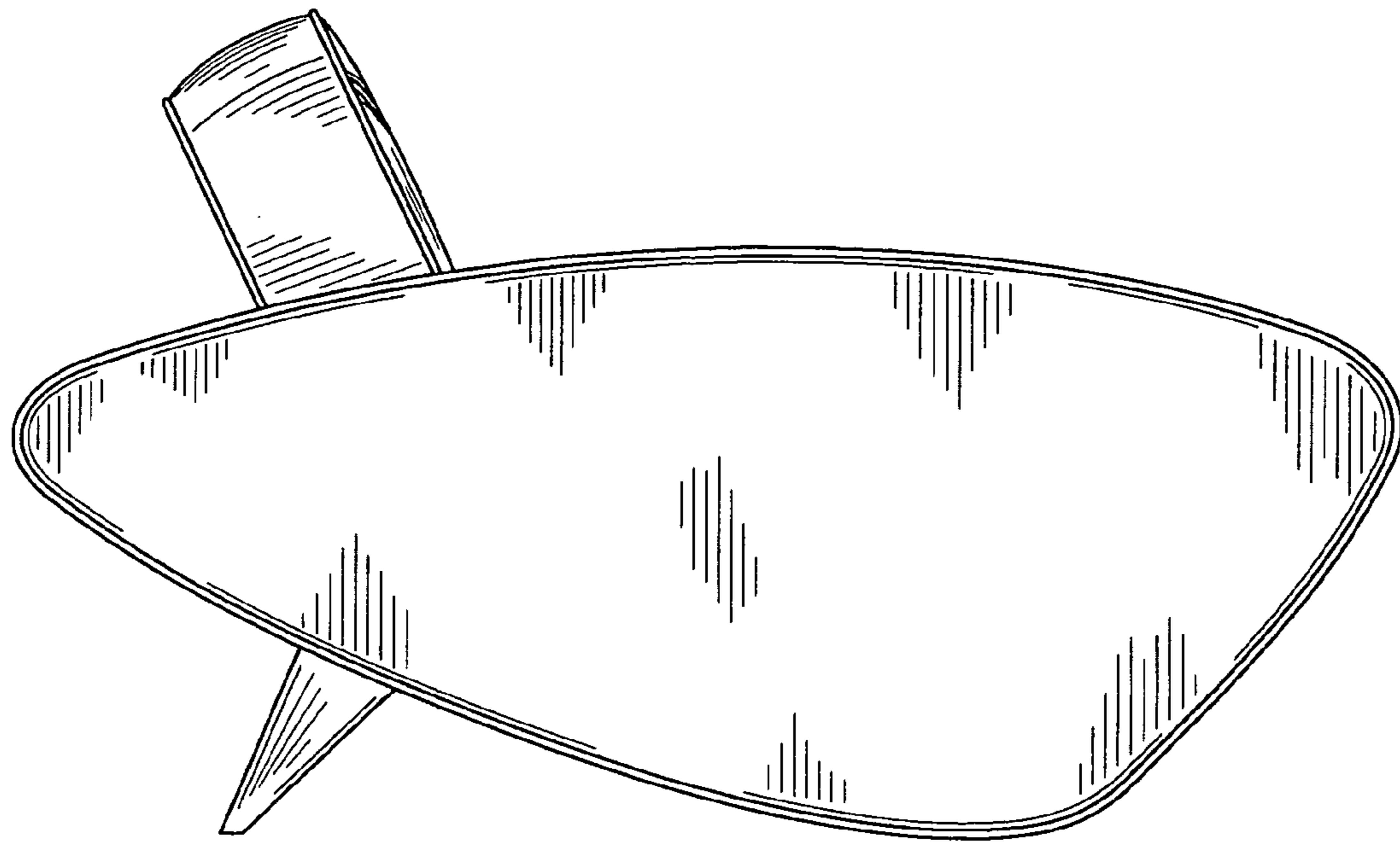

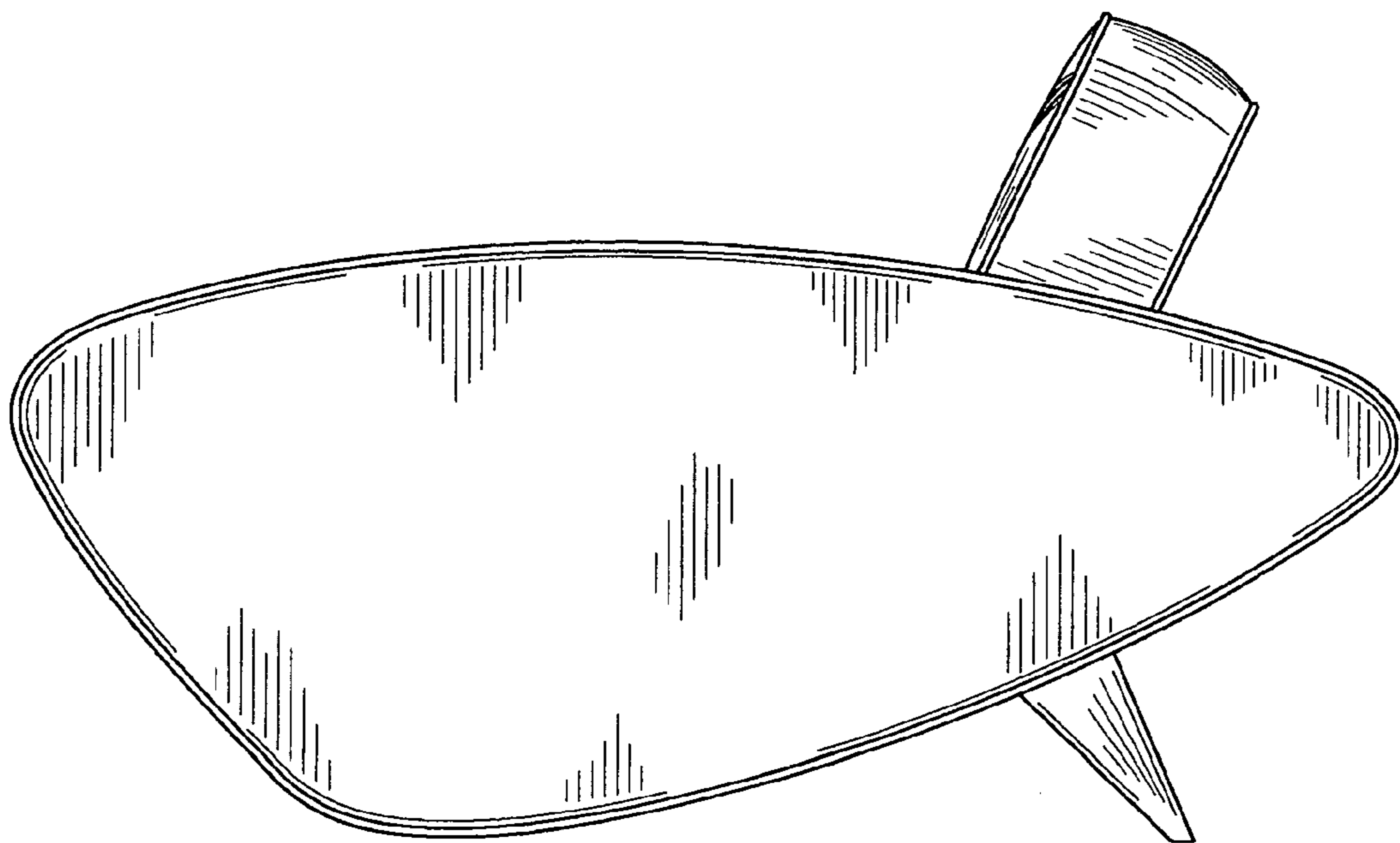

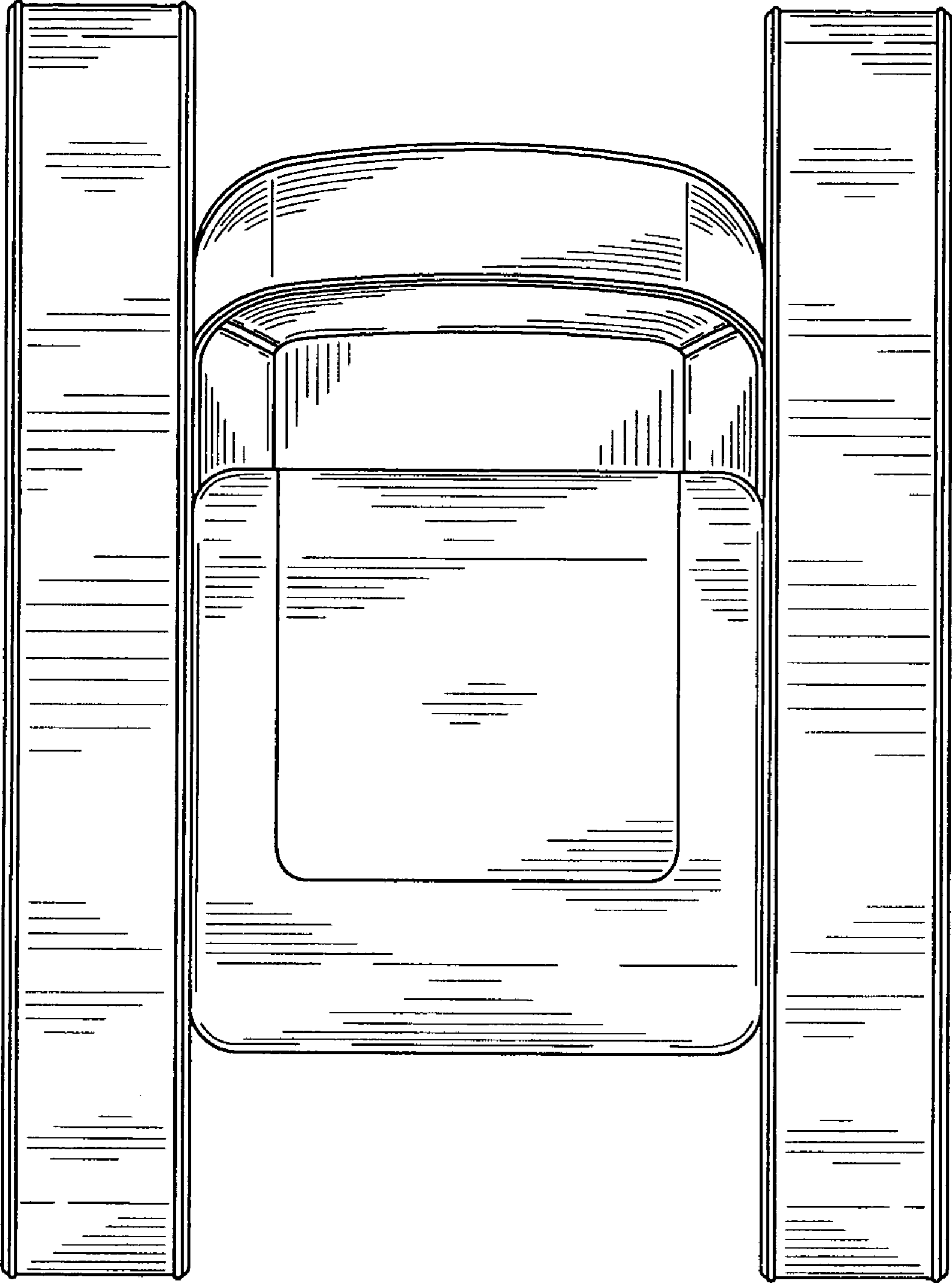

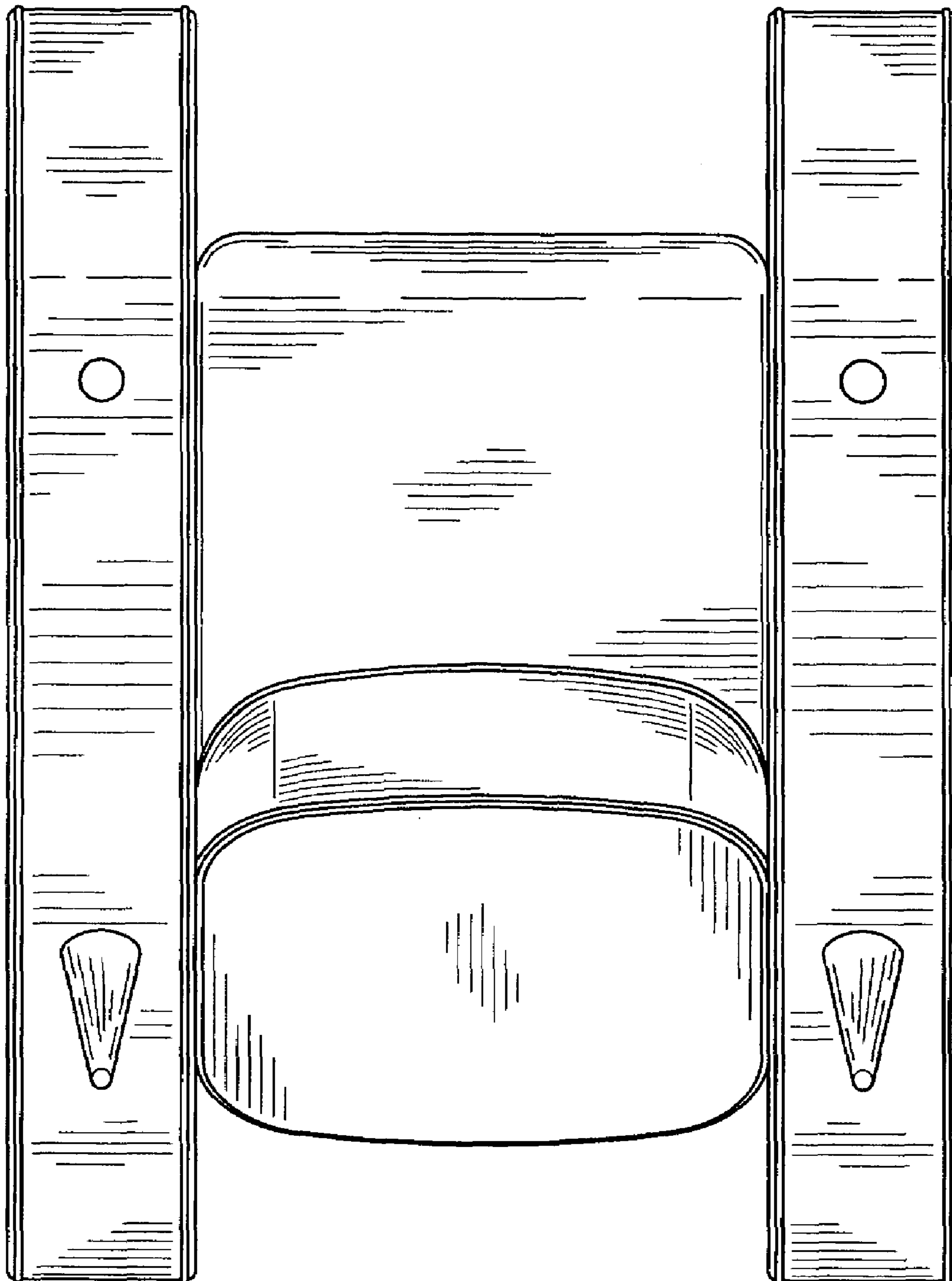
