FIG. 2 is a rear view thereof;

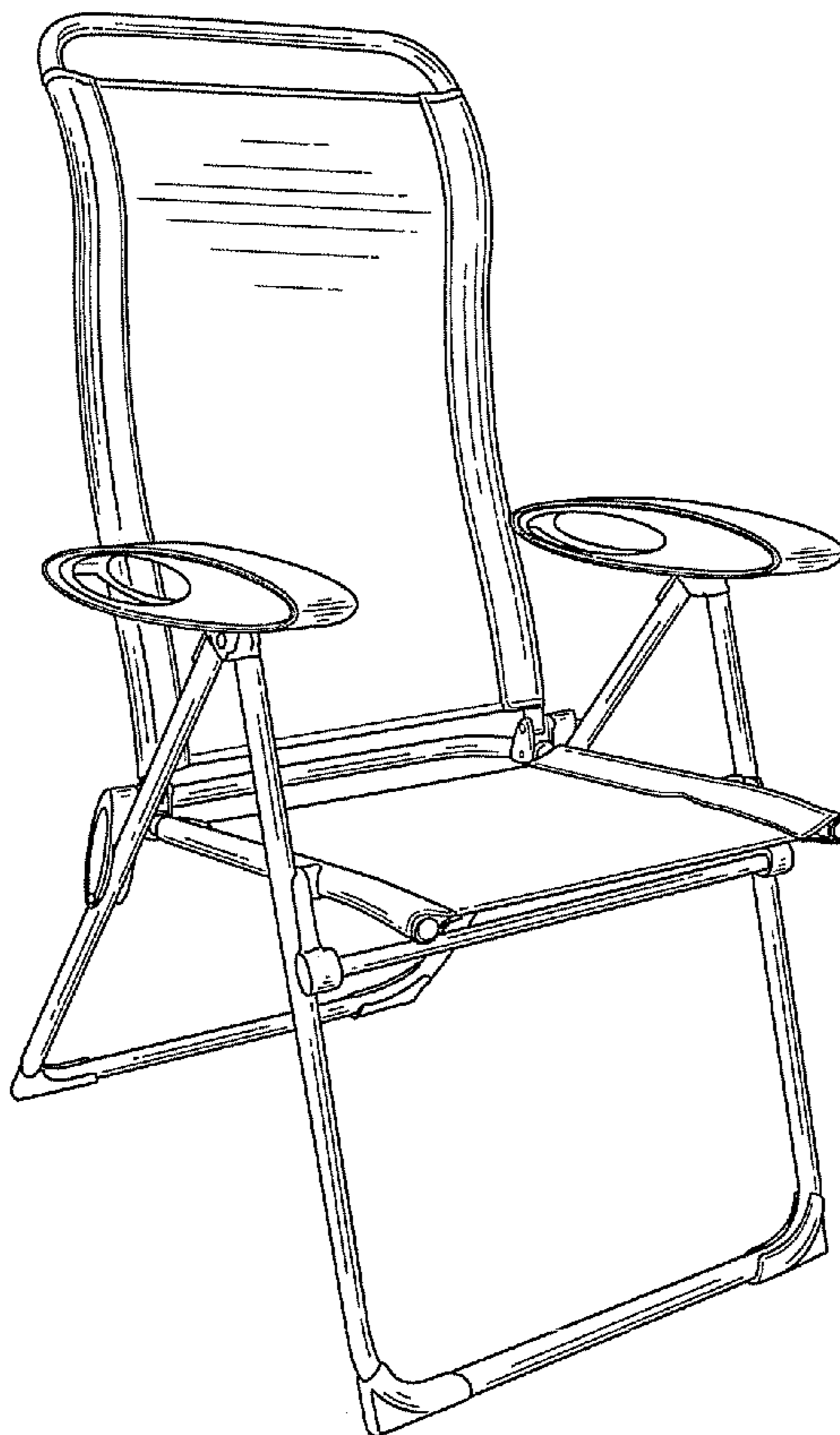
FIG. 3 is a front view thereof;

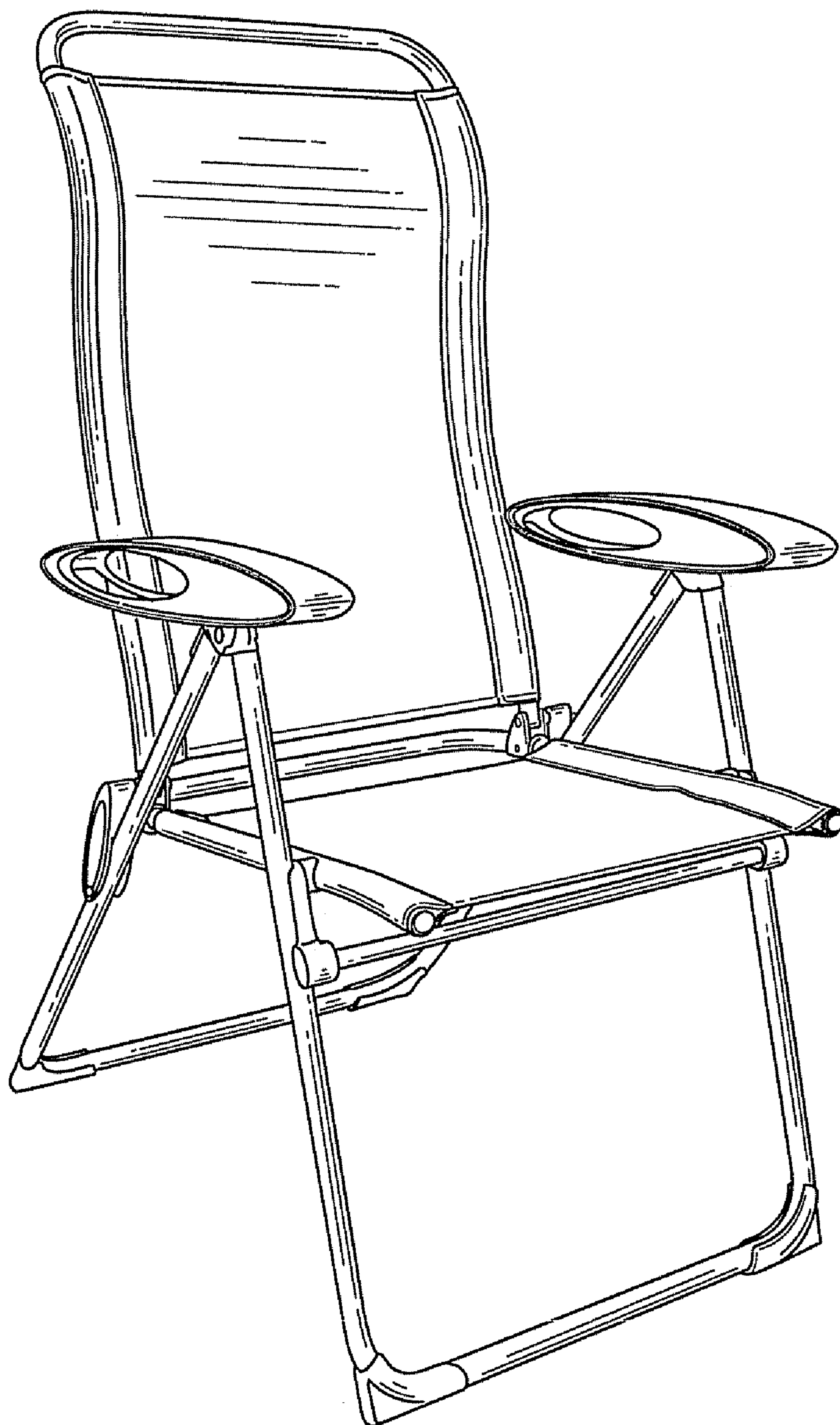
FIG. 4 is a side view thereof, the opposite side being a mirror image;

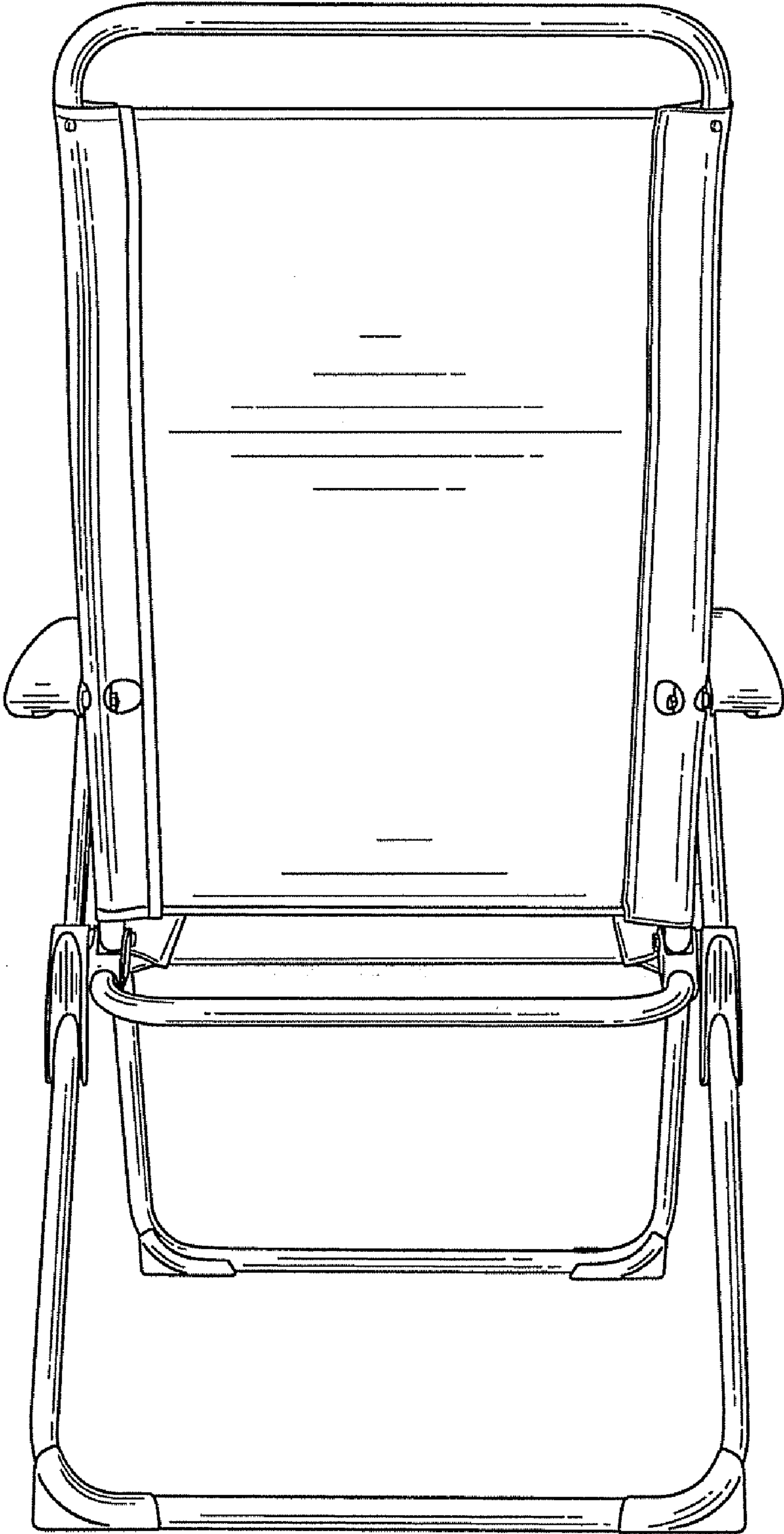
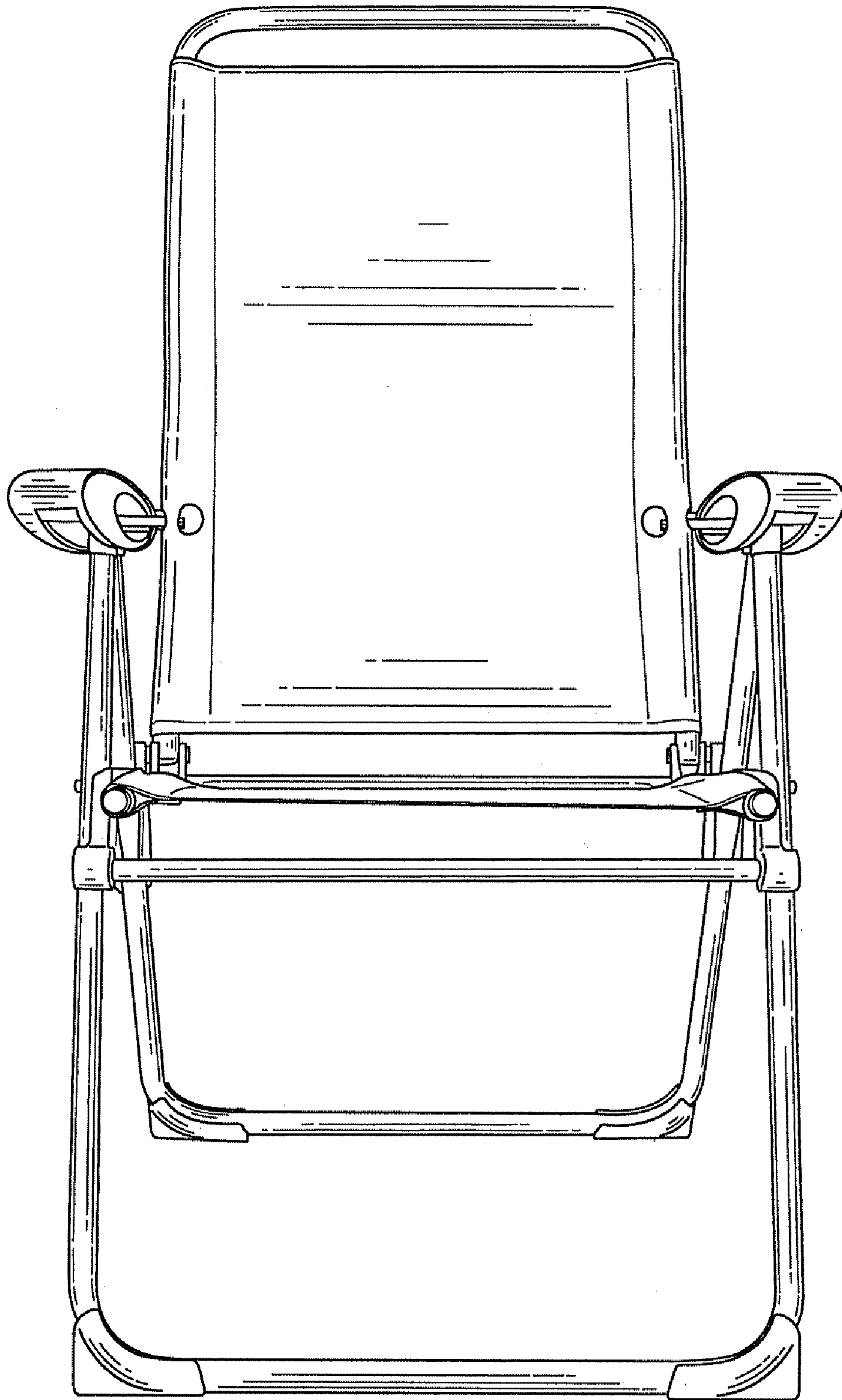
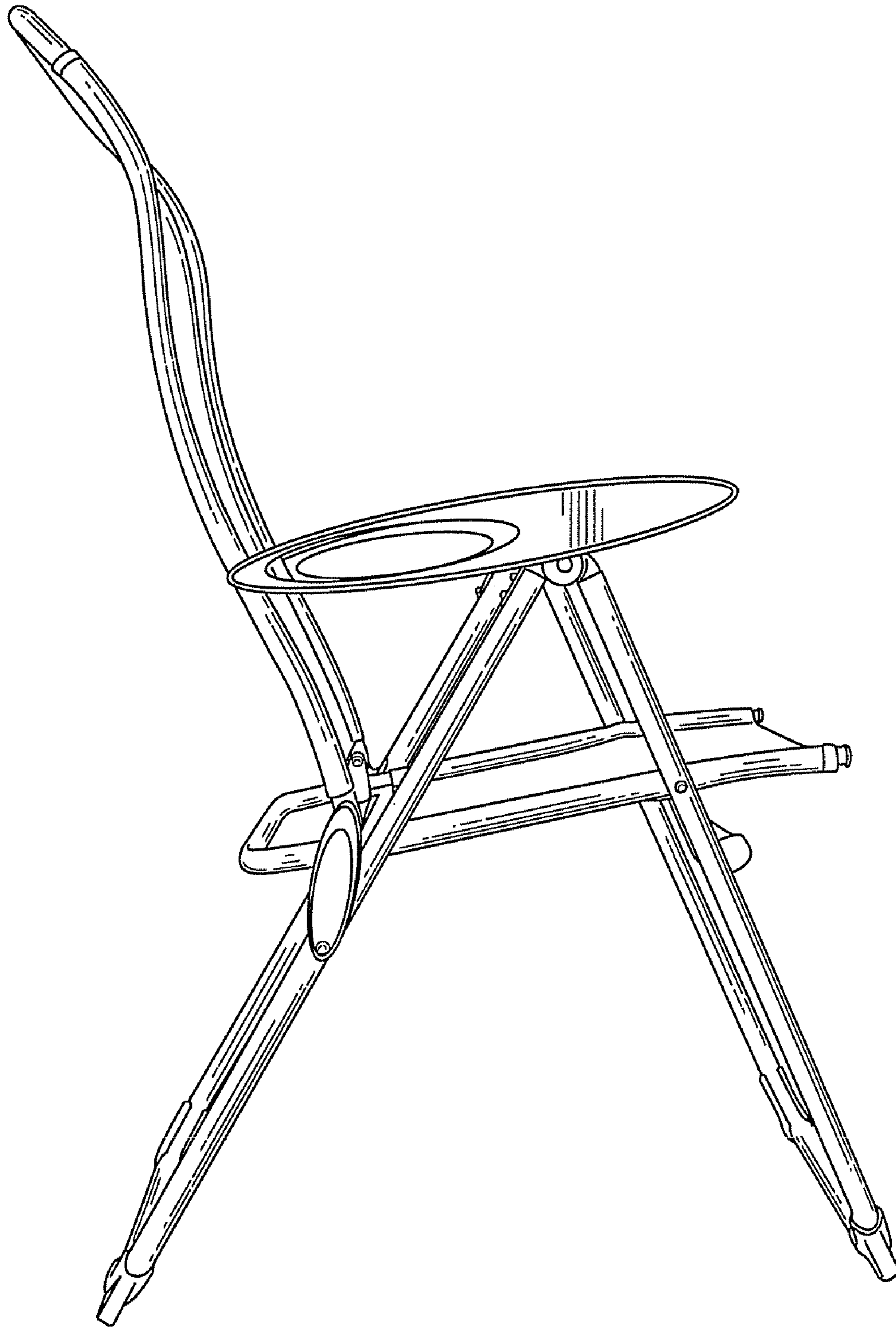


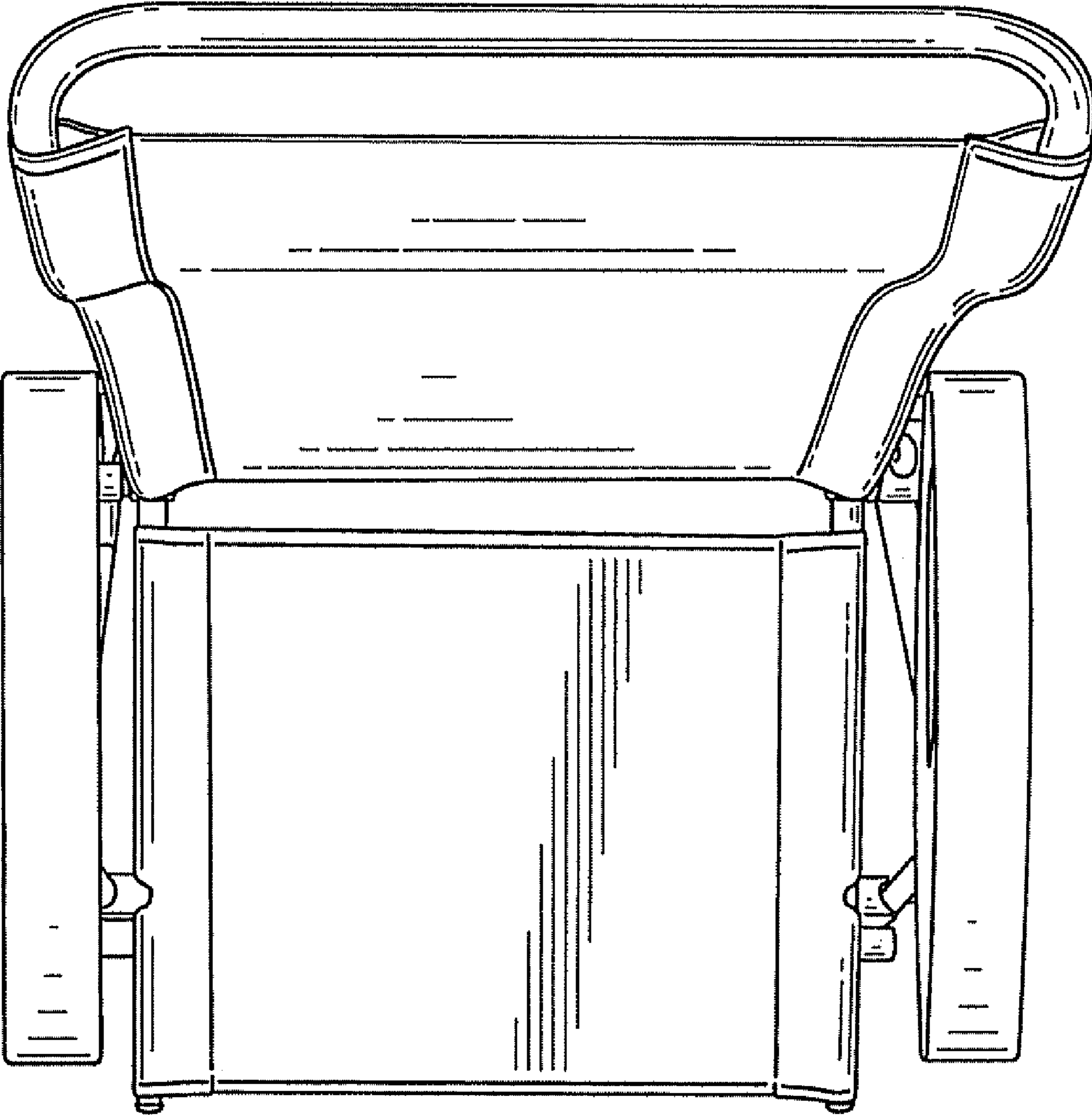

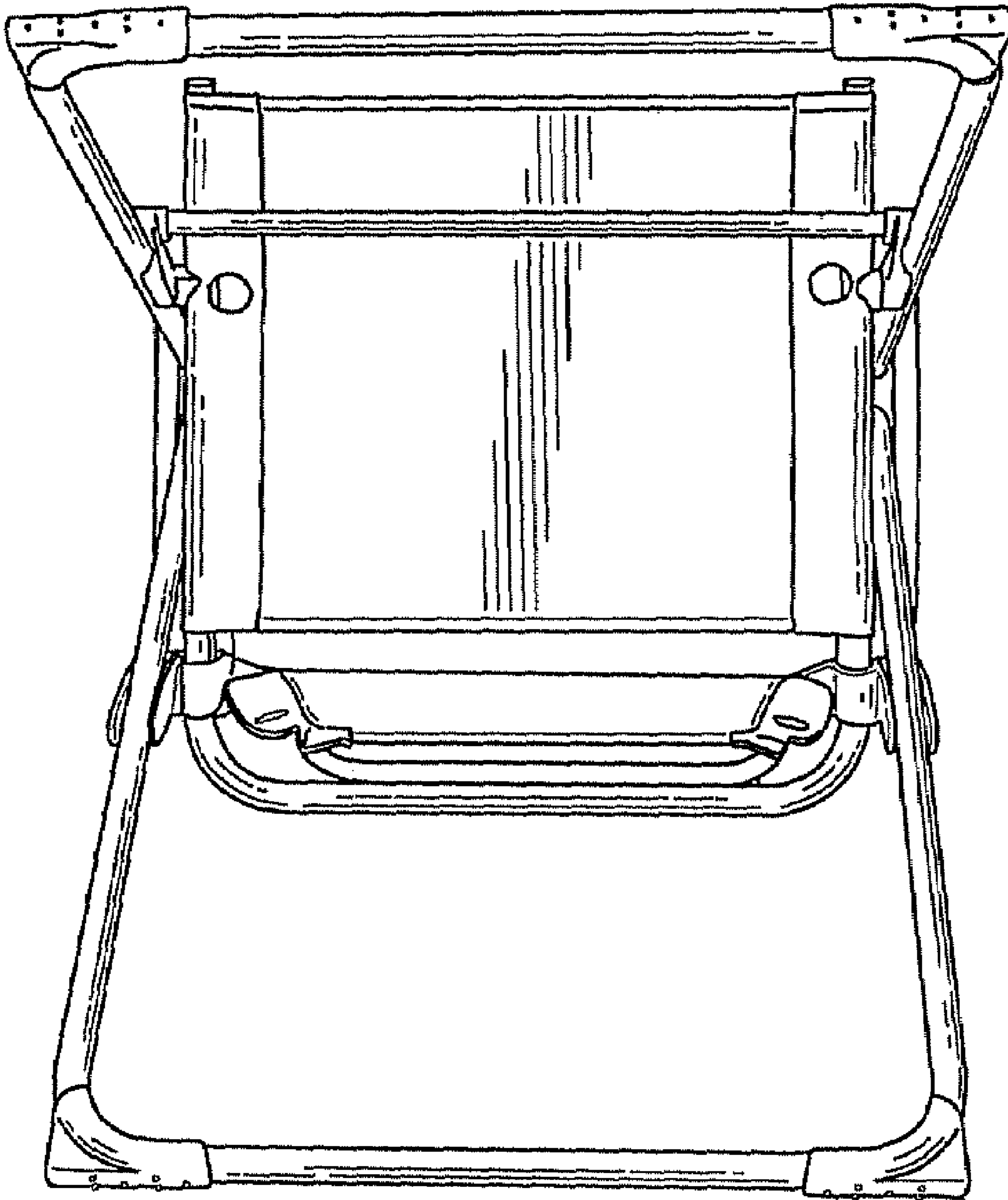
